(57) **CLAIM**

I claim an ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is an elevational view of a container in accordance with an illustrative embodiment of my new claimed design. FIG. 2 is an upper perspective view of the container in FIG. 1.

FIG. 3 is a top view of the container in FIG. 1. FIG. 4 is a bottom view of the container in FIG. 1.

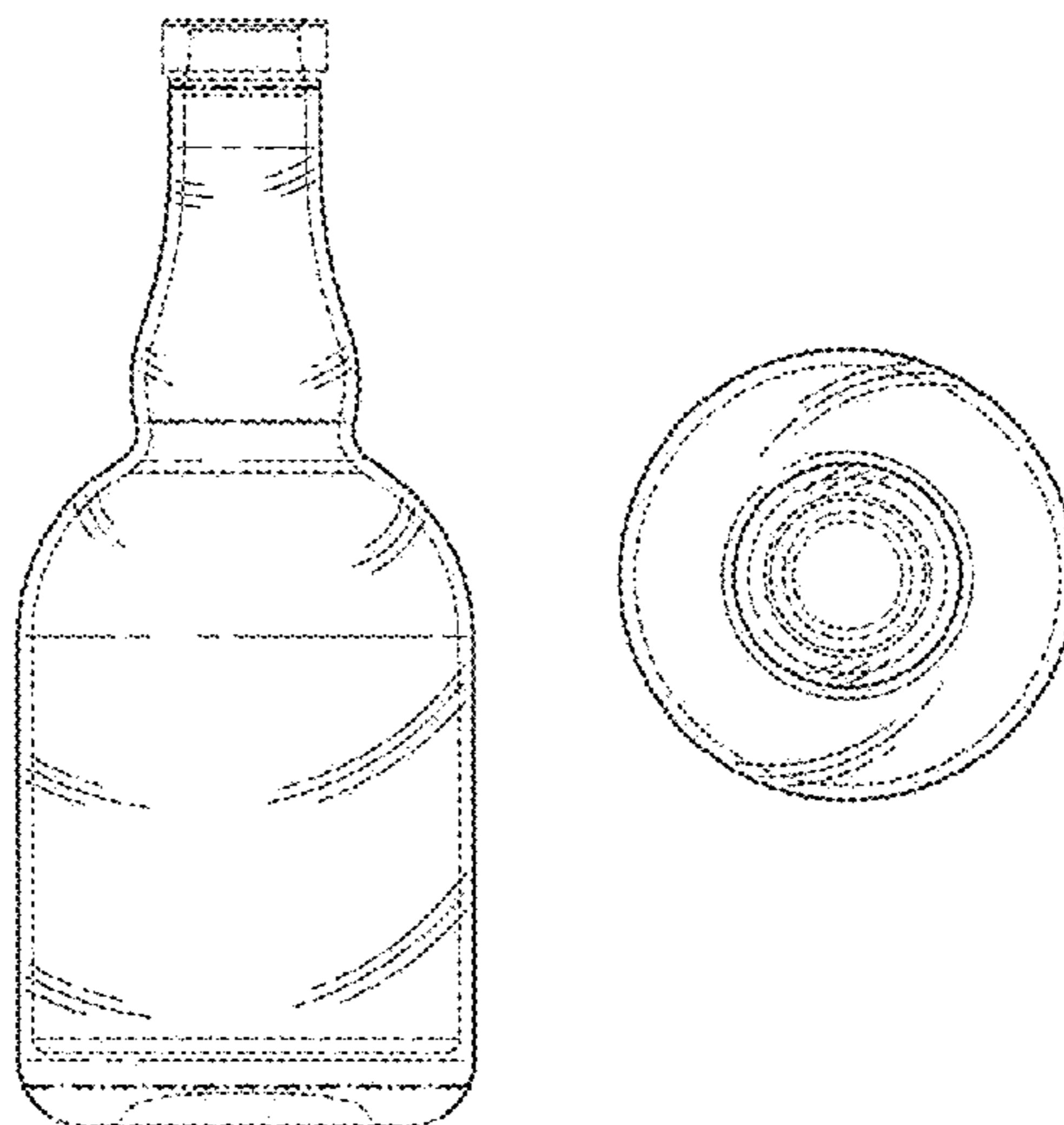
FIG. 5 is an elevational view of a container in accordance with another illustrative embodiment of my new claimed design.

FIG. 6 is an upper perspective view of the container in FIG. 5.

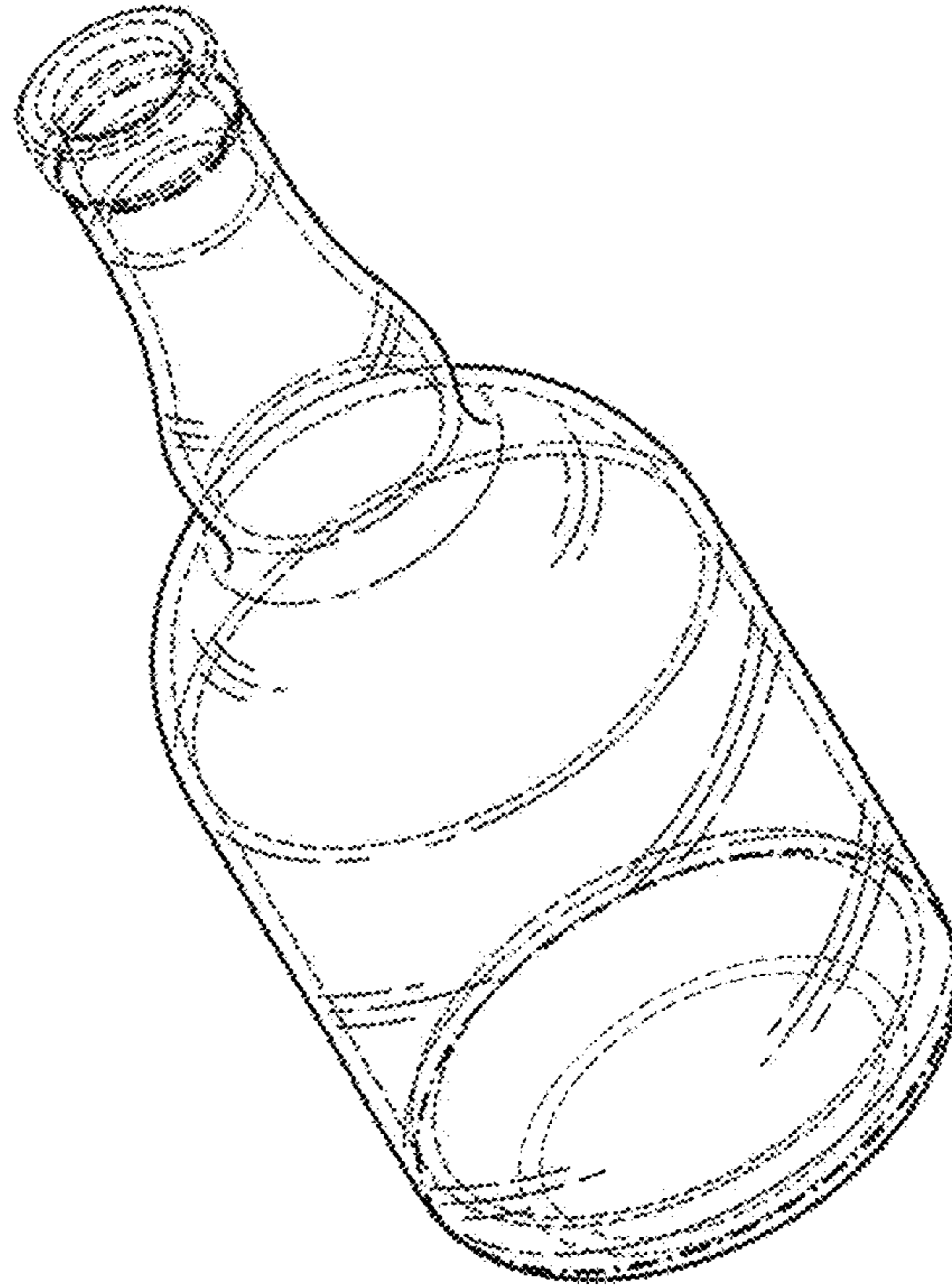

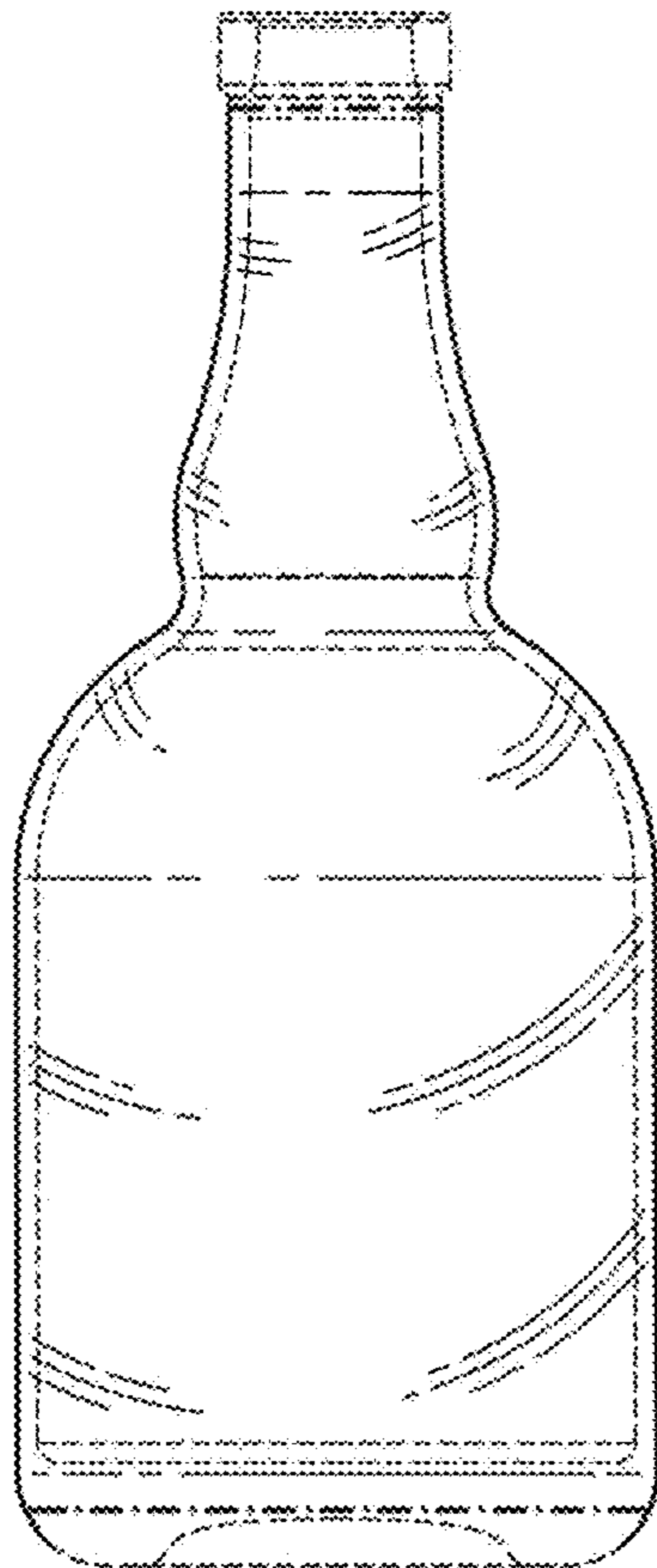

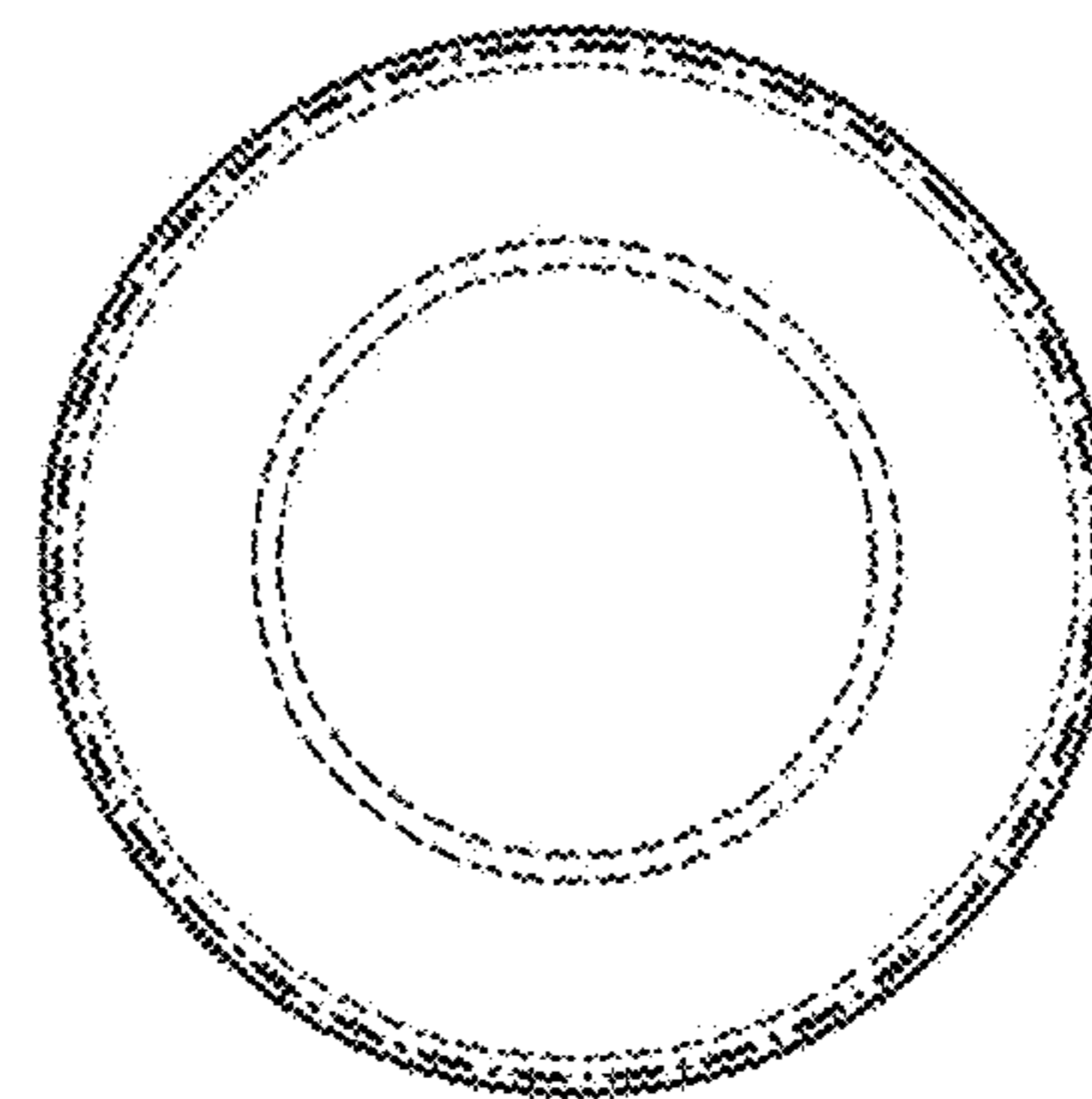

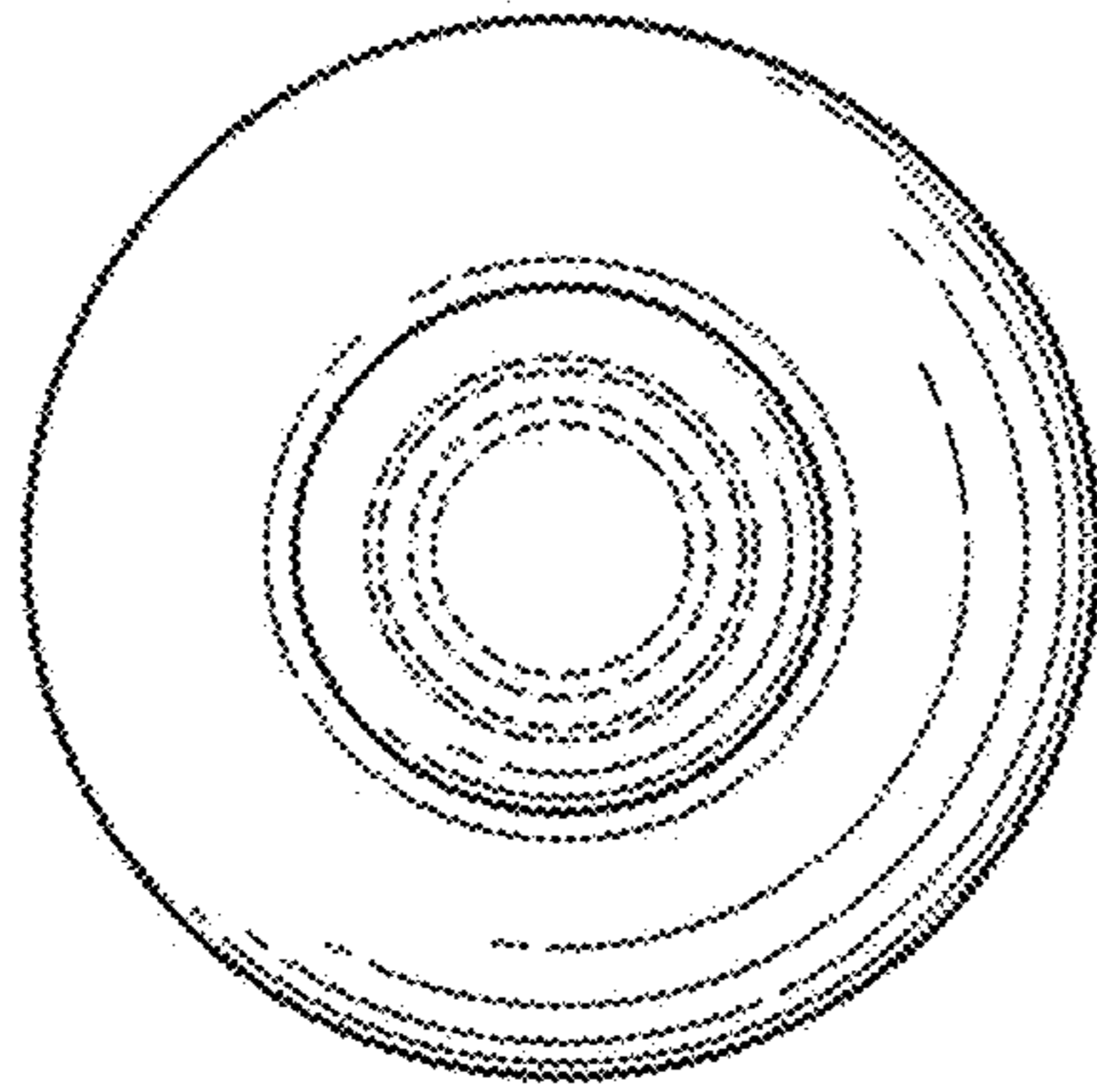

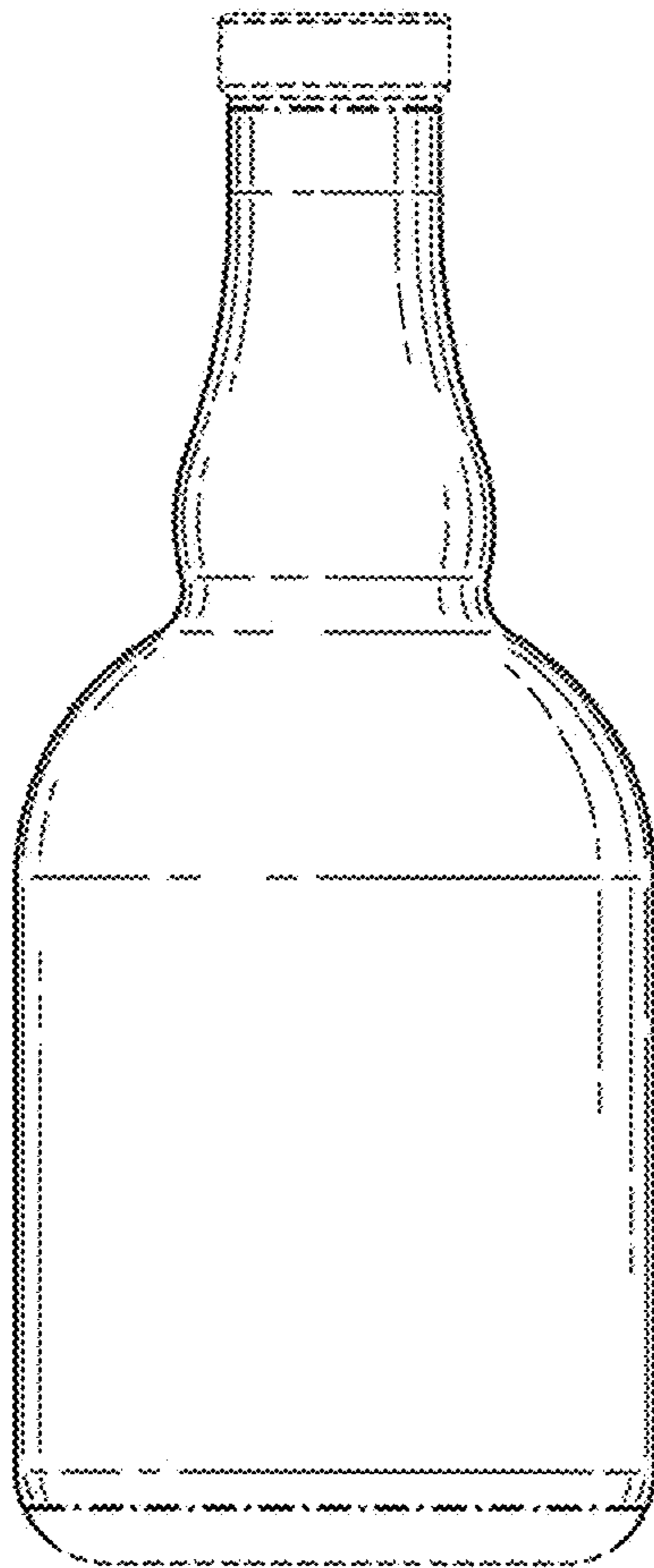

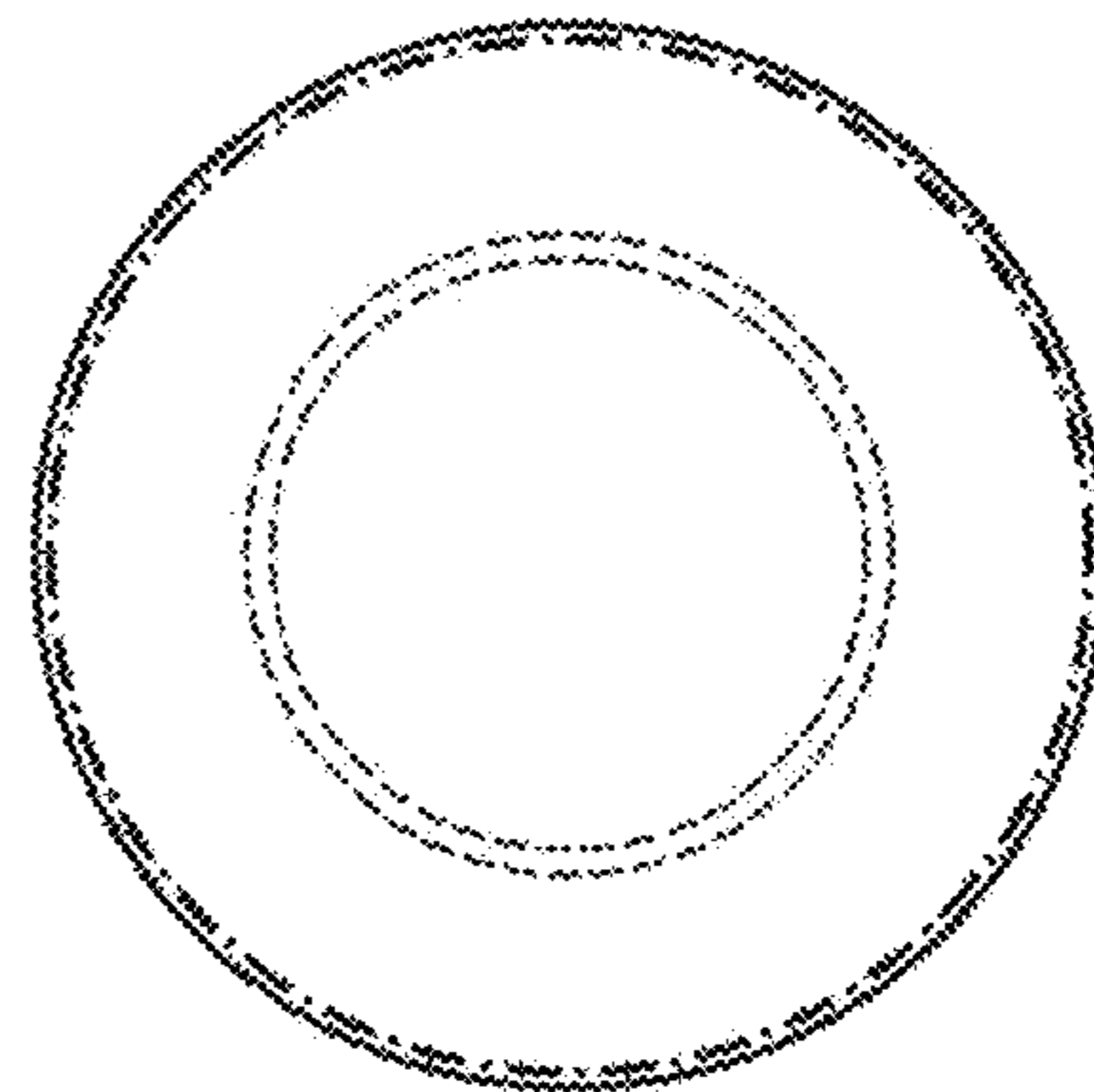
