(57) **CLAIM**

We claim the ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container in accordance with first embodiment of our new claimed design.

FIG. 2 is a top view of the container in FIG. 1.

FIG. 3 is a front view of the container in FIG. 1, the rear view being the same.

FIG. 4 is a bottom view of the container in FIG. 1.

FIG. 5 is a right side view of the container in FIG. 1, the left side view being the same.

FIG. 6 is a perspective view of a container in accordance with a second embodiment of our new claimed design.

FIG. 7 is a top view of the container in FIG. 6.

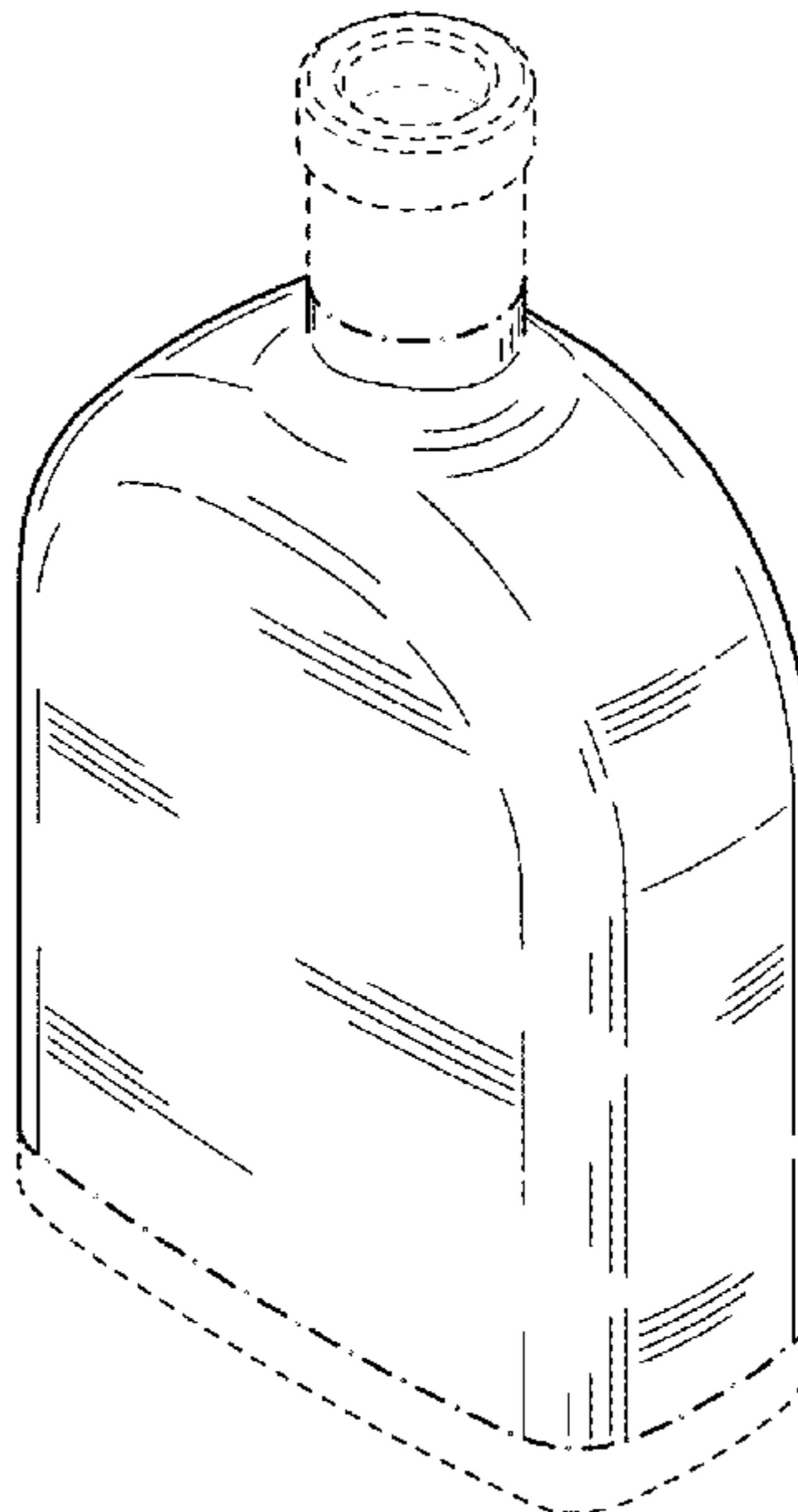
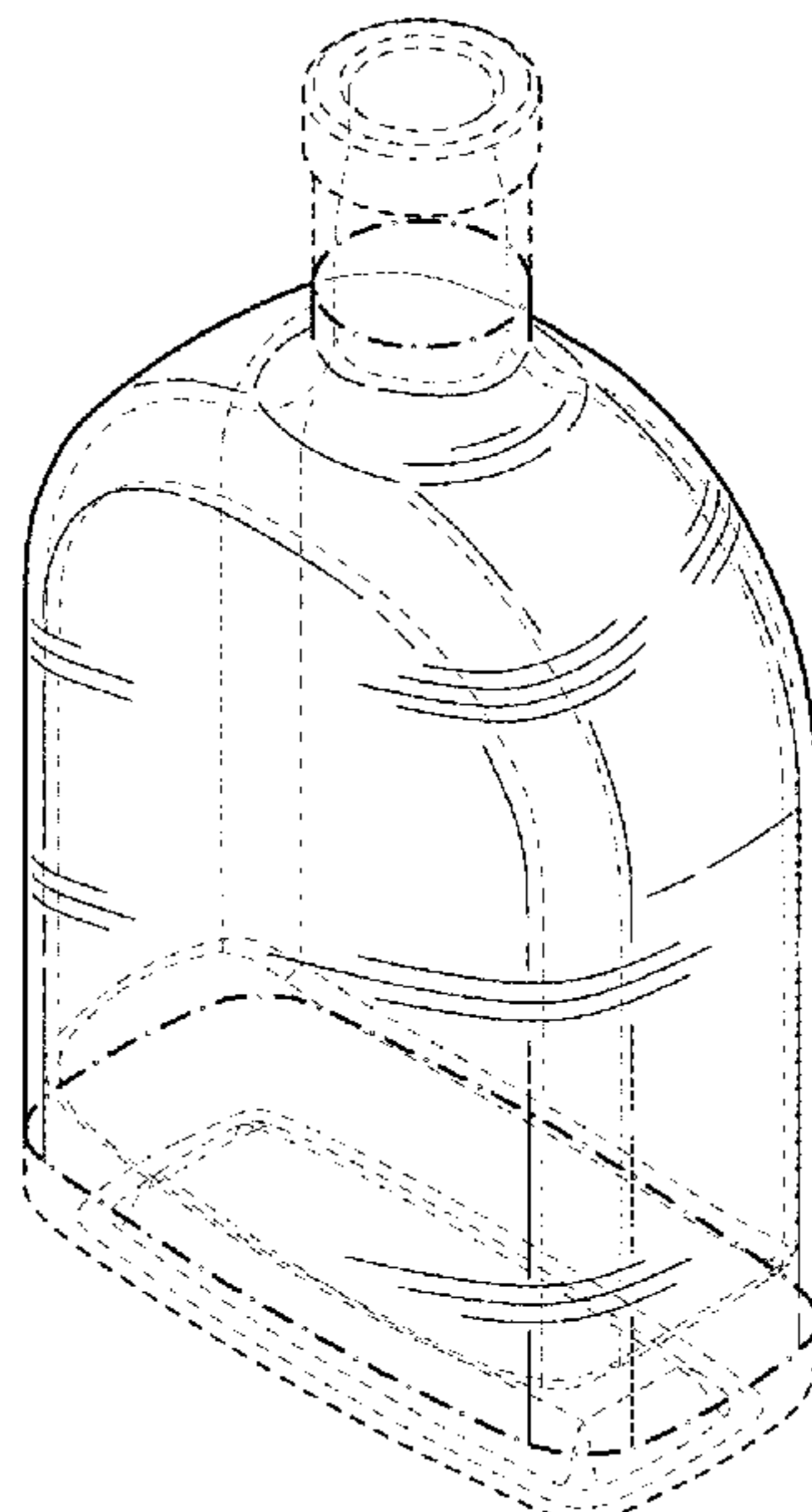
FIG. 8 is a front view of the container in FIG. 6, the rear view being the same.

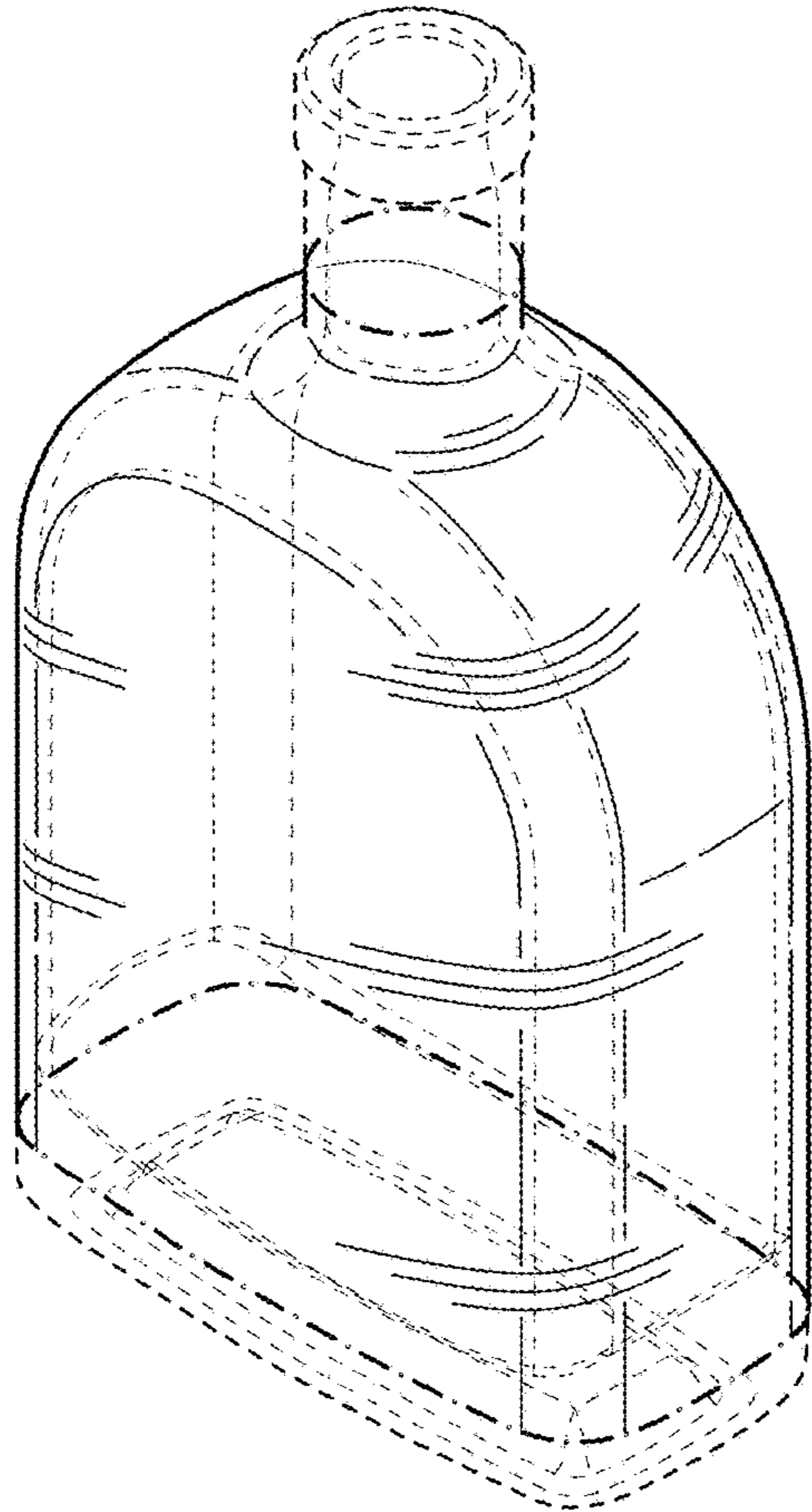

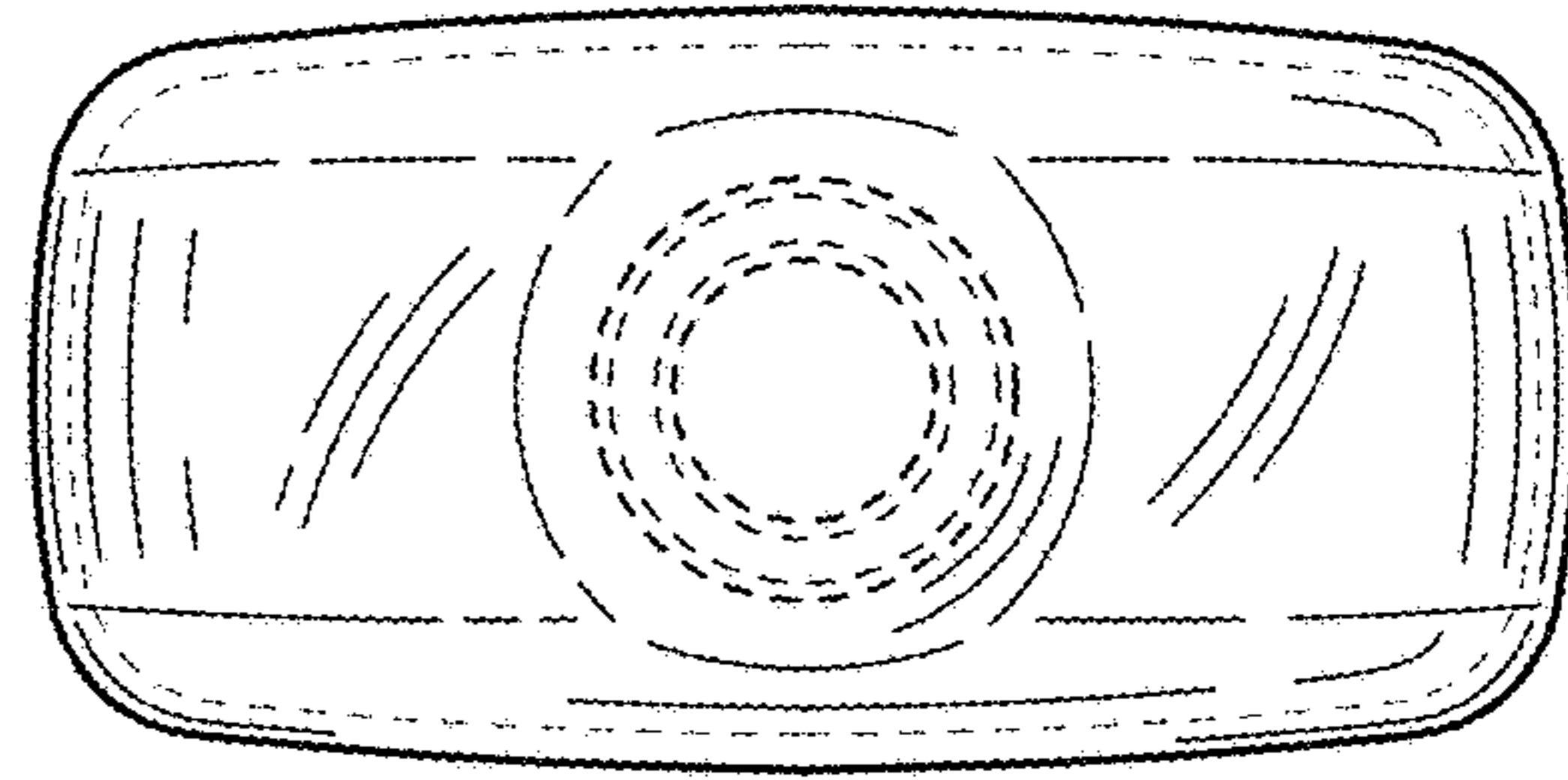

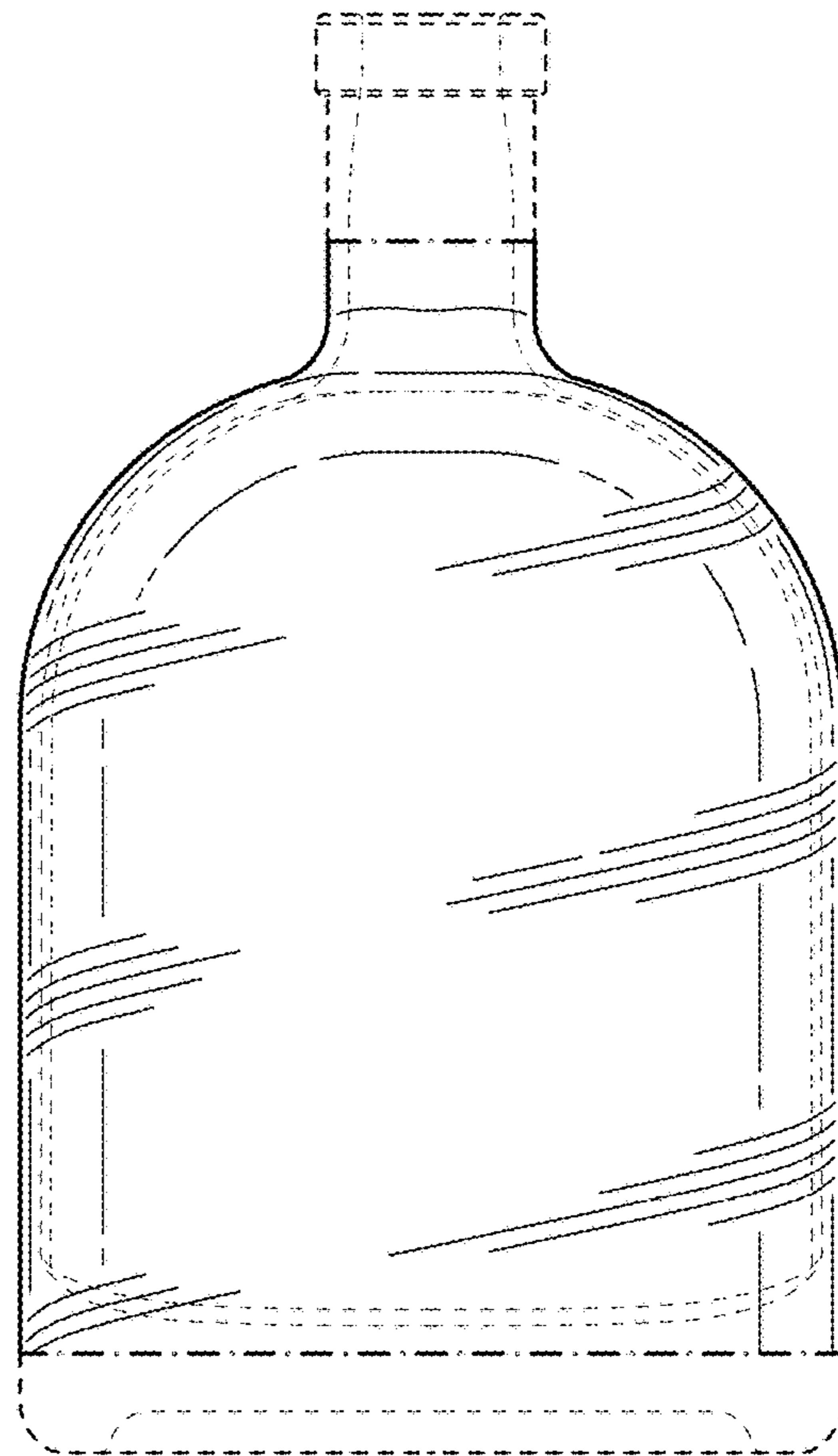

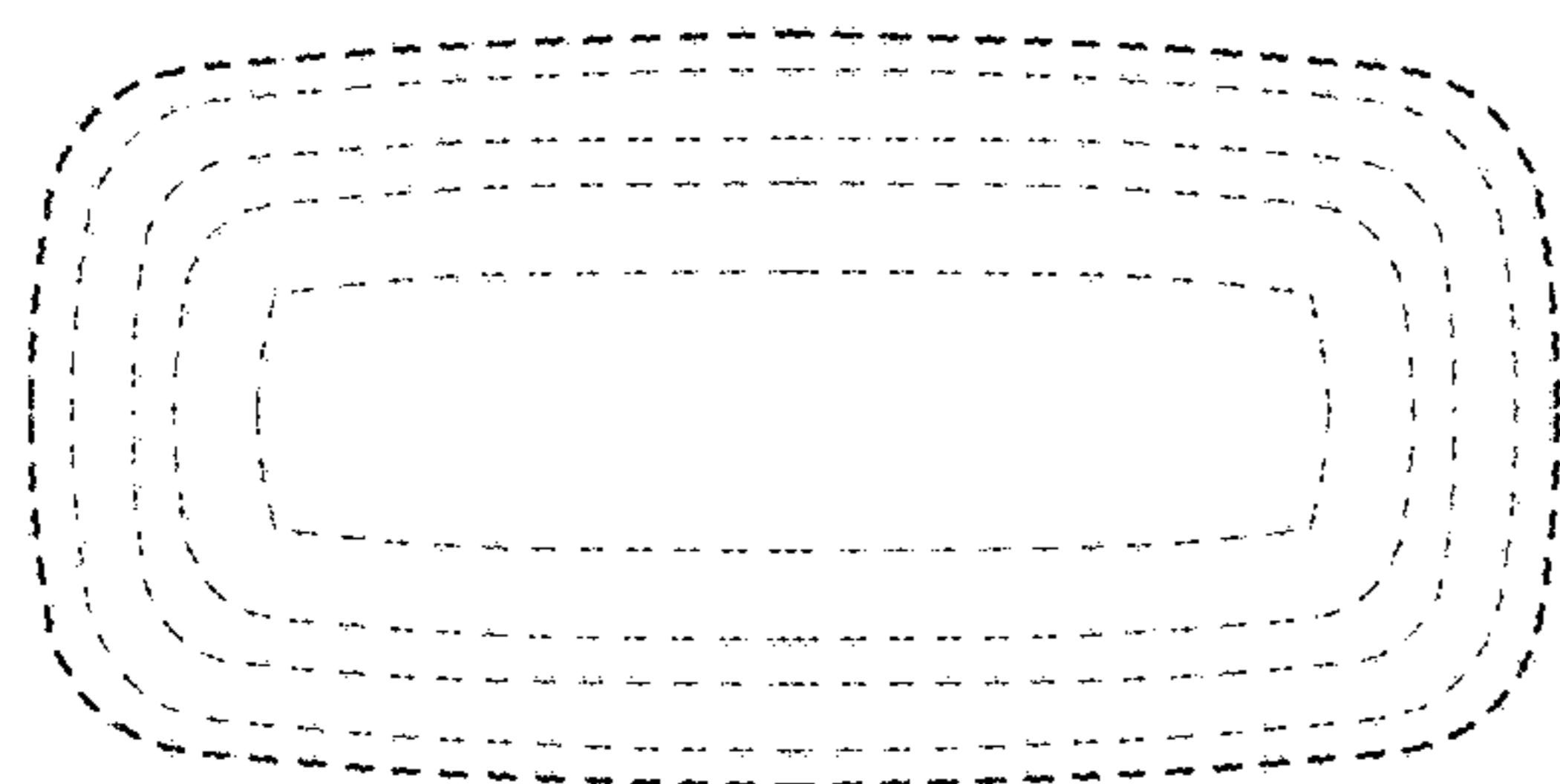

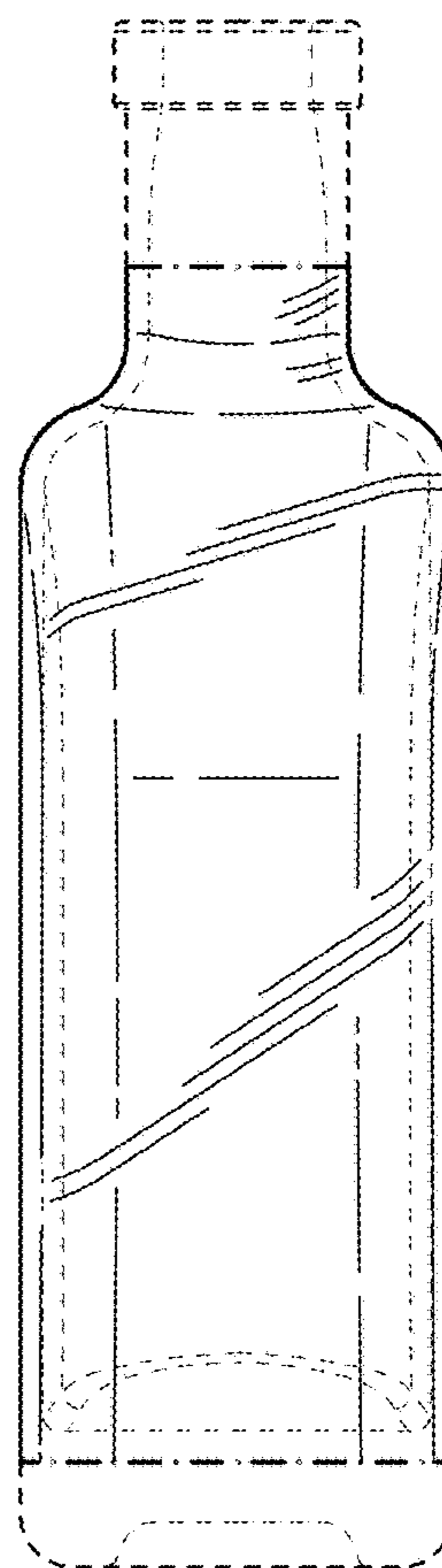

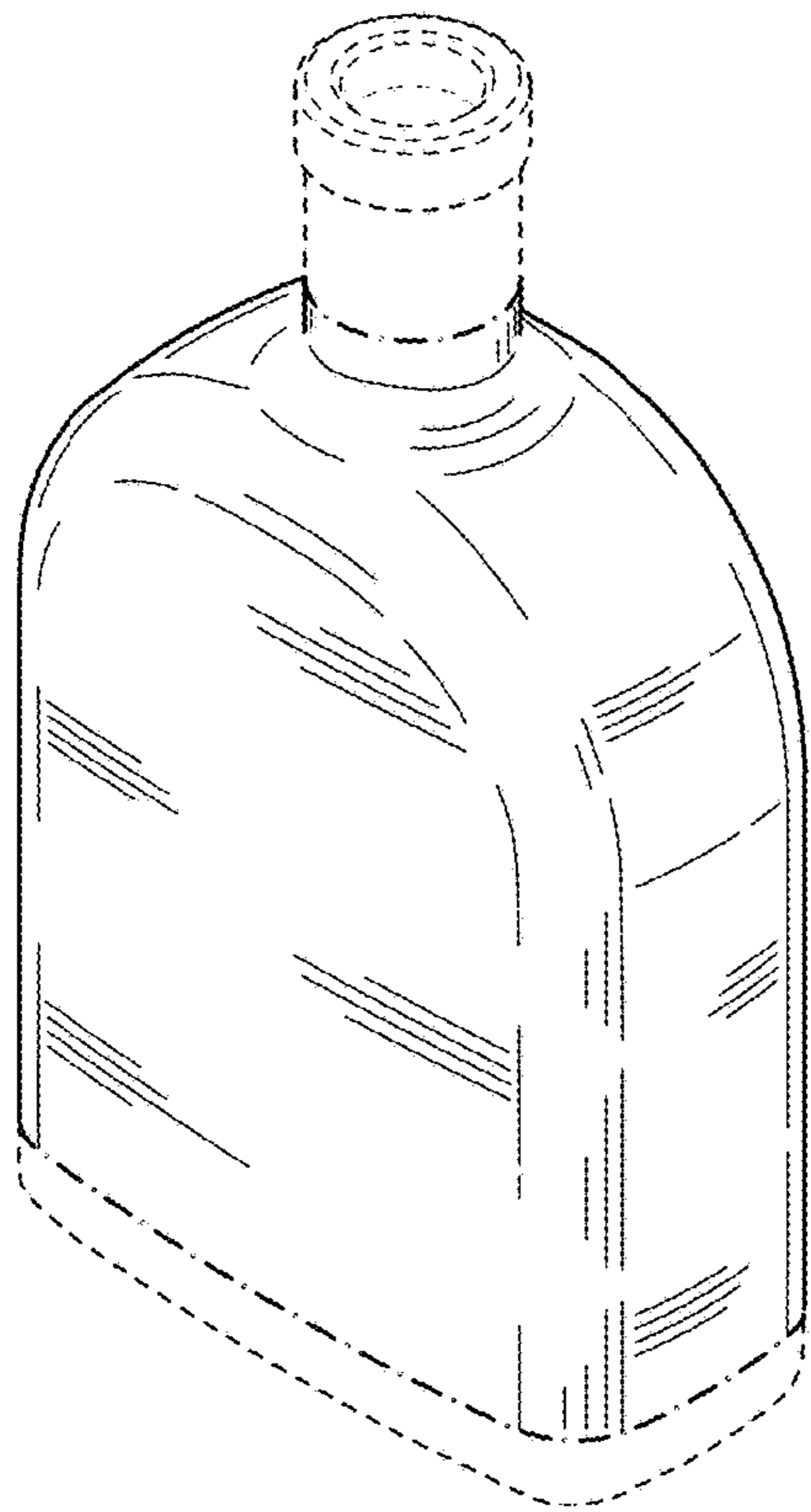

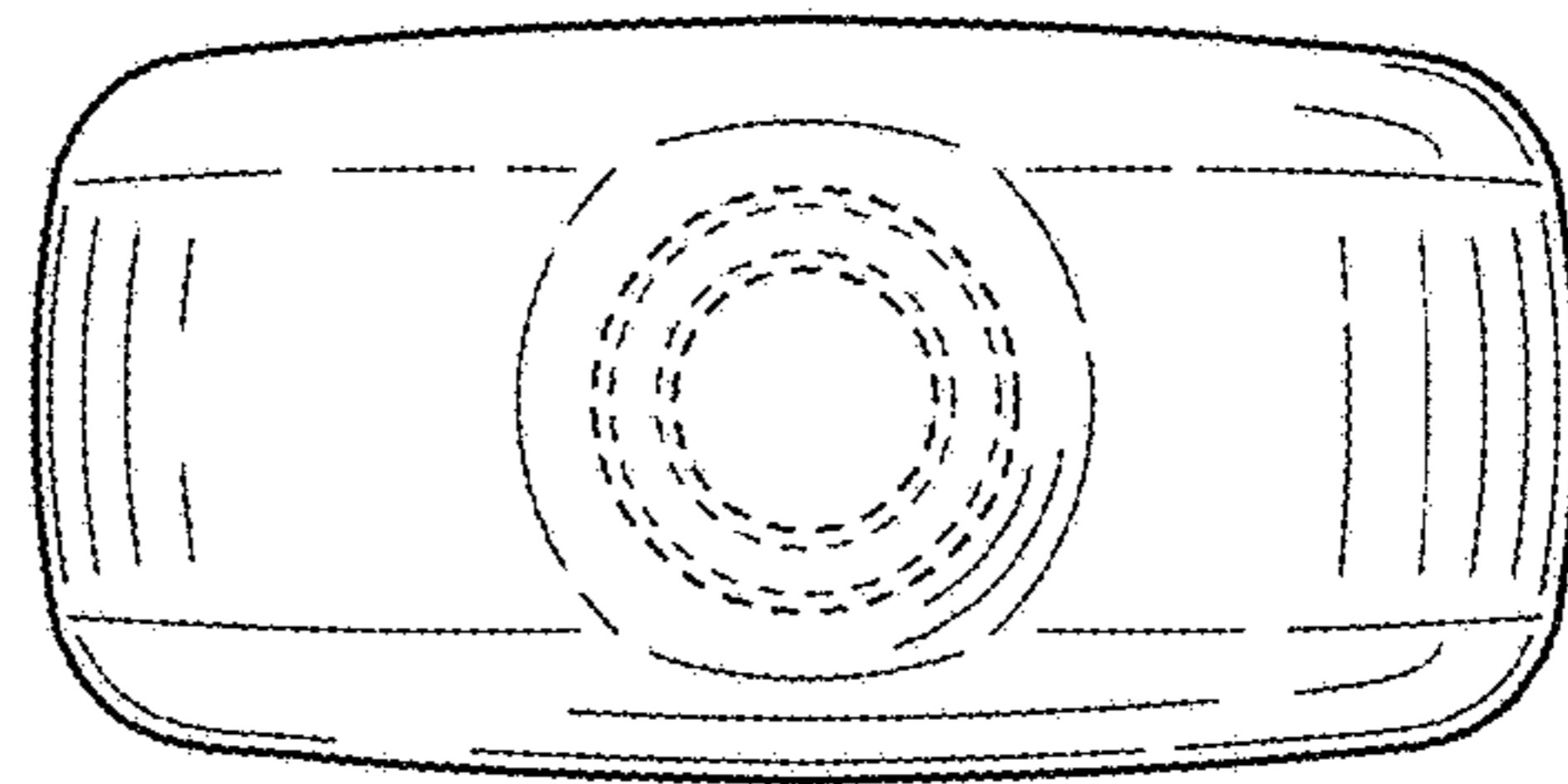

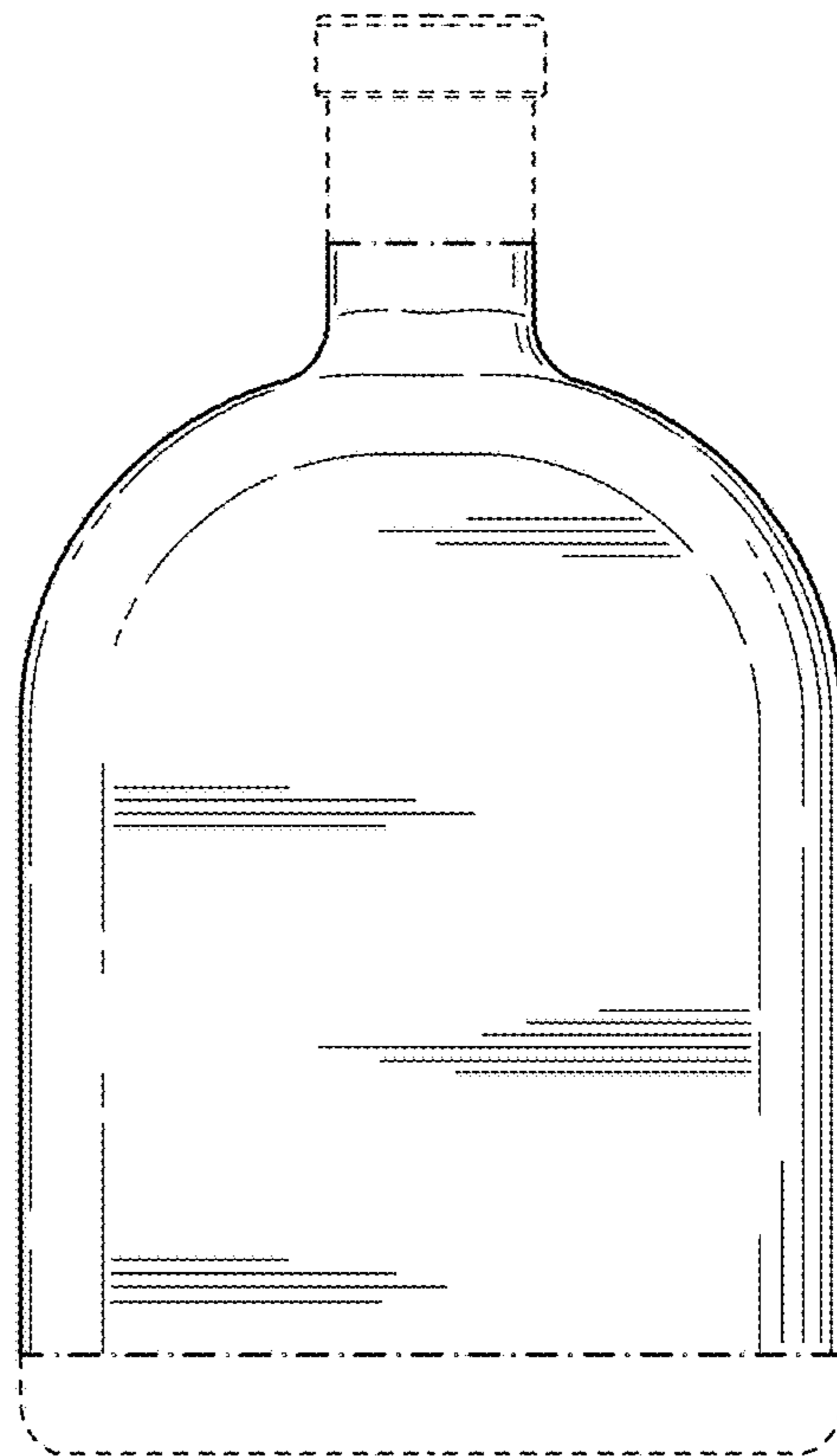

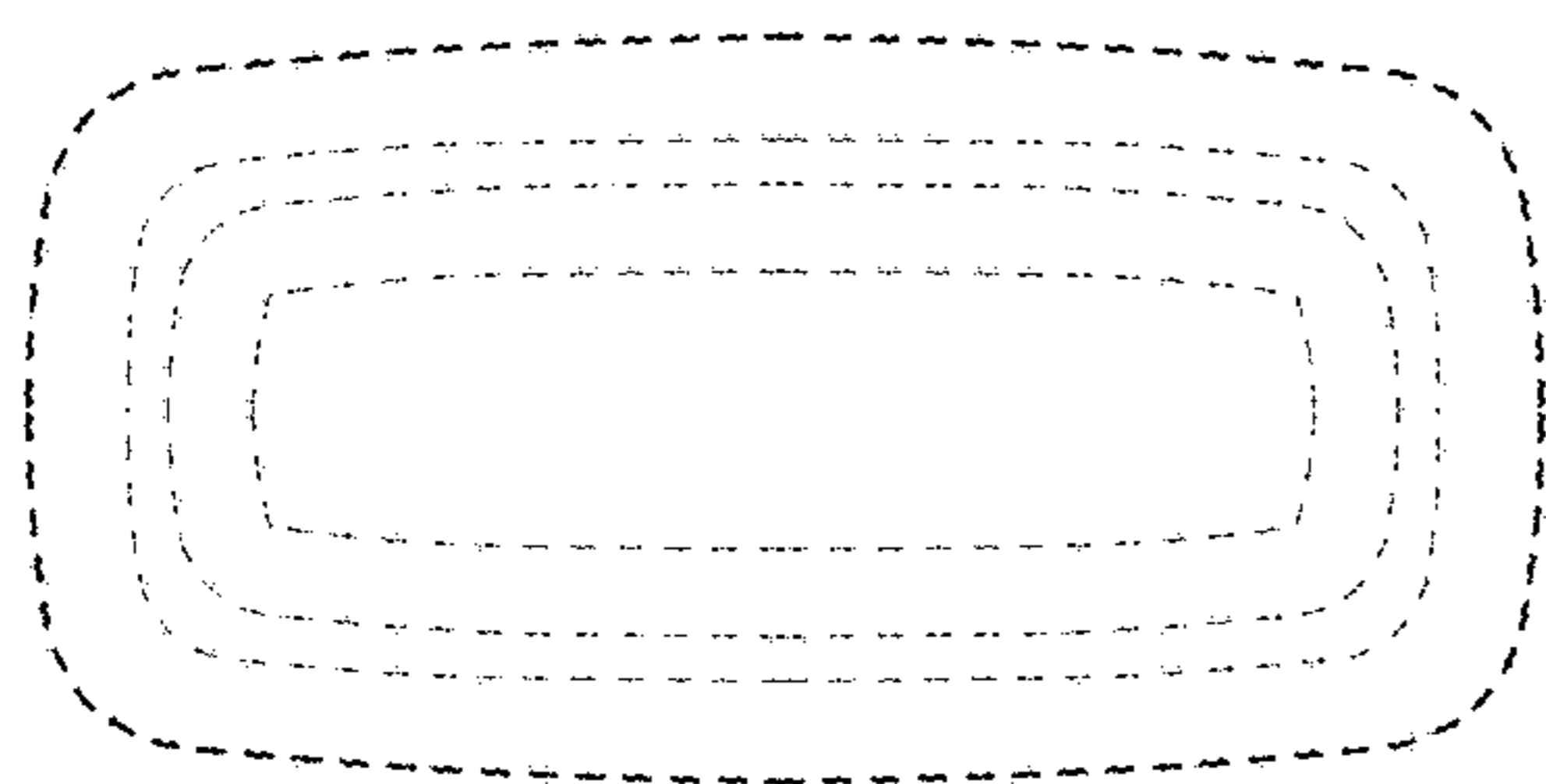

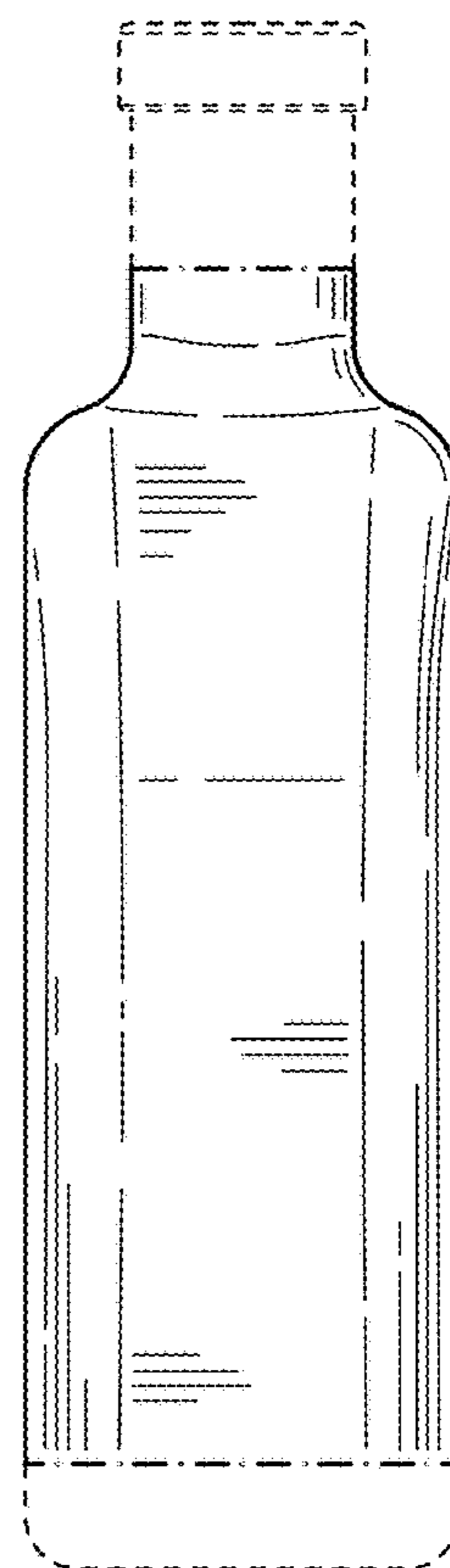
