The ornamental design for a wine bottle, as shown.

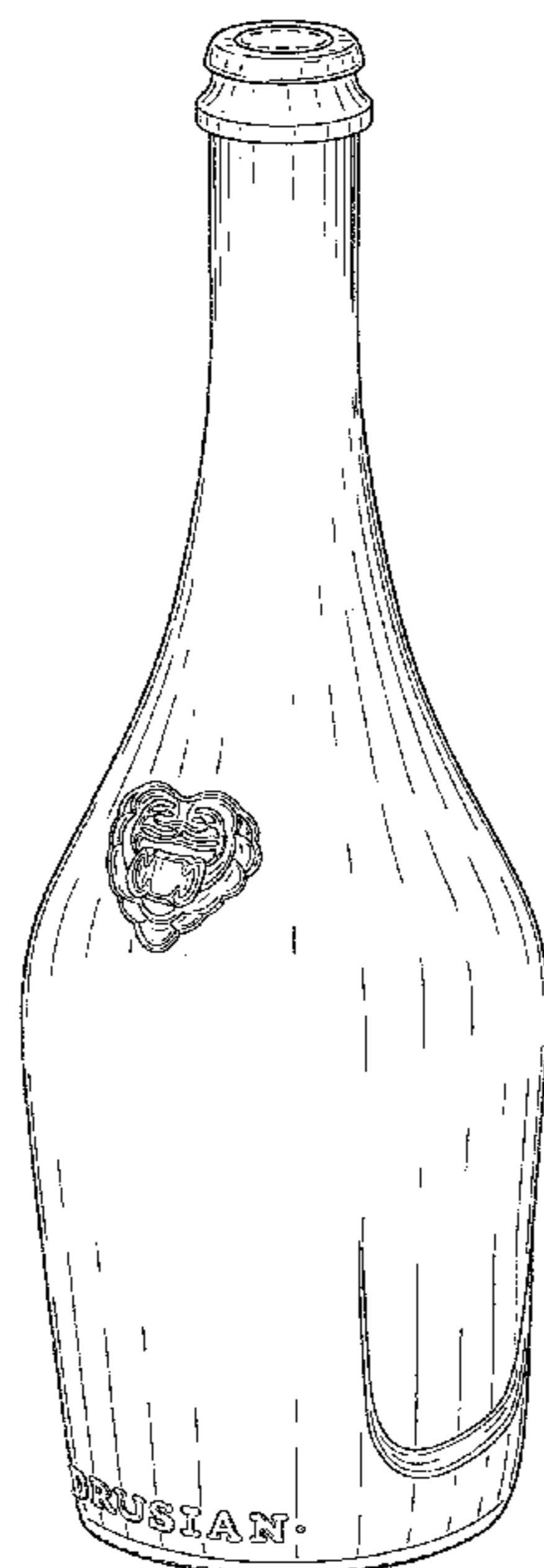
DESCRIPTION

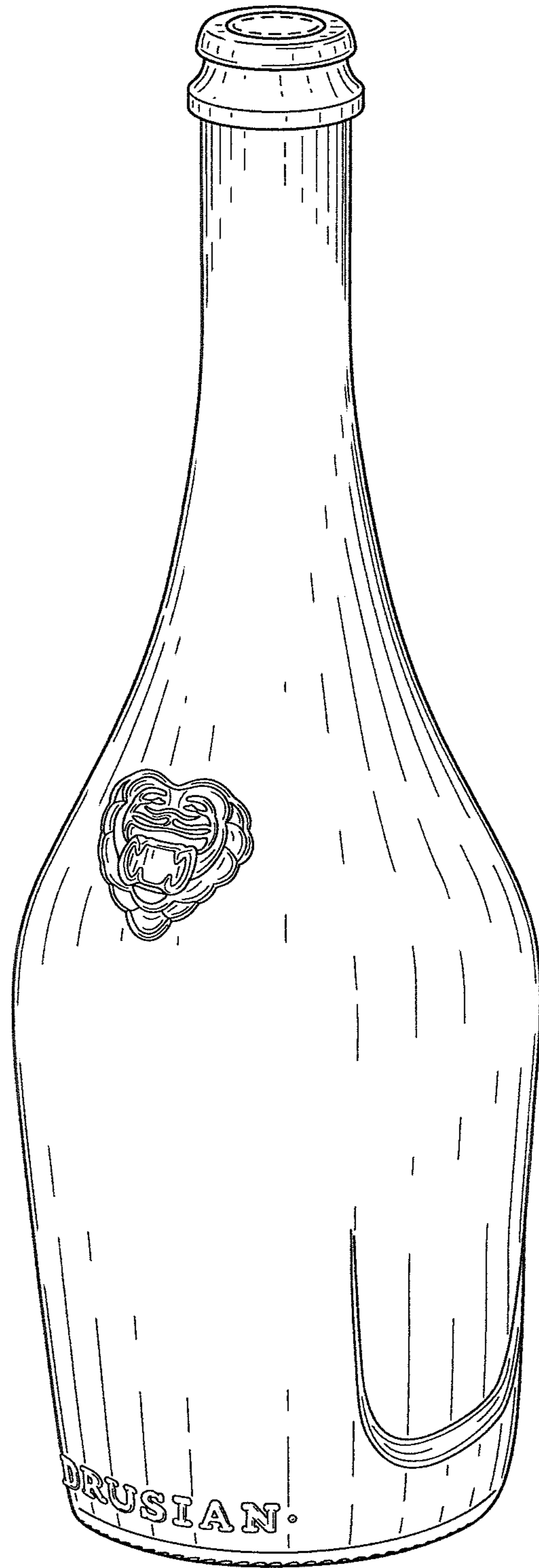

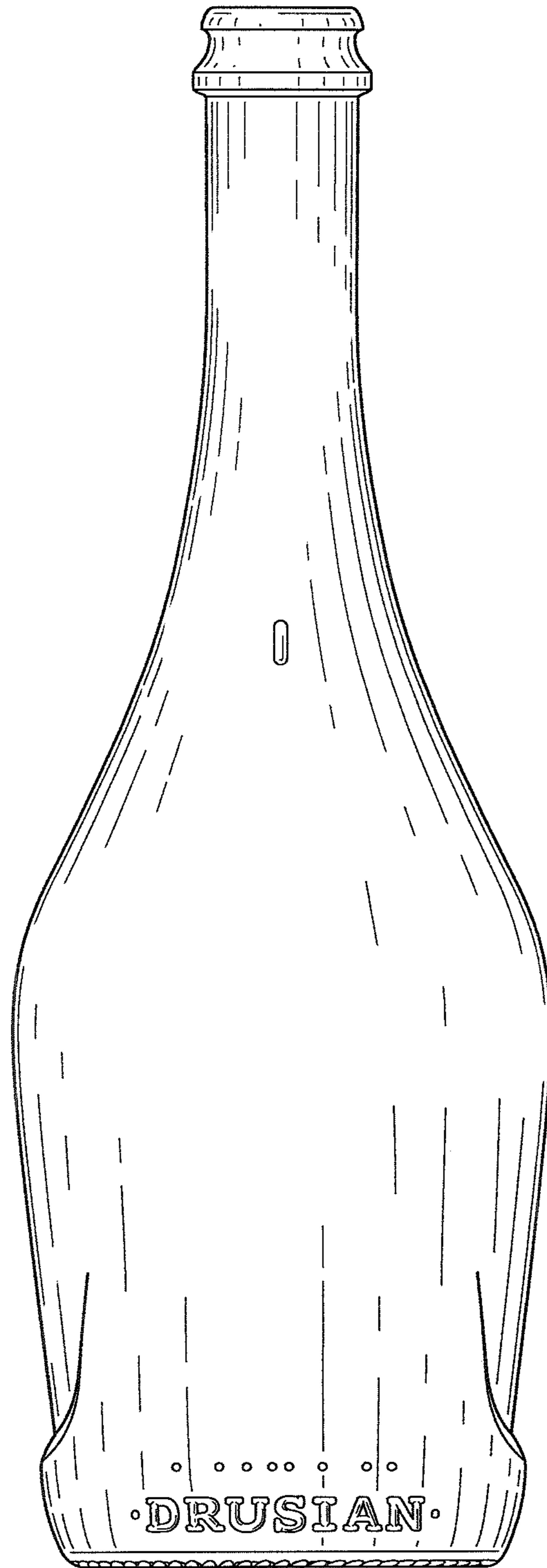

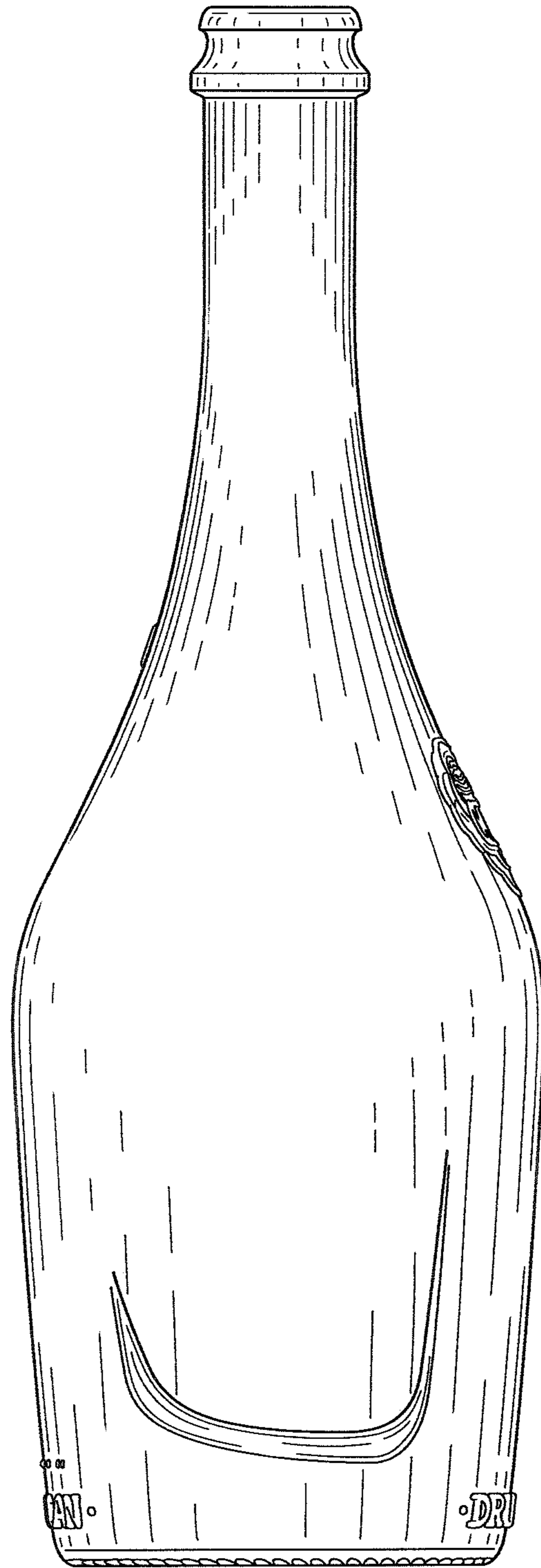

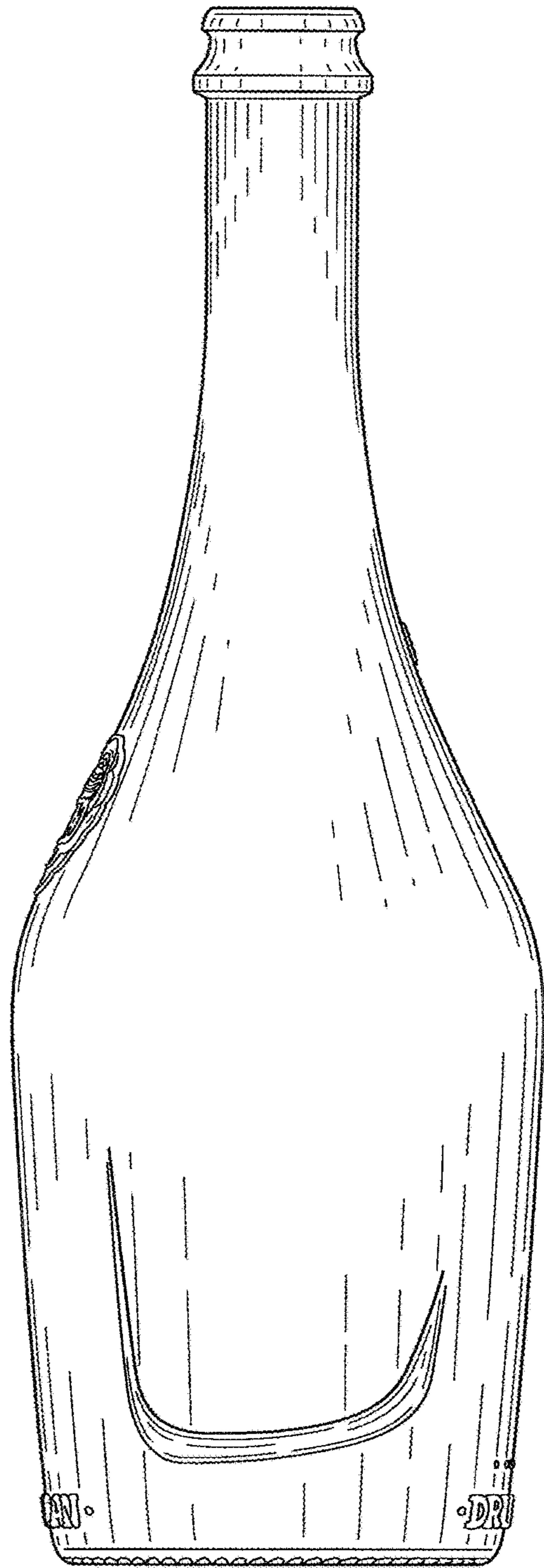

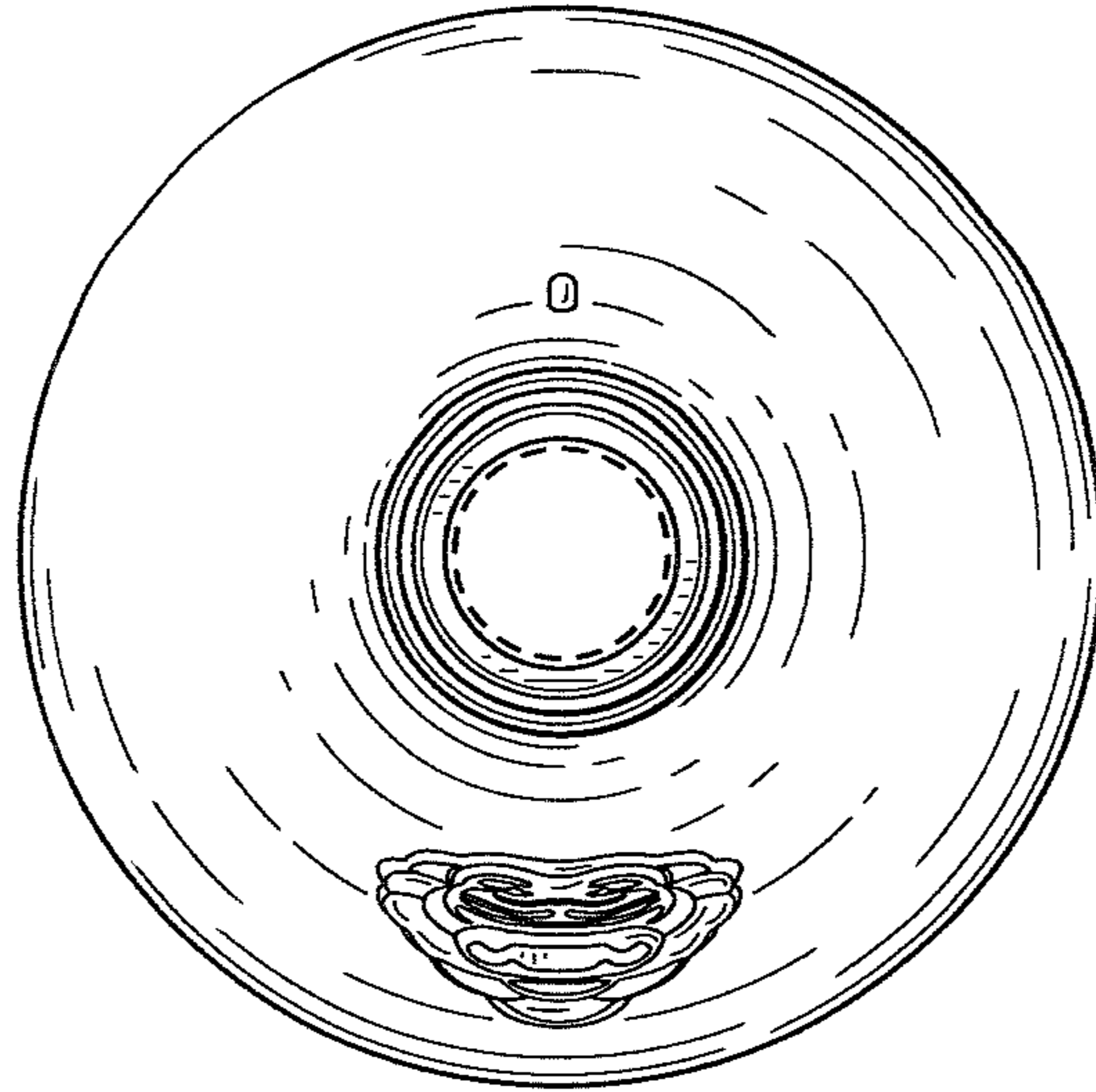

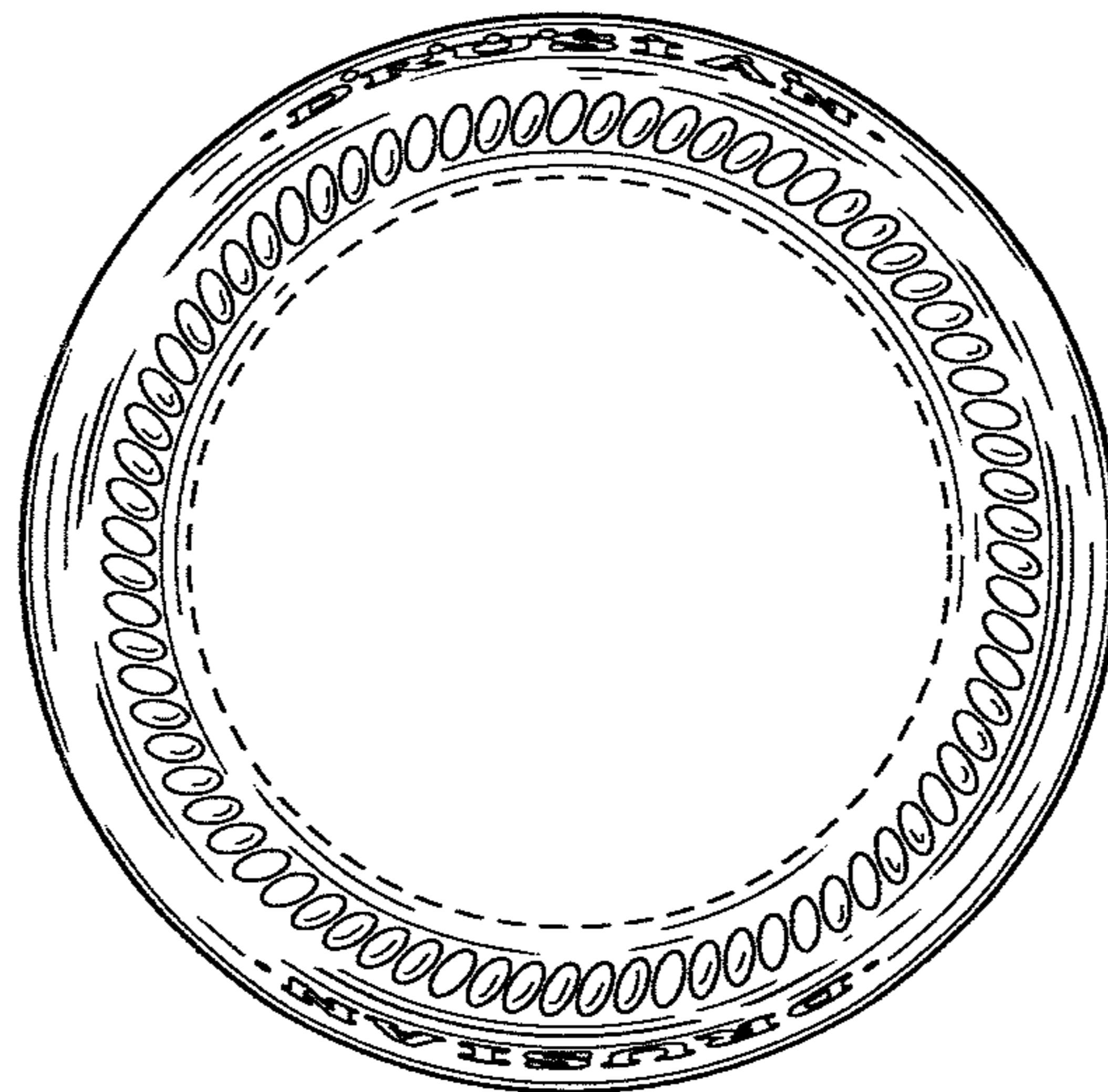
