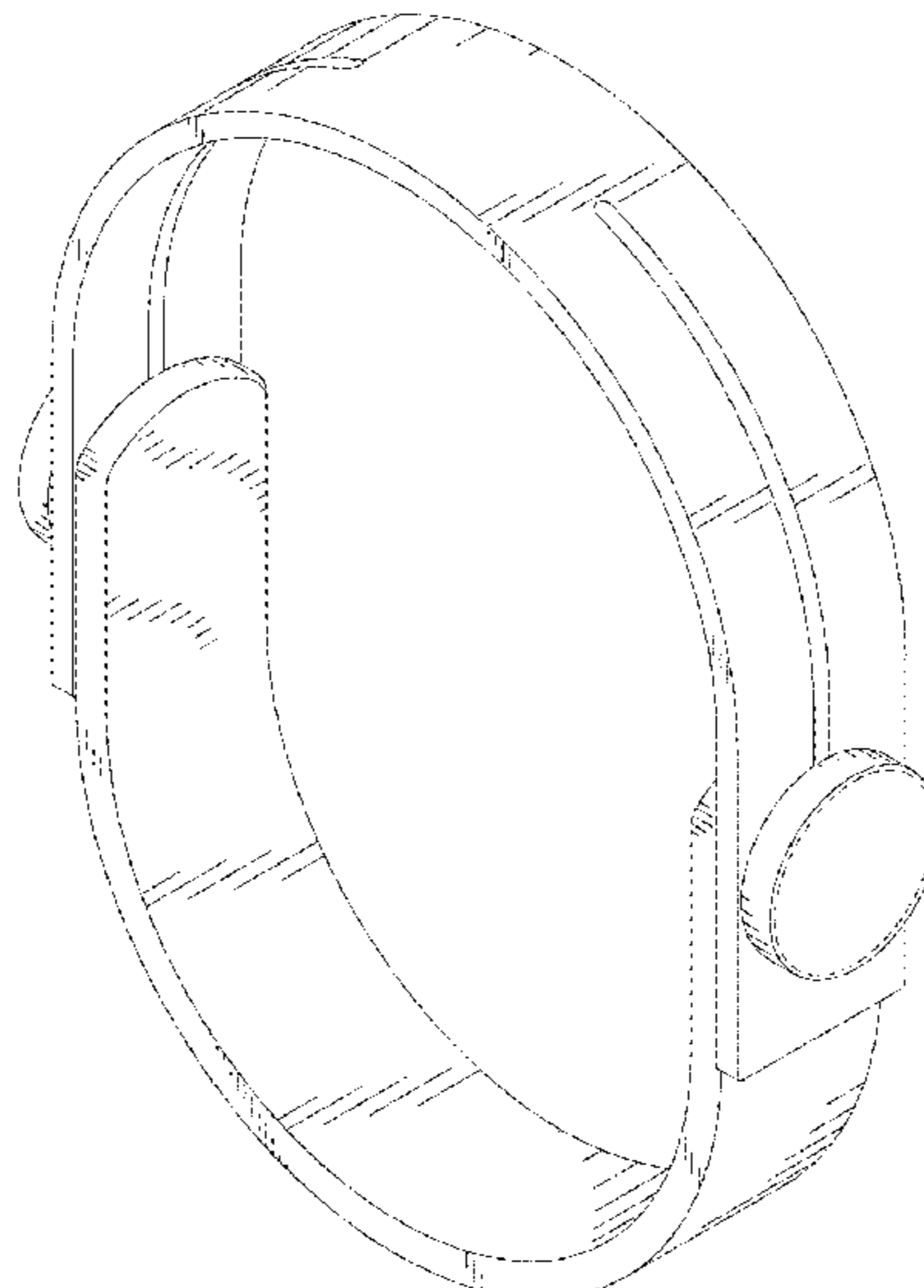
(57) **CLAIM**

The ornamental design for a spur bracelet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the spur bracelet; FIG. 2 is a front elevation view thereof; the rear elevation view being a mirror image thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevation view thereof; the left side being a mirror image thereof; FIG. 5 is a bottom plan view thereof; and, FIG. 6 is another perspective view thereof, showing the spur bracelet of FIG. 1 in a configuration of use. The broken lines shown in the drawings illustrate portions of the spur bracelet that form no part of the claimed design. The broken lines in FIG. 6 showing the spur bracelet in use illustrates environment and forms no part of the claim.

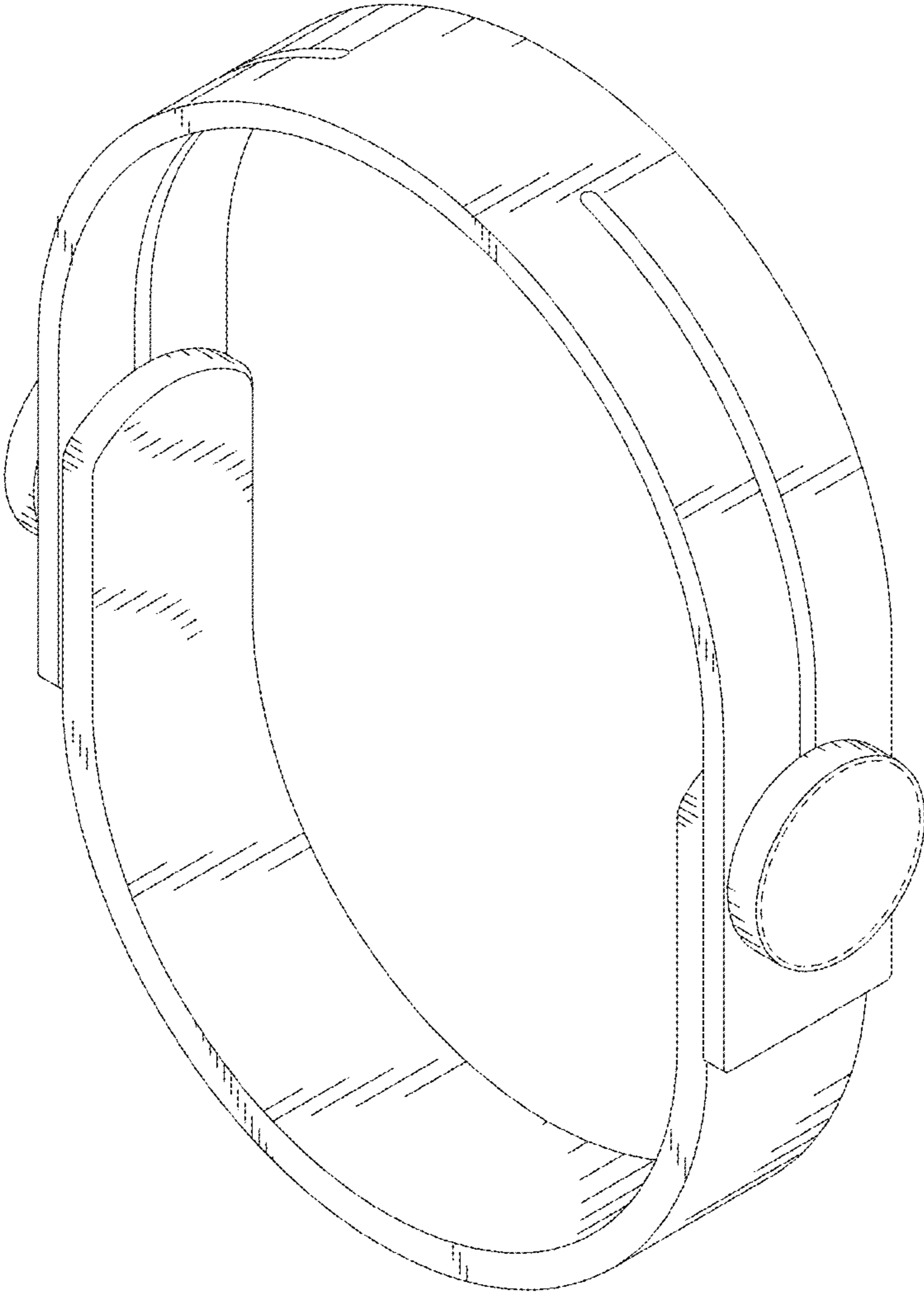

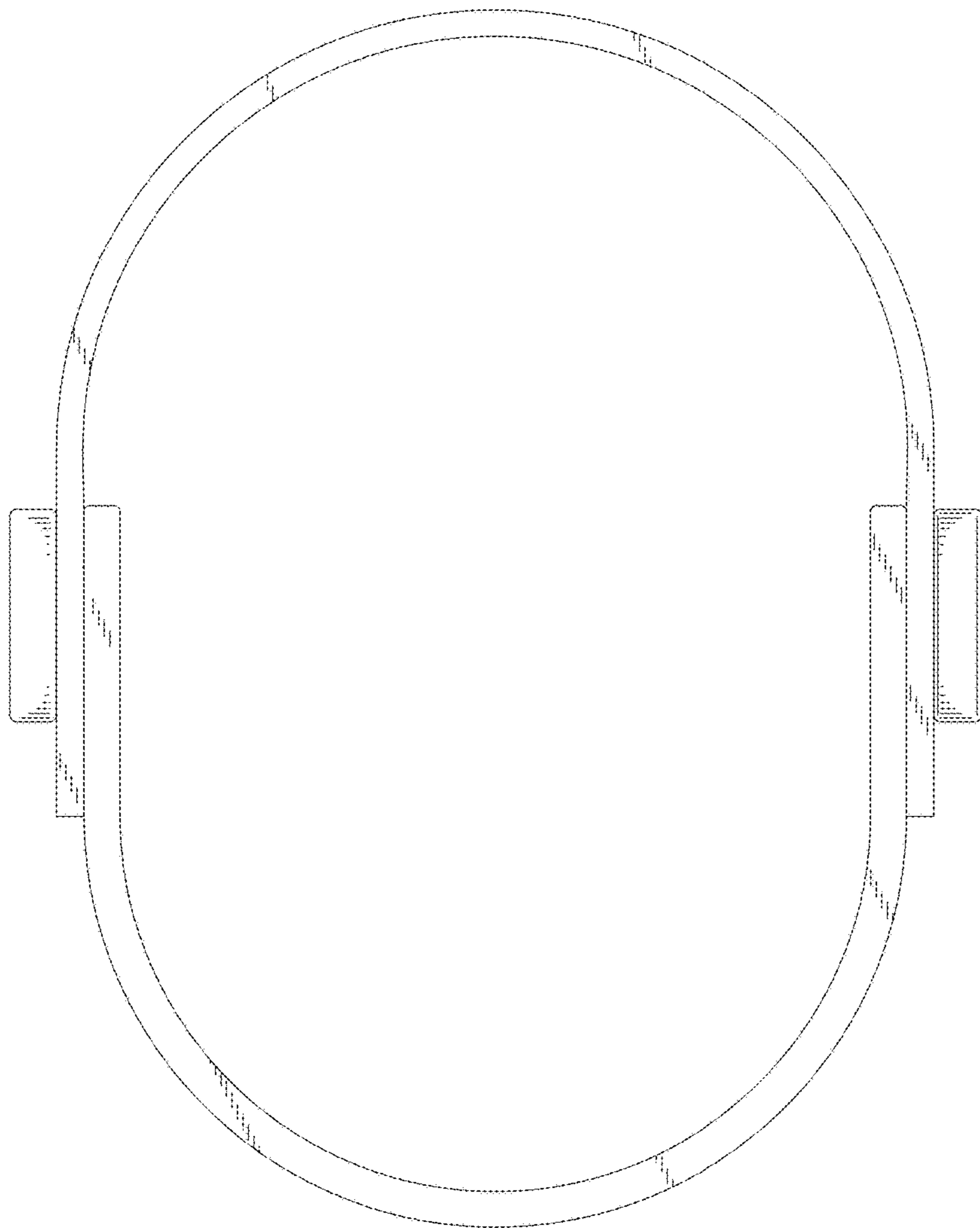

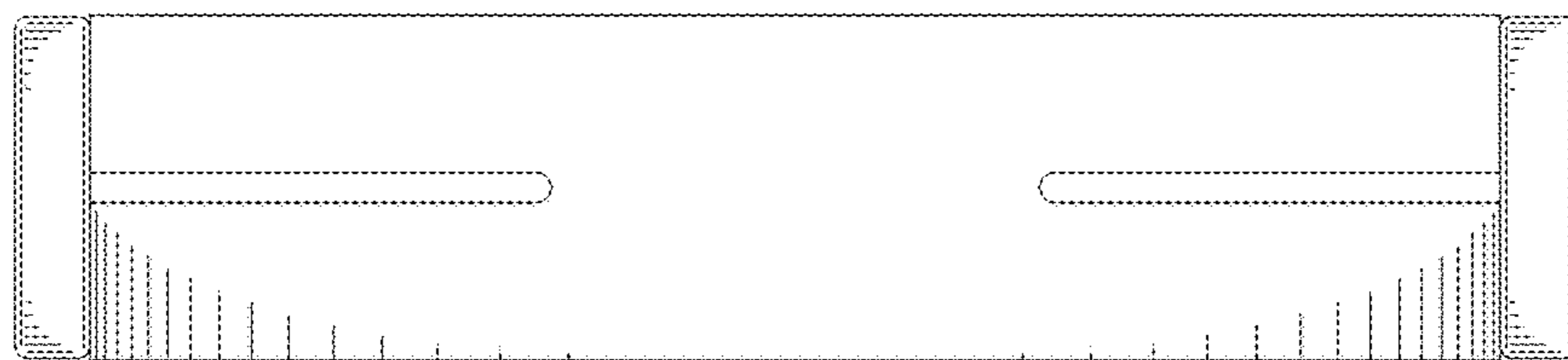

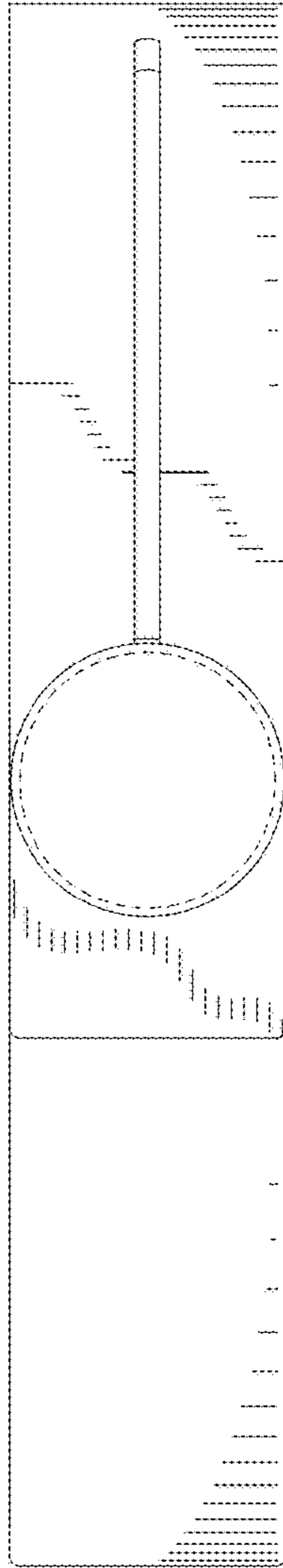

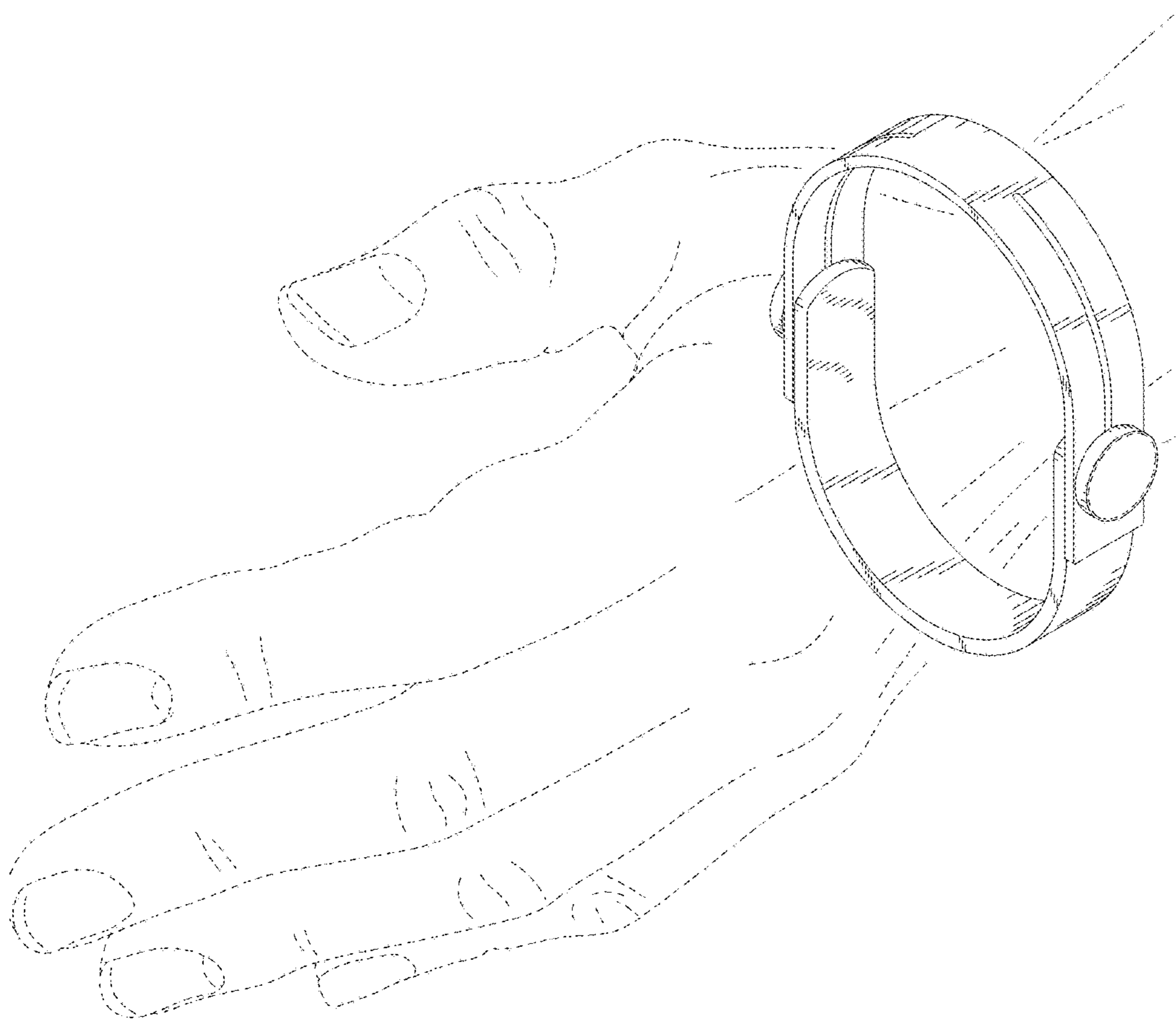
