(57) **CLAIM**

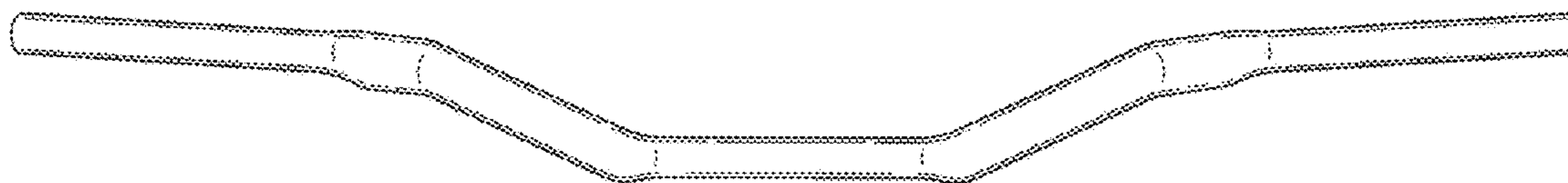
The ornamental design for a handlebar, as shown and described.

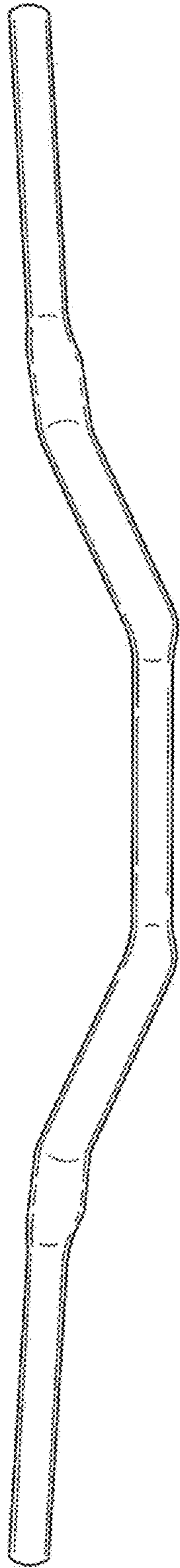
**DESCRIPTION**

FIG. 1 is a front elevation view of a handlebar showing my new design;  
FIG. 2 is a rear elevation view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a right side elevation view thereof; and,  
FIG. 6 is a left side elevation view thereof.

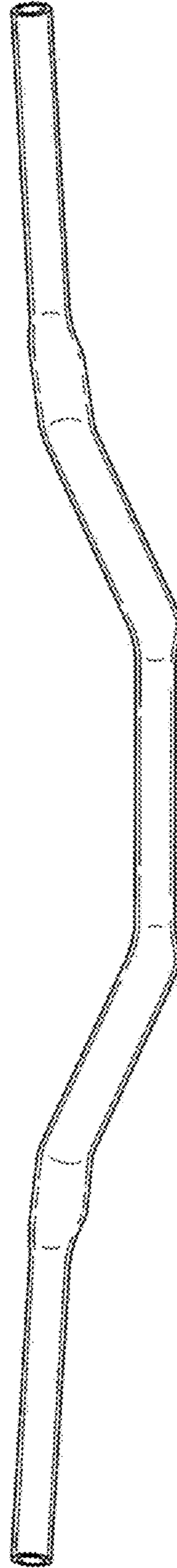
The handlebar embodying the design consists of a base portion, two outer gripping portions, and two transition portions, wherein the base portion and the gripping portions have narrower diameters than the transition portions therebetween.

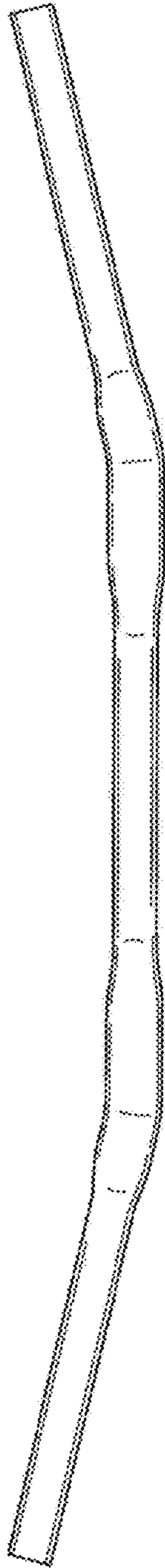

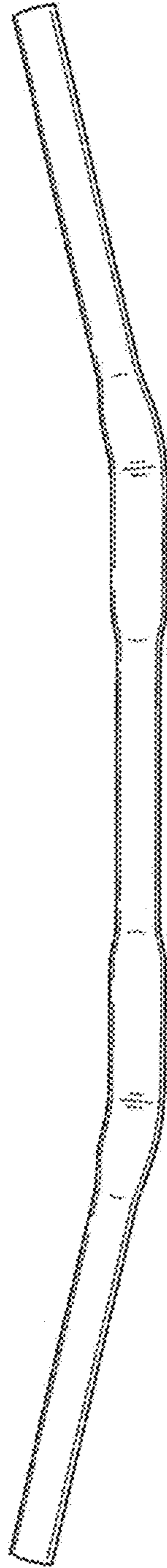

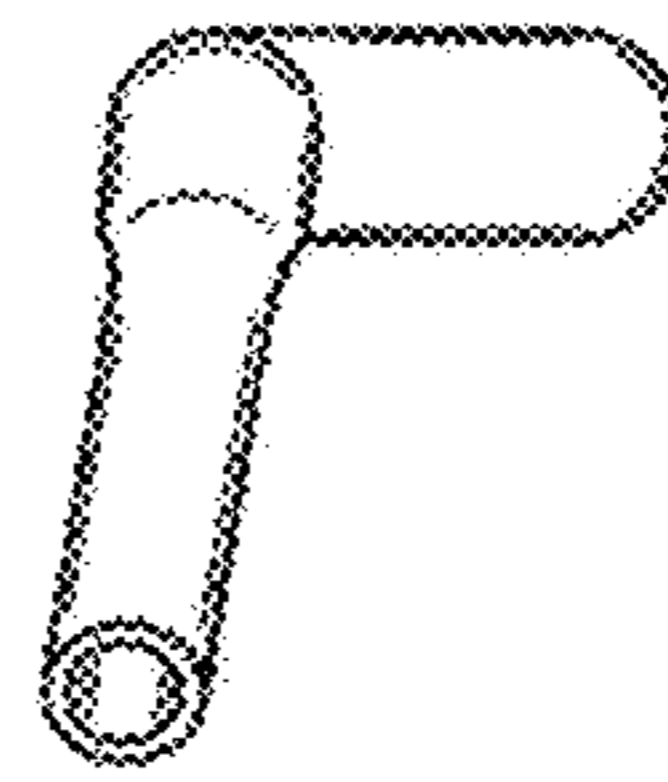

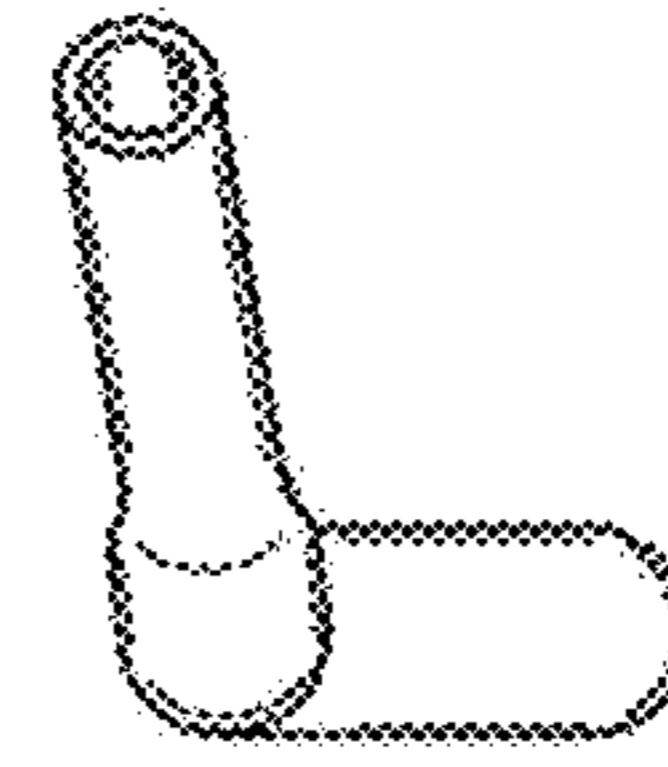
