DESCRIPTION

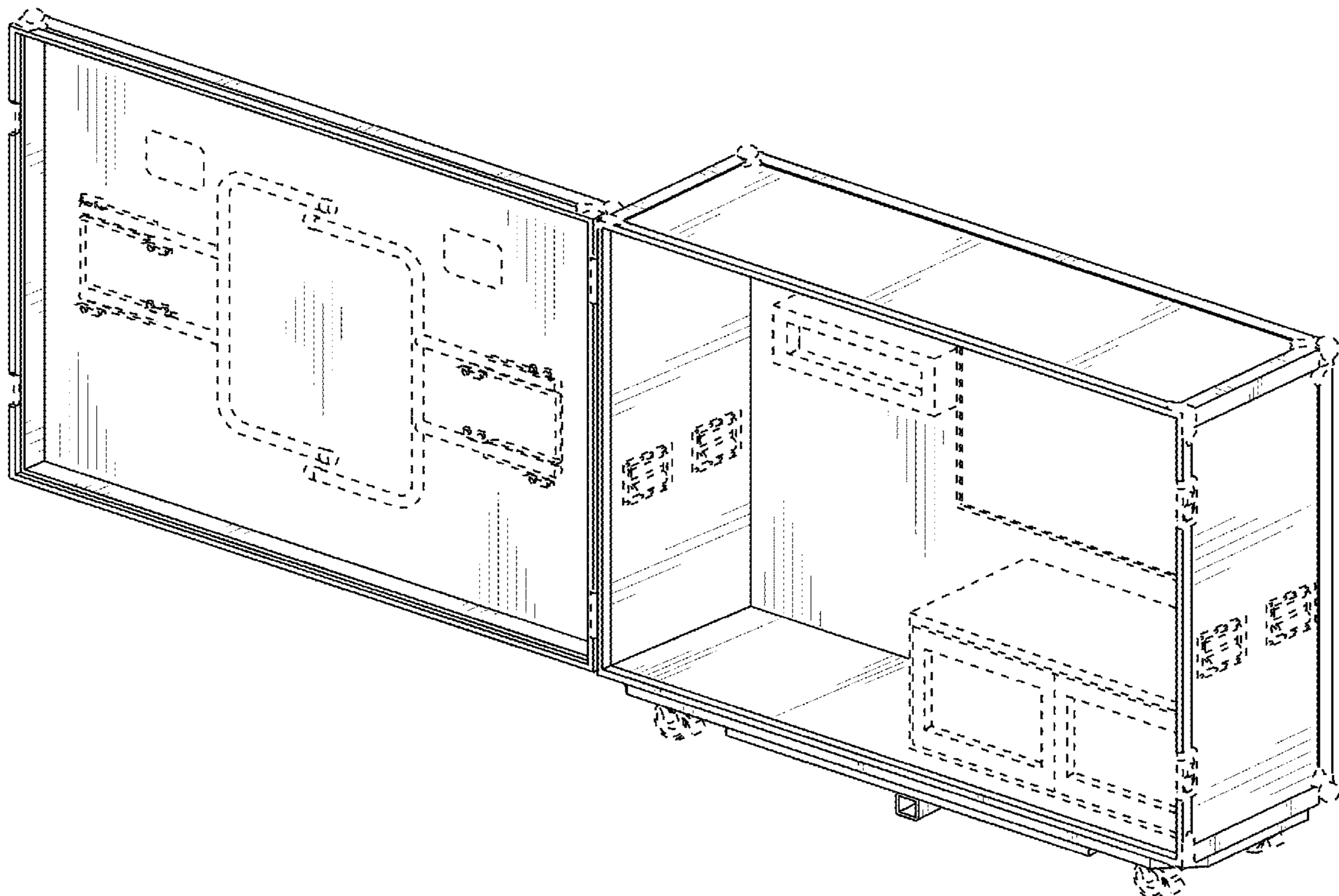
FIG. 1 is a perspective view of a tailgate trunk;

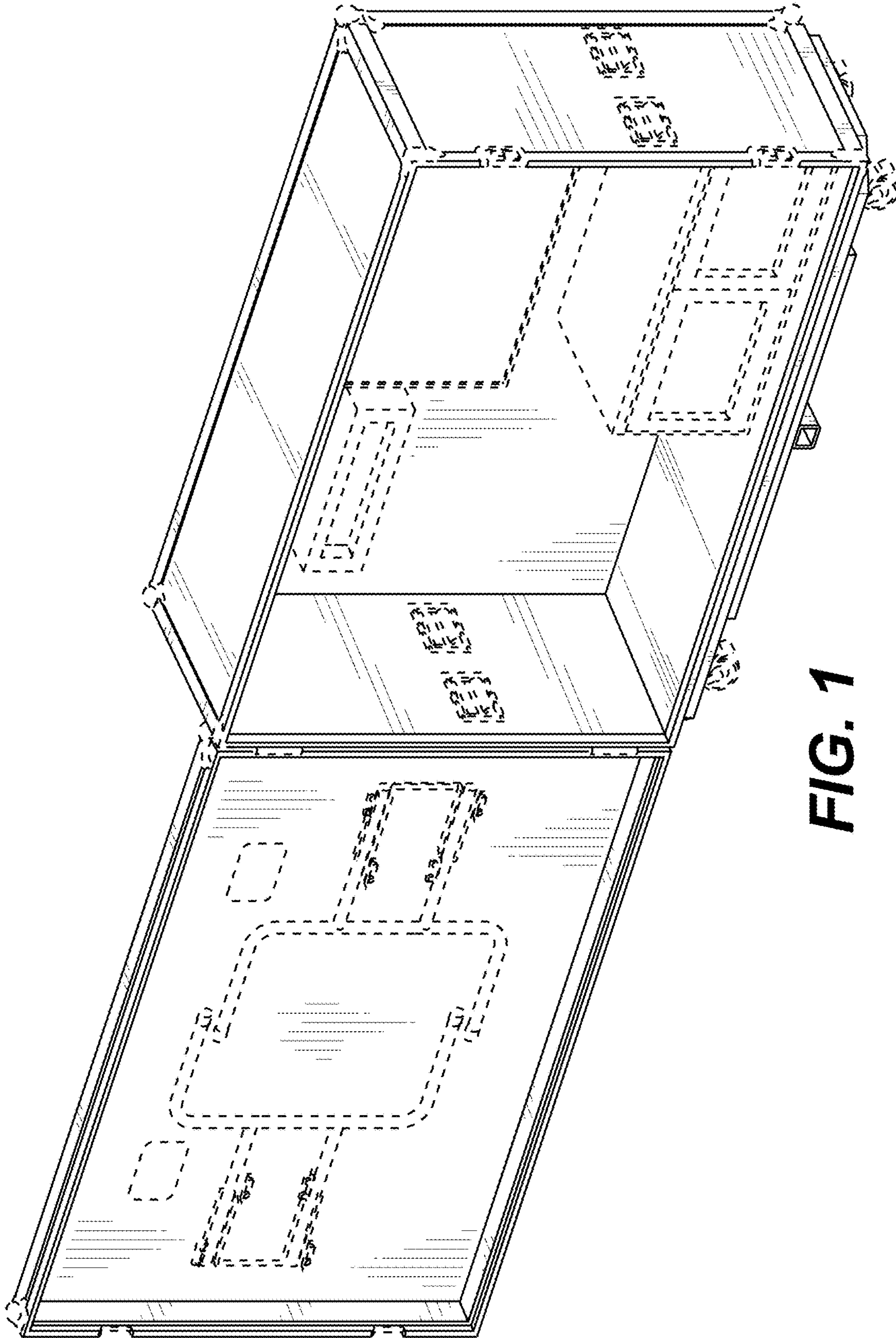

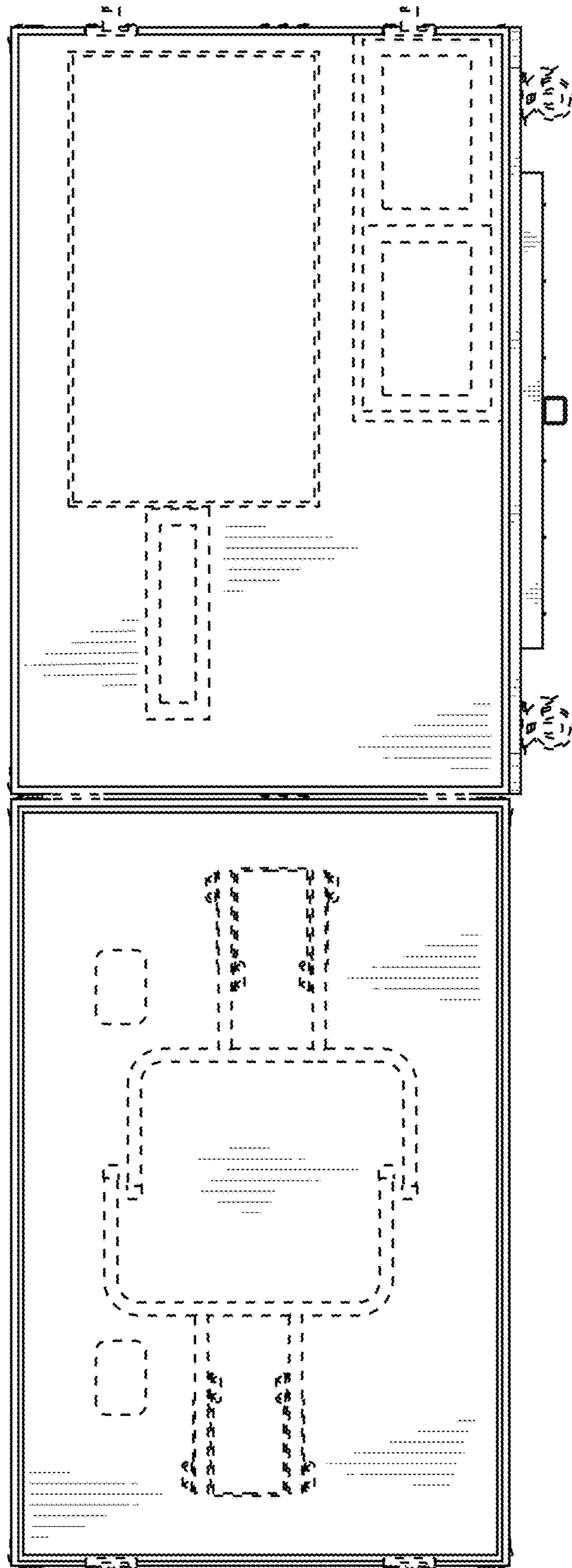

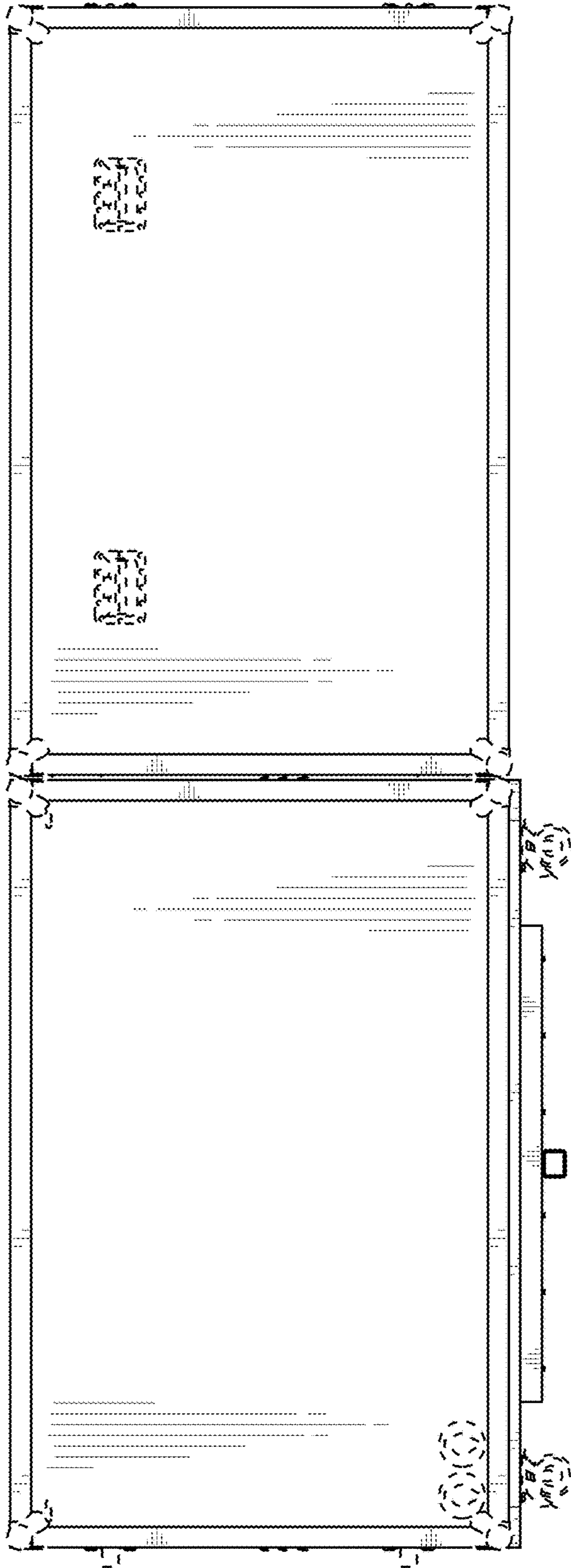

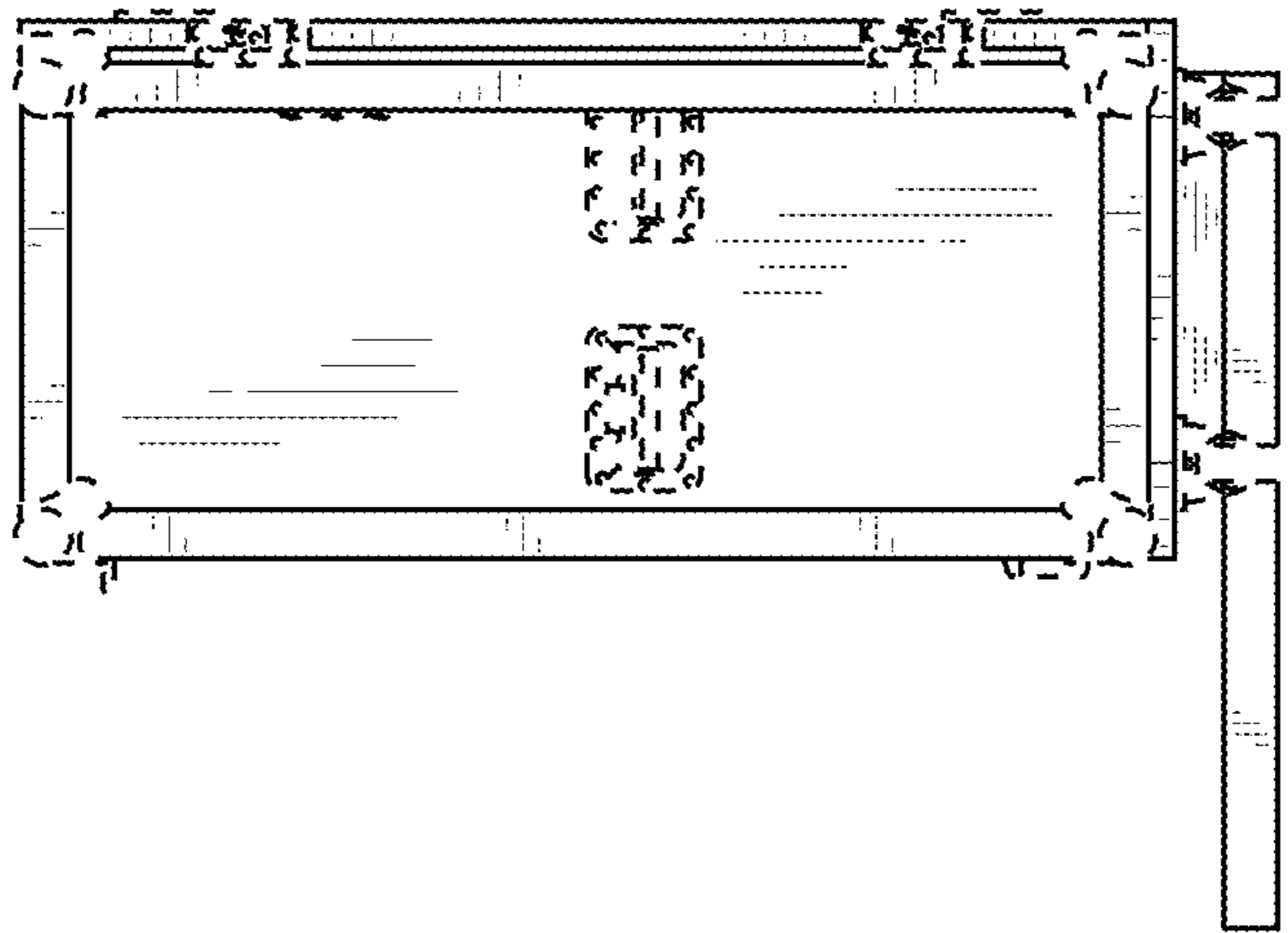

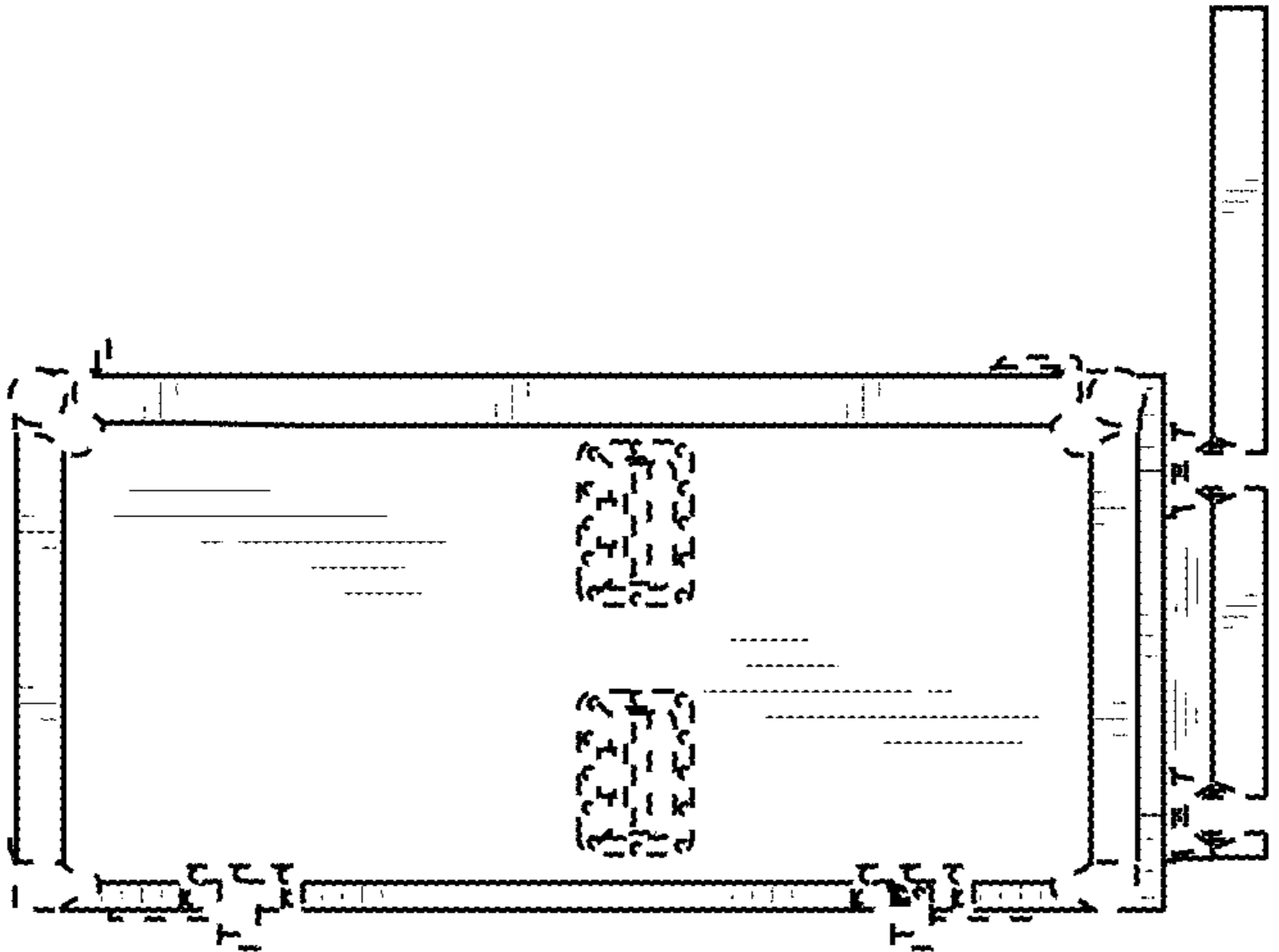

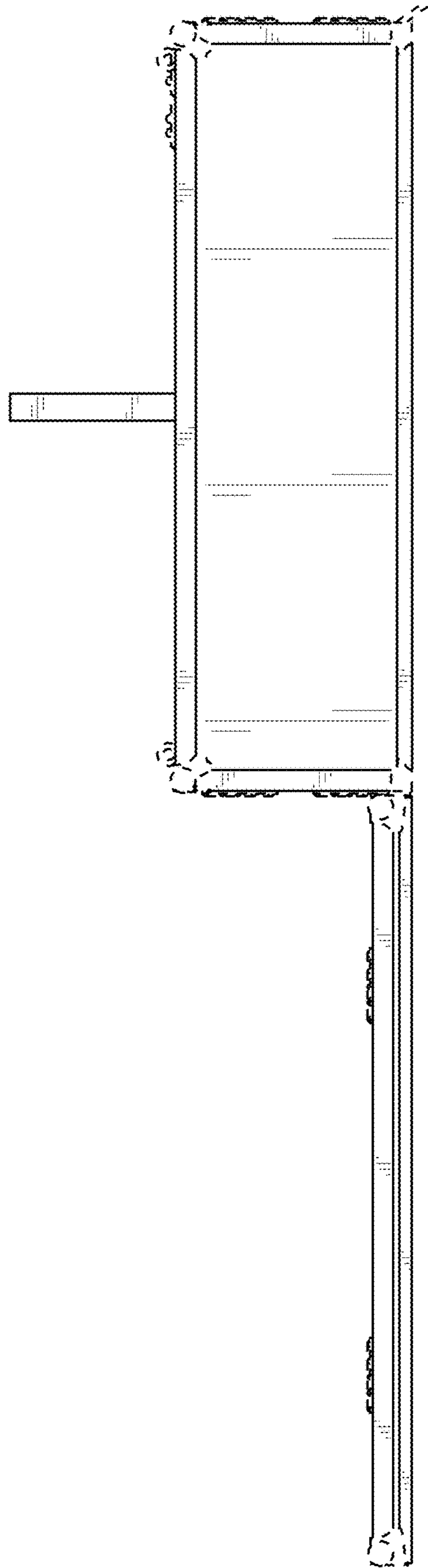

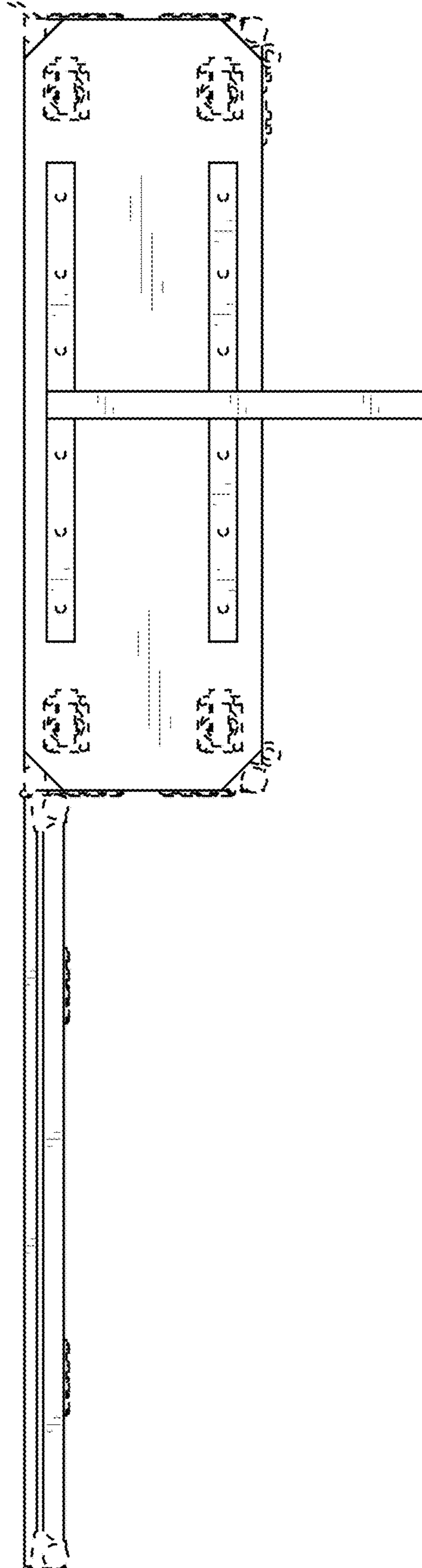
