FIG. 4 is a rear view of the earshaped ear pad;

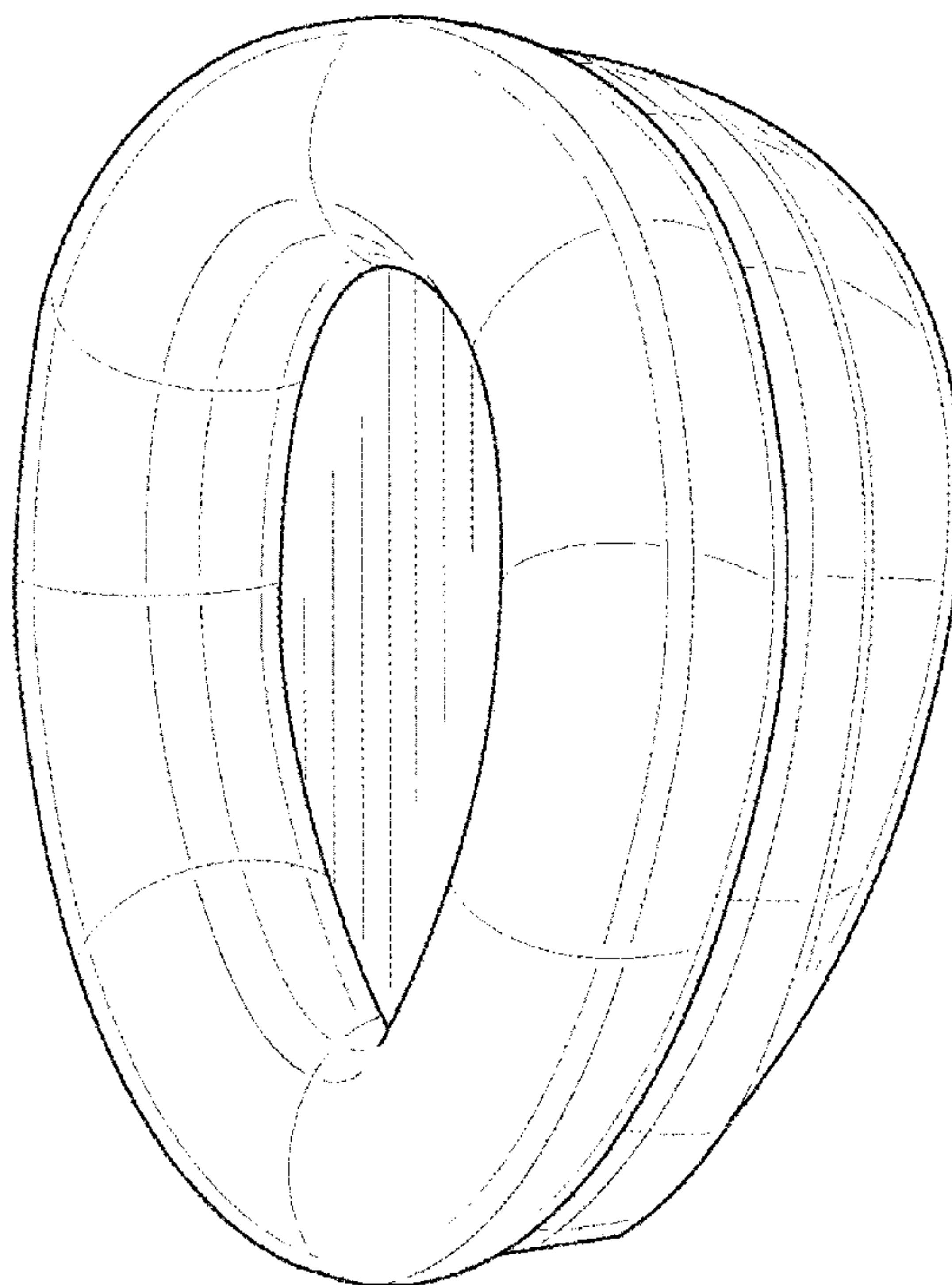
FIG. 5 is a bottom side view of the earshaped ear pad;

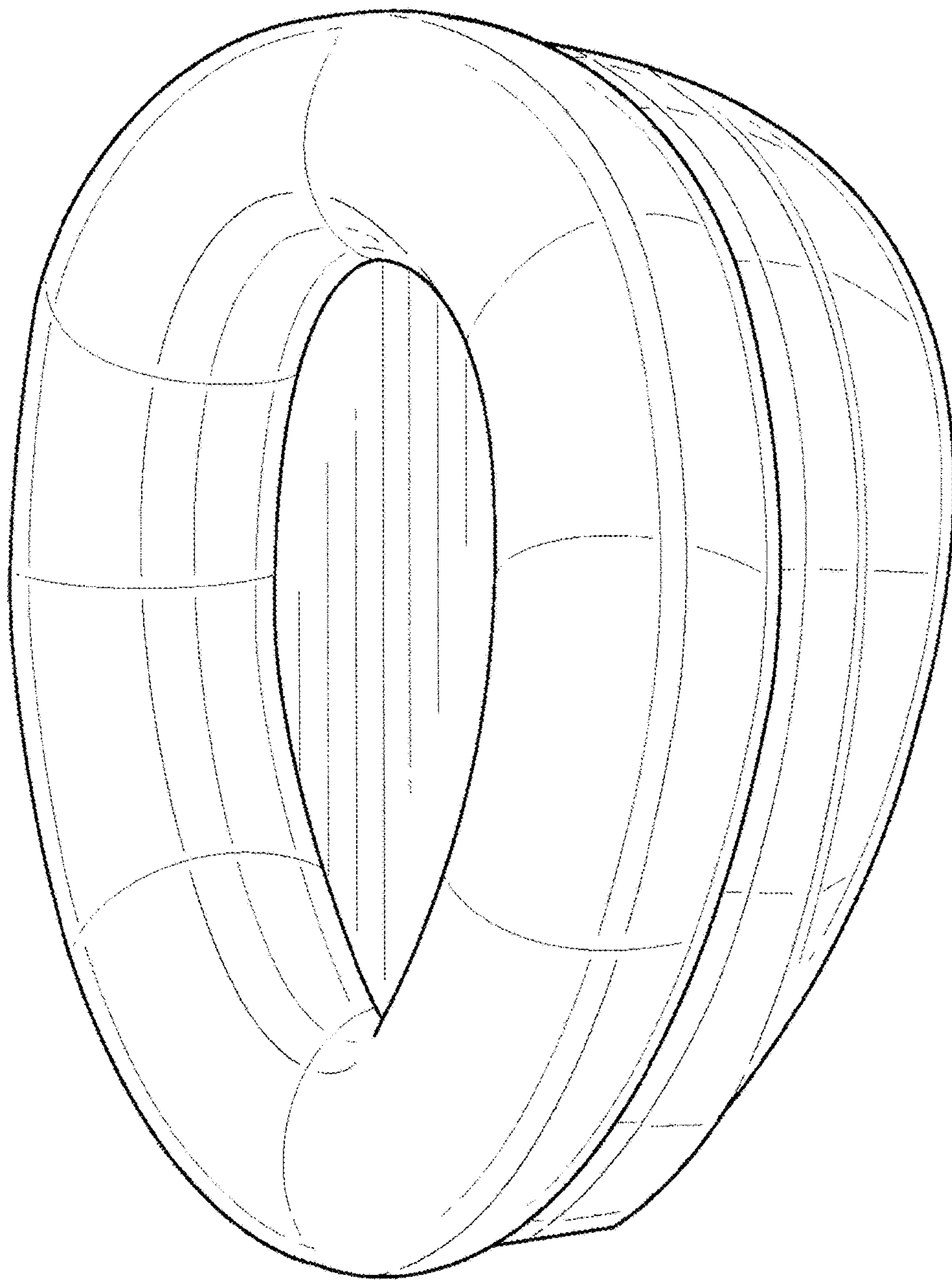

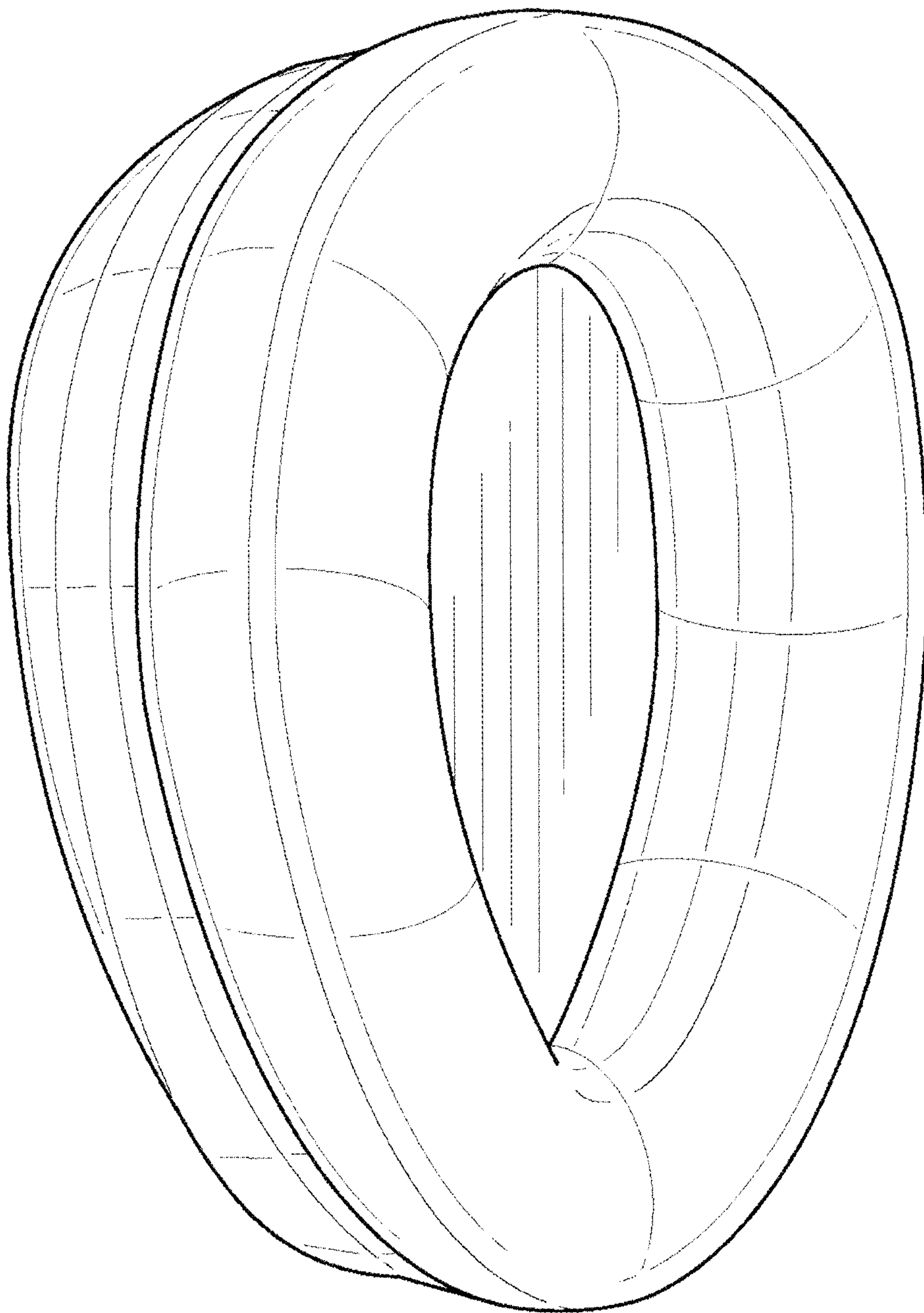

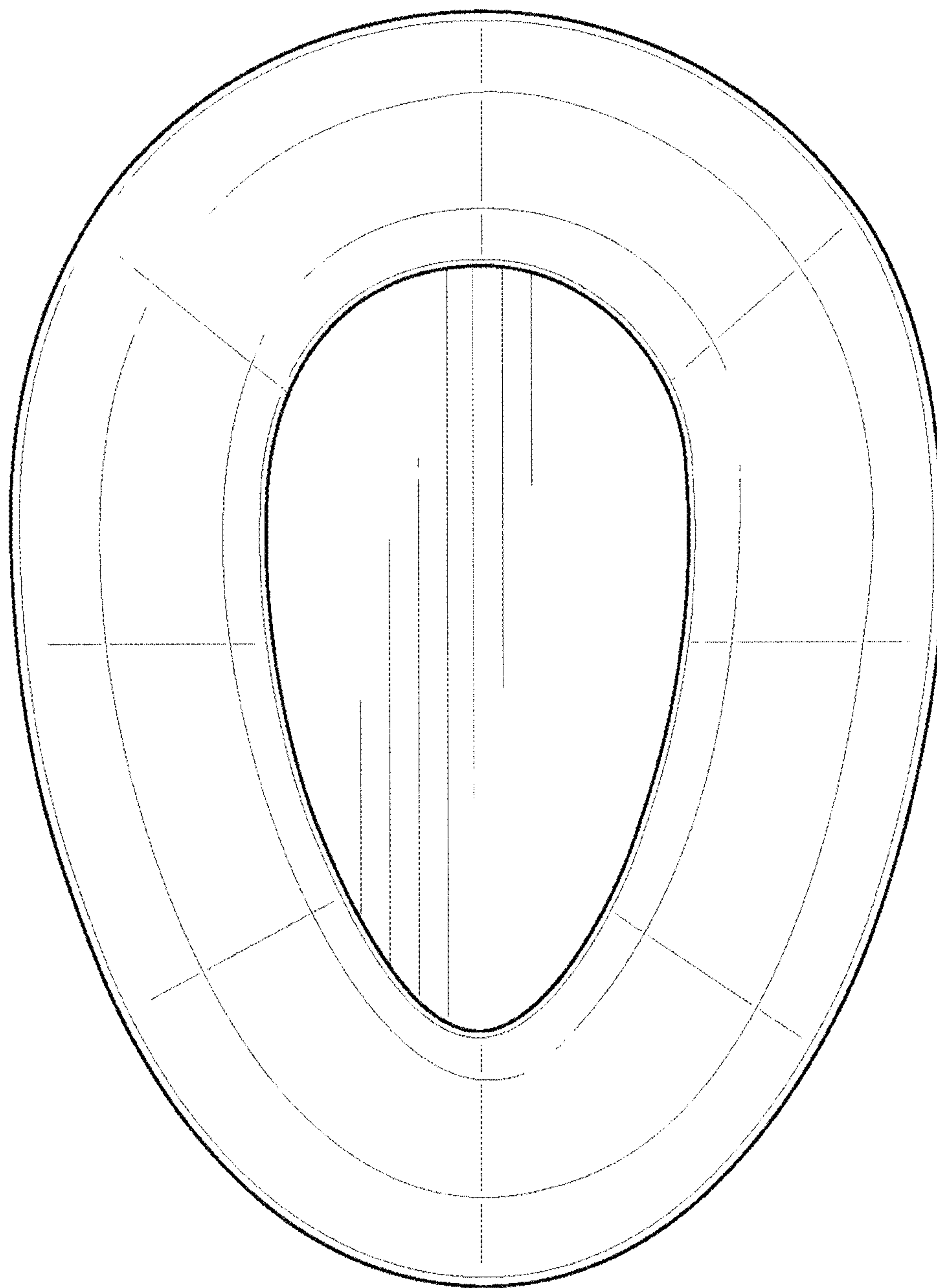

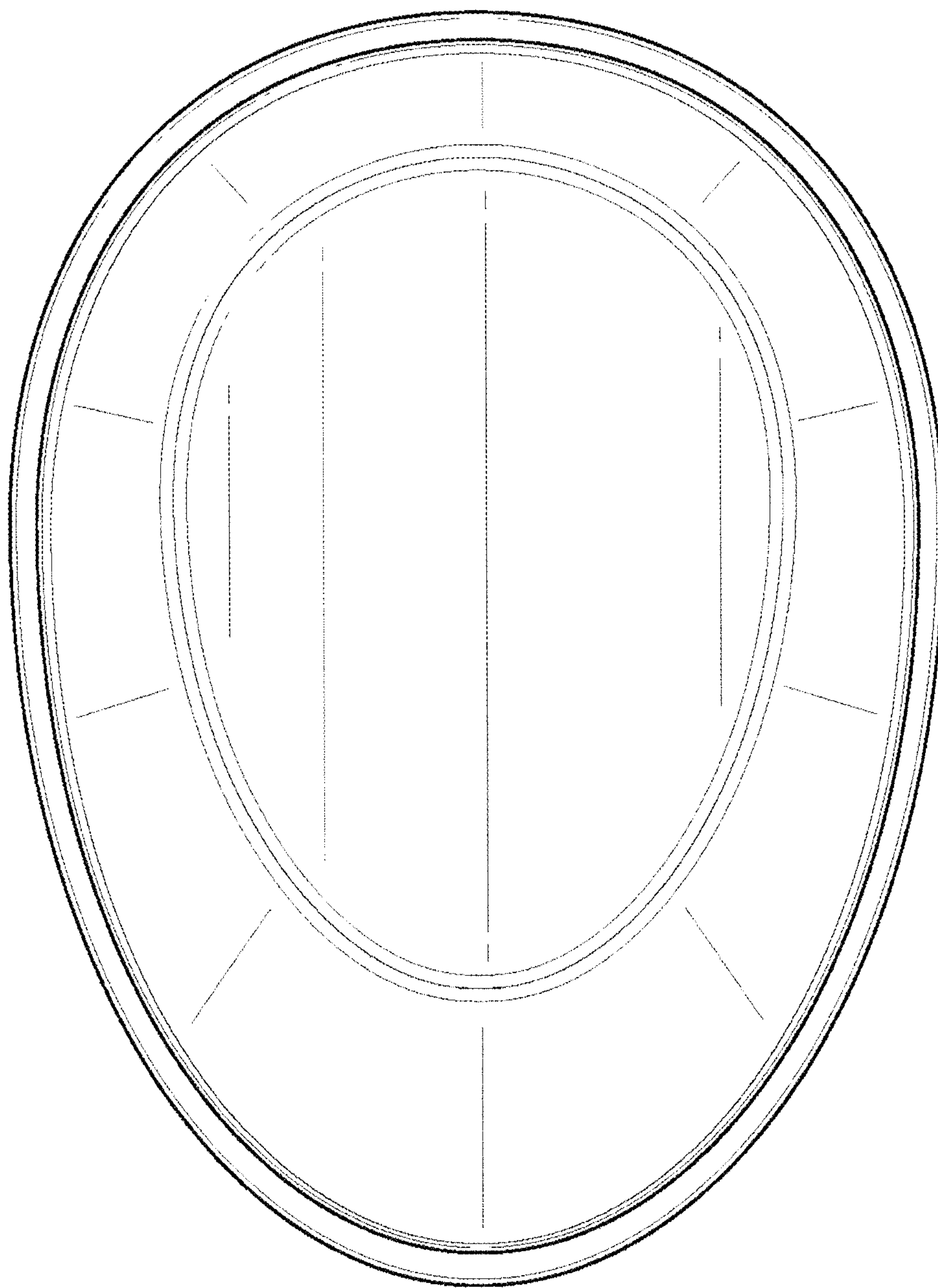

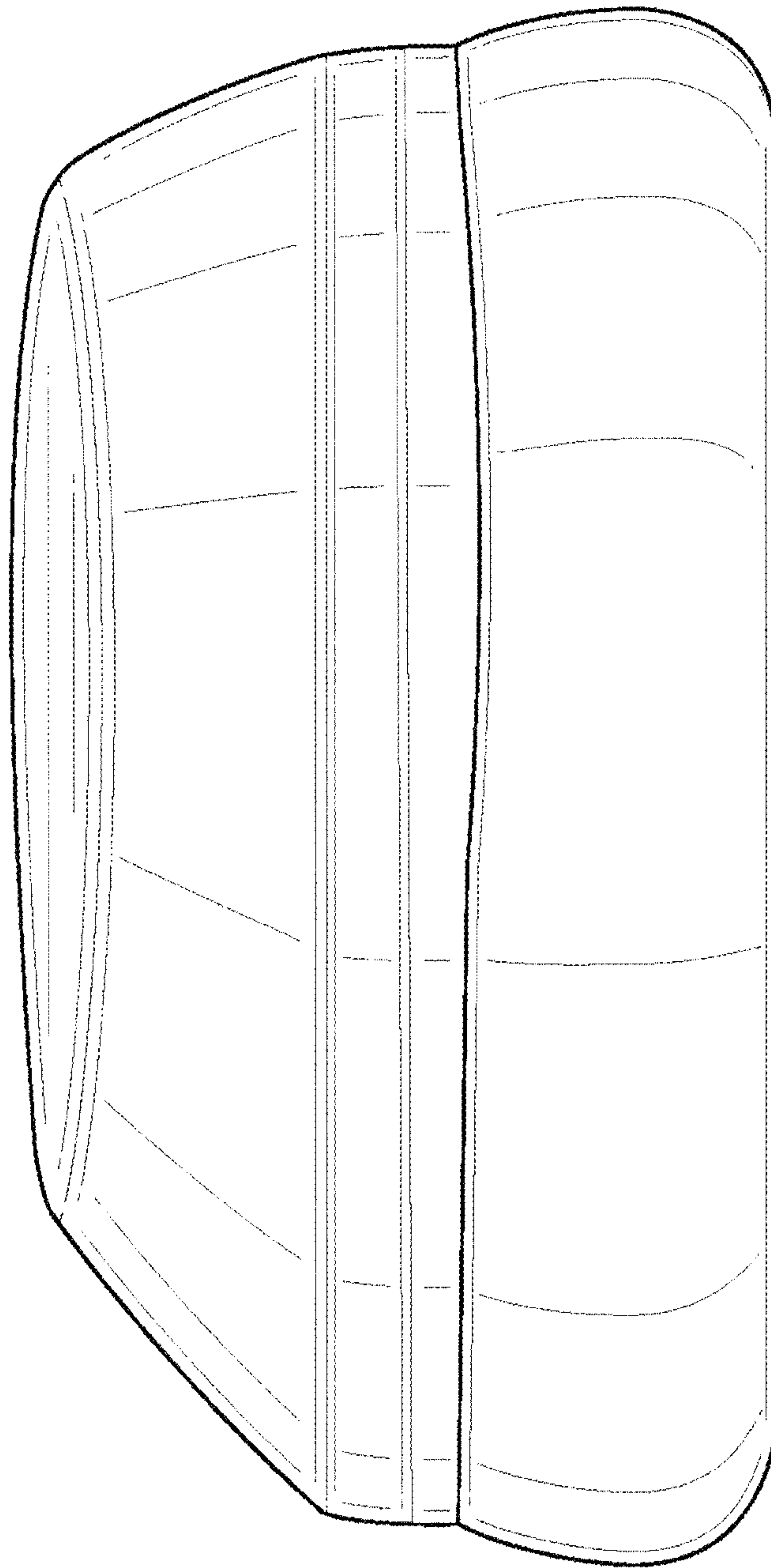

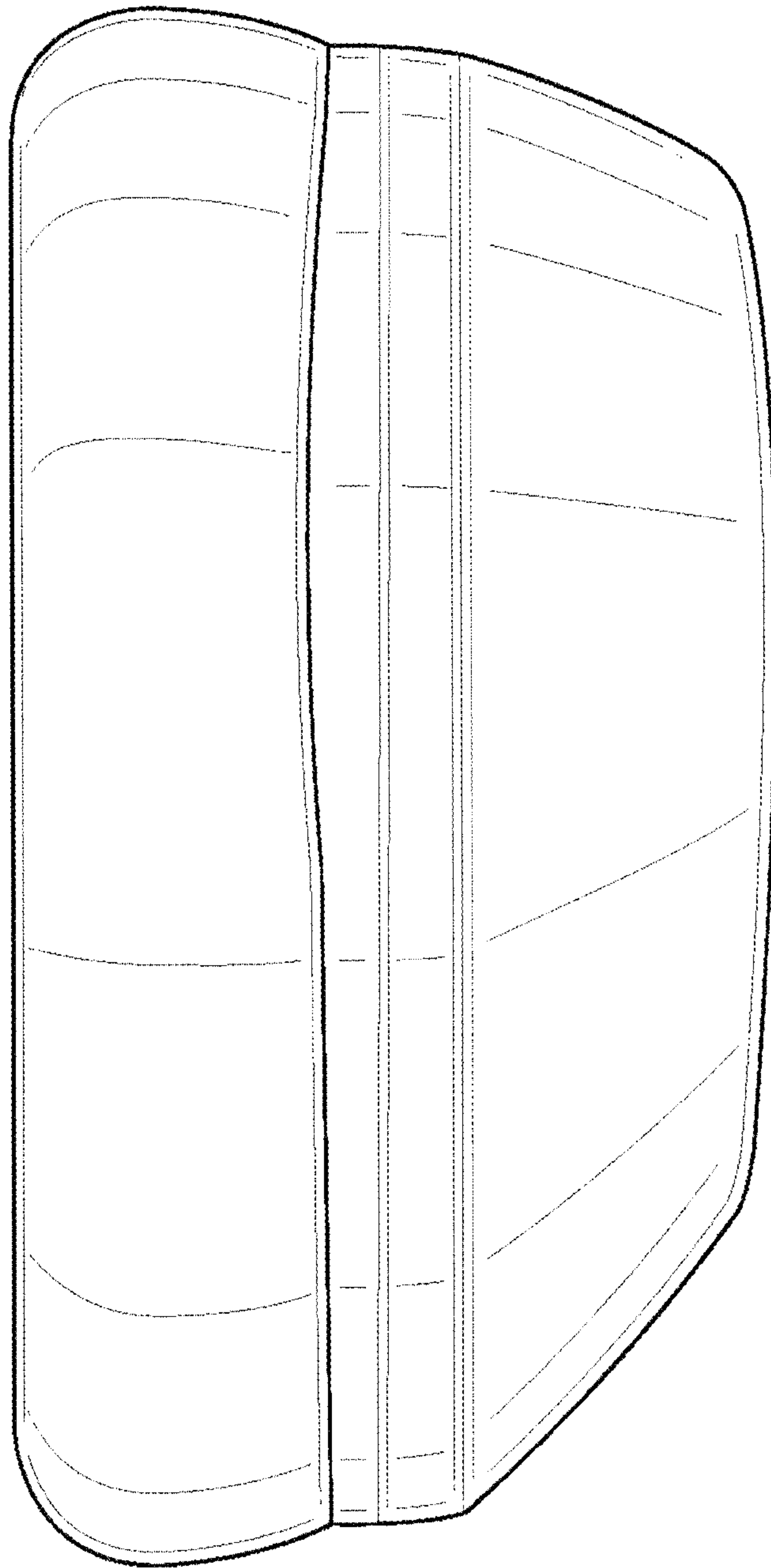

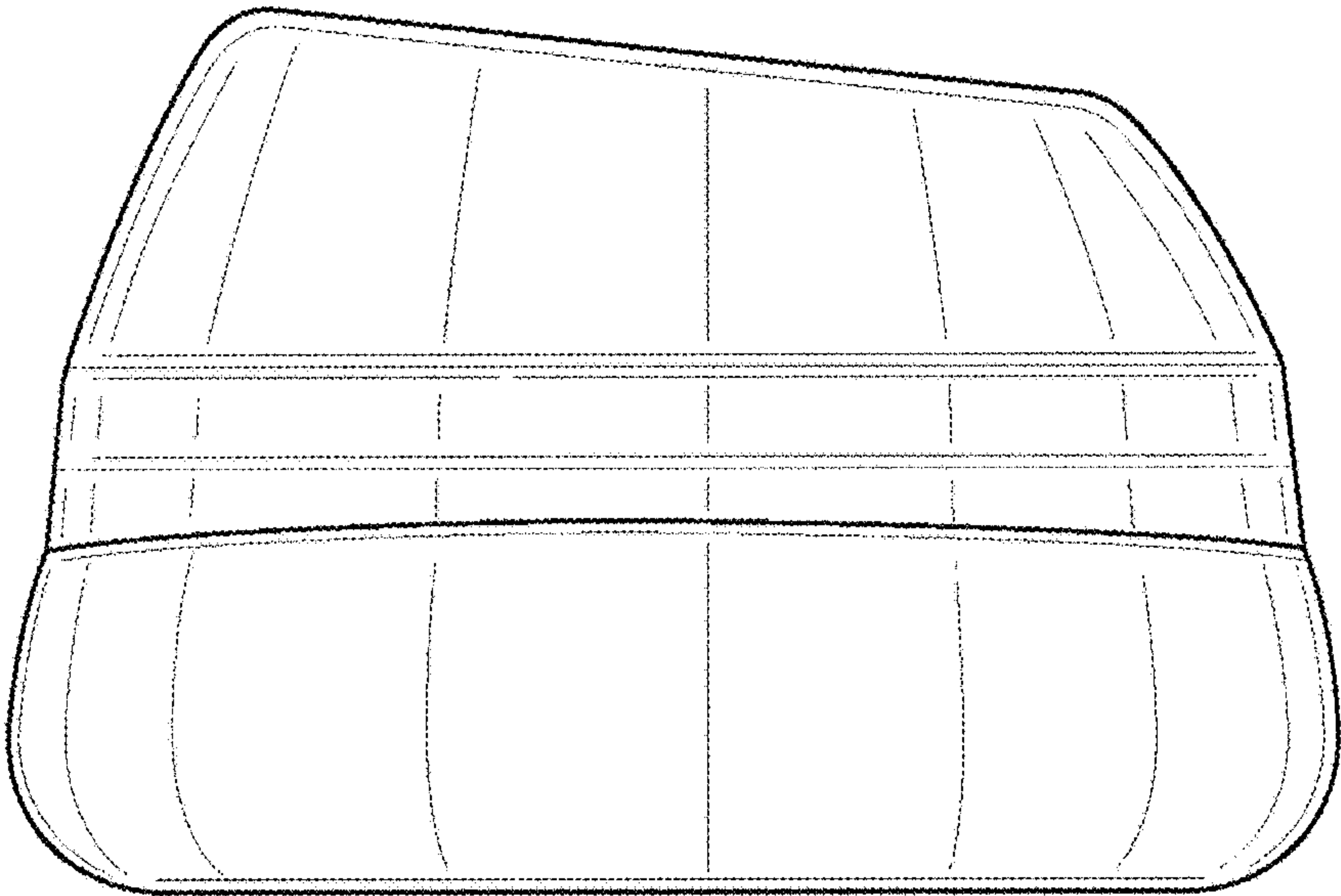

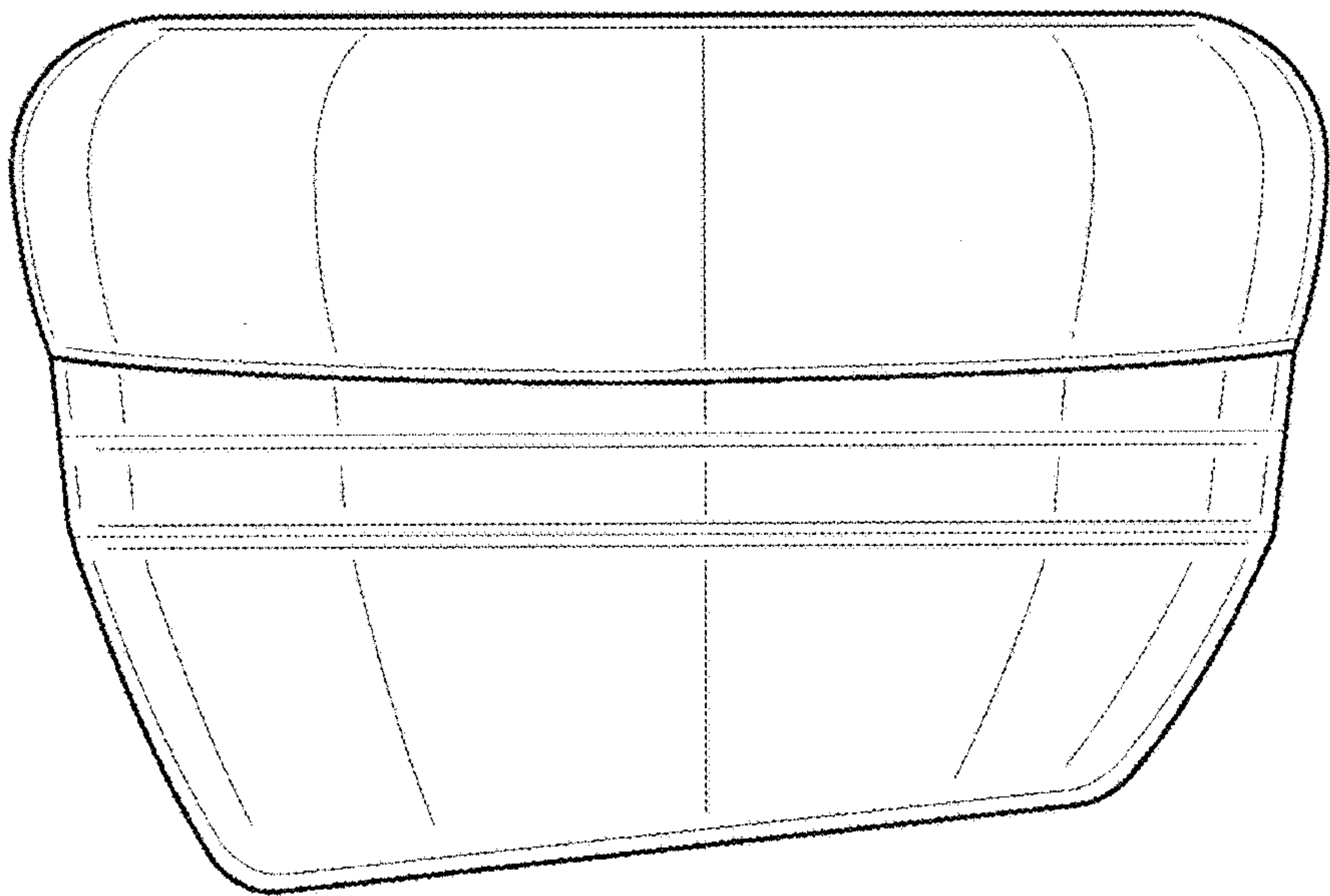
