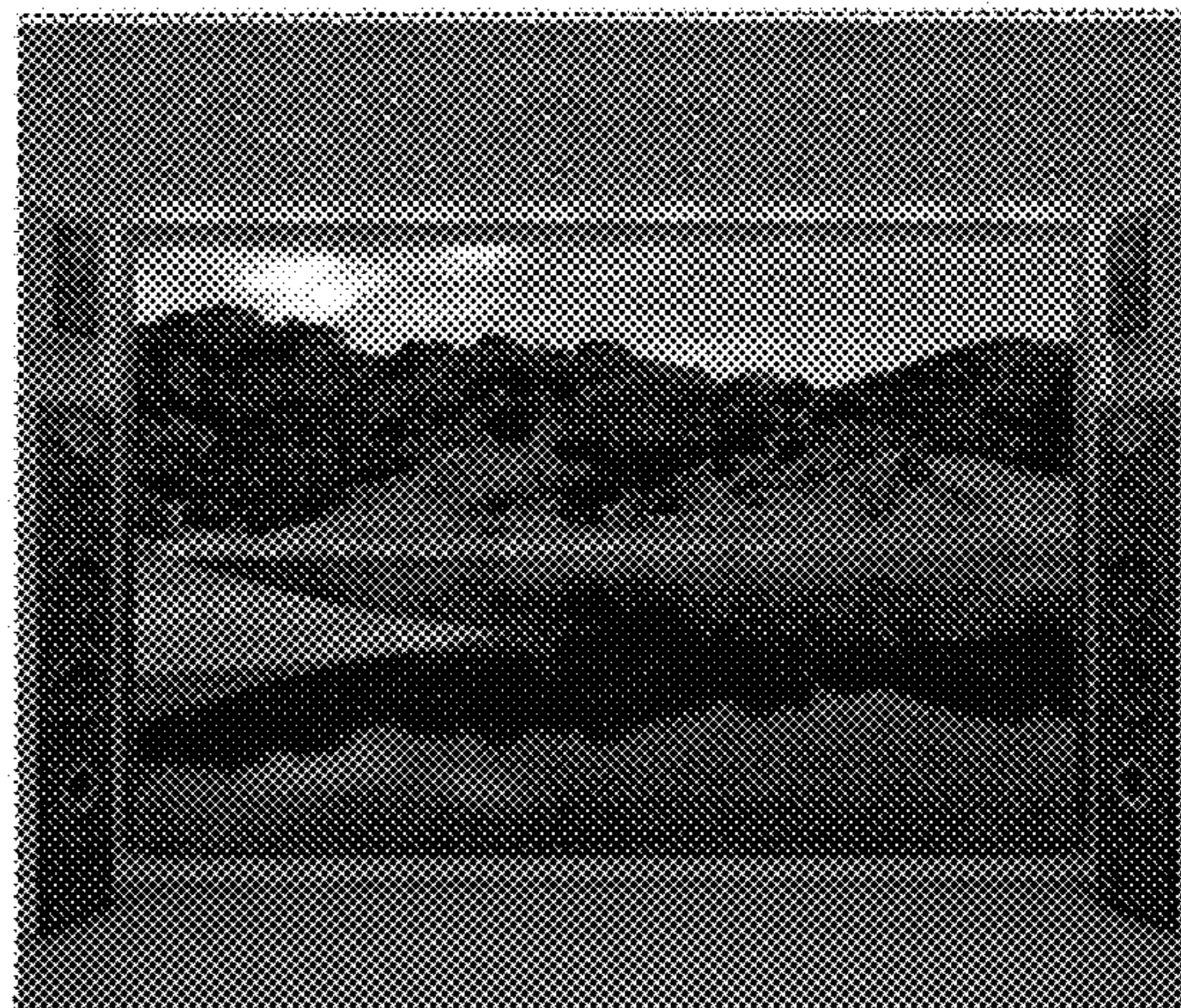
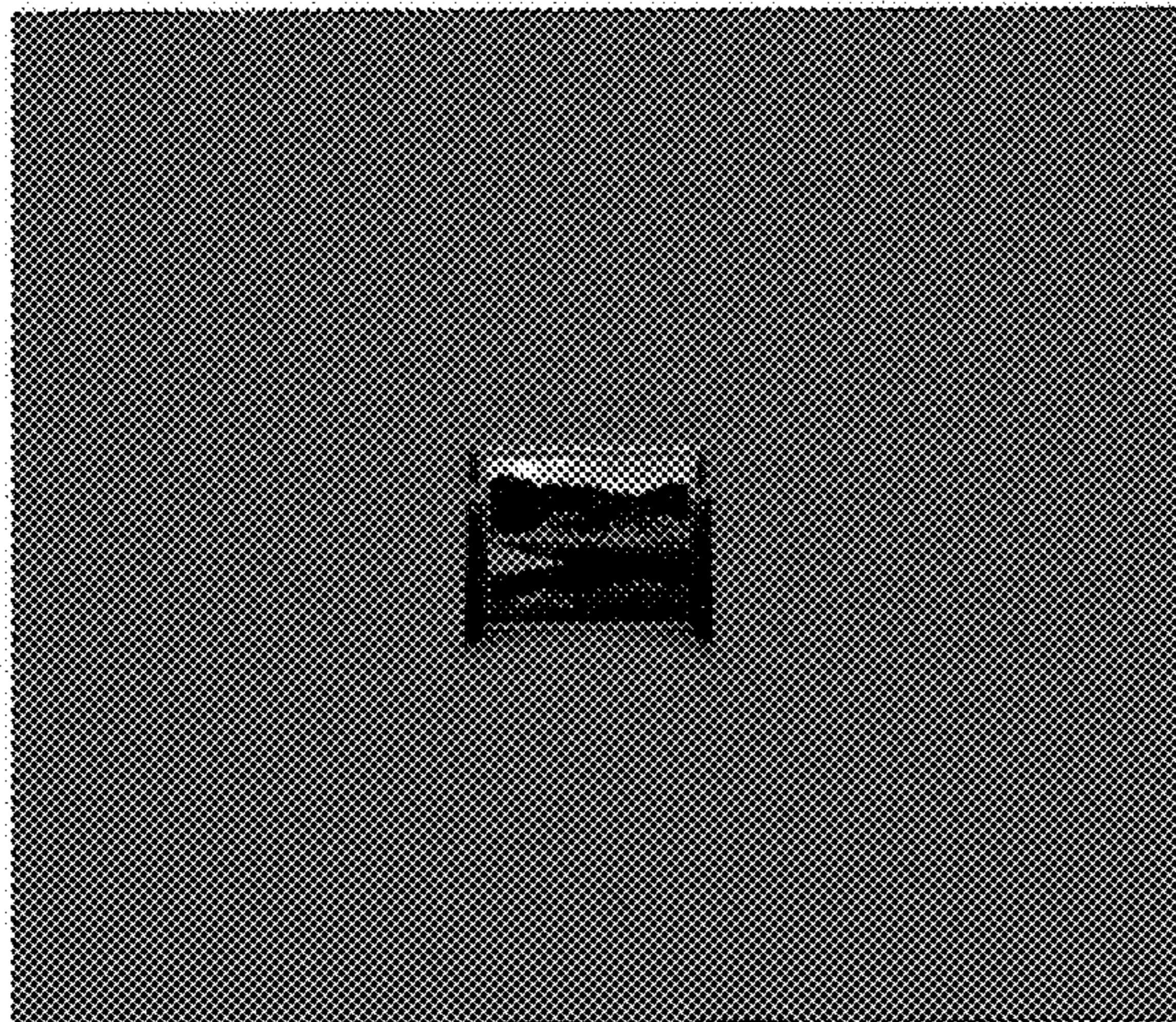
I claim the ornamental design for a display screen or a portion thereof with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the first image according to a first embodiment of a display screen or portion thereof with animated graphical user interface showing my new design; FIG. 2 is a front view of the second transitional image of the first embodiment thereof, FIG. 3 is a front view of the third transitional image of the first embodiment thereof, FIG. 4 is a front view of the fourth transitional image of the first embodiment thereof, FIG. 5 is a front view of the fifth transitional image of the first embodiment thereof, FIG. 6 is a front view of the sixth transitional image of the first embodiment thereof, FIG. 7 is a front view of the first image according to a second embodiment of a display screen or portion thereof with animated graphical user interface, FIG. 8 is a front view of the second transitional image of the second embodiment thereof, FIG. 9 is a front view of the third transitional image of the second embodiment thereof, FIG. 10 is a front view of the fourth transitional image of the second embodiment thereof, FIG. 11 is a front view of the fifth transitional image of the second embodiment thereof; and, FIG. 12 is a front view of the sixth transitional image of the second embodiment thereof.

The broken lines shown, of a display screen or a portion thereof, in FIG. 1-12 form no part of the claimed design. The appearance of the animated graphical user interface sequentially transitions between the images shown in FIGS. 1-6 and FIGS. 7-12. The process or period in which an image transitions to another forms no part of the claimed design.

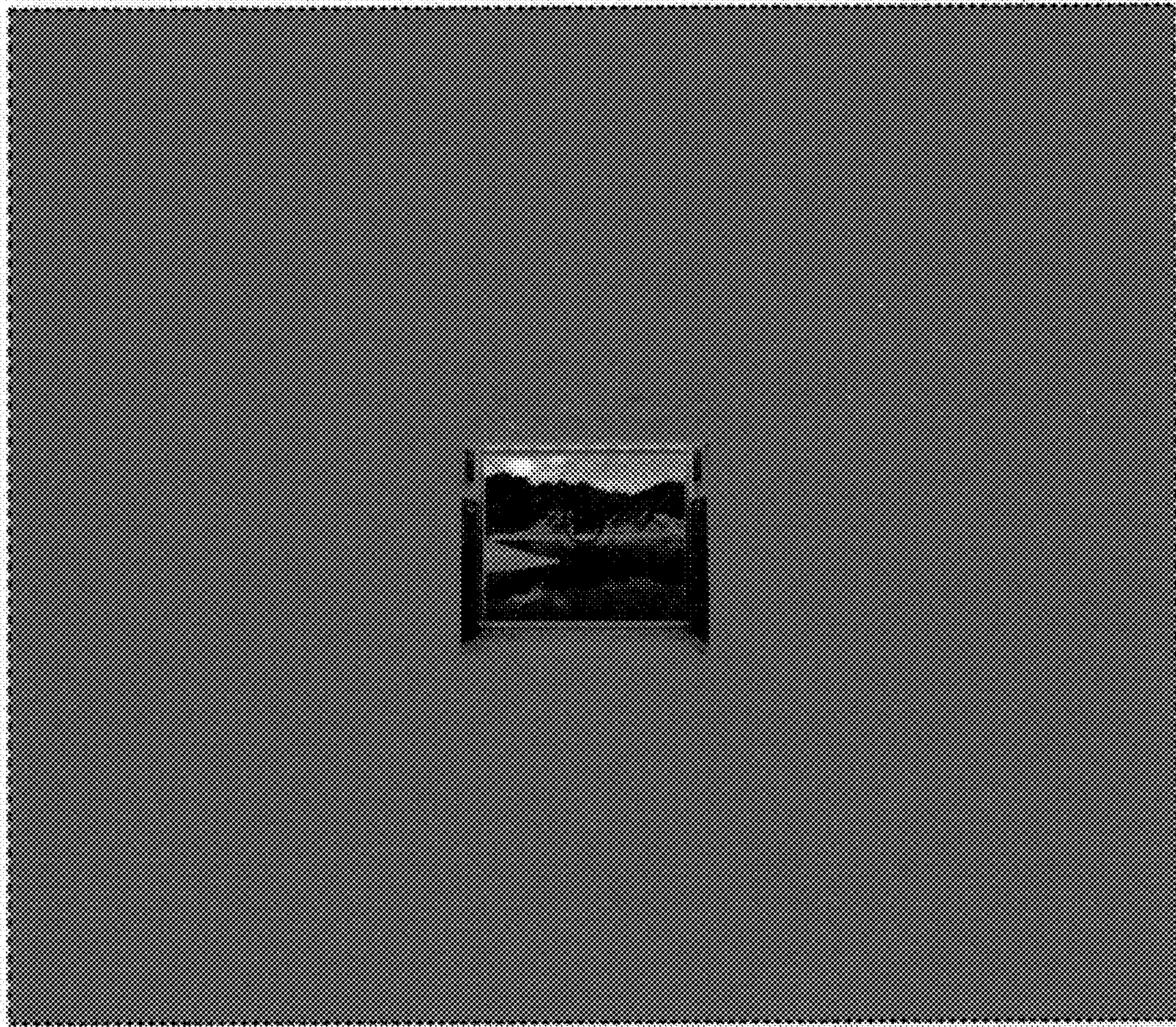

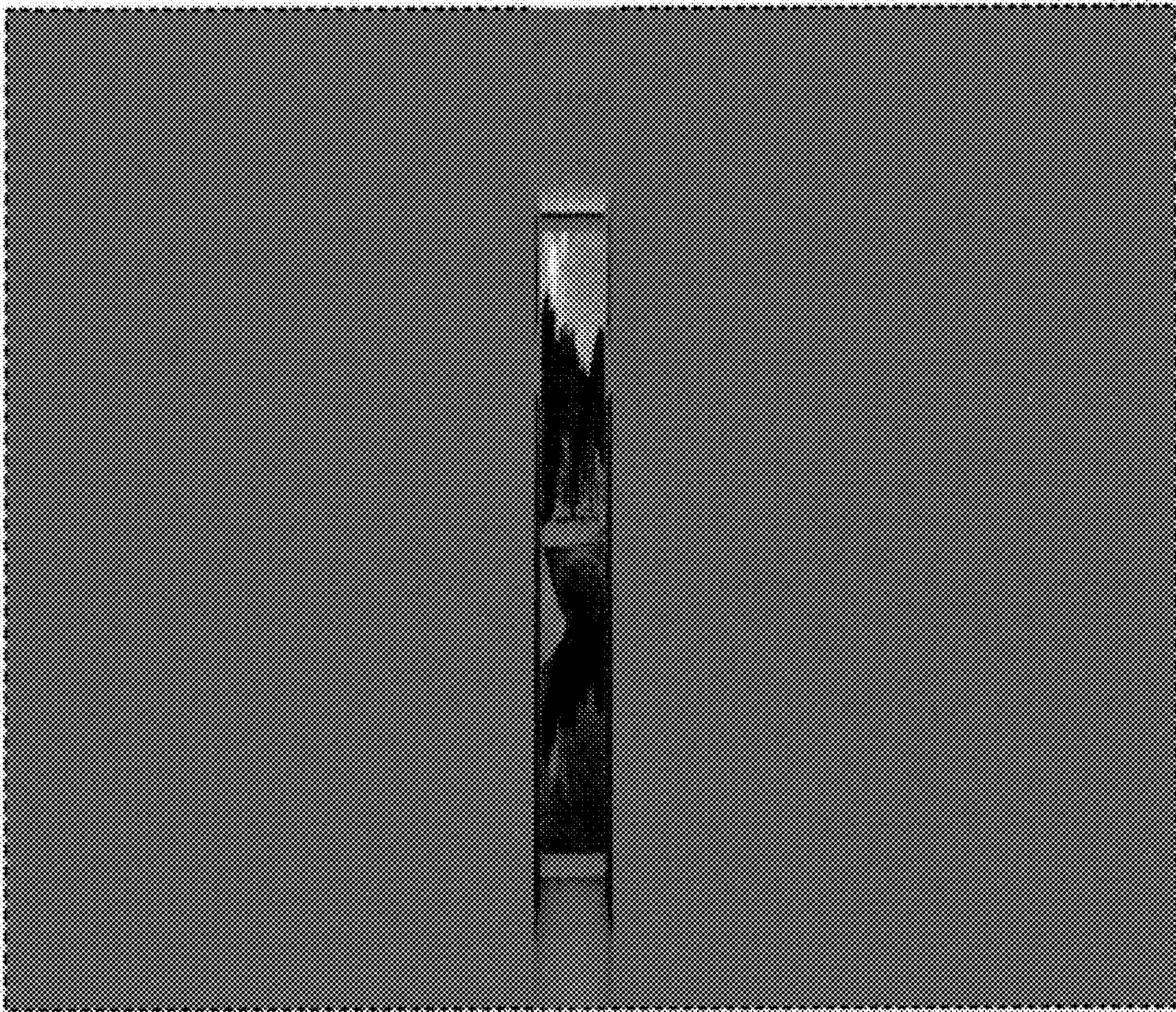

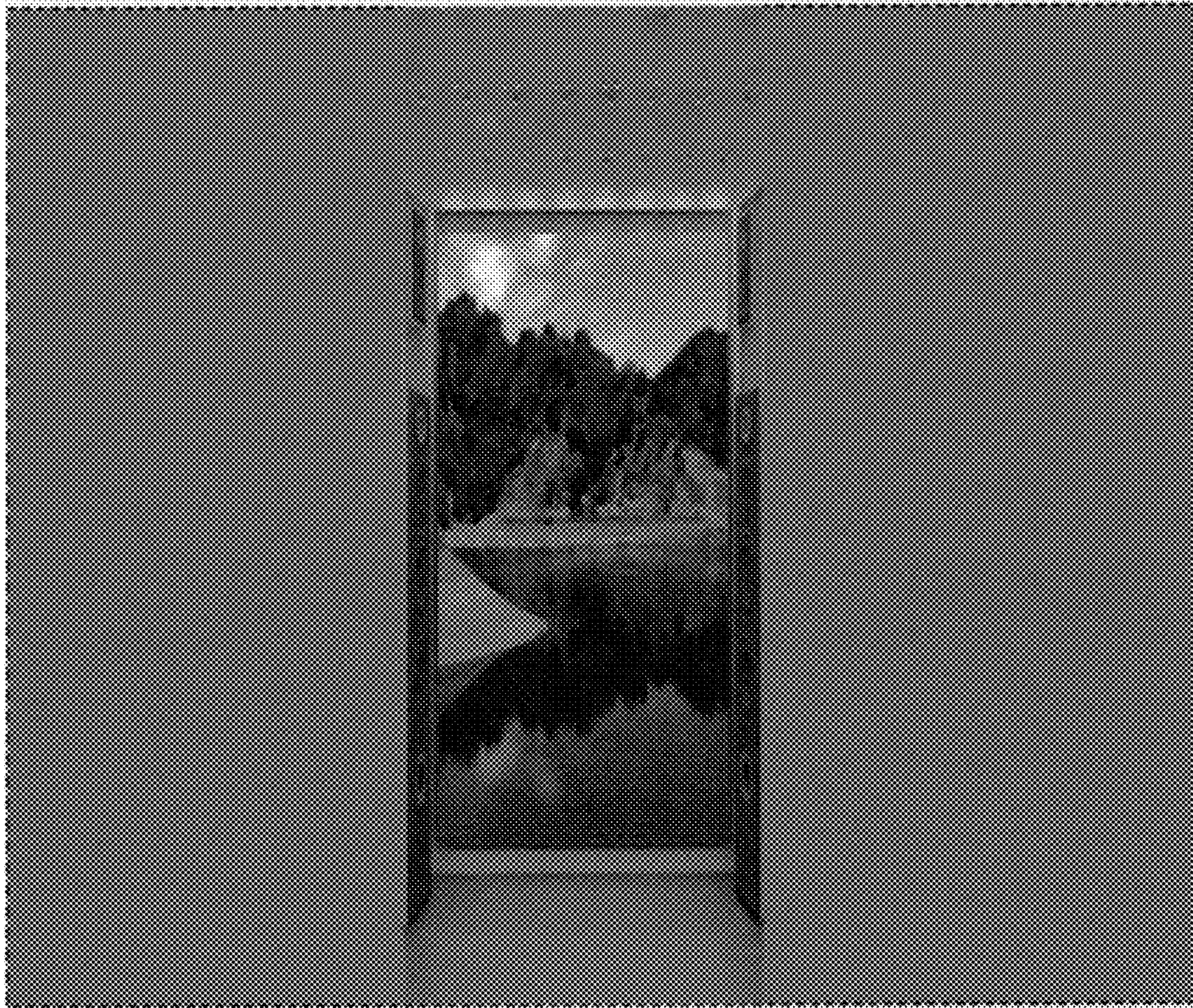

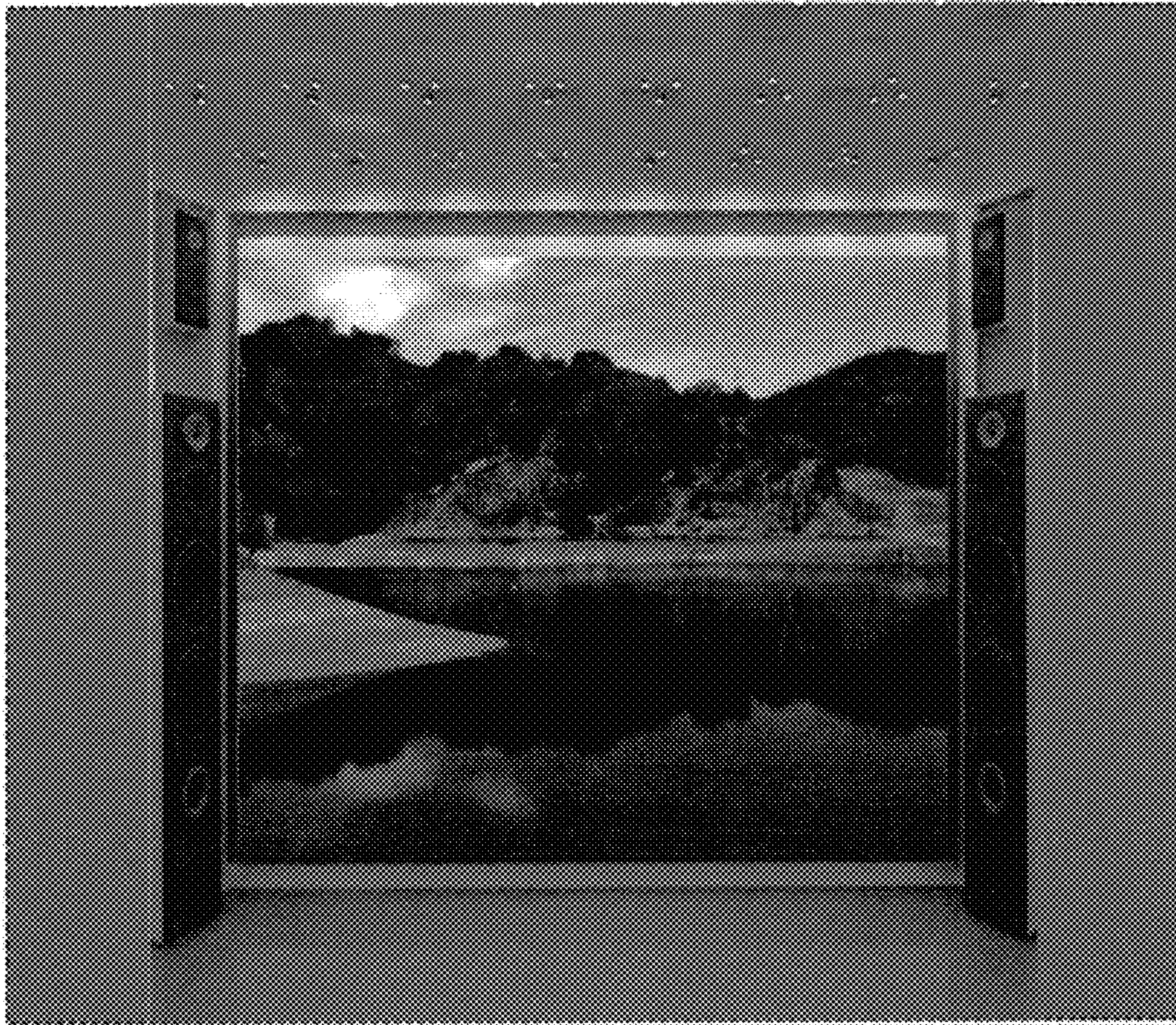

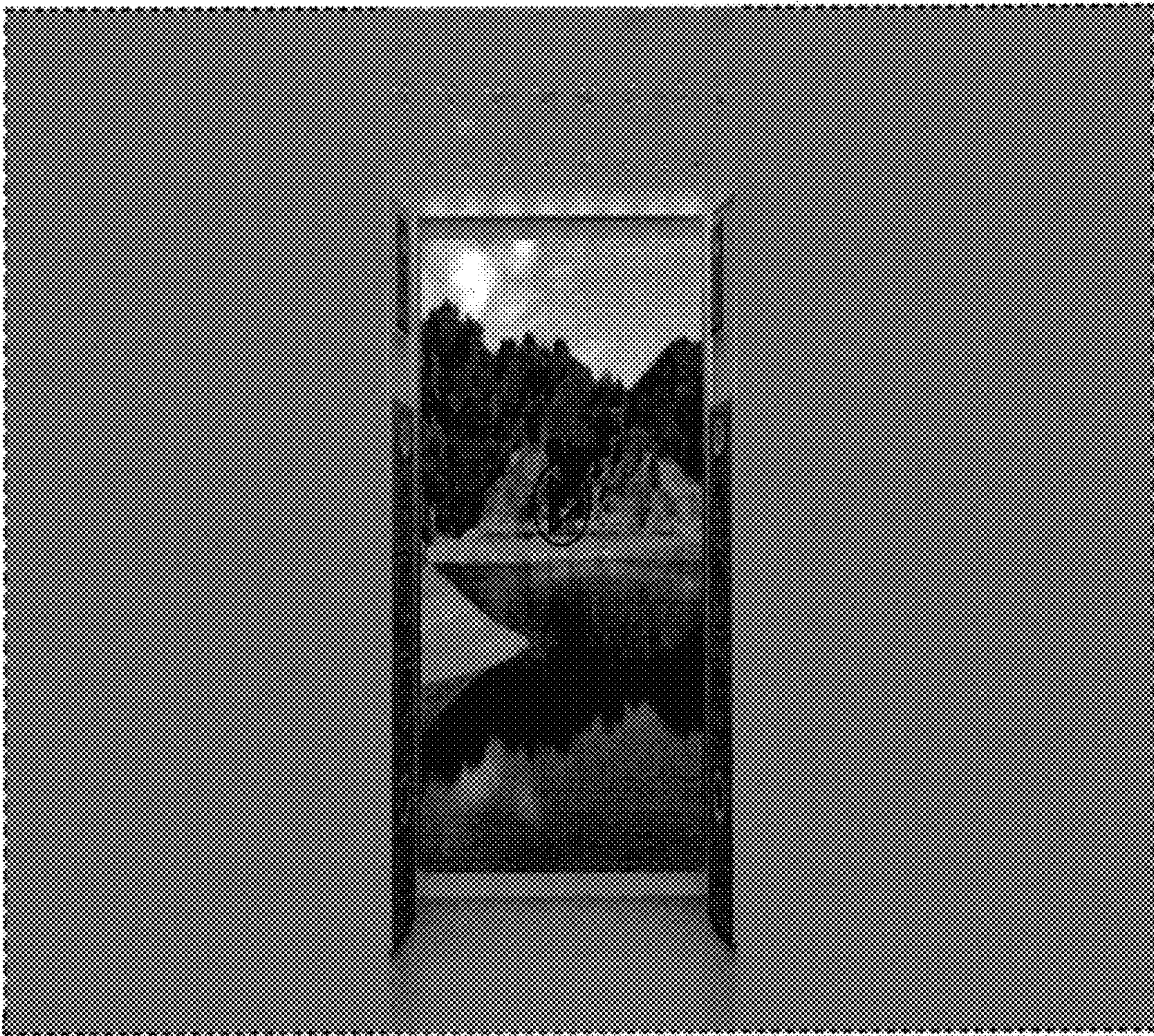

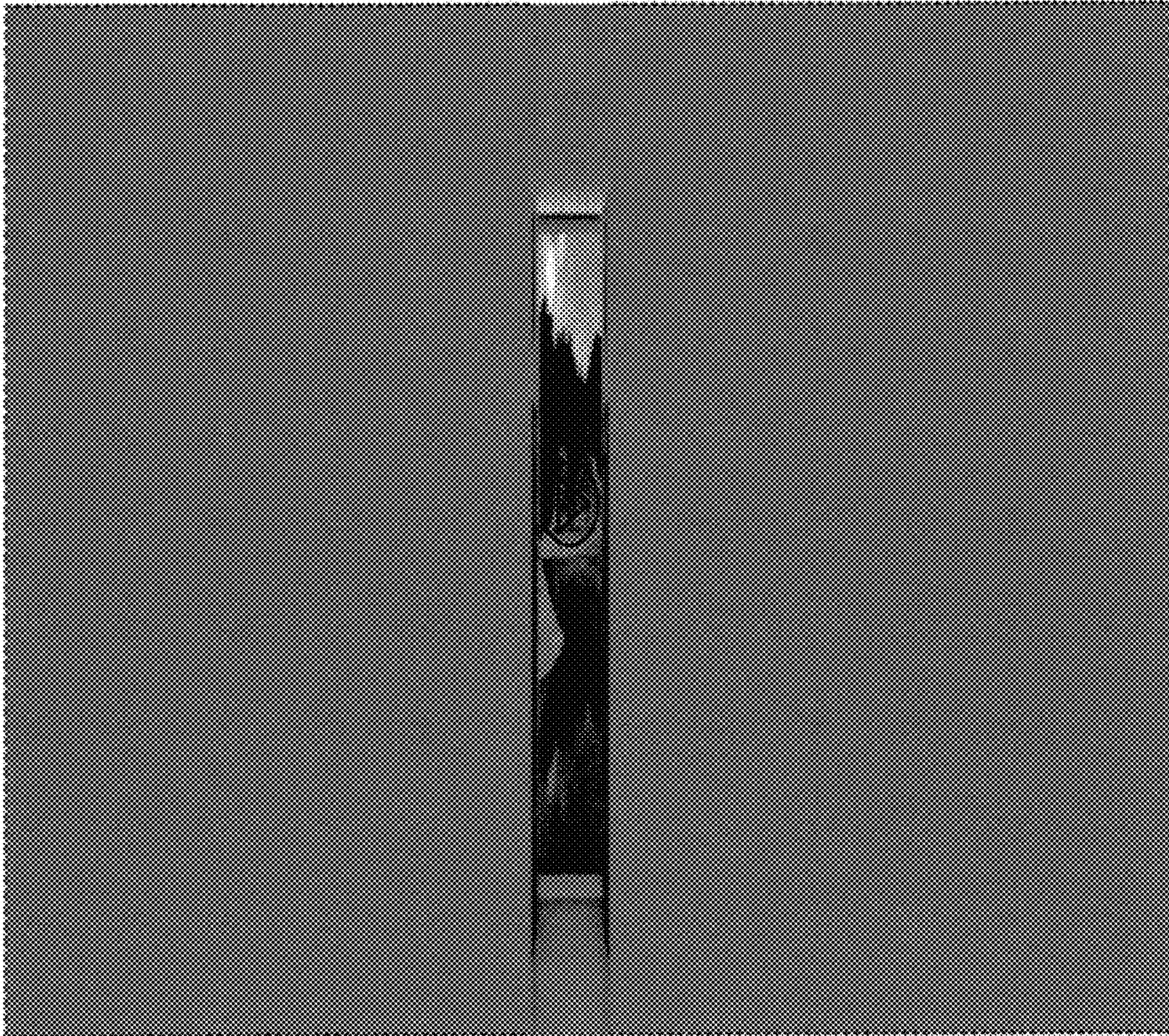

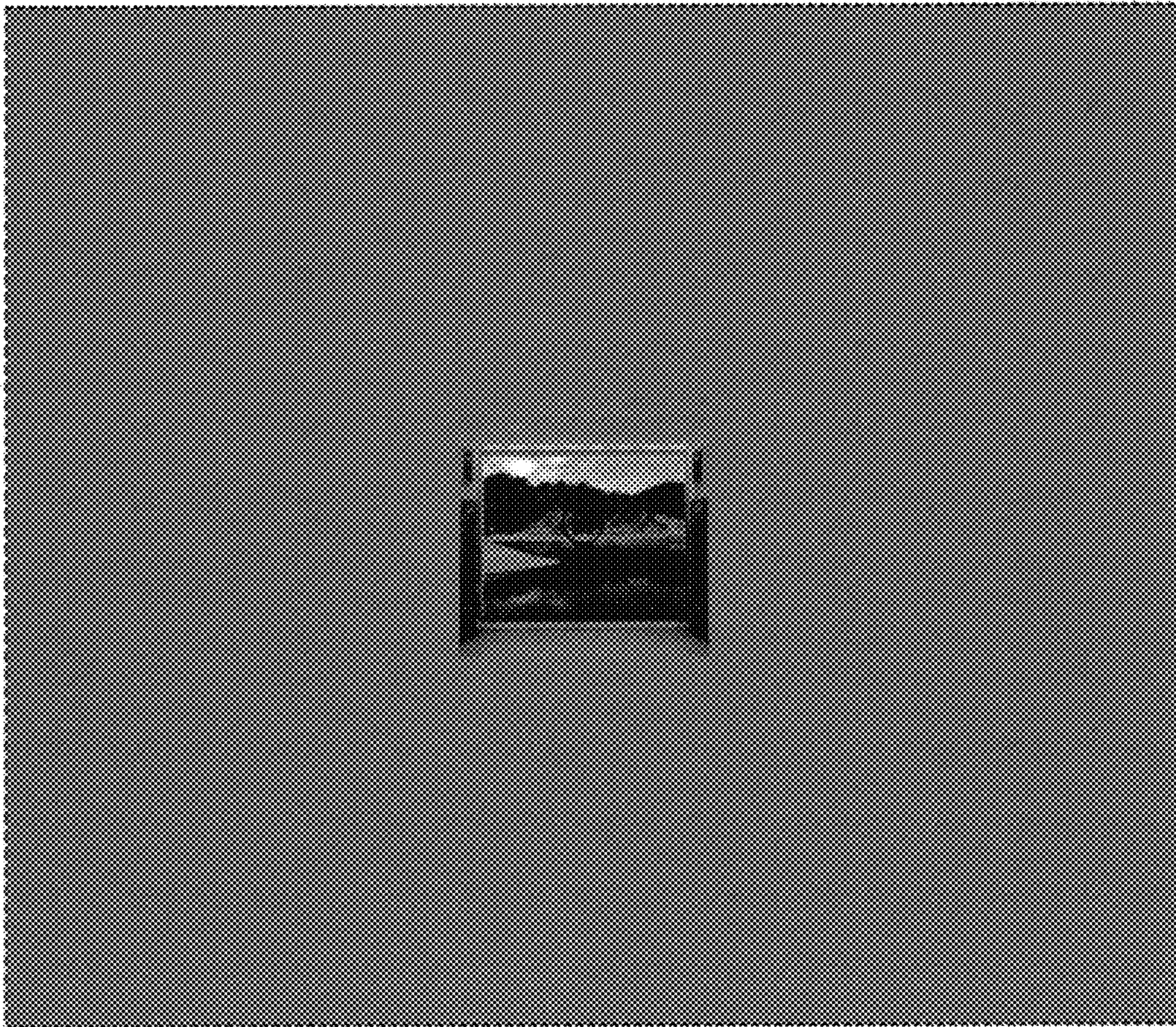
