The ornamental design for a computing device display screen or portion thereof with an icon, as shown and described.

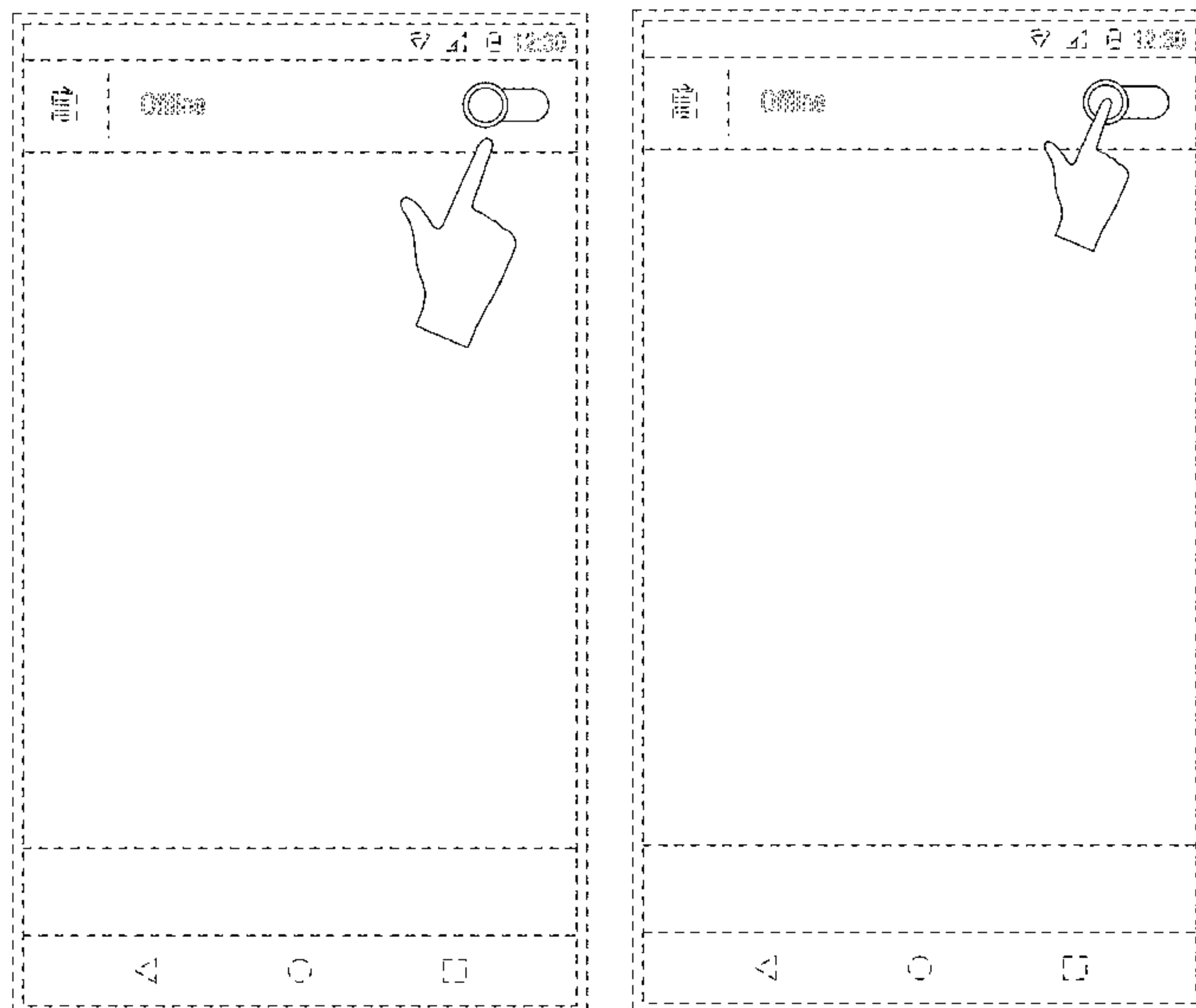
**DESCRIPTION**

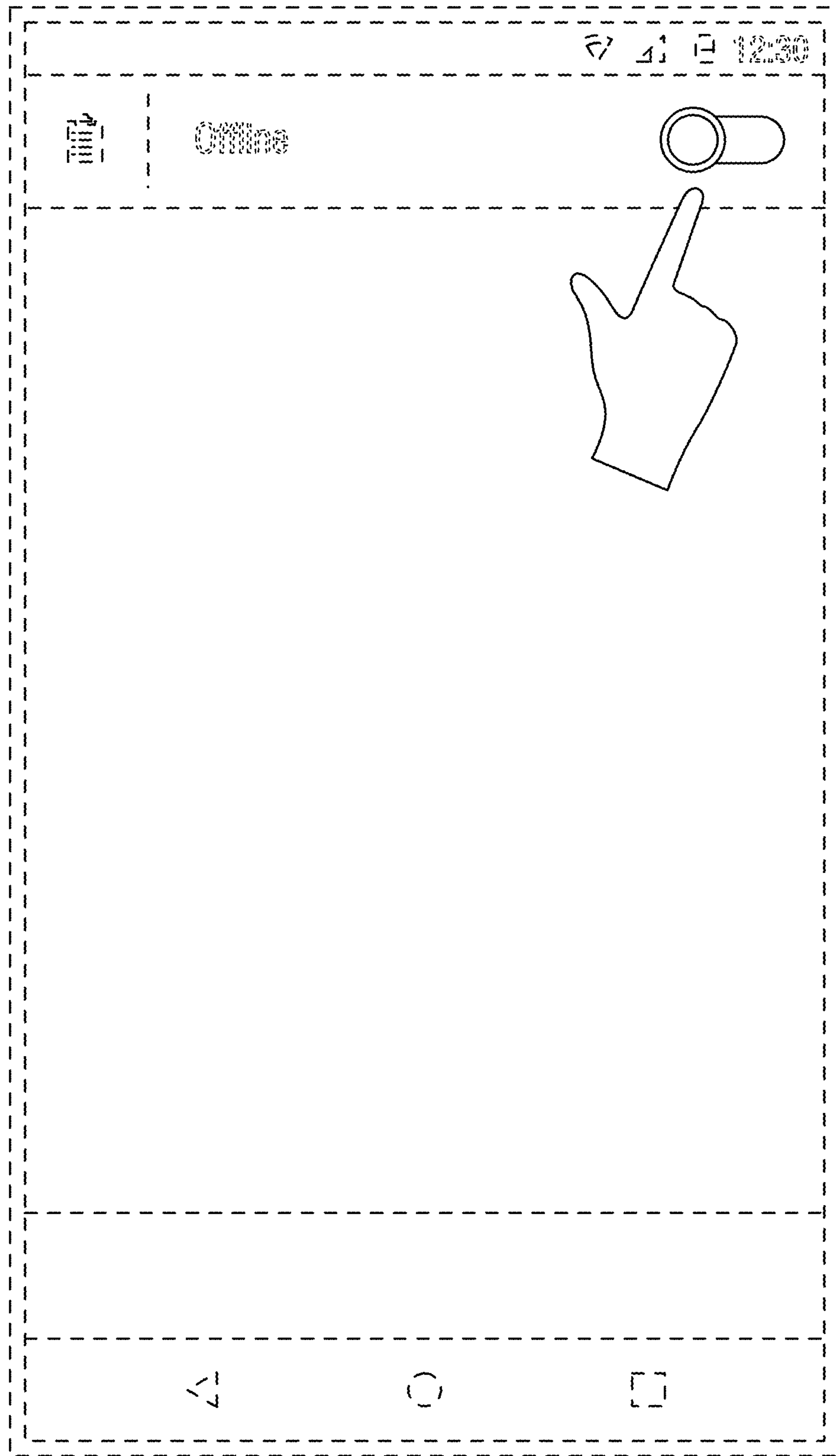

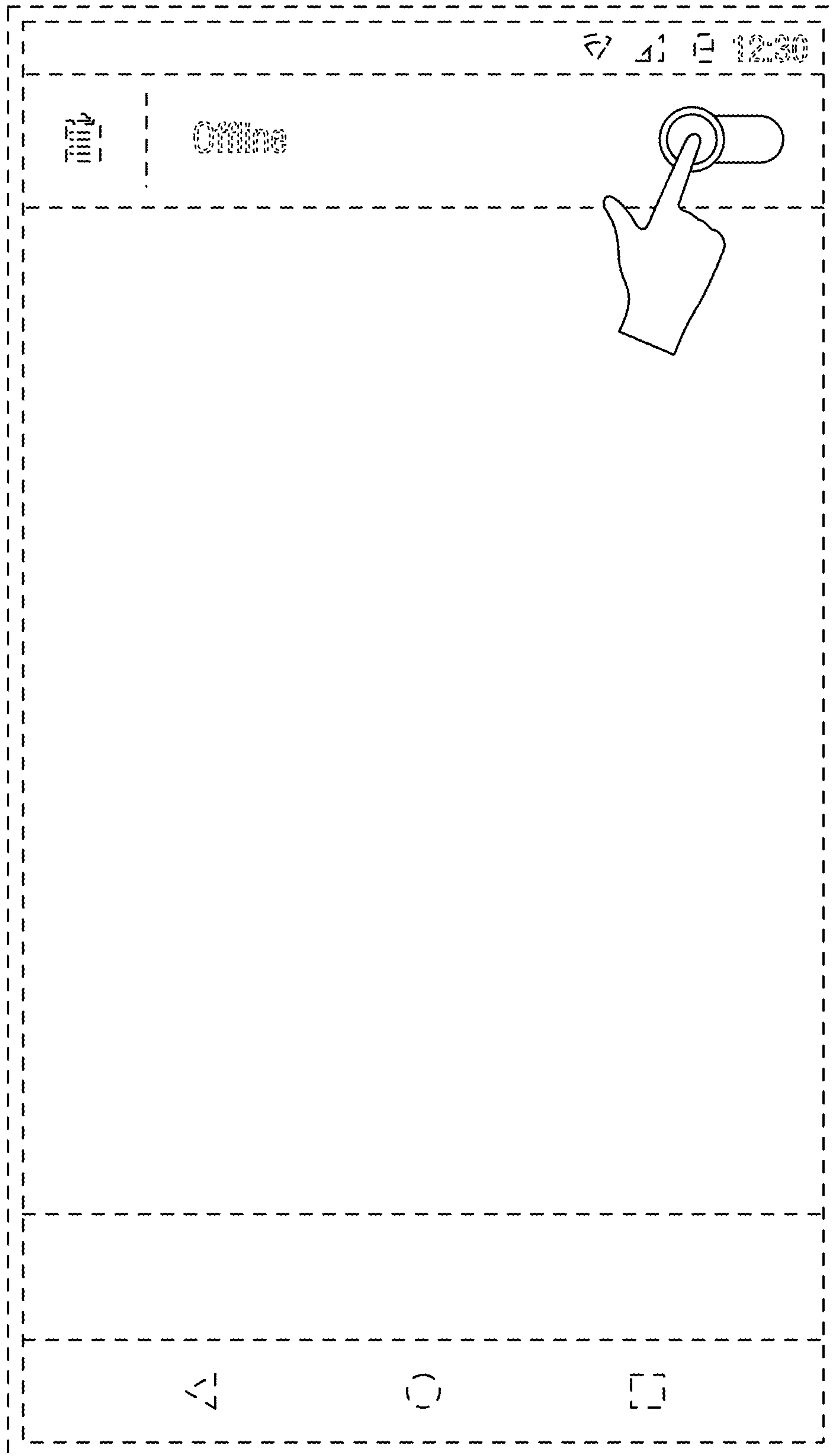
