DESCRIPTION

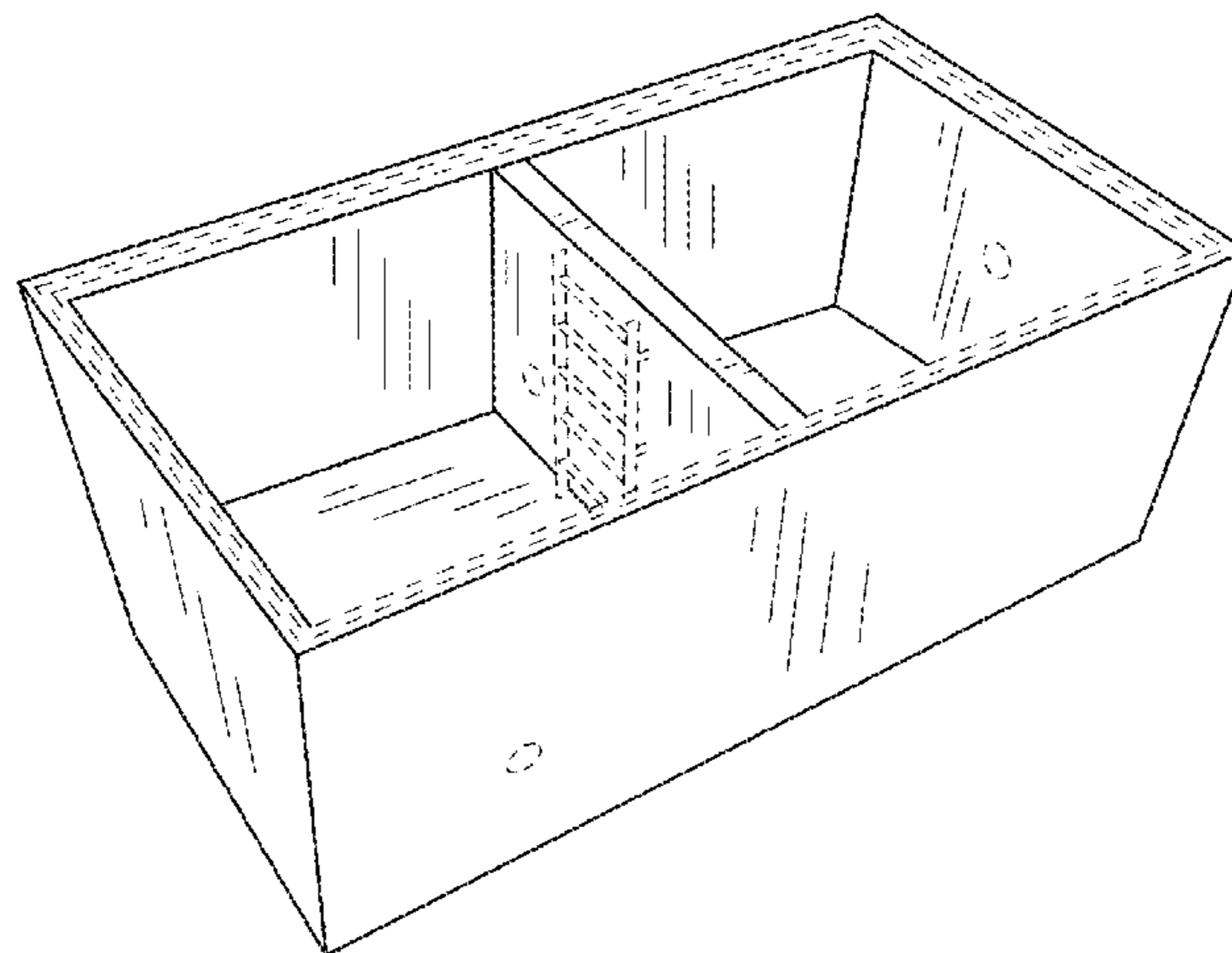
FIG. 1 is a perspective view of the precast valve housing; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right elevation view thereof; FIG. 5 is a left elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is bottom plan view thereof. The broken lines showing portions of the precast valve housing form environment structure that forms no part of the claimed design.

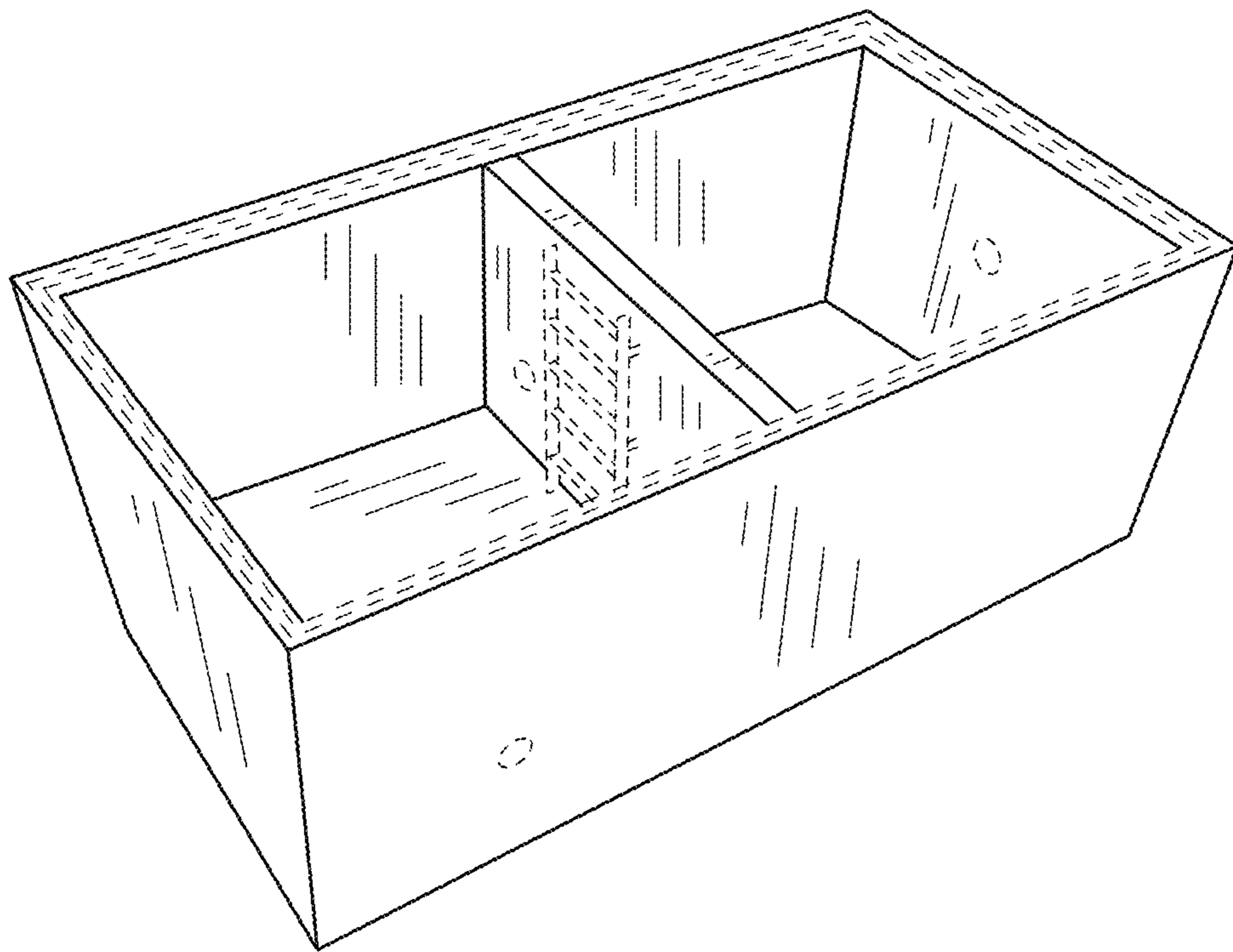

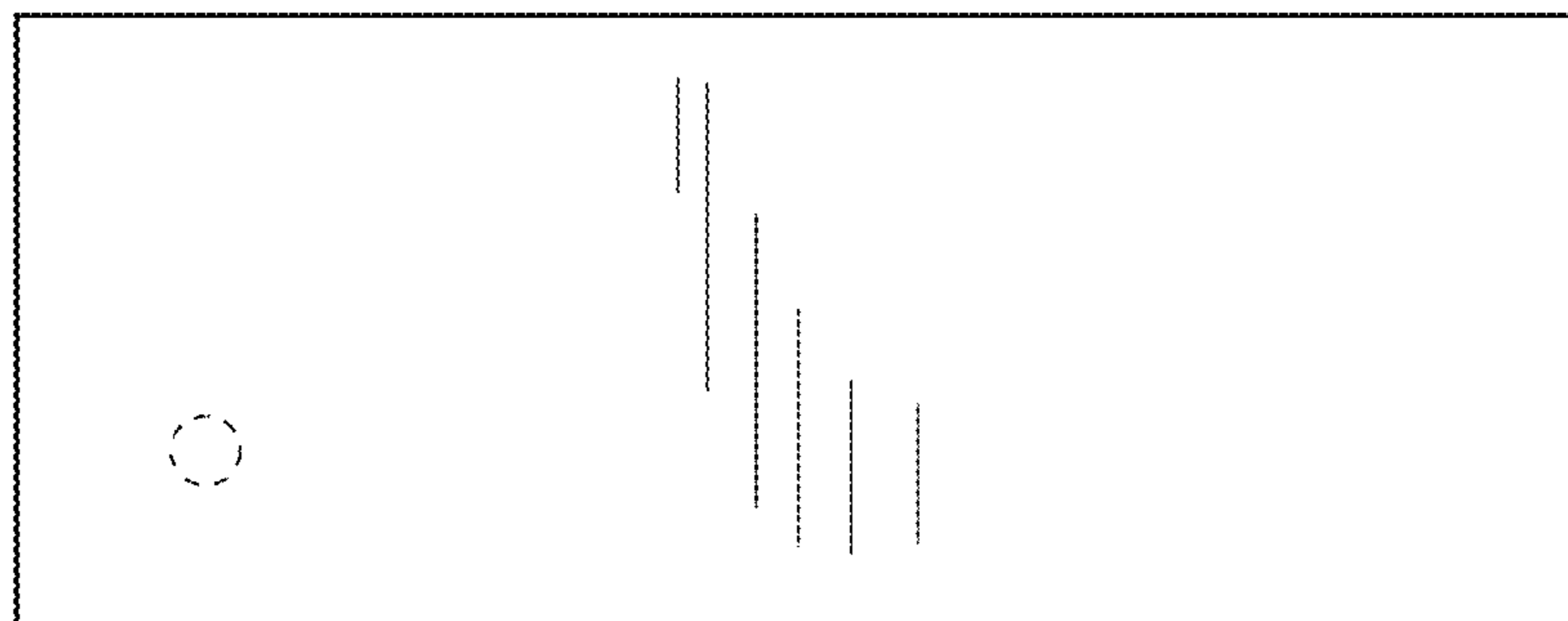

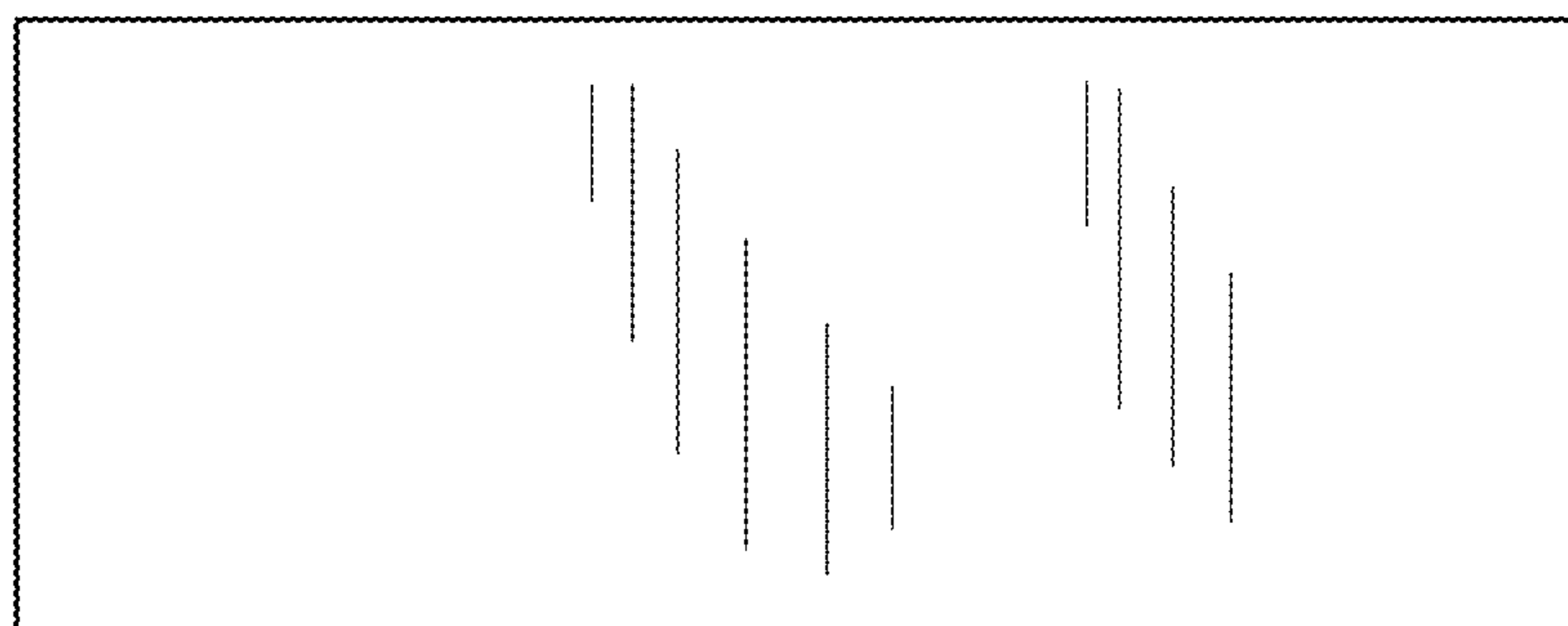

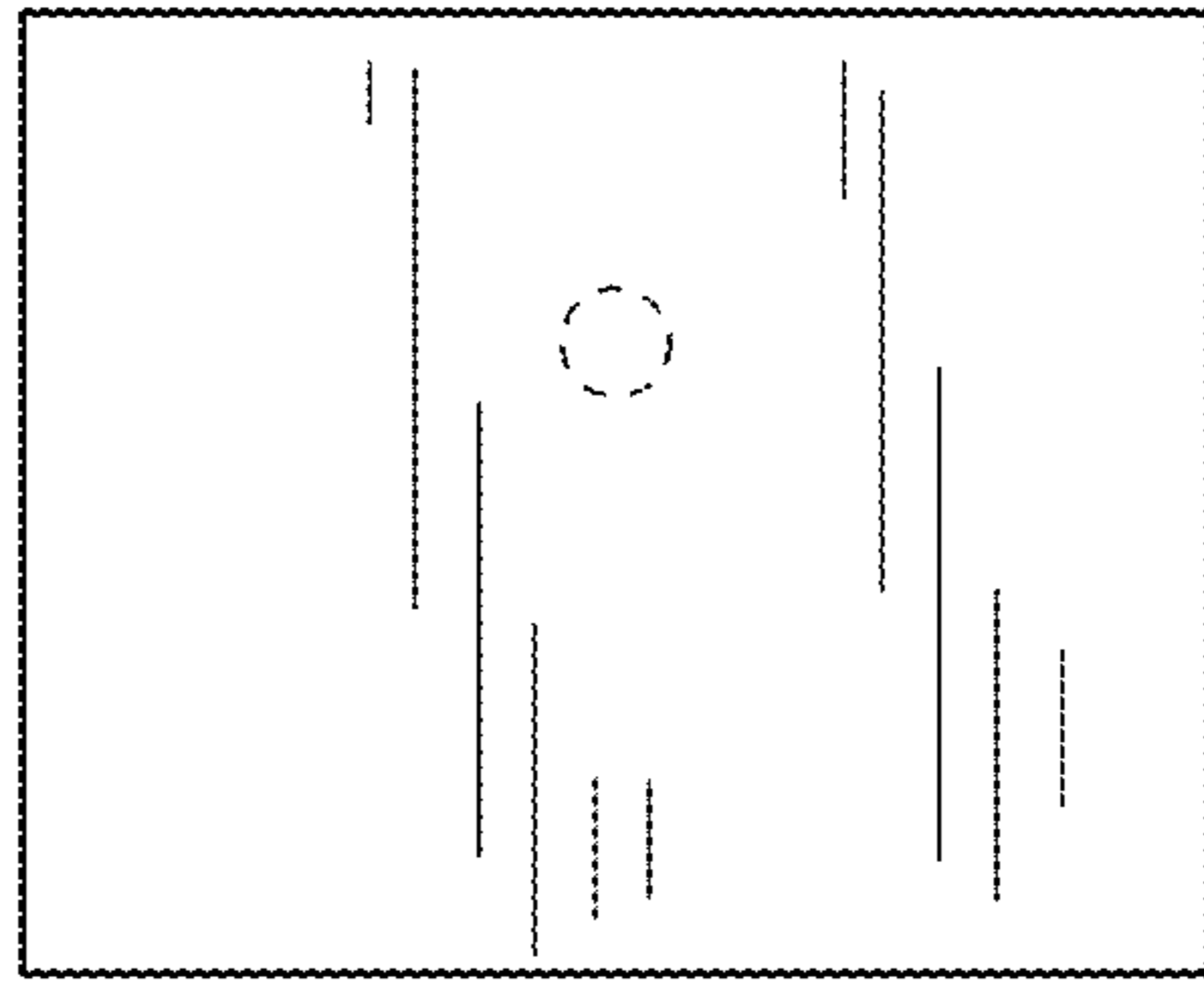

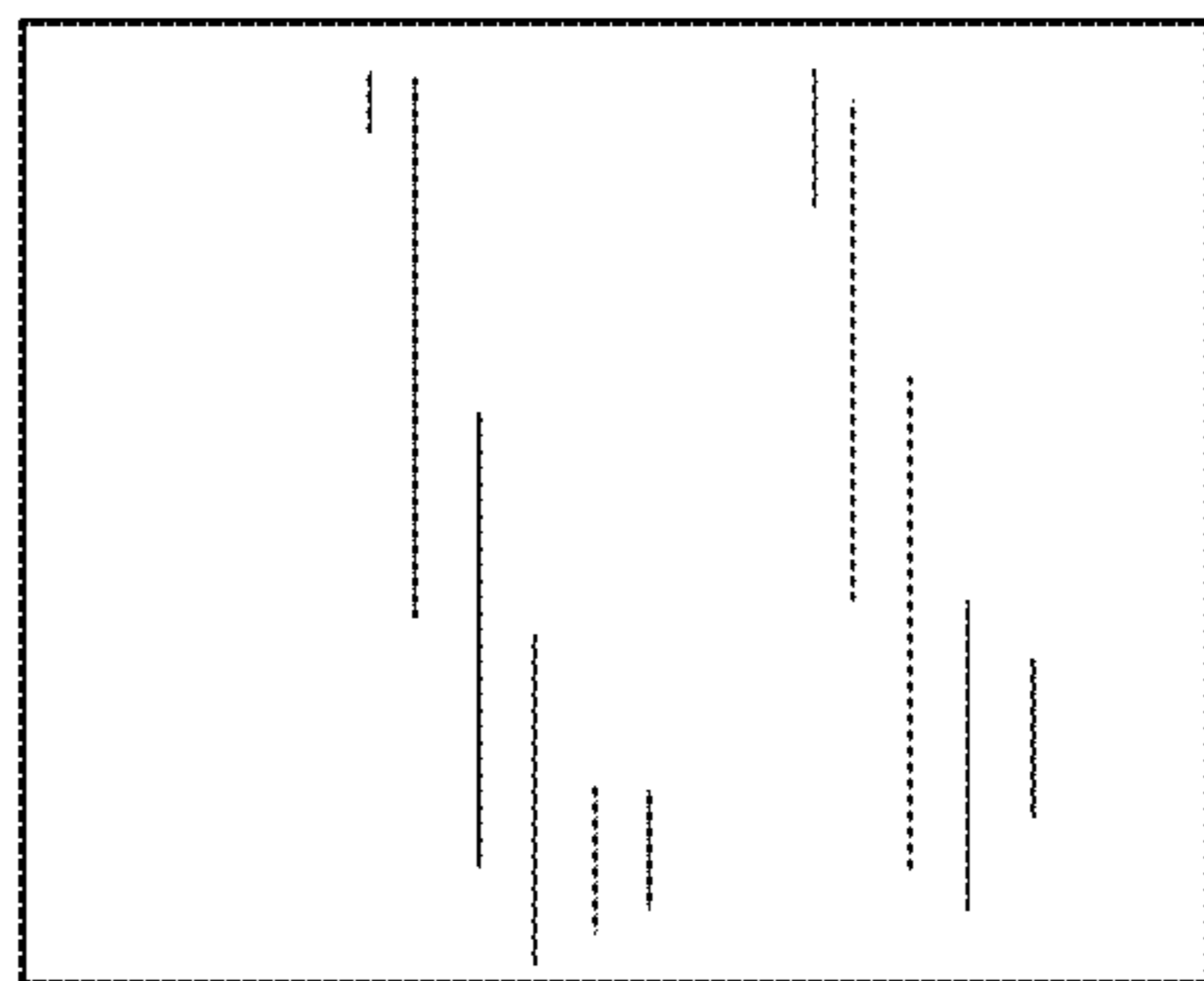

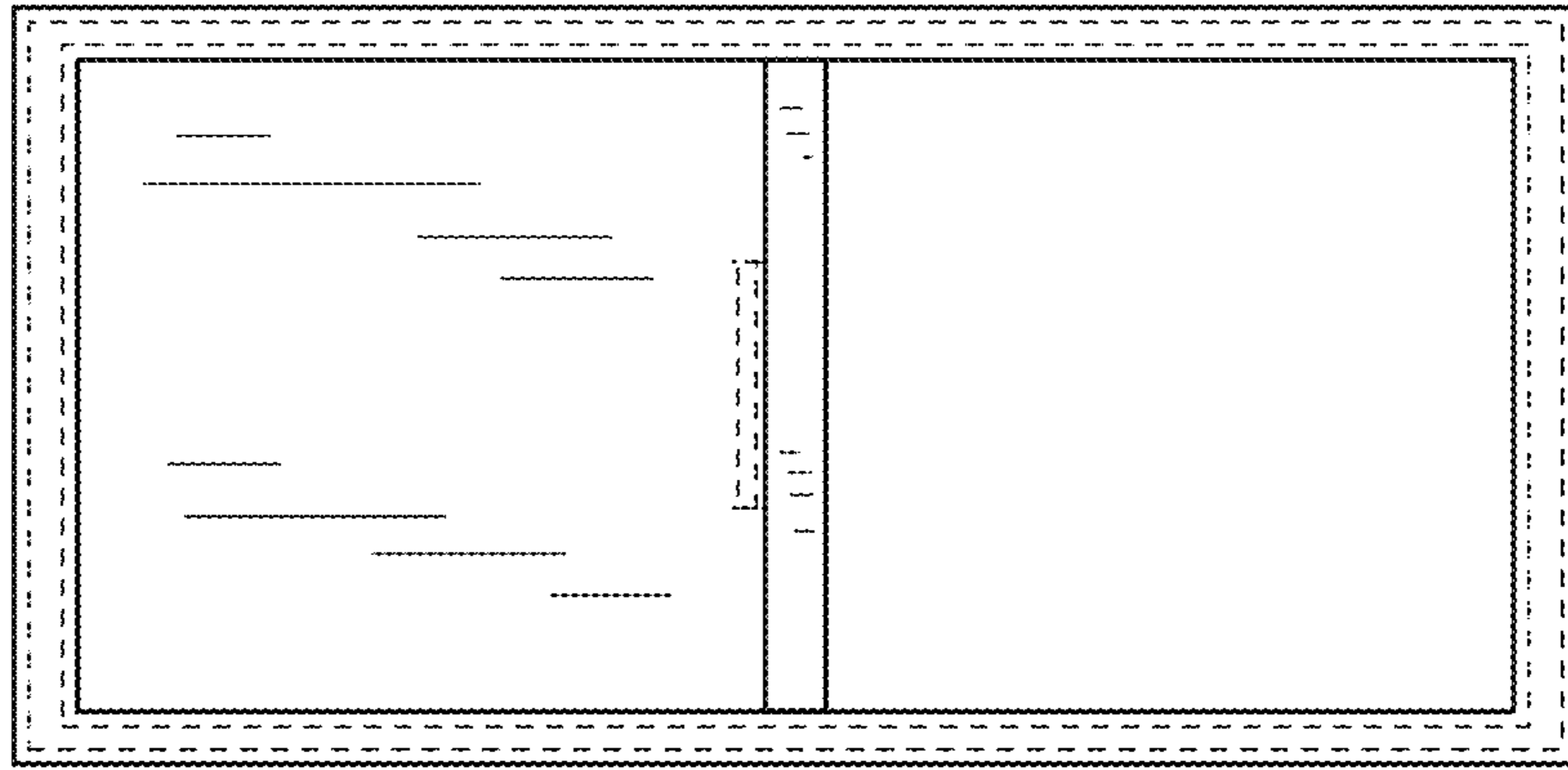

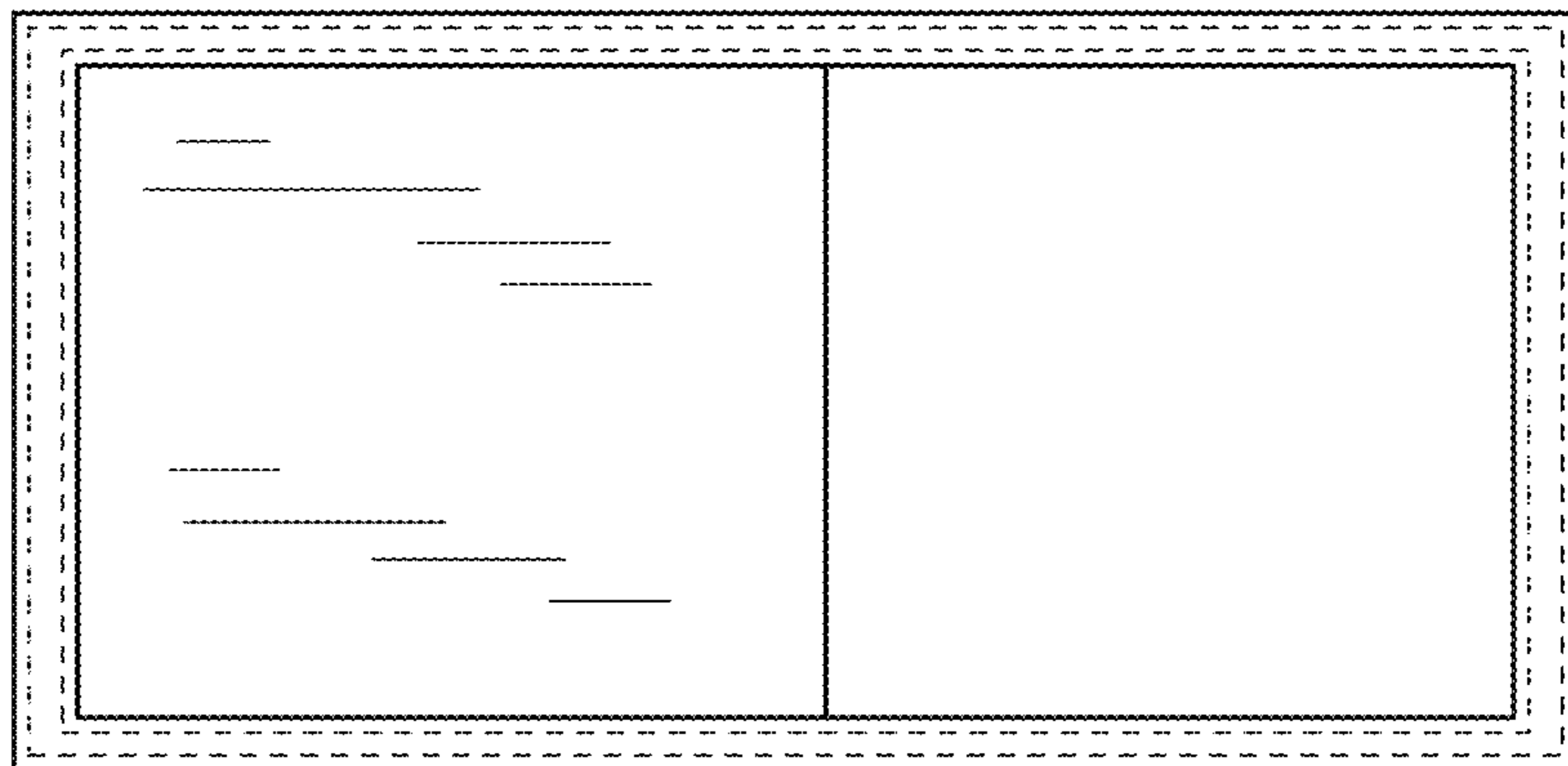
