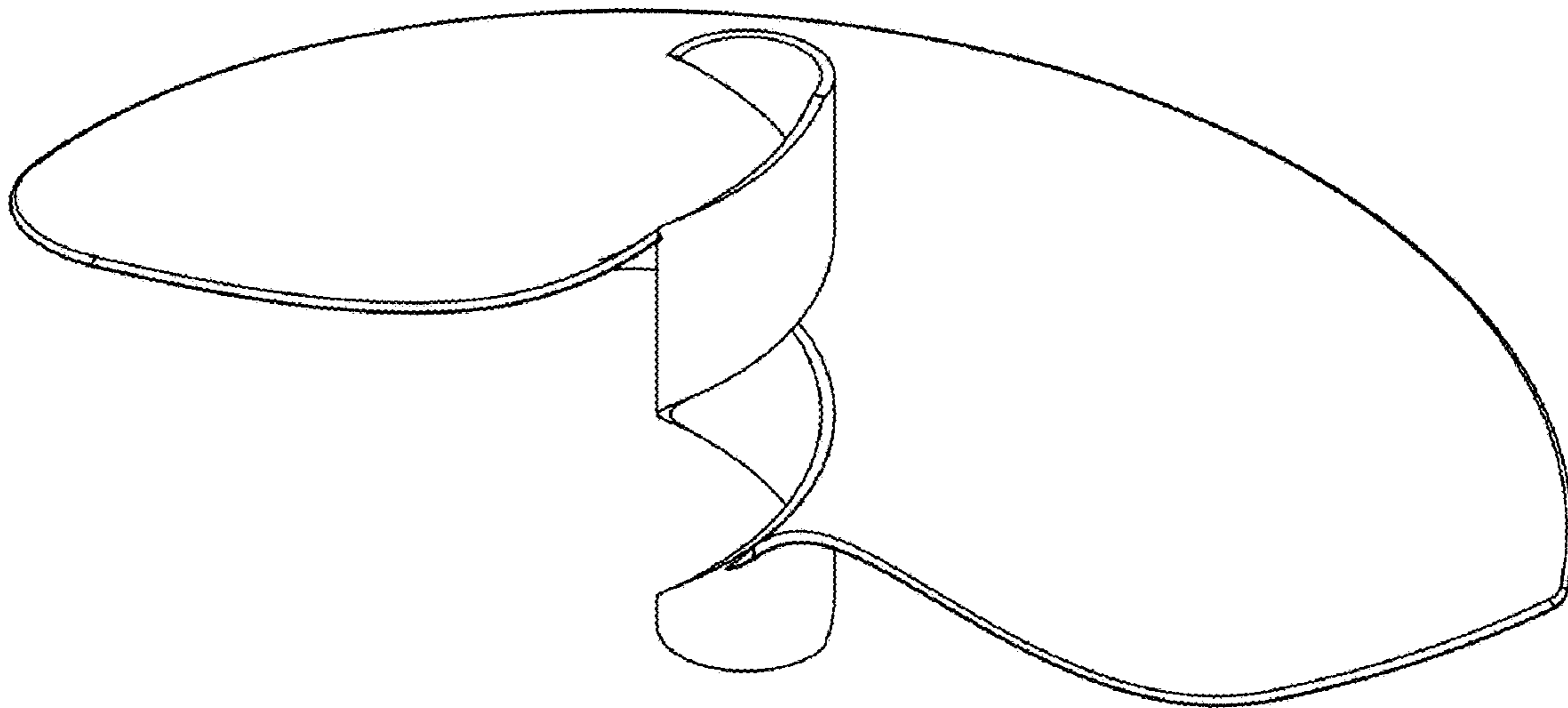
The ornamental design for an impeller, as shown and described.

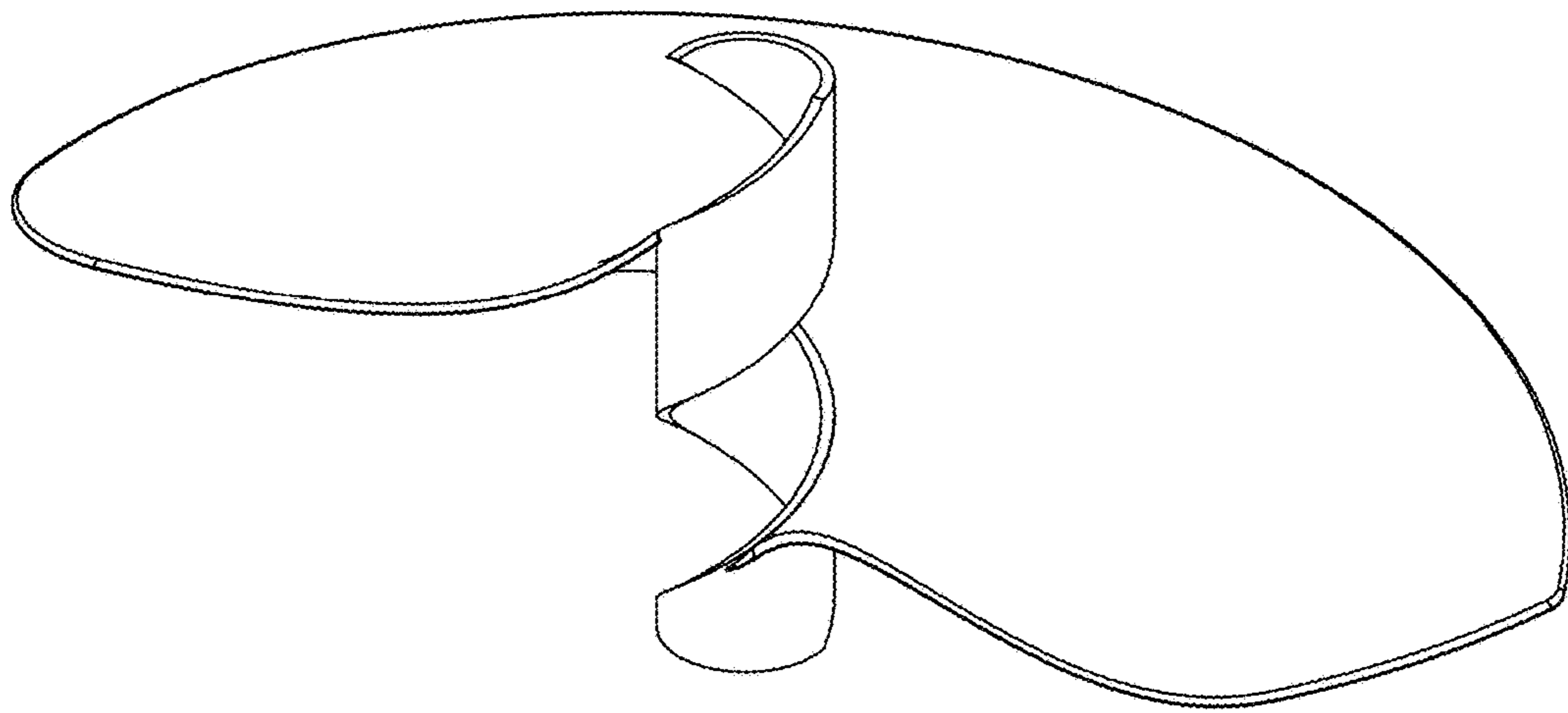

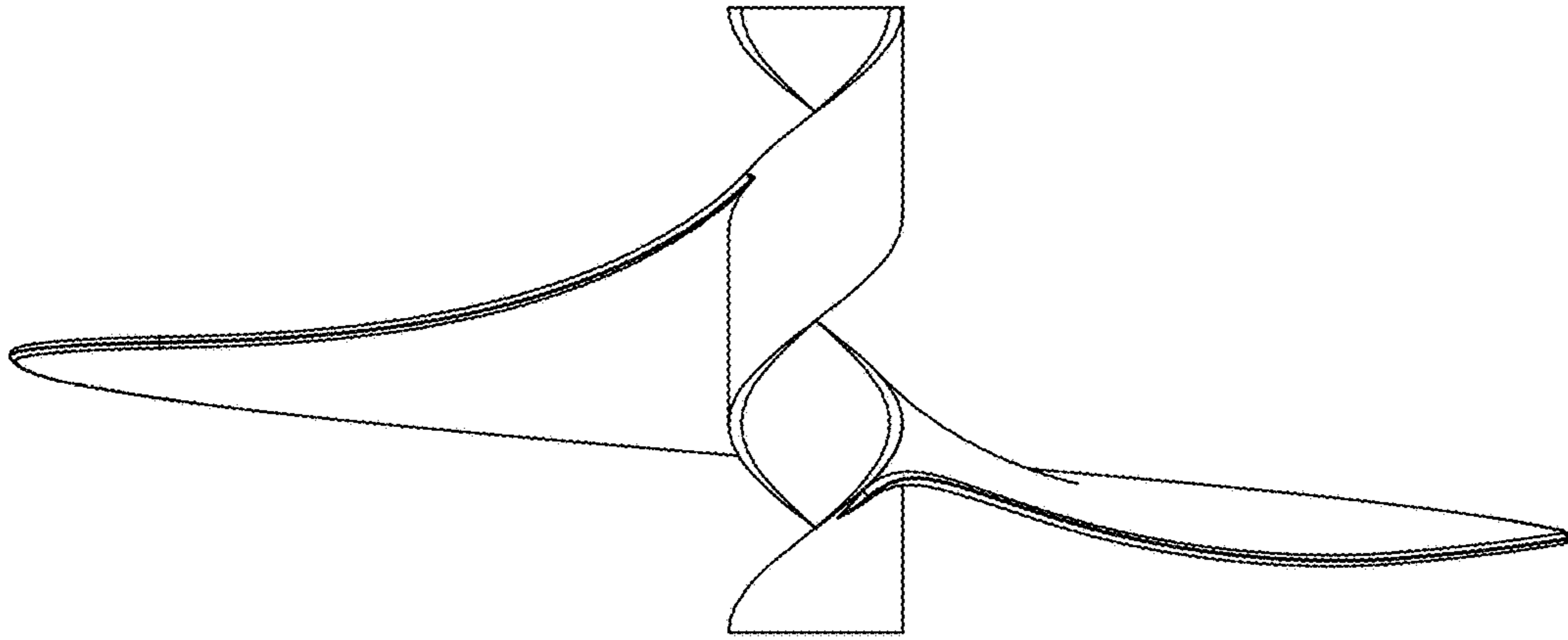

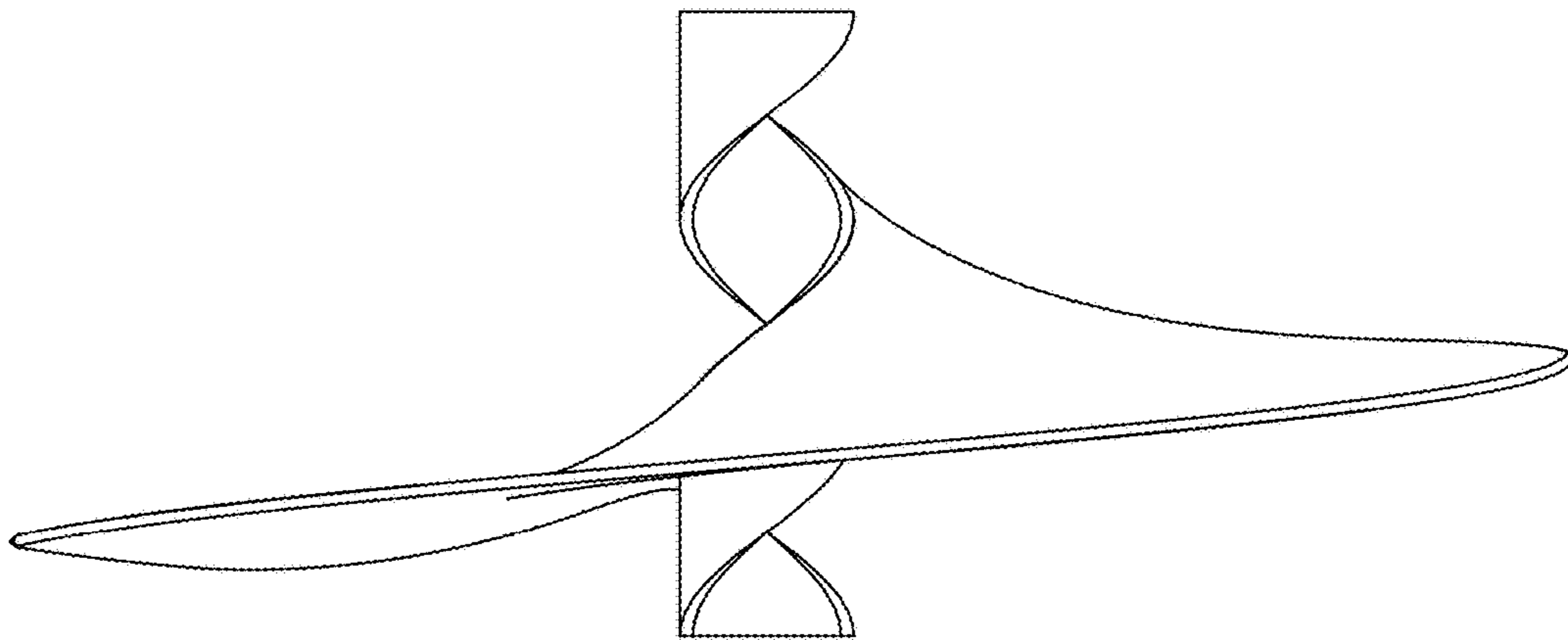

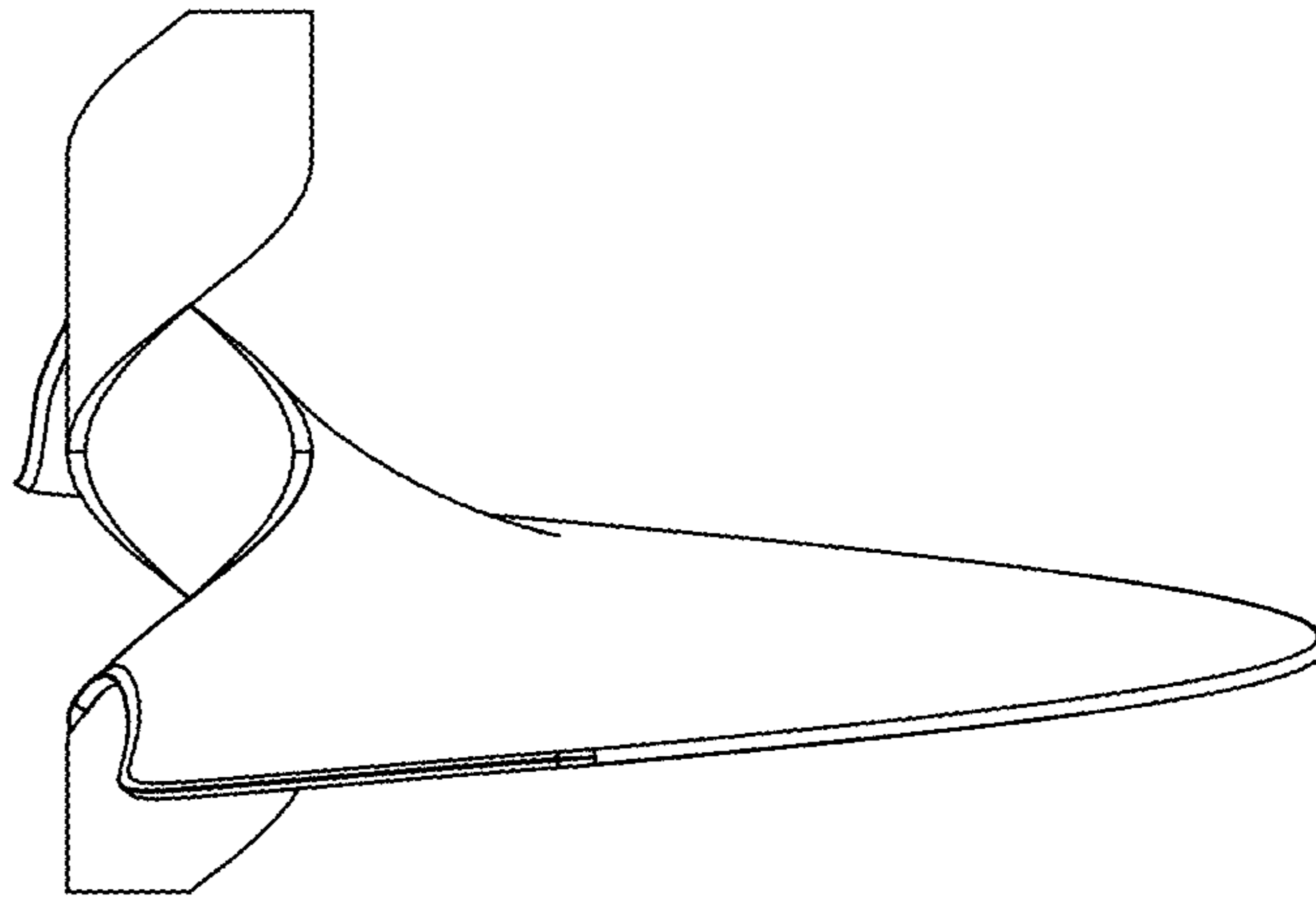

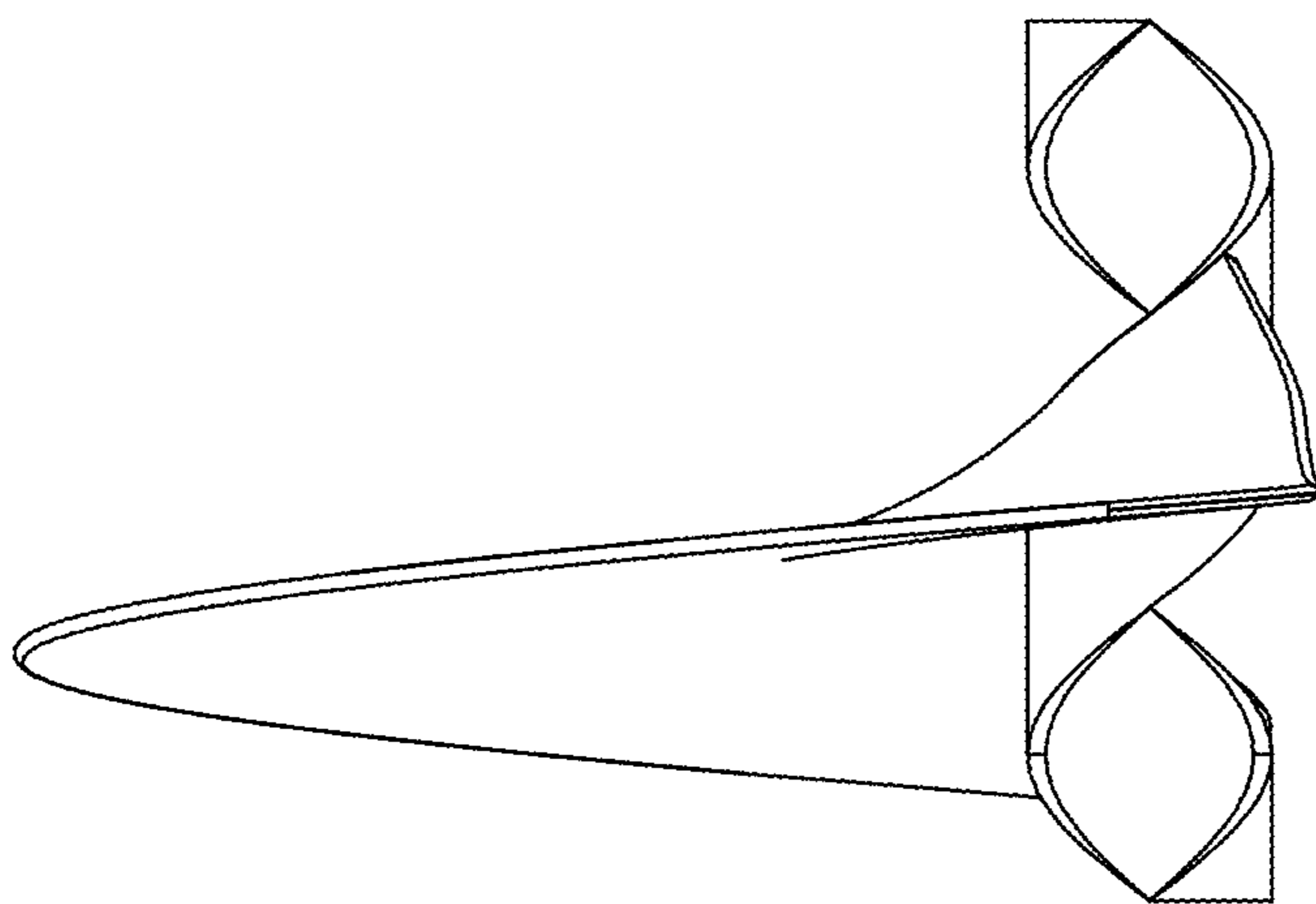

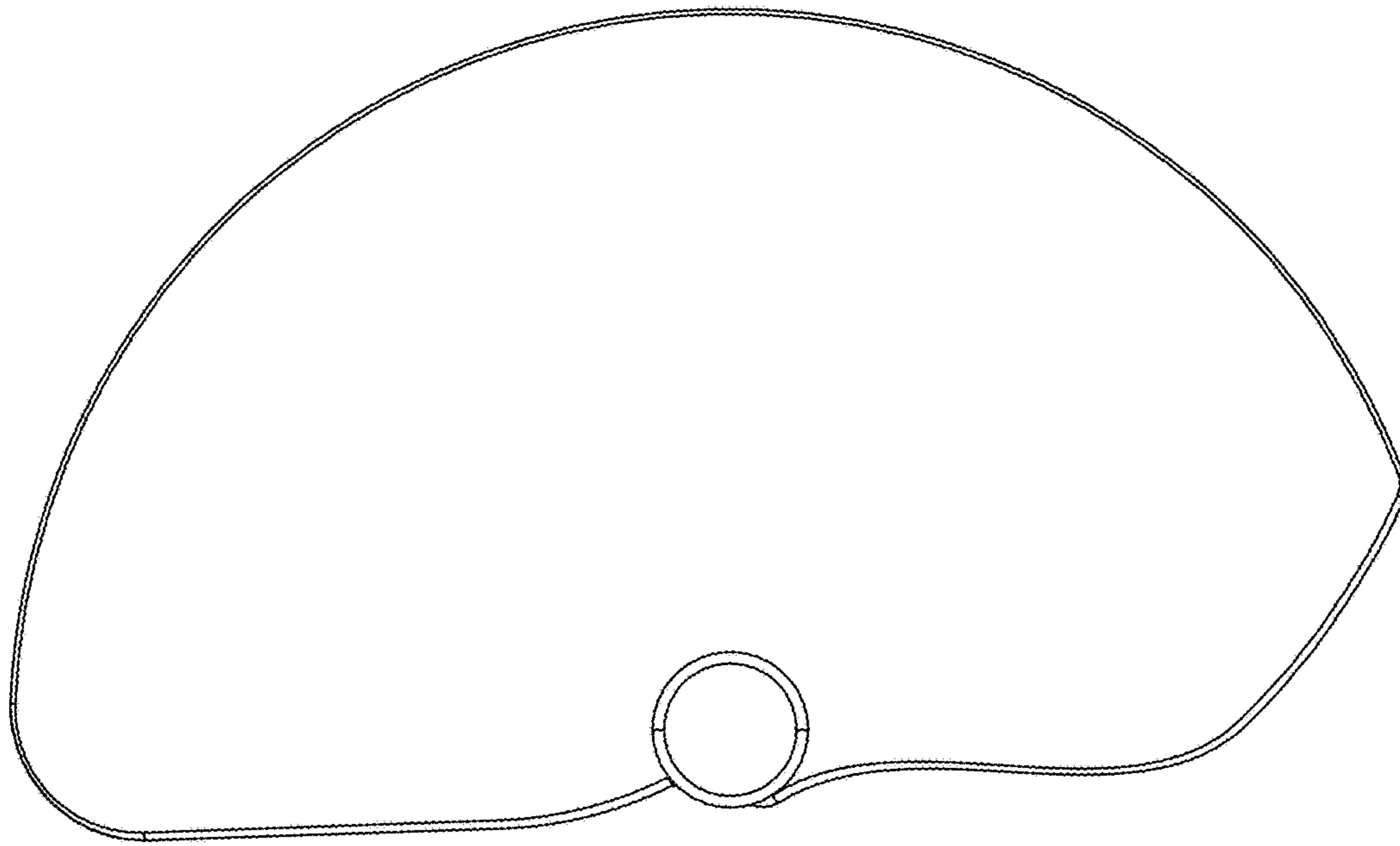

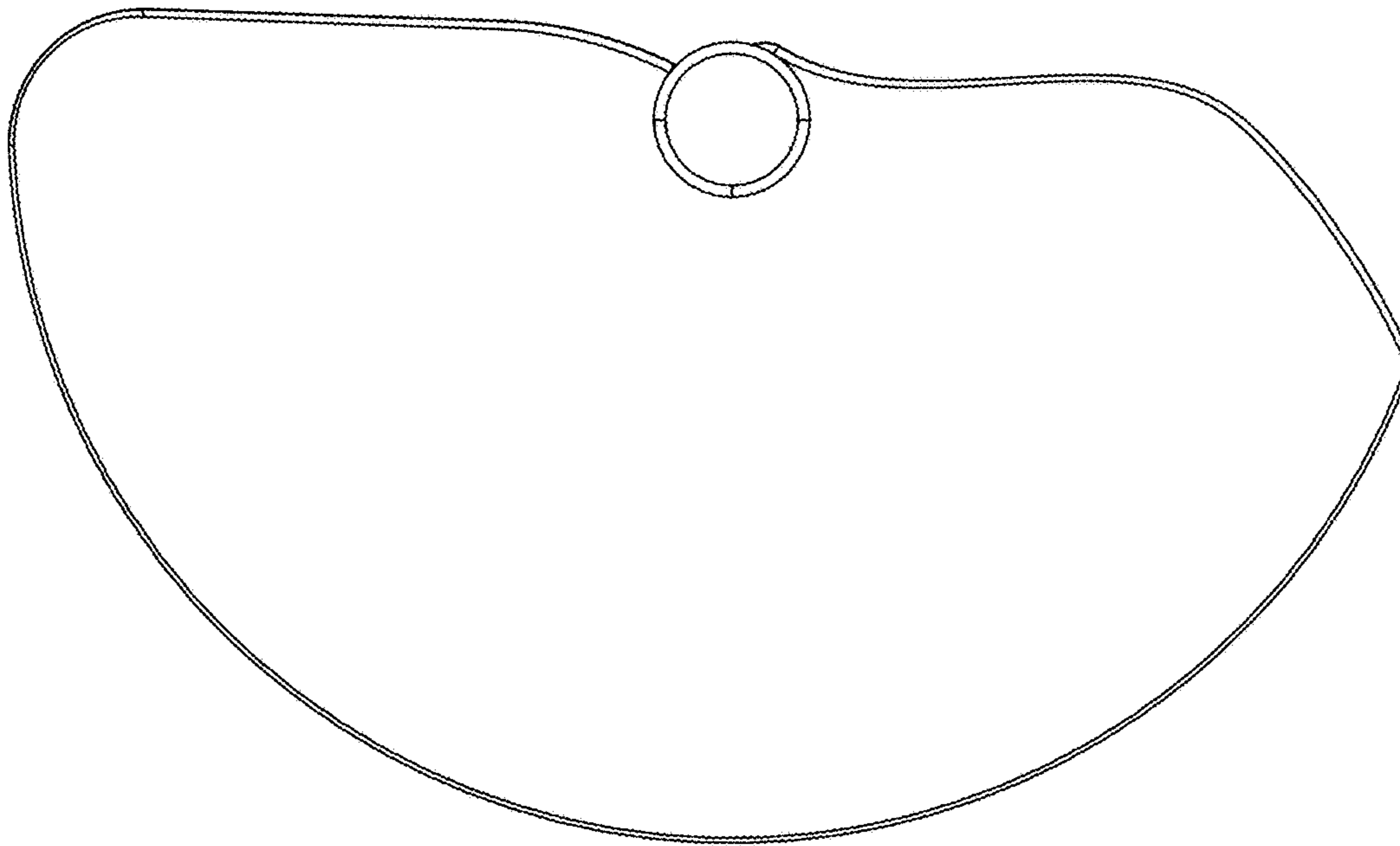
