(57) **CLAIM**

The ornamental design for a pair of yoga sock with straps, as shown and described.

DESCRIPTION

FIG. 1 is a perspective photographic view of a left sock for a pair of yoga socks with straps, the right foot being a mirror image thereof.

FIG. 2 is a top photographic partial view of a left sock for a pair of yoga socks with straps of FIG. 1.

FIG. 3 is a bottom photographic partial view of a left sock for a pair of yoga socks with straps of FIG. 1.

FIG. 4 is a first side photographic partial view of a left sock for a pair of yoga socks with straps of FIG. 1.

FIG. 5 is a second side photographic partial view of a left sock for a pair of yoga socks with straps of FIG. 1.

FIG. 6 is a front photographic partial view of a left sock for a pair of yoga socks with straps of FIG. 1.

FIG. 7 is an enlarged photographic partial view of a left sock for a pair of yoga socks with straps of FIG. 1, showing the straps folded over to display the surface texture of the straps.

FIG. 8 is a perspective photographic partial view of a right sock for a pair of yoga socks with straps.

FIG. 9 is a top photographic partial view of a right sock for a pair of yoga socks with straps of FIG. 8.

FIG. 10 is a bottom photographic partial view of a right sock for a pair of yoga socks with straps of FIG. 8.

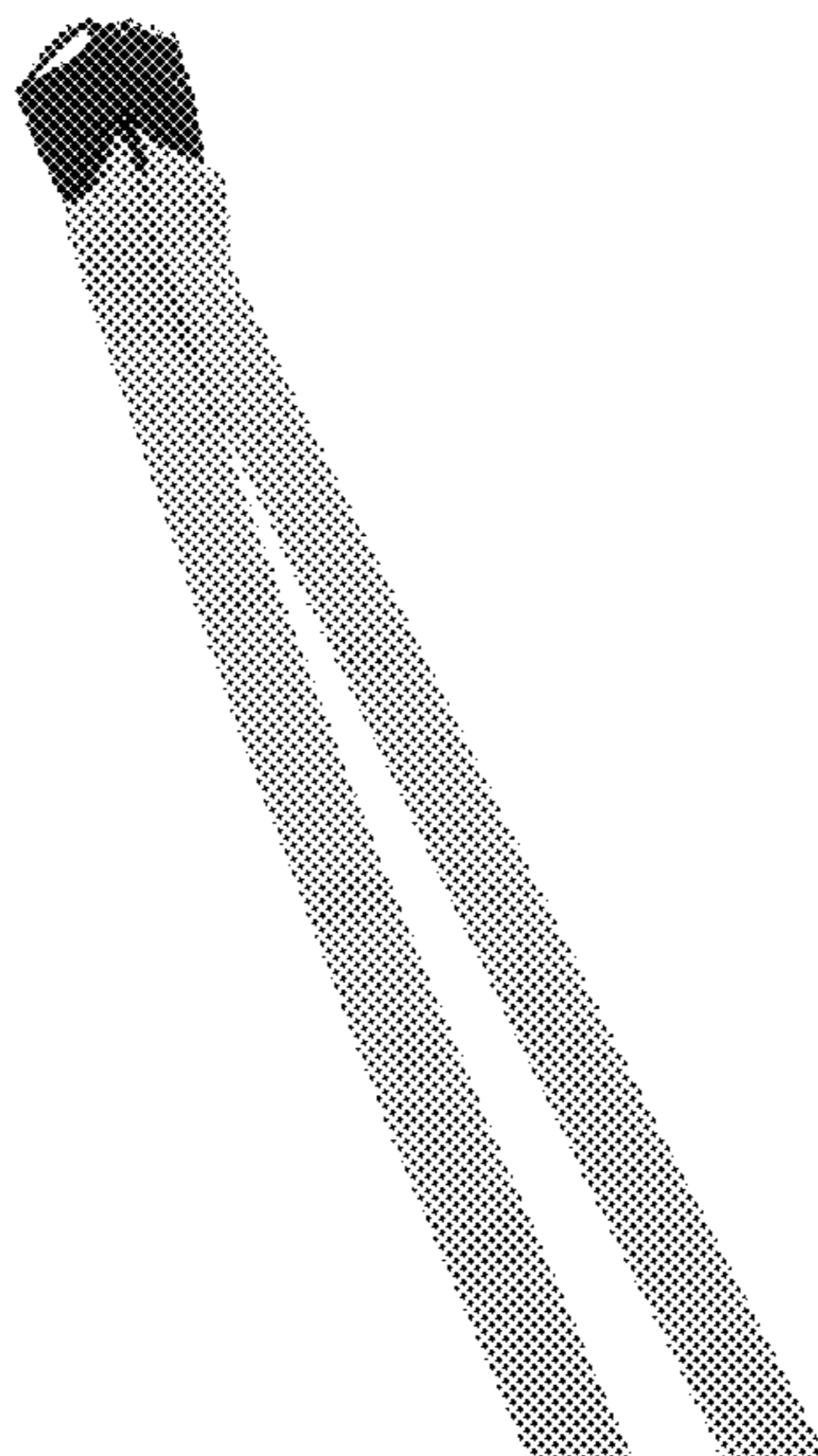
FIG. 11 is a first side photographic partial view of a right sock for a pair of yoga socks with straps of FIG. 8.

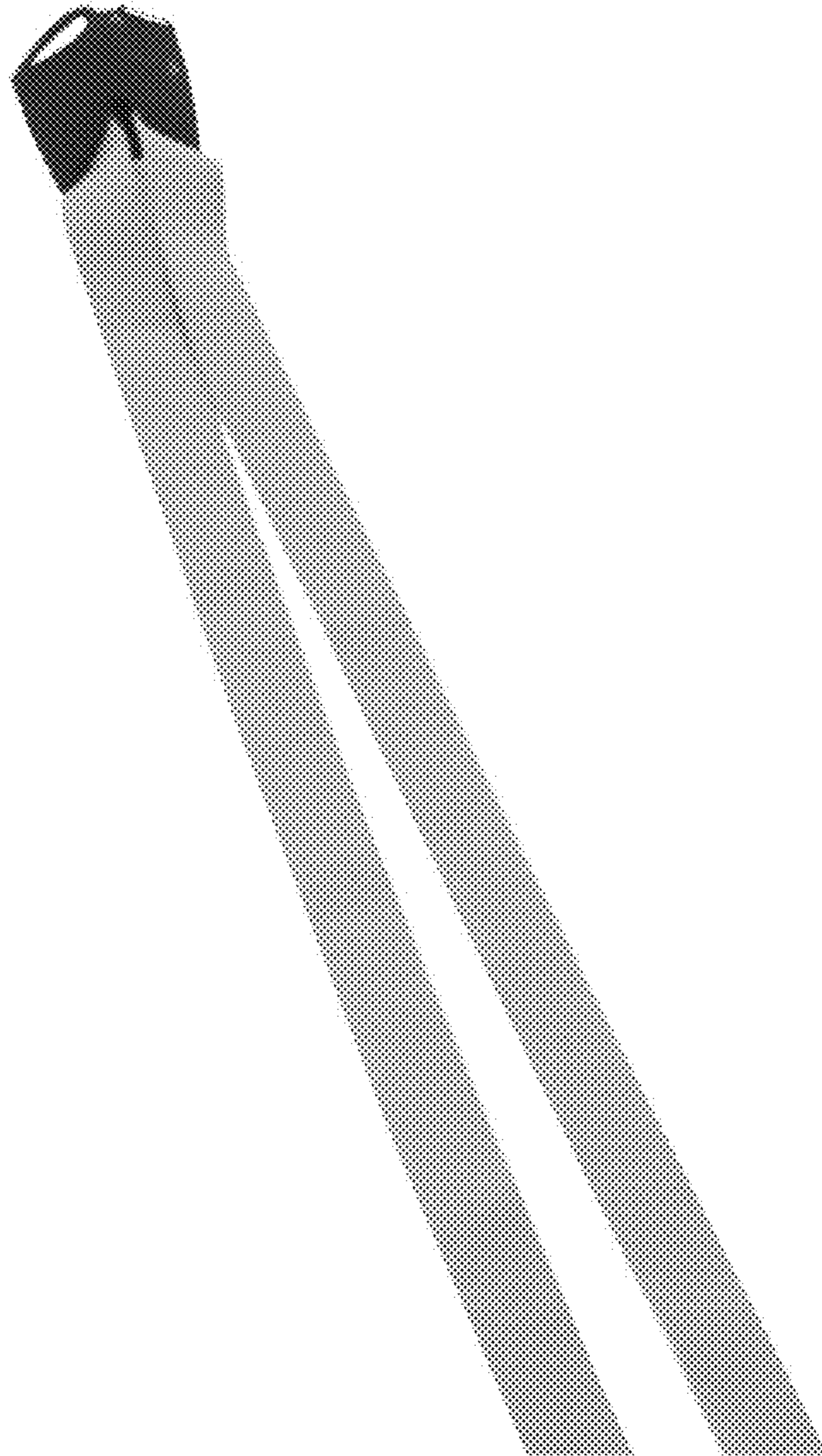

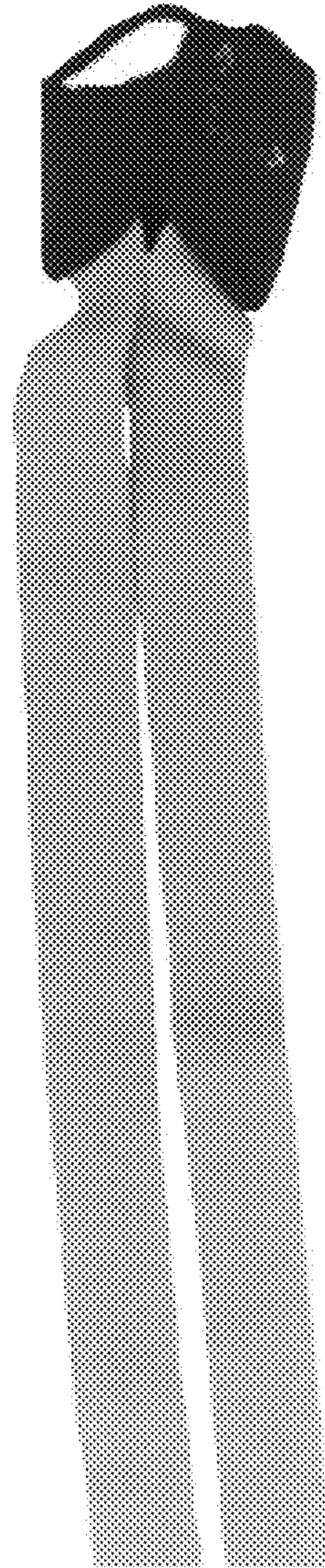

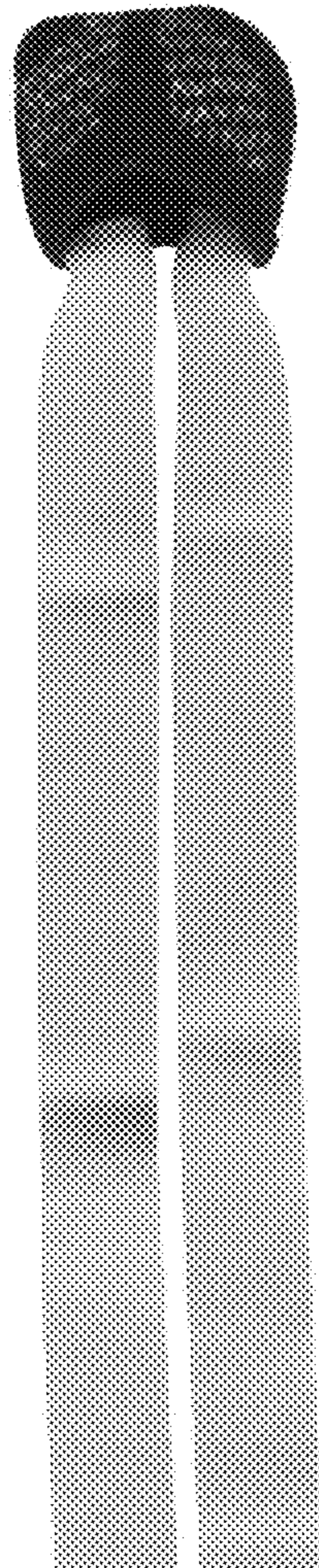

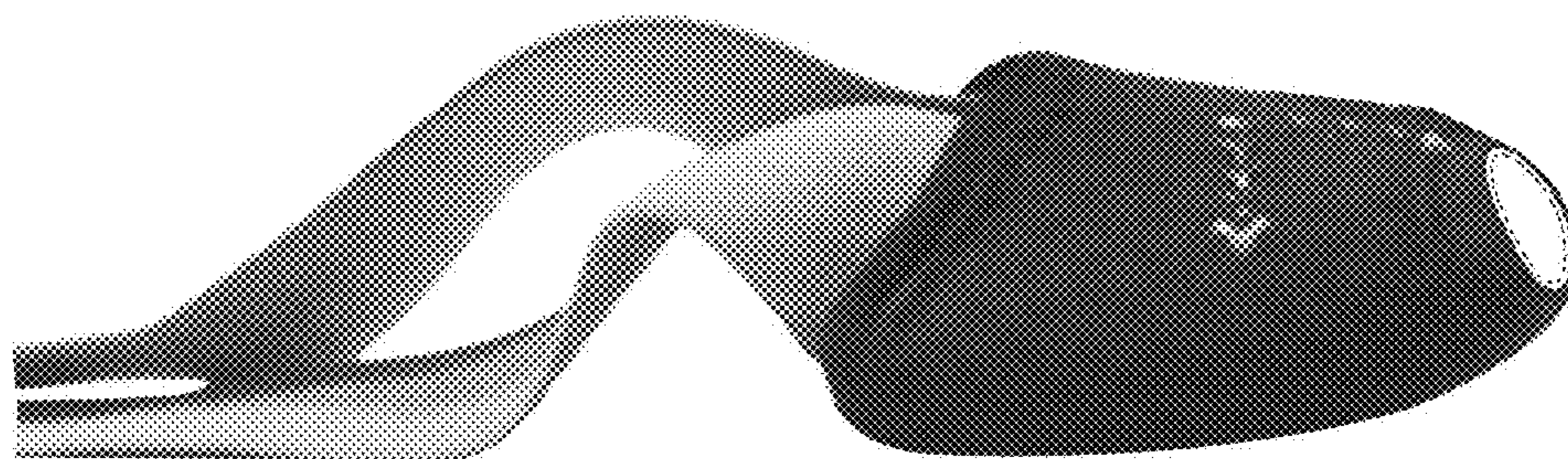

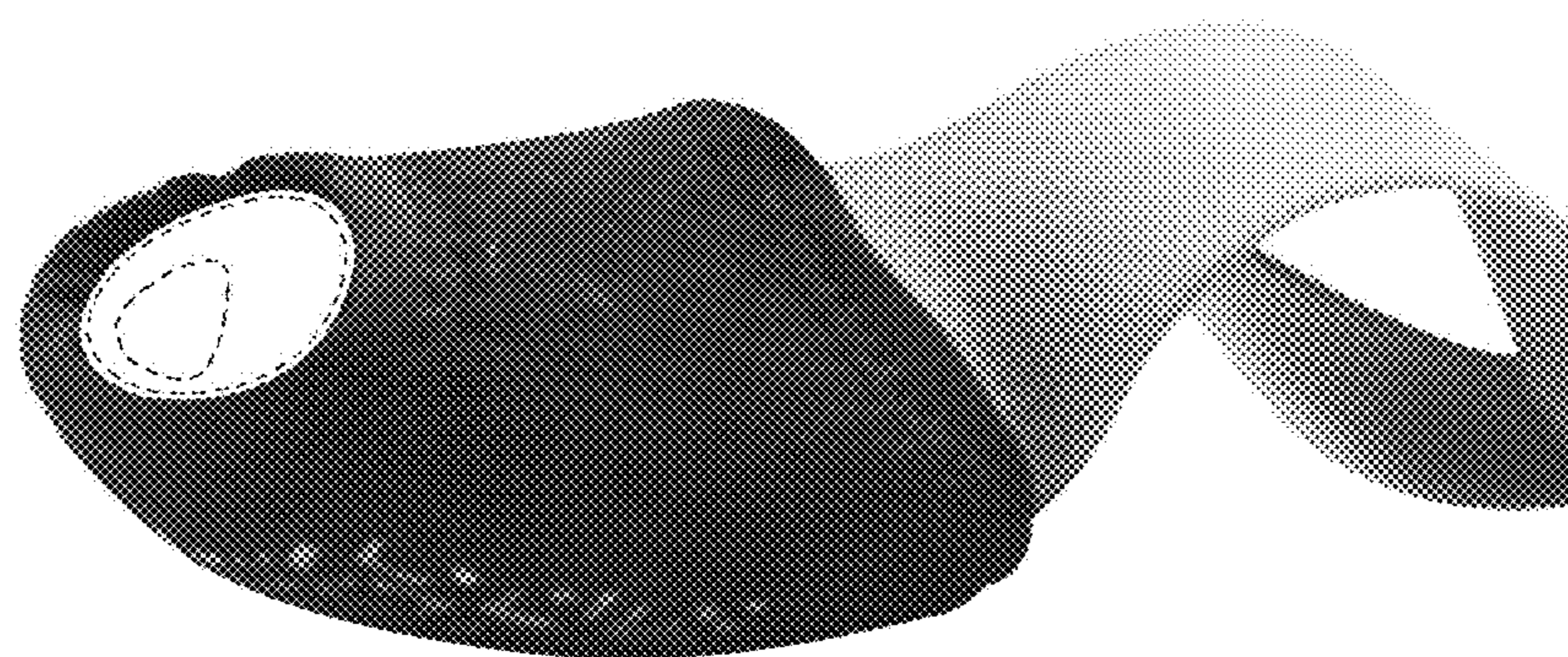

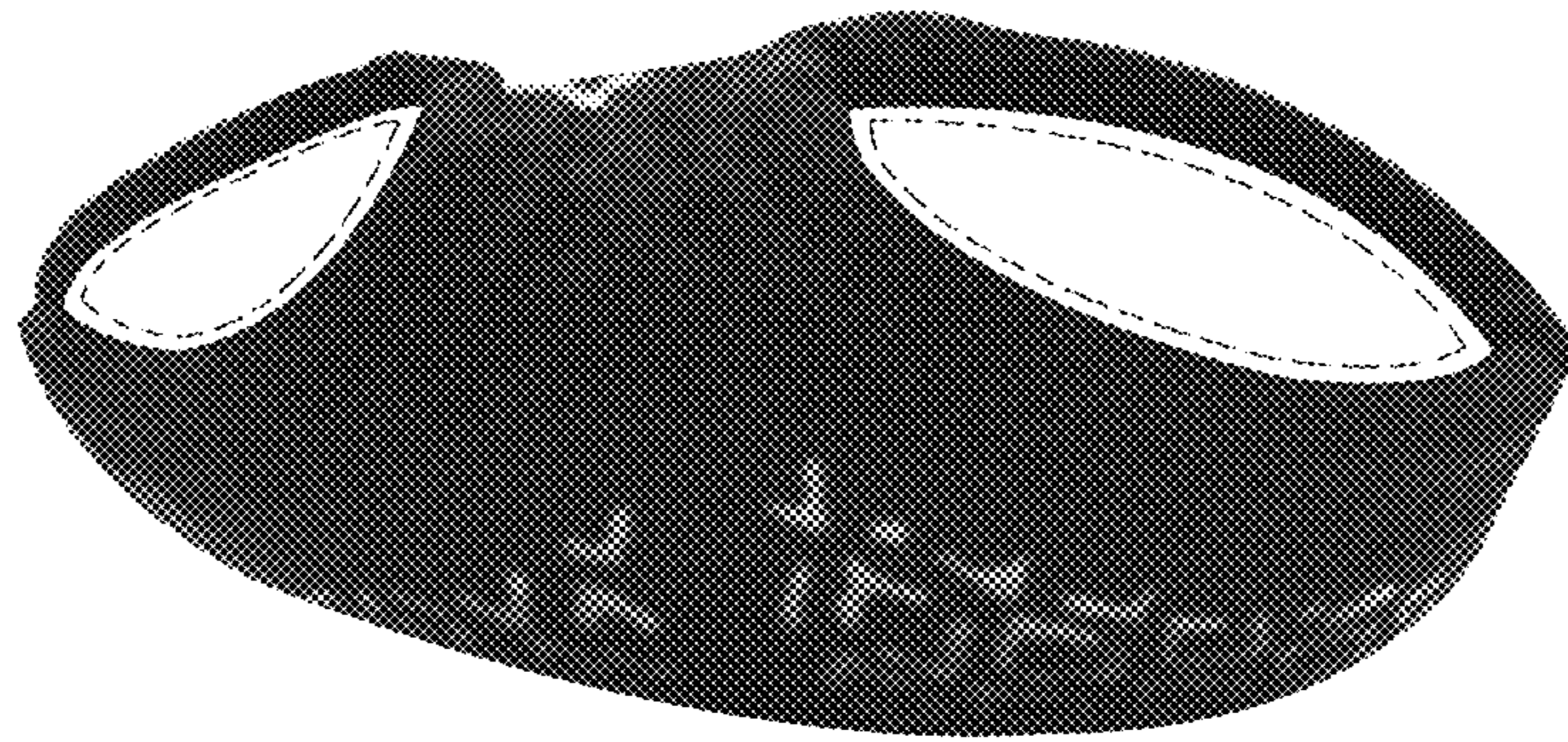

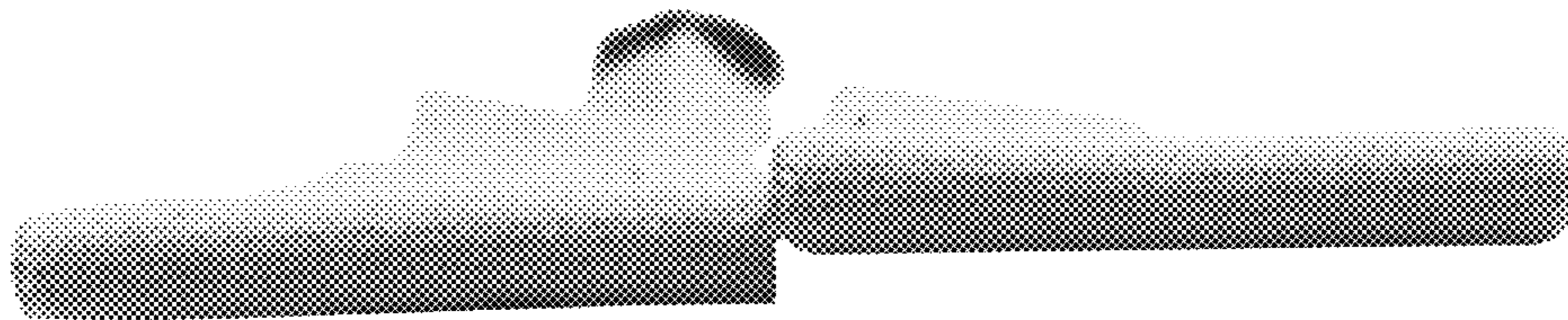

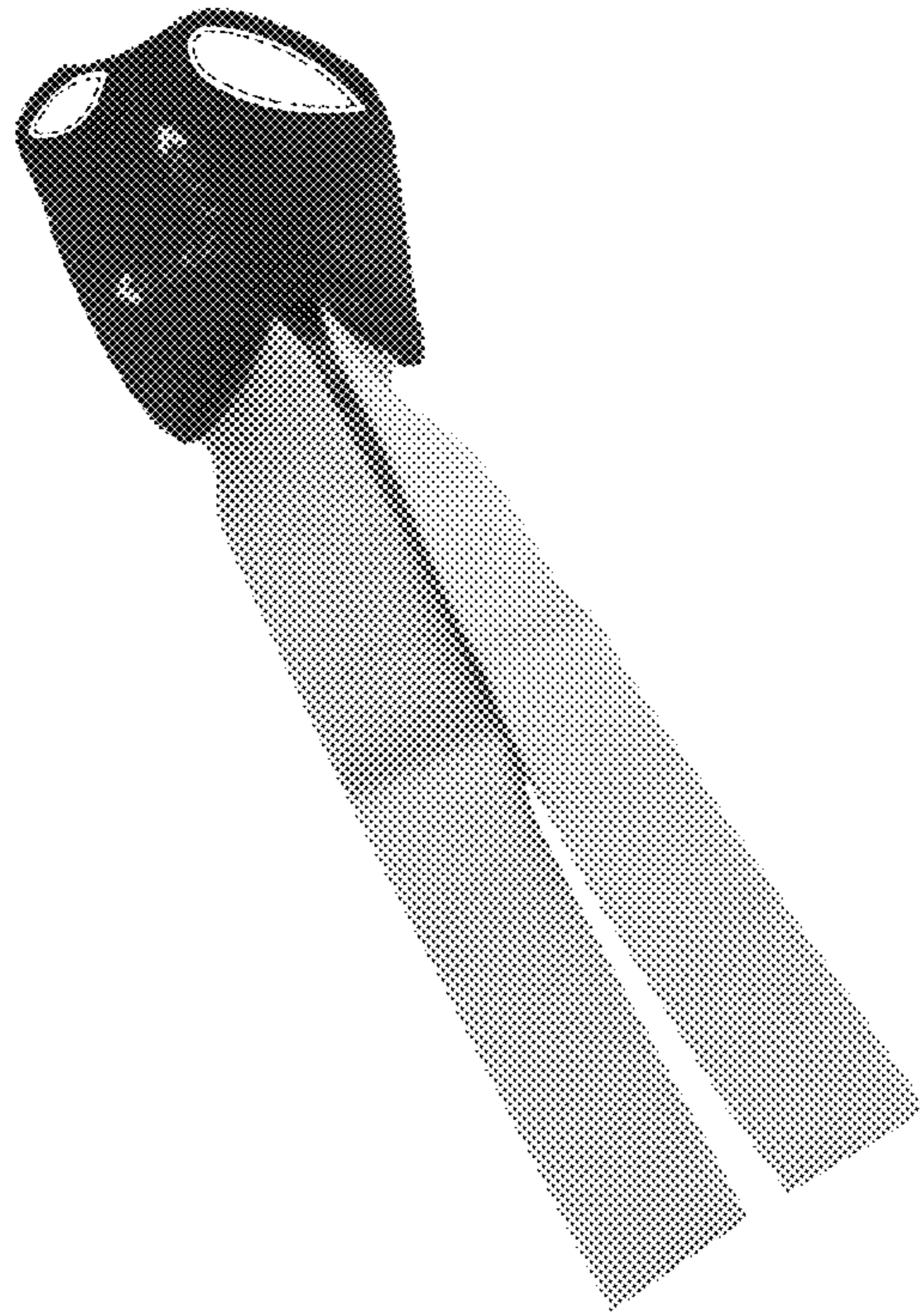

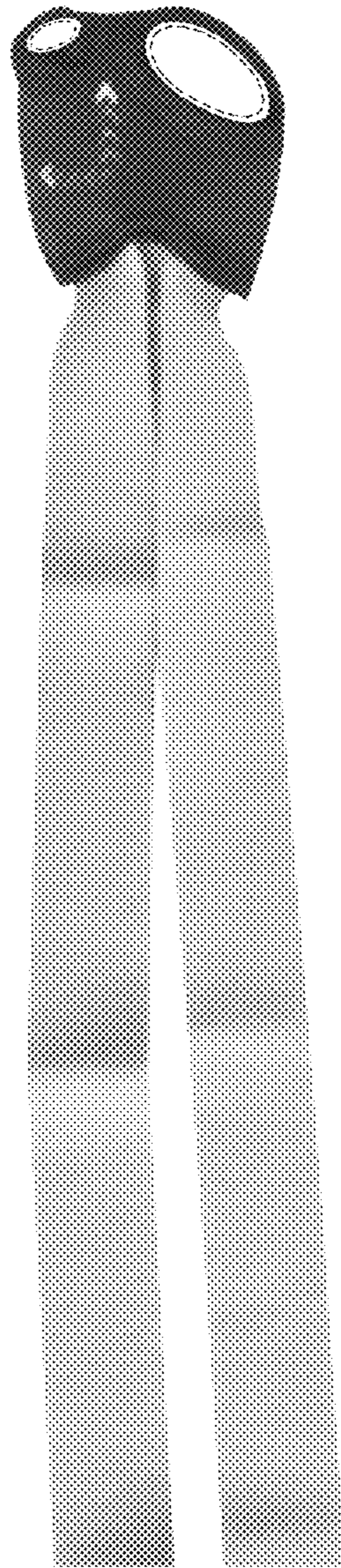

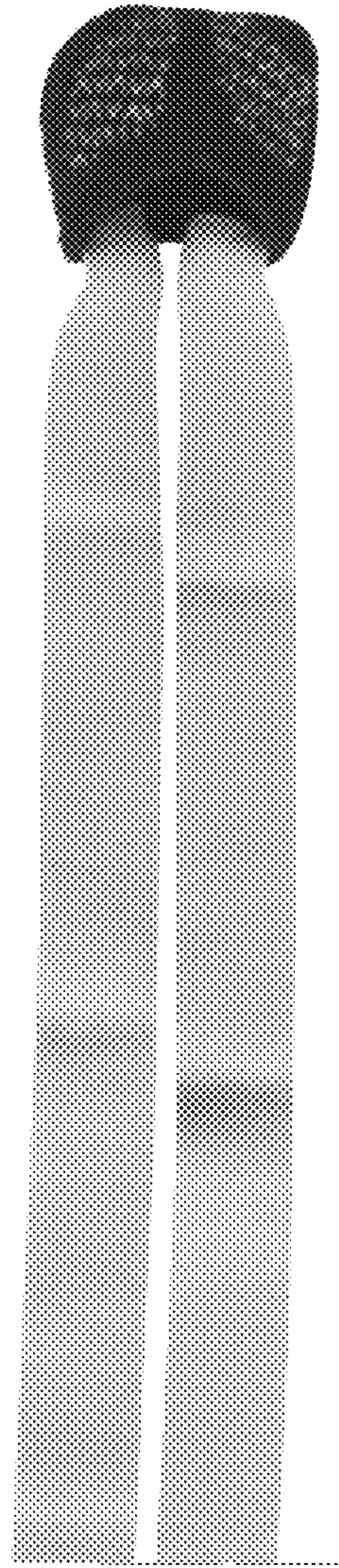

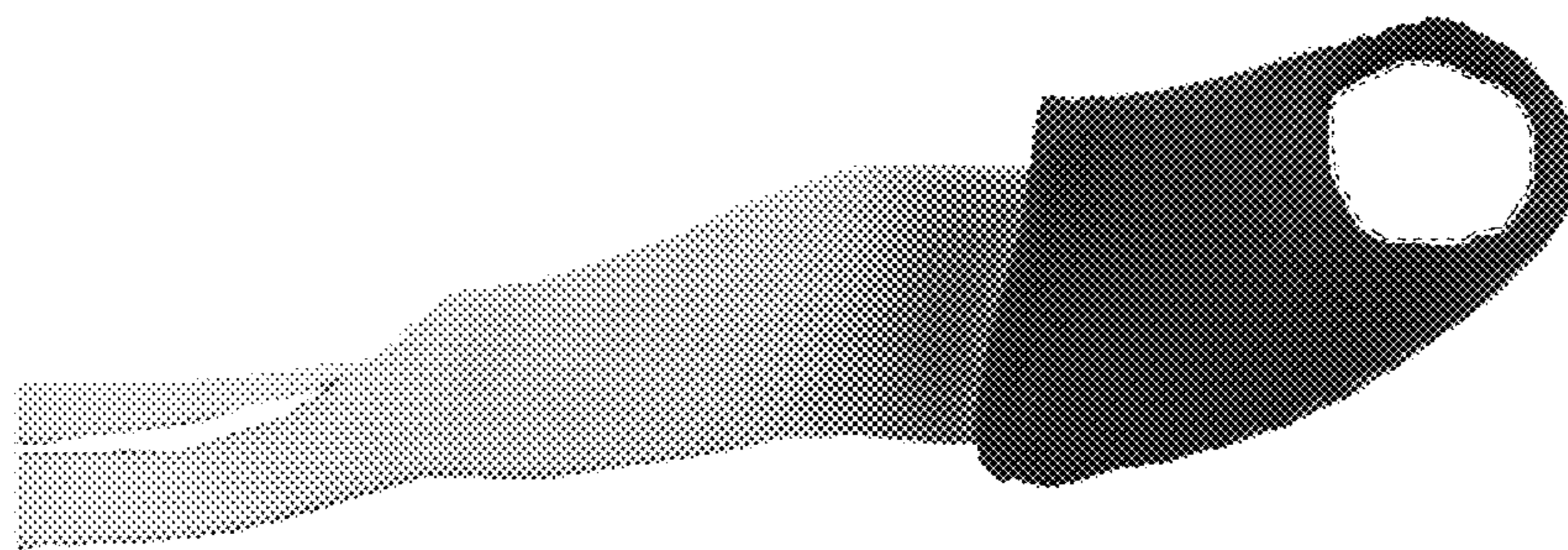

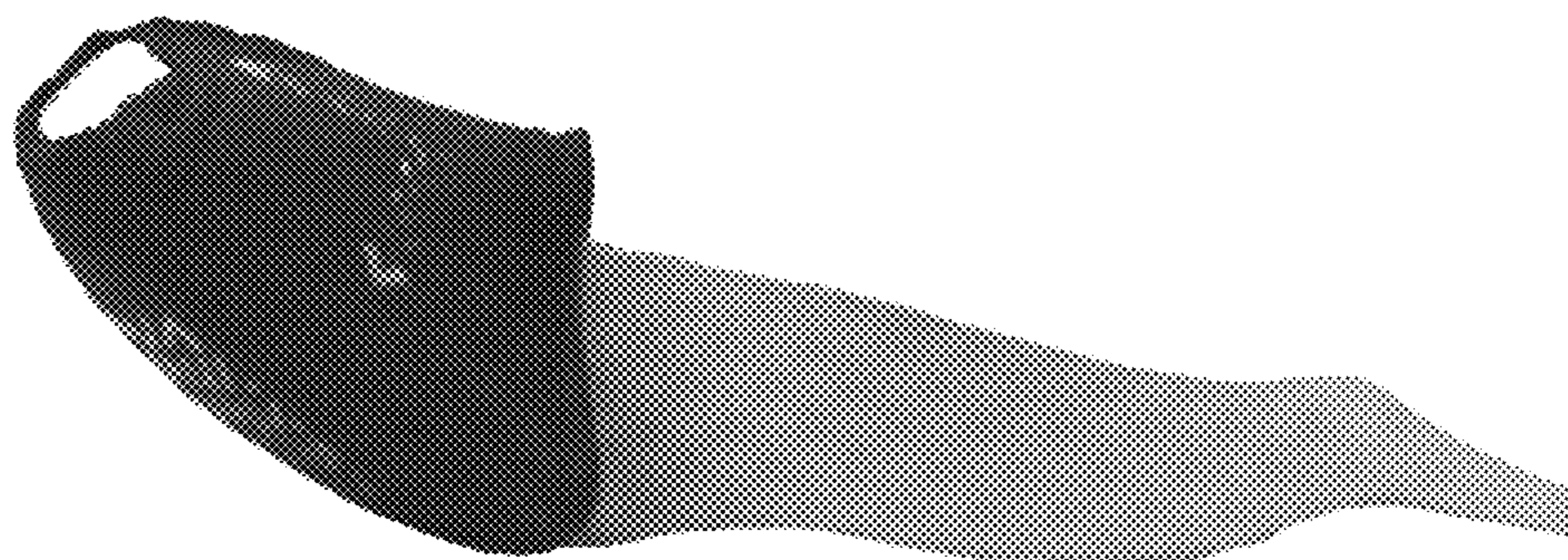

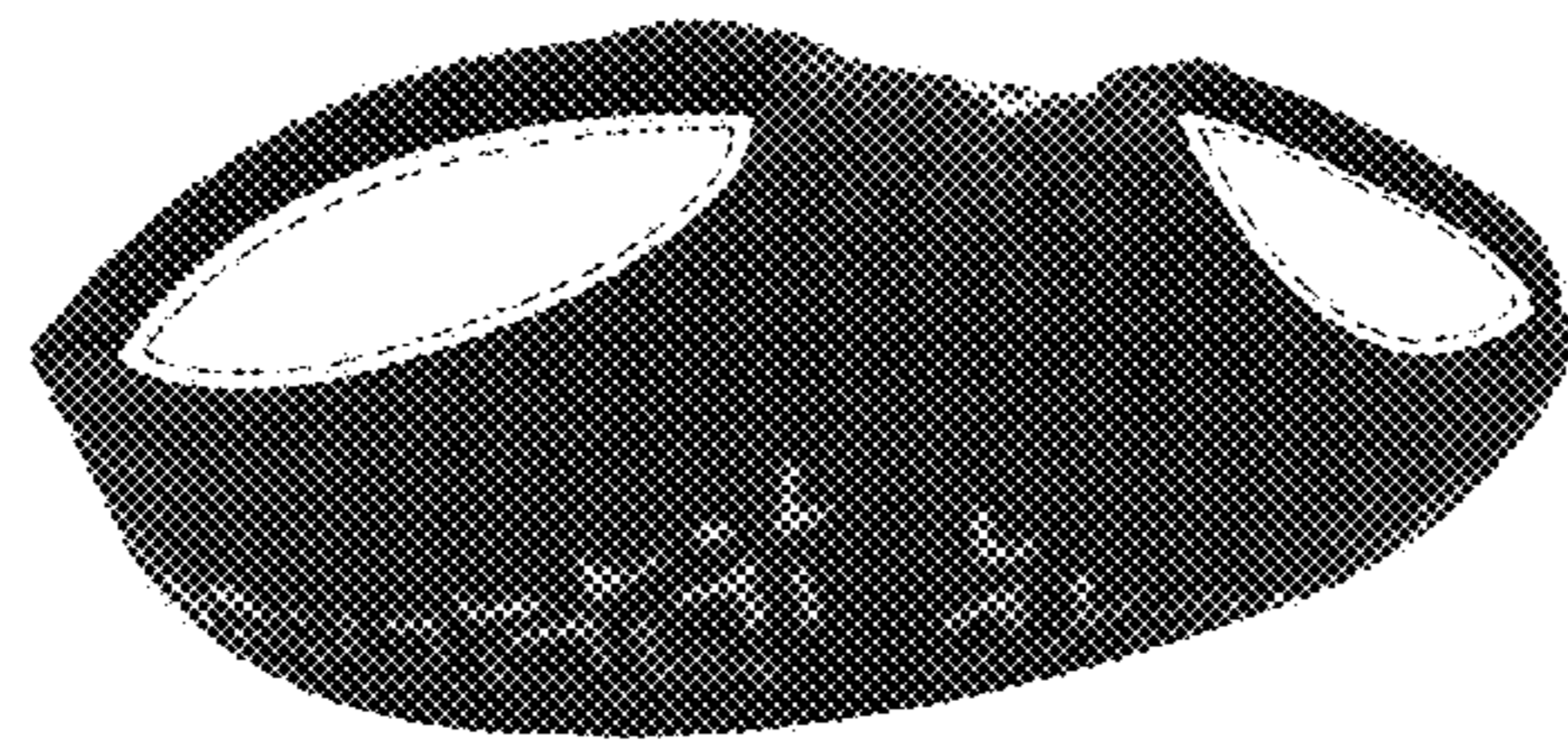

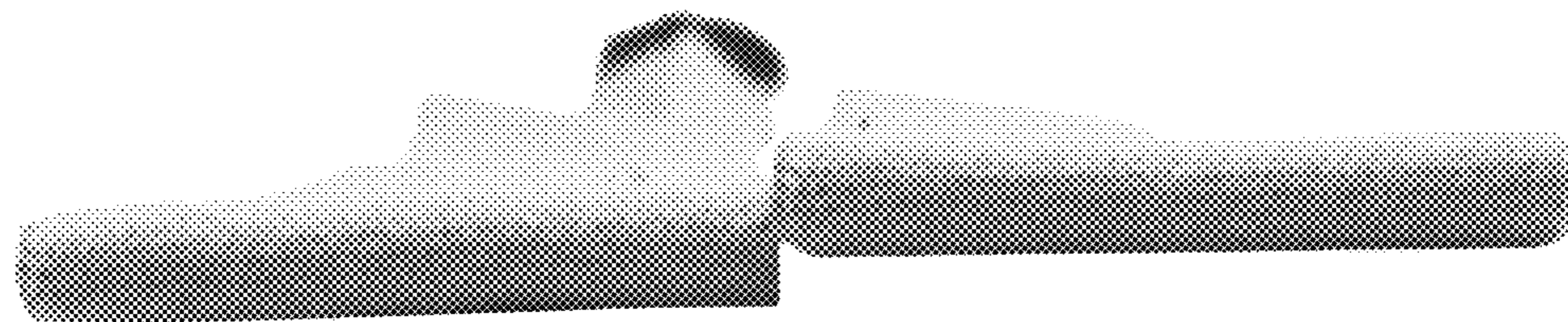
