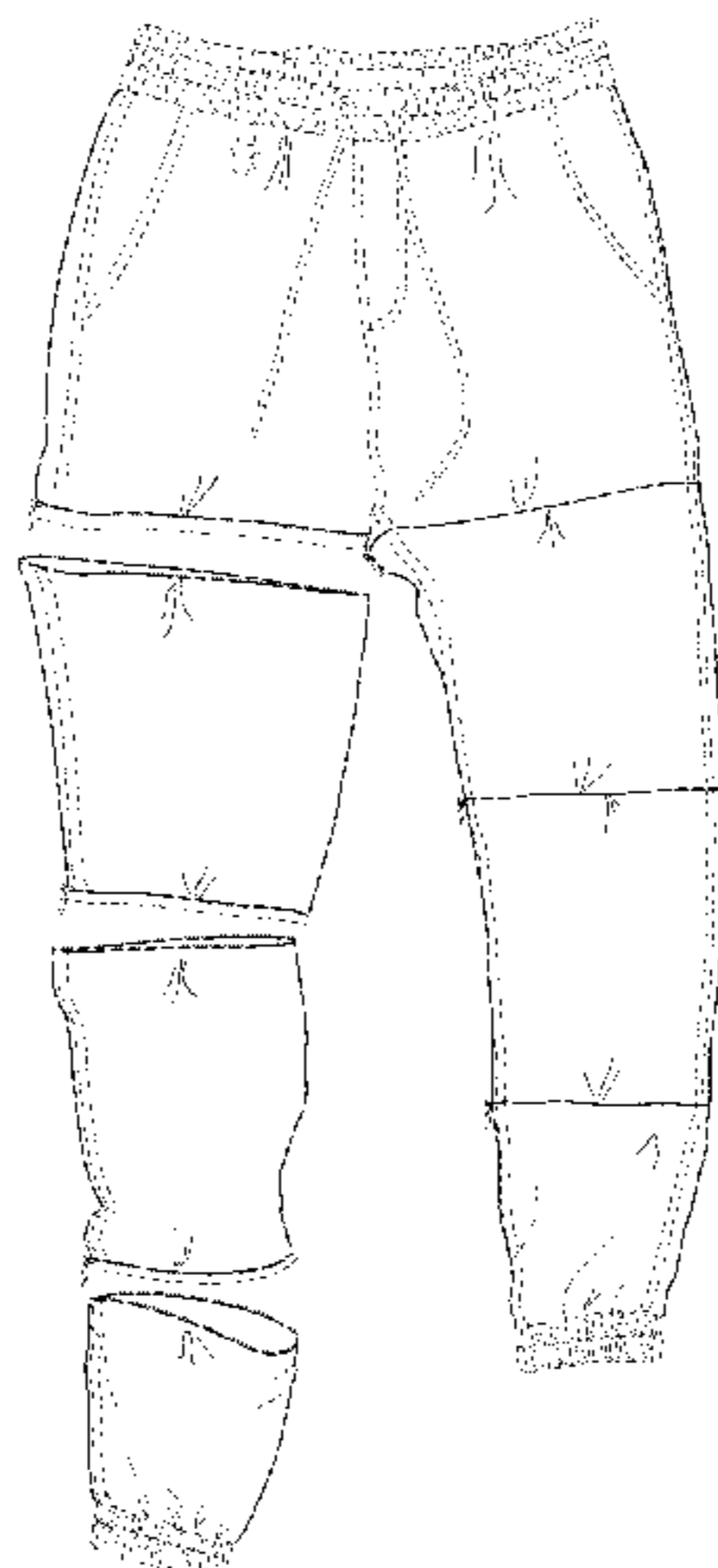
(57) **CLAIM**

The ornamental design for pants, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of pants showing my new design;
FIG. 2 is a rear perspective view thereof; and,
FIG. 3 is an enlarged, front perspective view of pants showing my new design.
The broken line portions of the drawings depict portions of the article including the waistband, the drawstring, the pockets, the key ring, the cuffs, the zipper tabs, and the seams, and form no part of the claimed design.

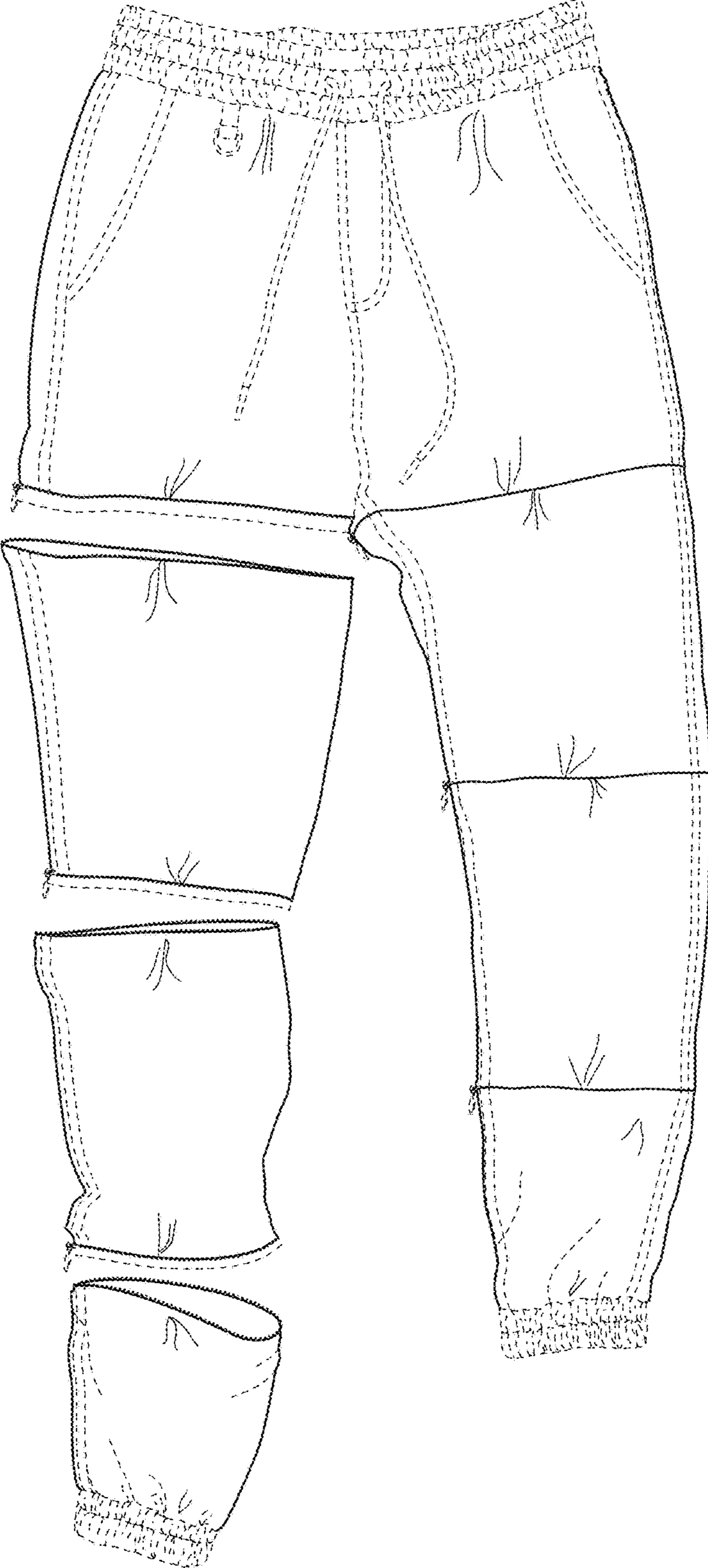

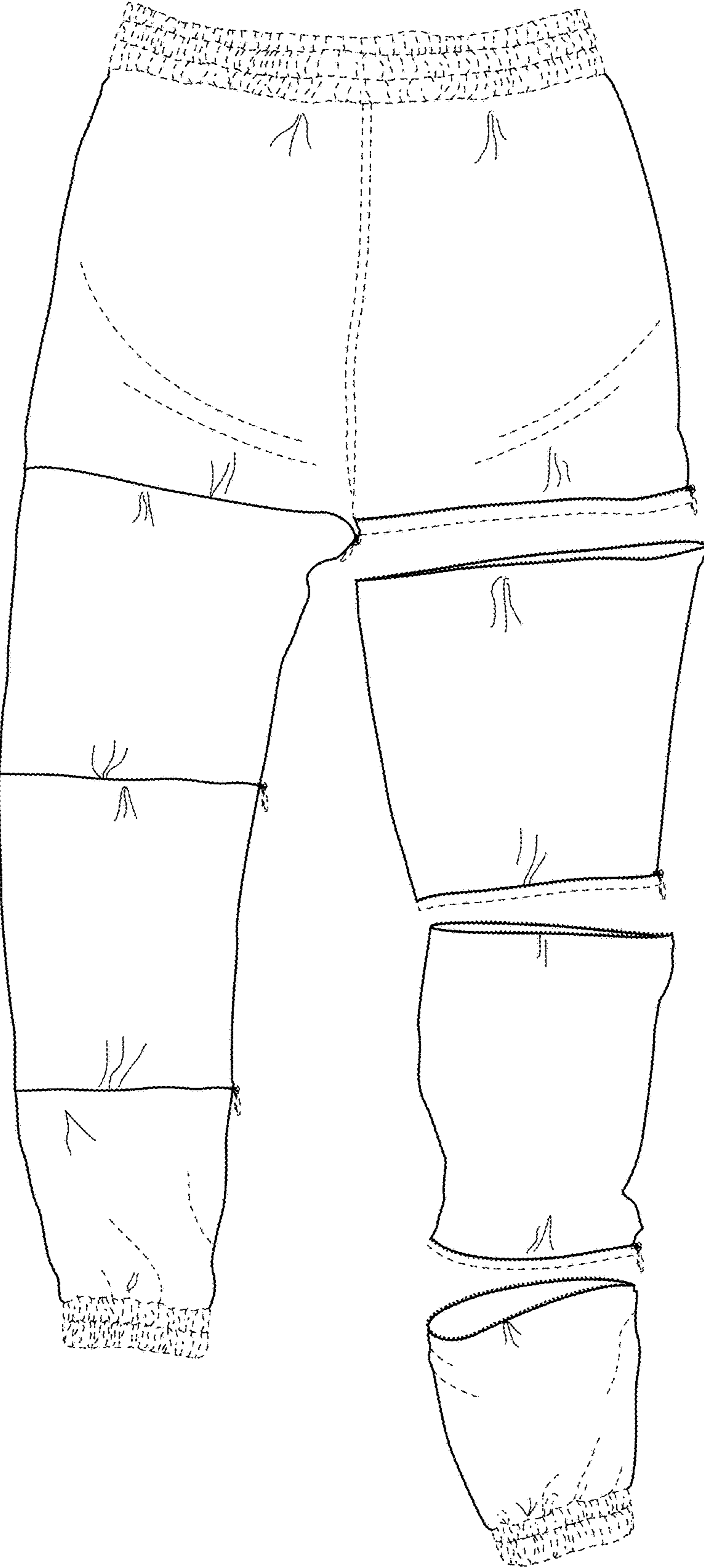

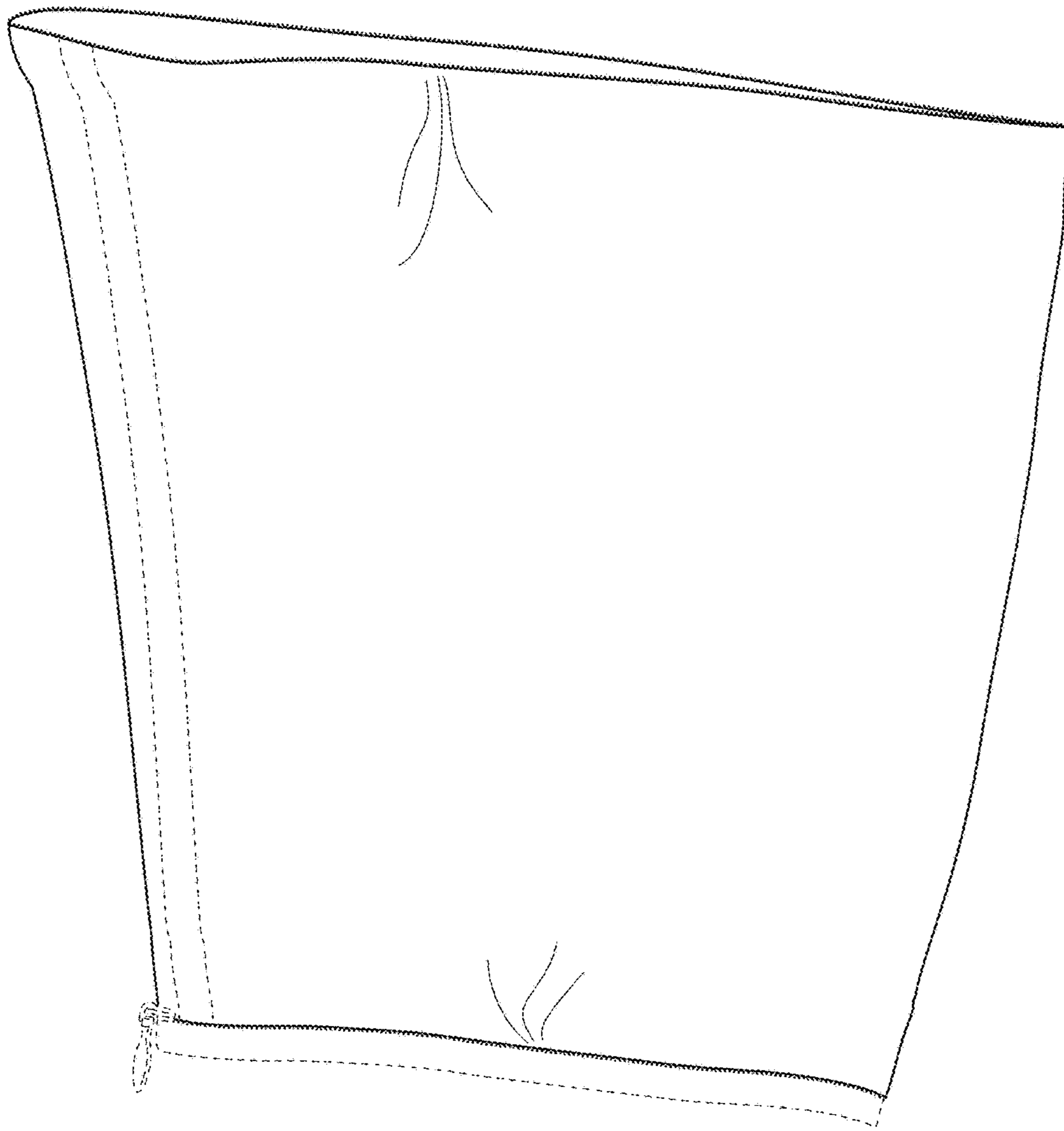
