(57) **CLAIM**

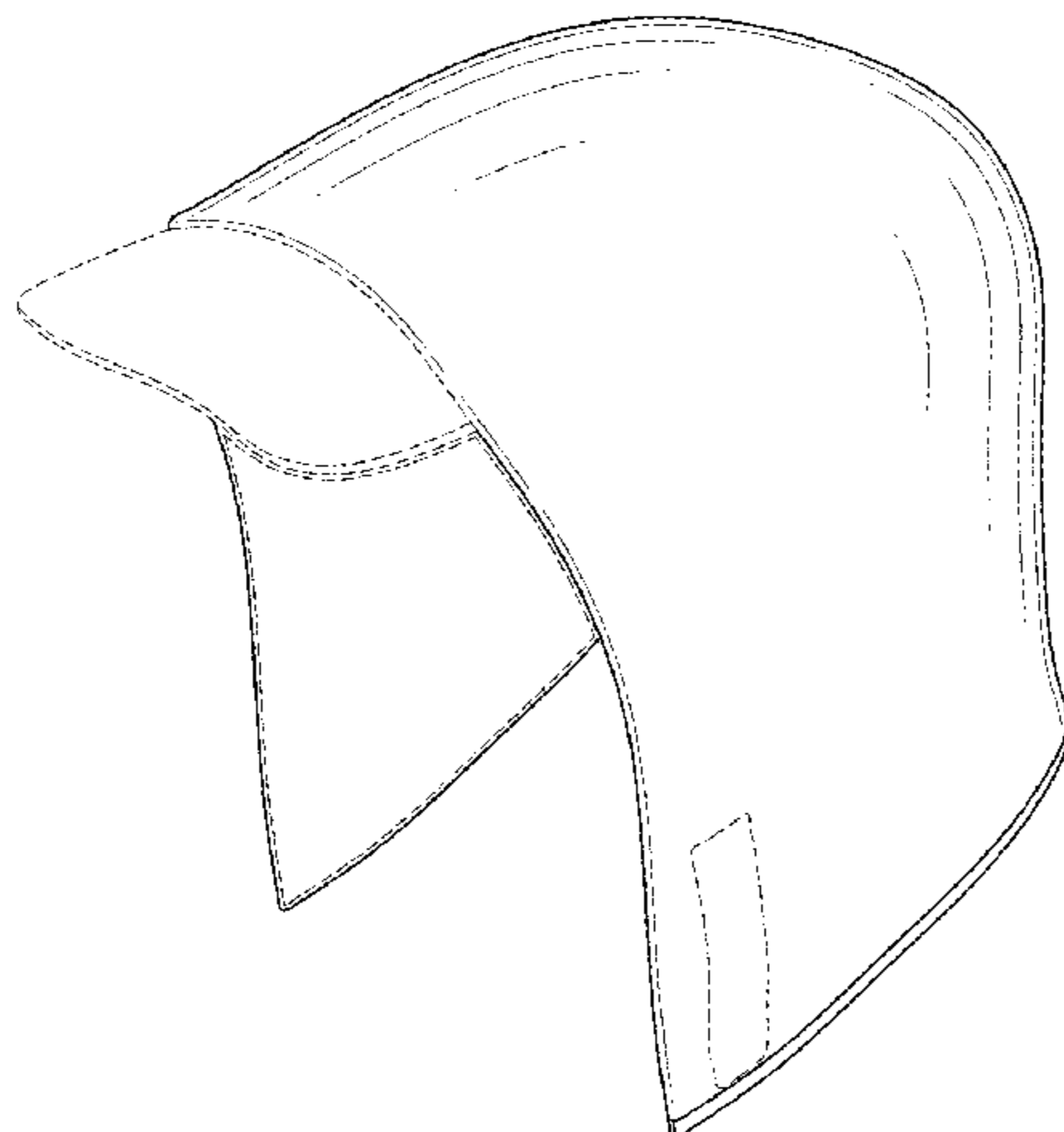
The ornamental design for a detachable foldable hood with attached pouch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a detachable foldable hood with attached pouch;

 FIG. 4 is a first side elevation view thereof;

 FIG. 13 is a top plan view thereof;

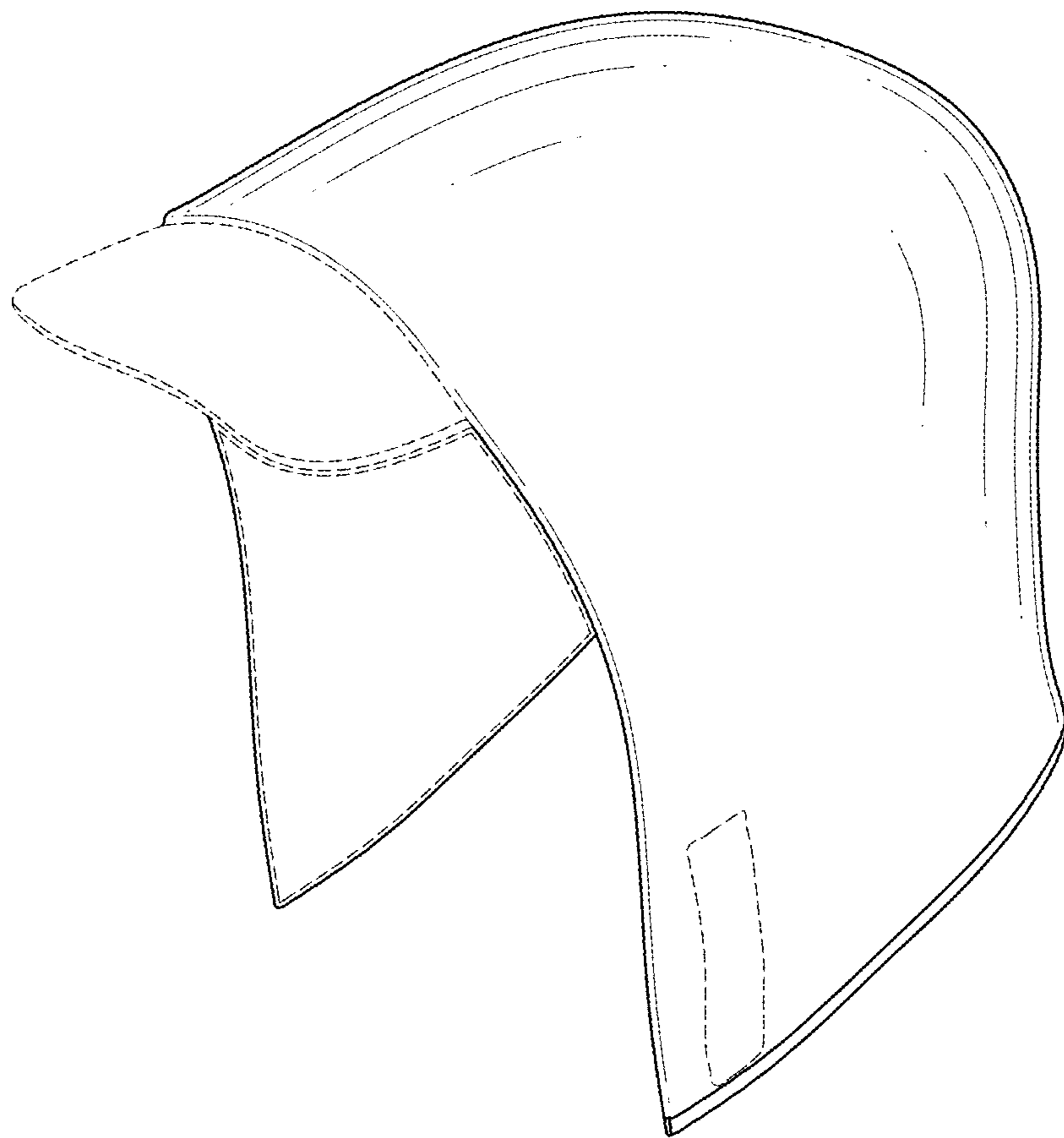

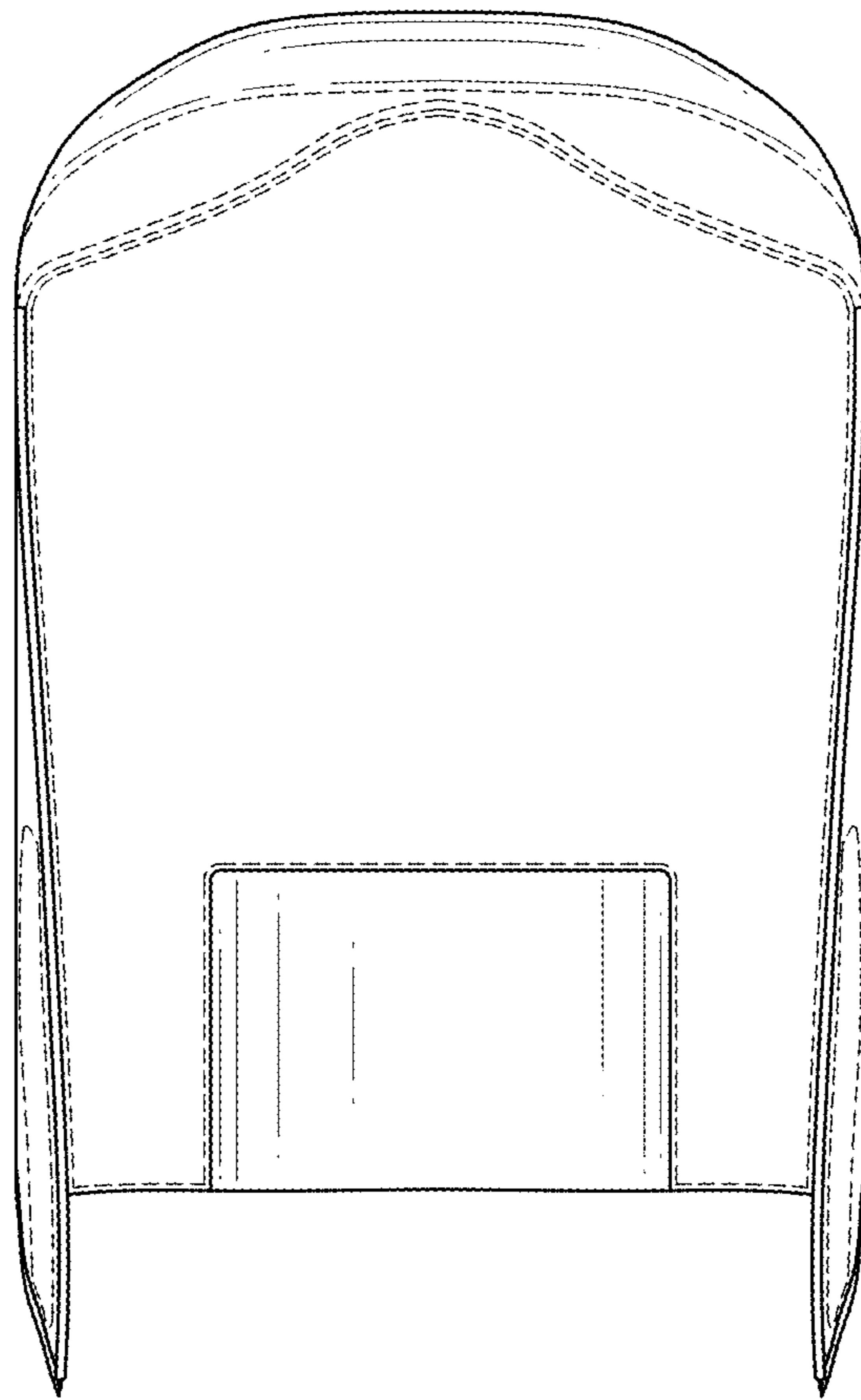

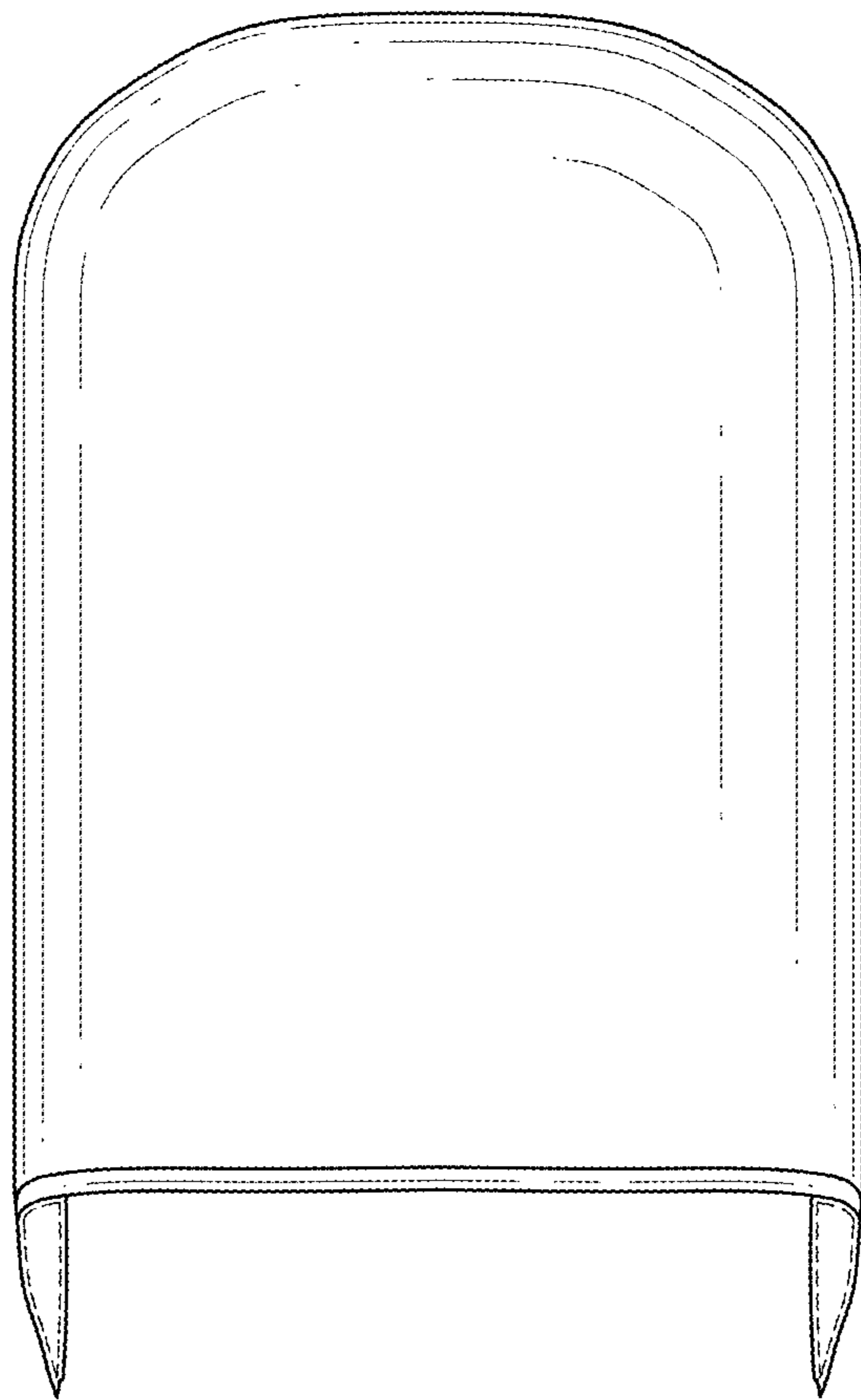

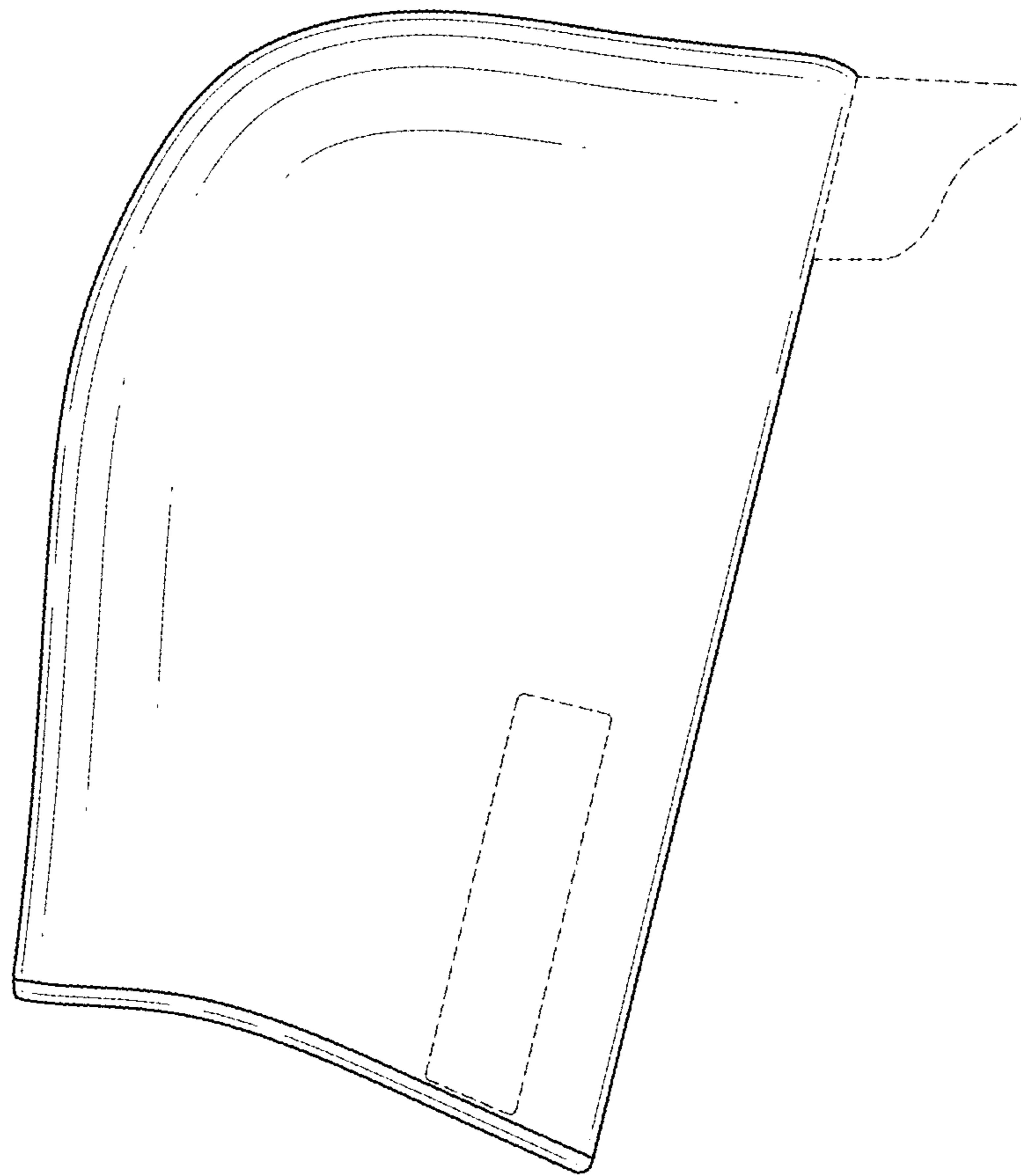

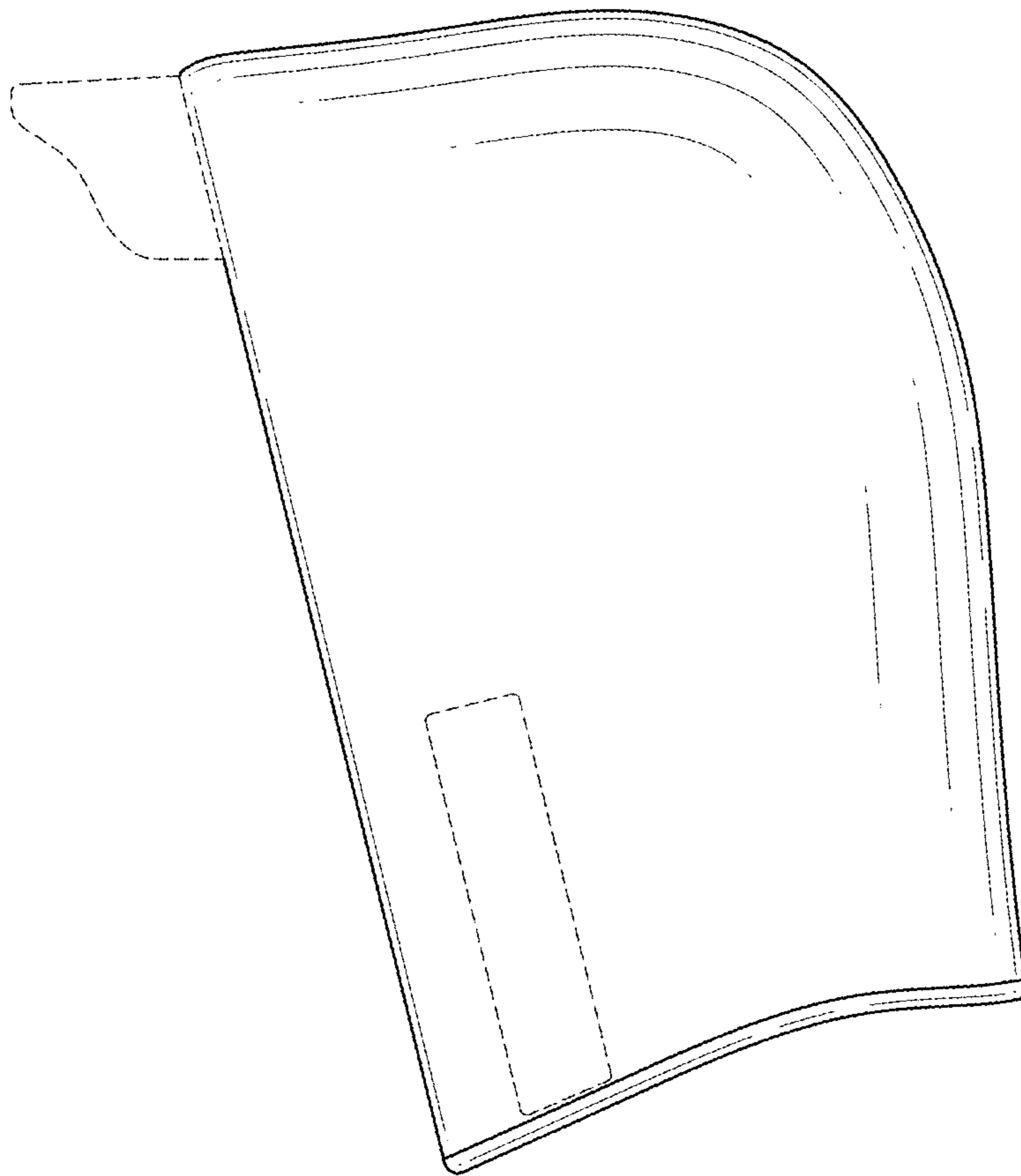

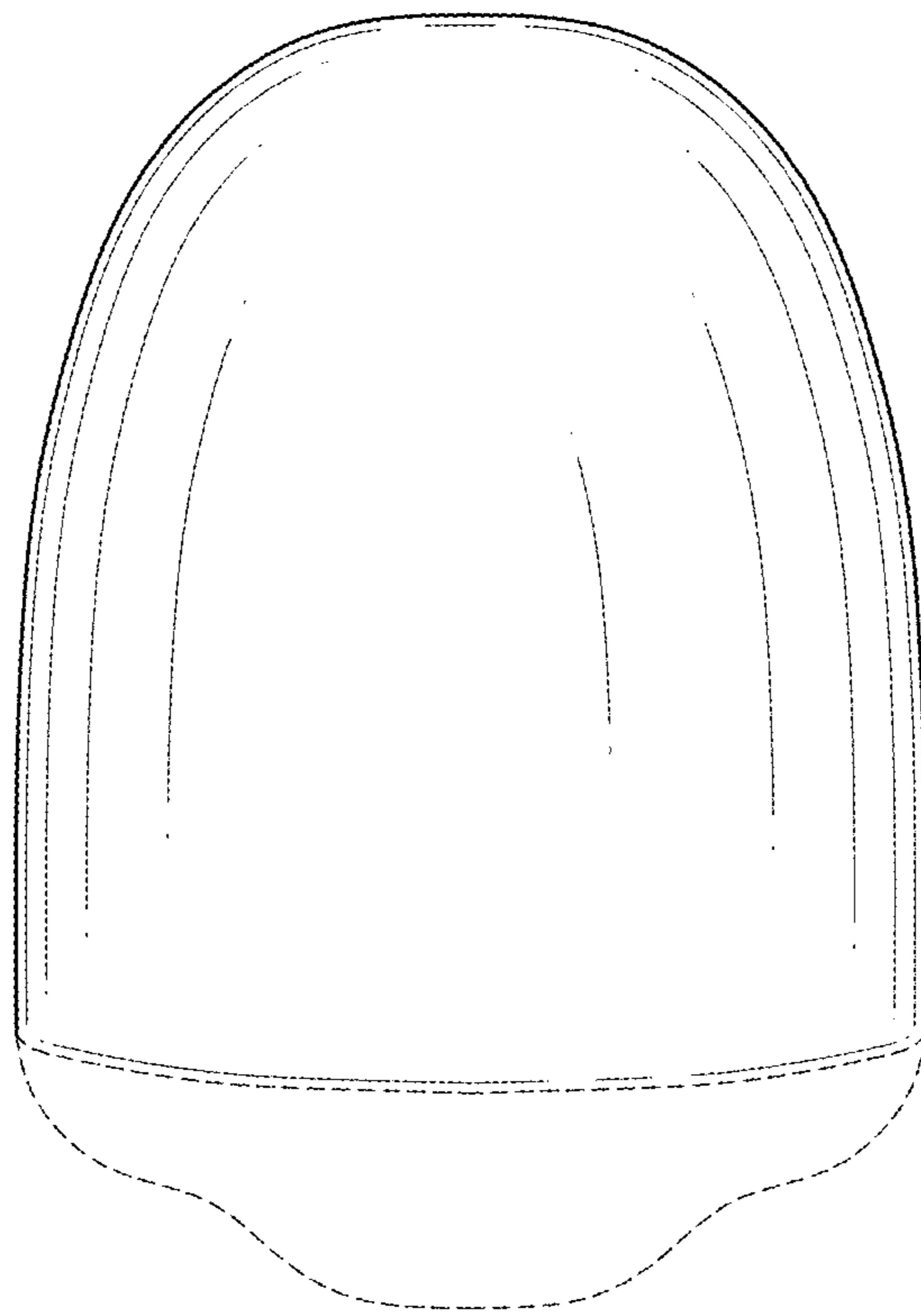

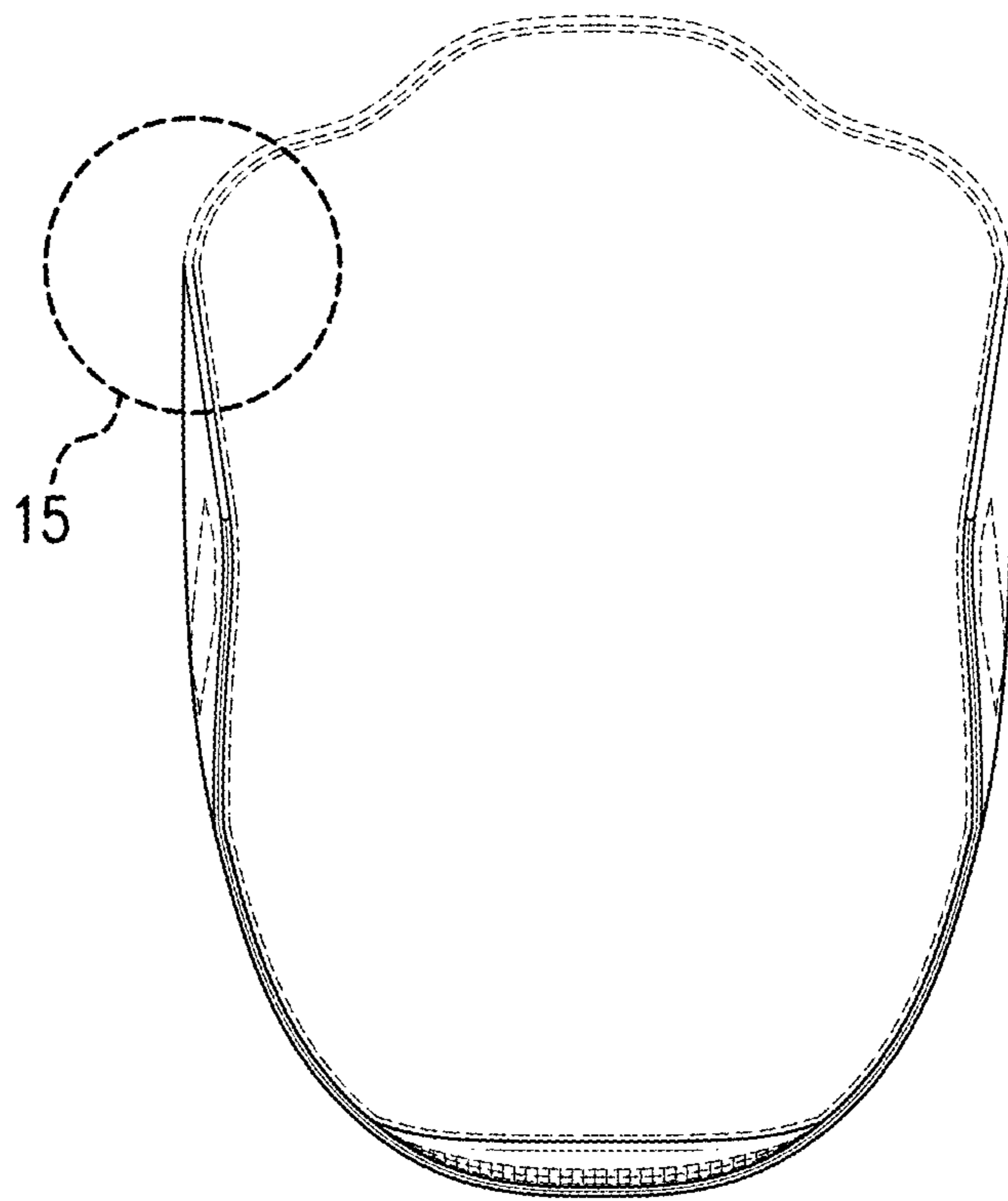

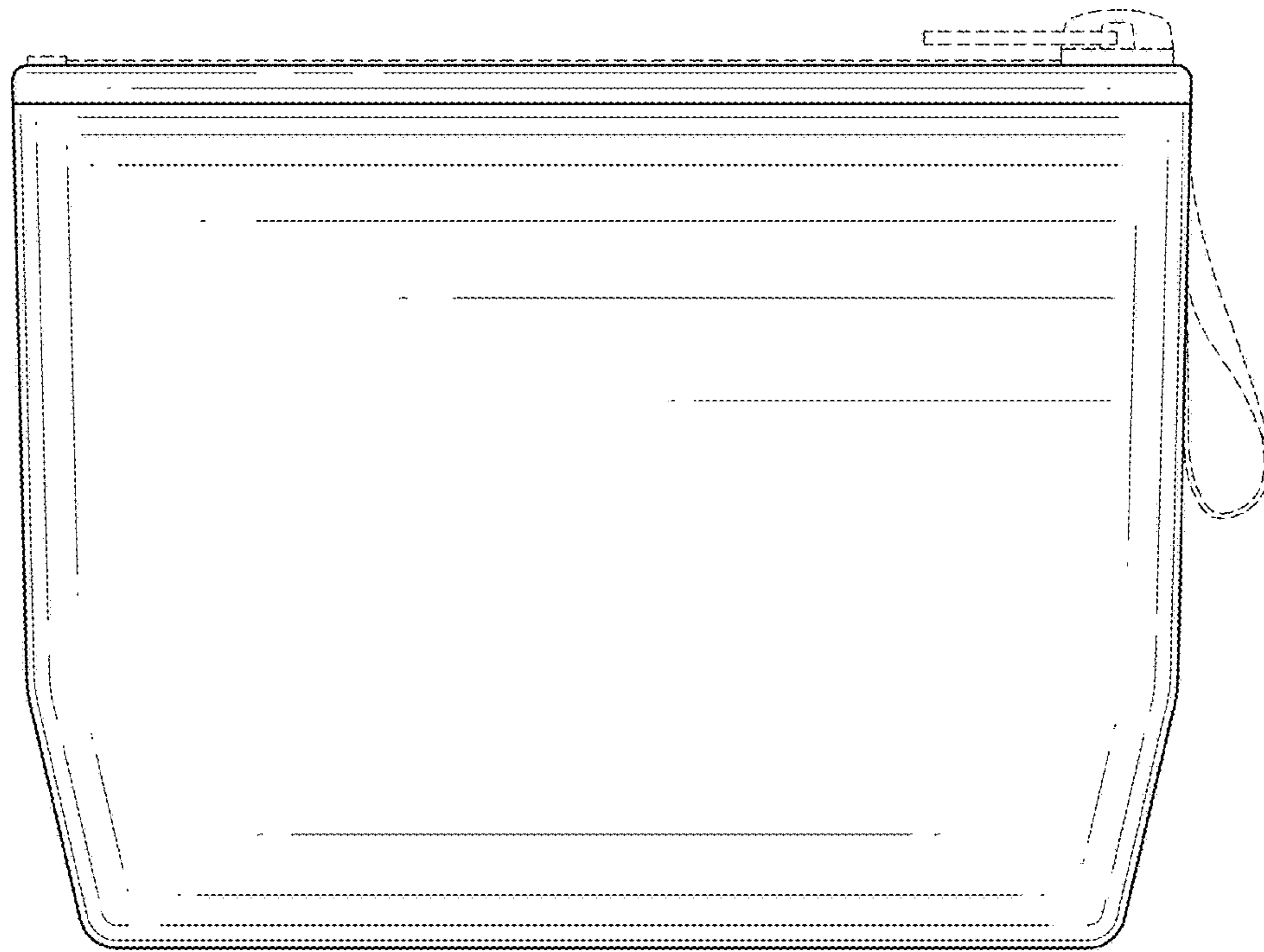

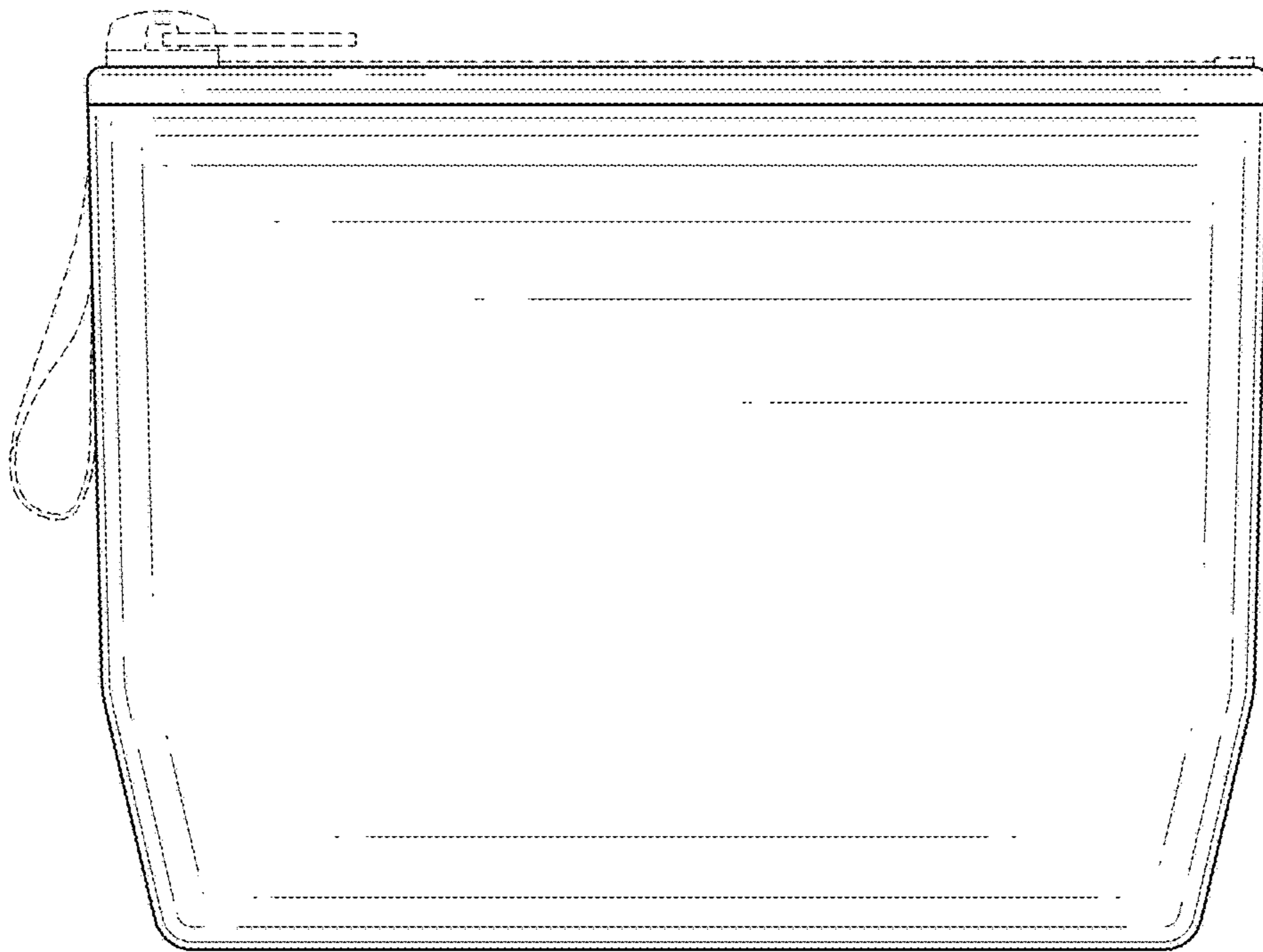

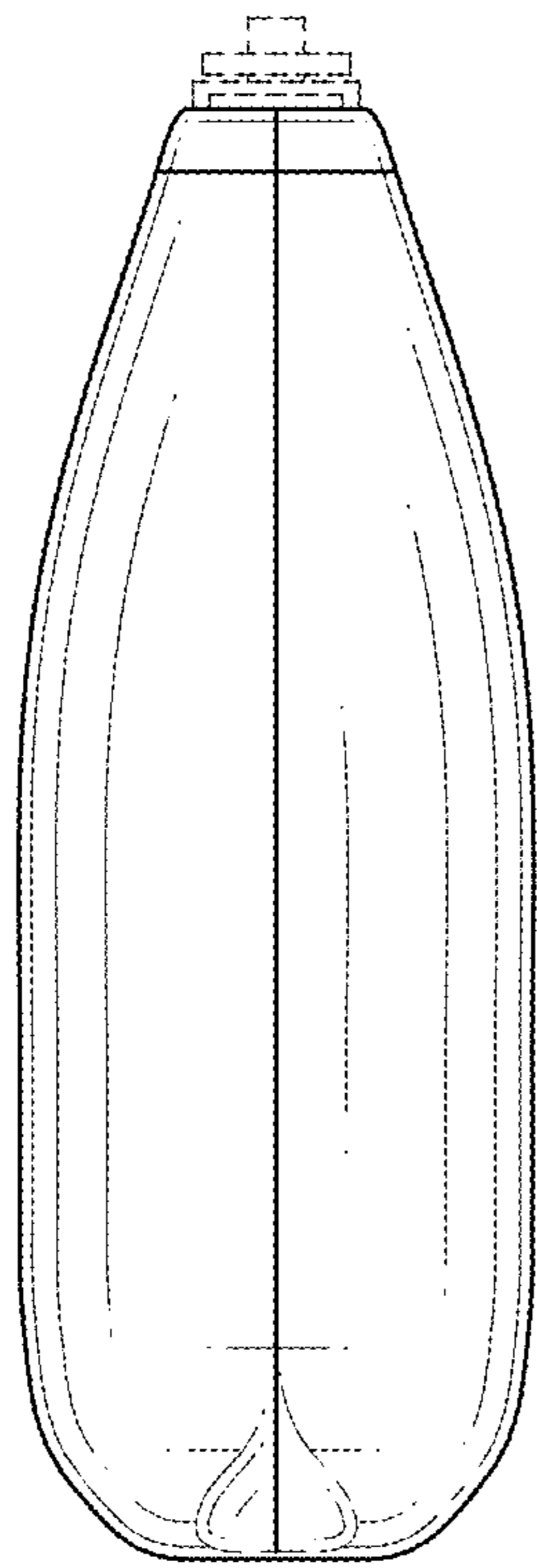

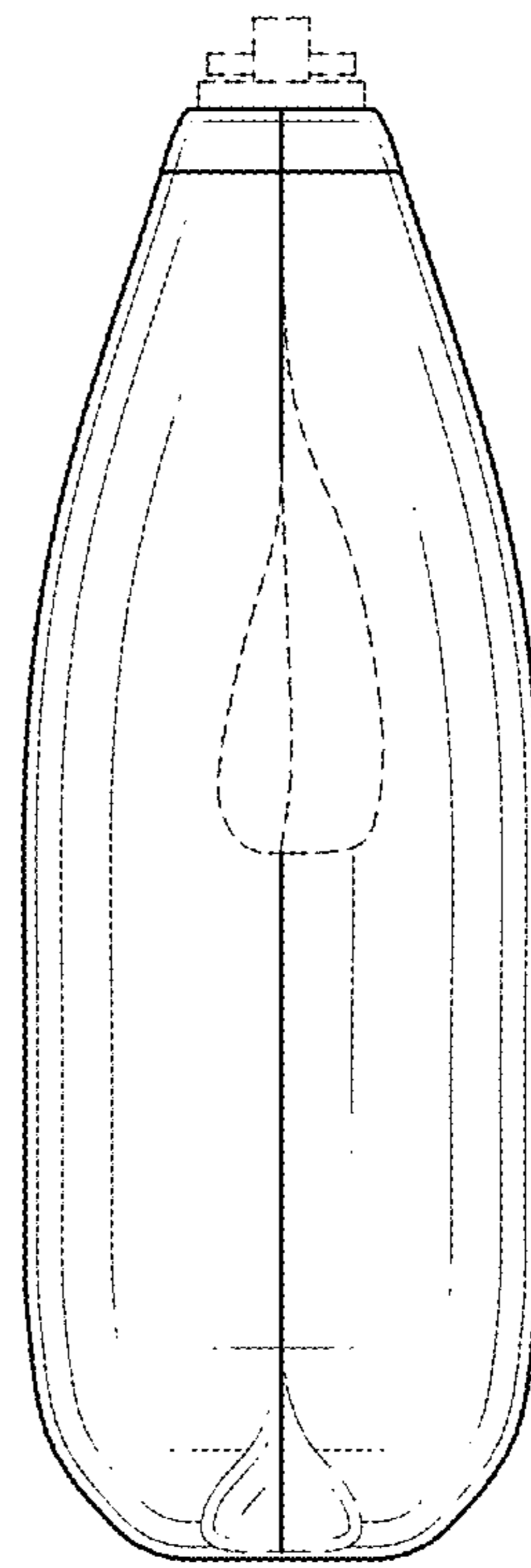

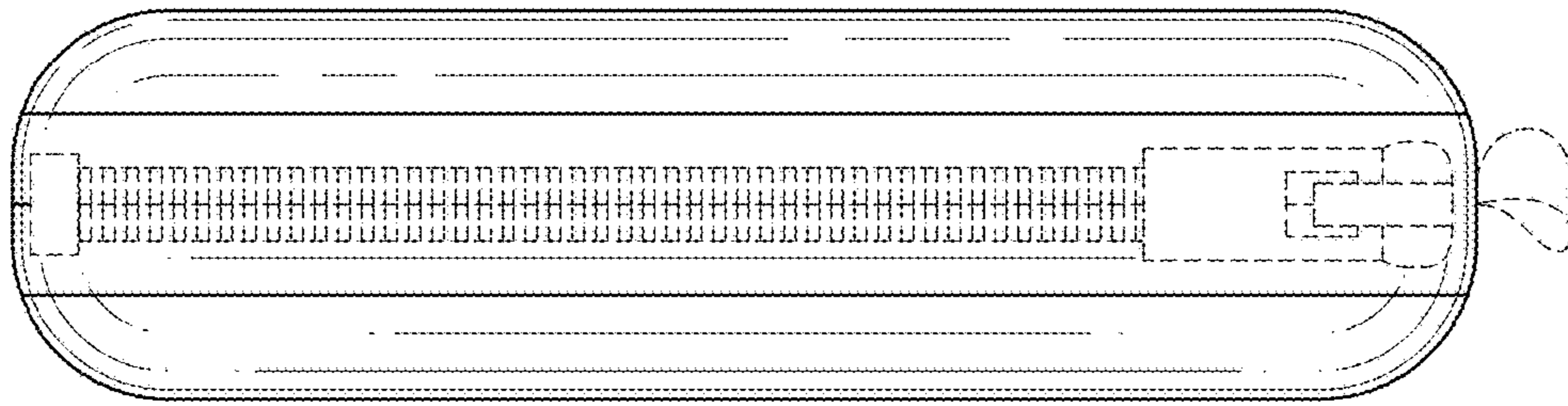

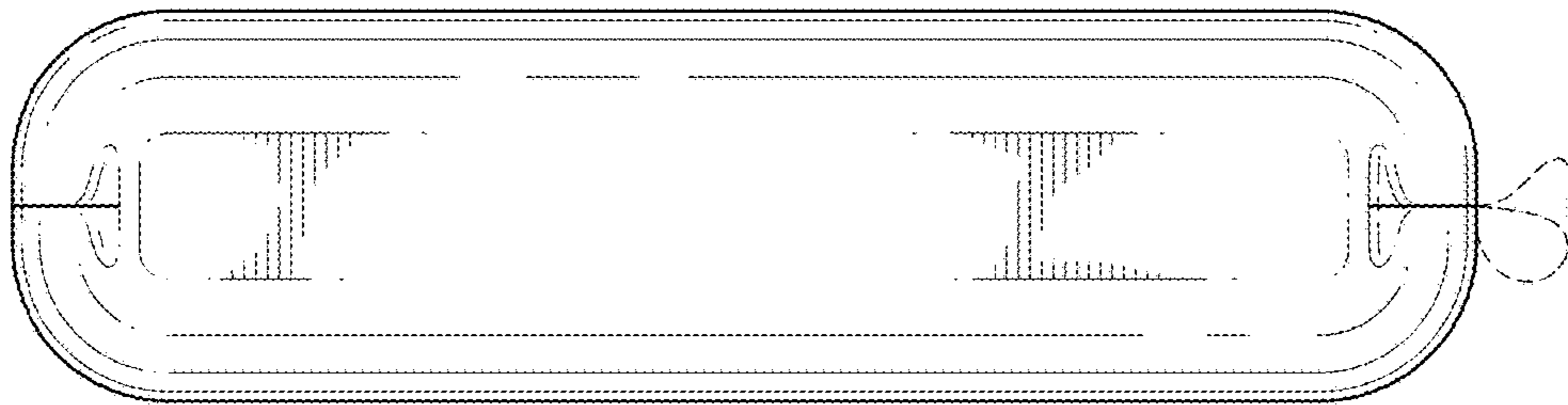

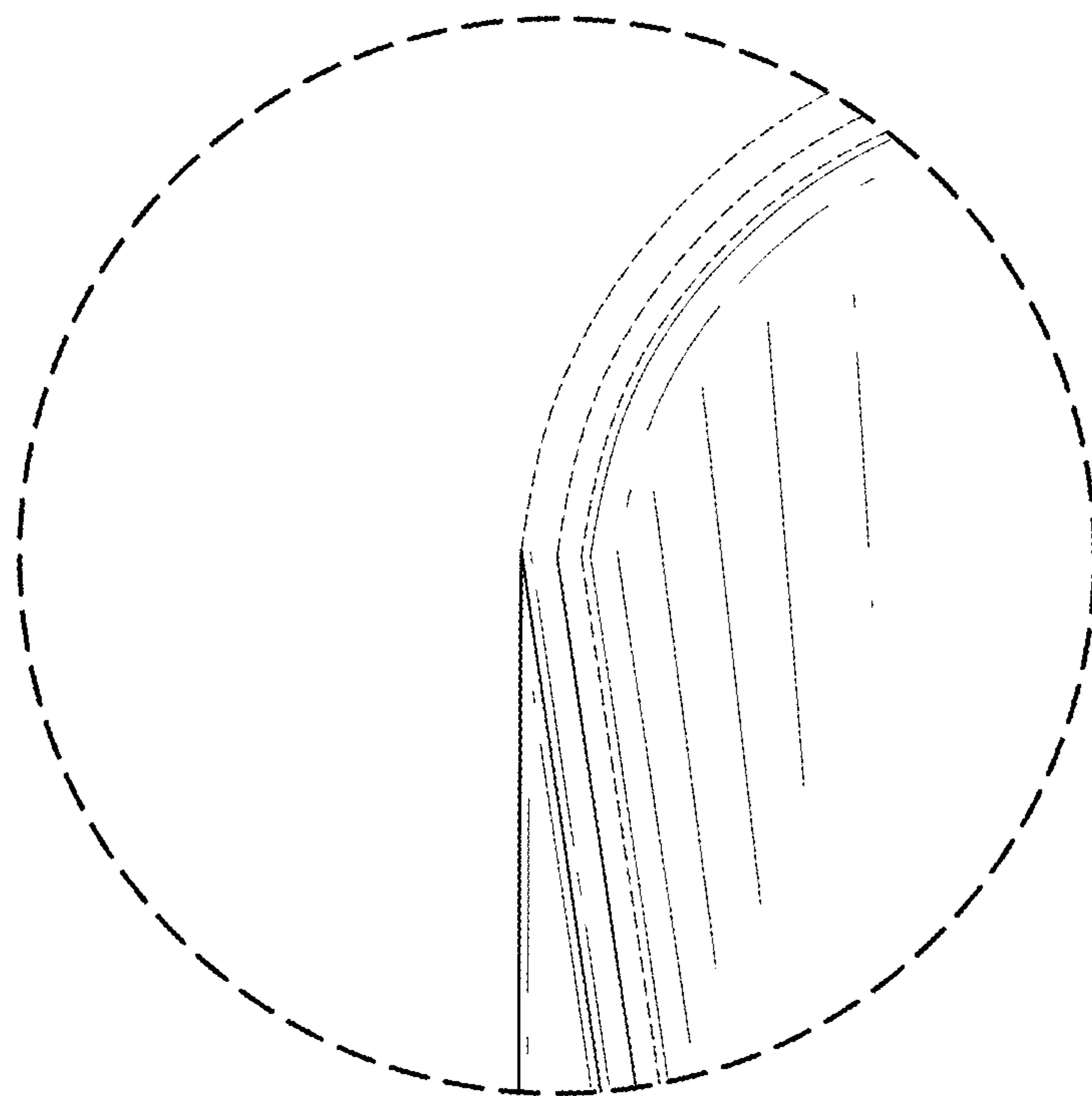
