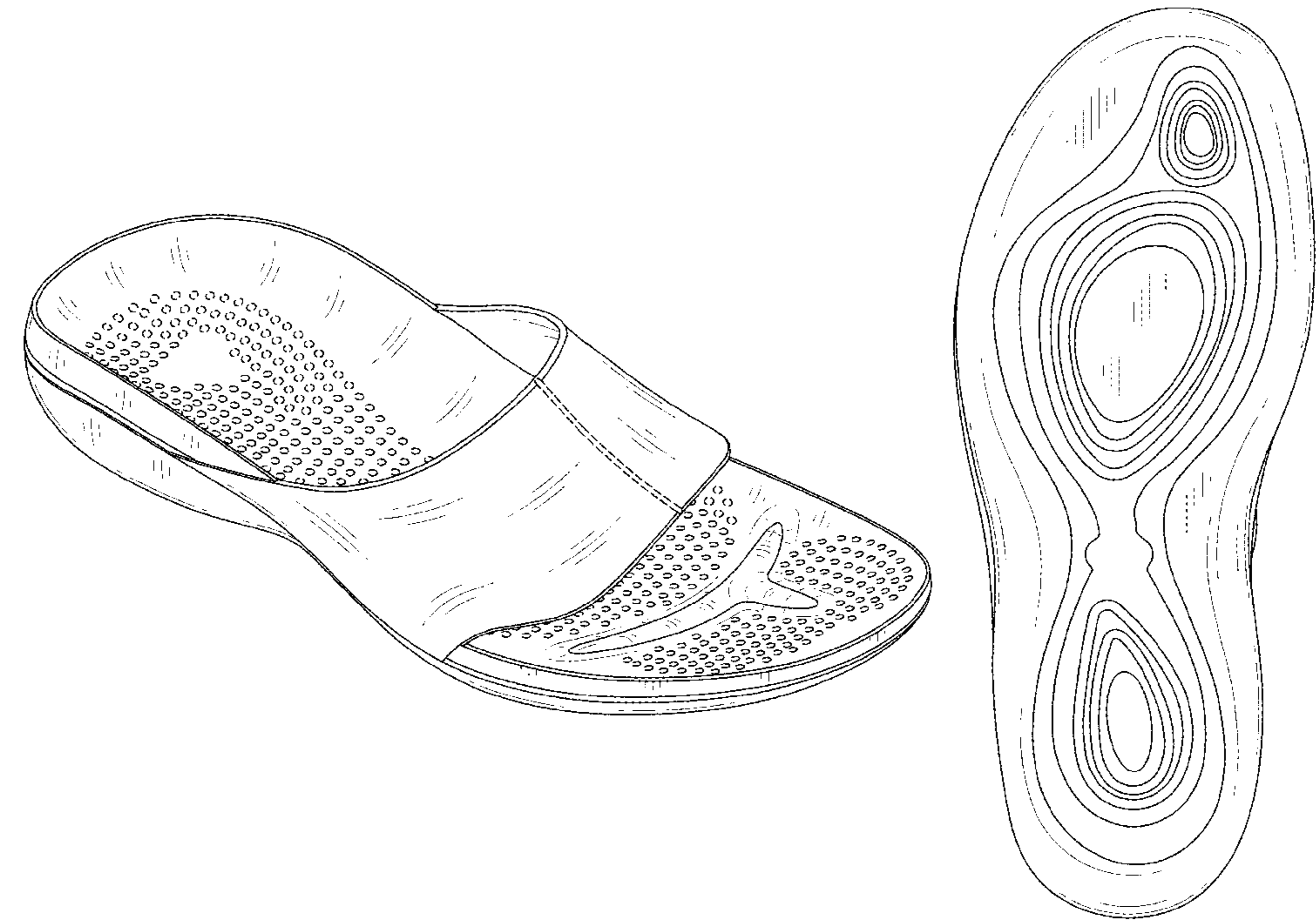
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a slide in accordance with an embodiment of my new design;

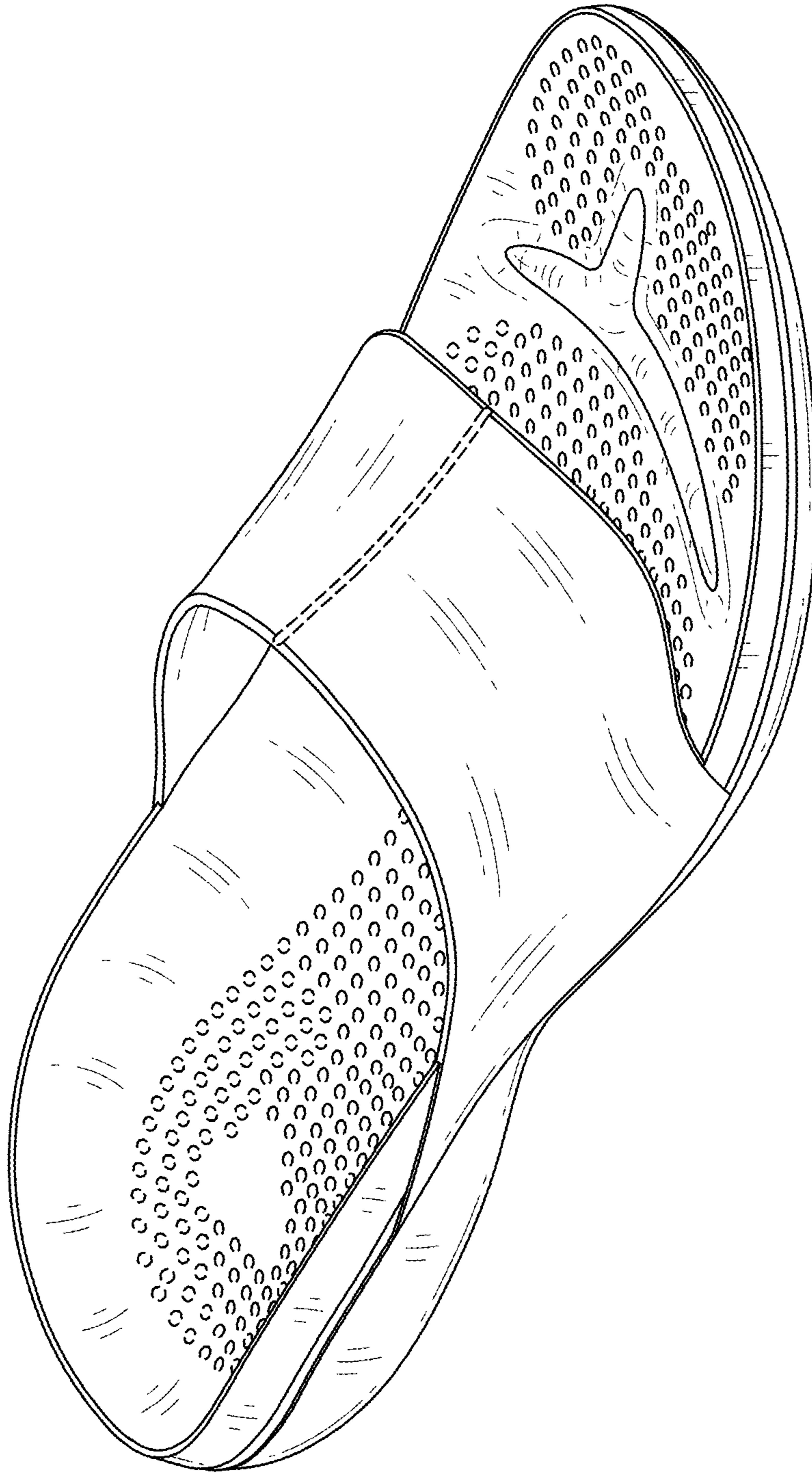

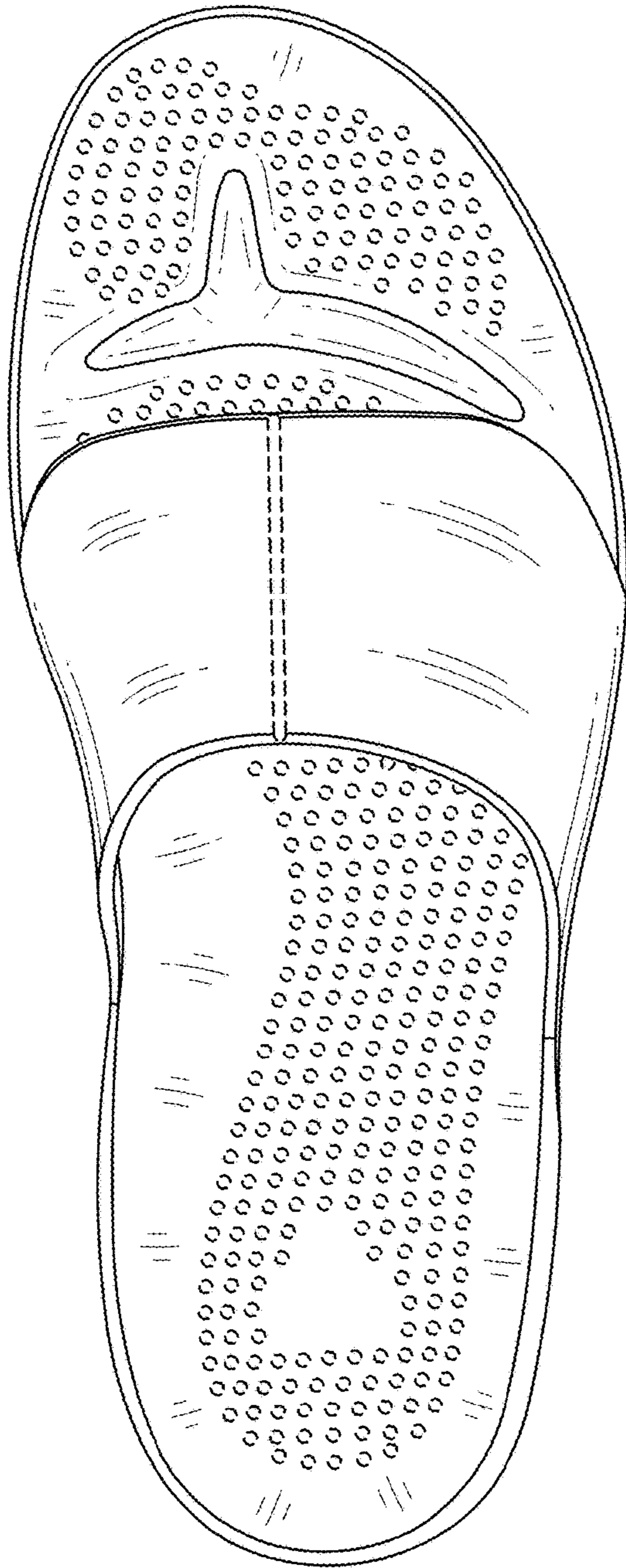

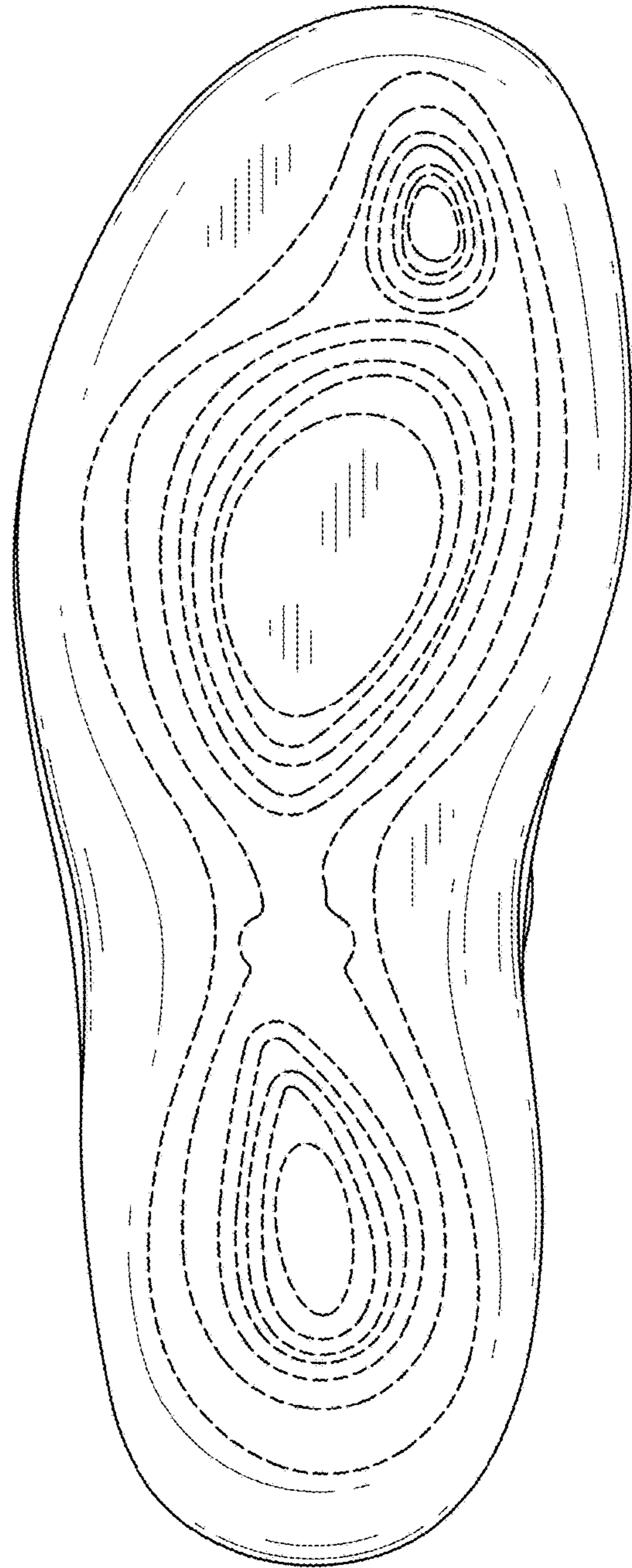

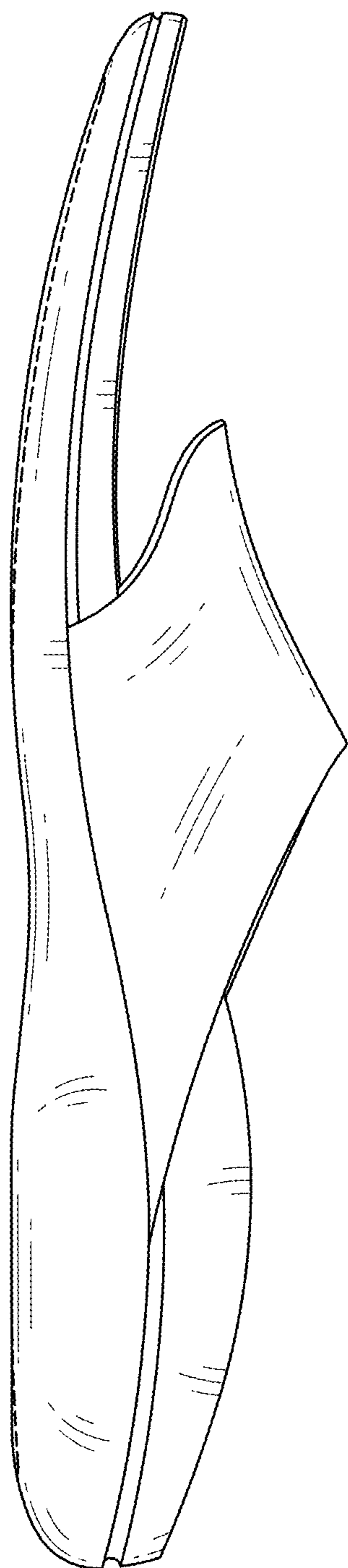

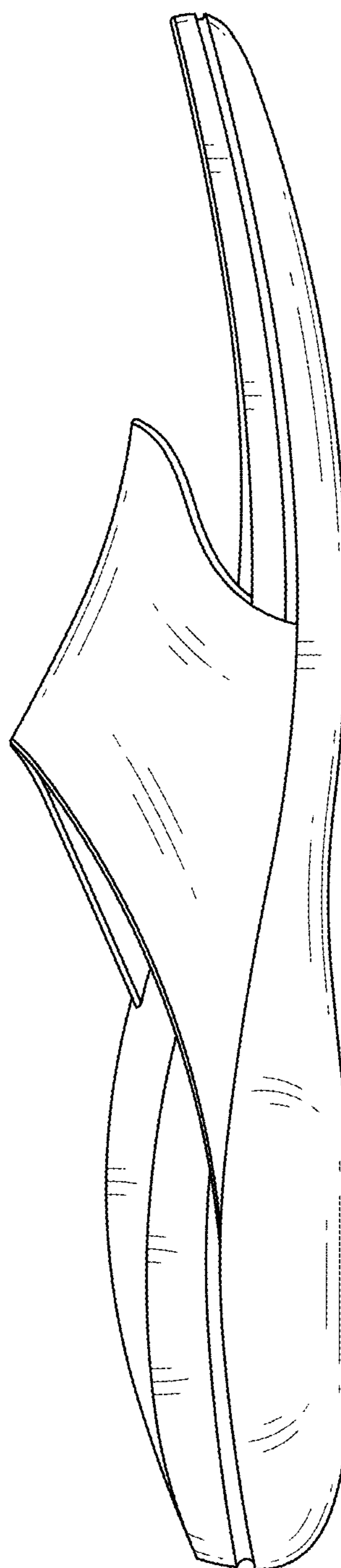

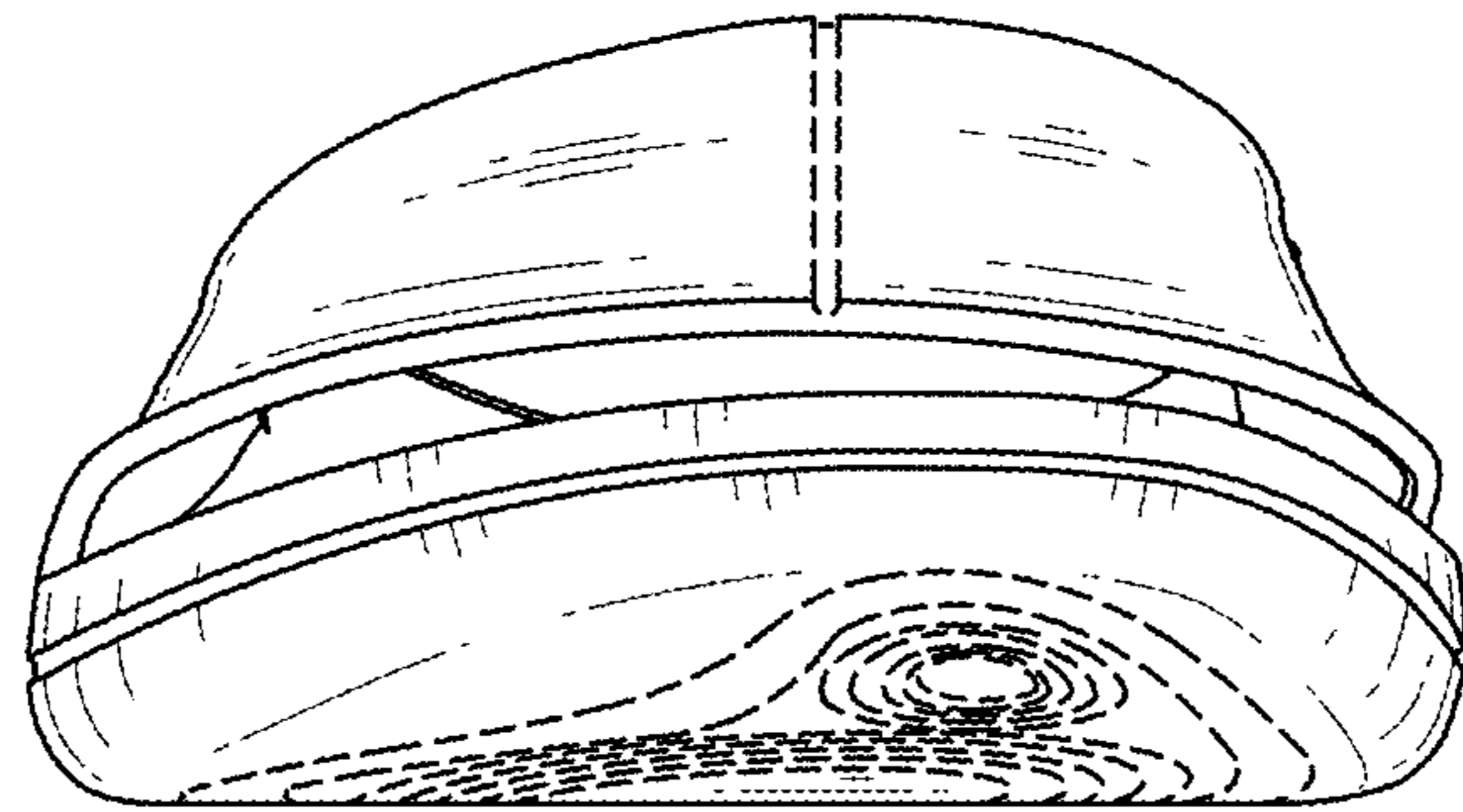

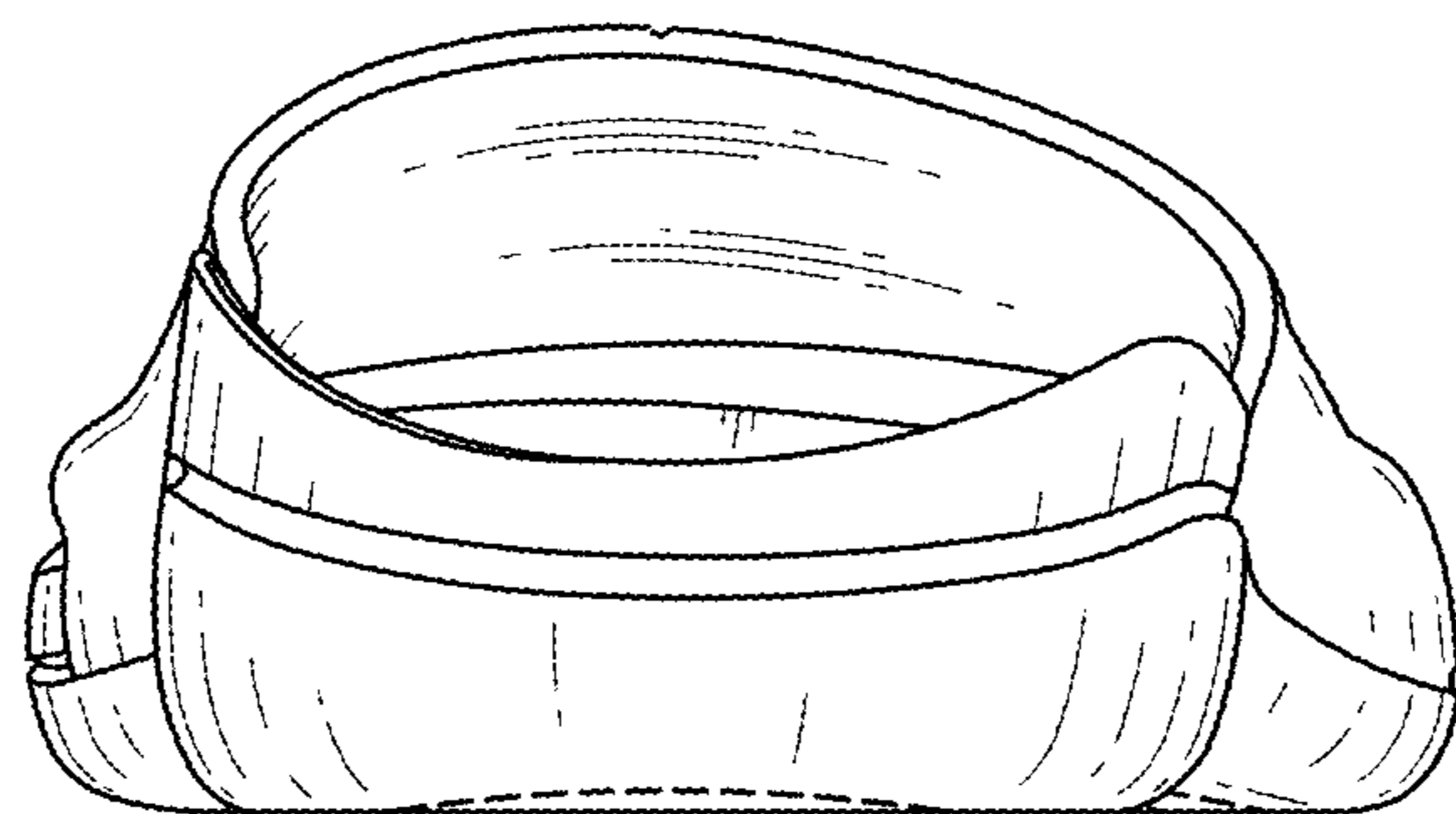

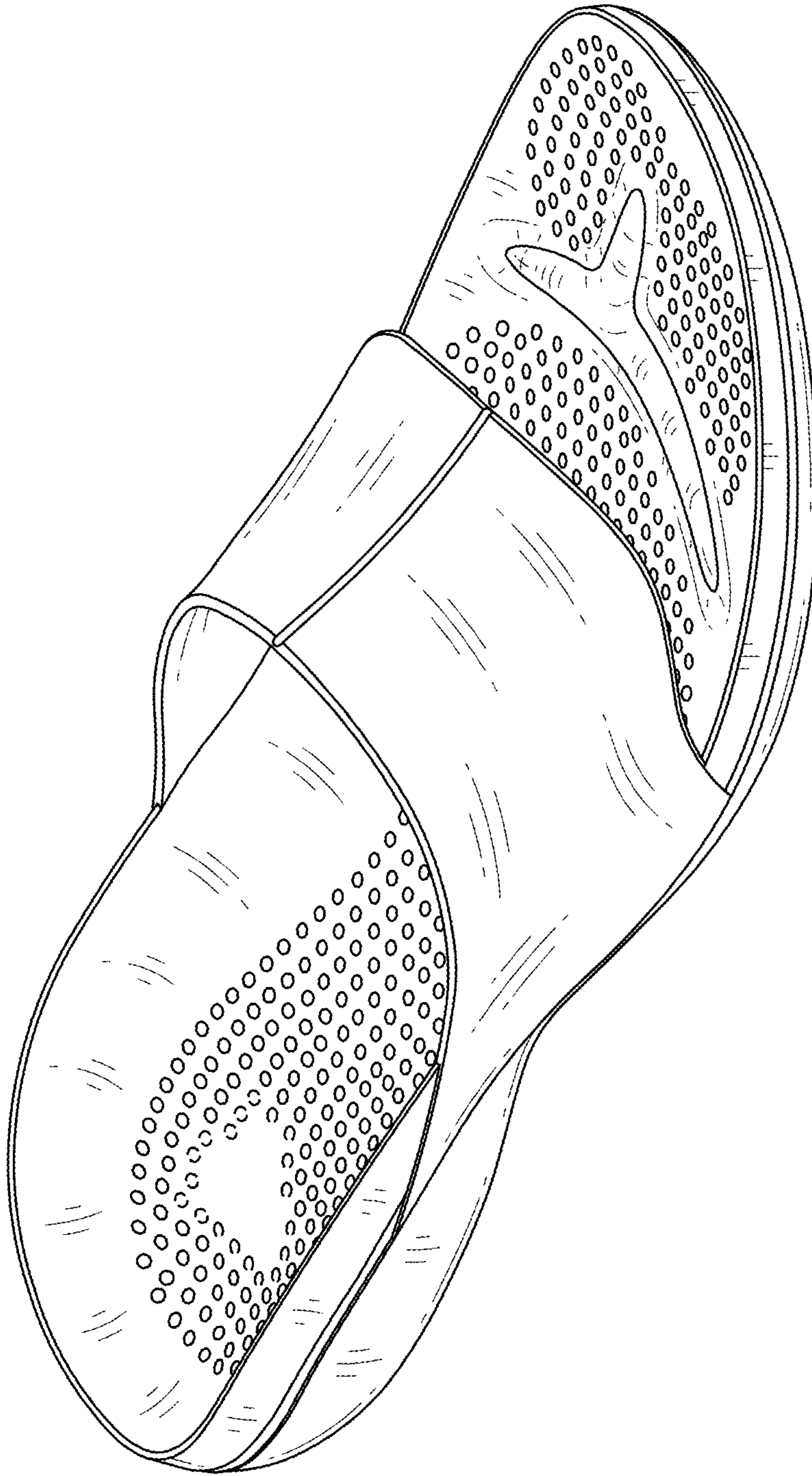

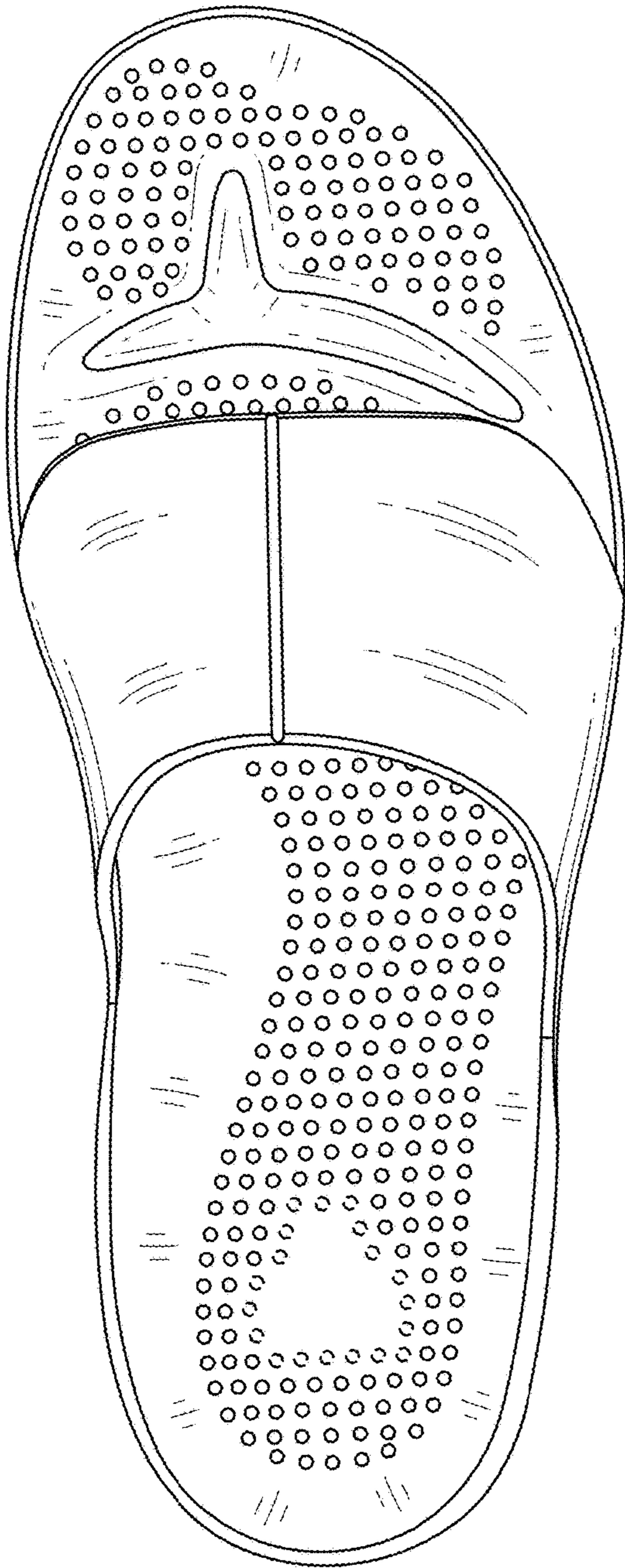

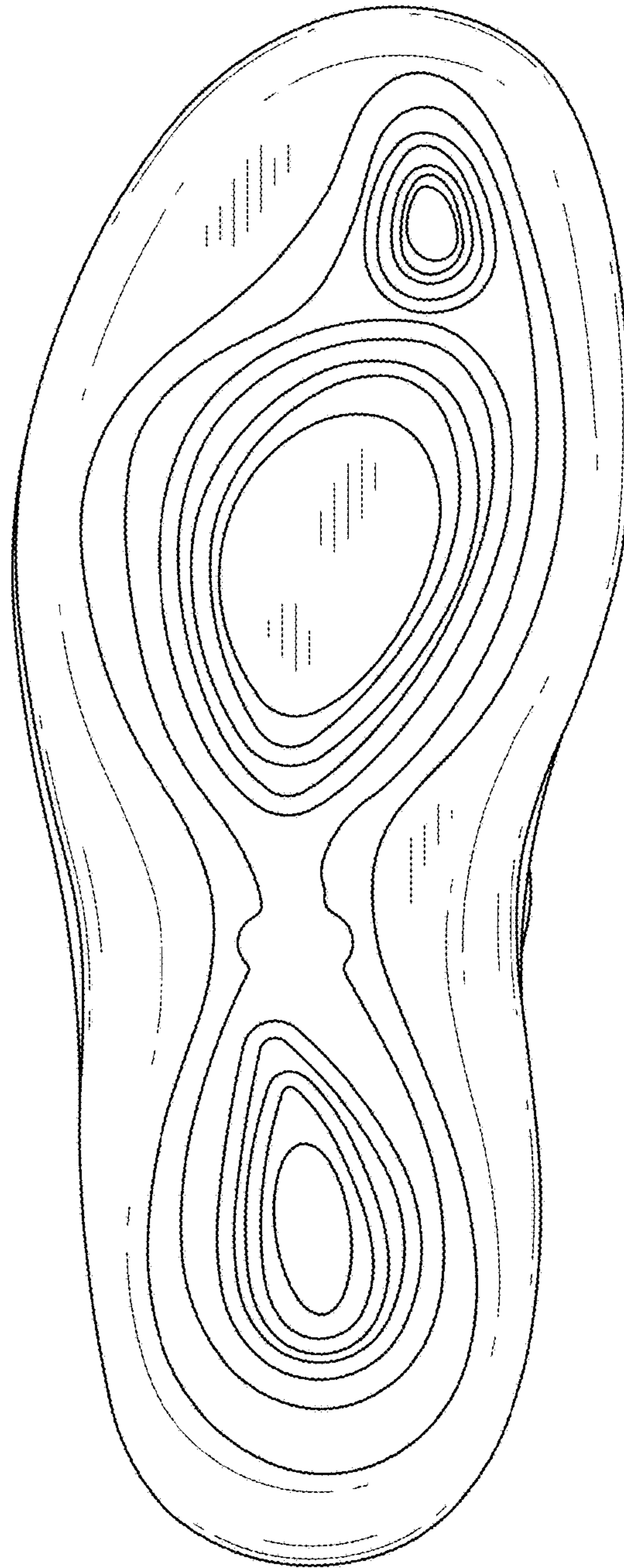

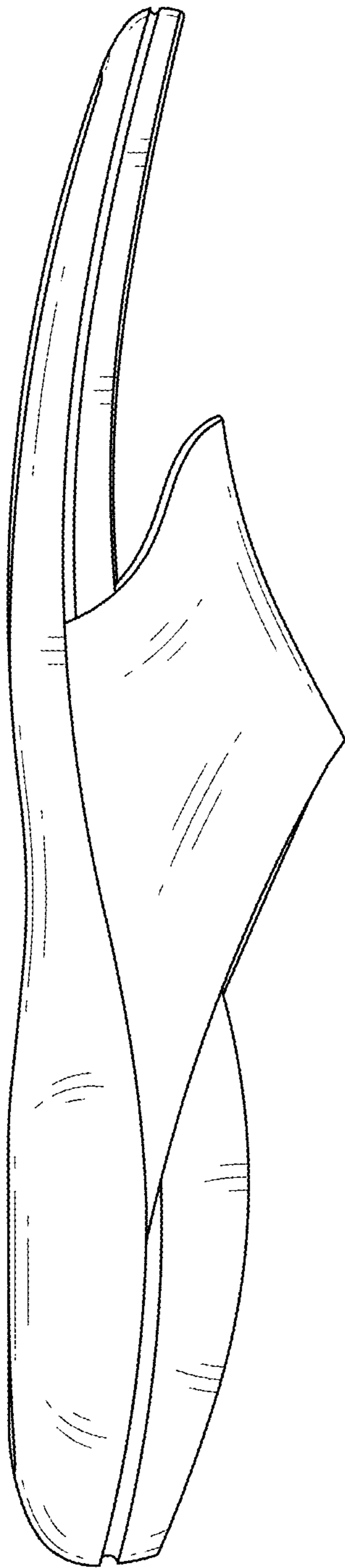

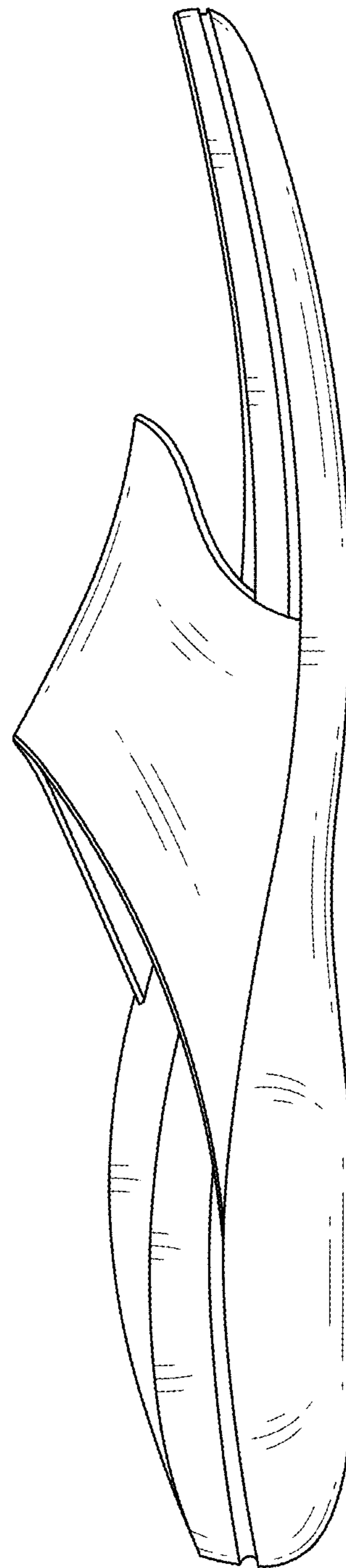

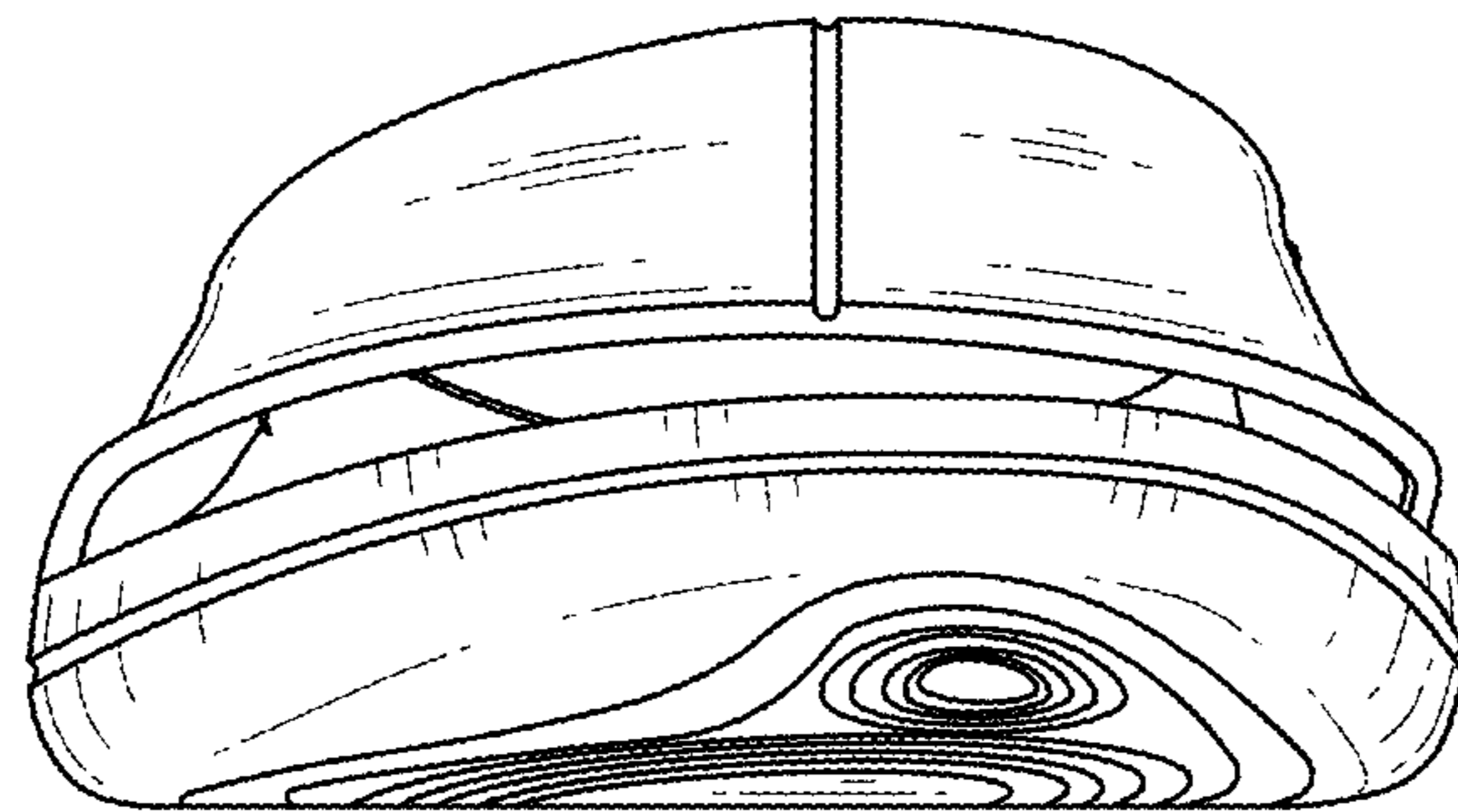

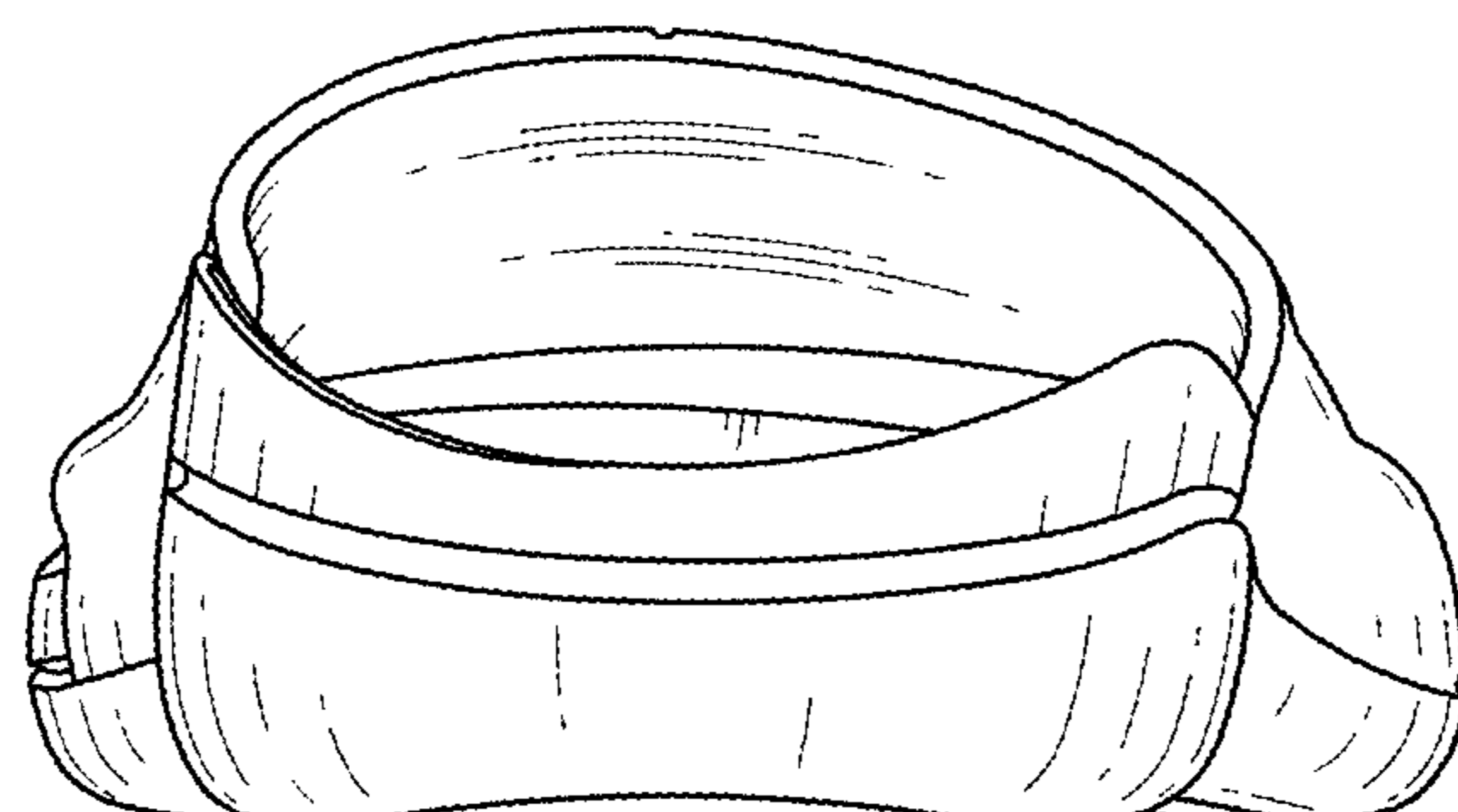
