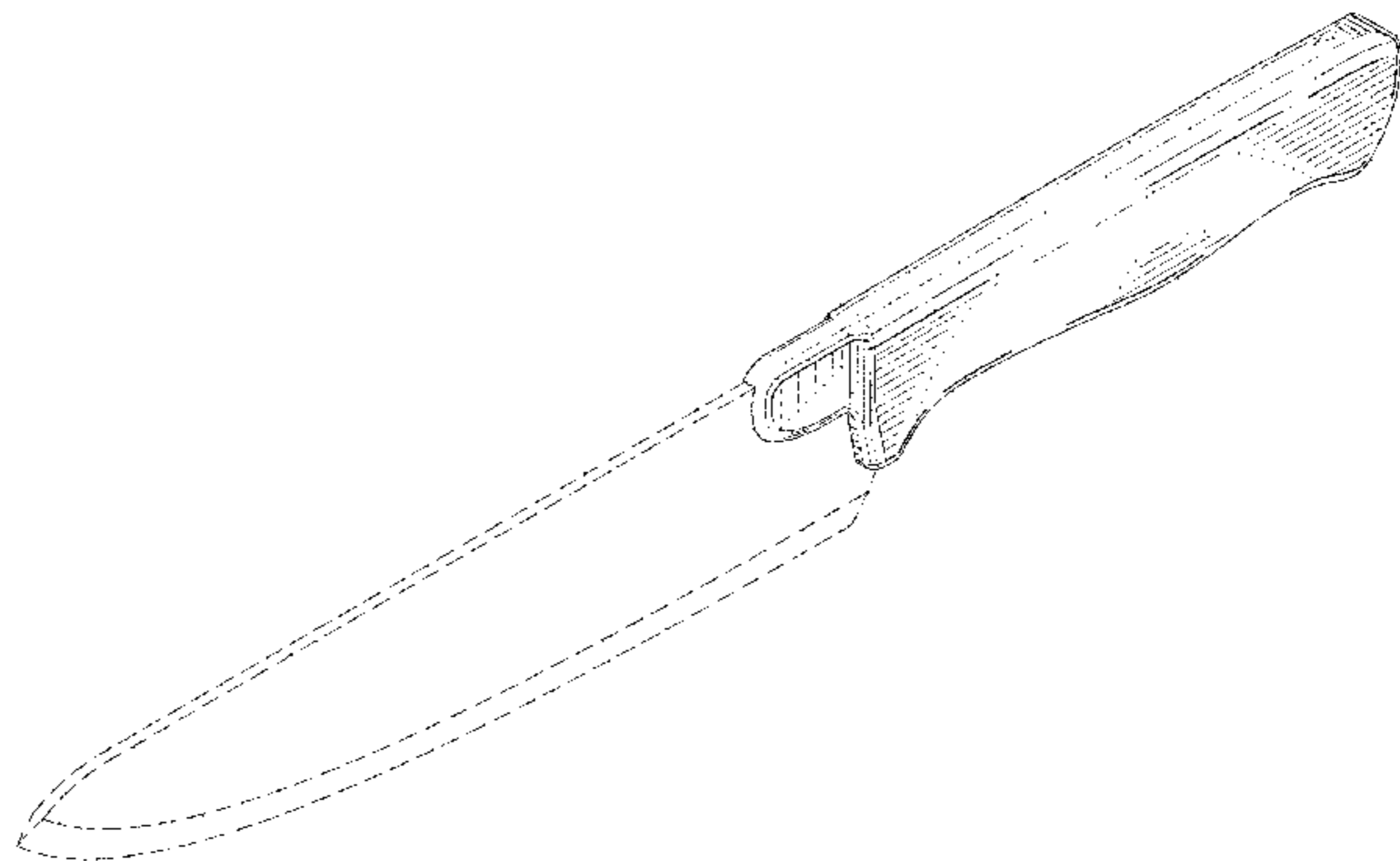
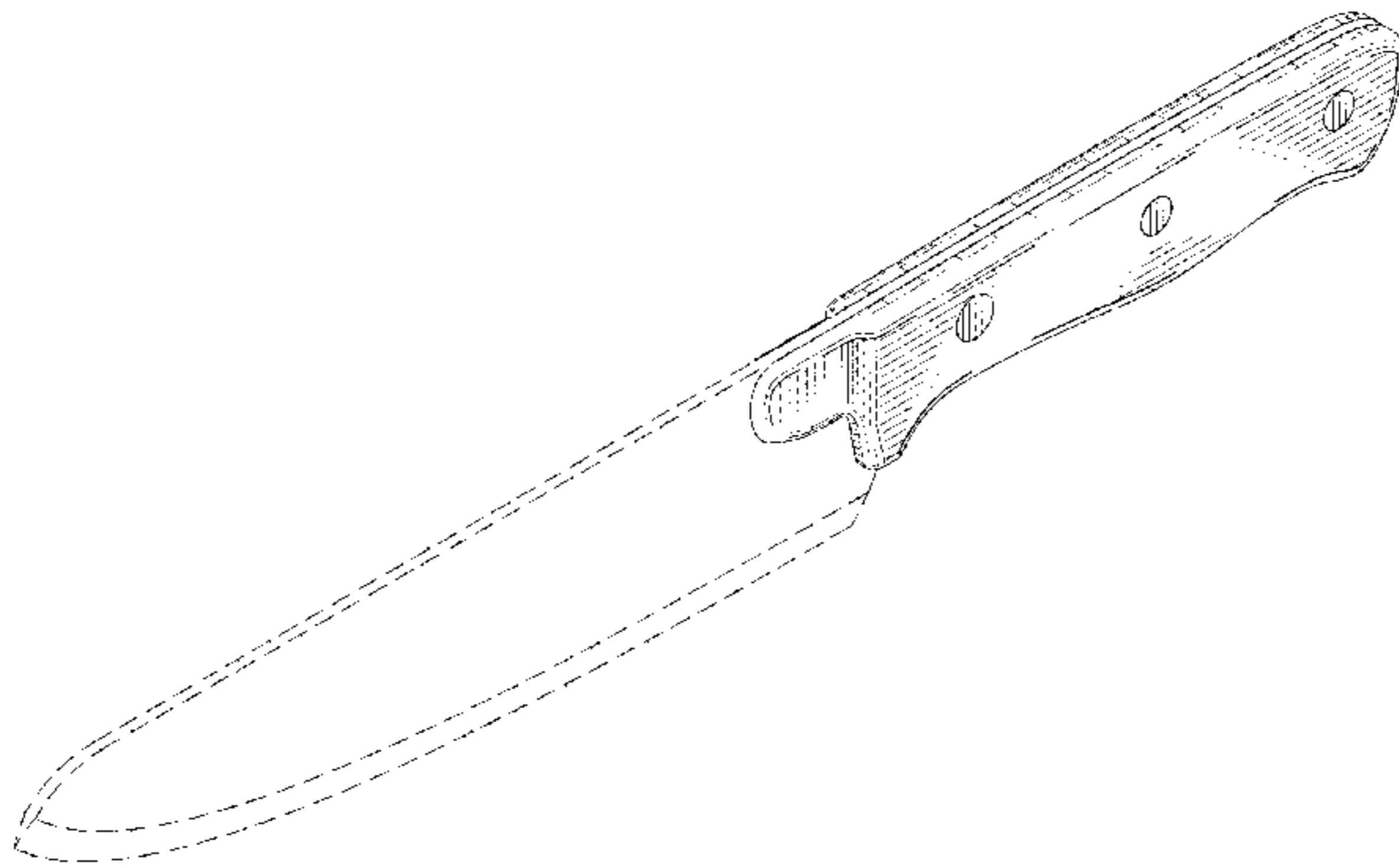
The ornamental design for a knife handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a knife handle showing a first embodiment of the new design;
 FIG. 2 is a left side view (the right side view being a mirror image) of the embodiment of the new design shown in FIG. 1;
 FIG. 3 is an enlarged front elevational view of the new design shown in FIG. 1;
 FIG. 4 is an enlarged back or rear elevational view of the new design shown in FIG. 1;
 FIG. 5 is a top plan view of the new design shown in FIG. 1;
 FIG. 6 is a bottom plan view of the new design shown in FIG. 1;
 FIG. 7 is a perspective view of the knife handle showing a second embodiment of the new design;

 FIG. 9 is an enlarged front elevational view of the new design shown in FIG. 7;

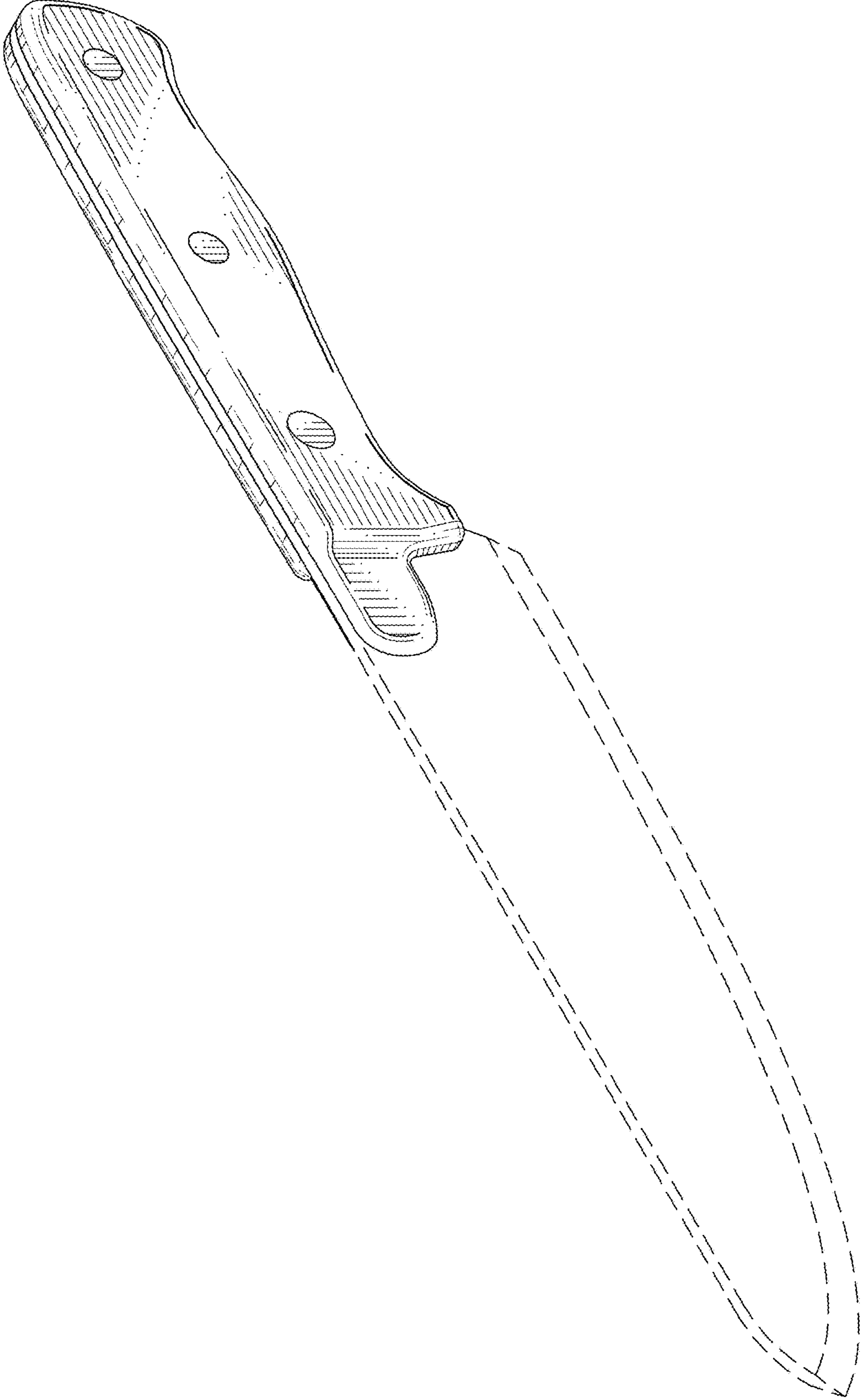

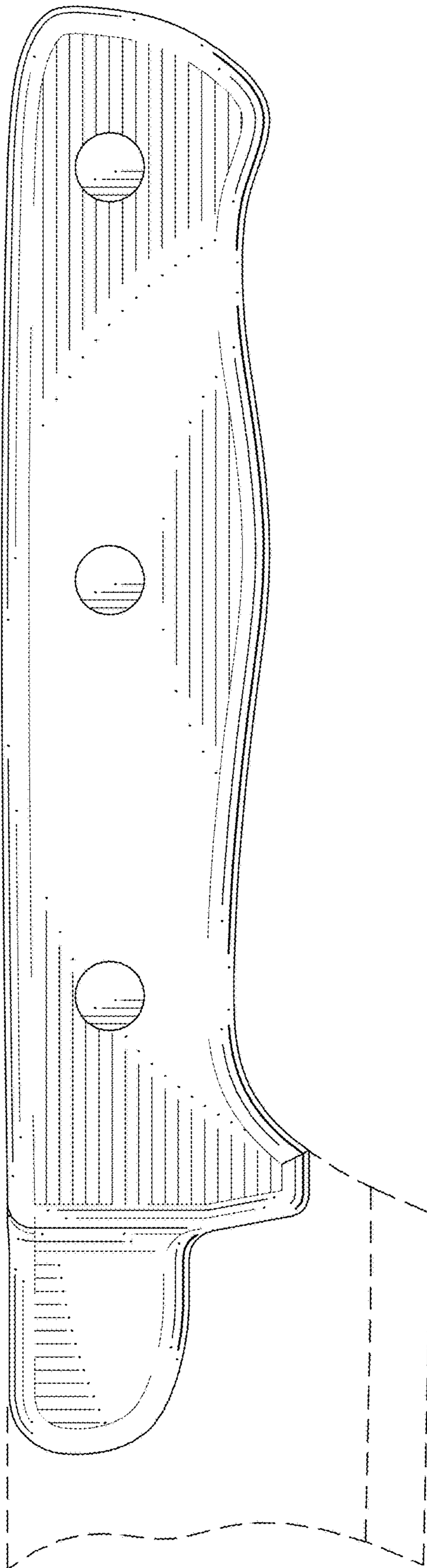

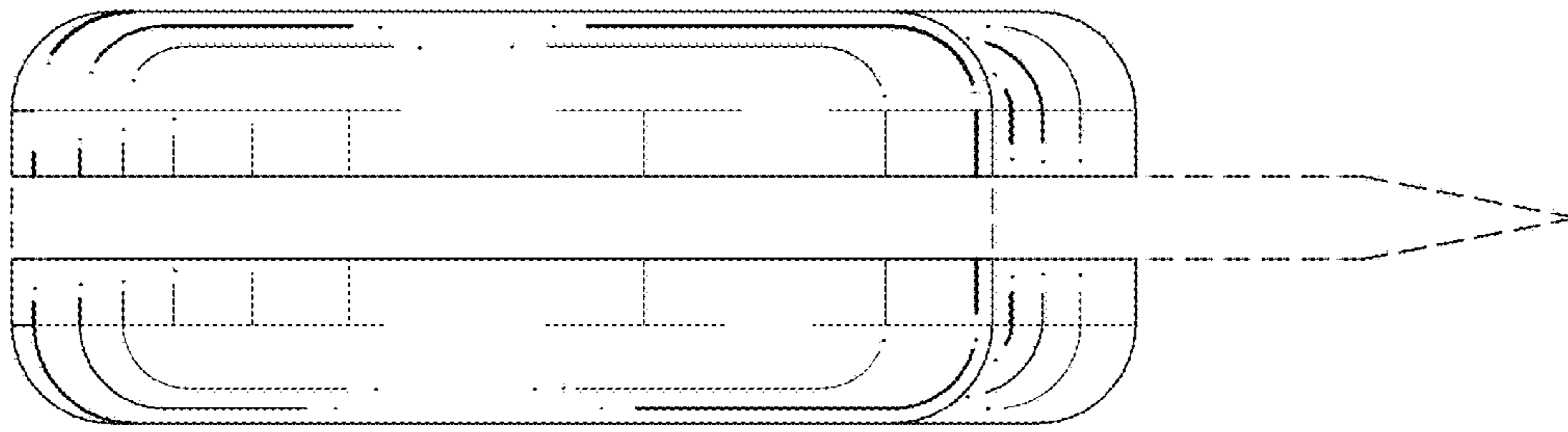

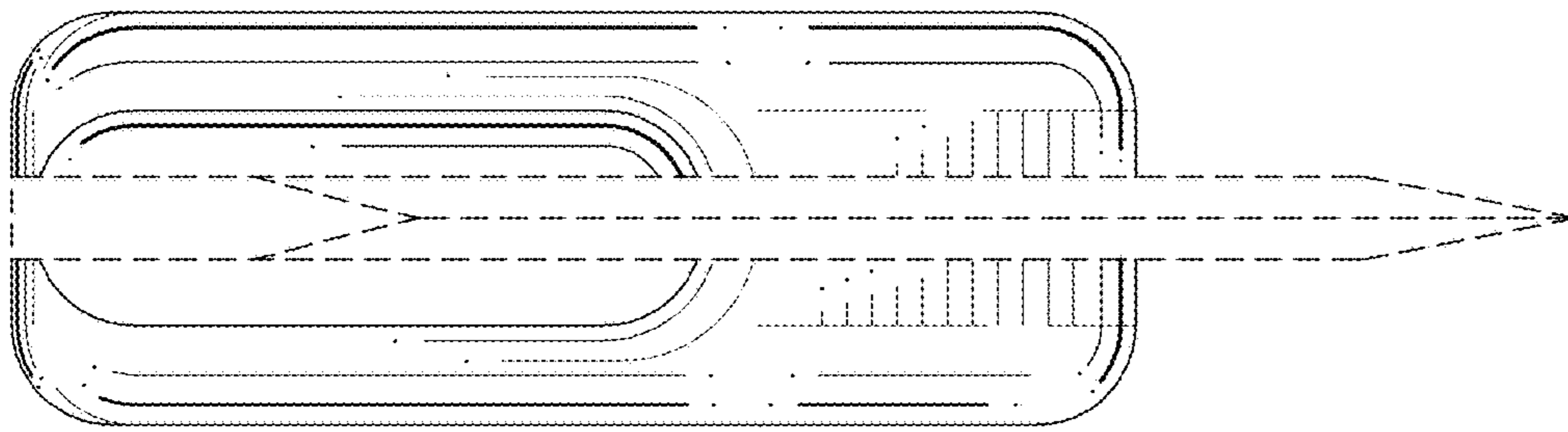

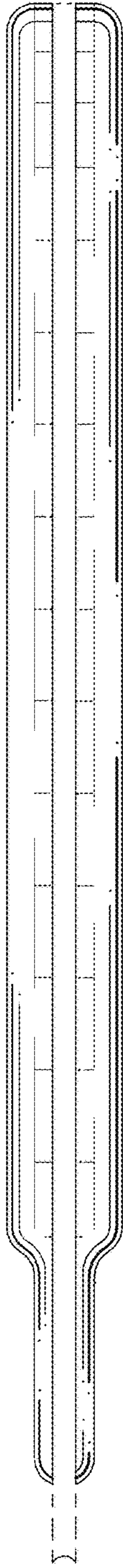

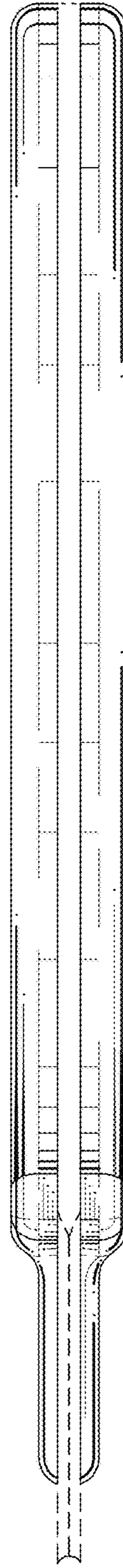

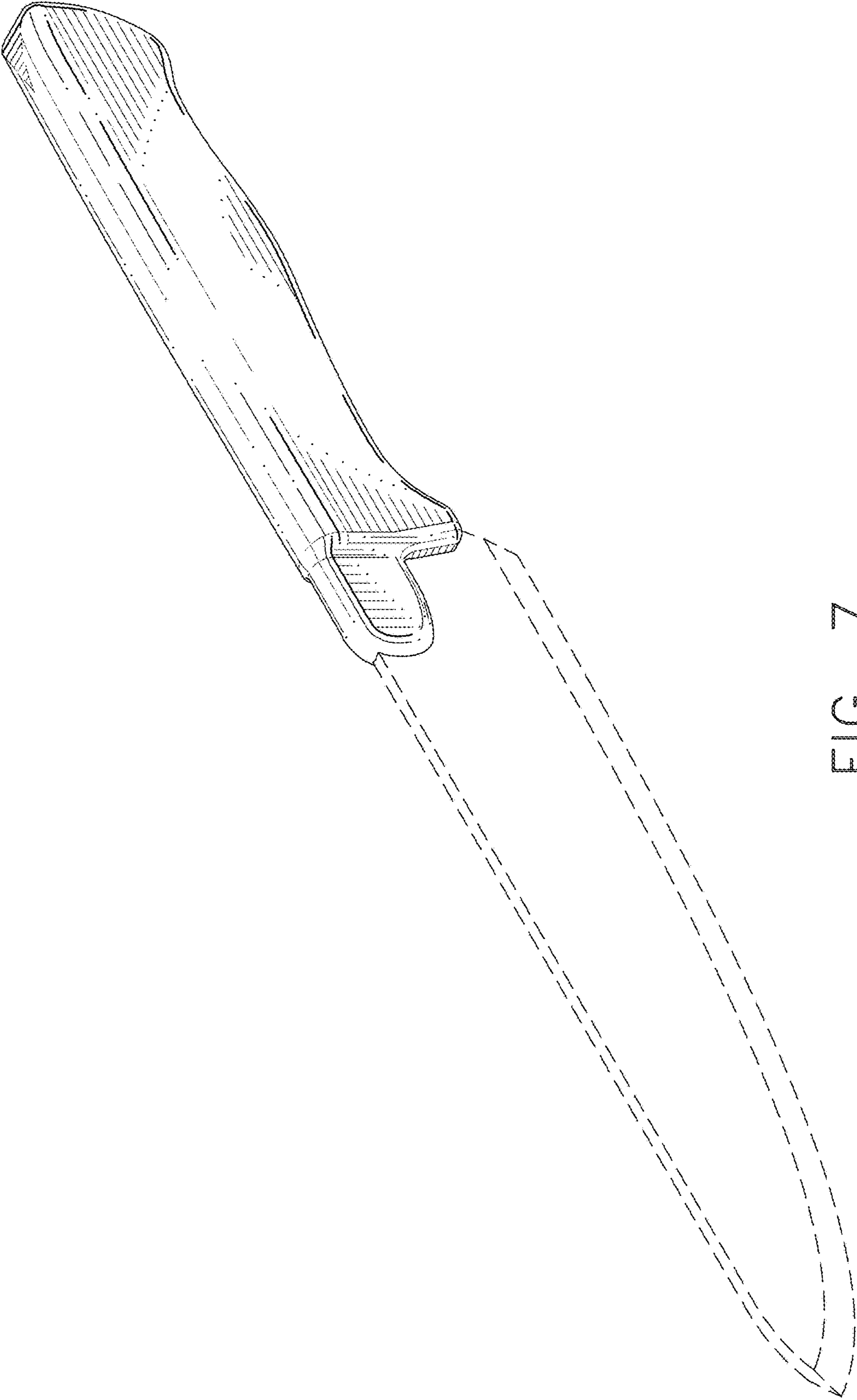

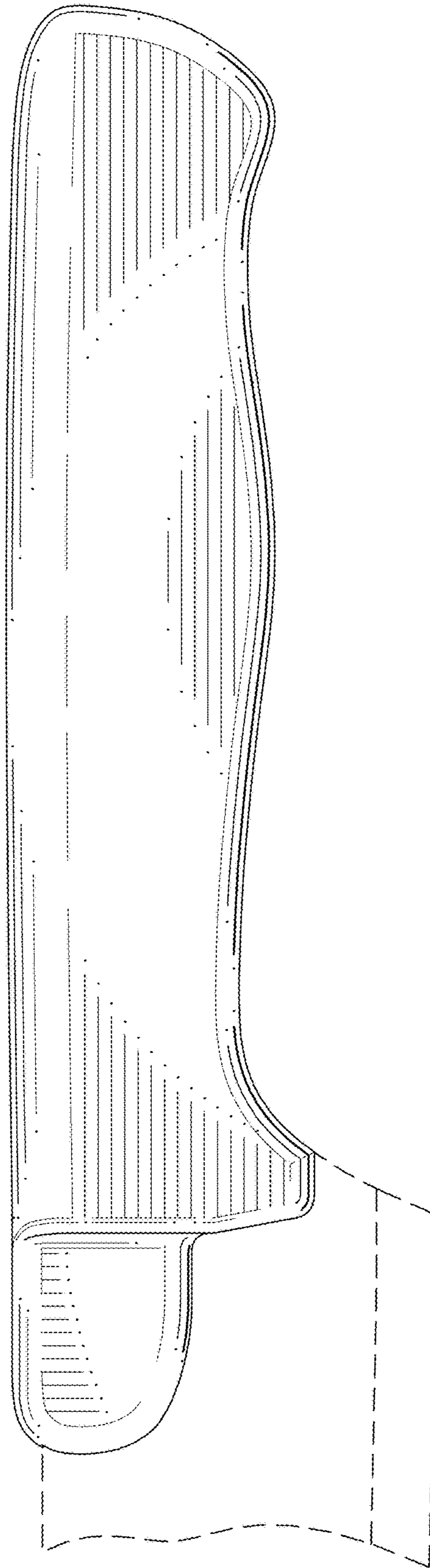

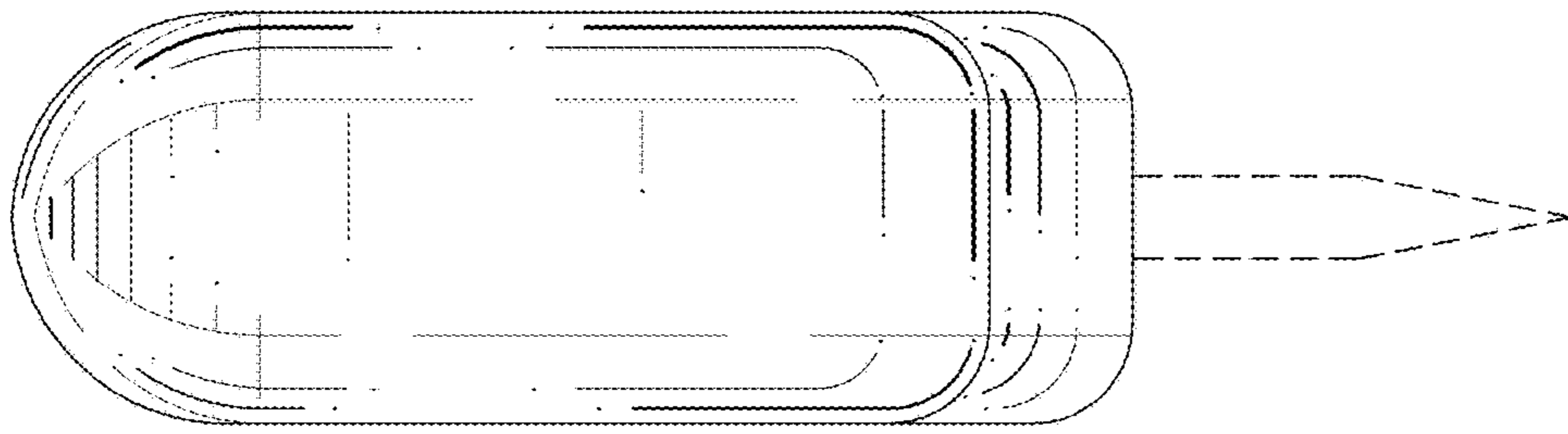

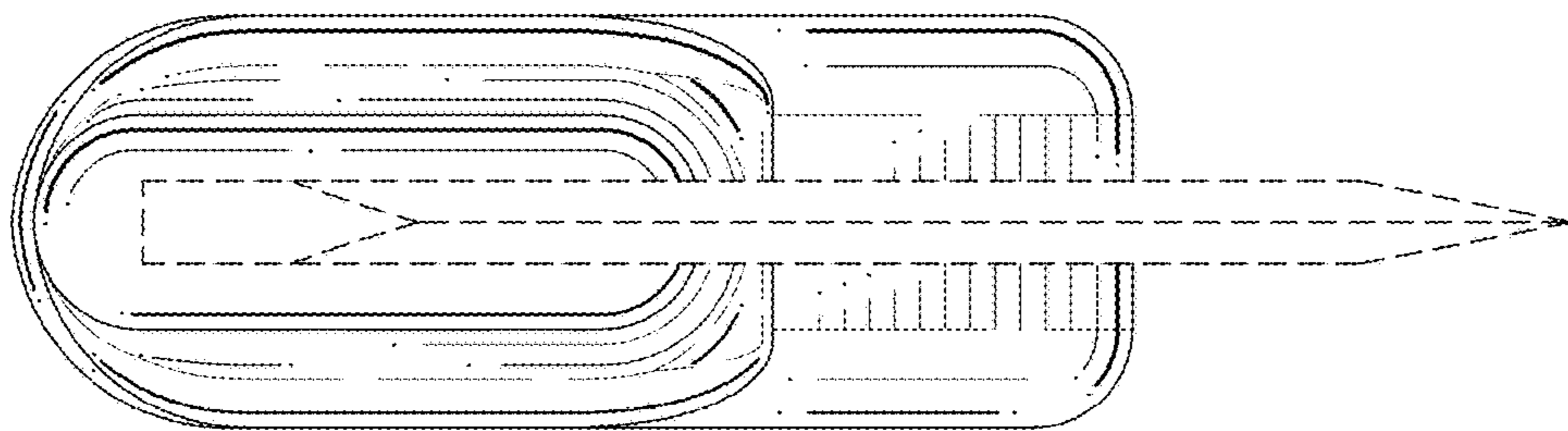

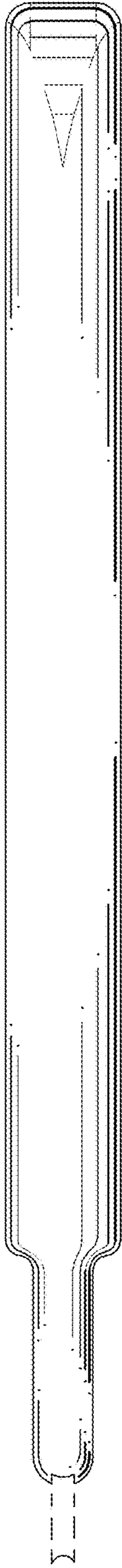

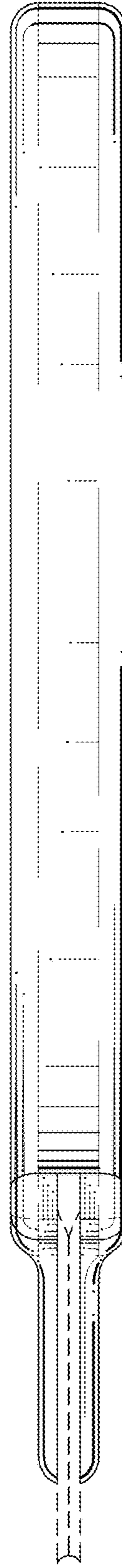
