DESCRIPTION

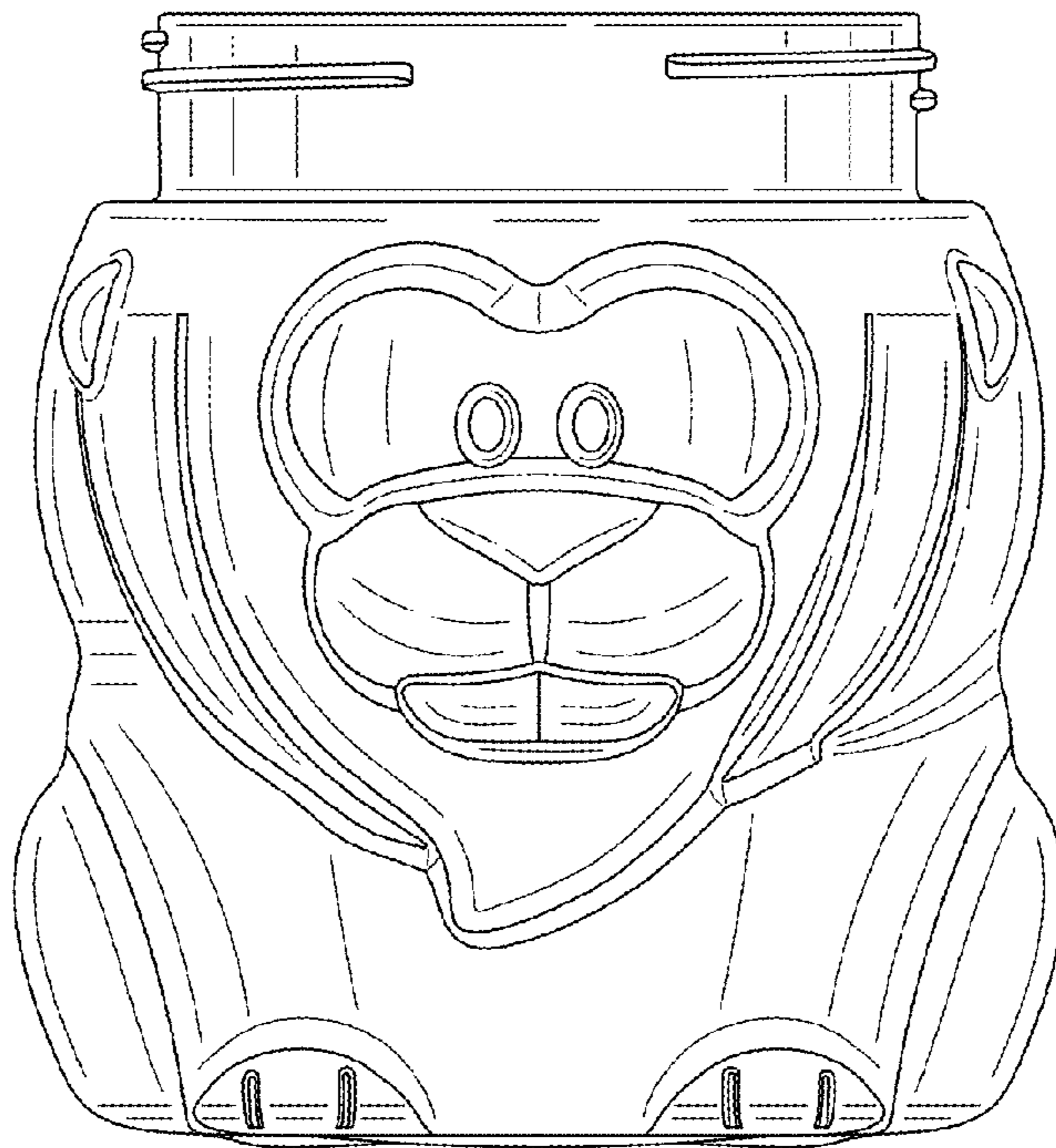
FIG. 1 is a top, front and left side perspective view of a snack cup with lion shape showing my new design;

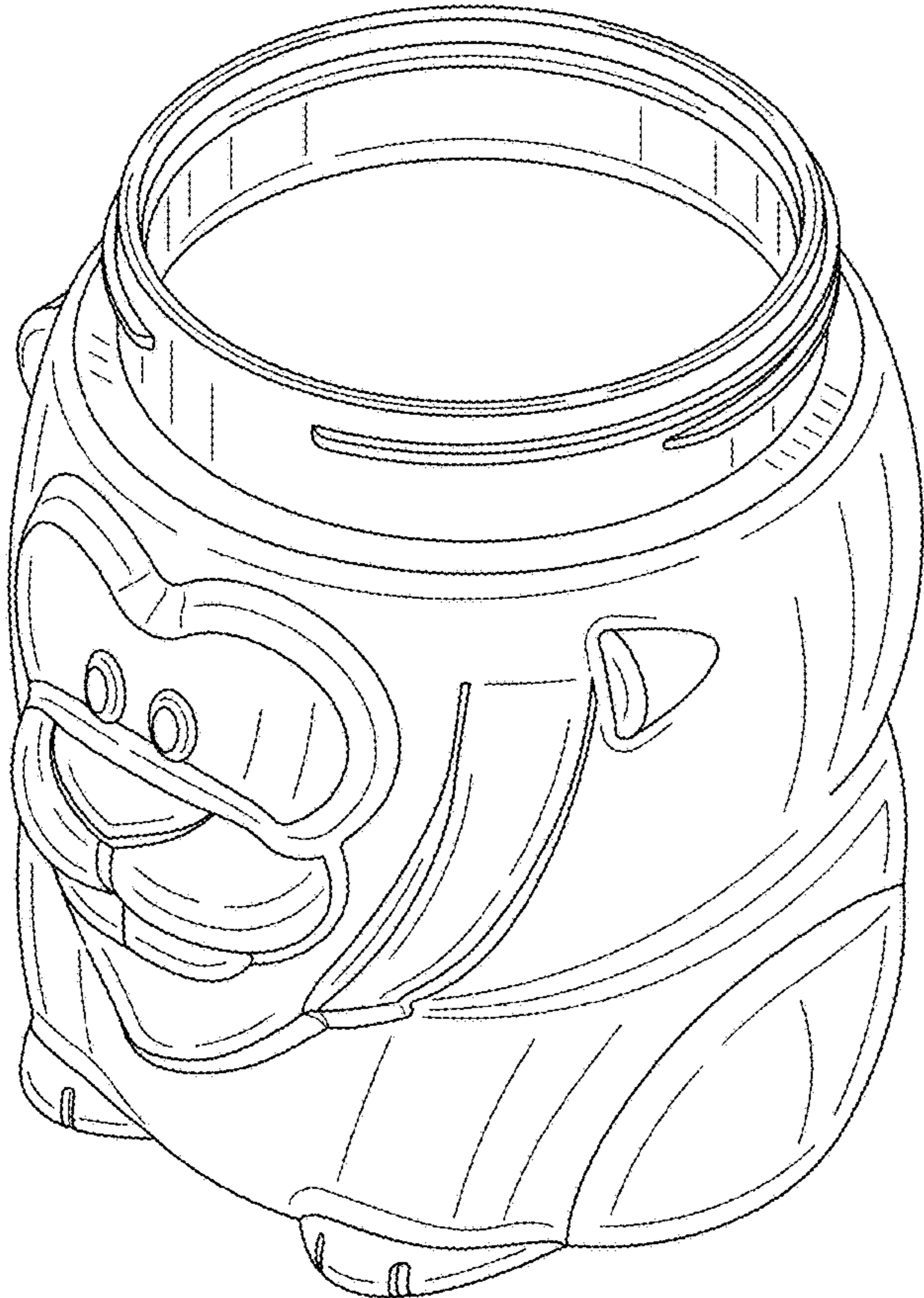

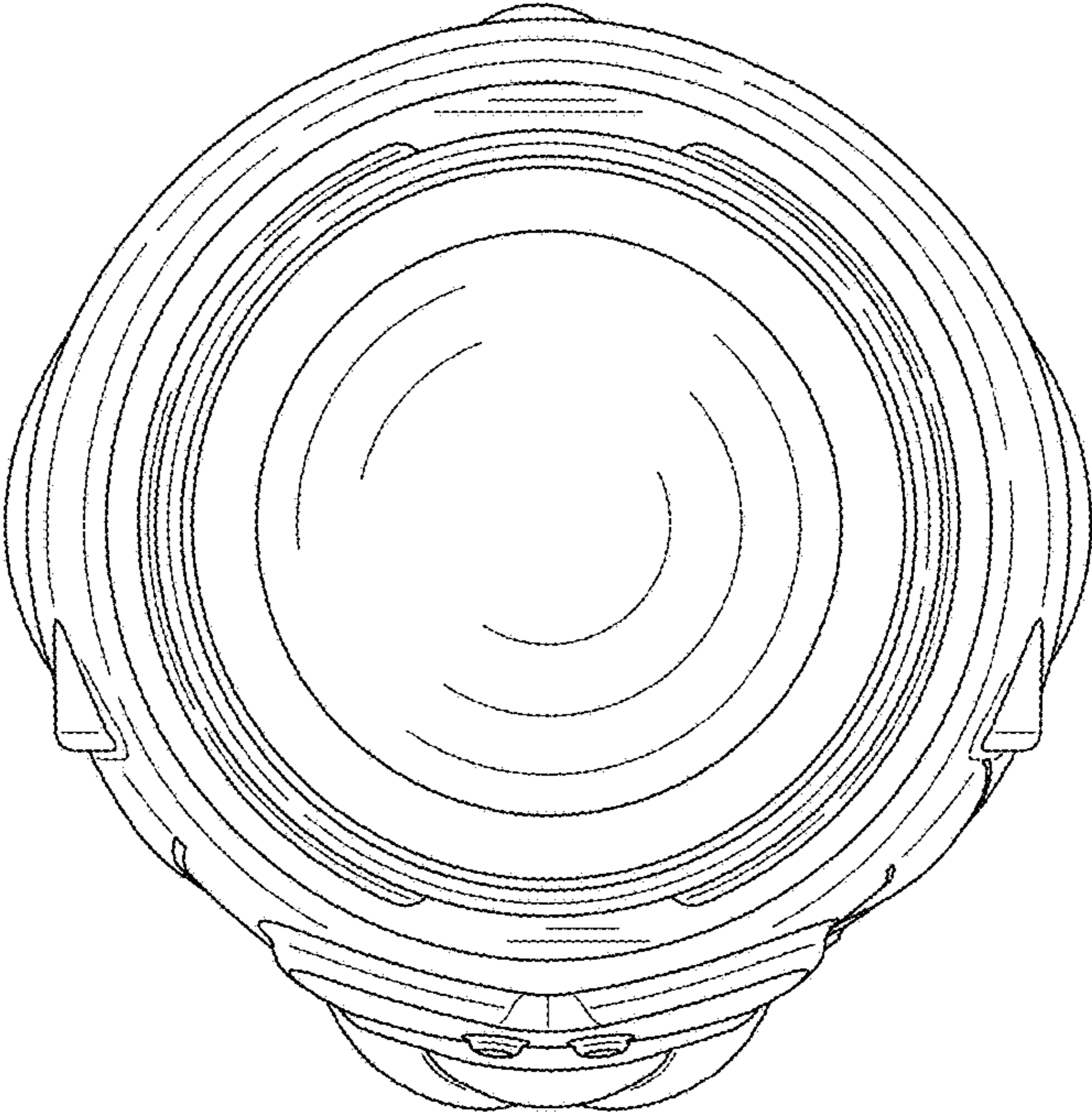

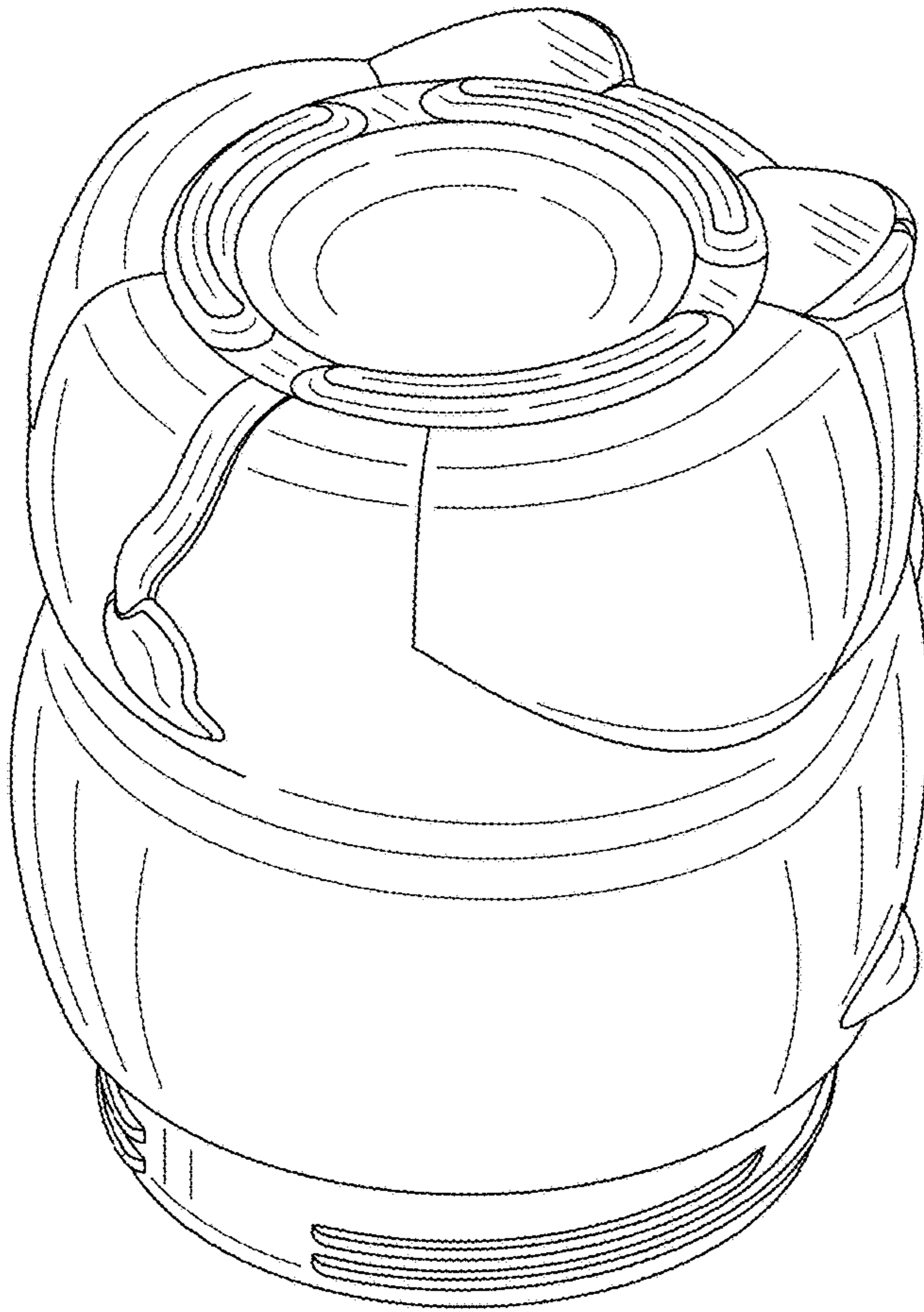
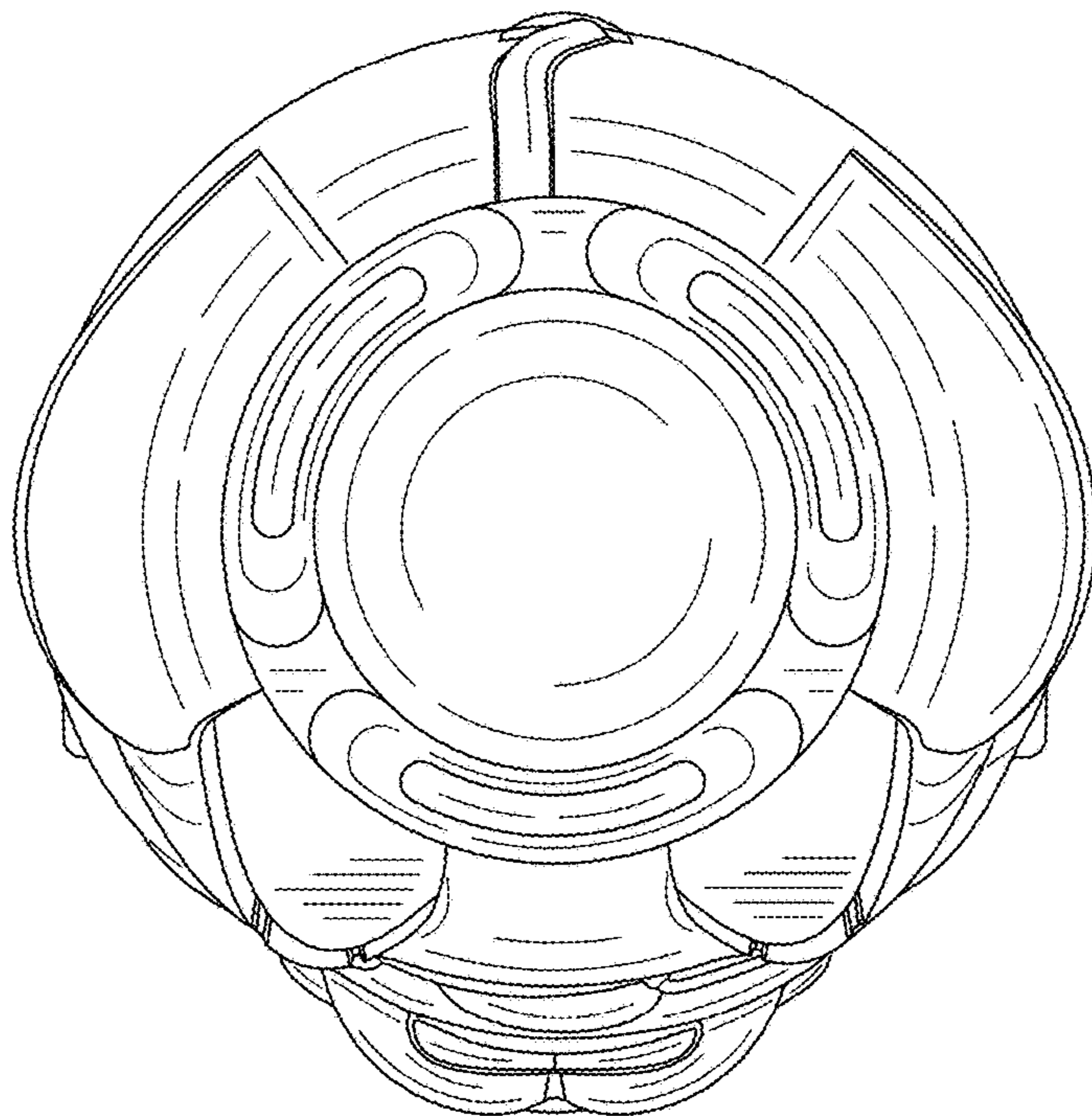

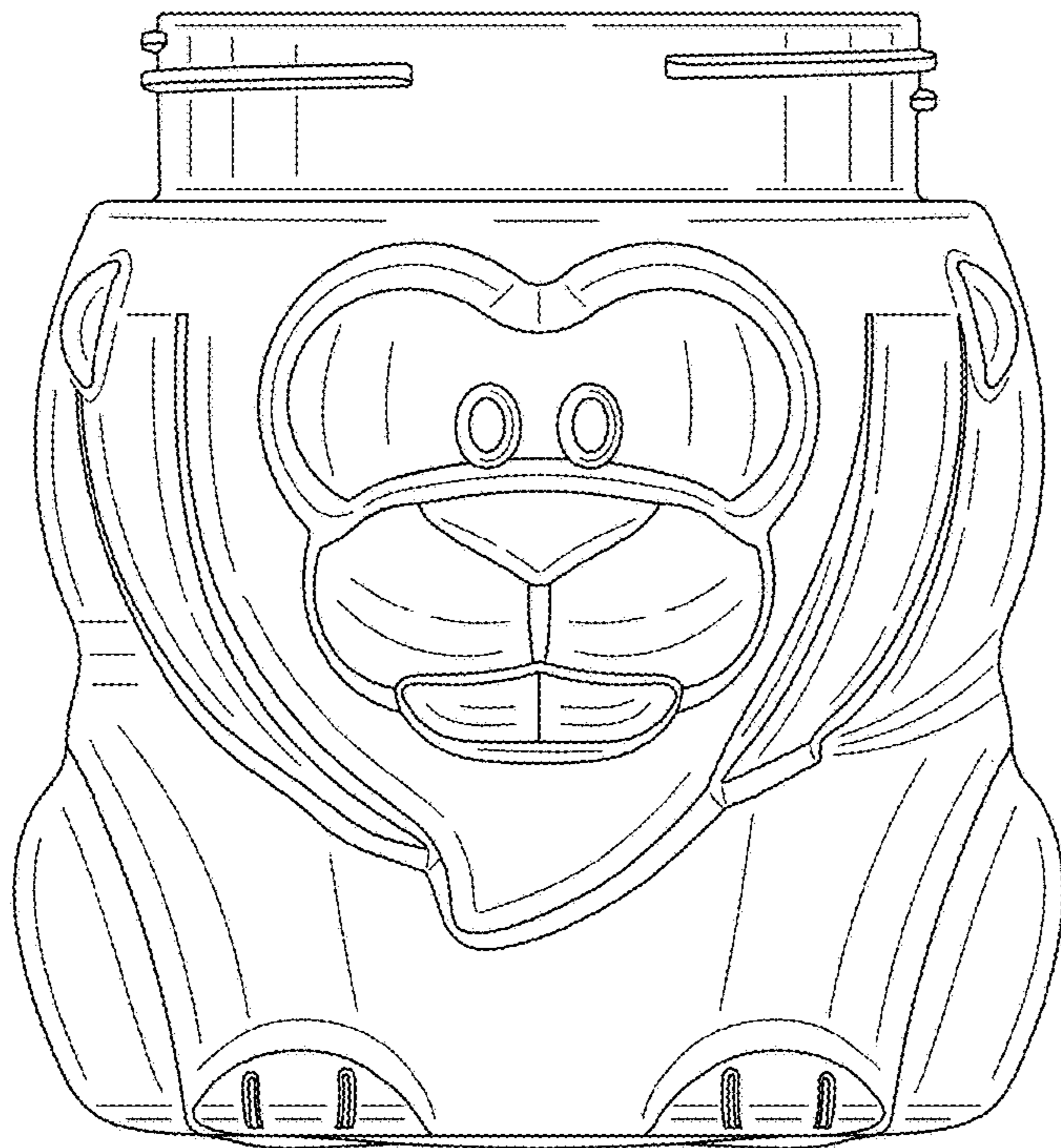
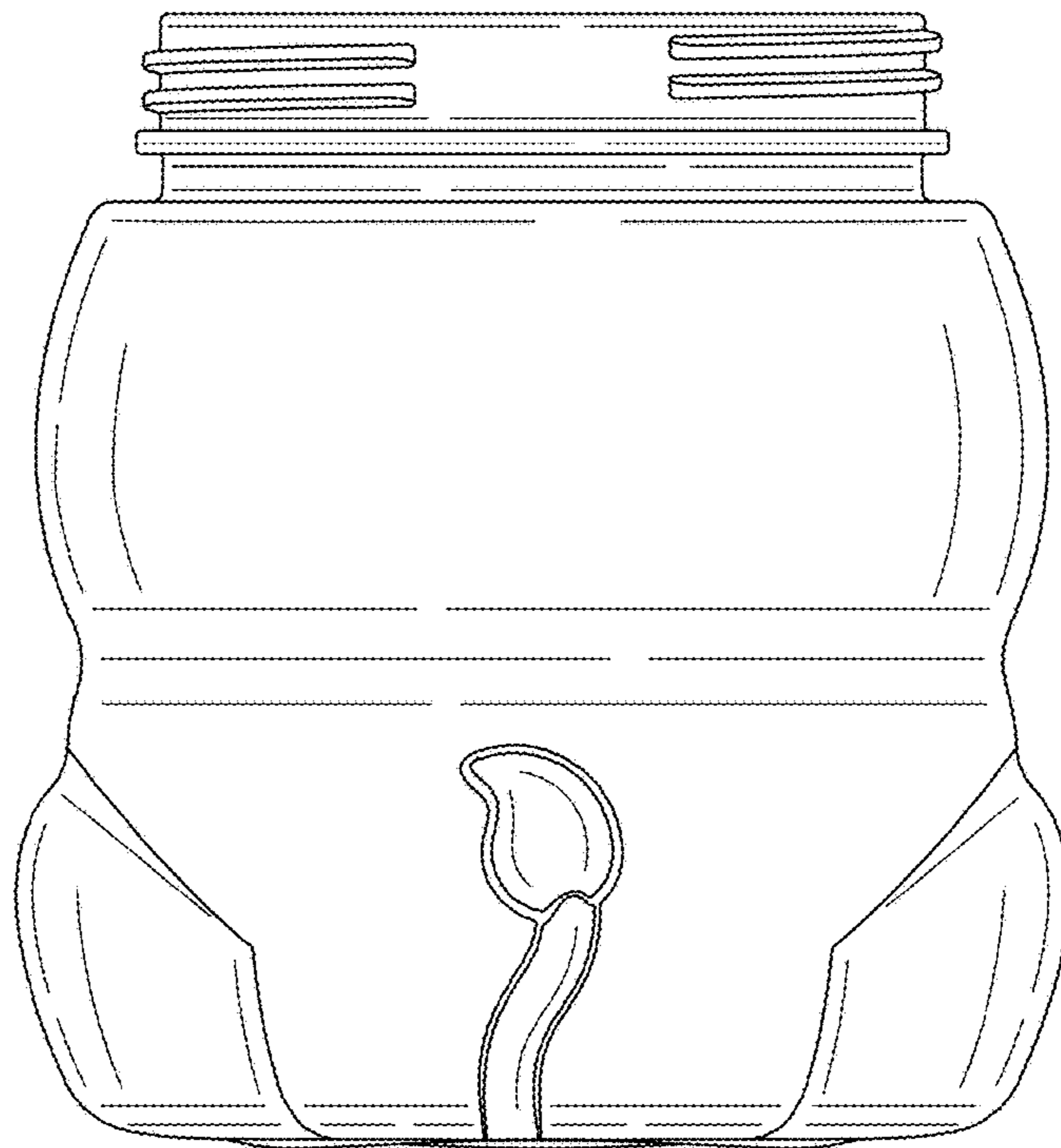

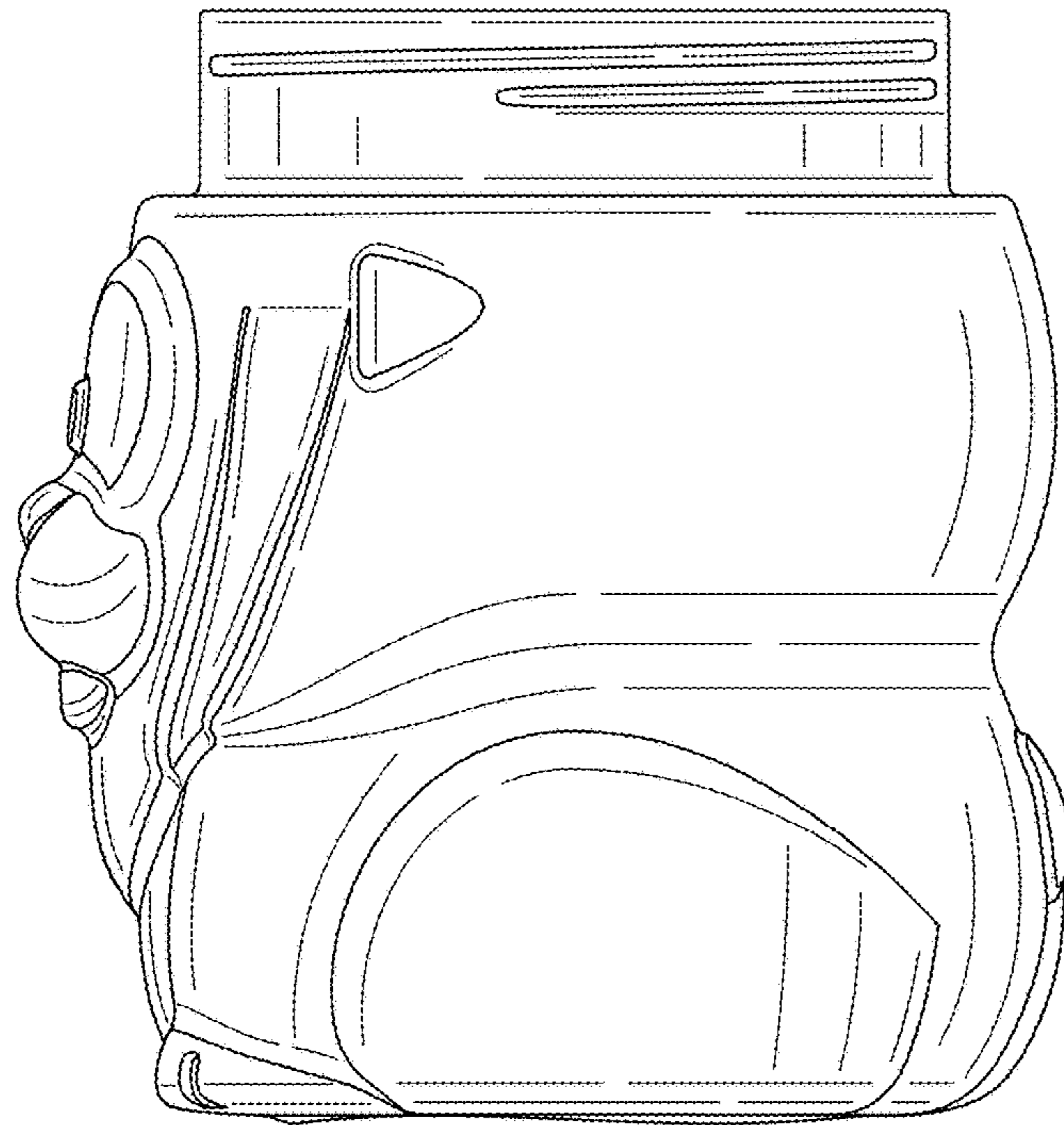
