DESCRIPTION

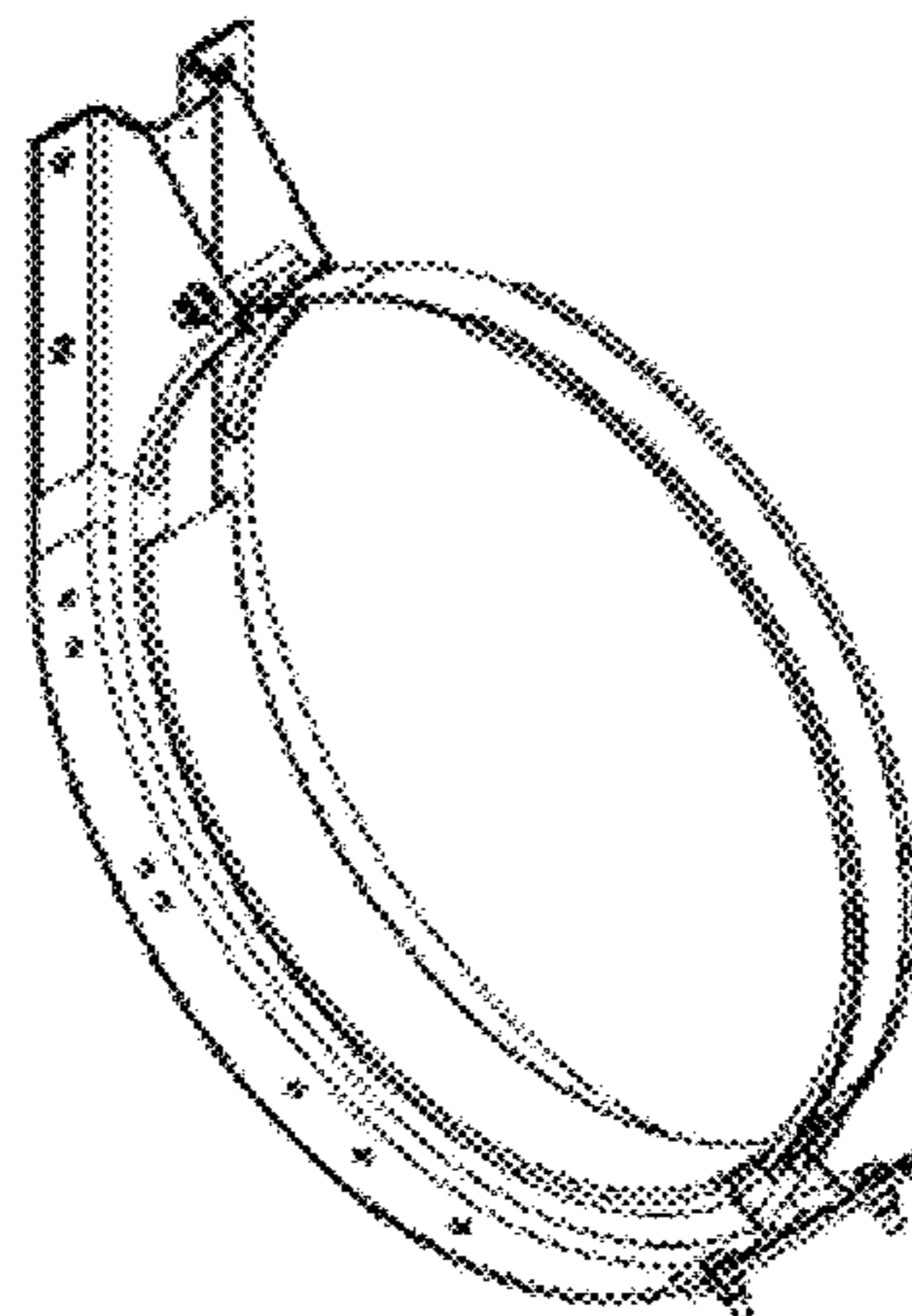
FIG. 1 is a perspective view of a cylinder support system showing my new design;

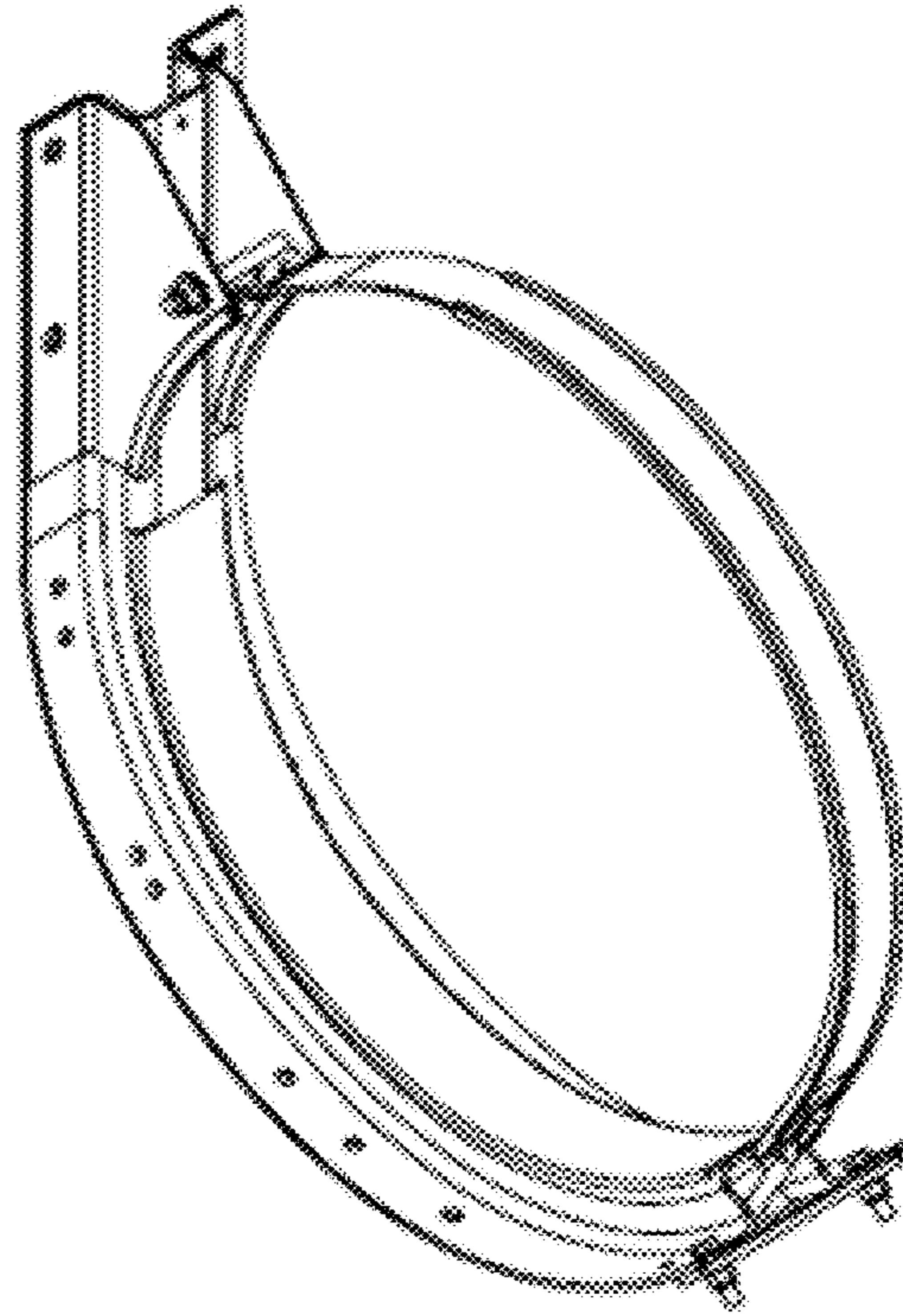

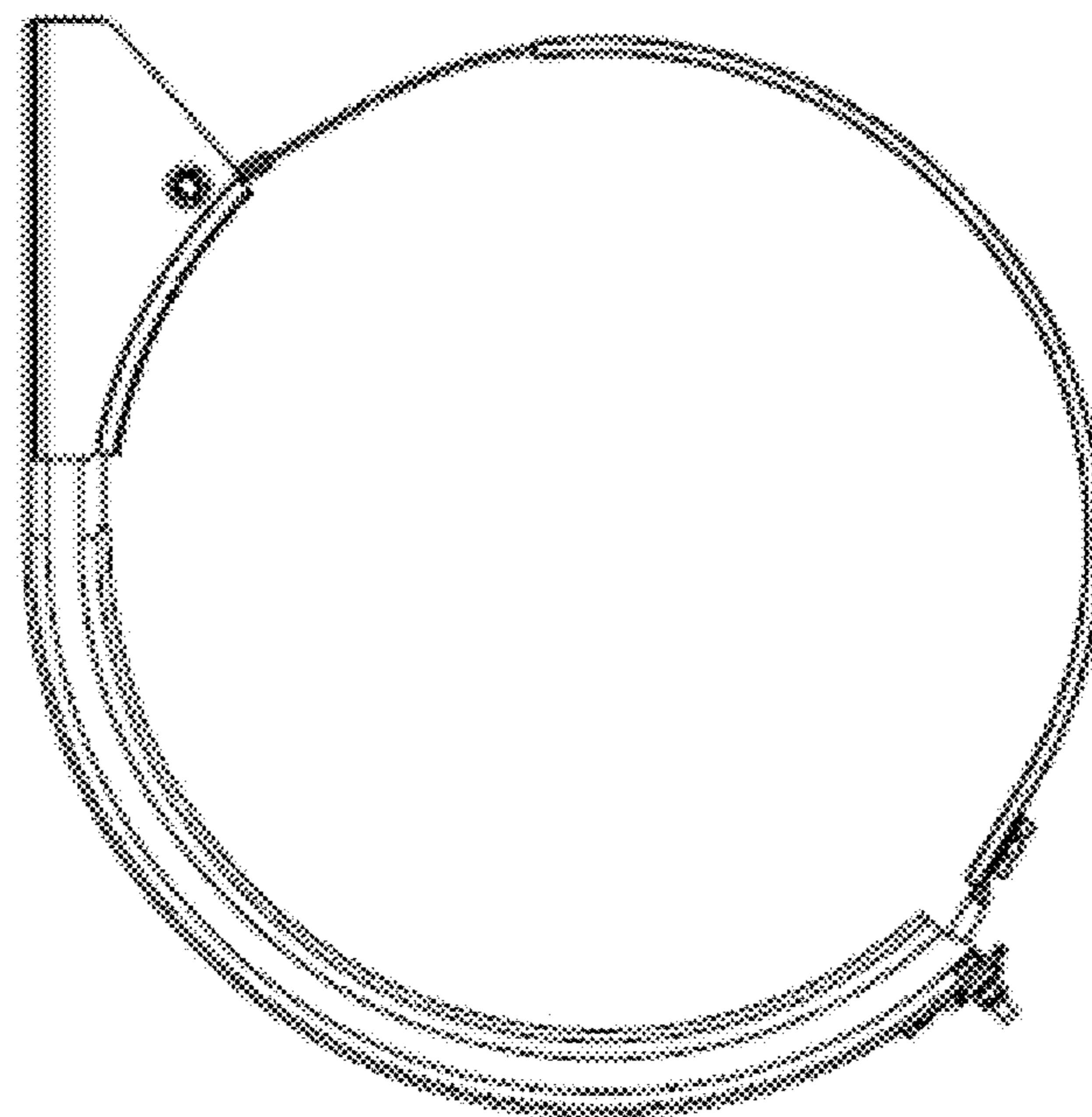

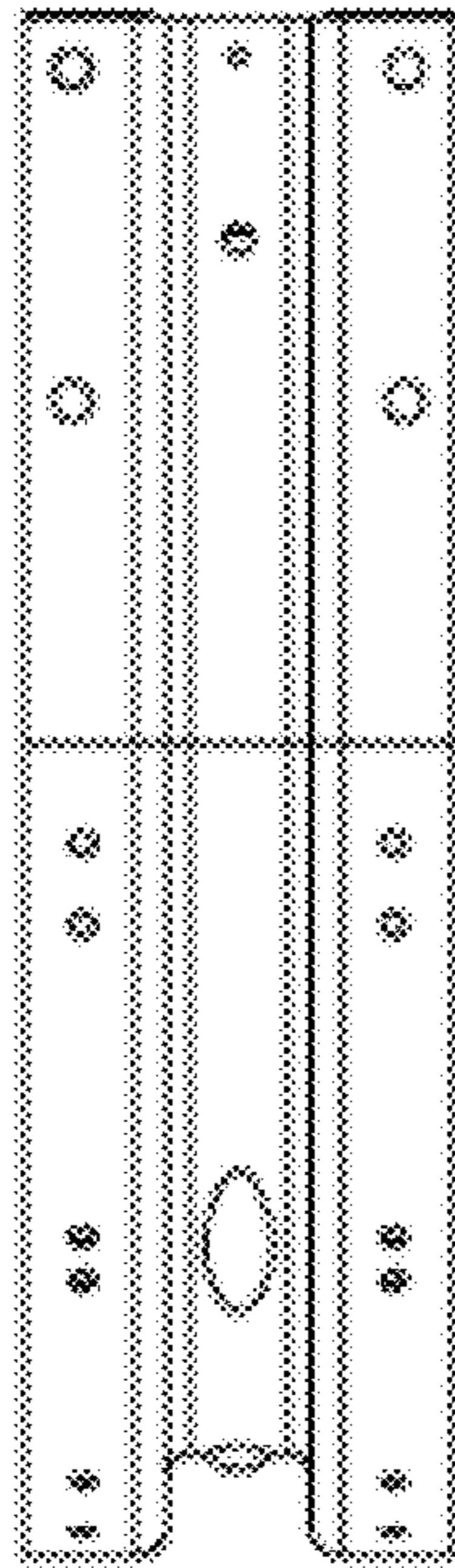

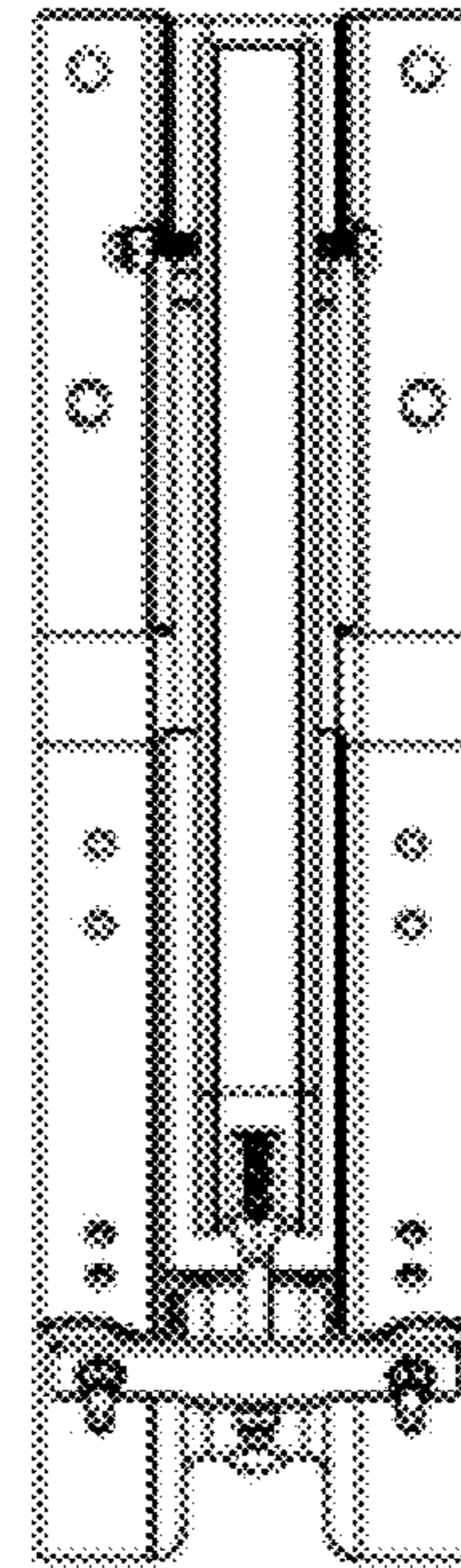

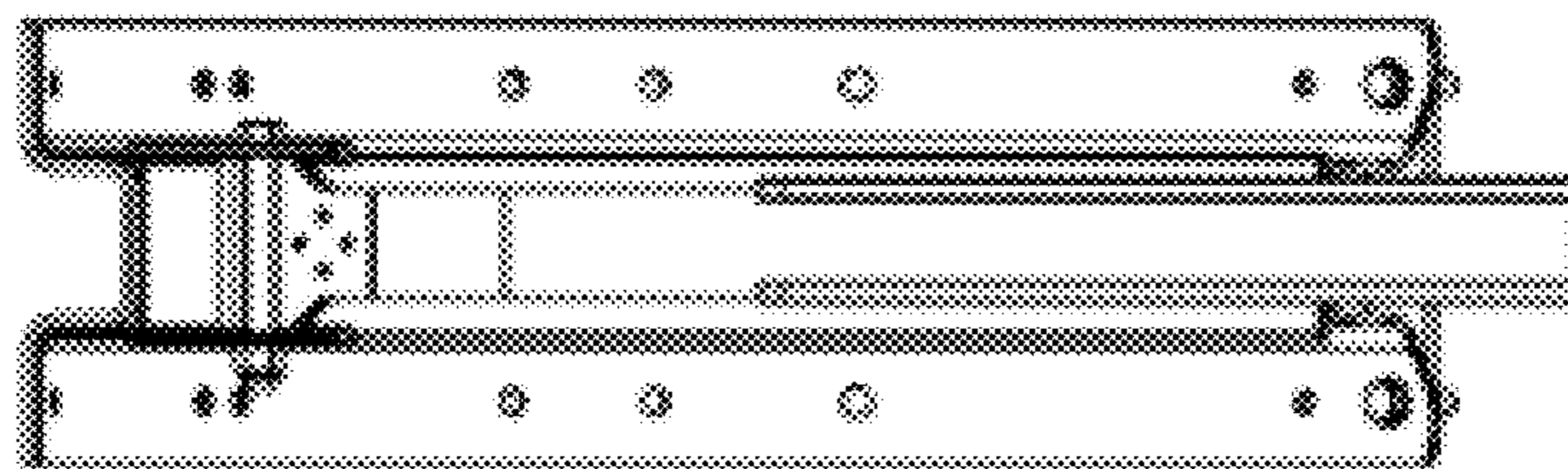
