(57) **CLAIM**

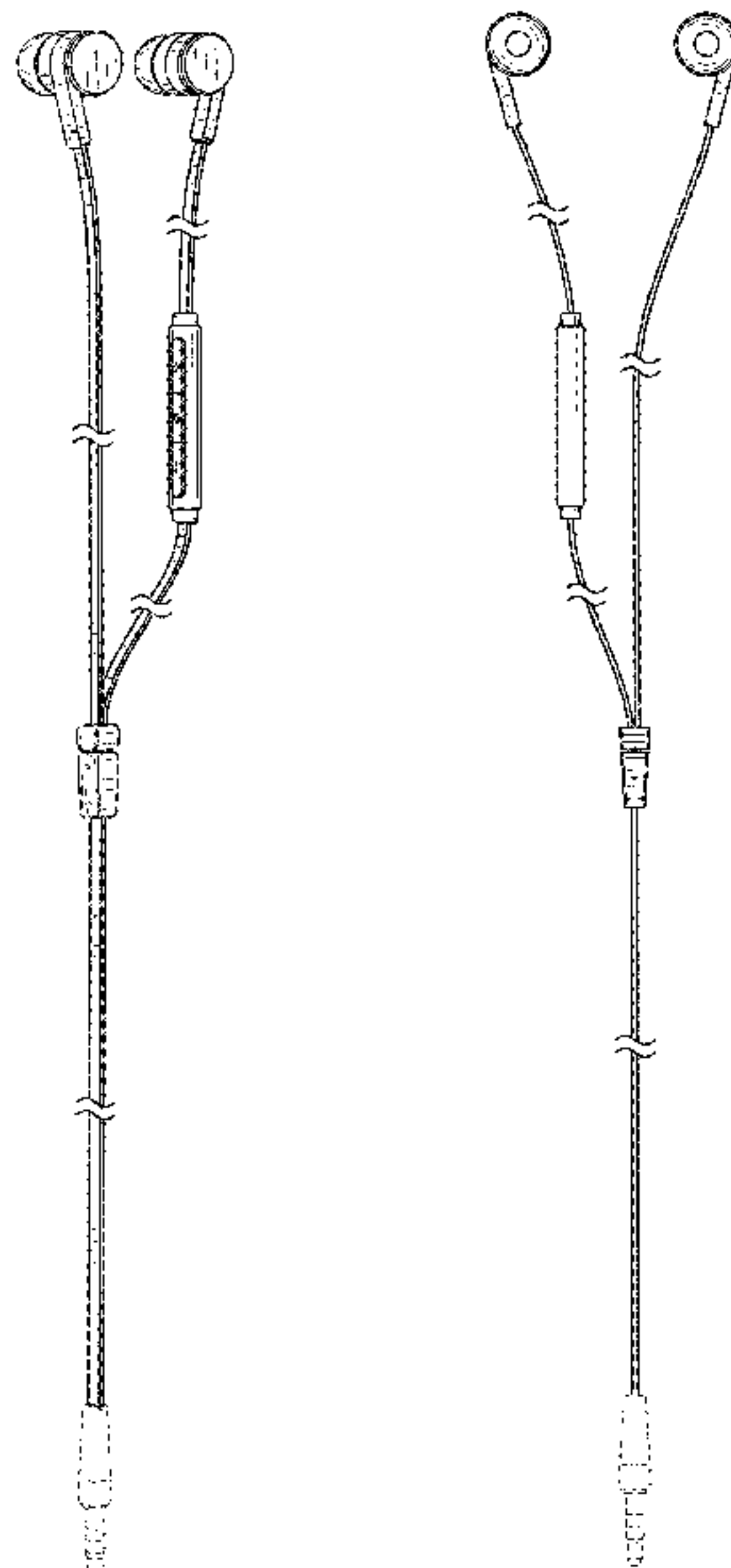
The ornamental design for earphones, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of earphones showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

The broken line showing of portions of the earbuds in FIGS. 1, 2, 3, 5, and 6 represents environmental subject matter and forms no part of the claimed design. In FIGS. 1, 2, 3, 5, and 6 portions of the cord shown broken away represent indefinite length. The earphones are shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

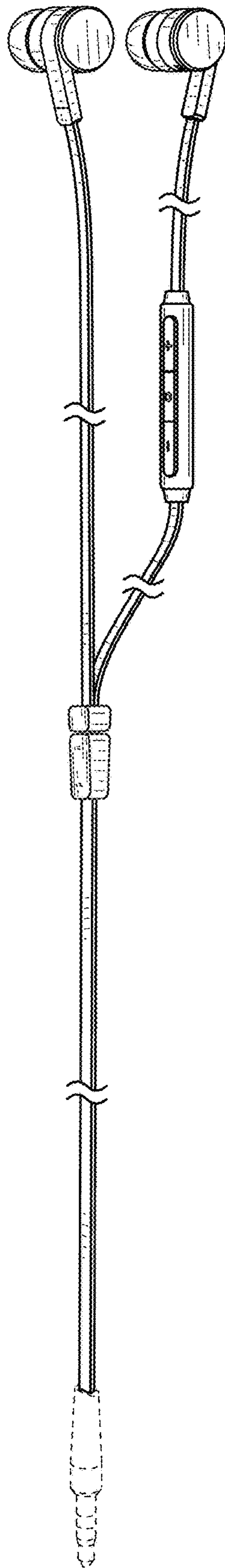

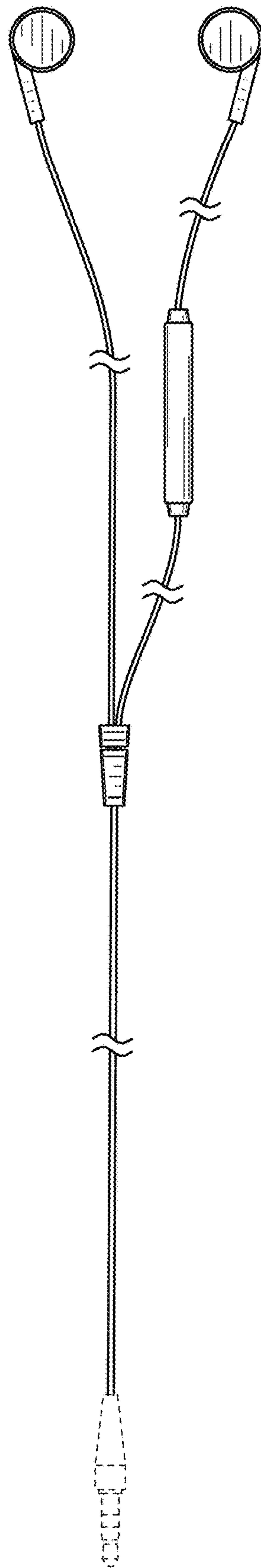

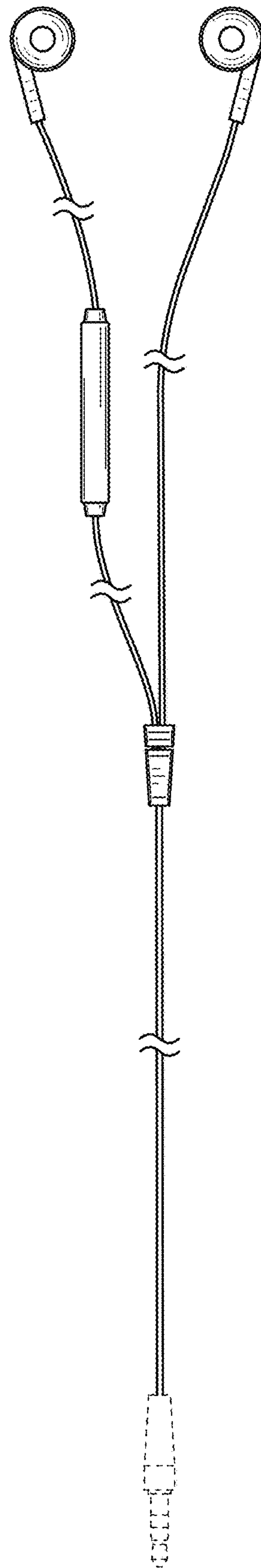

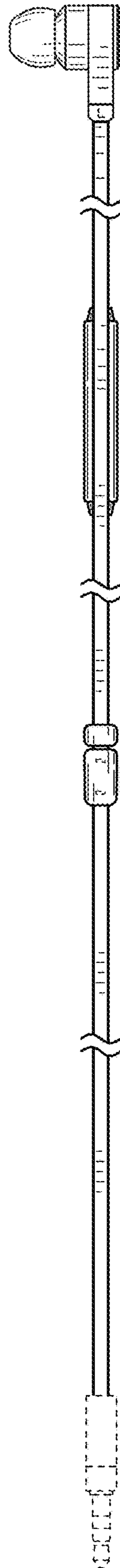

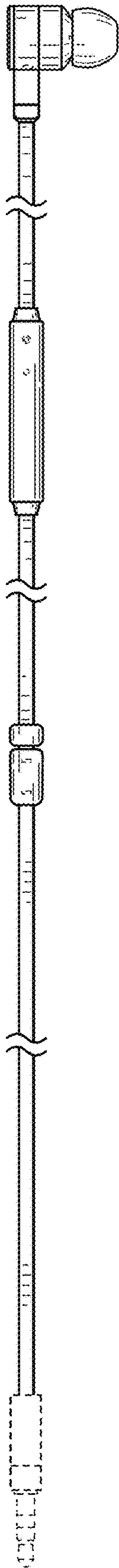

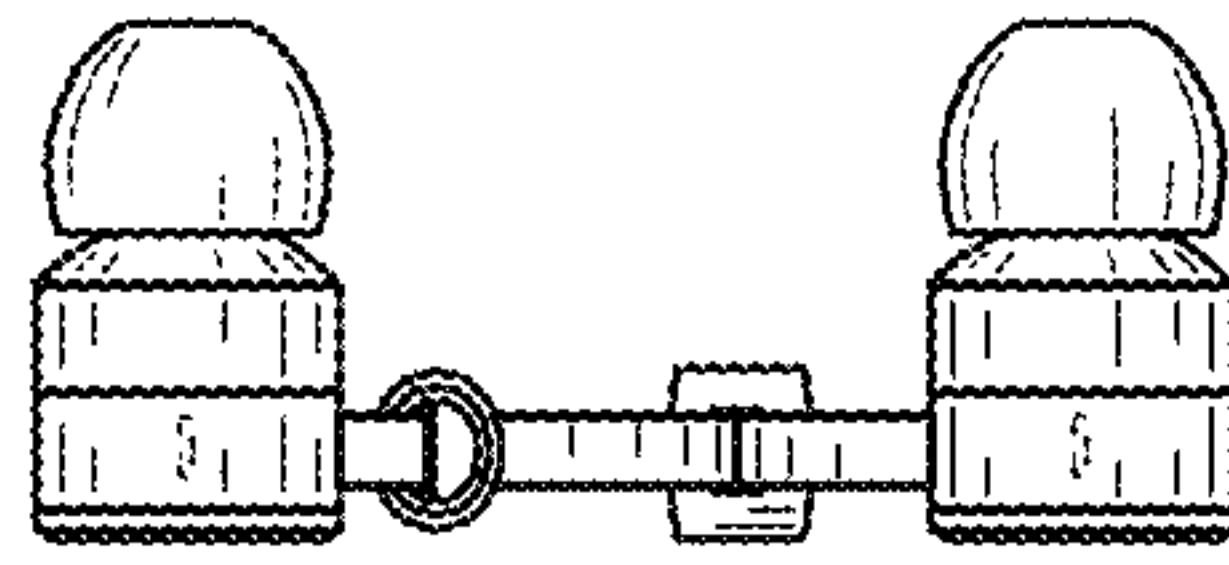

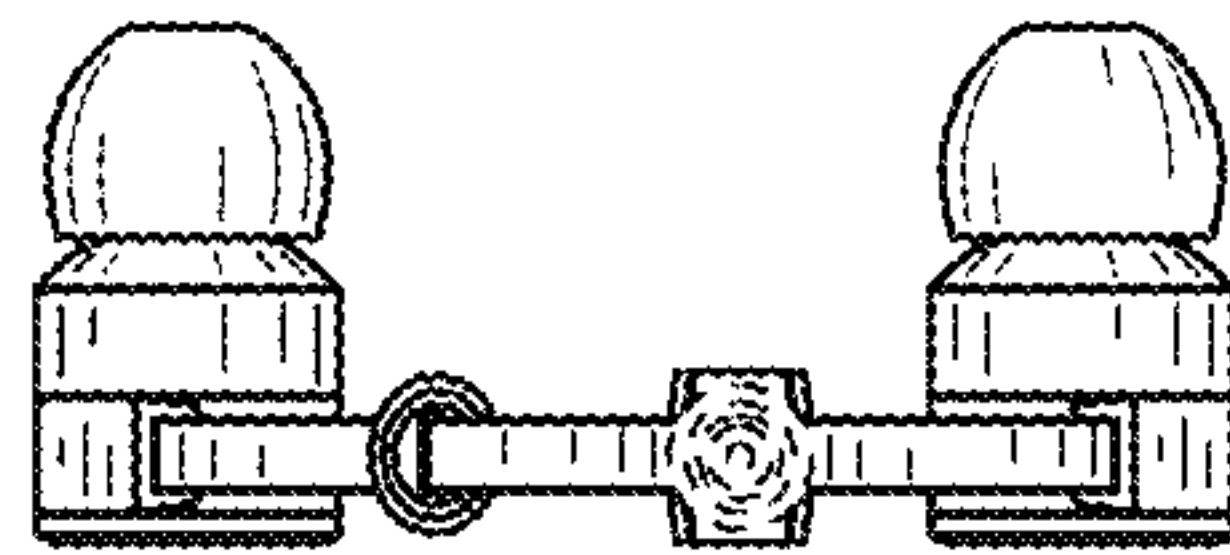
