FIG. 6 is a left side view thereof.

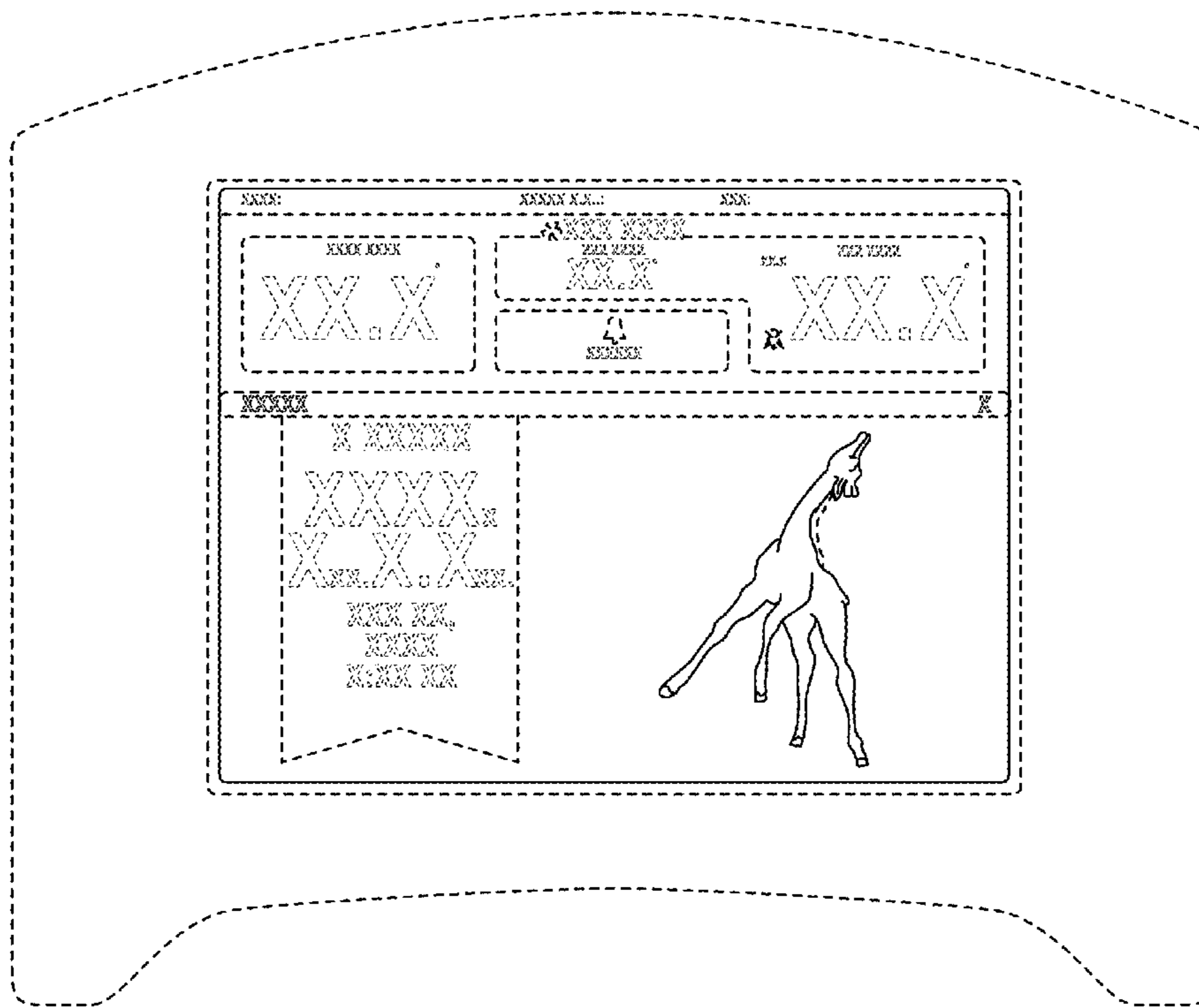

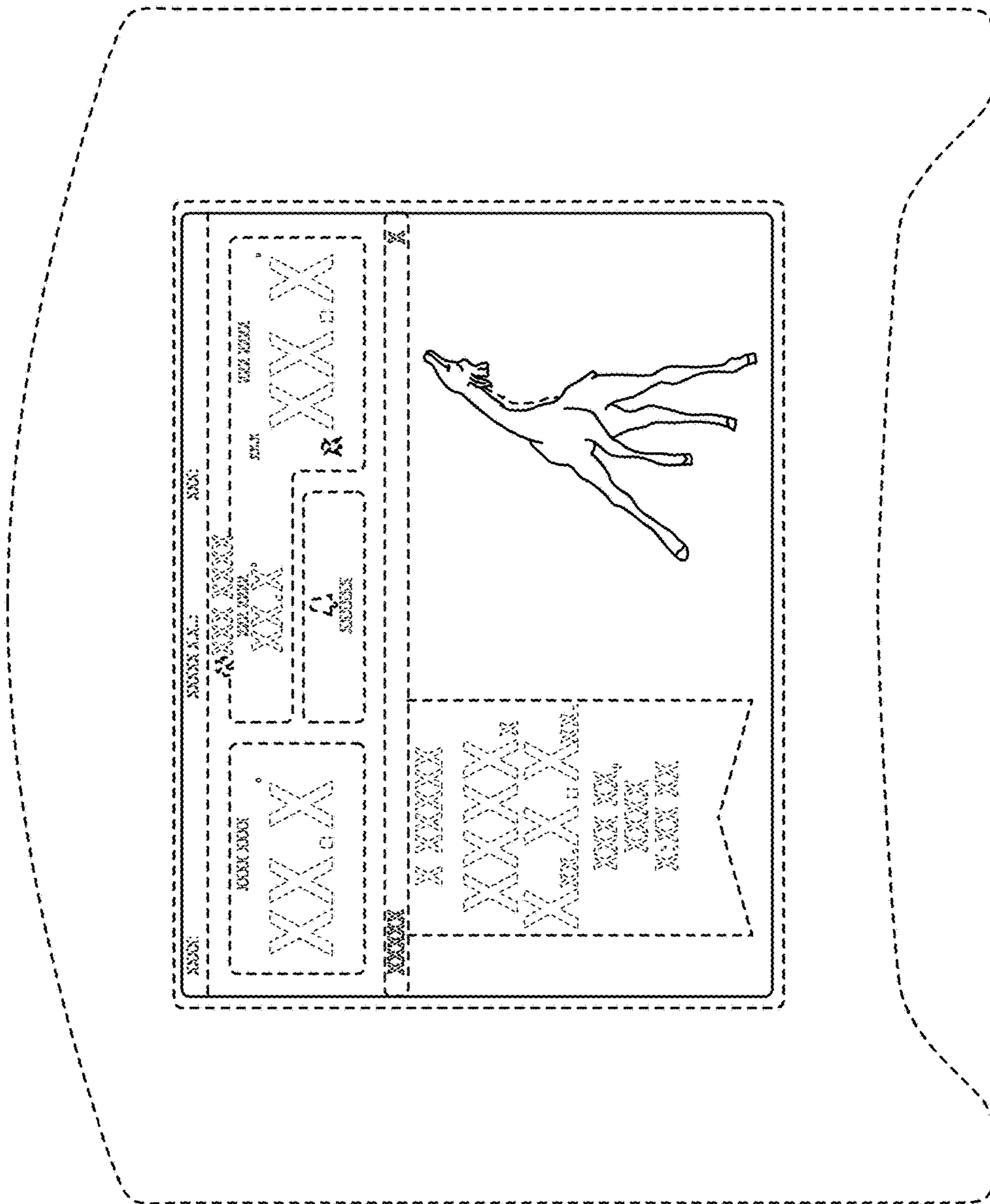

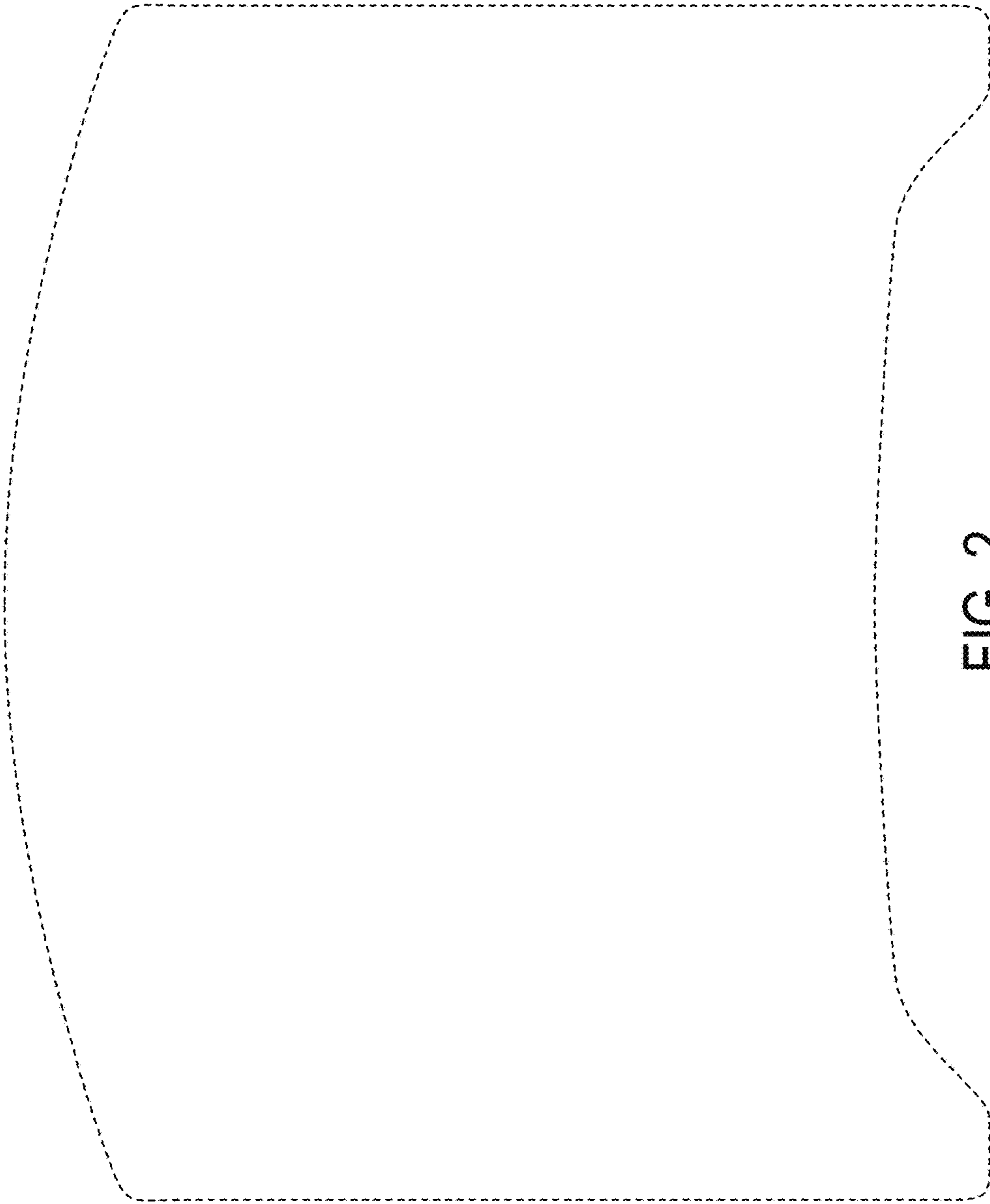

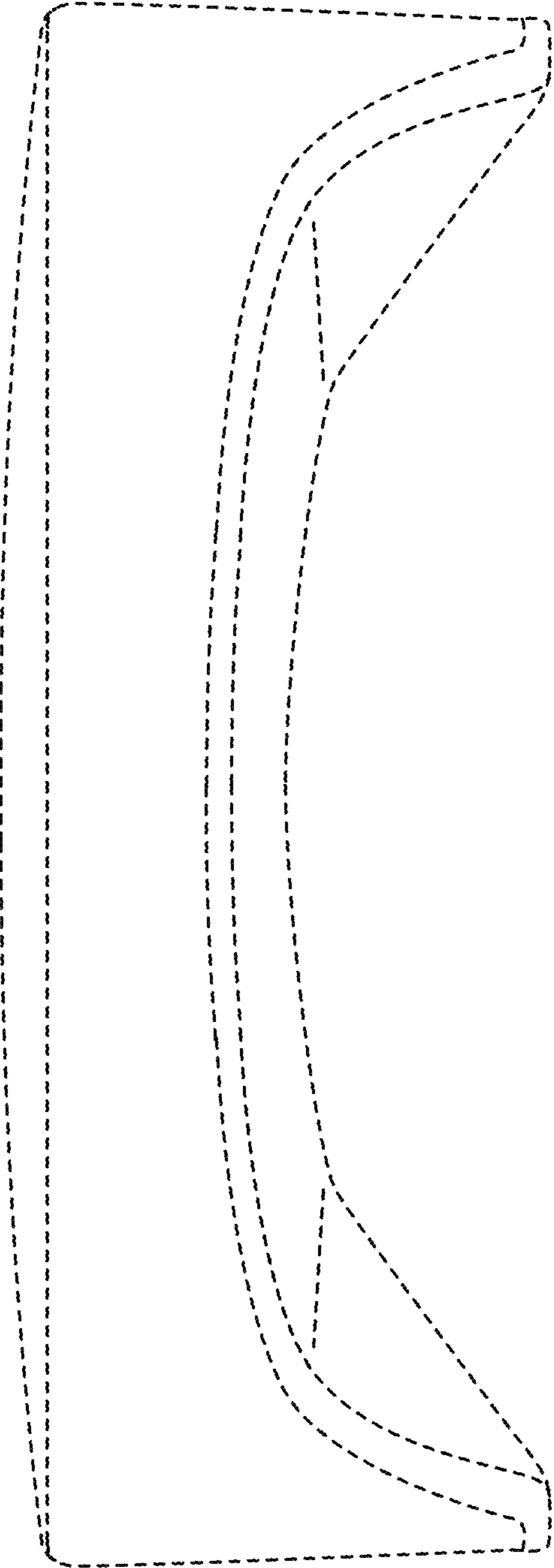

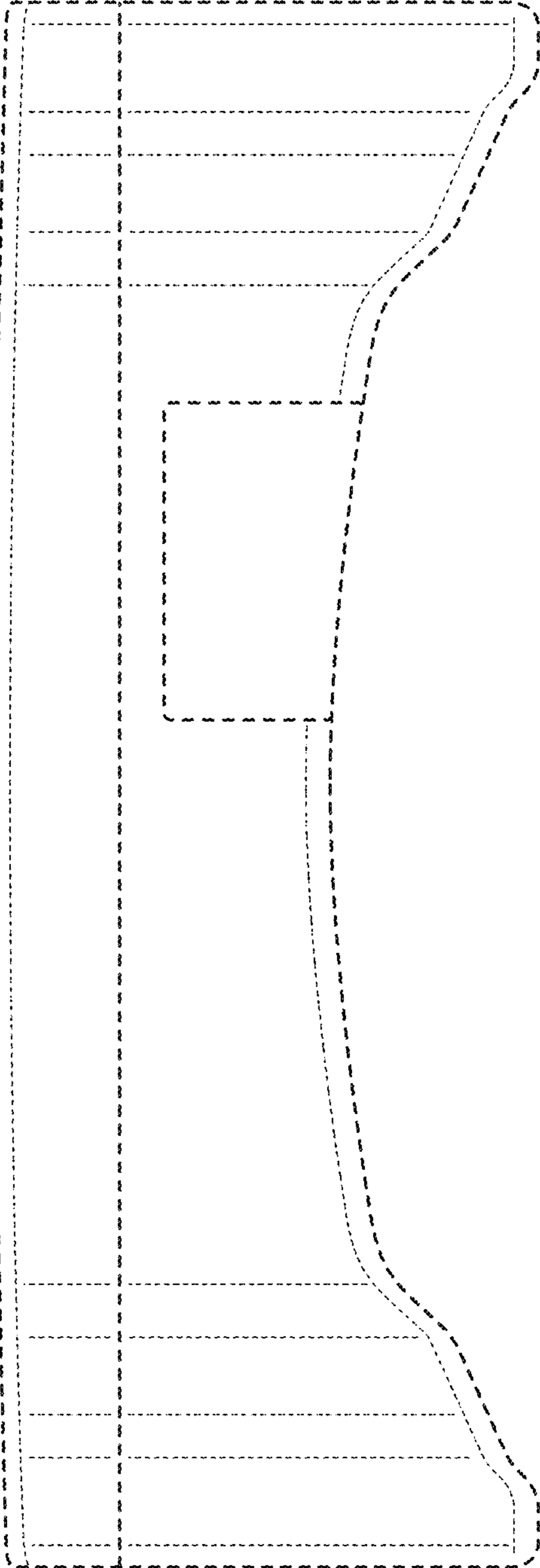

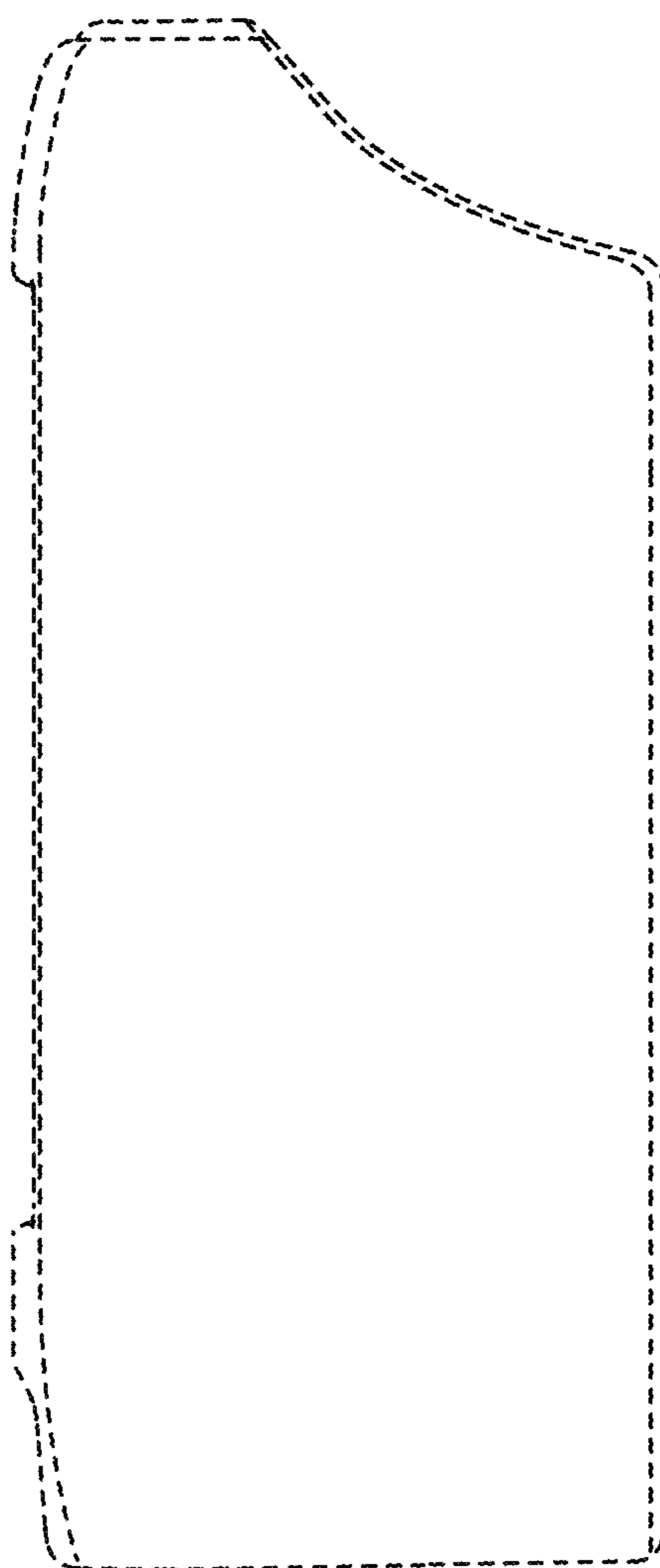

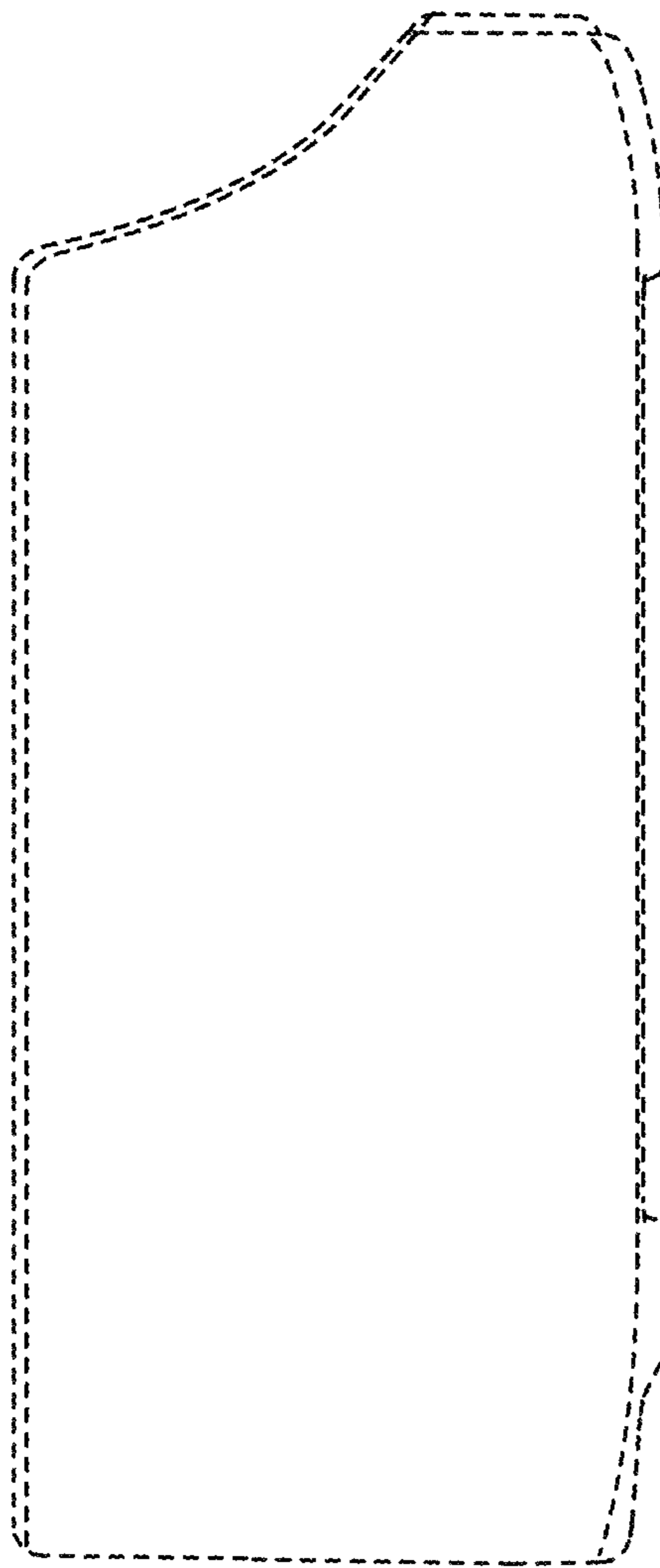
