(57) **CLAIM**

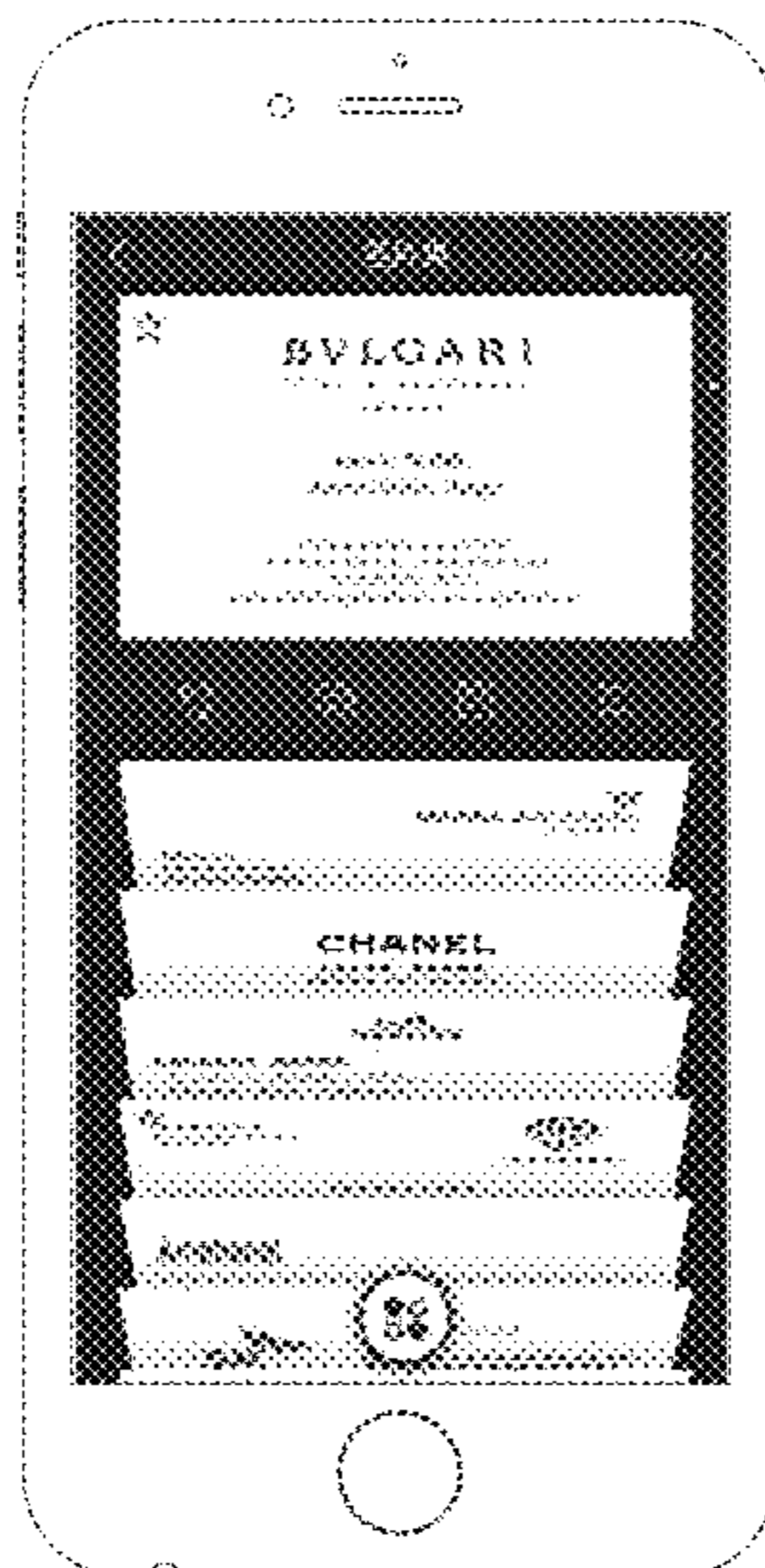
I claim the ornamental design for a display screen with graphic user interface for a mobile electronic device, as shown and described.
