(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 5 is a fifth image thereof;

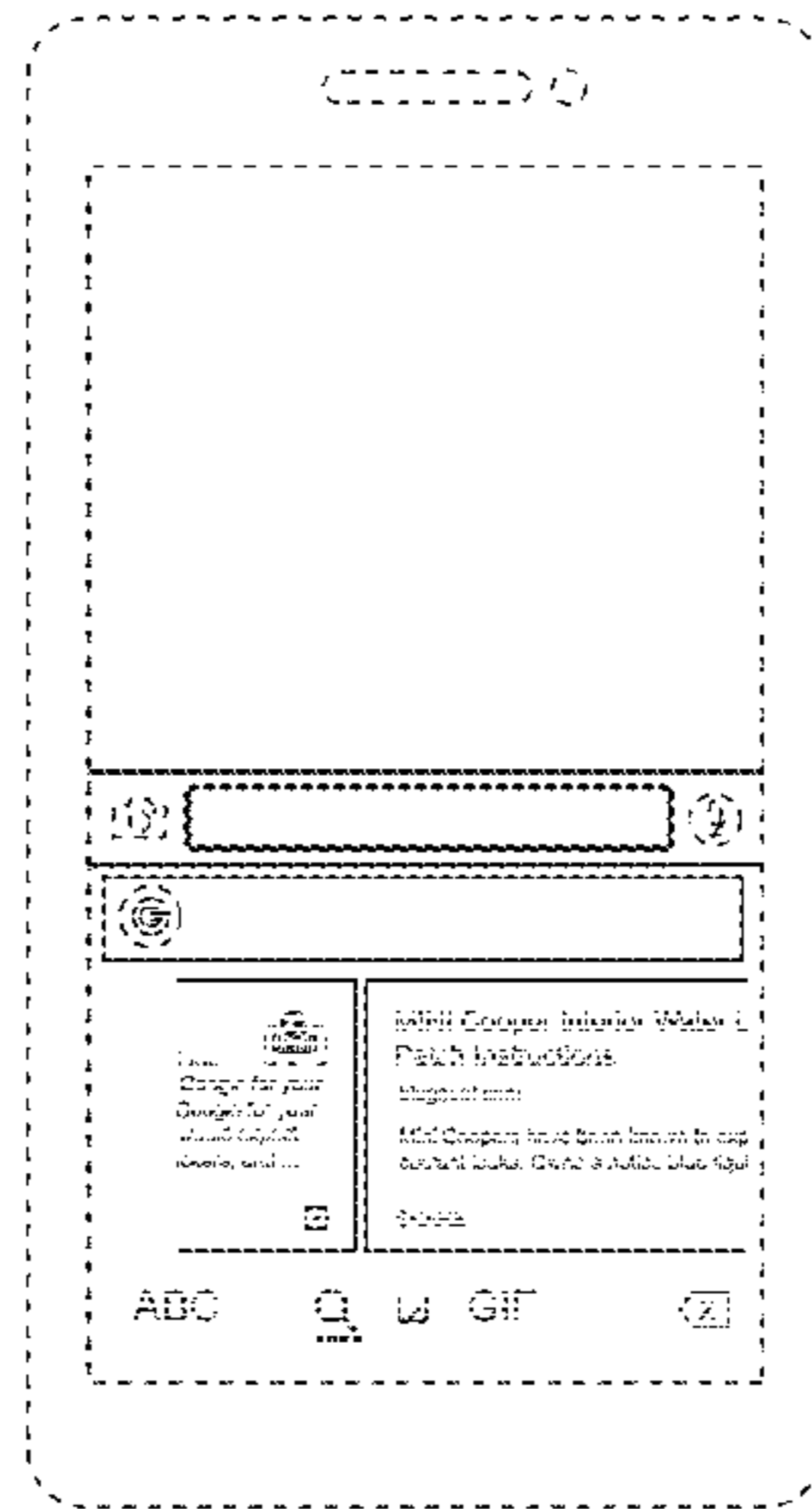
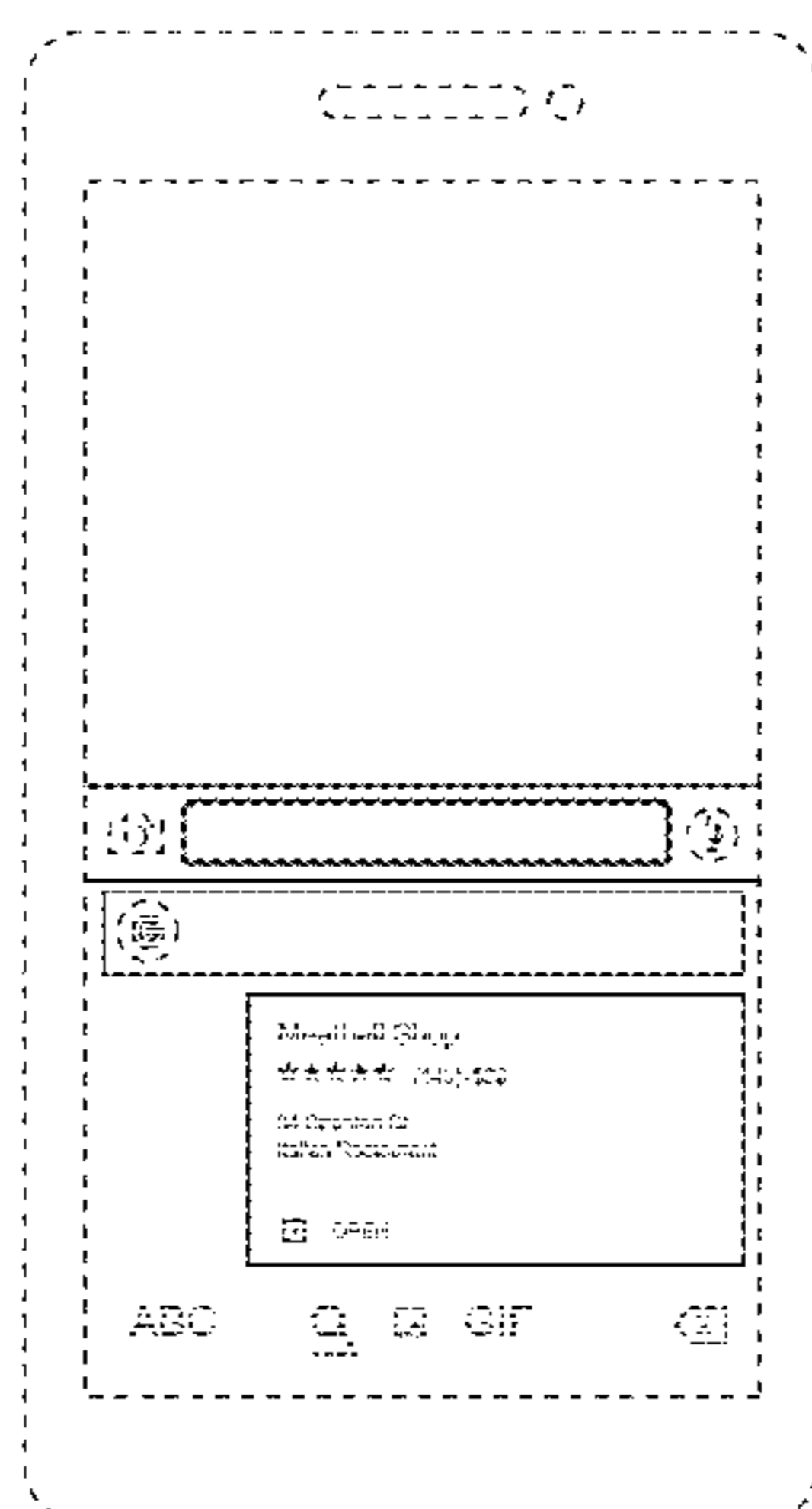
FIG. 6 is a sixth image thereof; and,

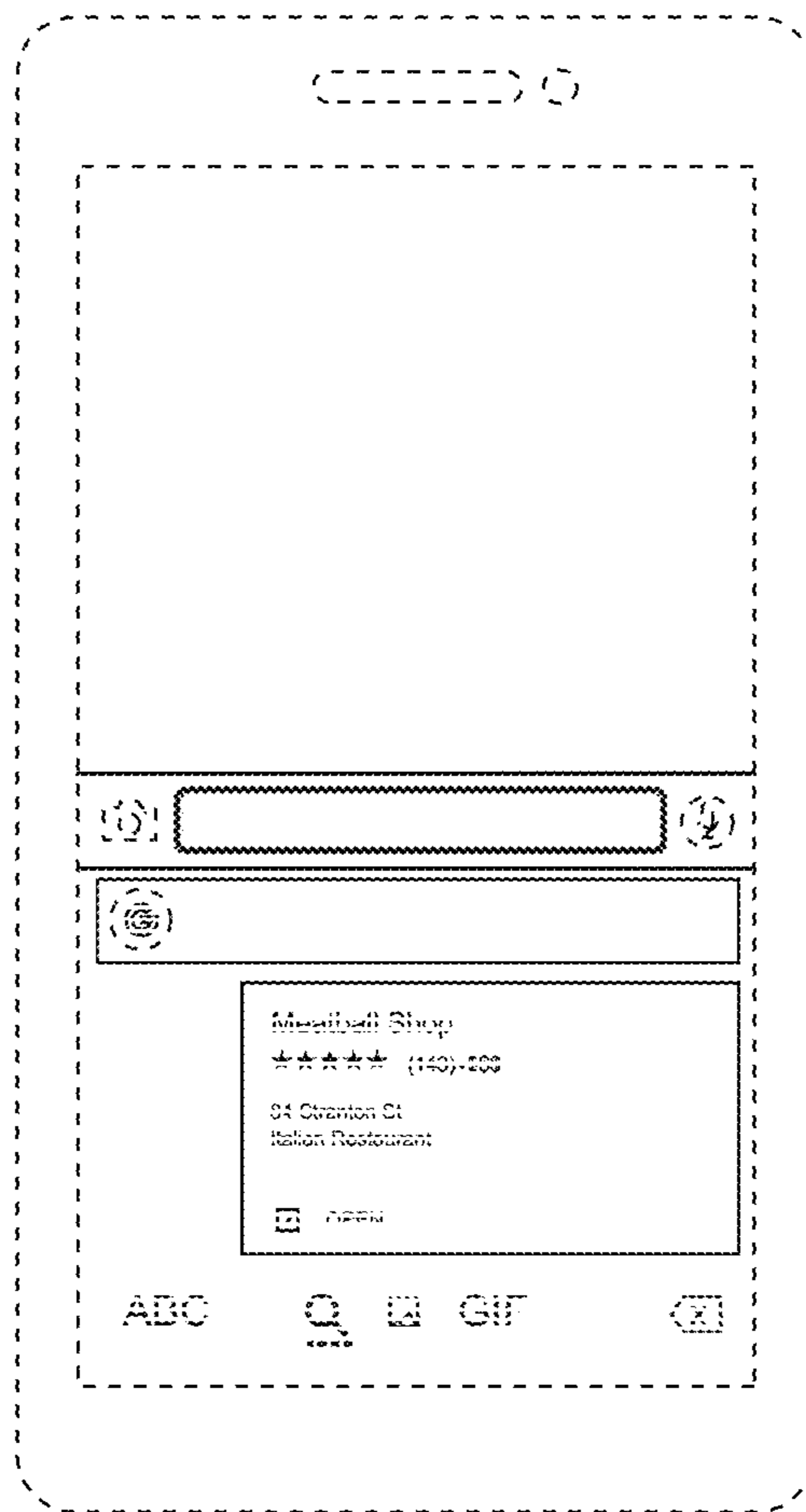

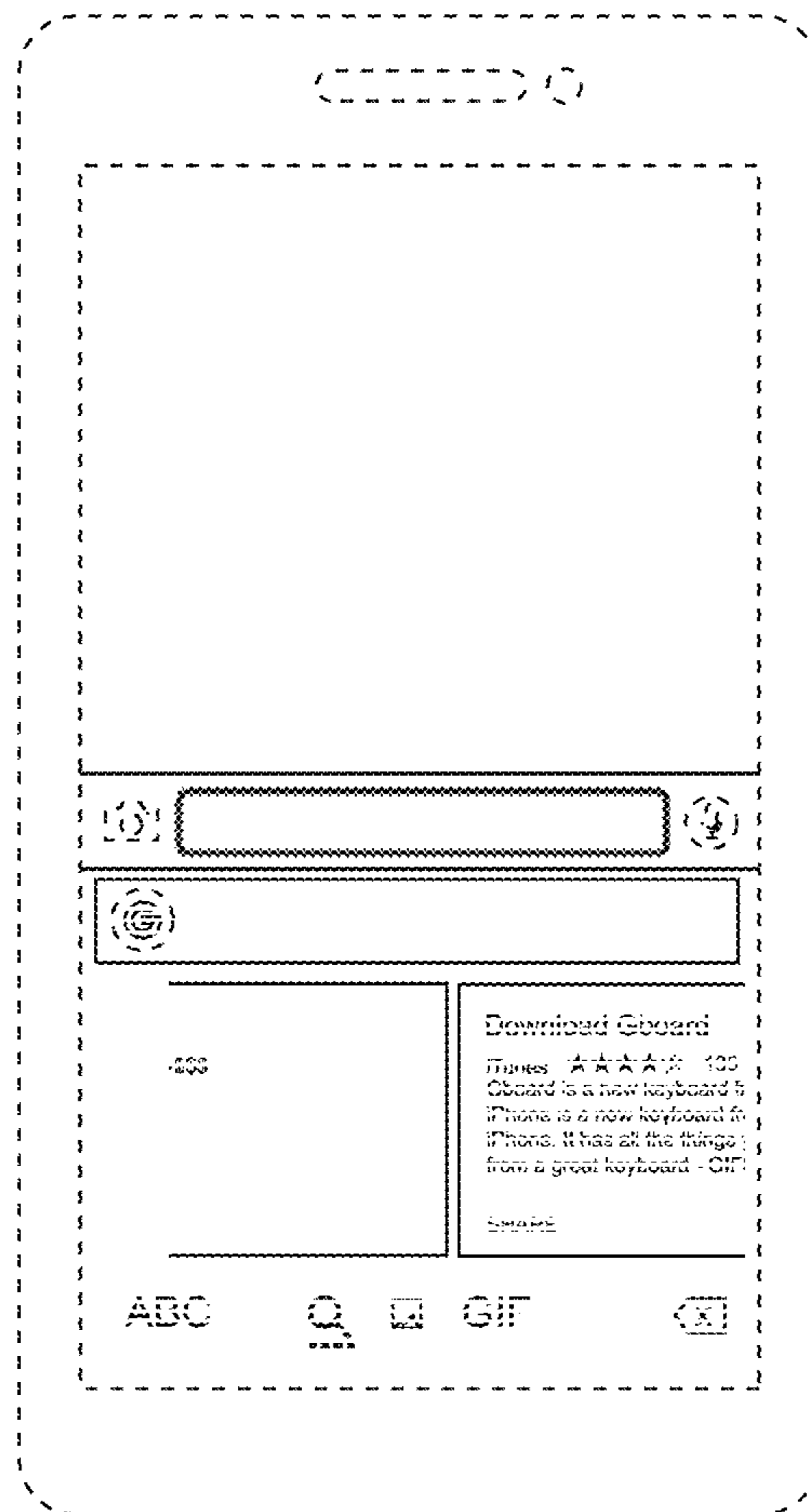

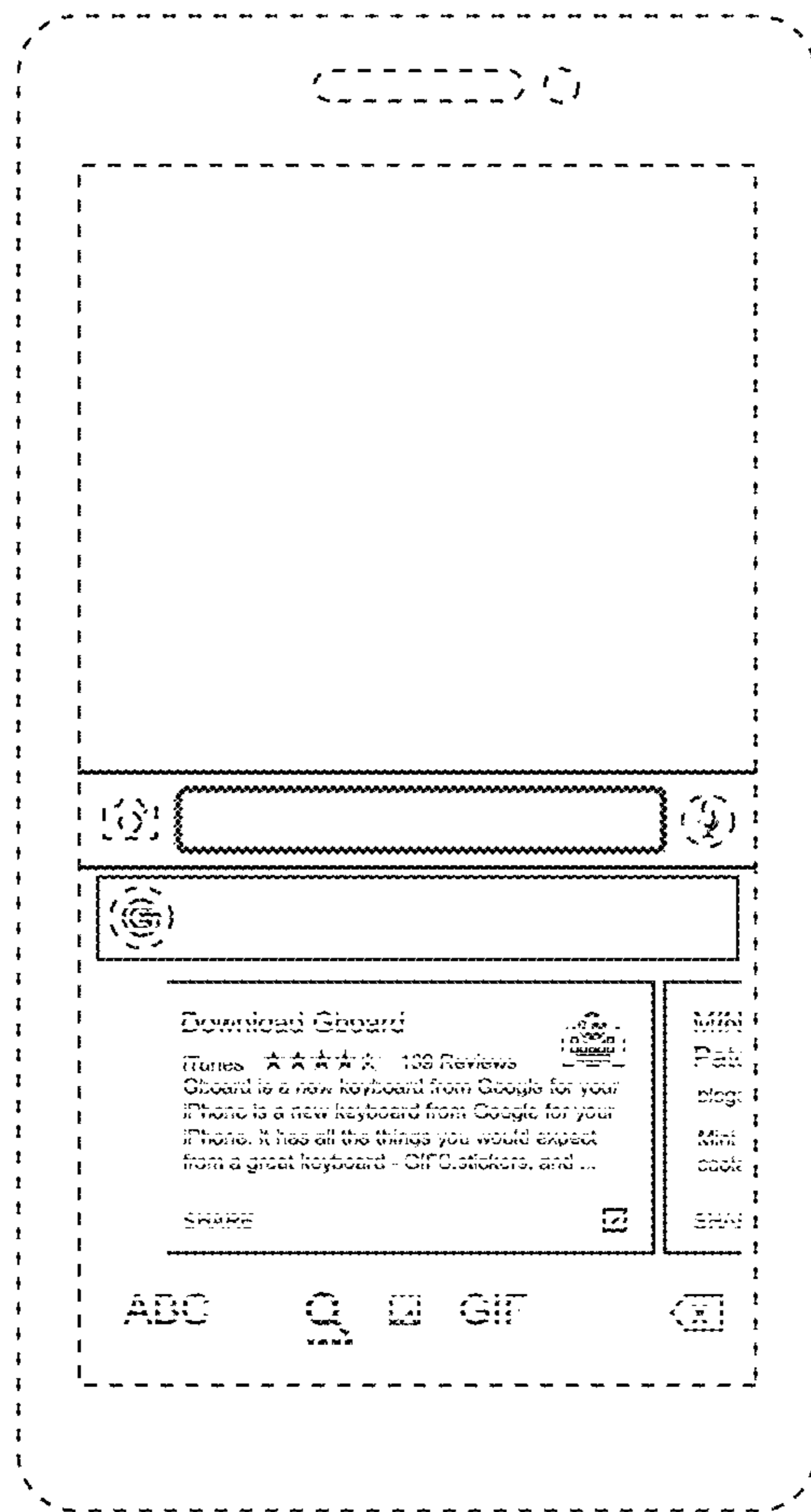

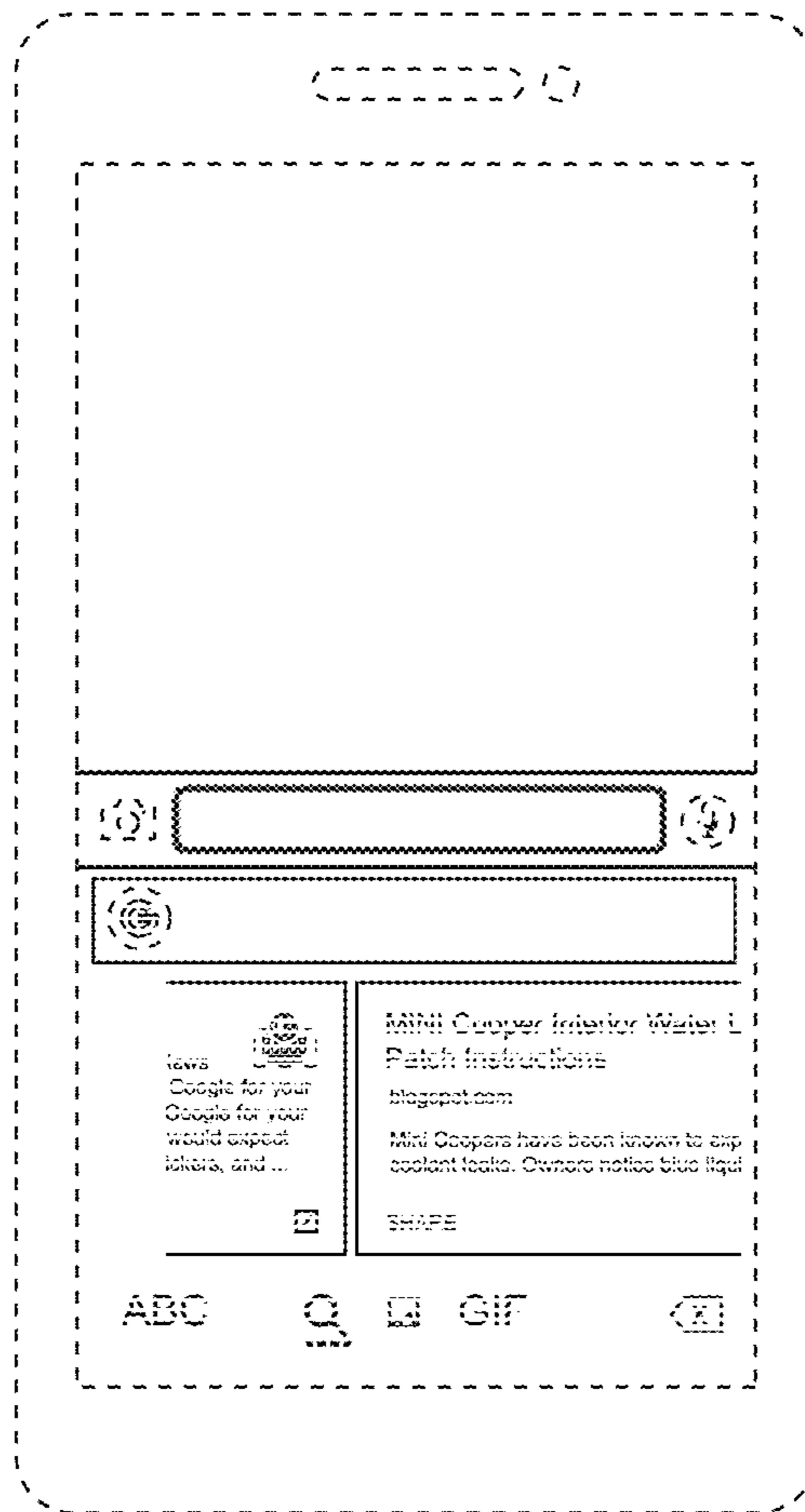

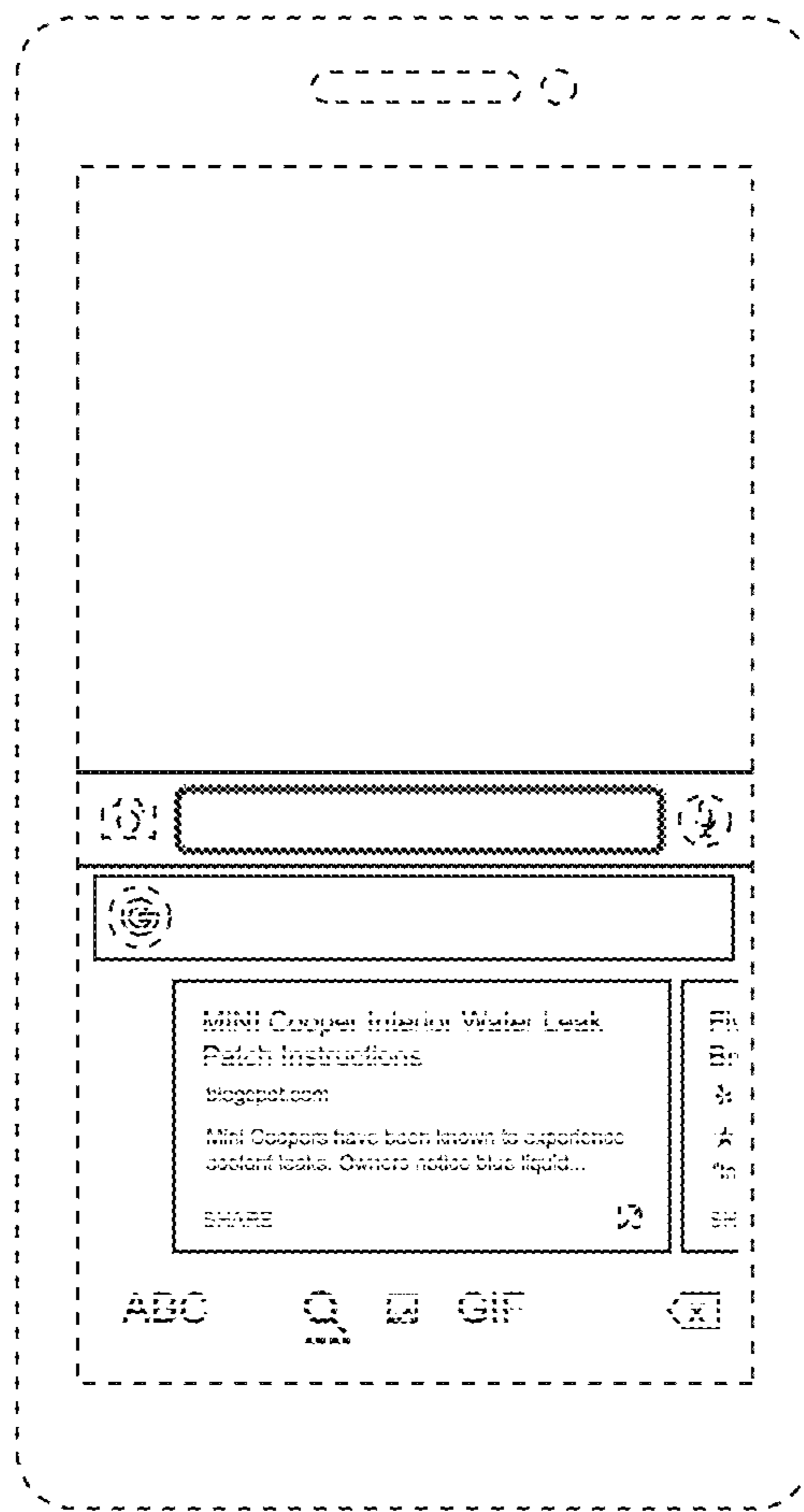

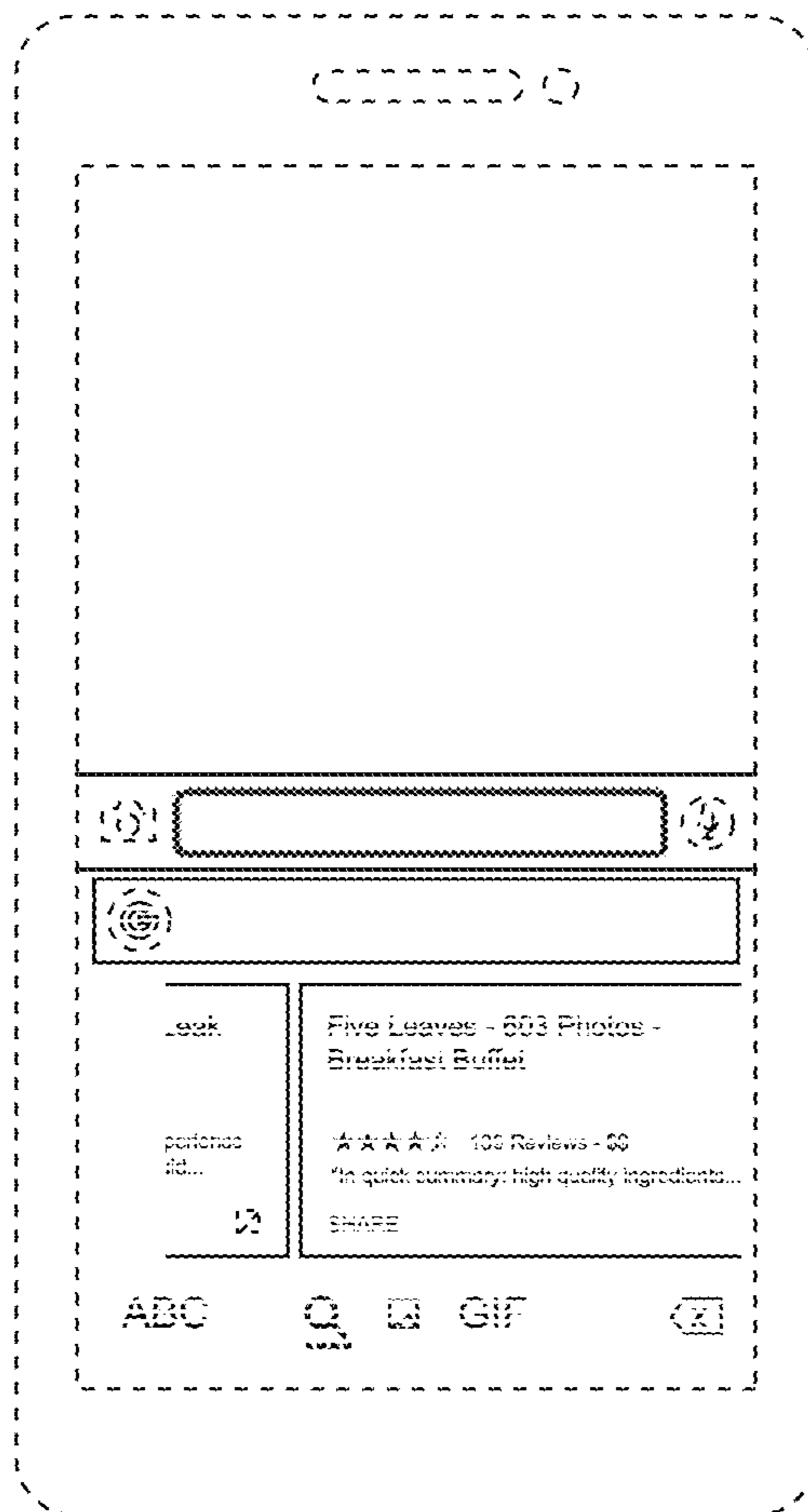

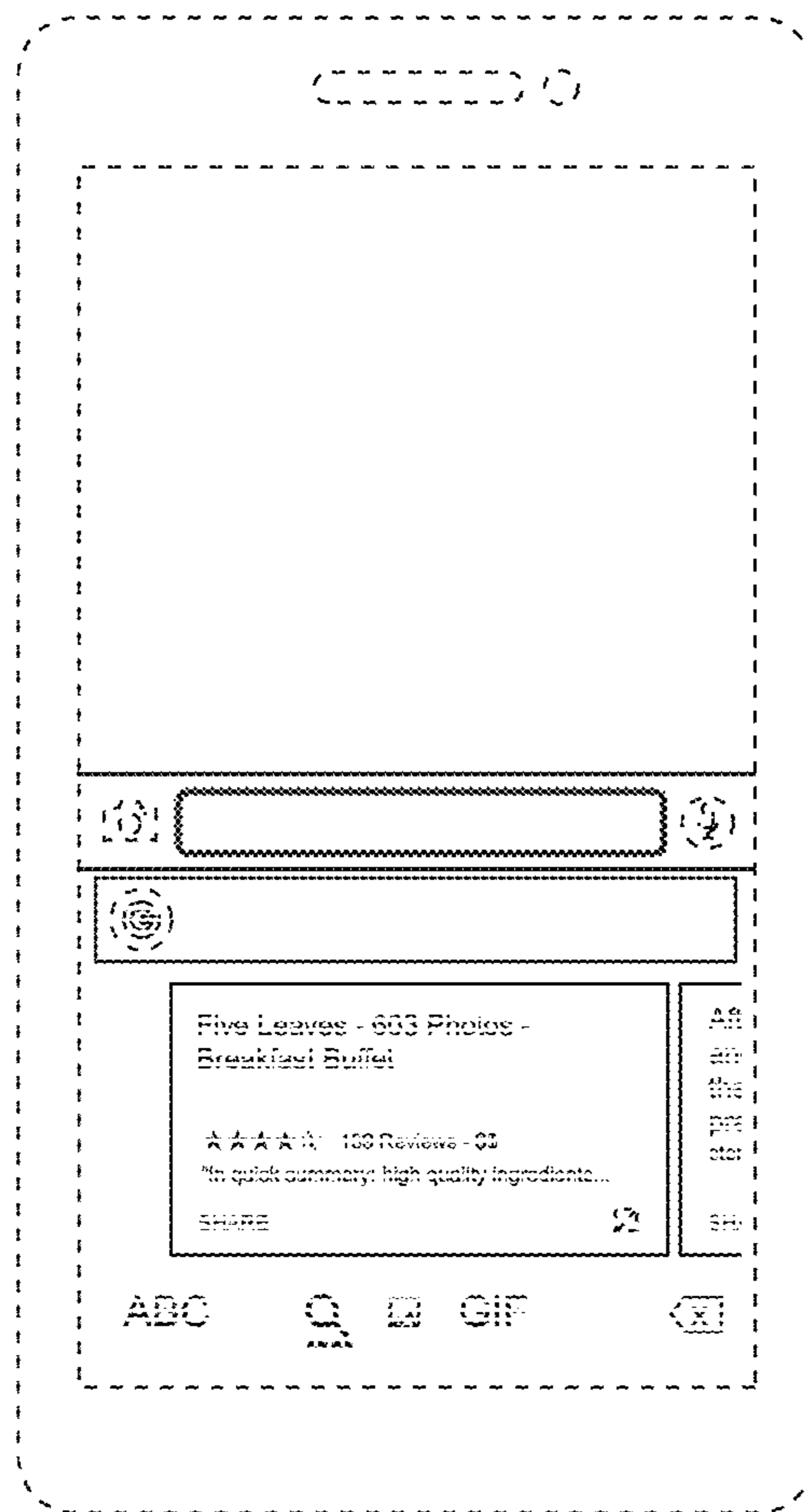
