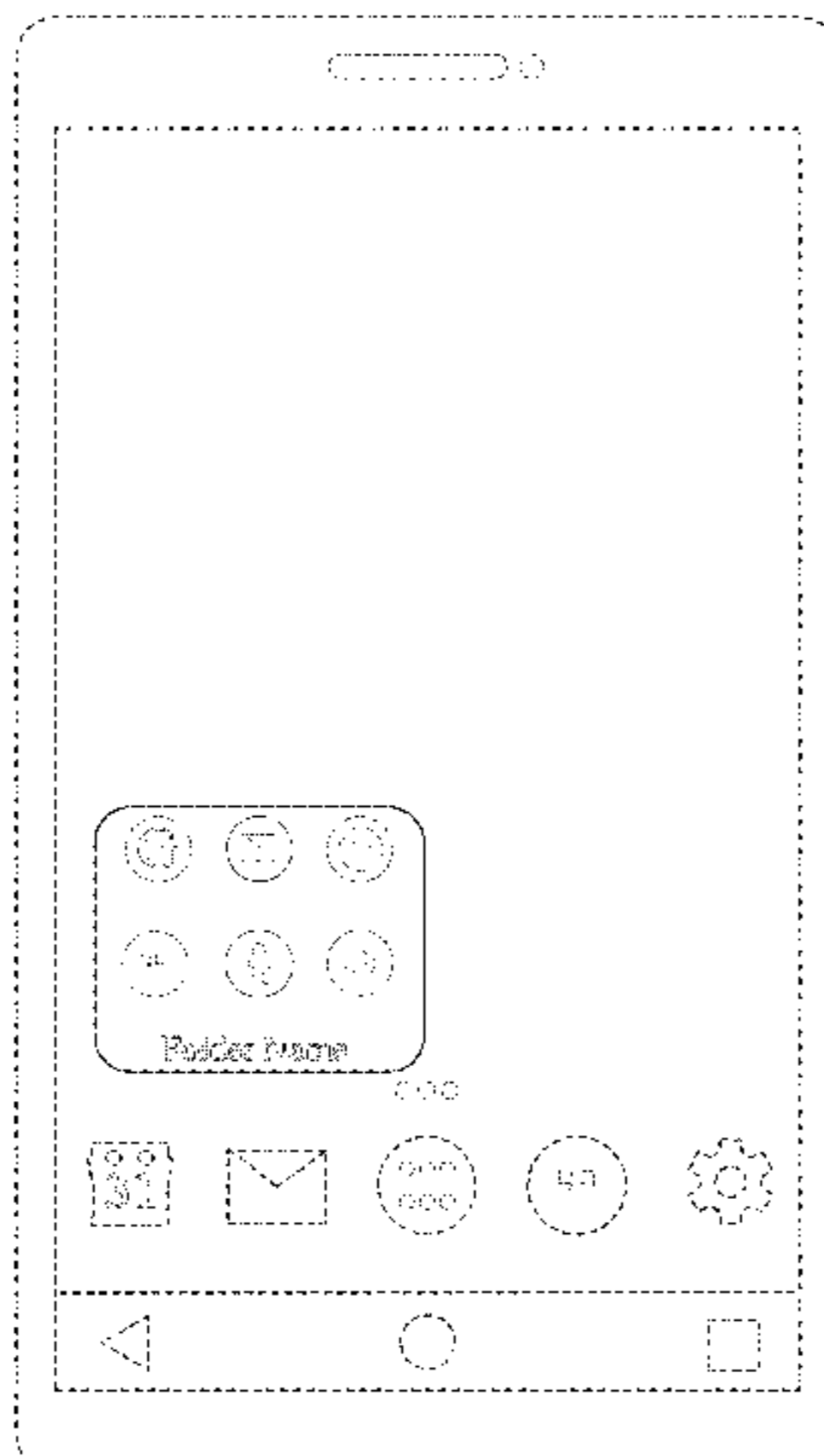
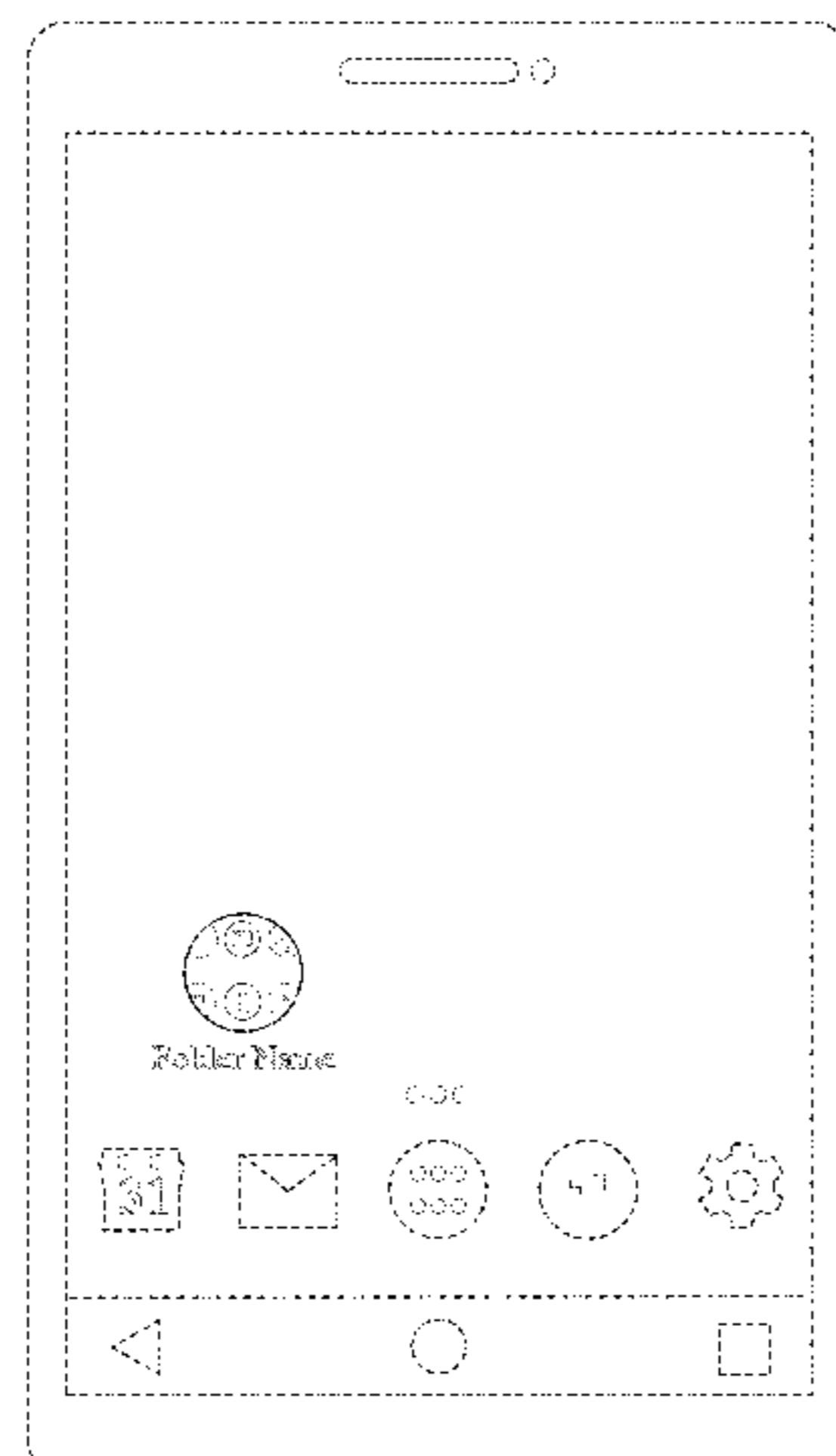
The ornamental design for a display screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a first image in a sequence of a display screen with an animated graphical user interface, showing our design; FIG. 2 is a second image thereof; FIG. 3 is a third image thereof; FIG. 4 is a fourth image thereof; FIG. 5 is a fifth image thereof; FIG. 6 is a sixth image thereof; FIG. 7 is a seventh image thereof; FIG. 8 is an eight image thereof; and, FIG. 9 is a ninth image thereof.

The appearance of the image transitions sequentially between the images shown in the sequence of FIGS. 1 through 9. The process or period in which one image transitions to another forms no part of the claimed design. The outermost broken lines illustrate an electronic device, which is the environment of the design, and forms no part of the claim. The remaining broken lines, including all text and icons, illustrate the display screen and portions of the graphical user interface that form no part of the claimed design.

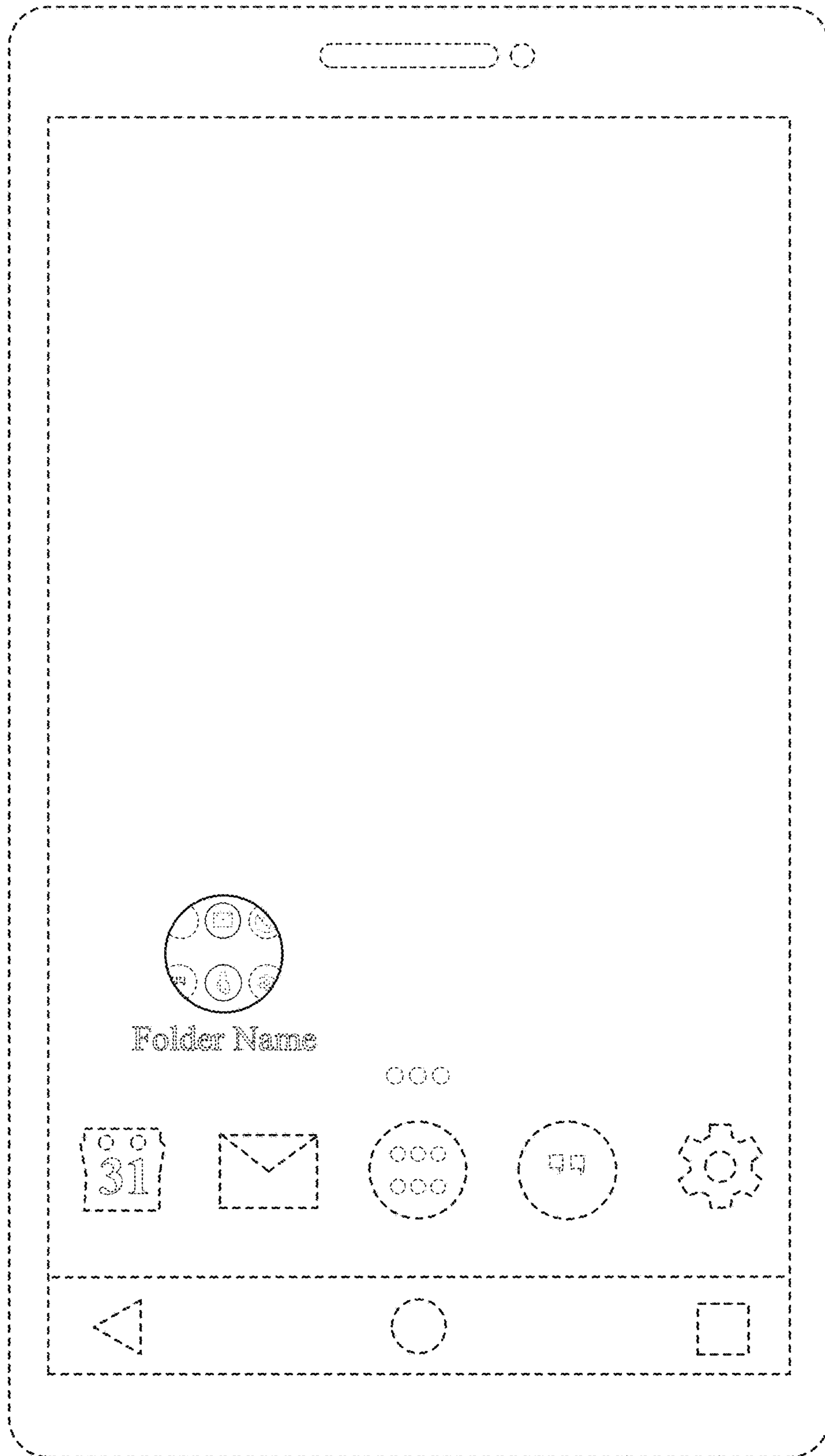

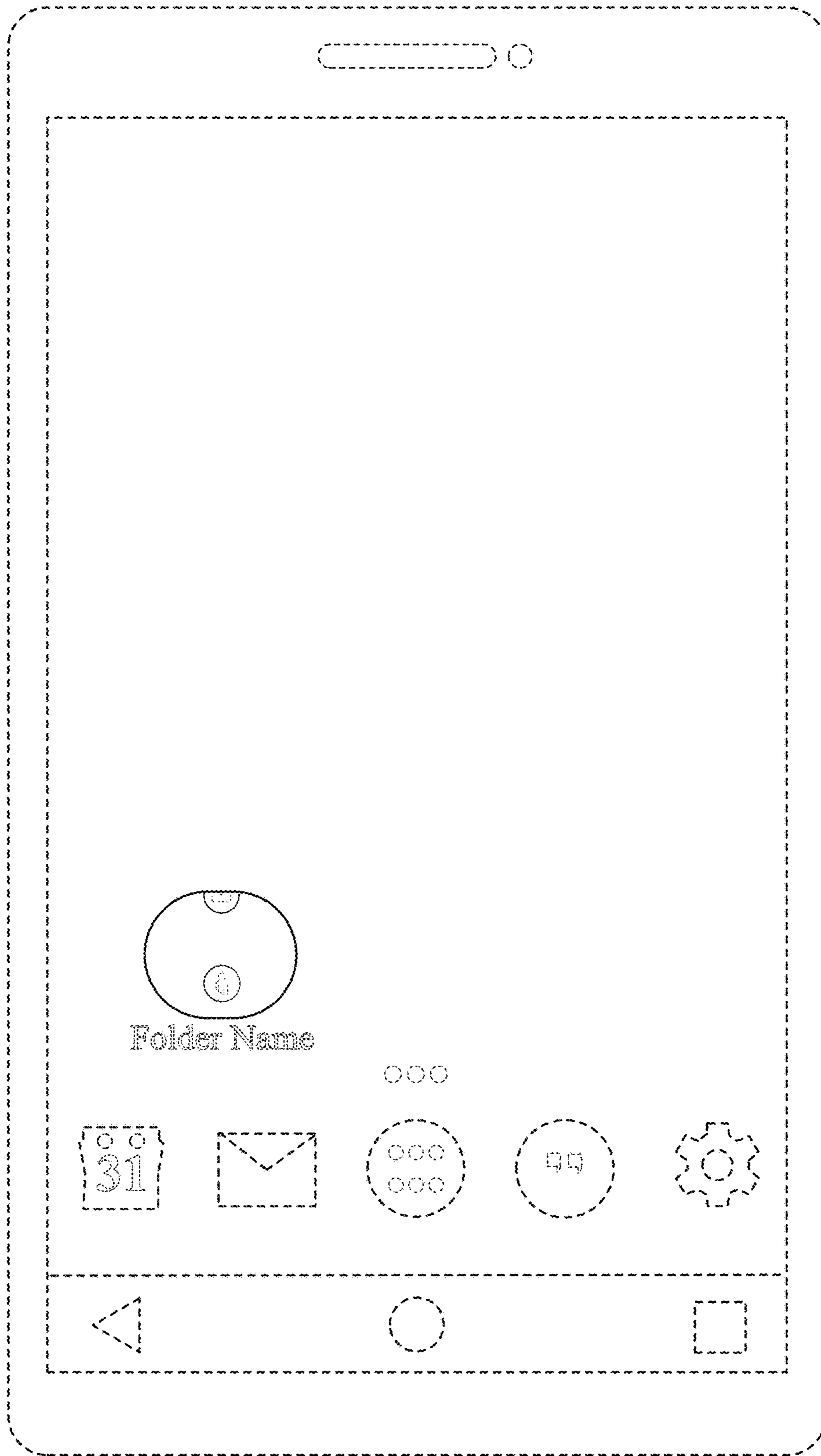

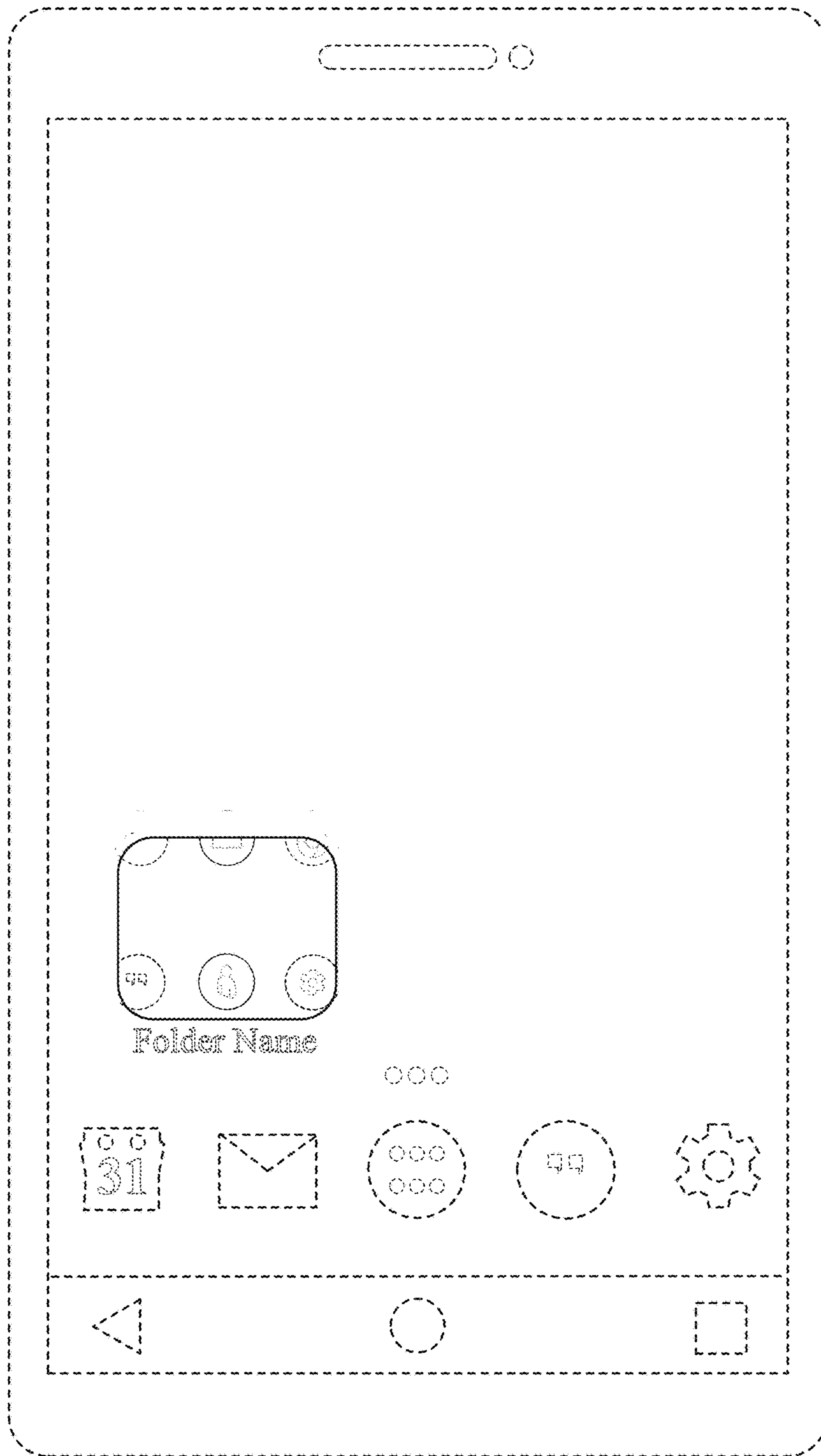

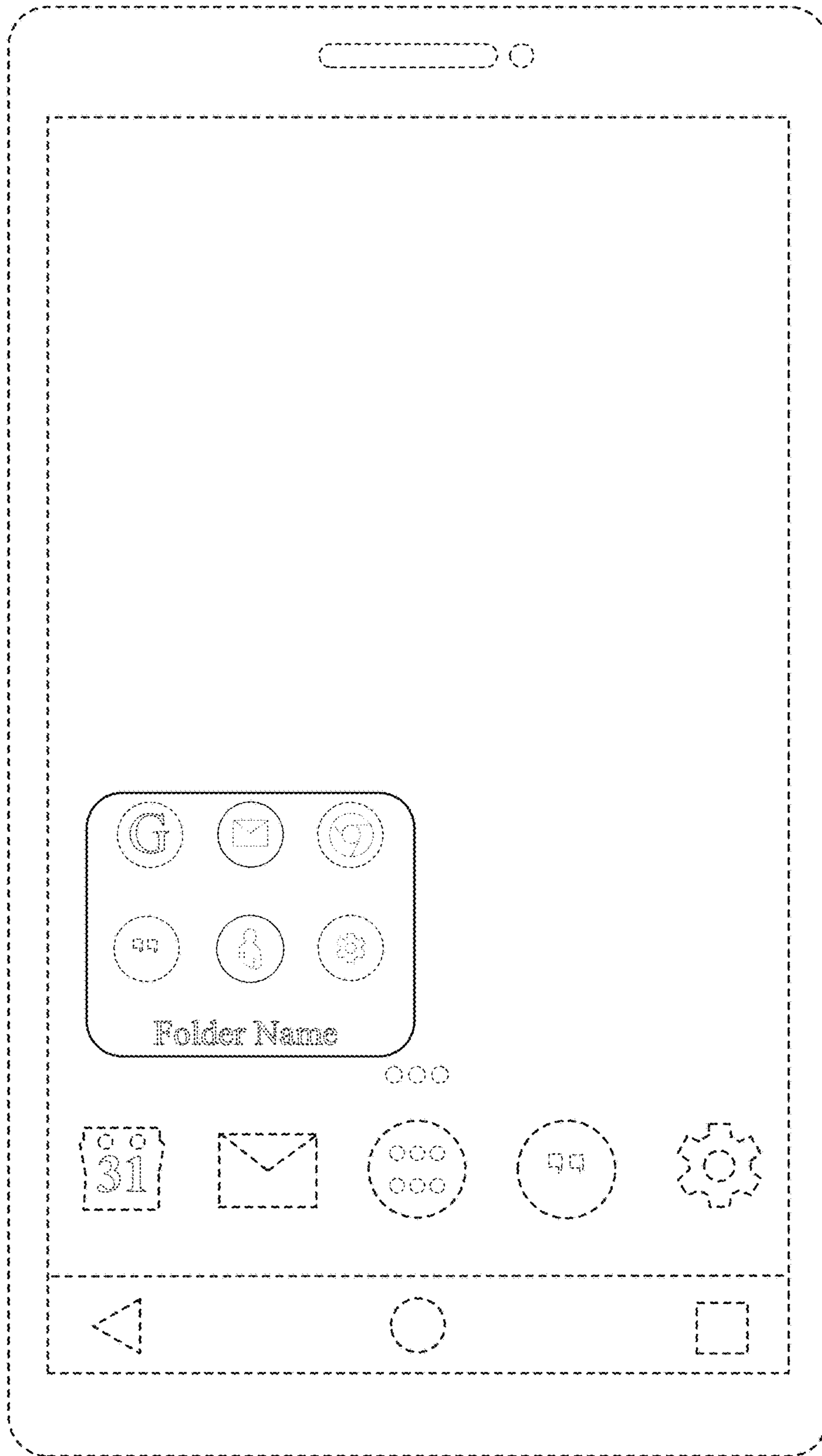

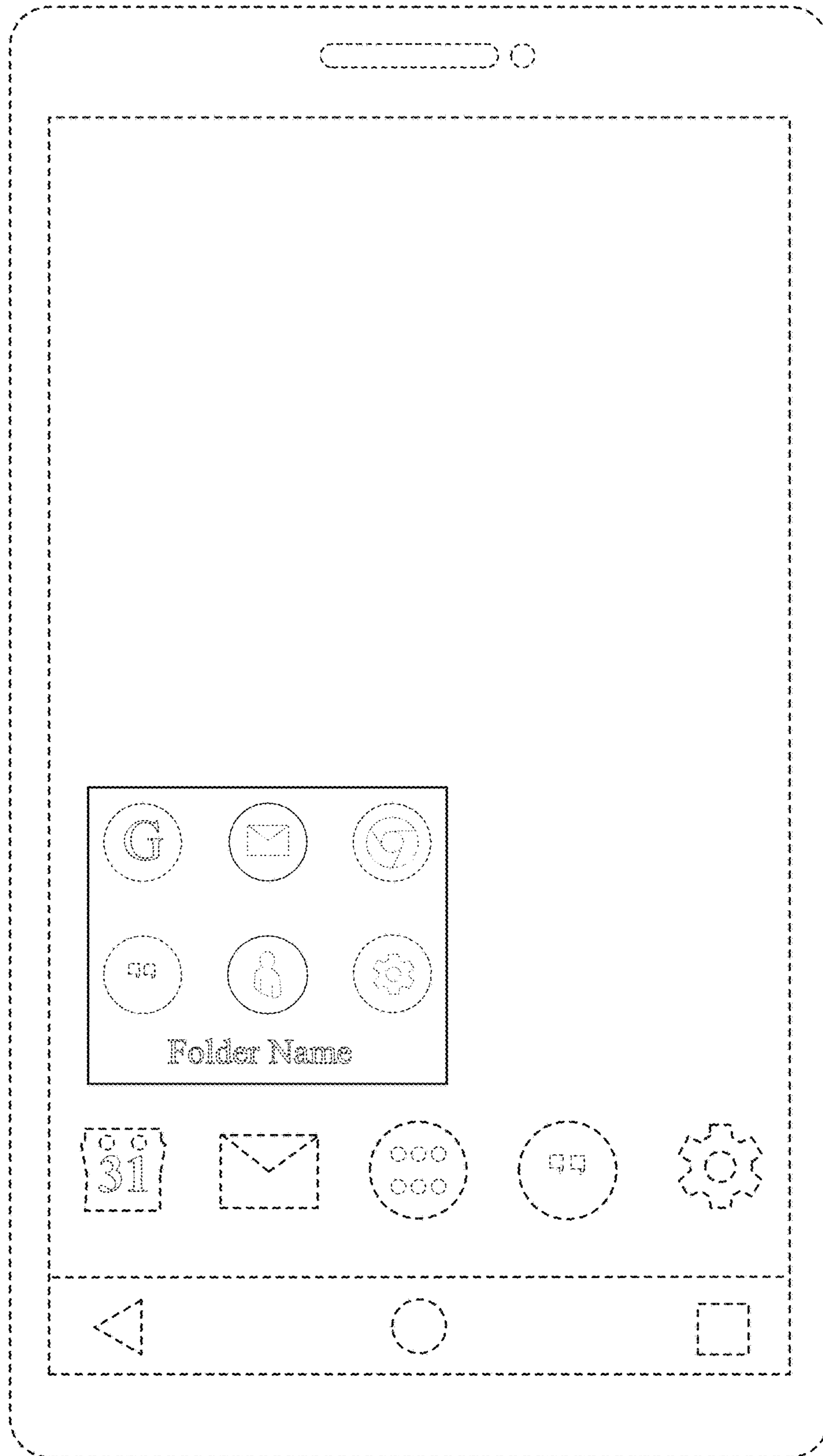

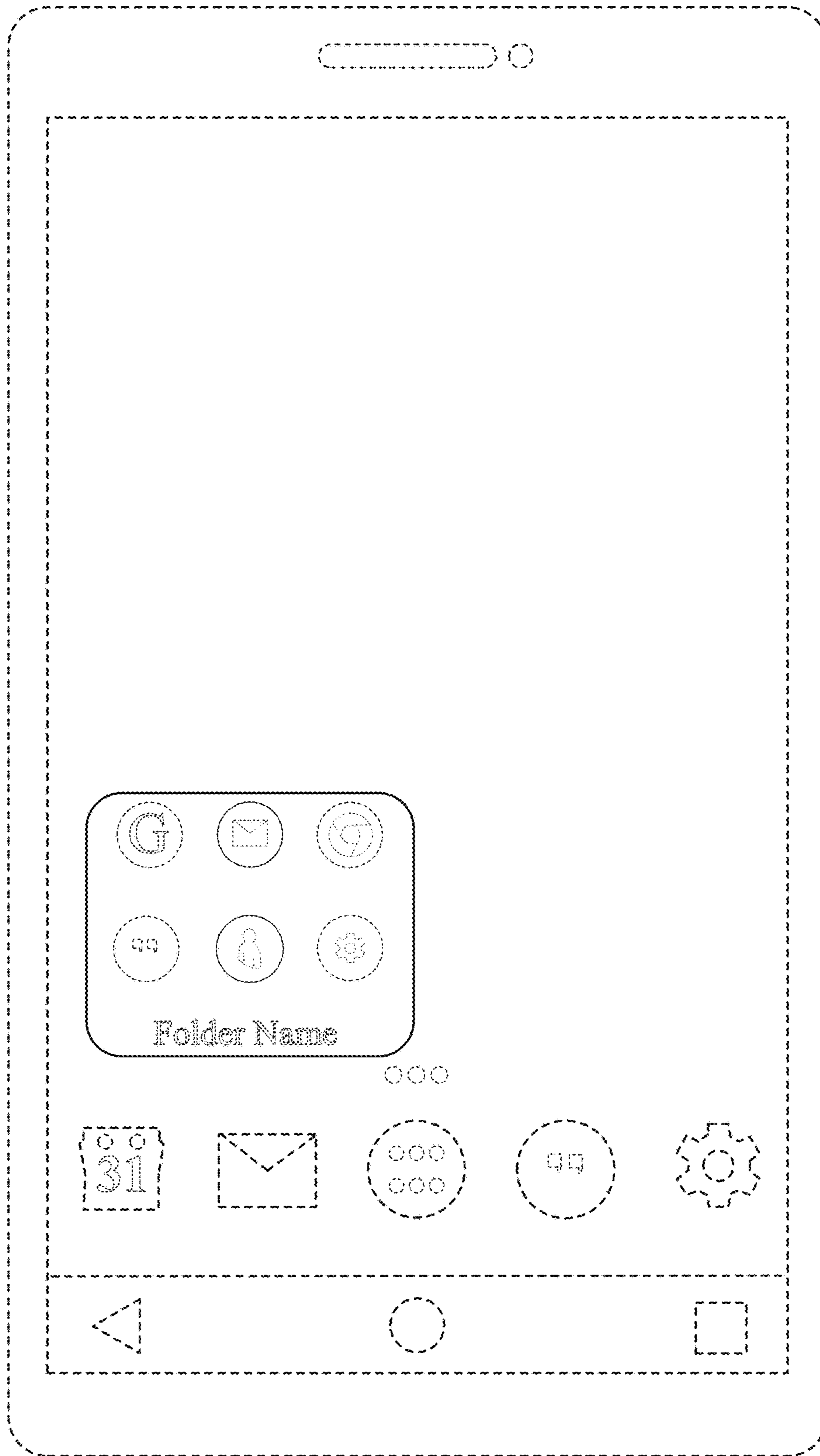

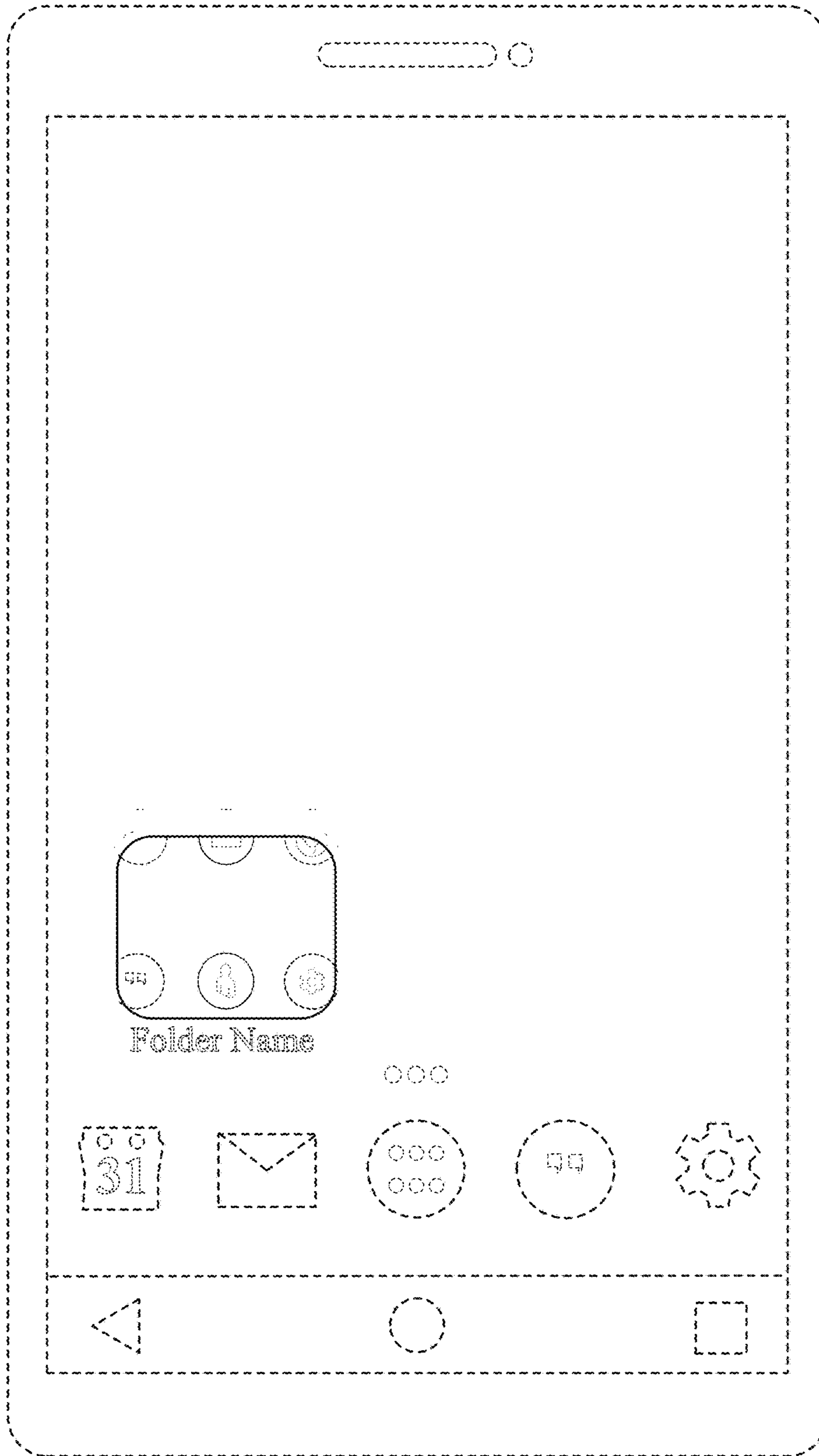

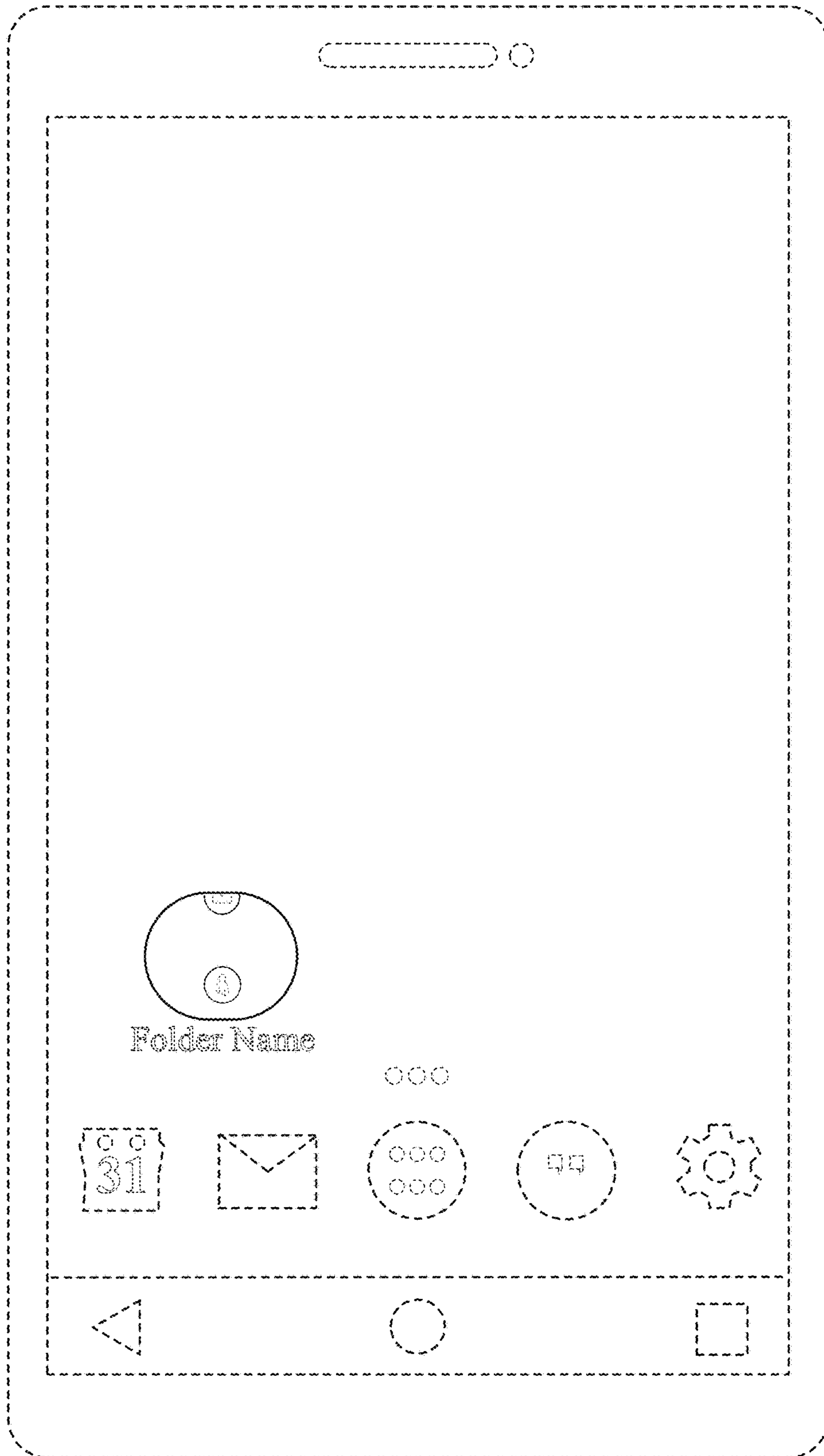

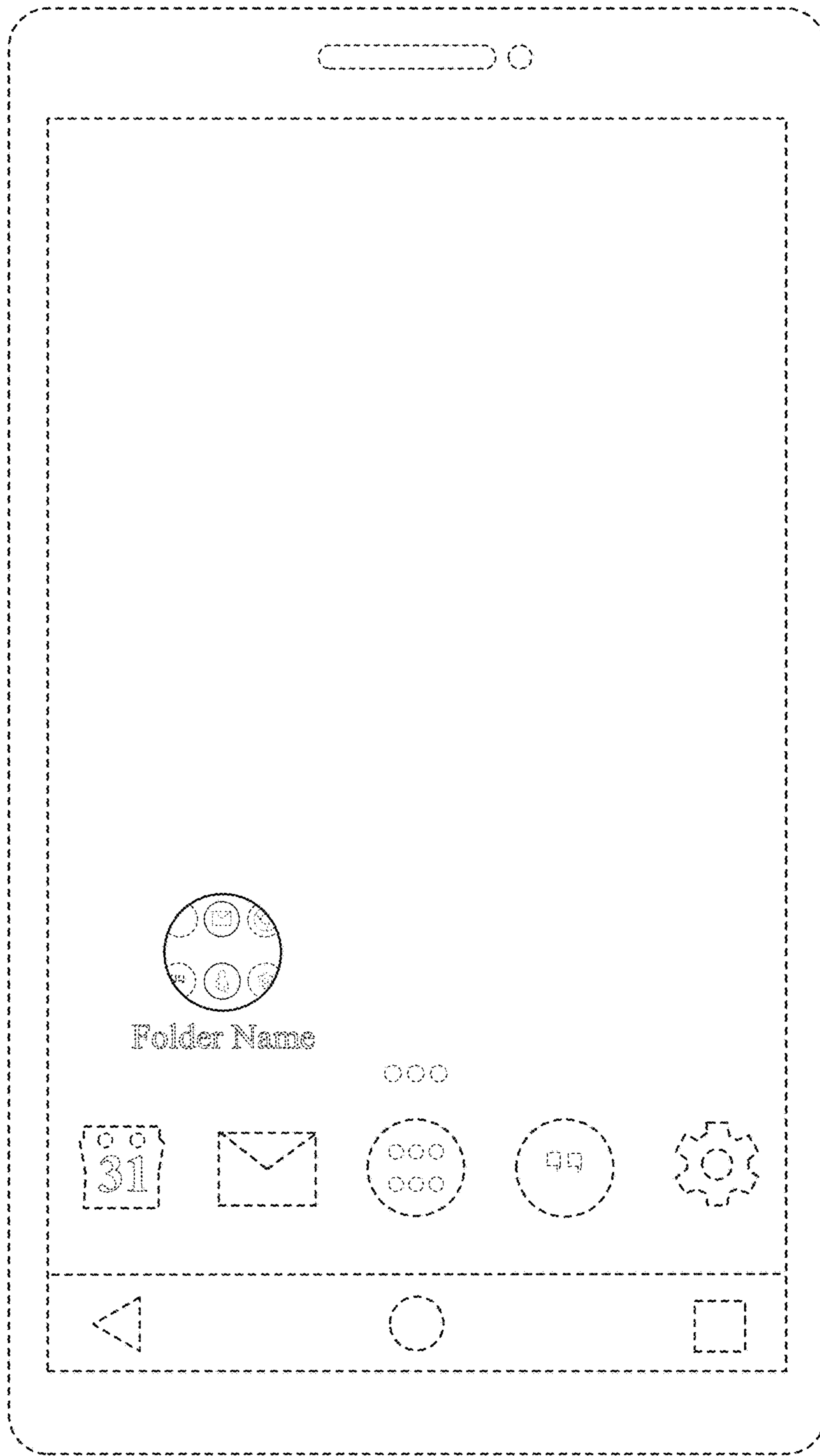
