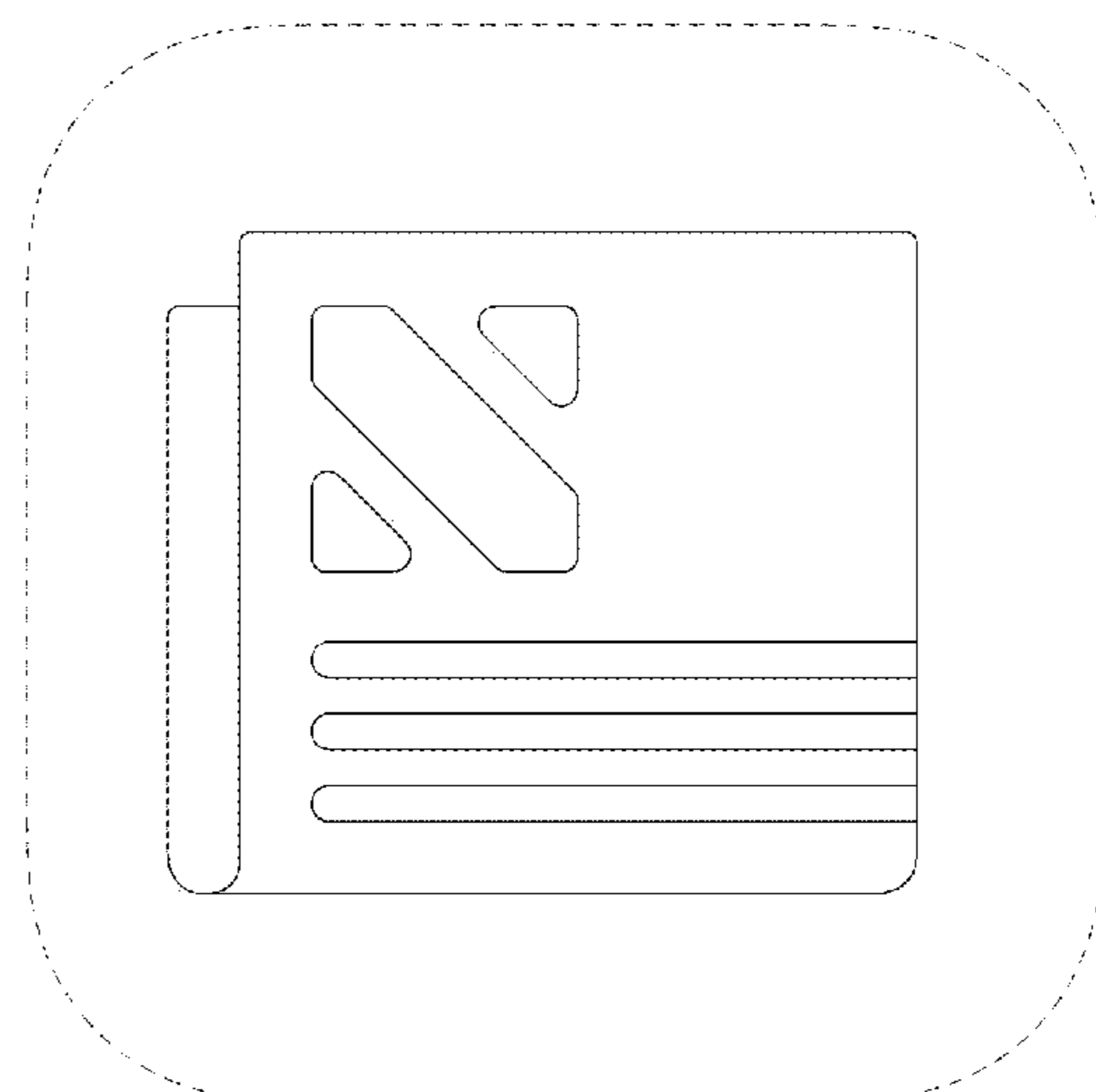
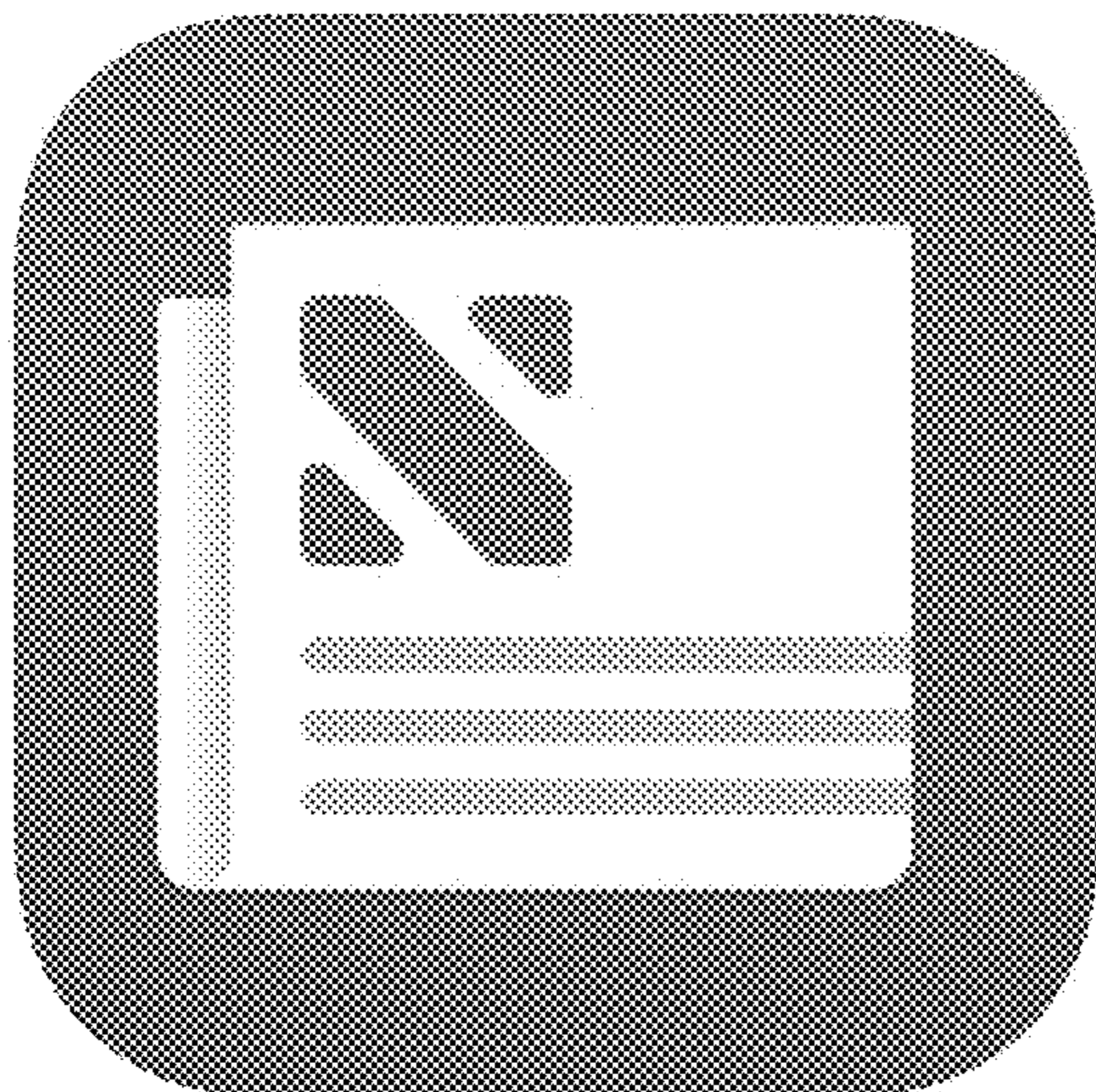
FIG. 1 shows a display screen or portion thereof with icon showing our new design;

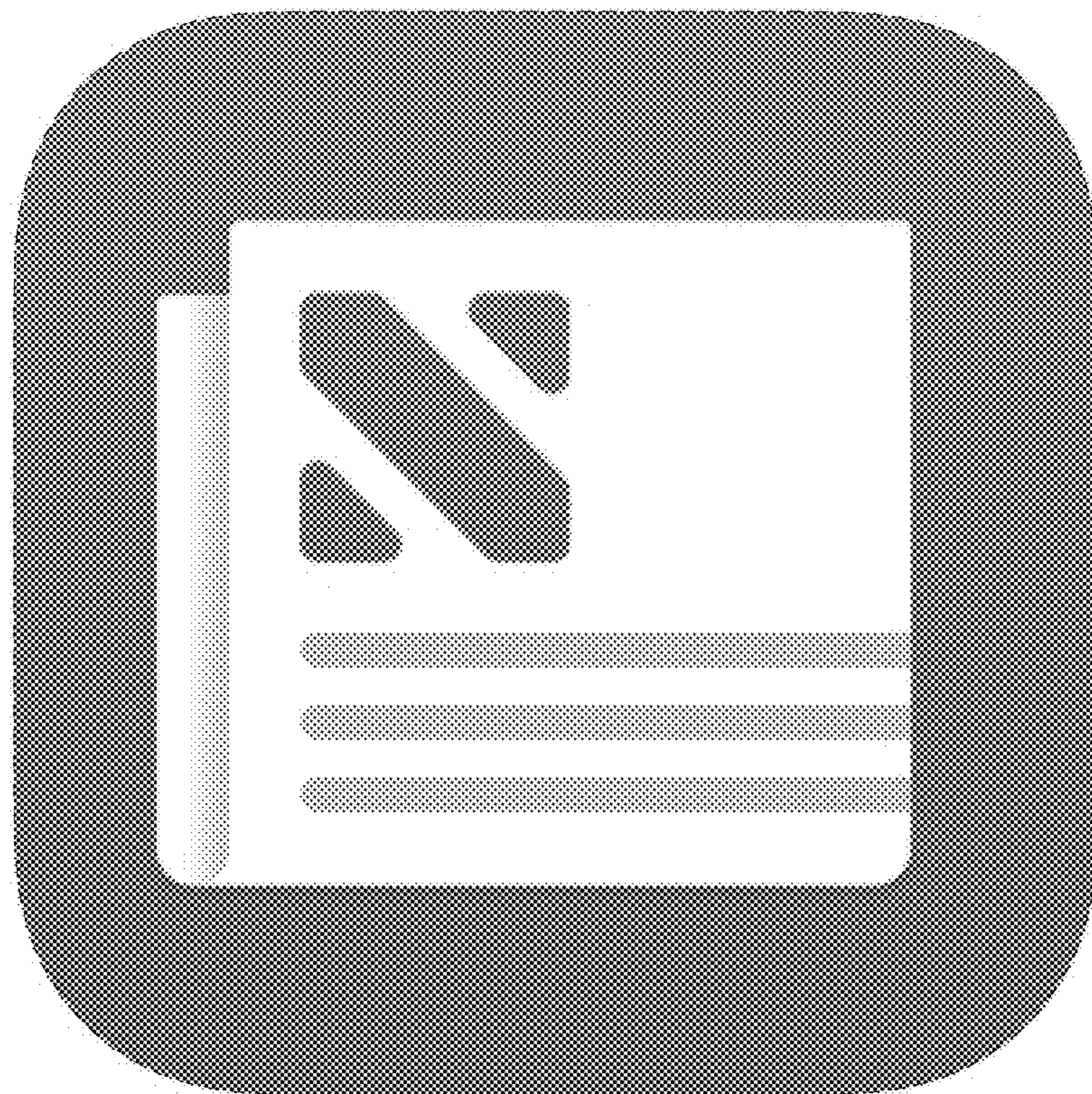

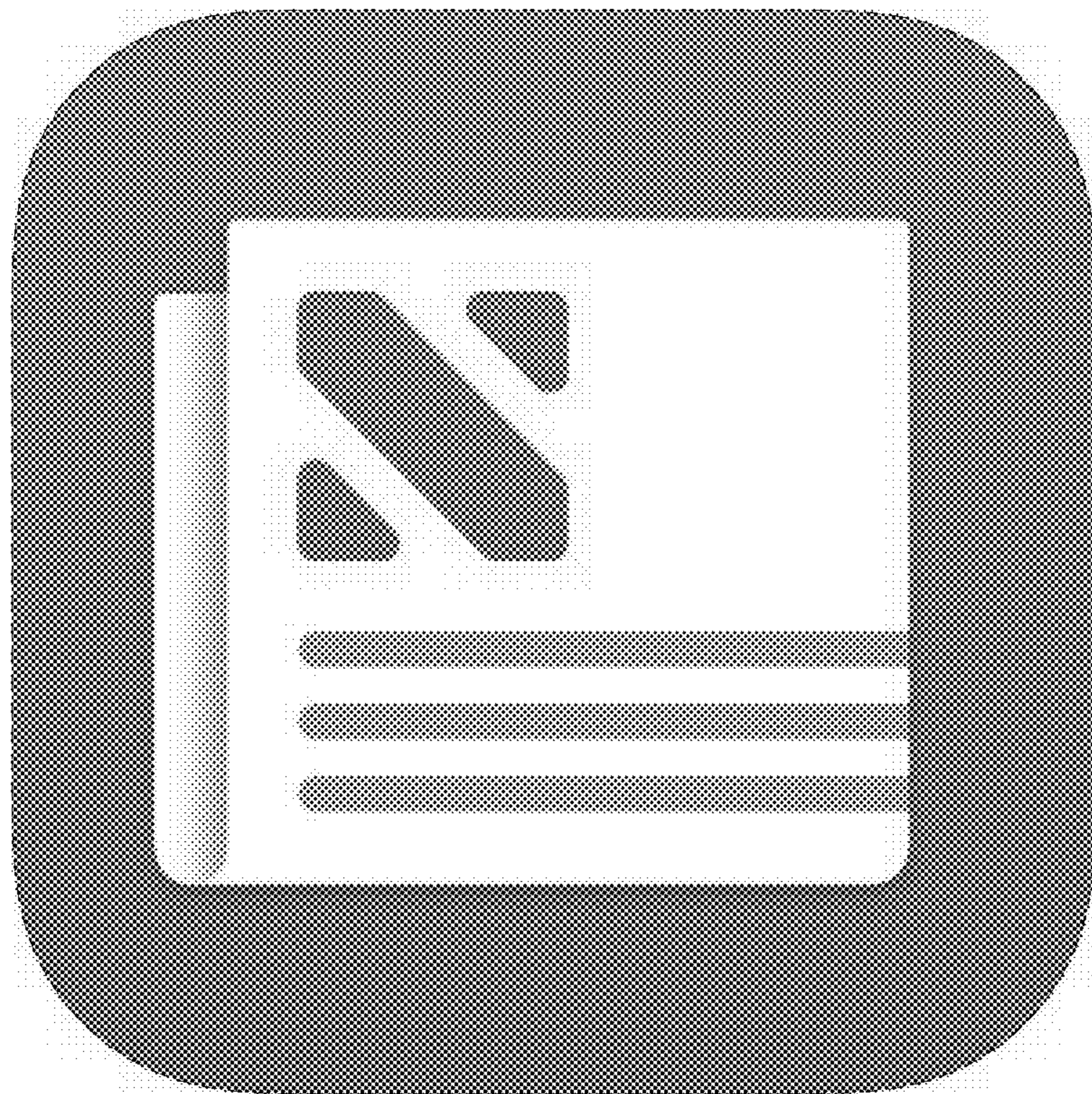

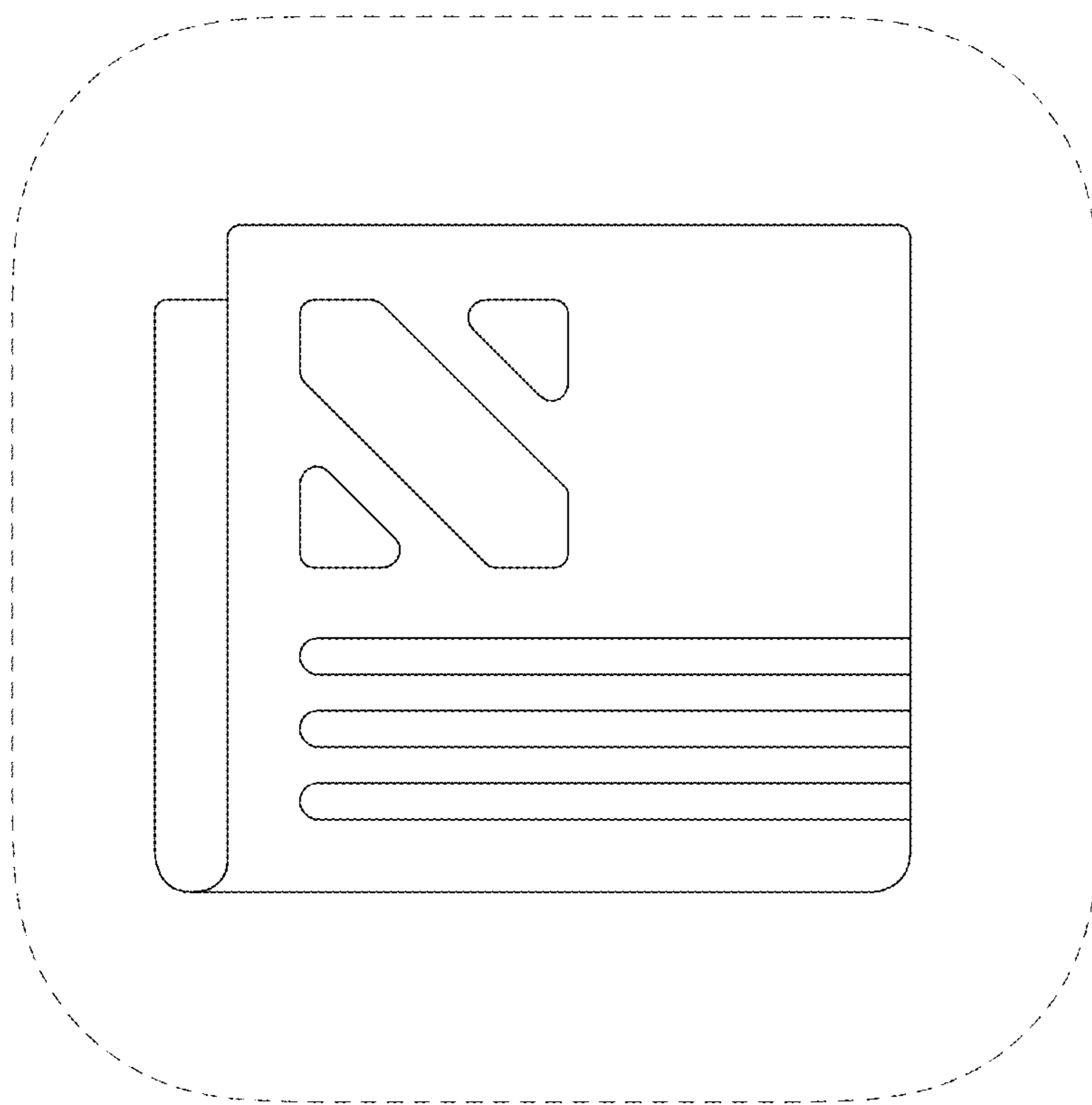
