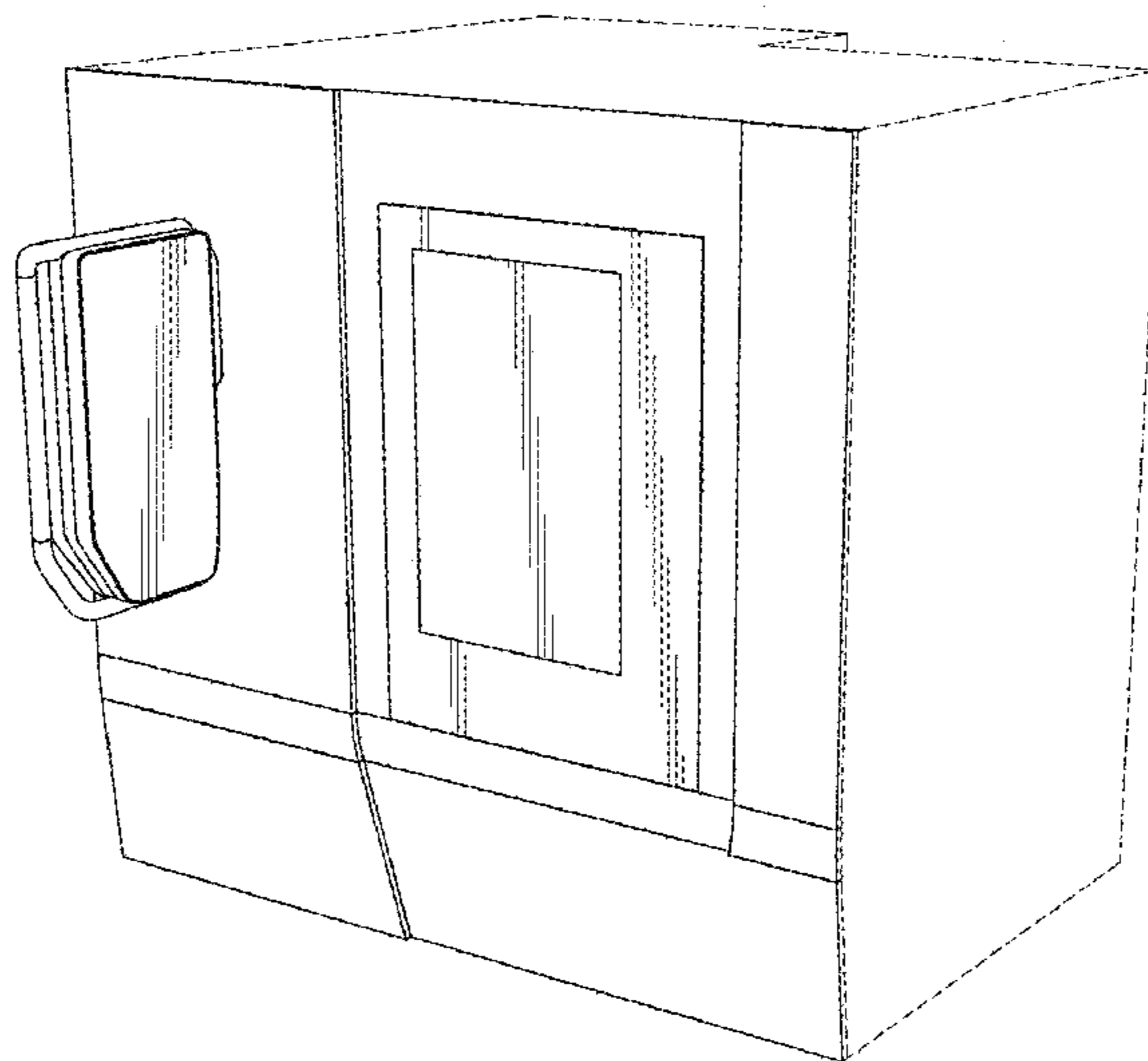
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevation view of a gear manufacturing machine;

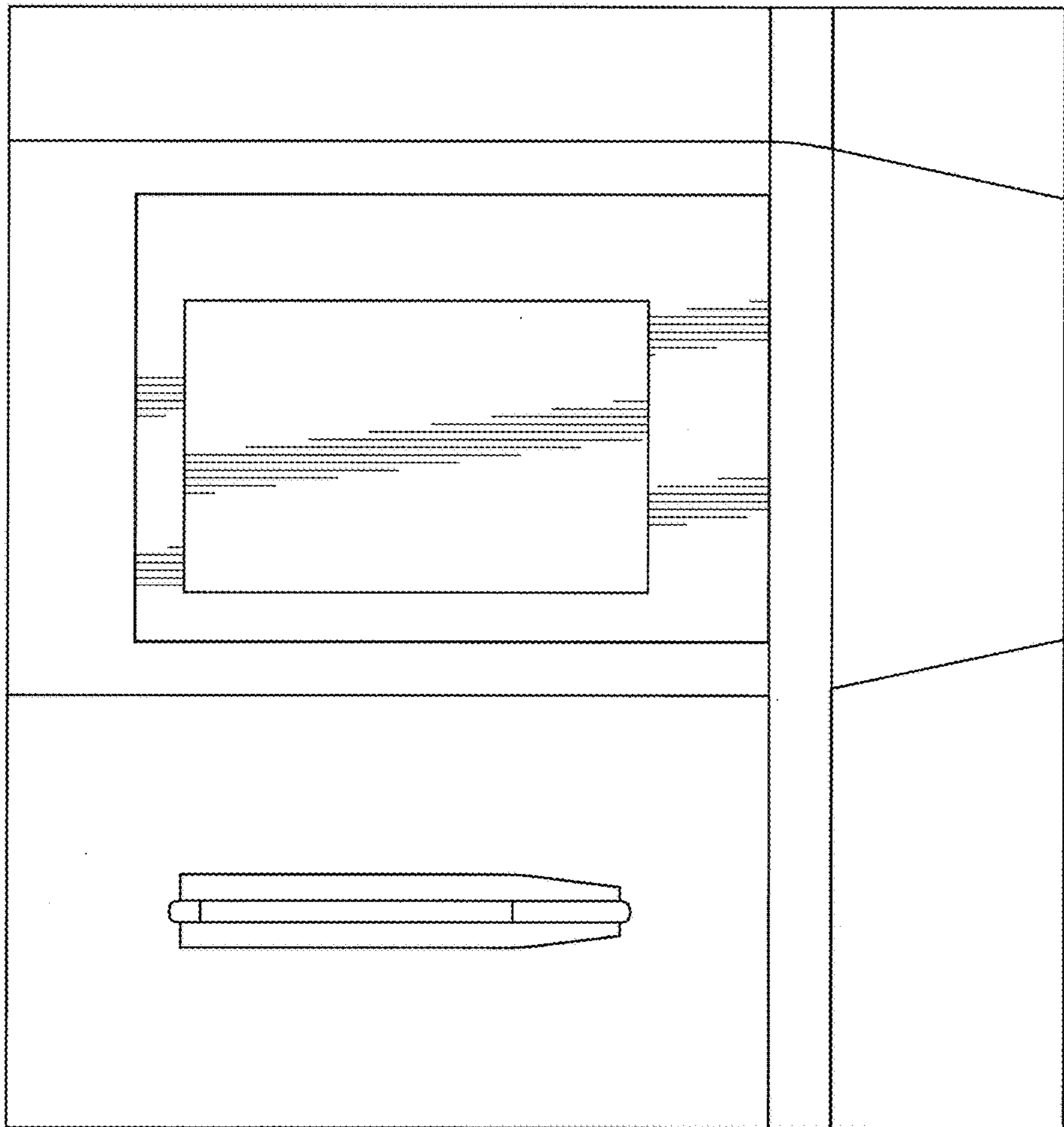

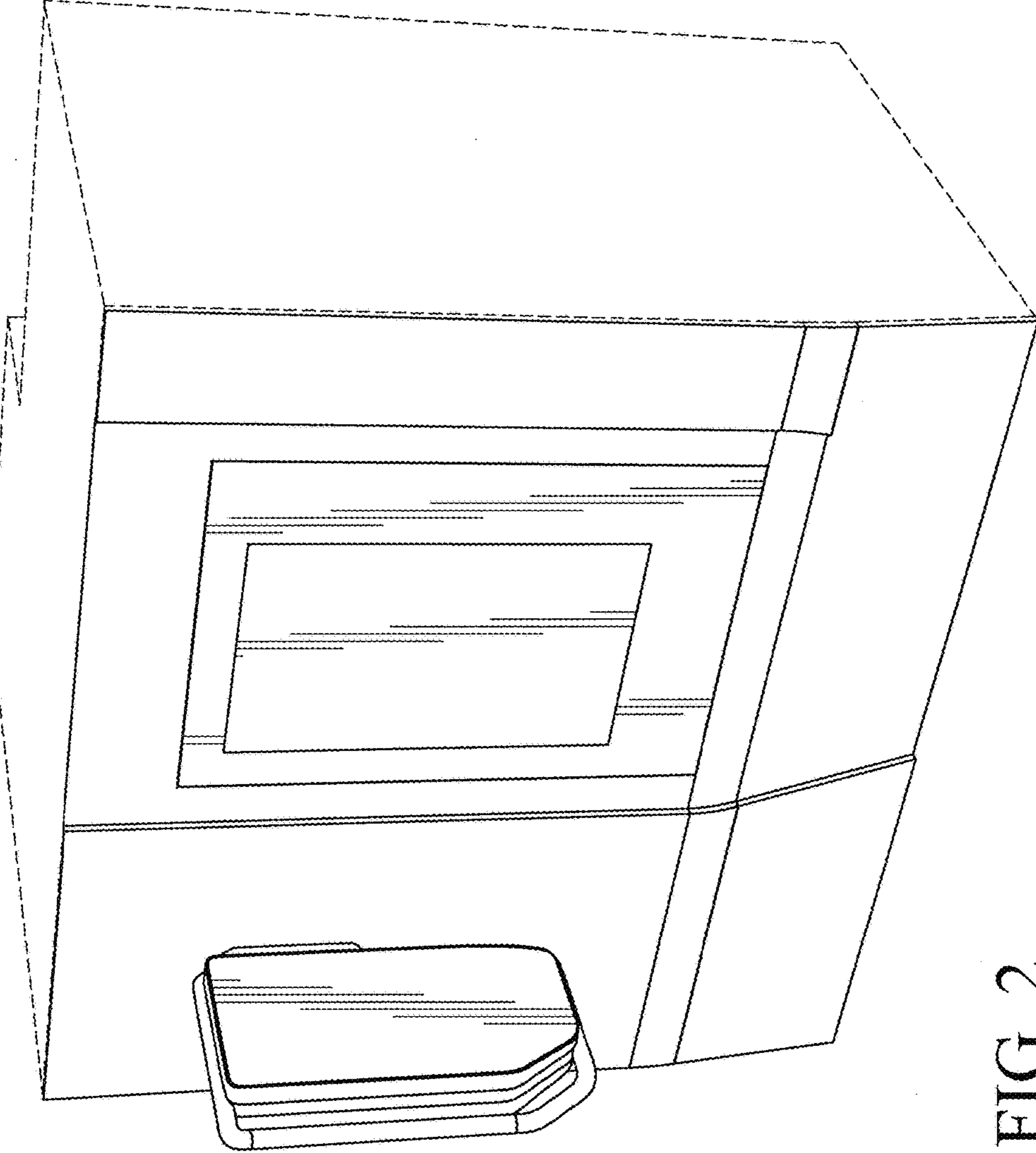

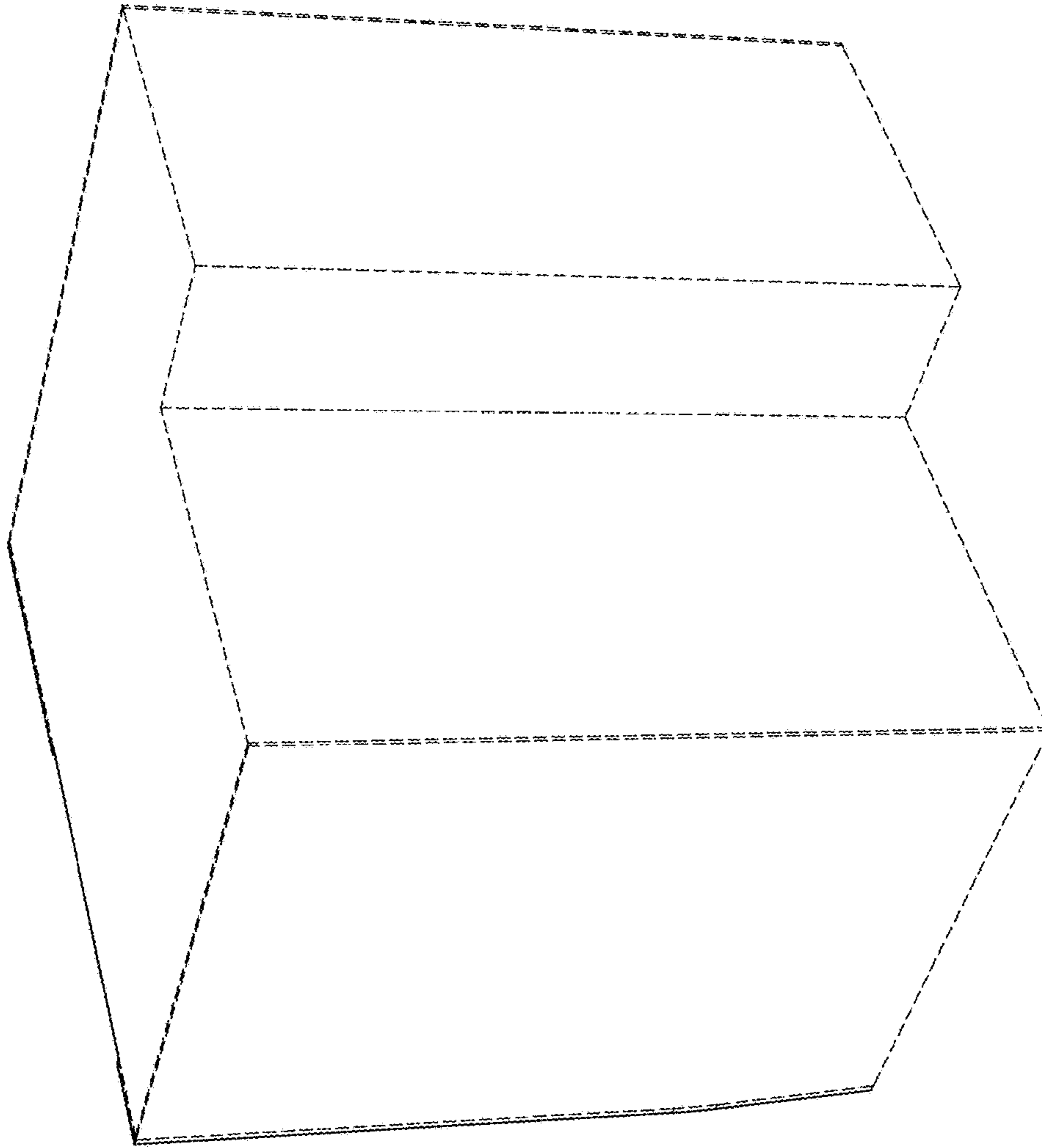

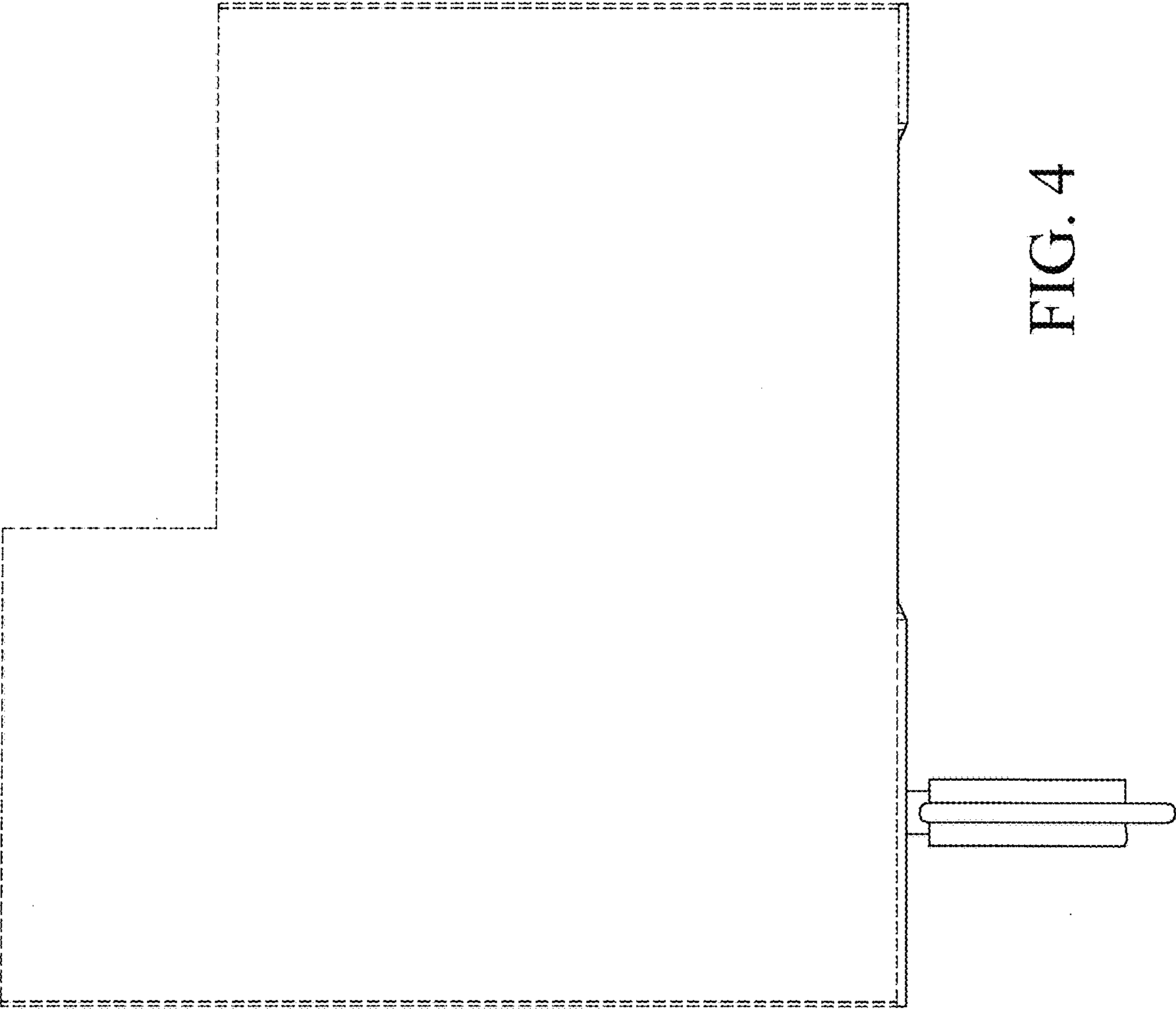
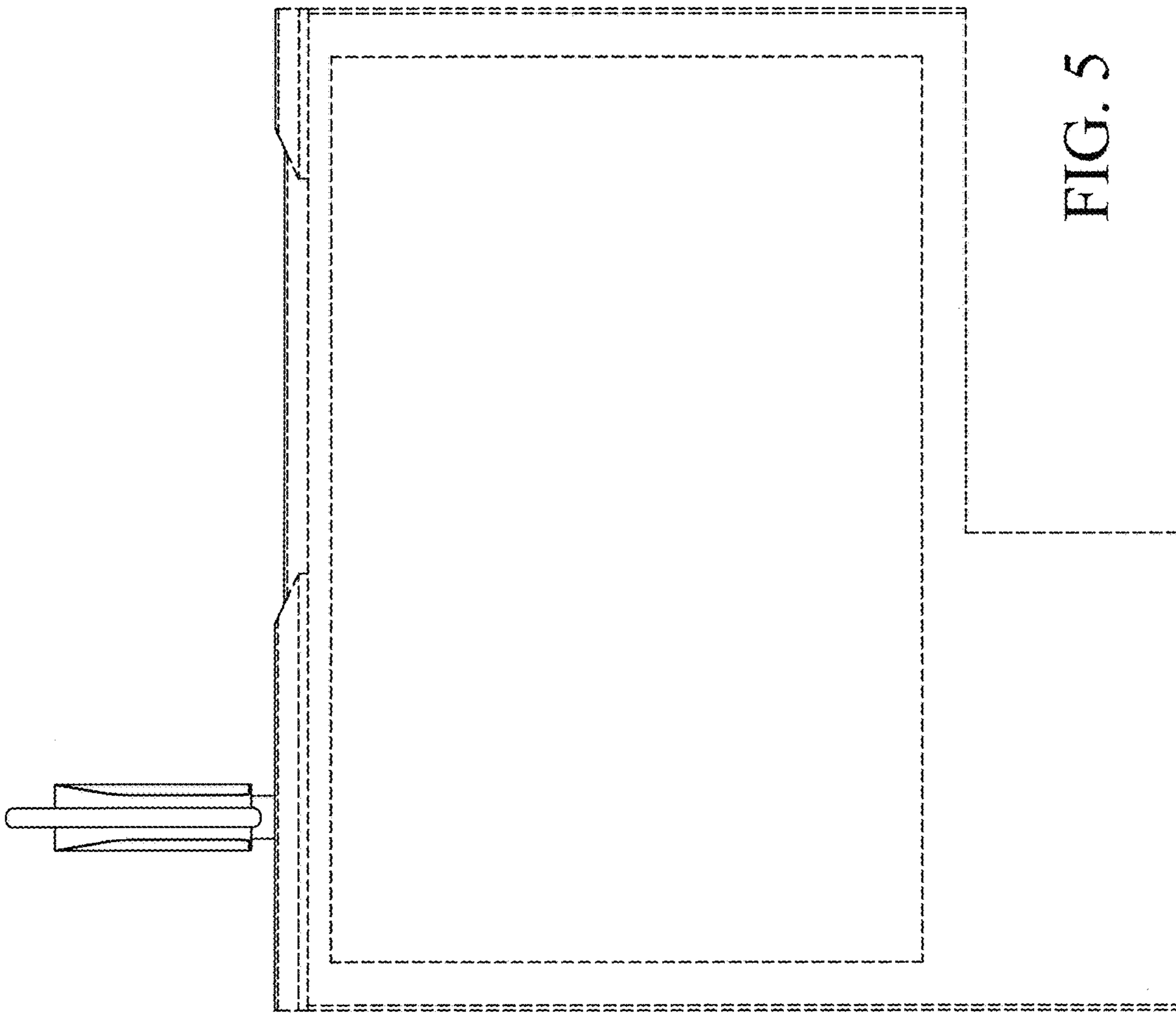

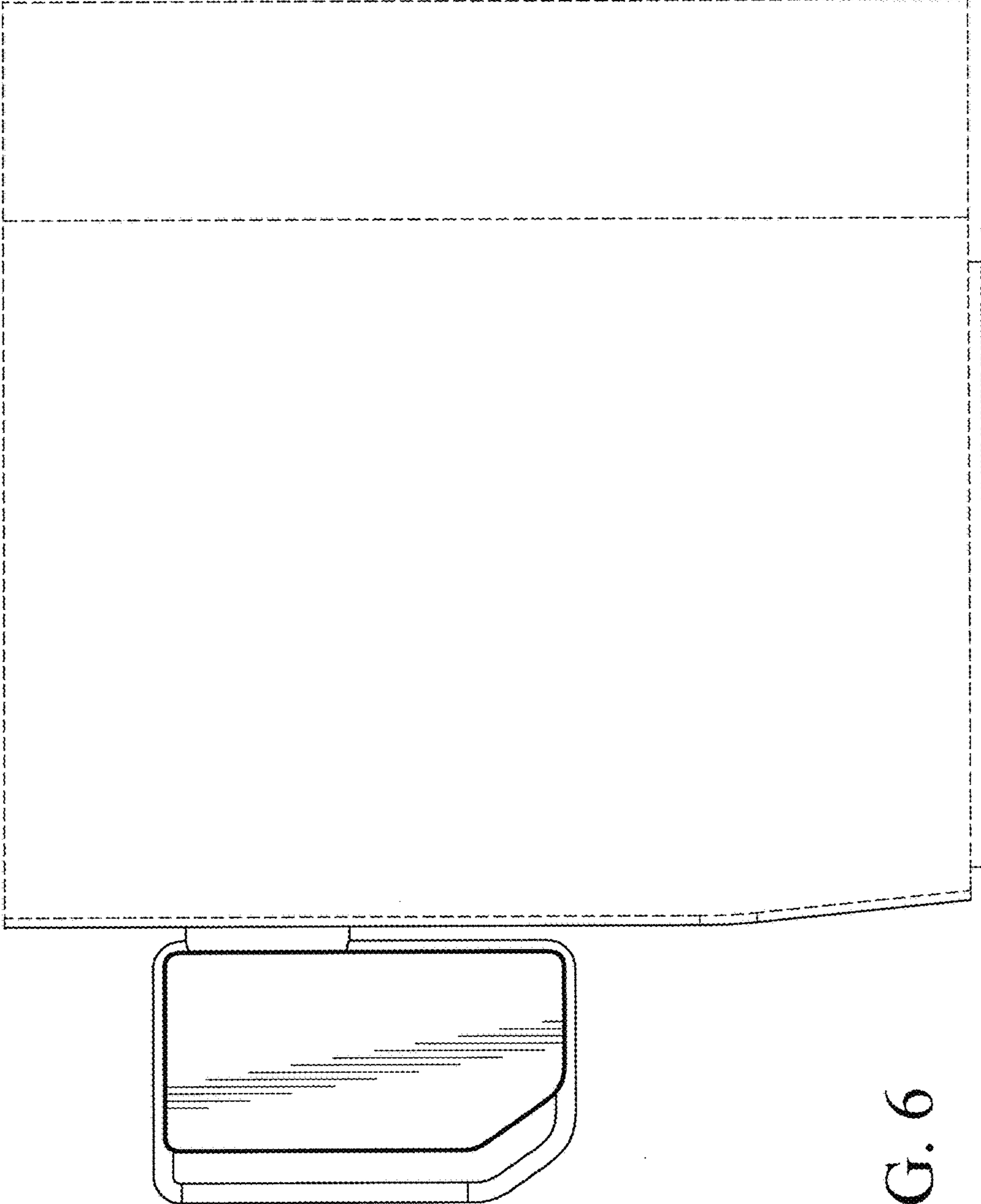

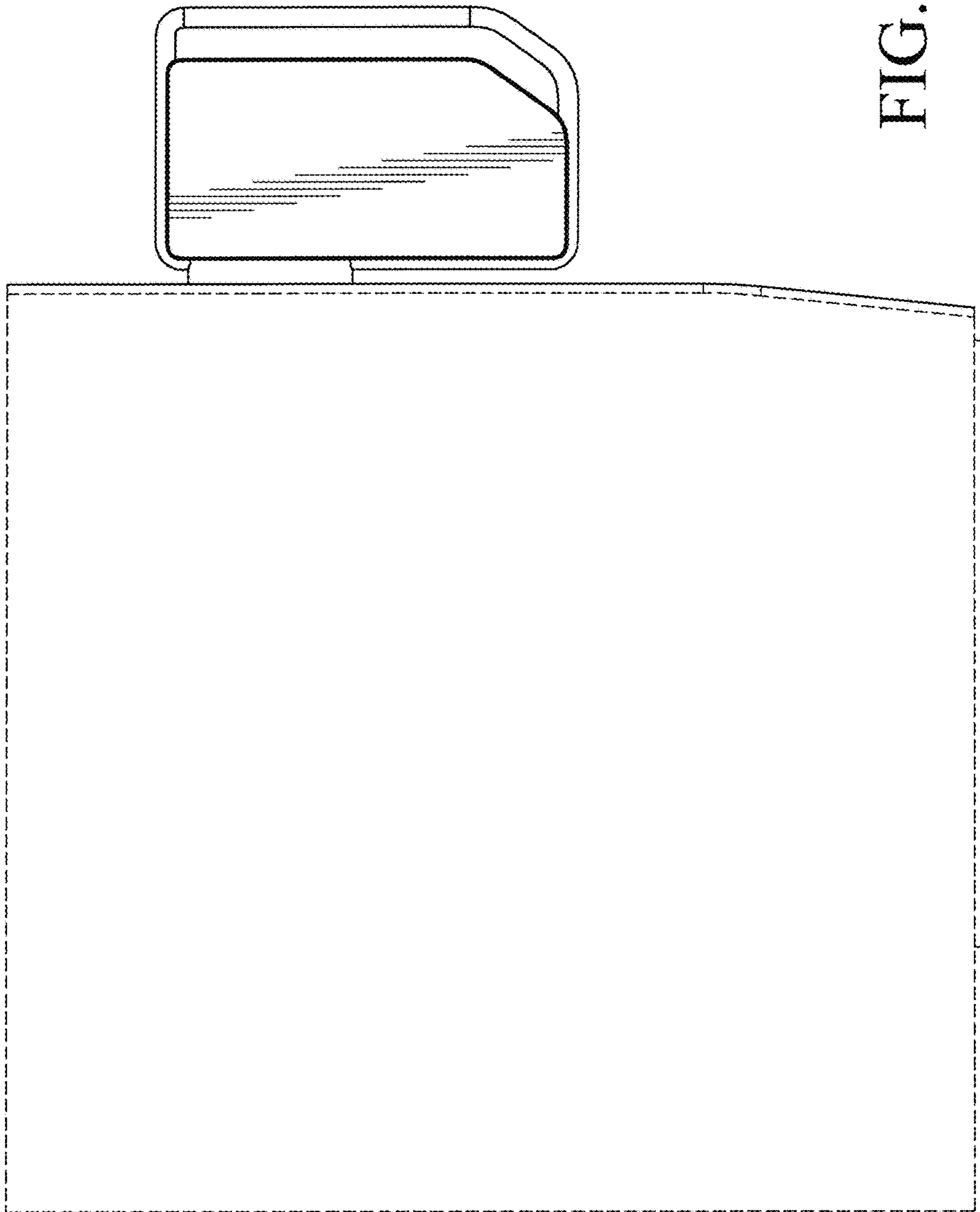

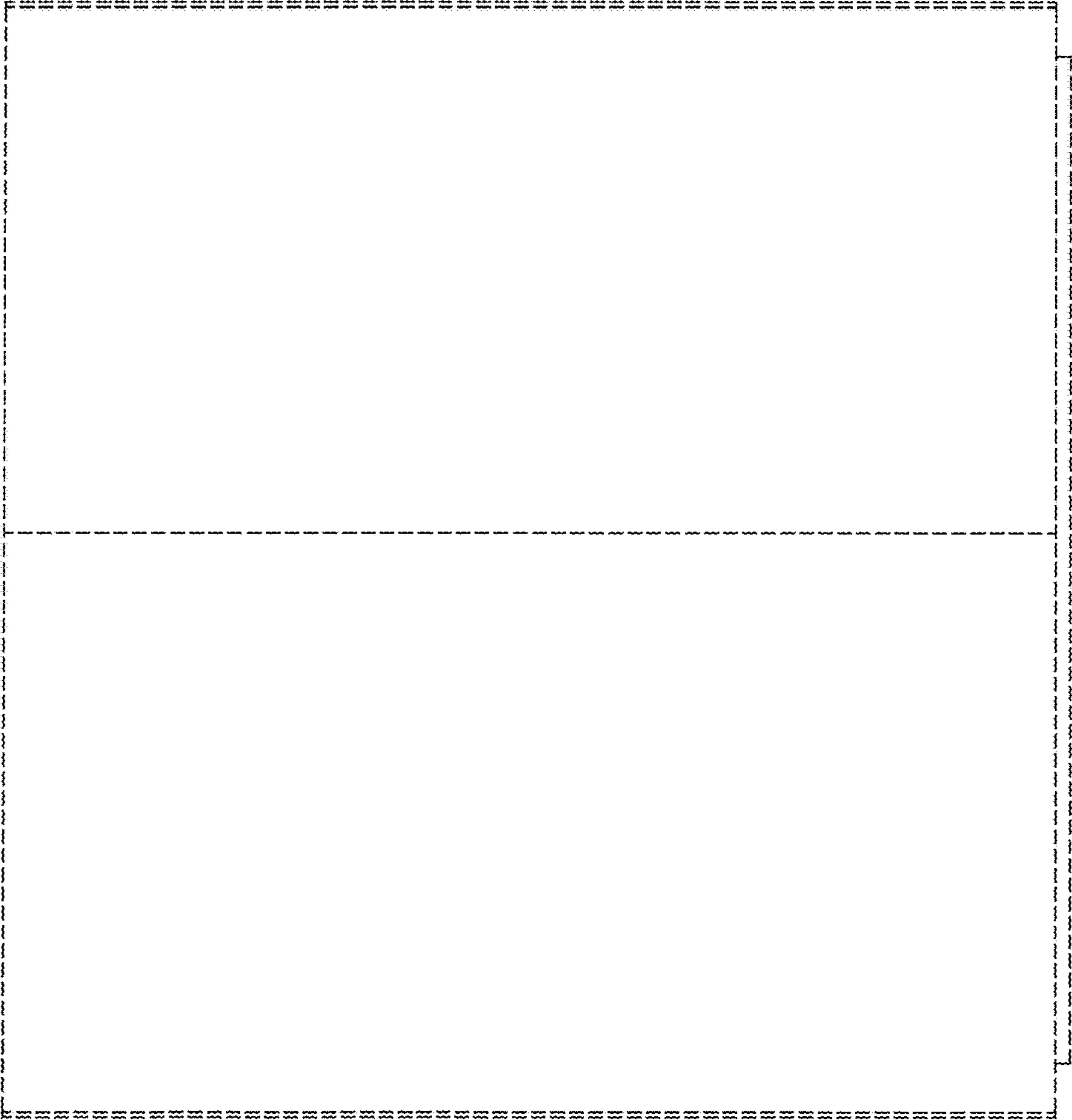
