We claim the ornamental design for a portable printer, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a portable printer showing our new design;
FIG. 2 is an enlarged top view thereof;

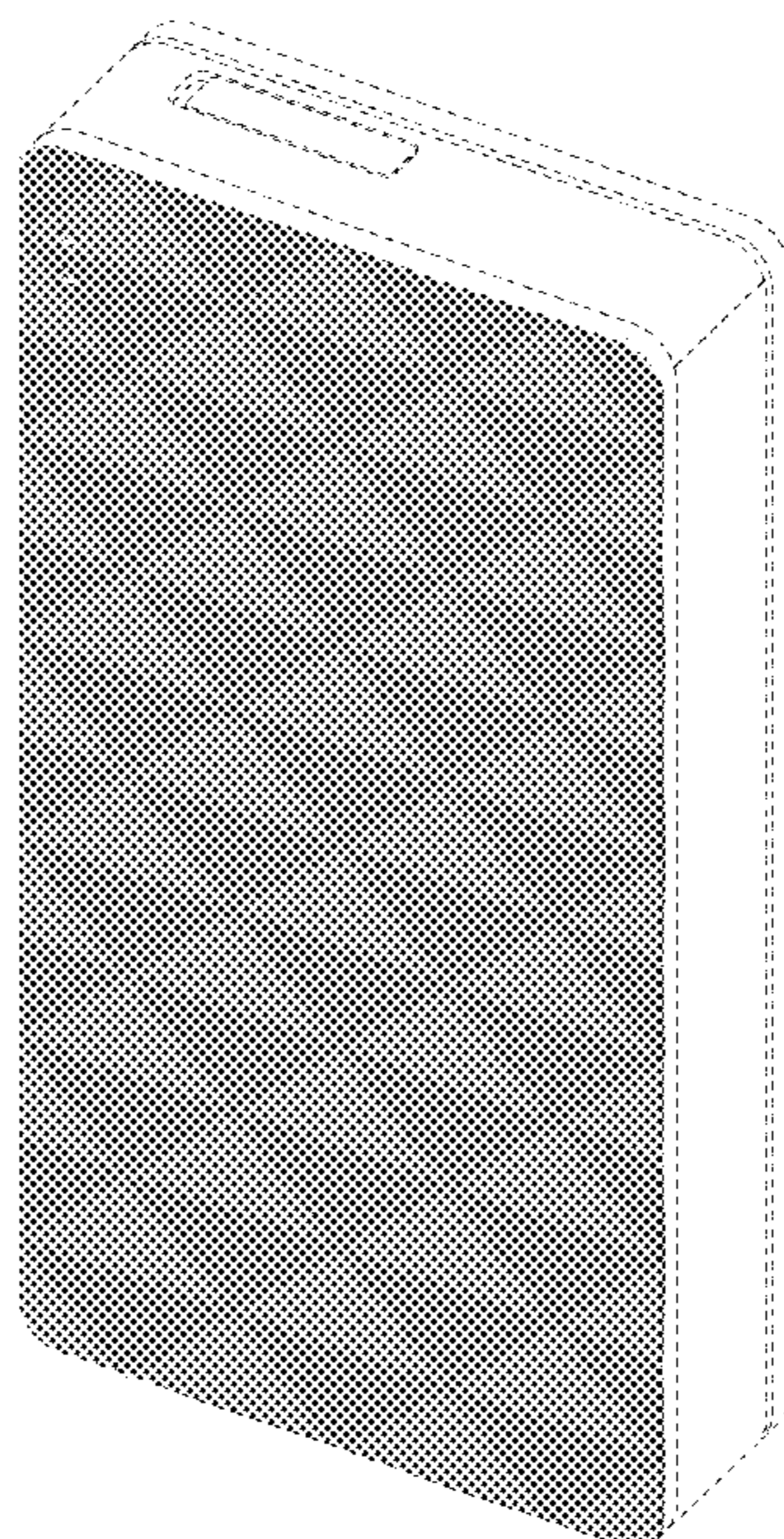

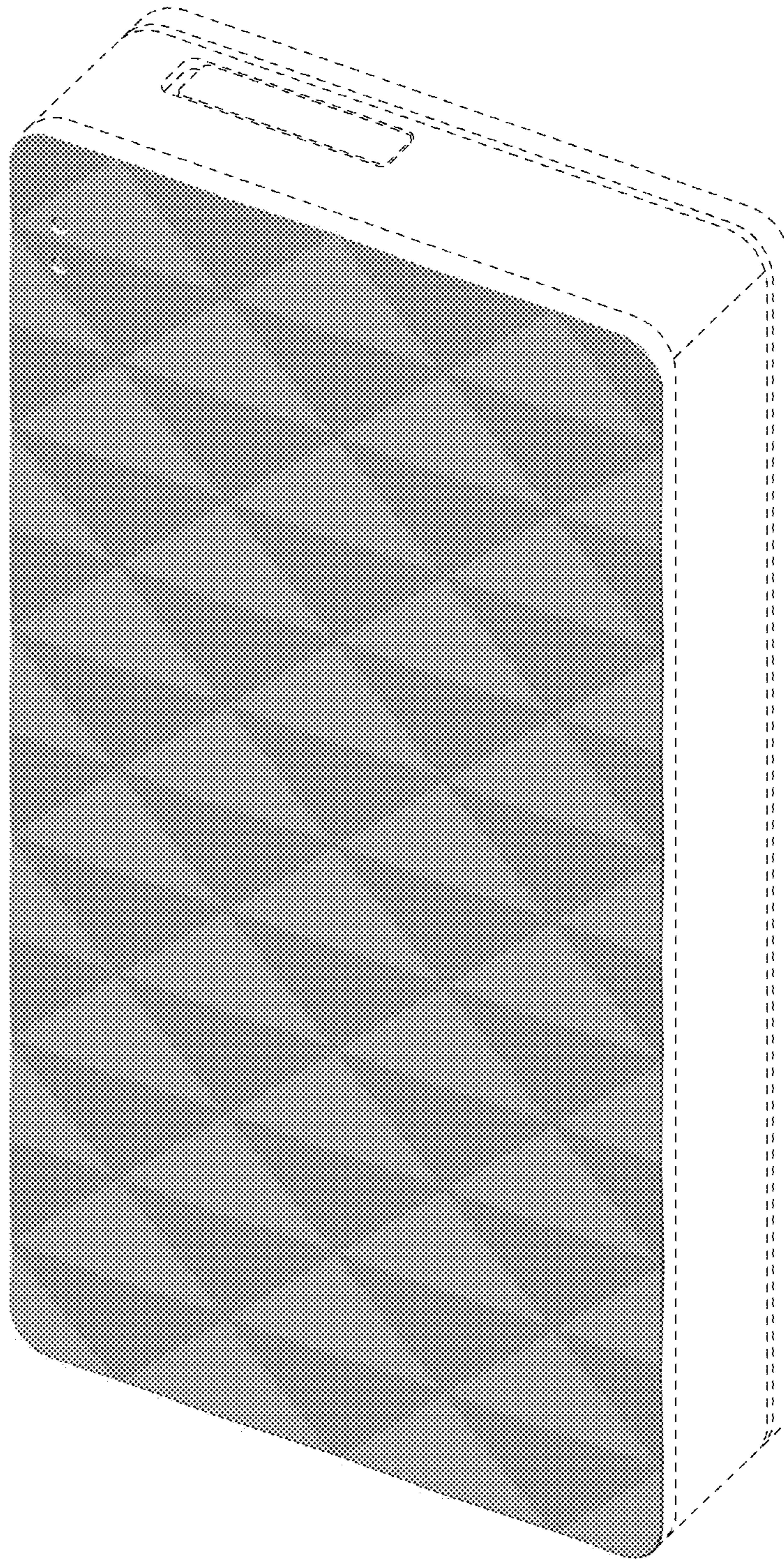

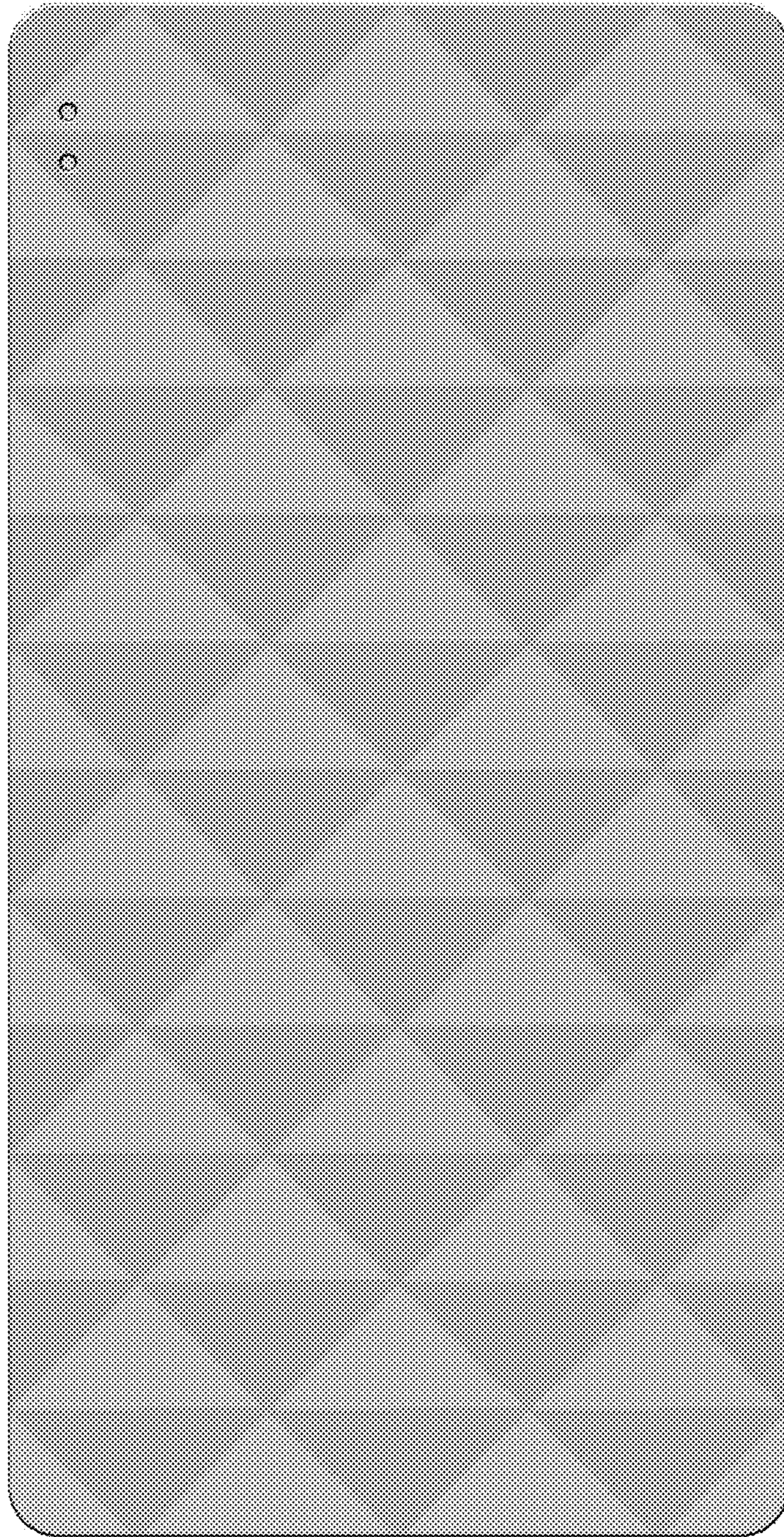

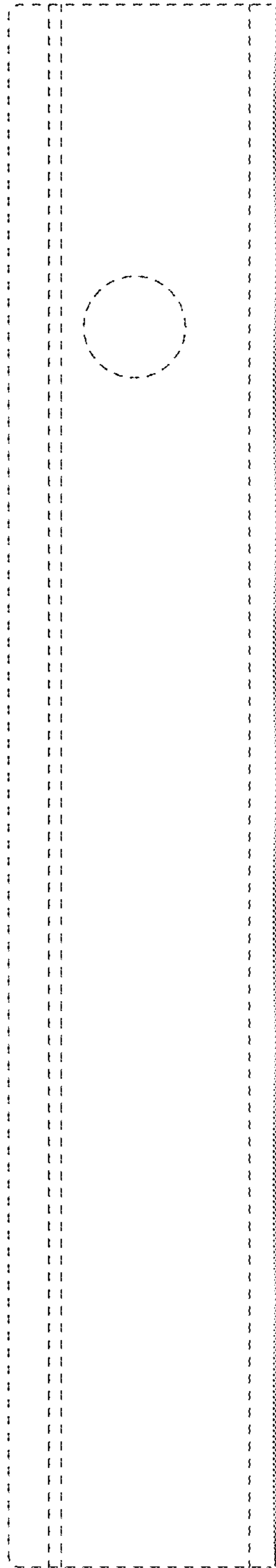

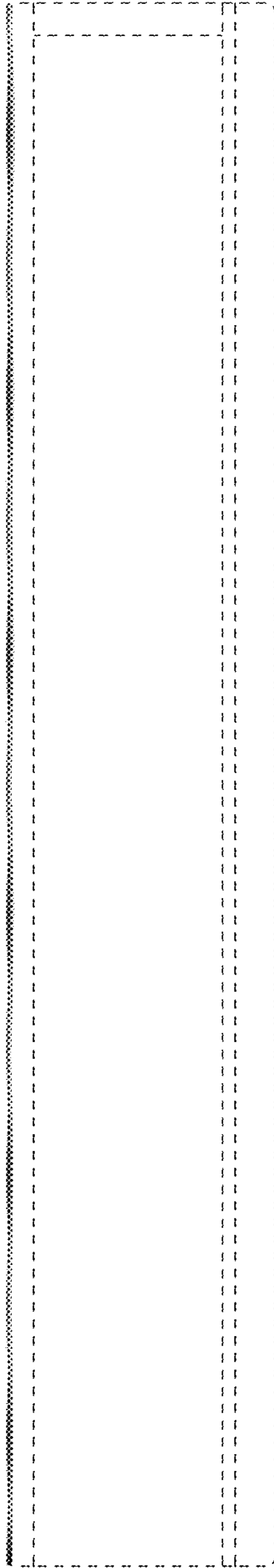

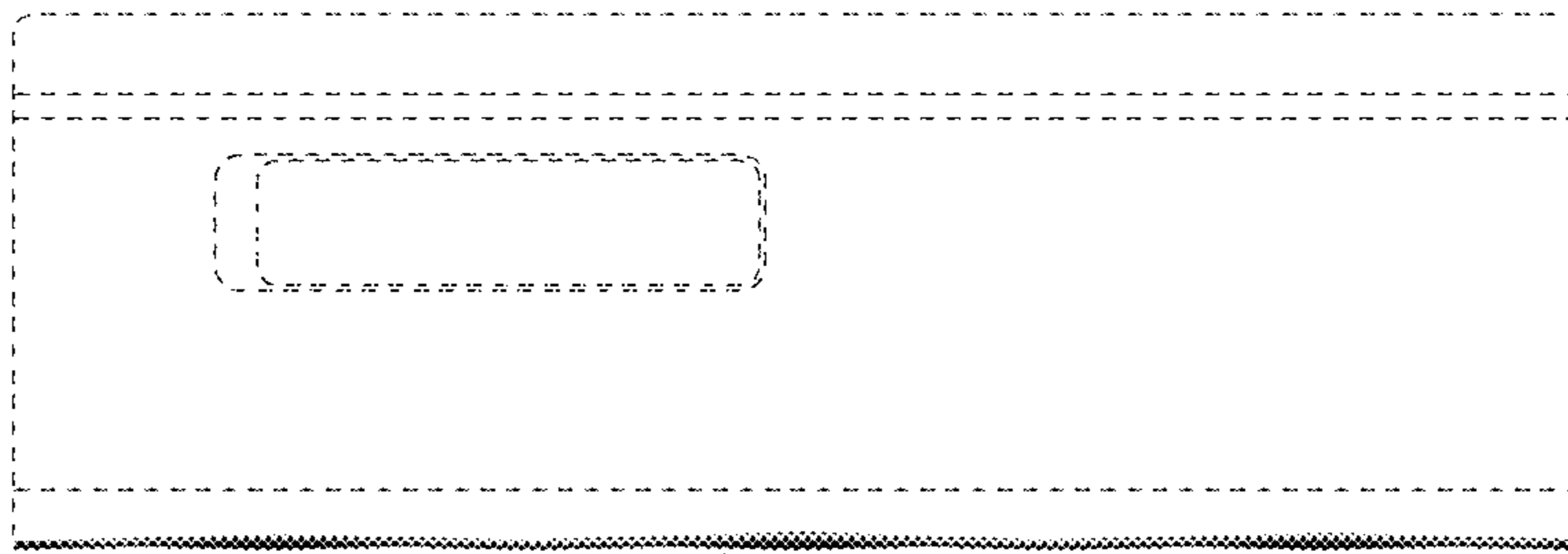
