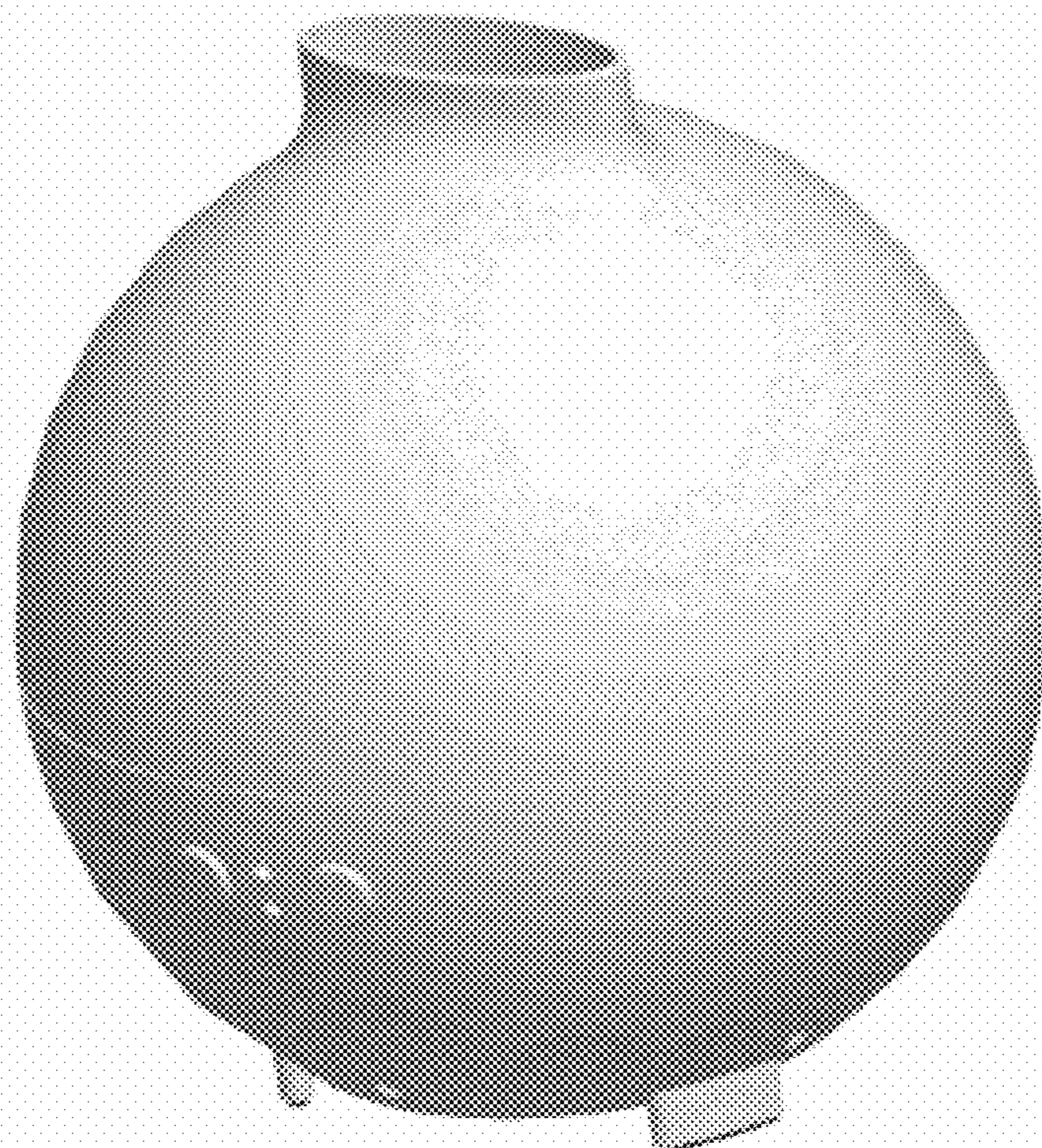
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an aroma diffuser of the present invention;

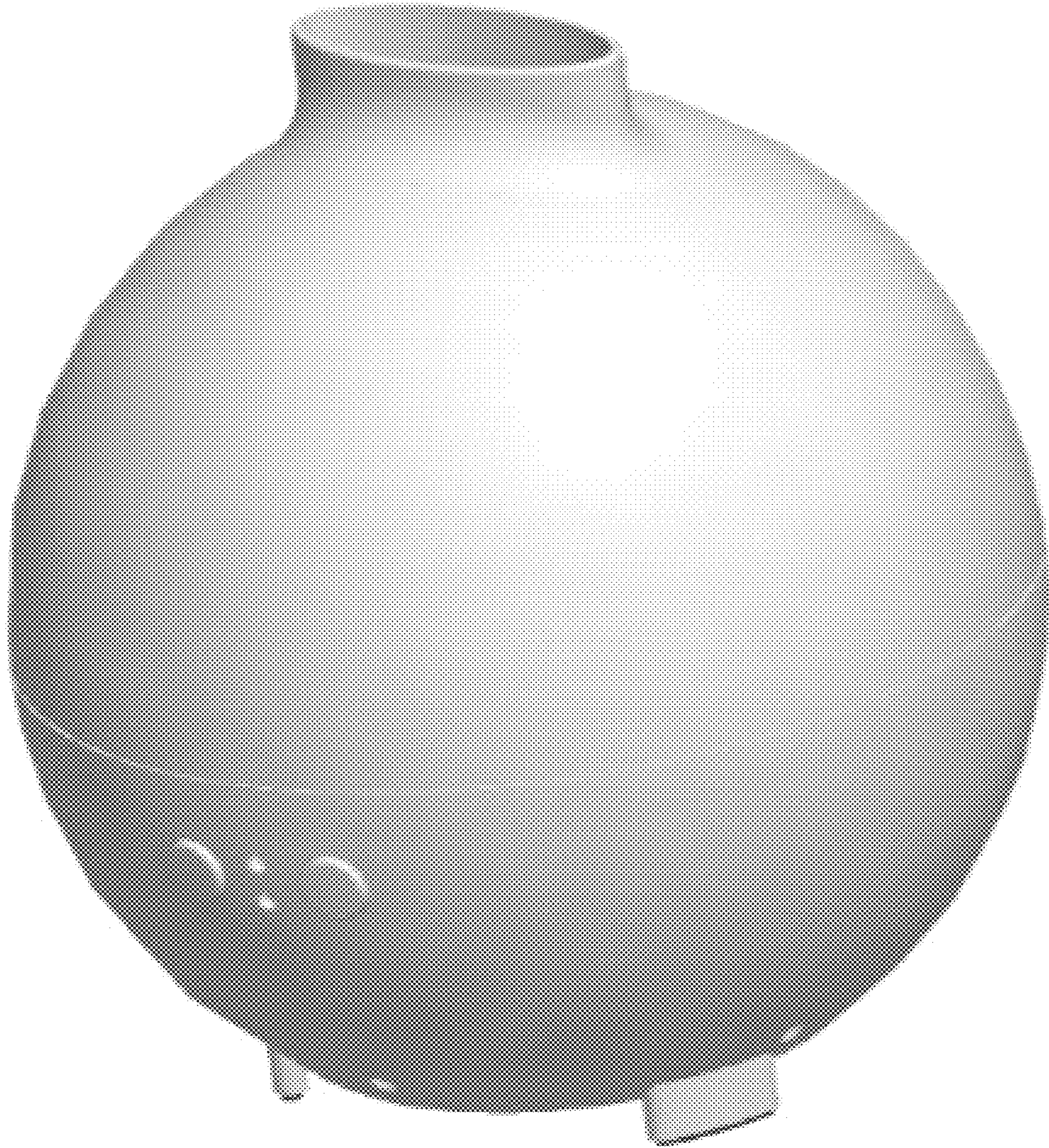

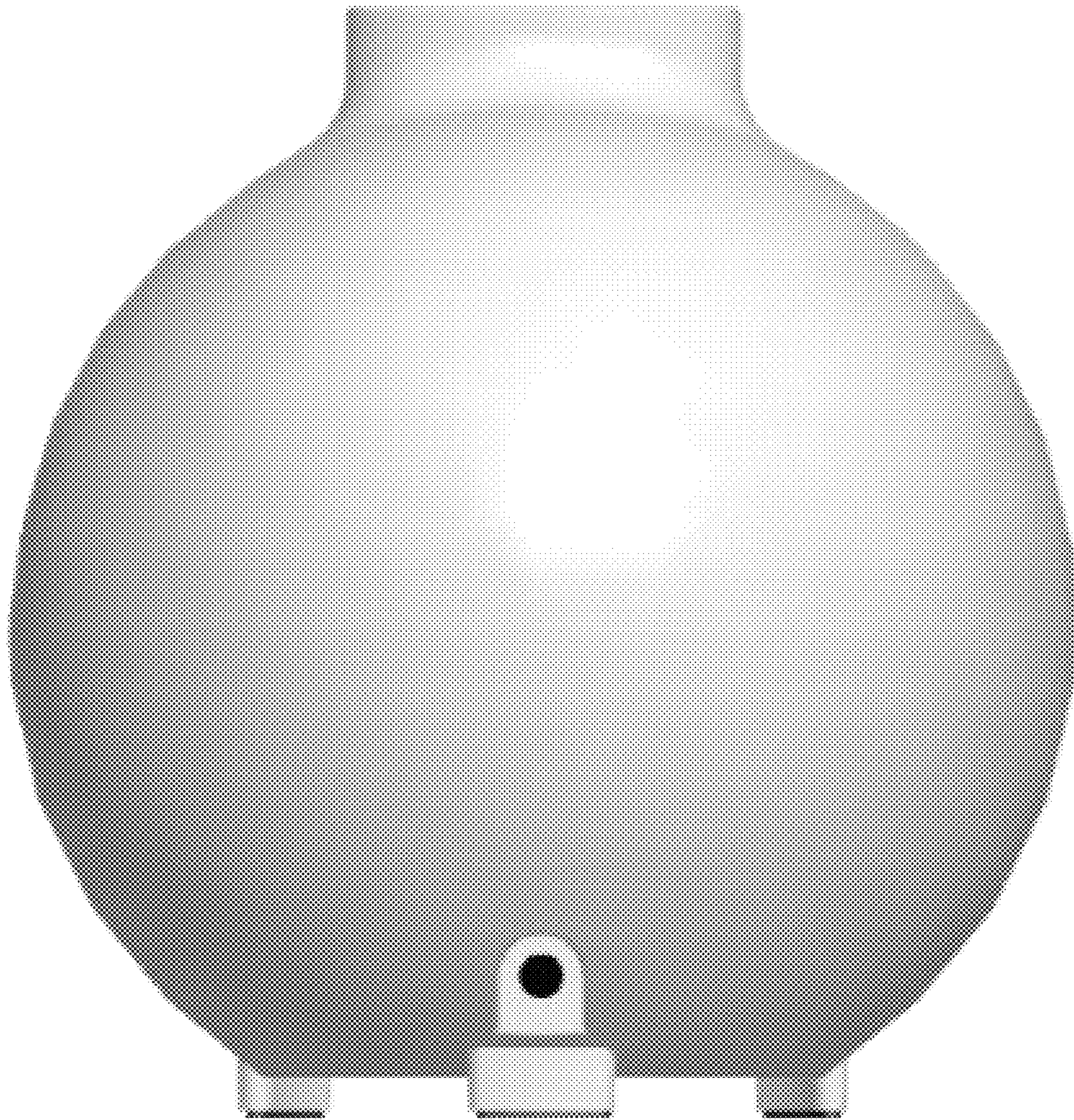

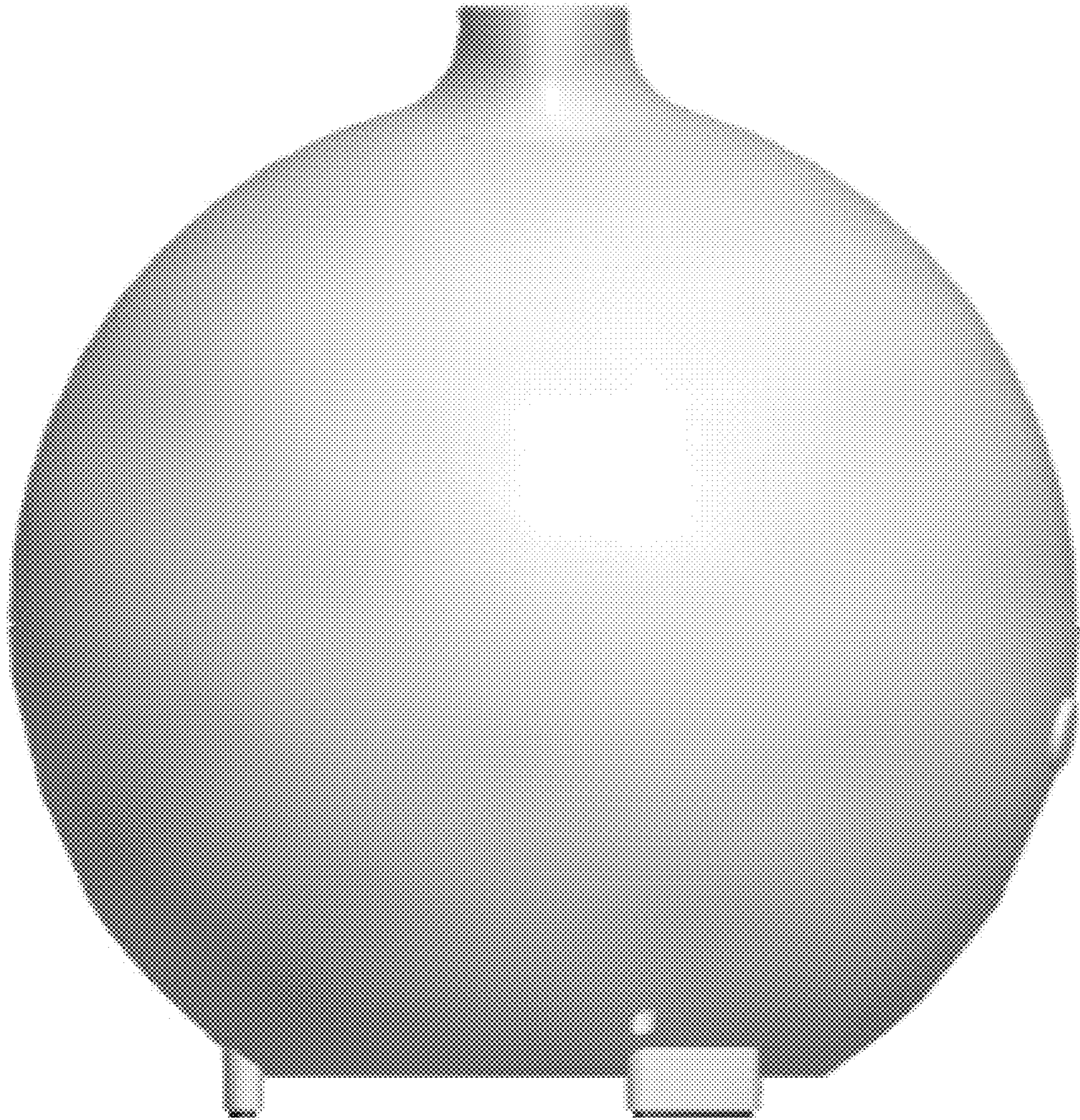

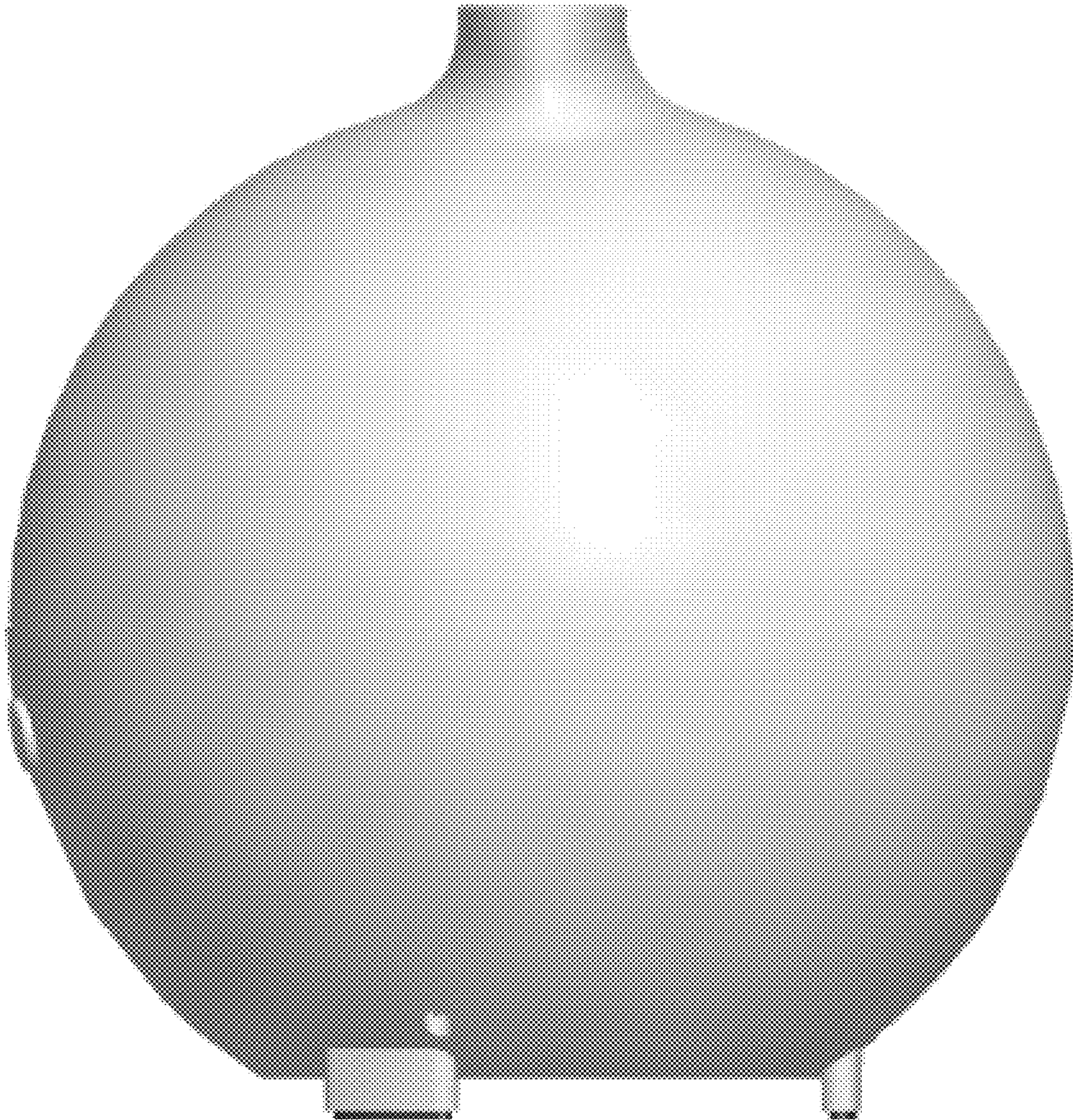
