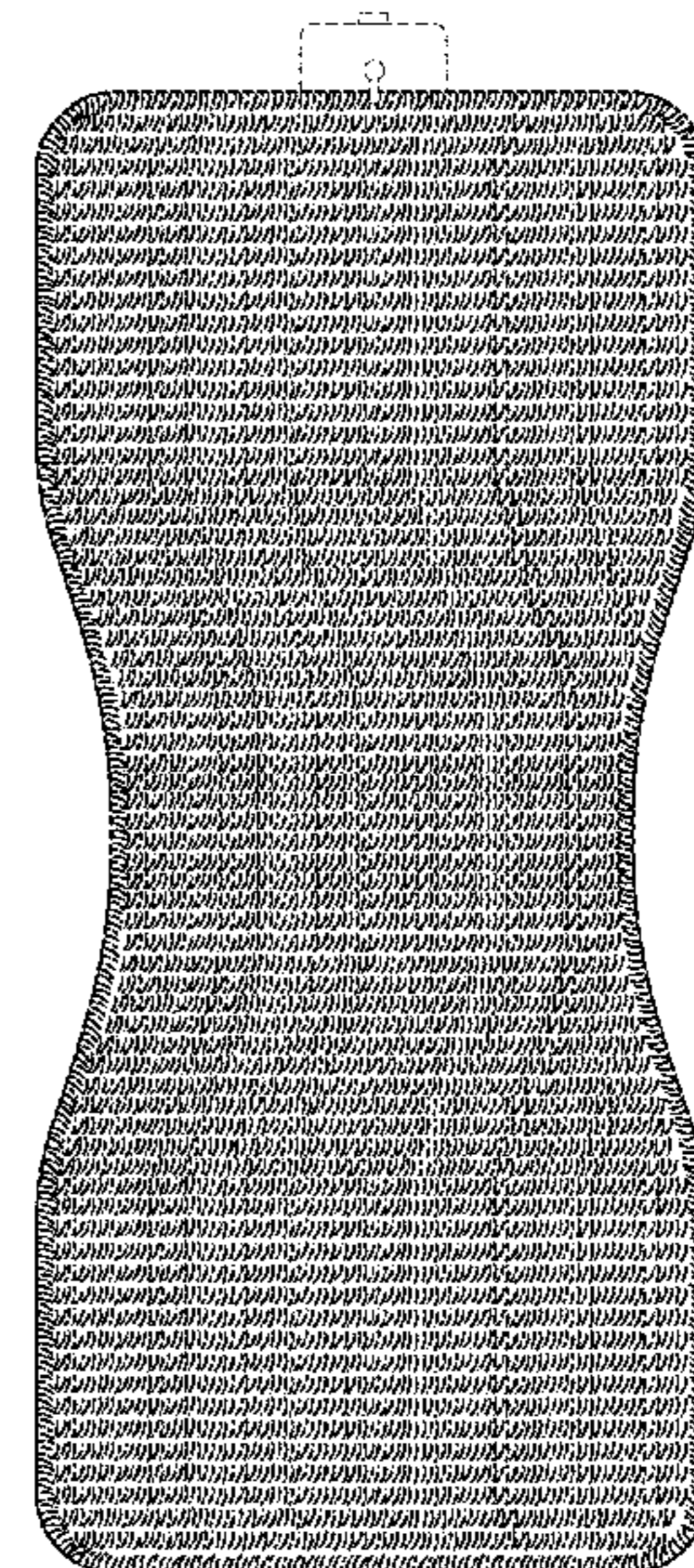
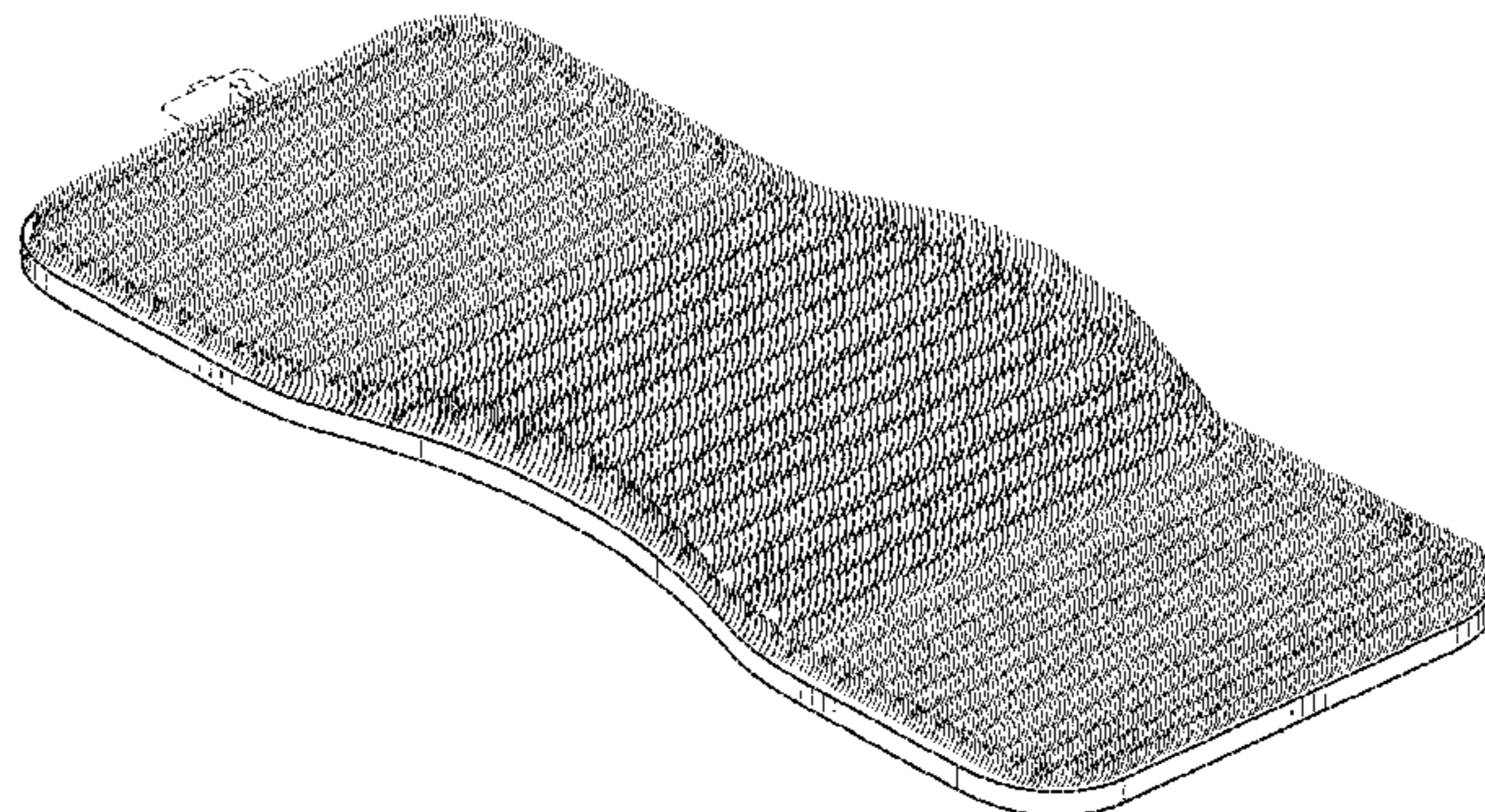
(57) **CLAIM**

The ornamental design for a wall mounted back scrubbing brush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wall mounted back scrubbing brush showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a left side elevational view thereof showing the wall mounted back scrubbing brush in use. The partial human figure drawn in broken lines in FIG. 7 is environmental included to assist in showing how the claimed design may be used, and forms no part thereof.

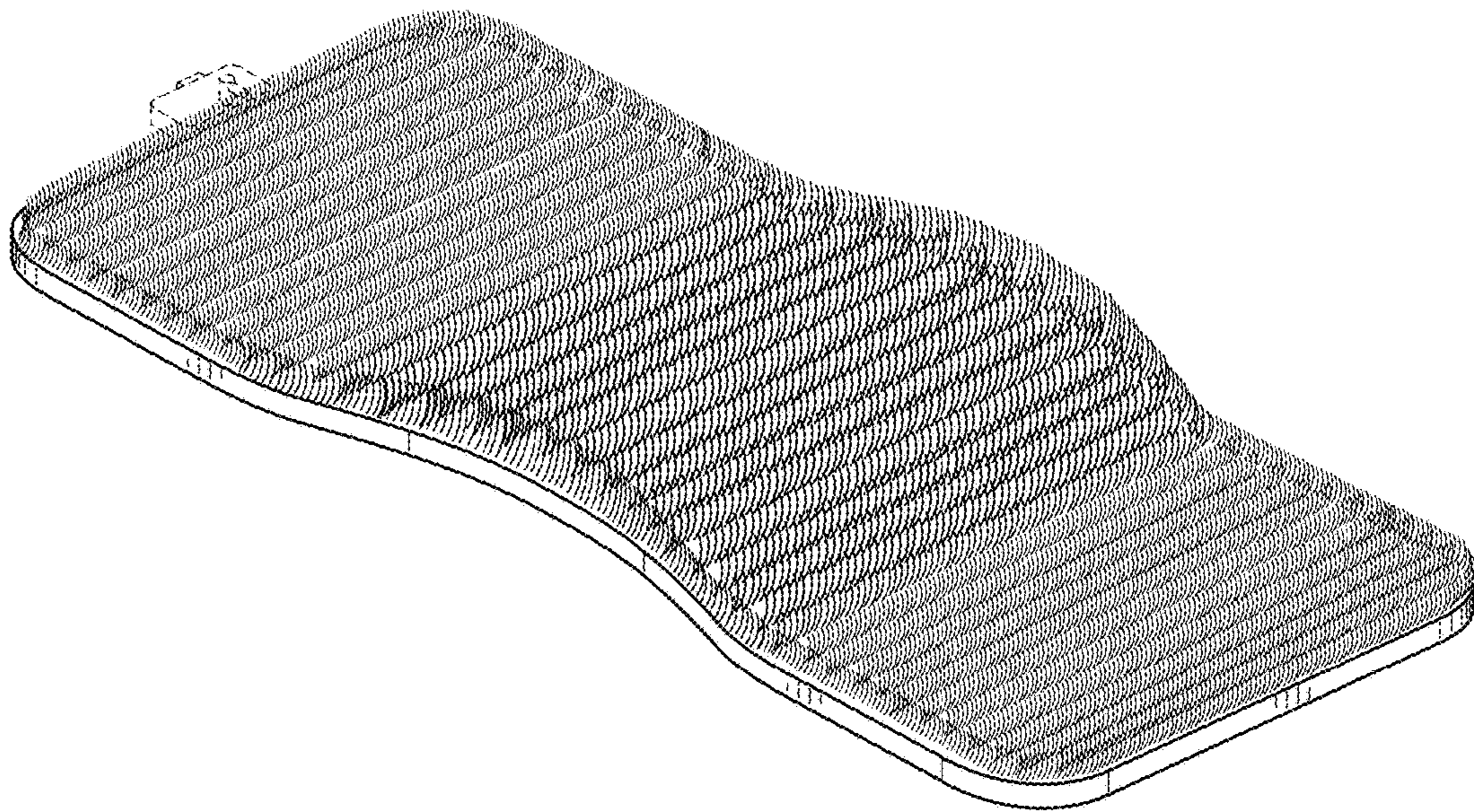

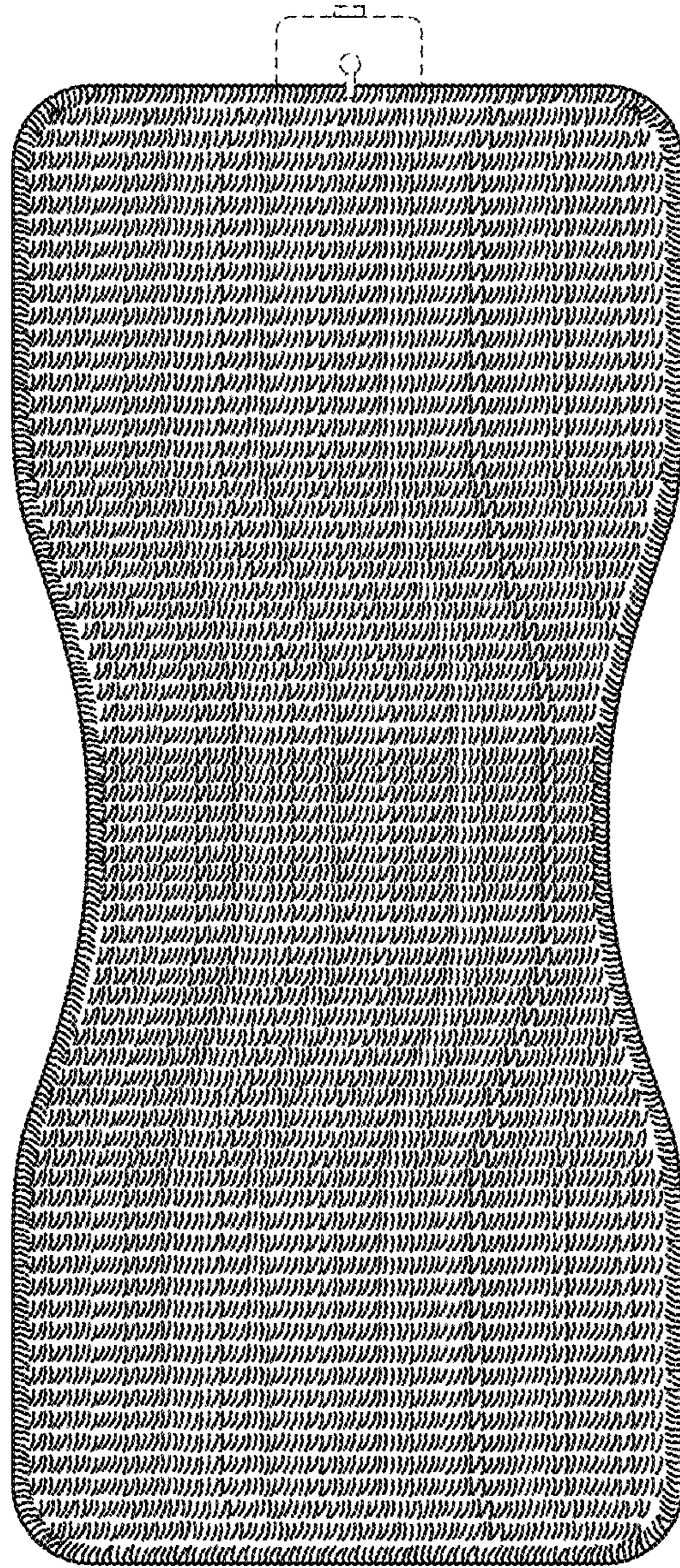

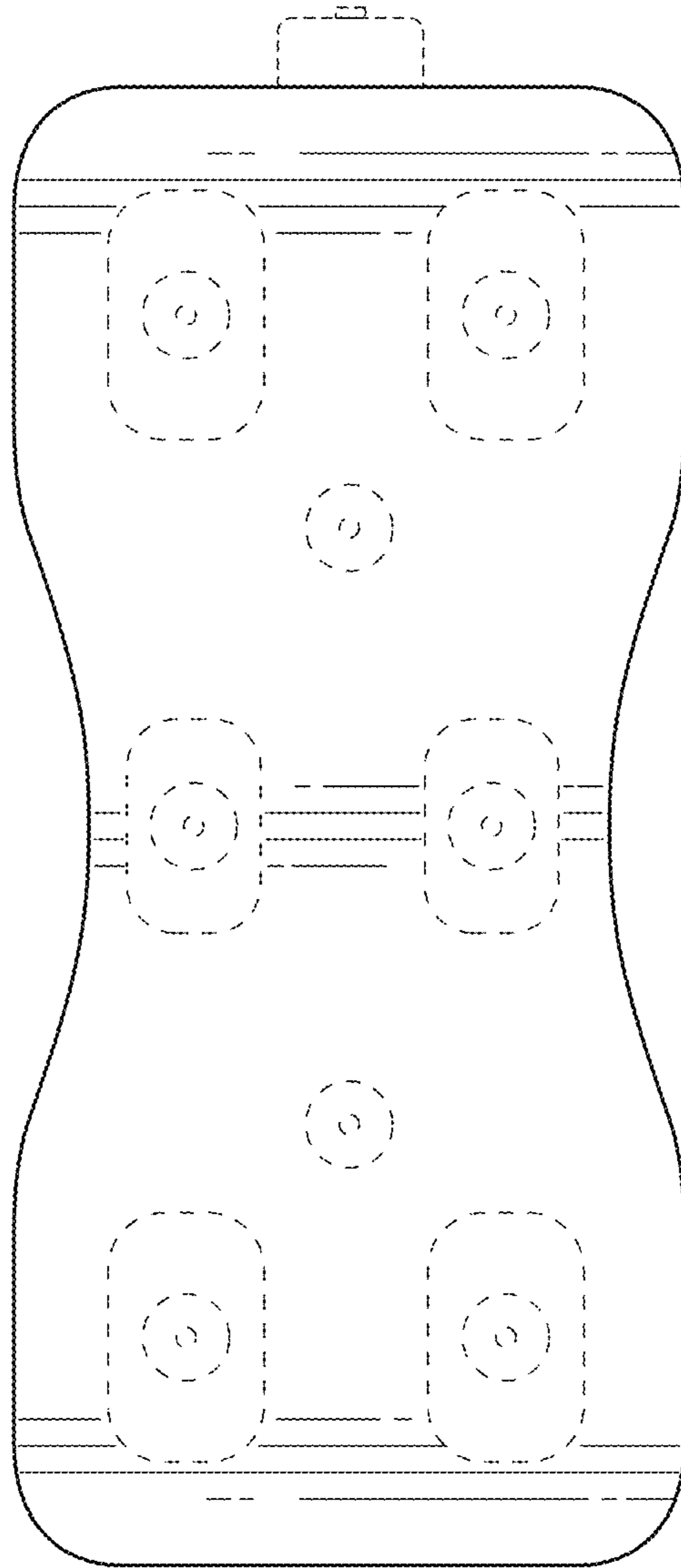

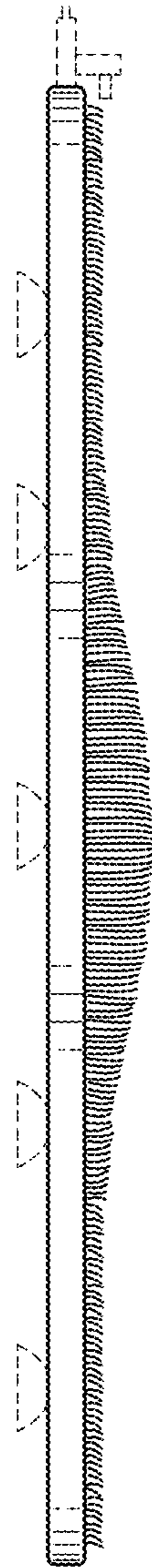

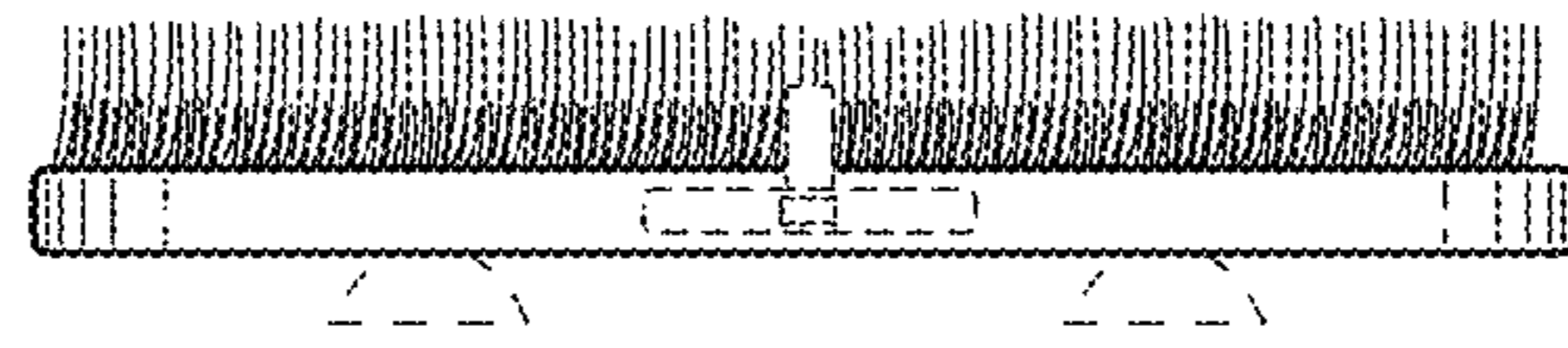

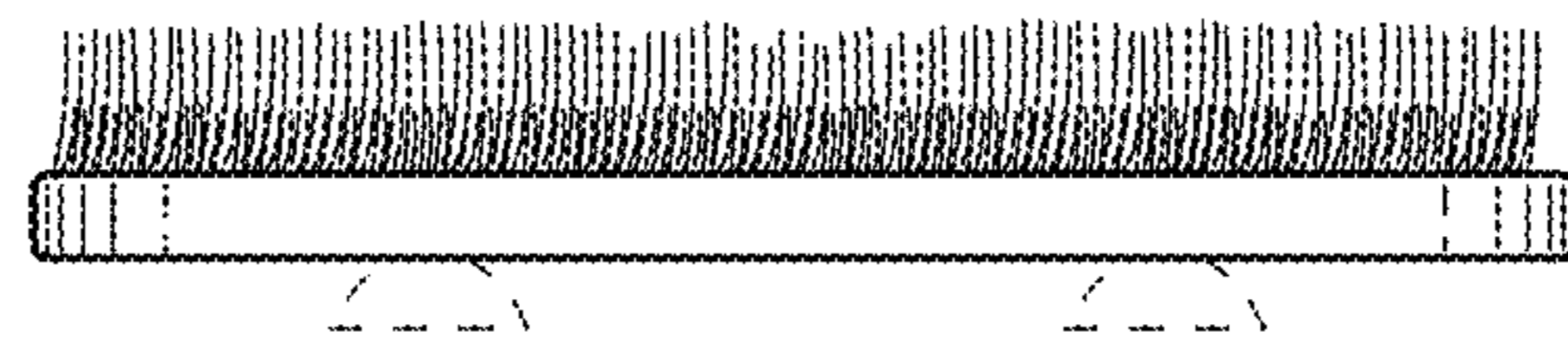

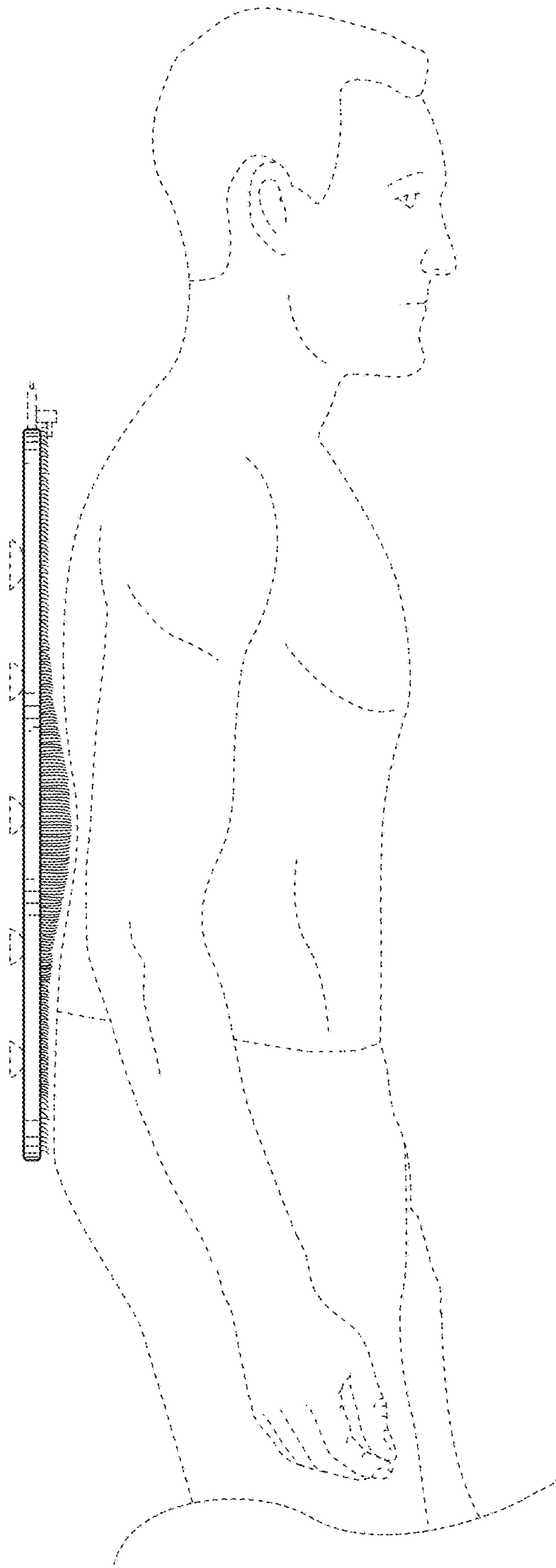
