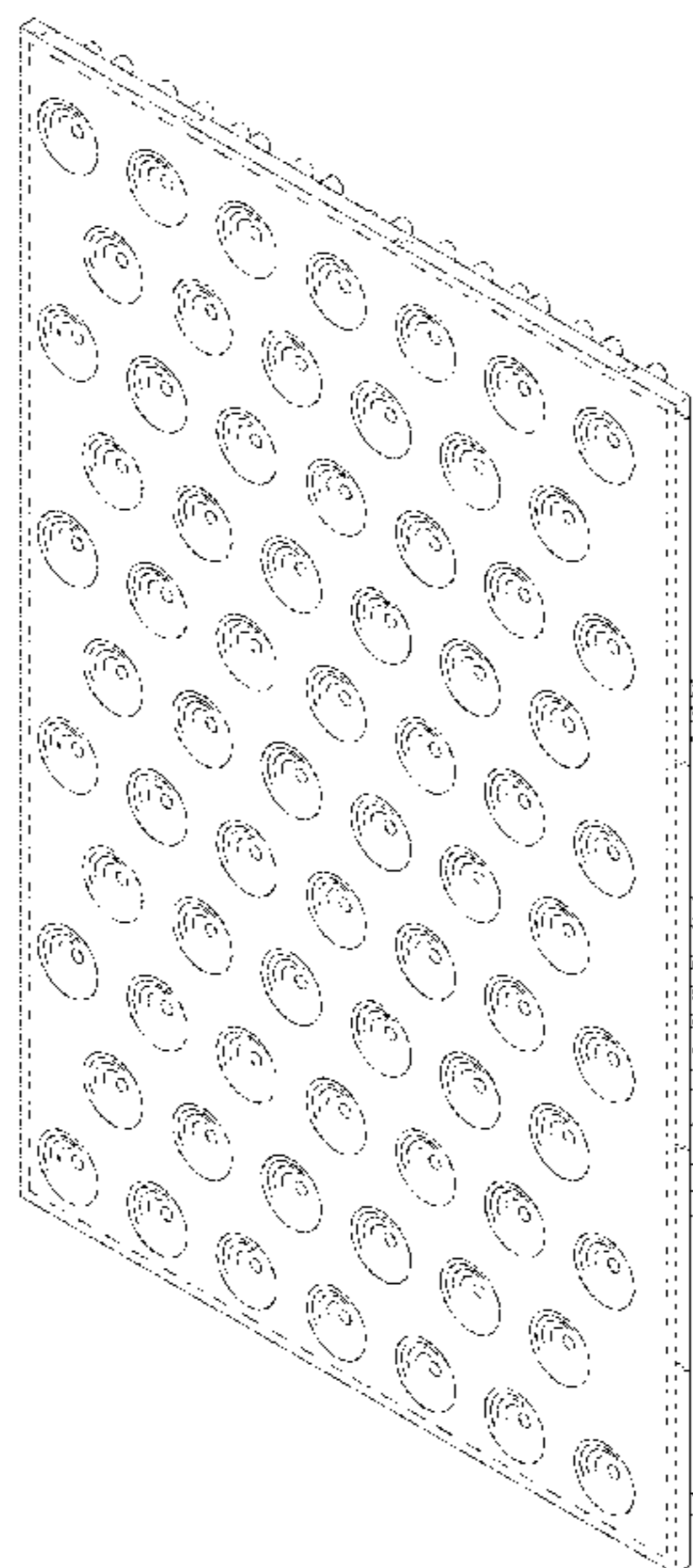
(57) **CLAIM**

The ornamental design for a back scrubber, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the back scrubber showing my new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a rear elevation view thereof;
FIG. 7 is a right side elevation view thereof; and,
FIG. 8 is a left side elevation view thereof.
The broken lines shown in FIG. 3 of the drawings illustrate environmental structure that forms no part of the claimed design.

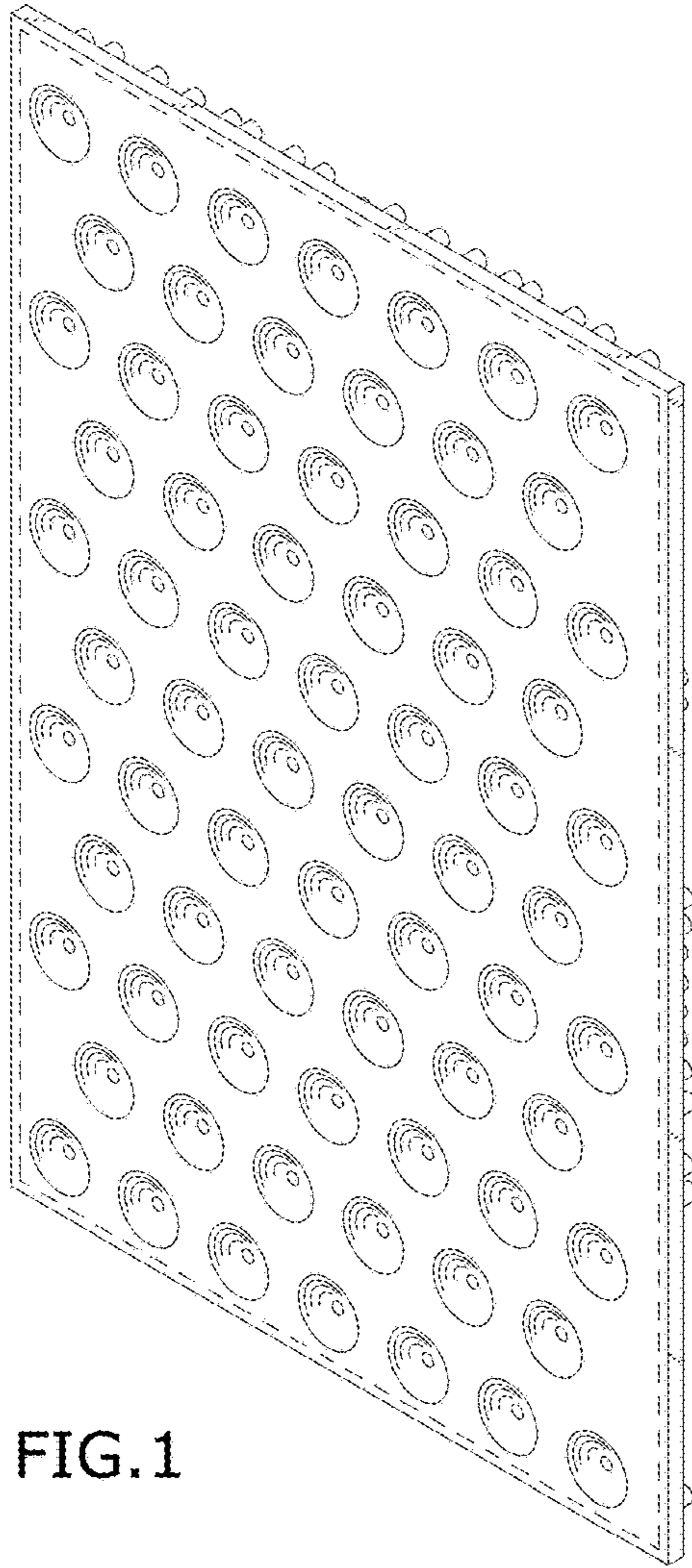

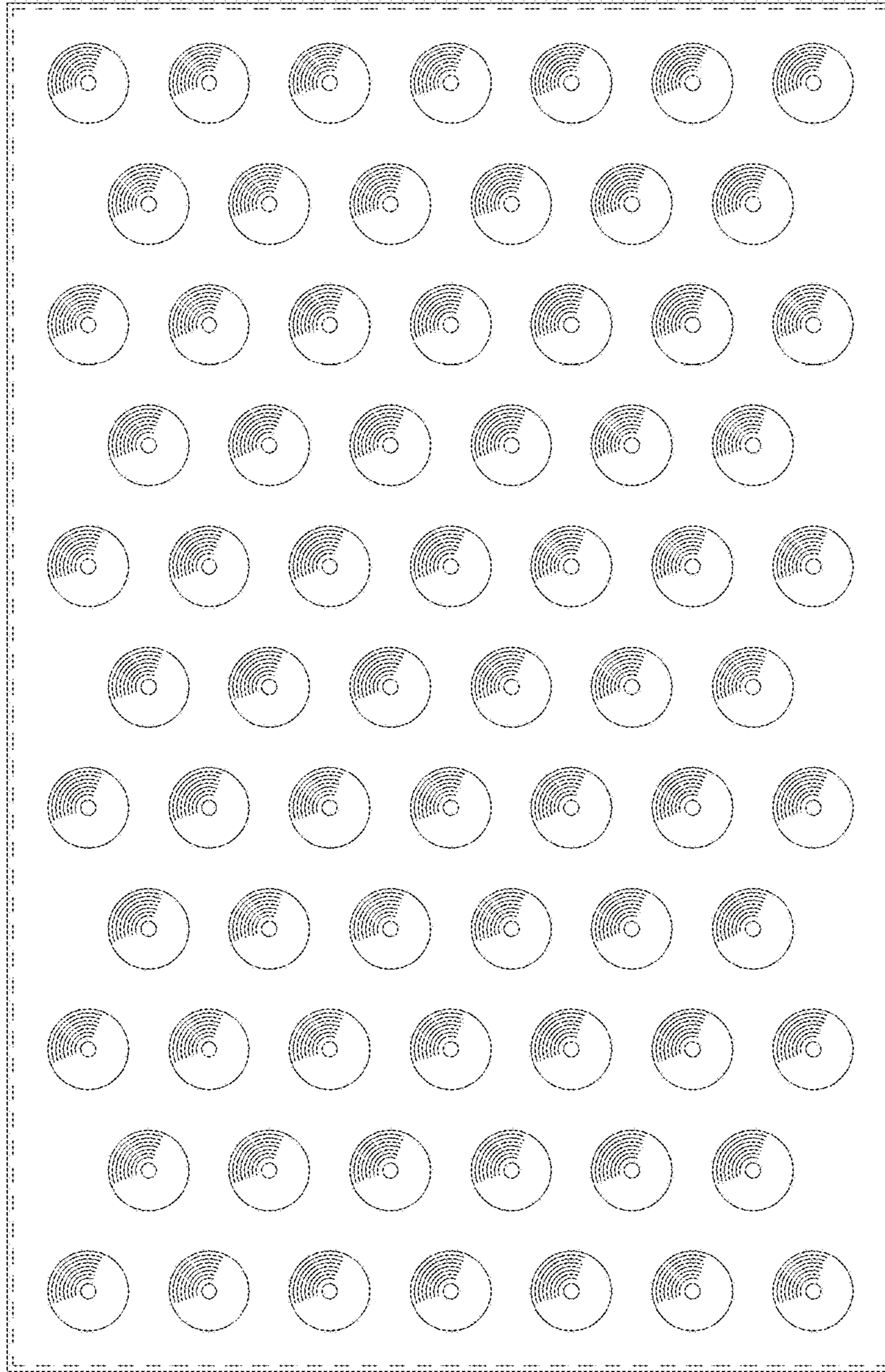

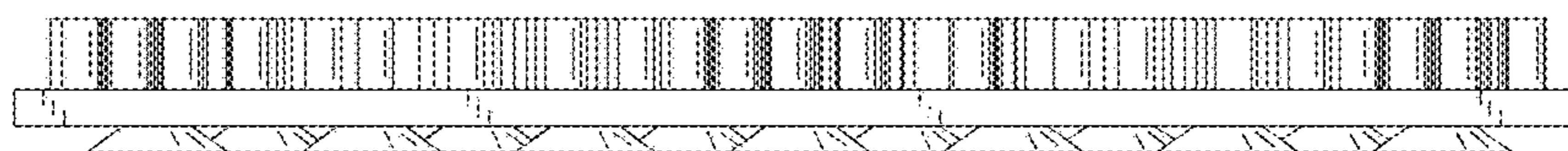
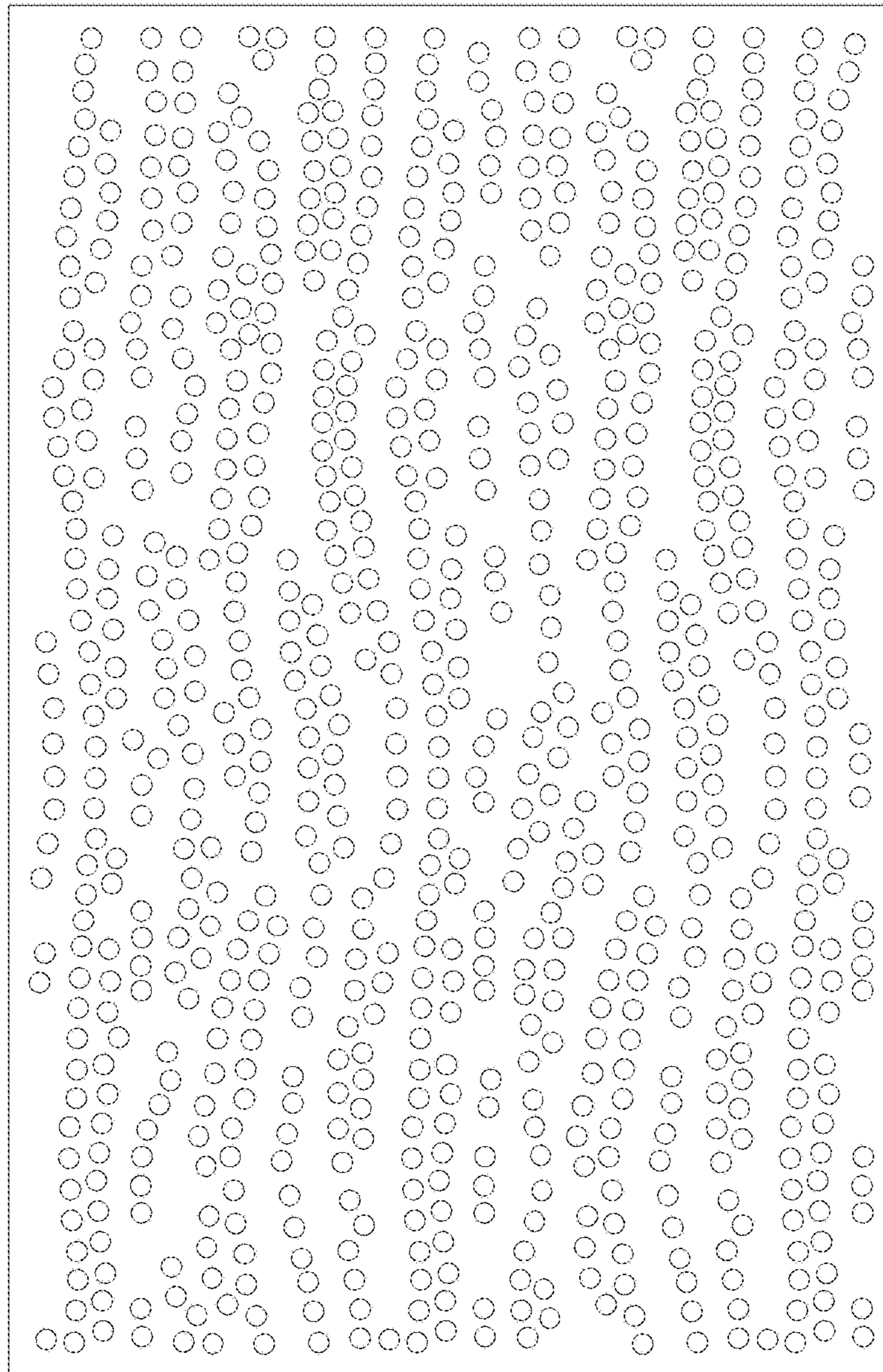

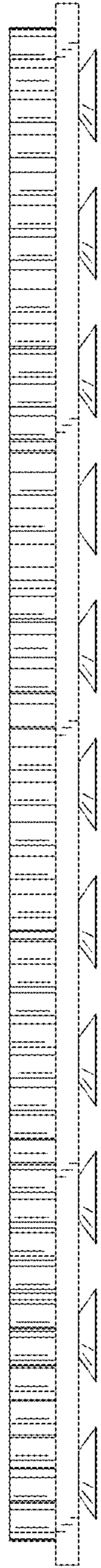

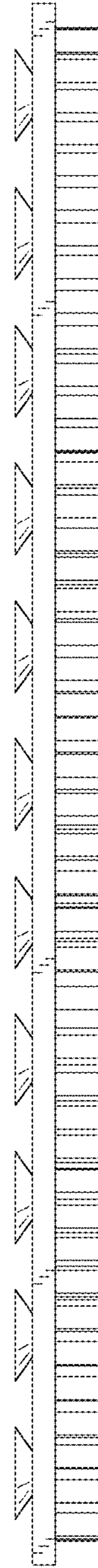
