The ornamental design for a medical garment, as shown and described.

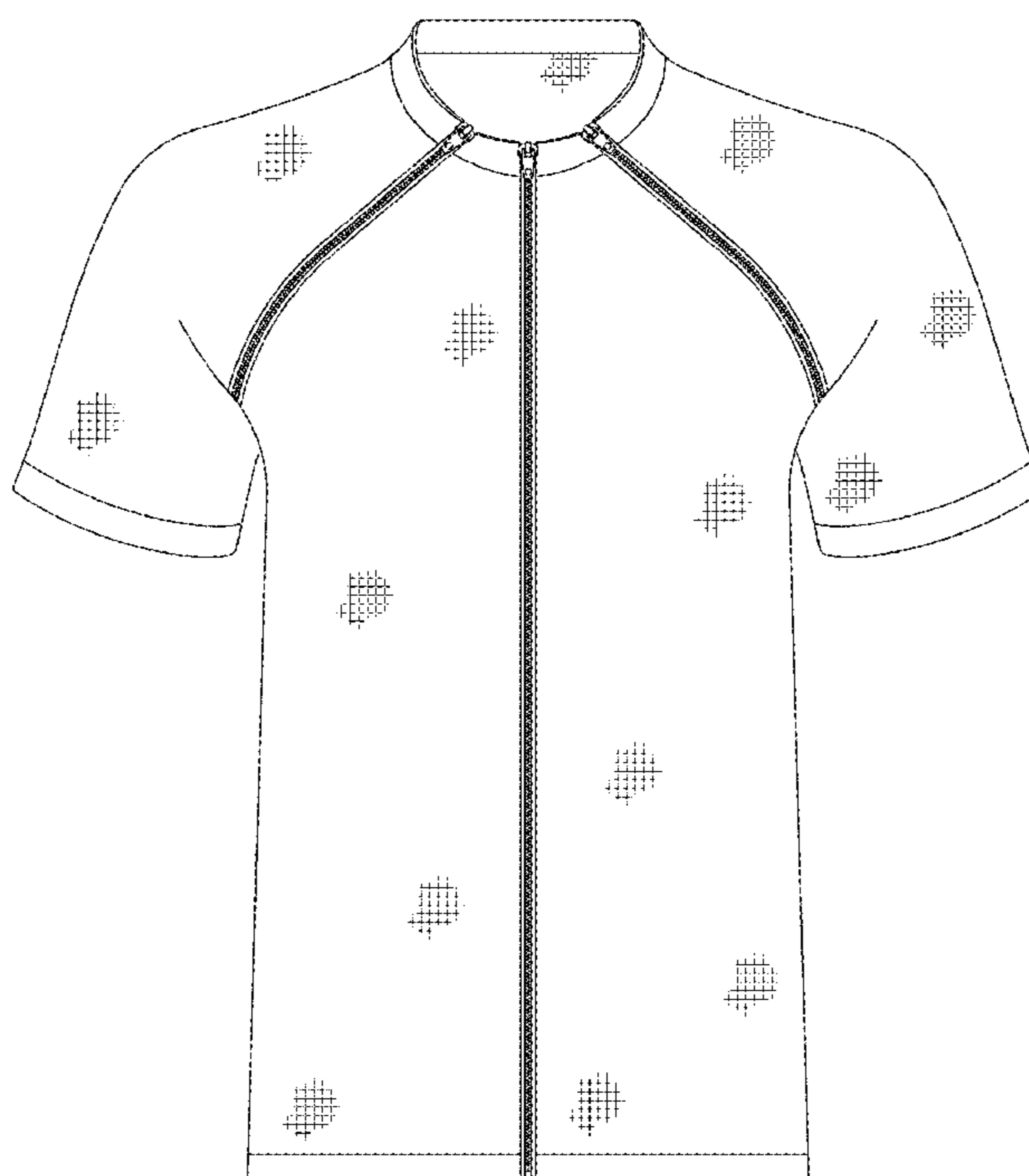

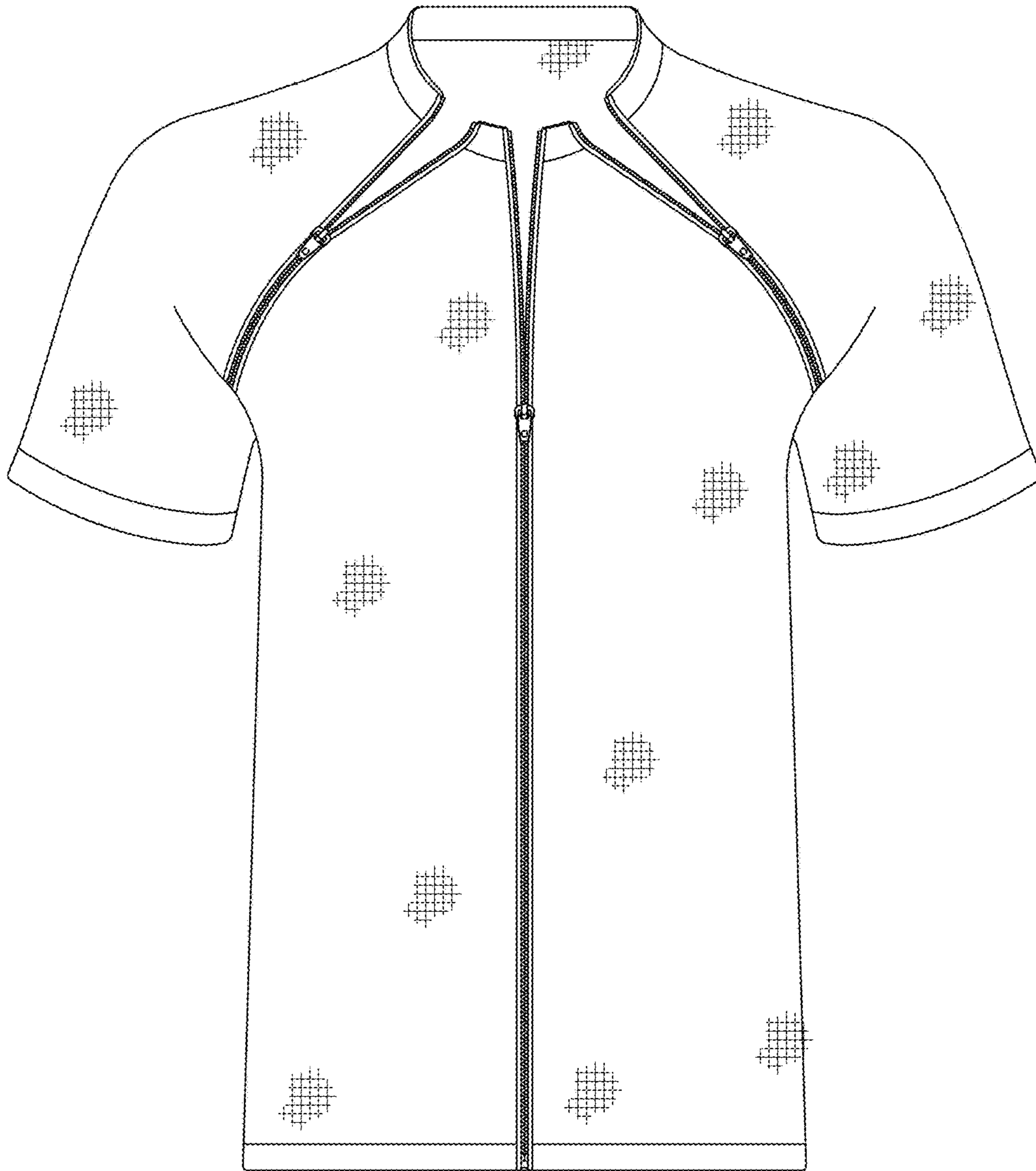

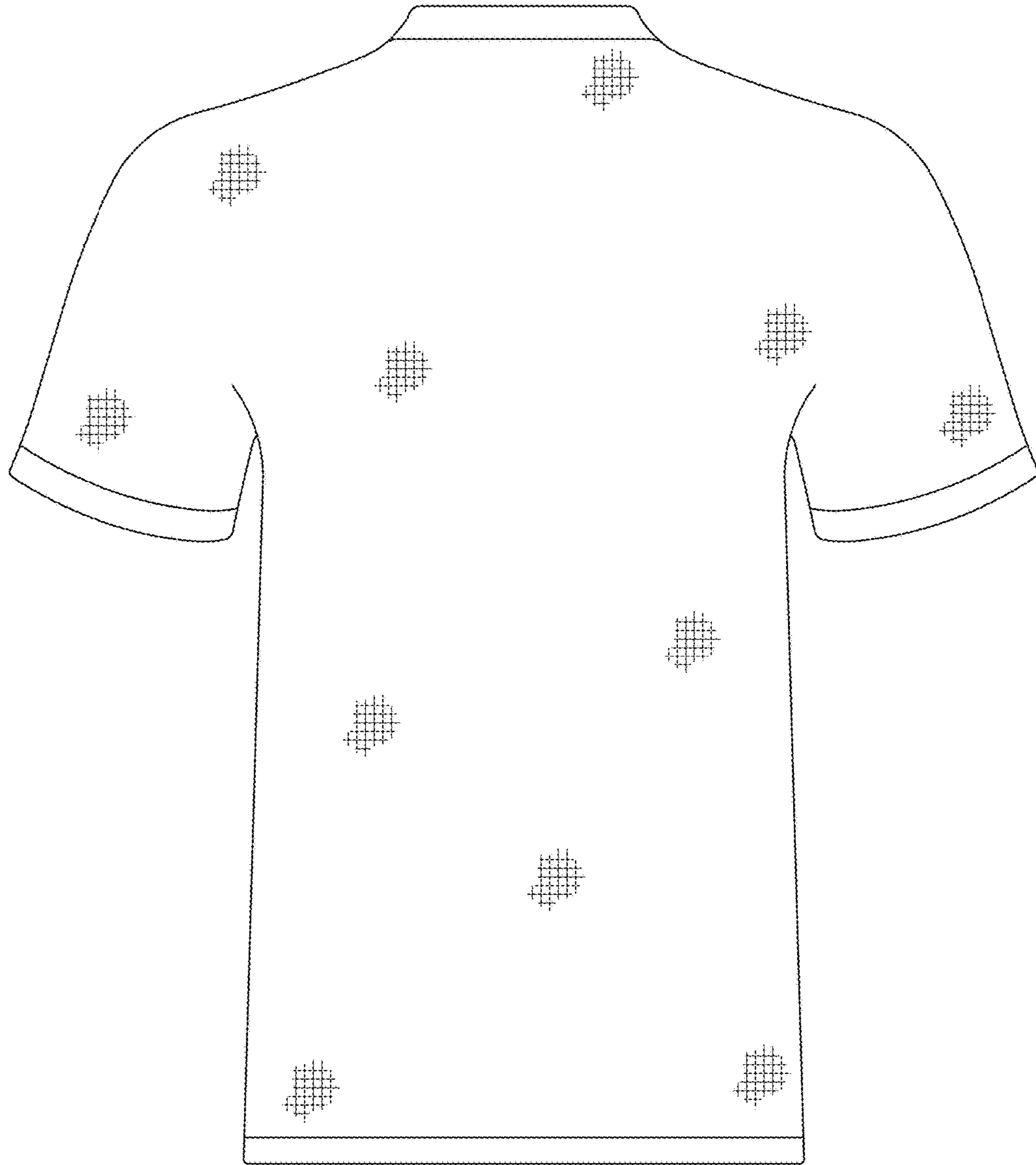

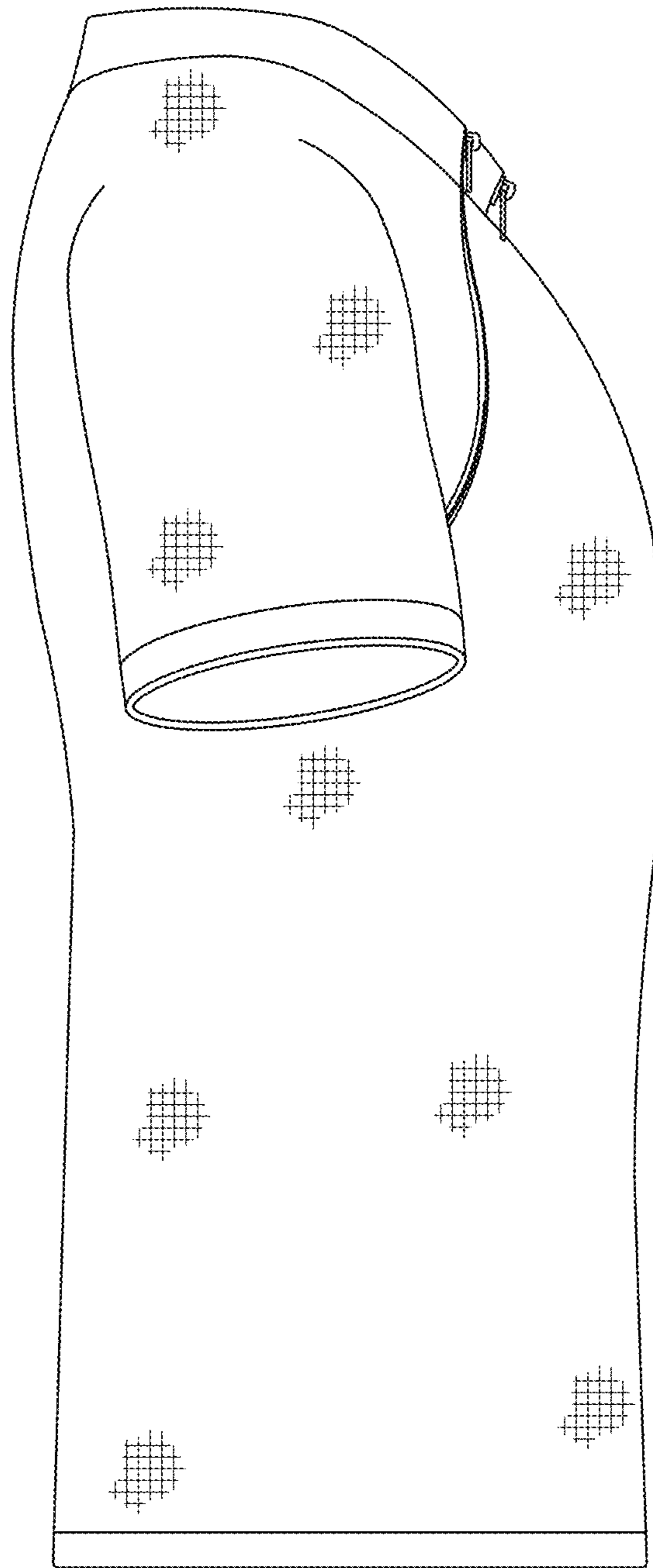
