DESCRIPTION

FIG. 1 is a perspective view of the body apparel;

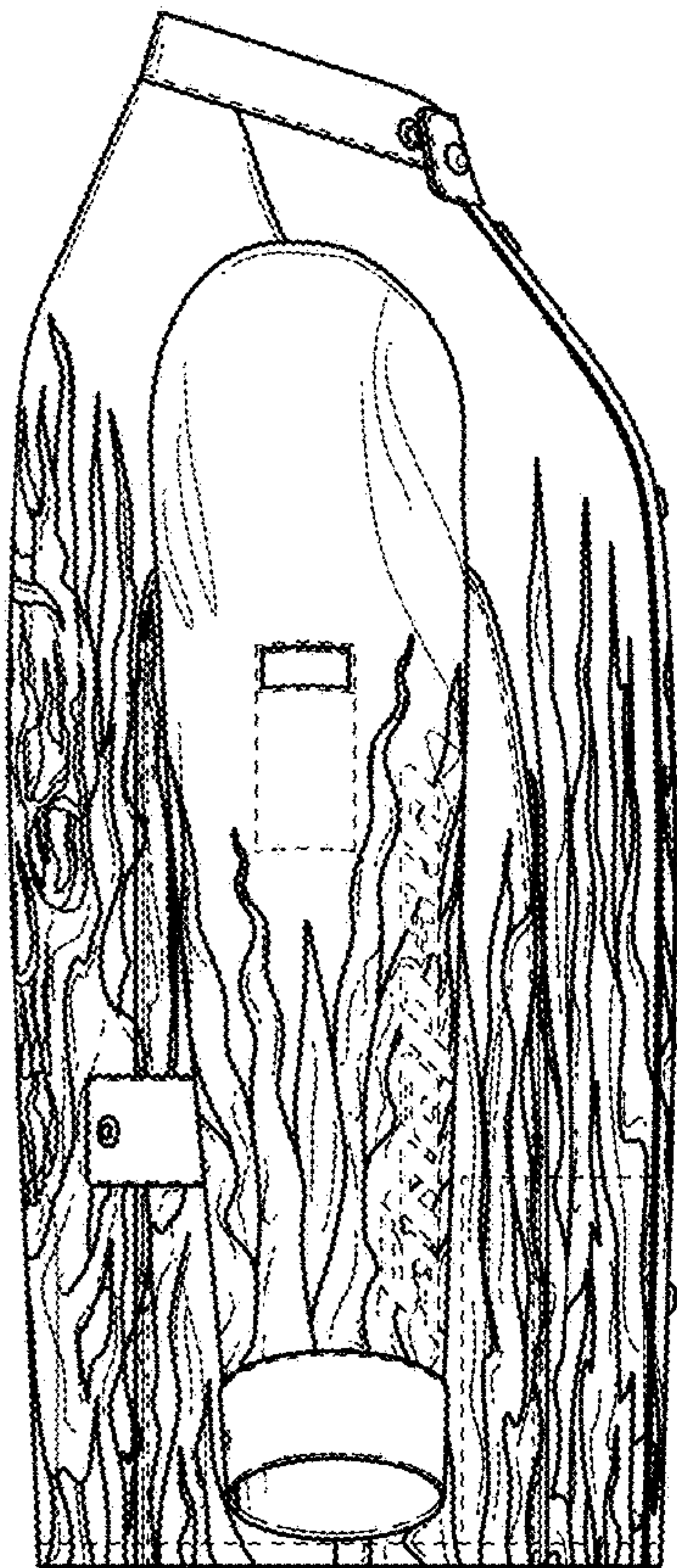

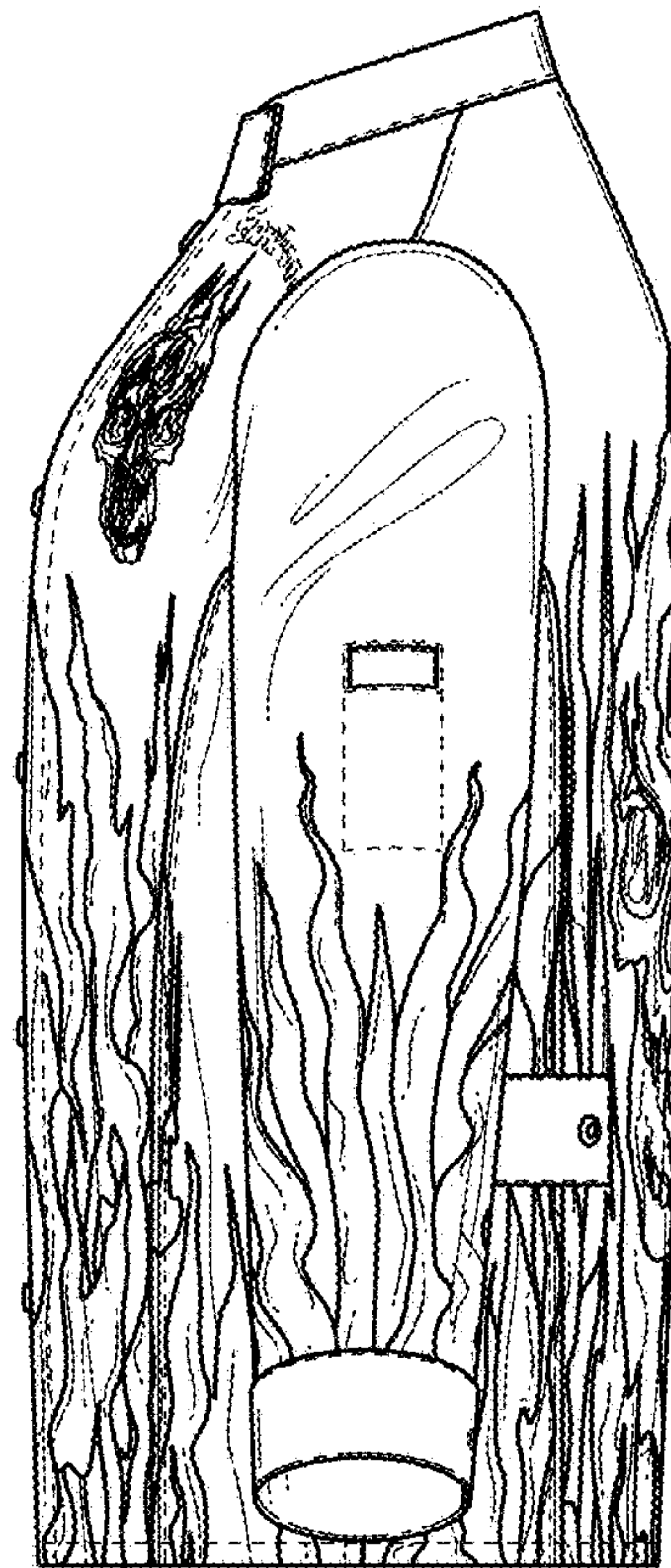

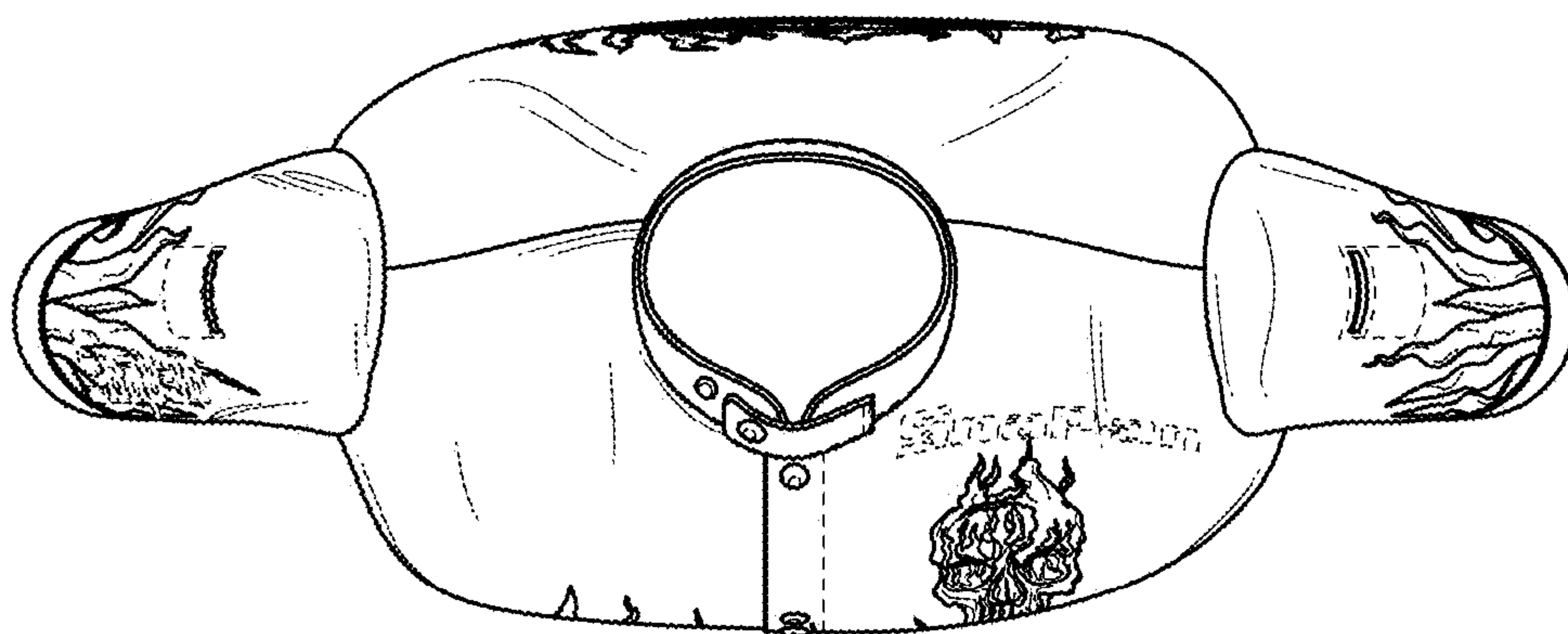

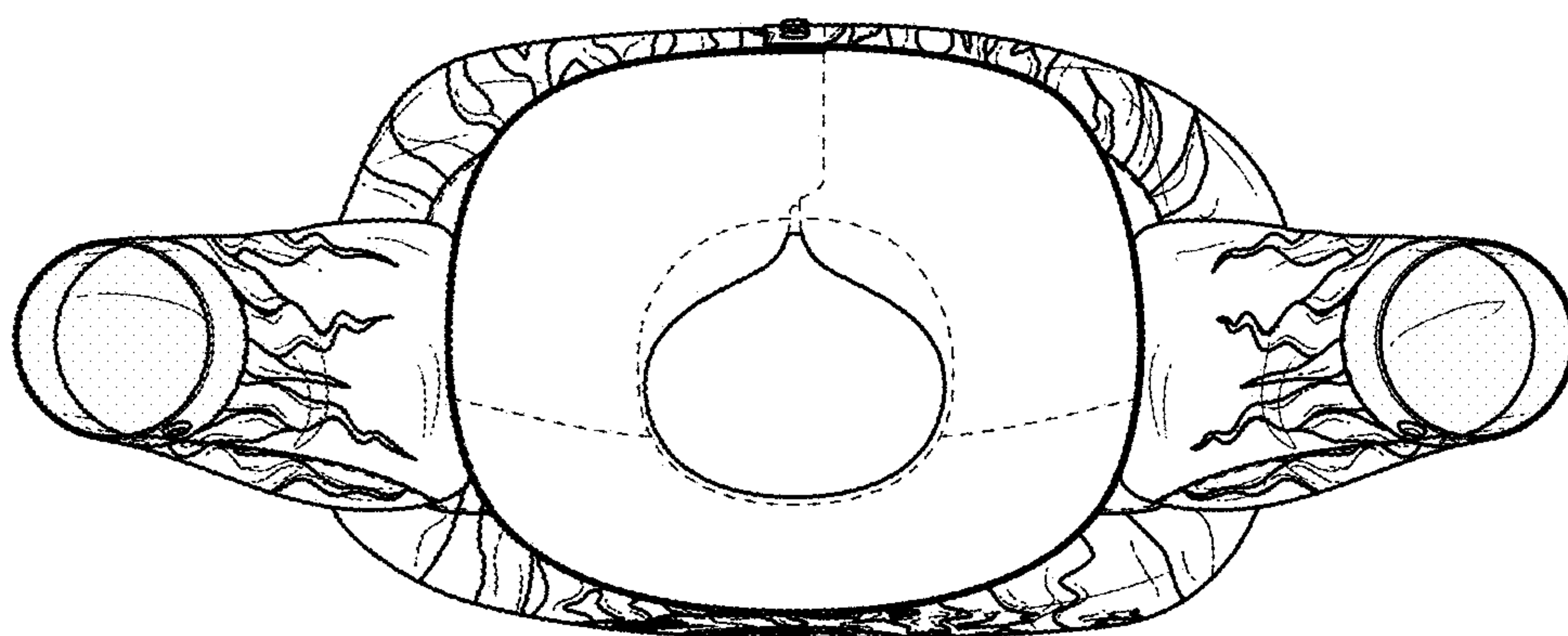
