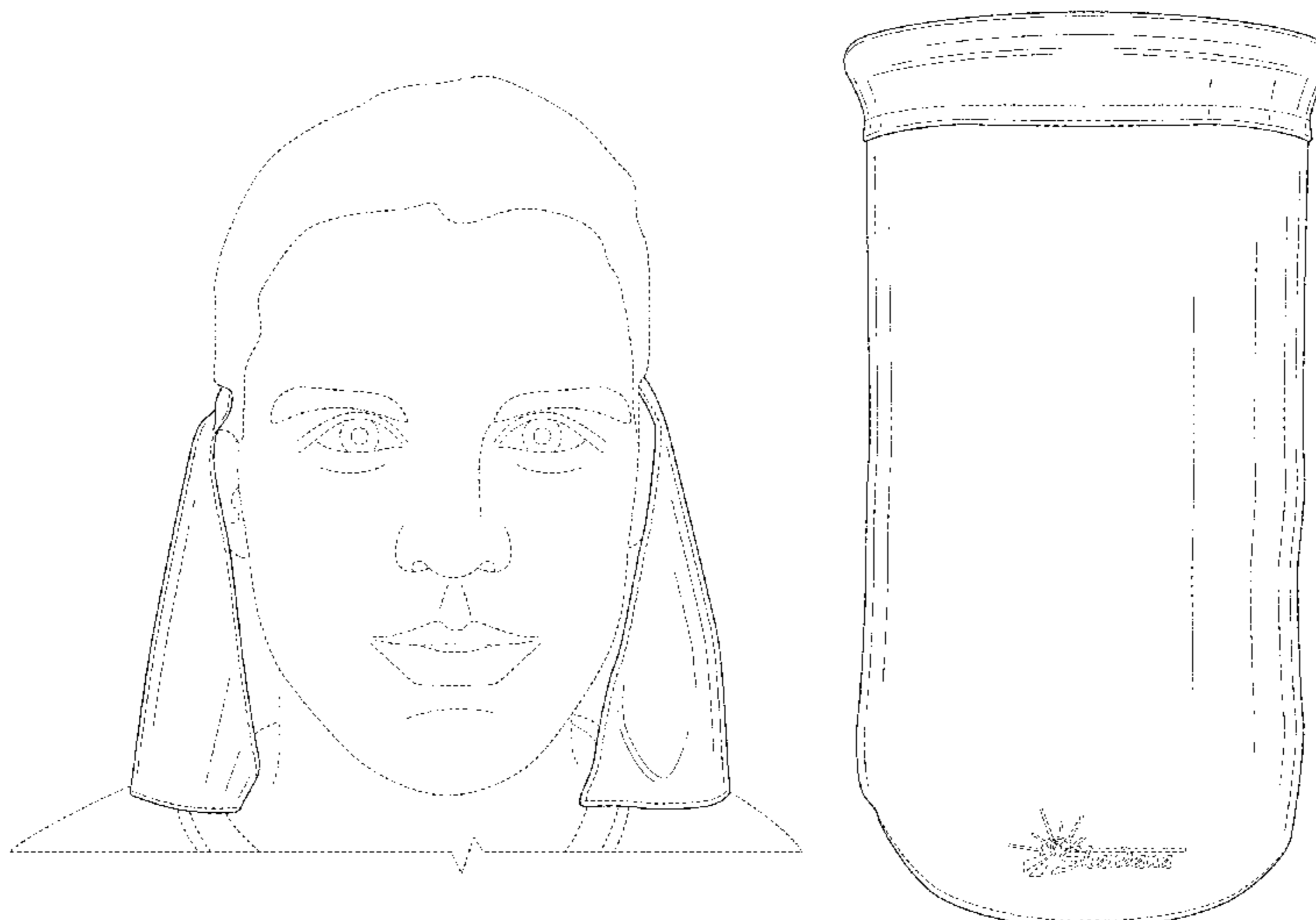
(57) **CLAIM**

I claim the ornamental design for a neck sun shield headwear accessory, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevation view of the neck sun shield headwear accessory on a user's head;
FIG. 2 is a rear elevation view of the neck sun shield headwear accessory on the user's head;
FIG. 3 is a right side elevation view of the neck sun shield headwear accessory on the user's head;
FIG. 4 is a front perspective view of the neck sun shield headwear accessory;

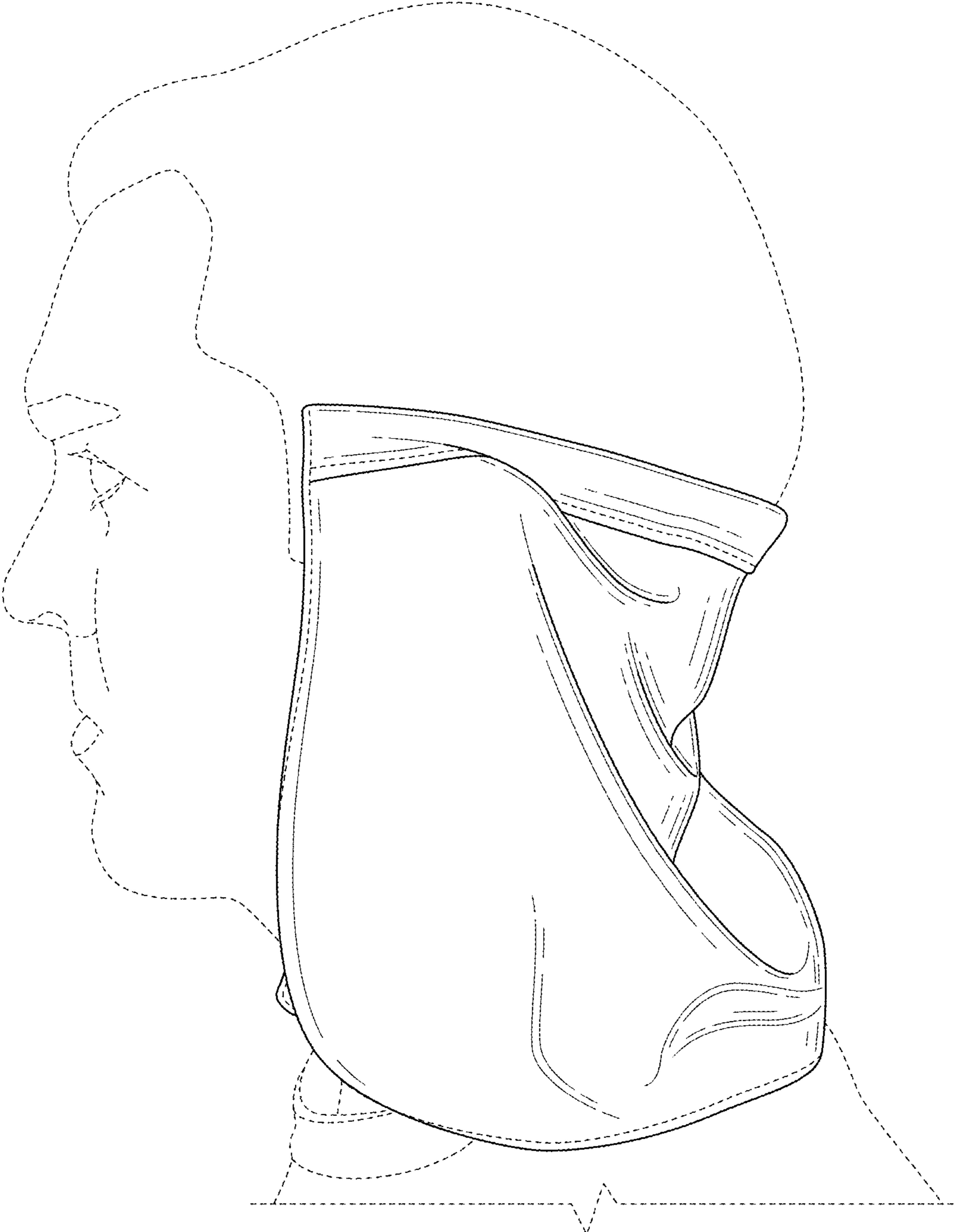

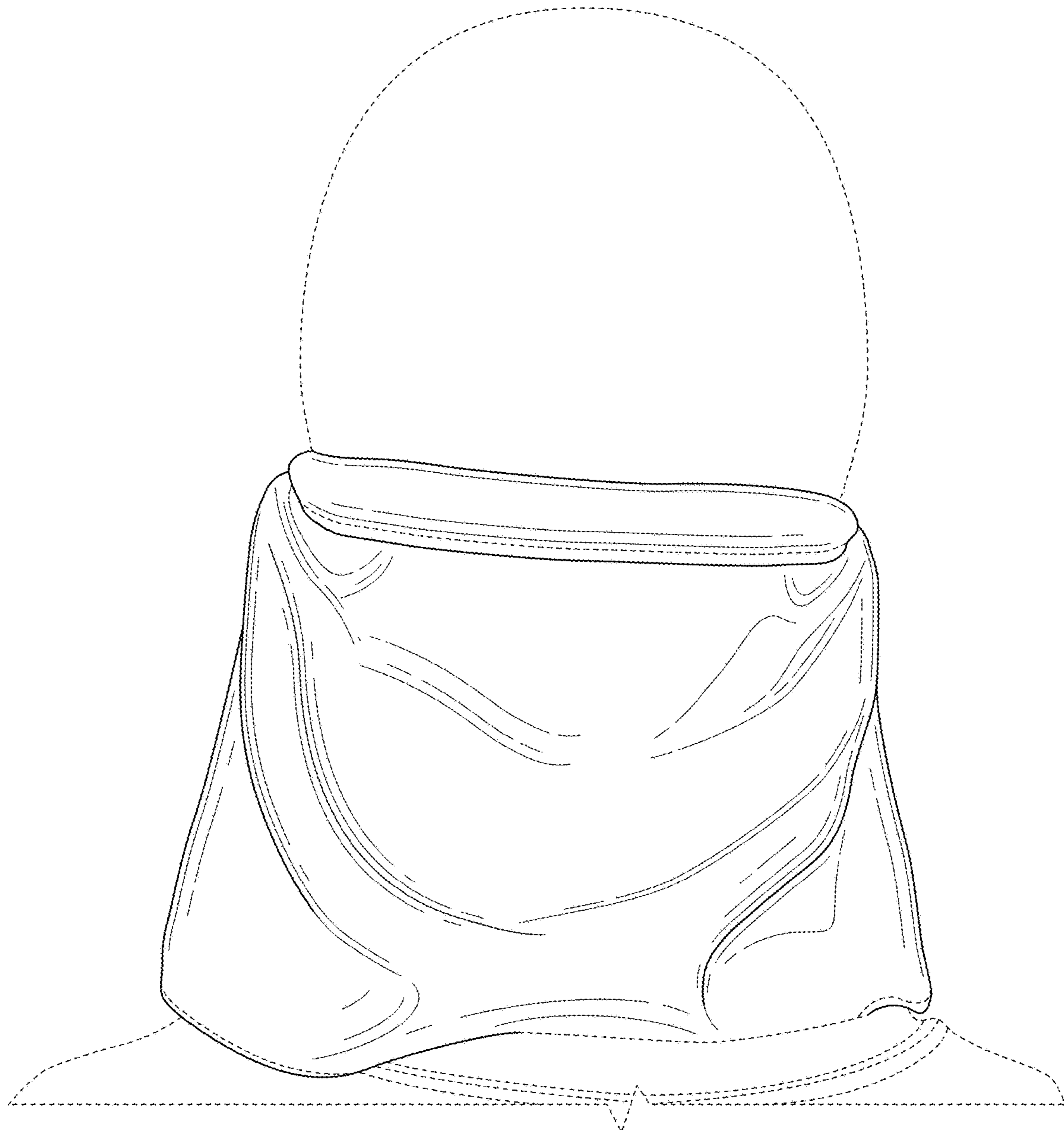

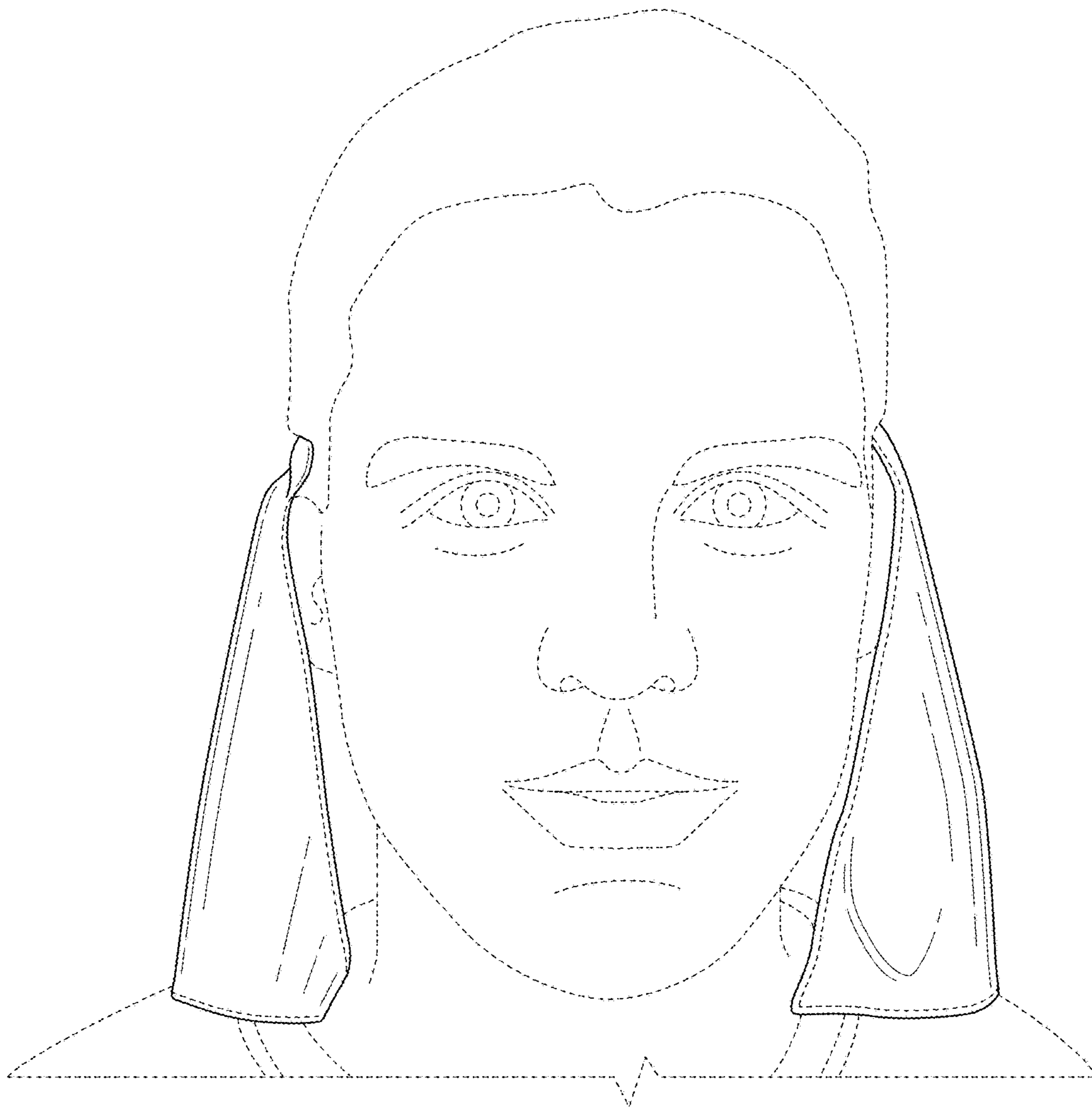

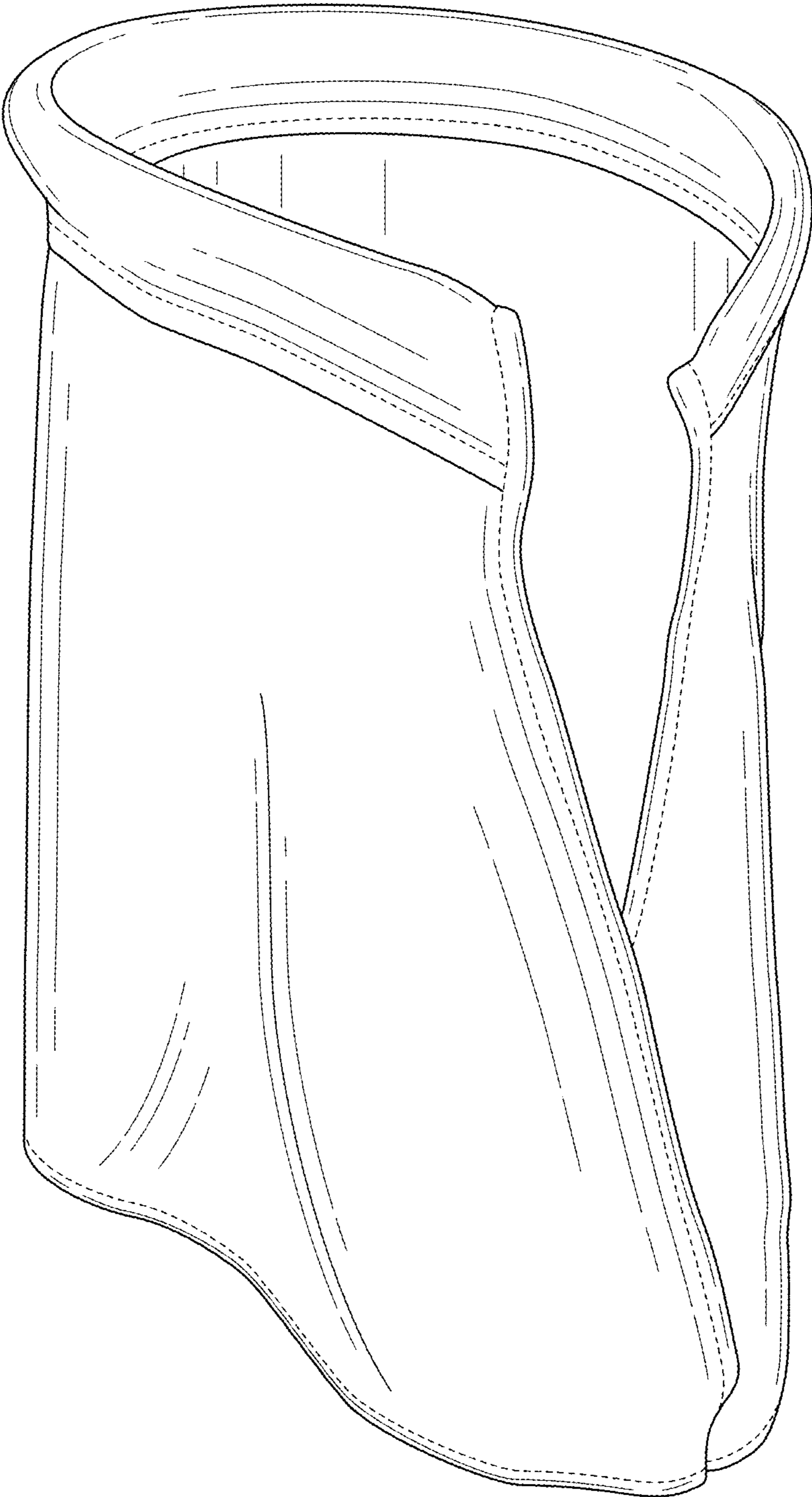

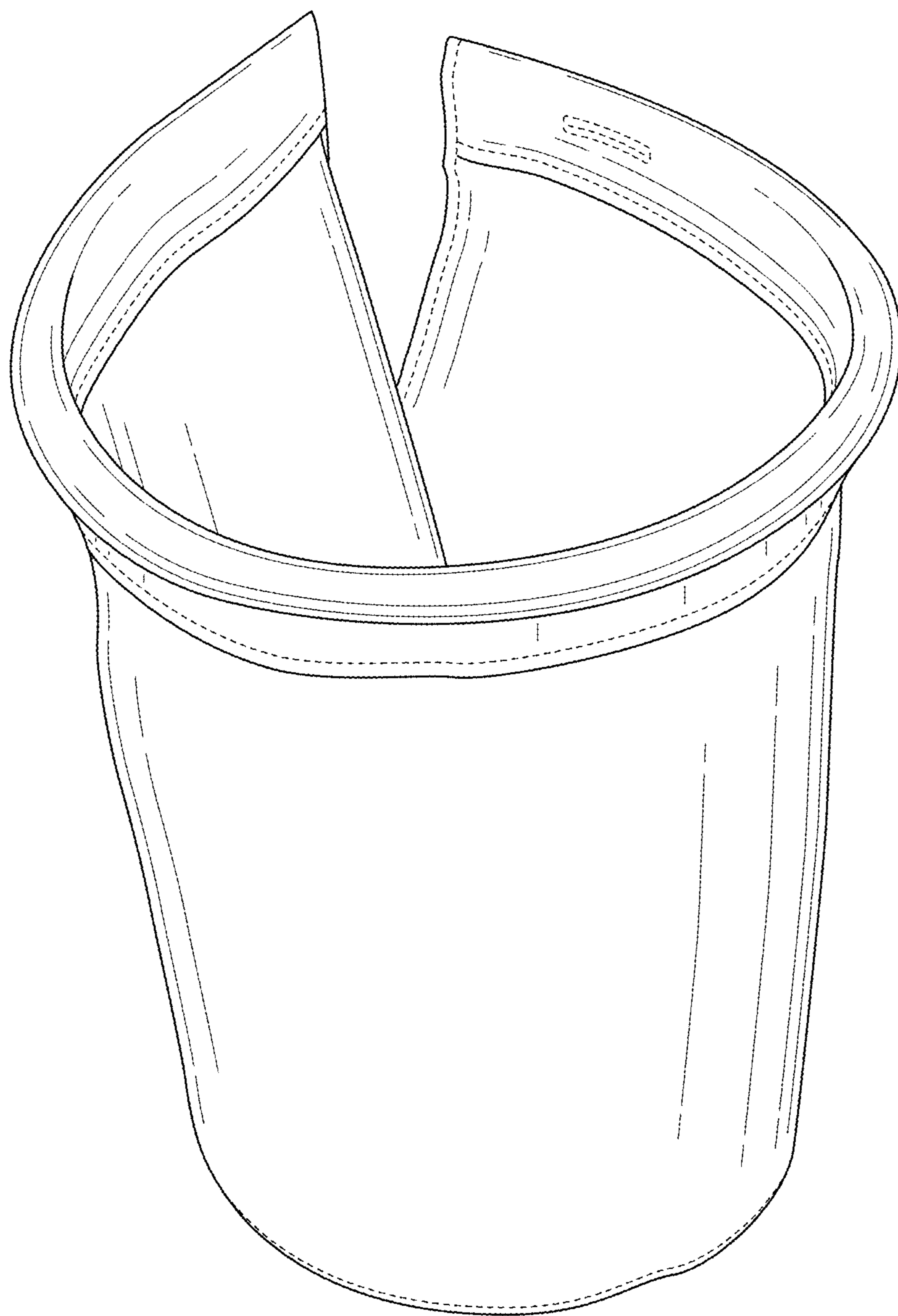

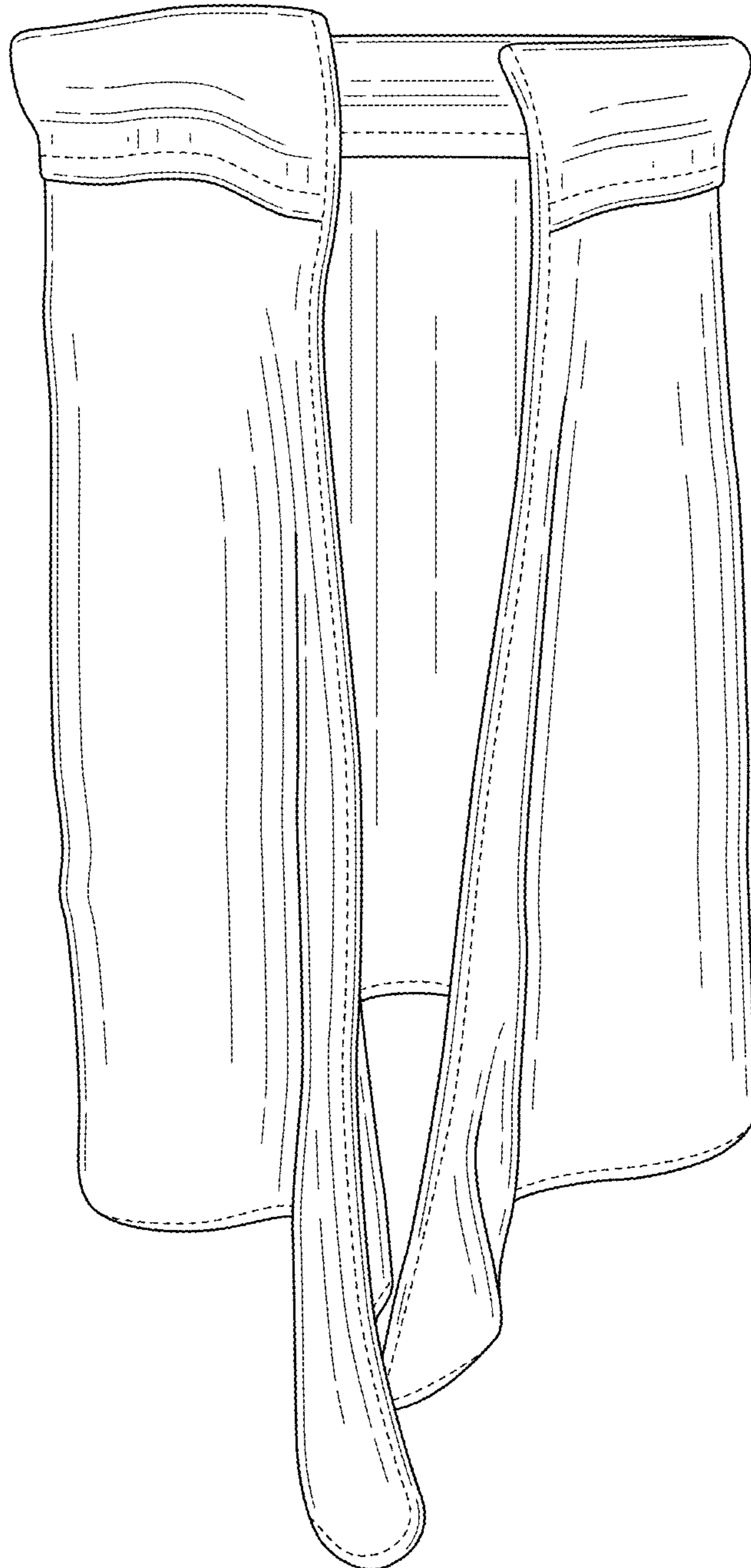

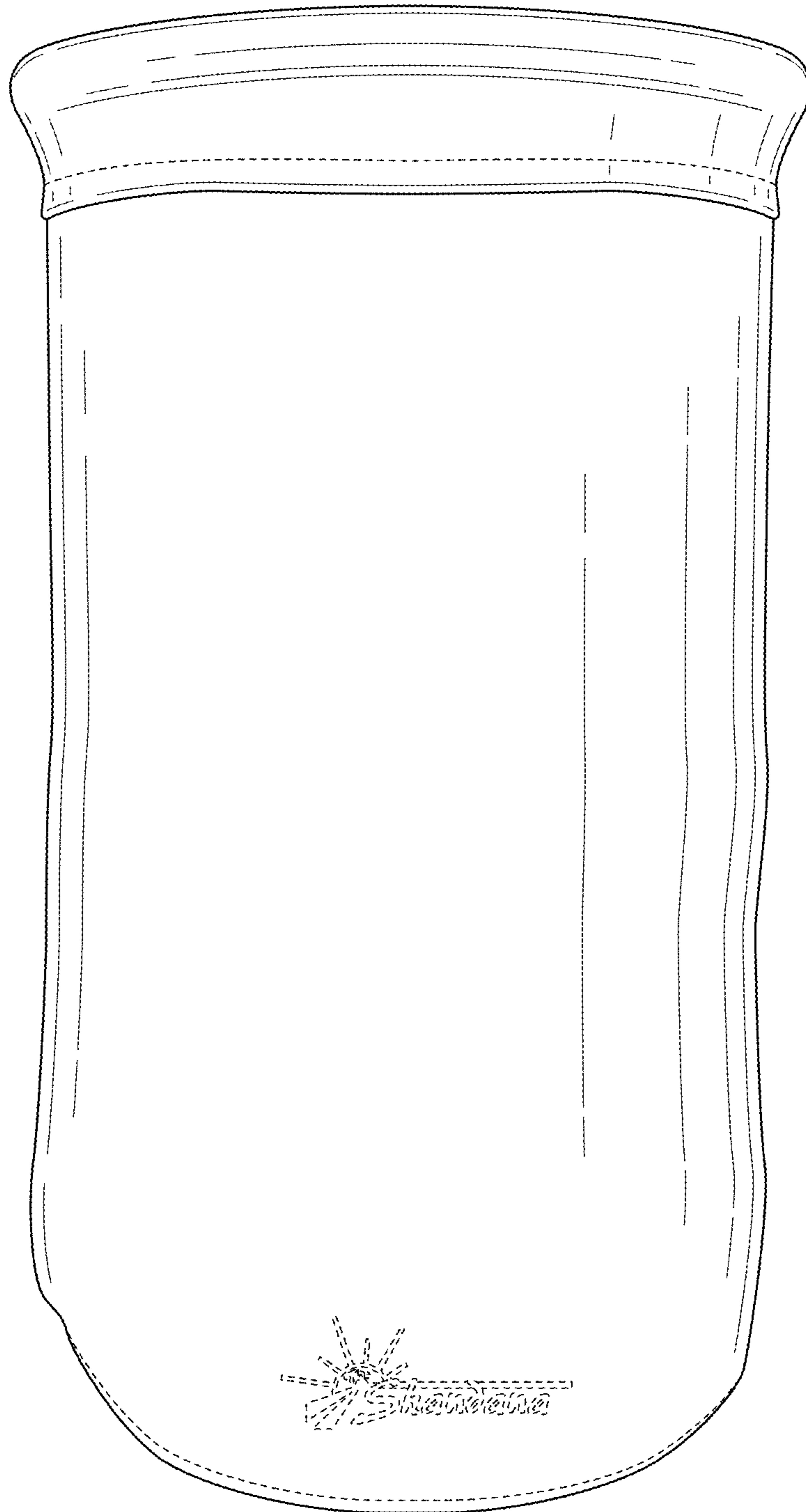

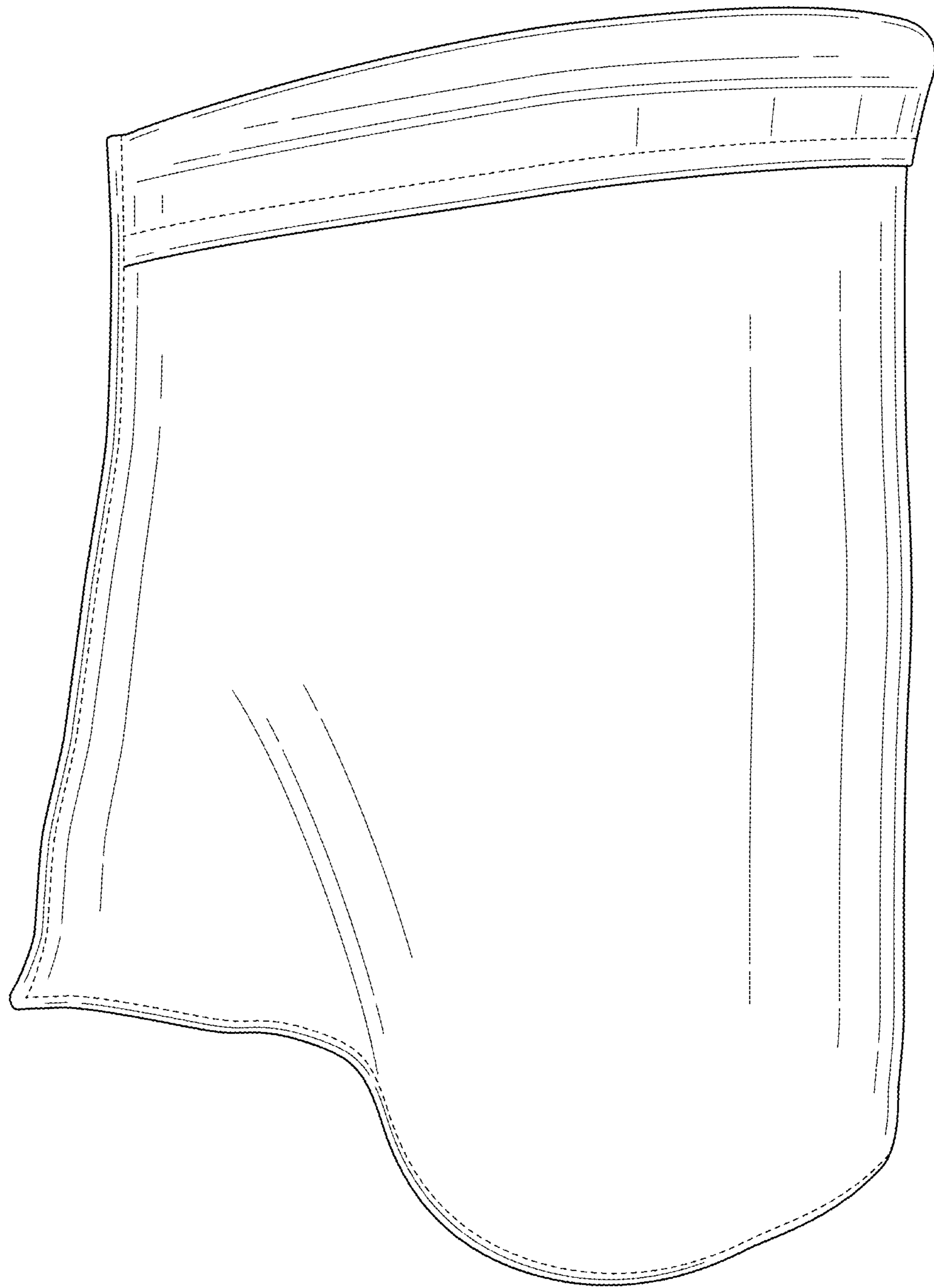

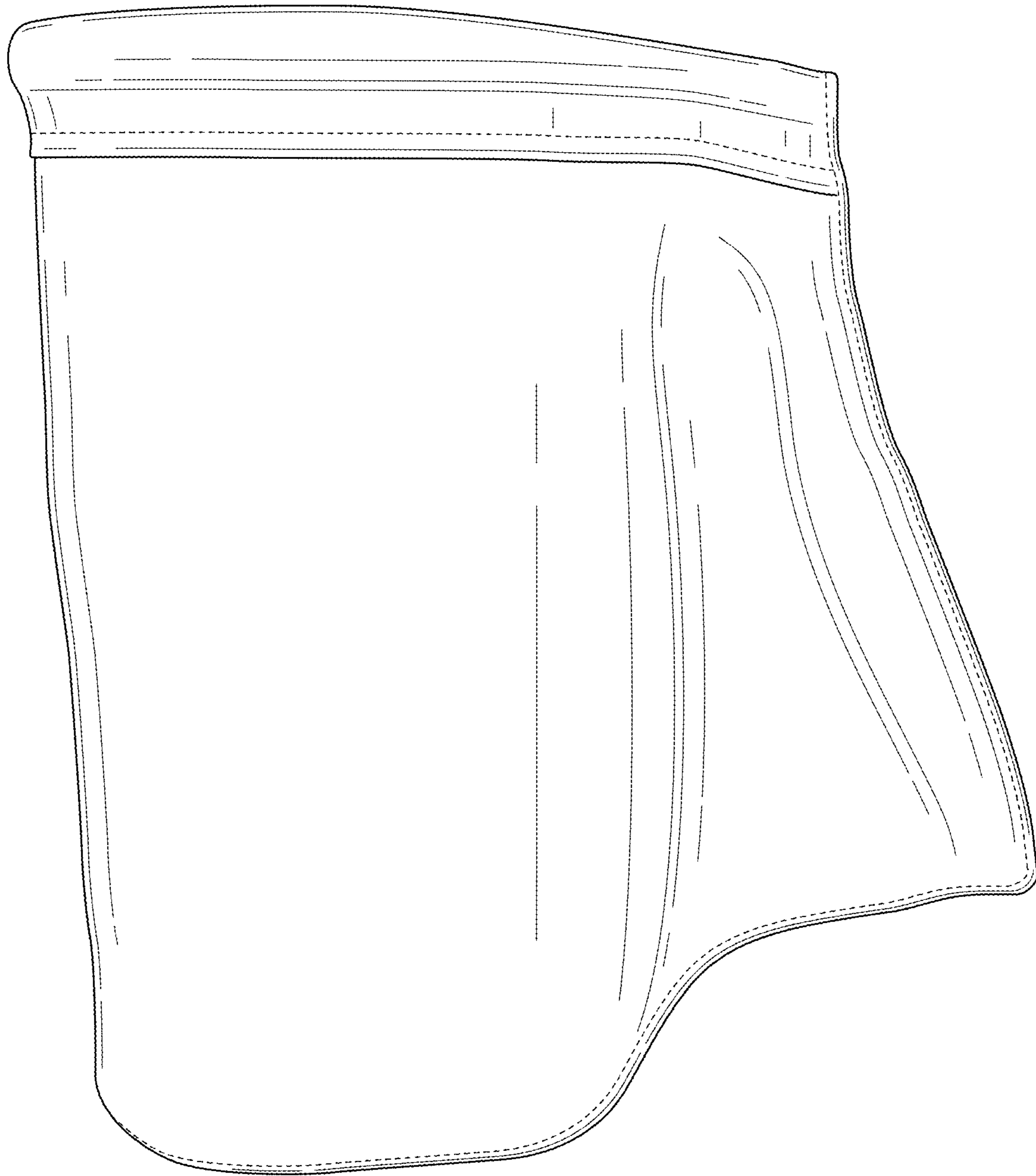

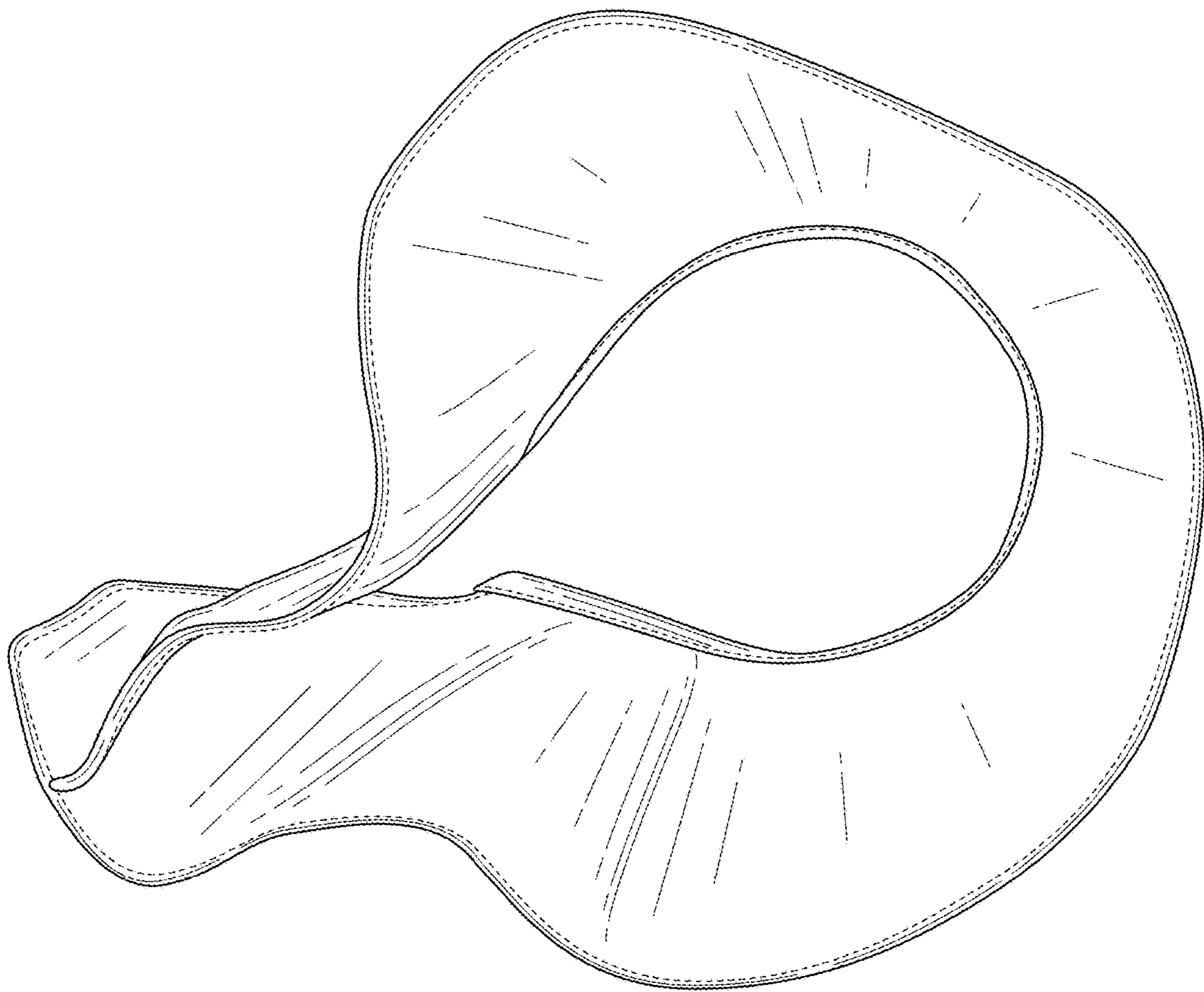

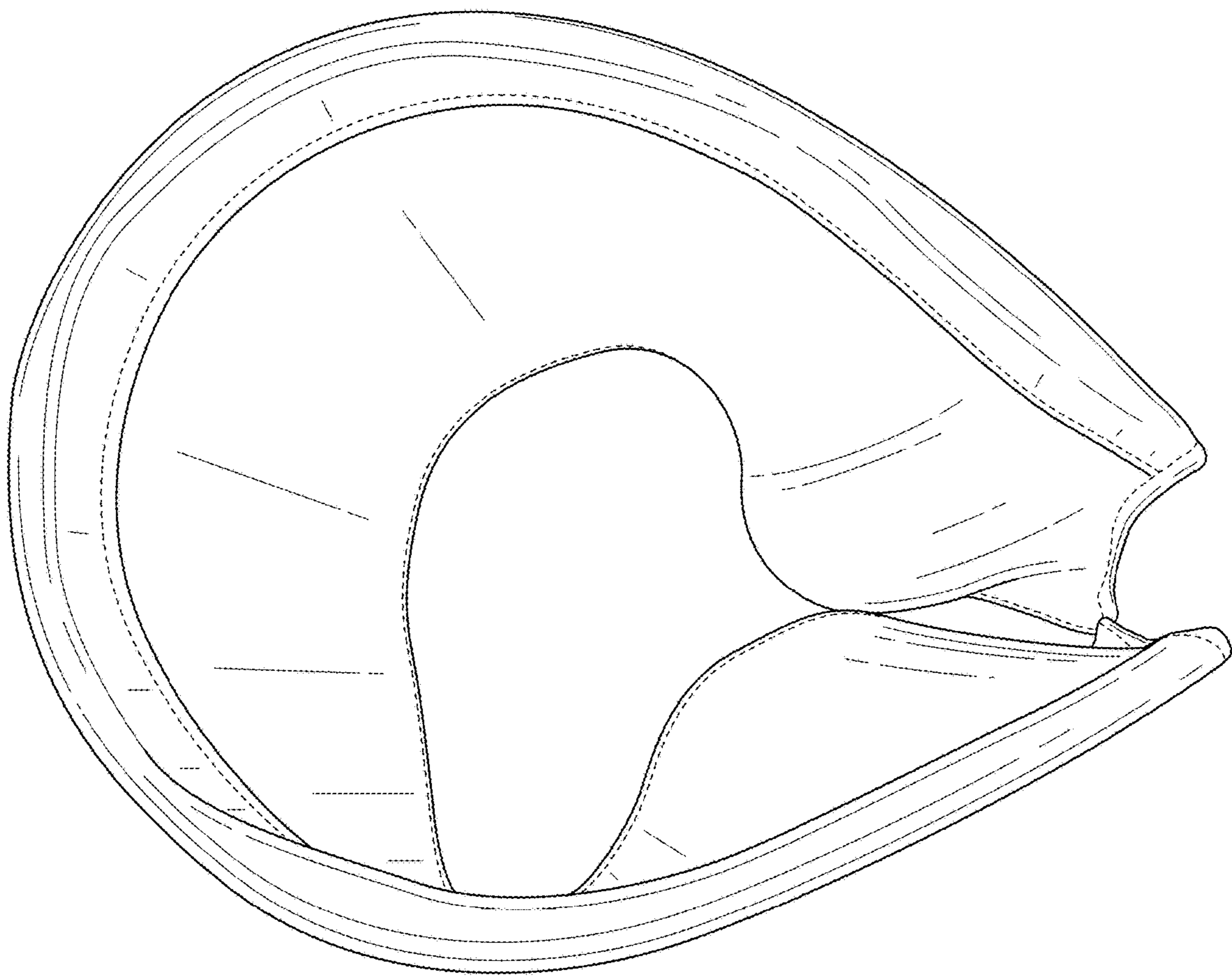
