(57) **CLAIM**

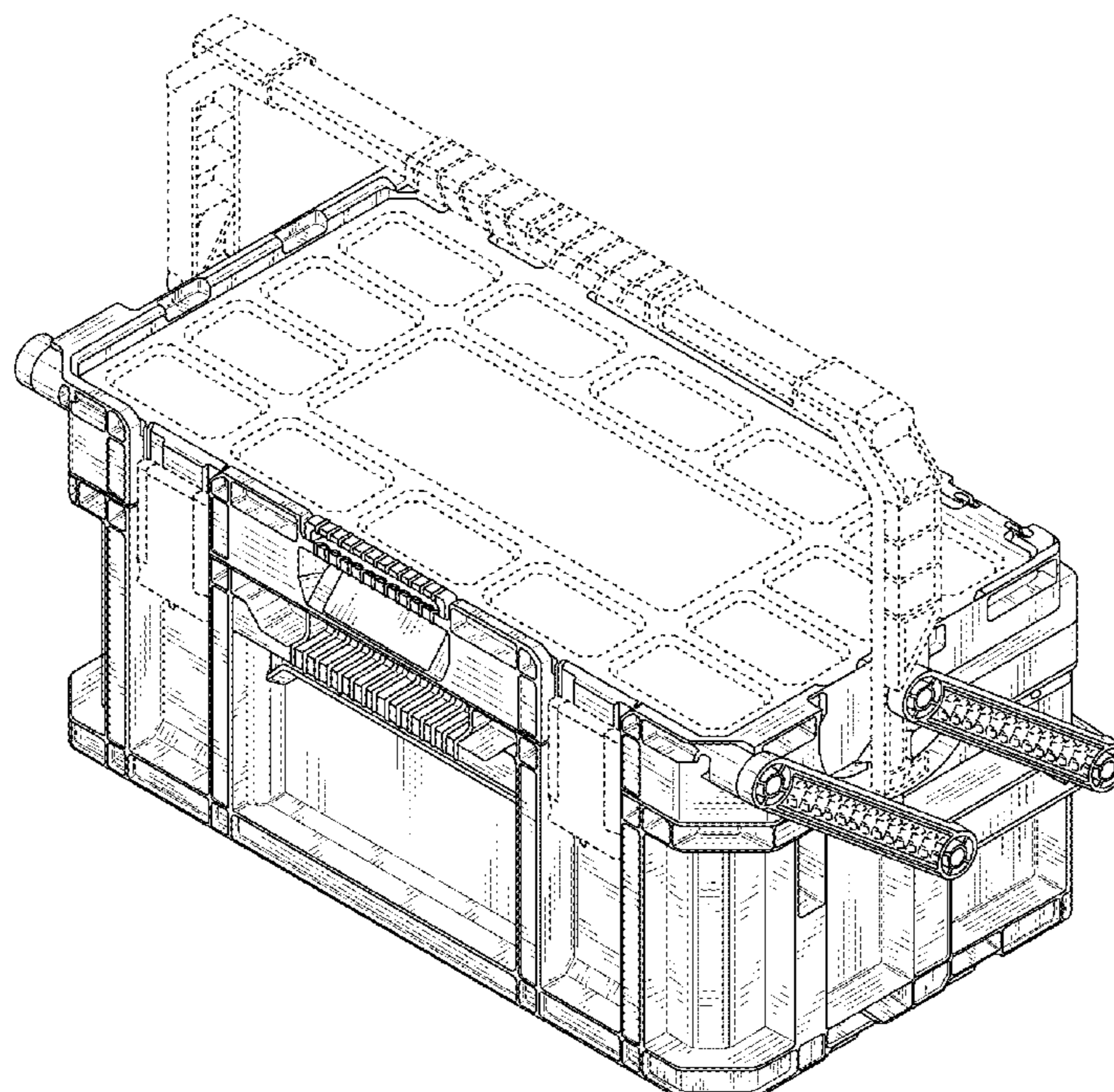
The ornamental design for a cantilever toolbox, as shown and described.

**DESCRIPTION**

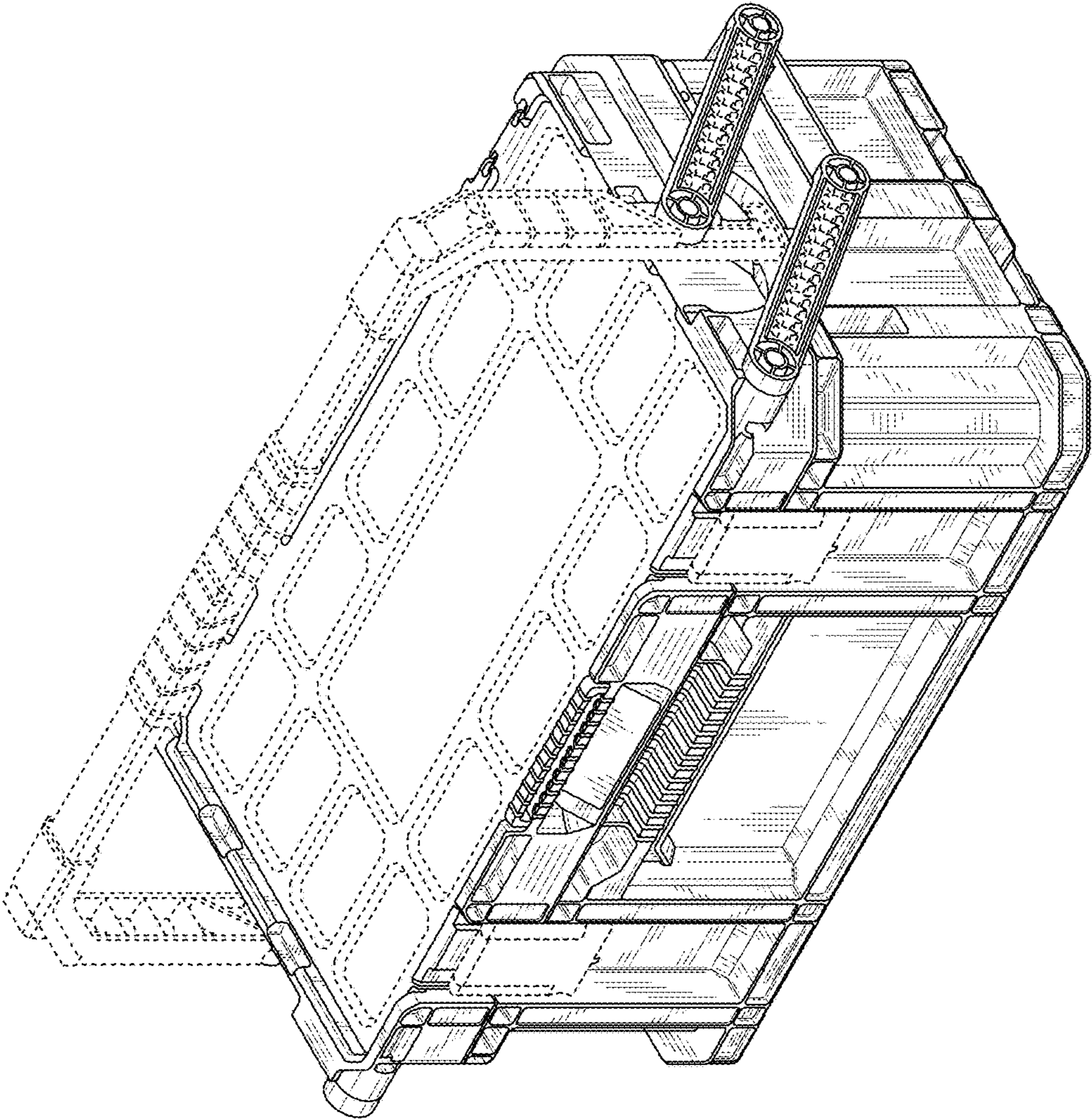

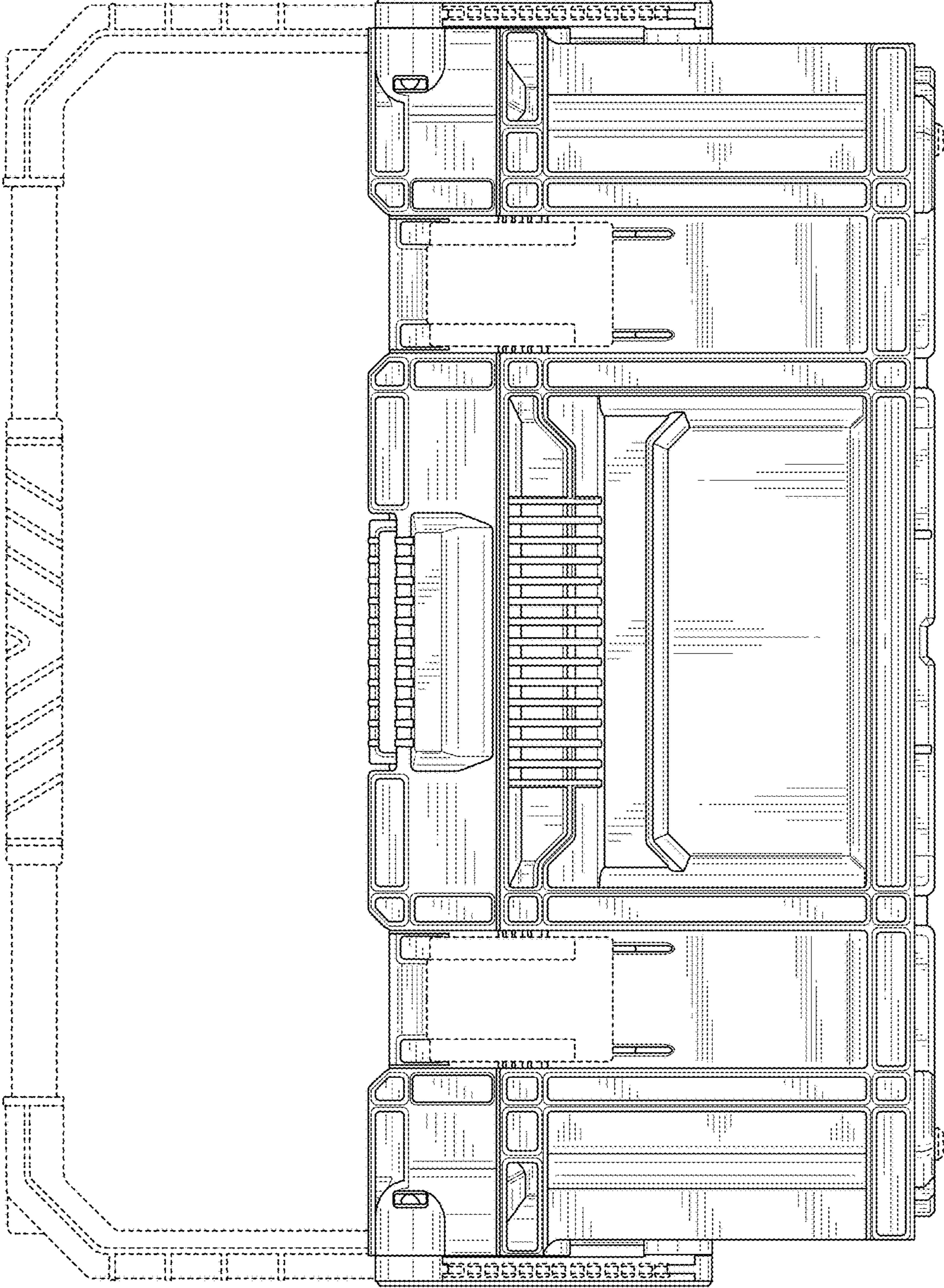

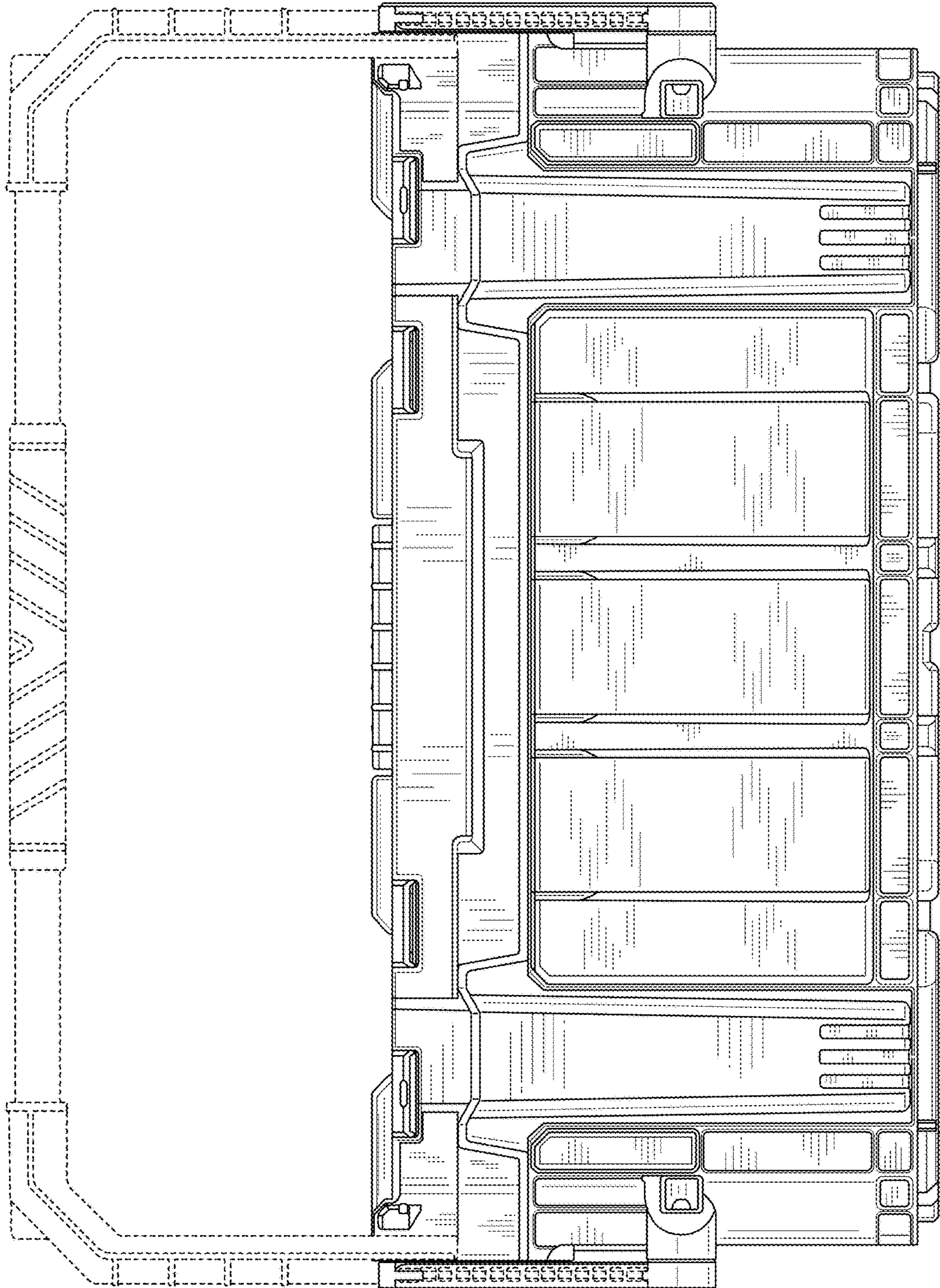

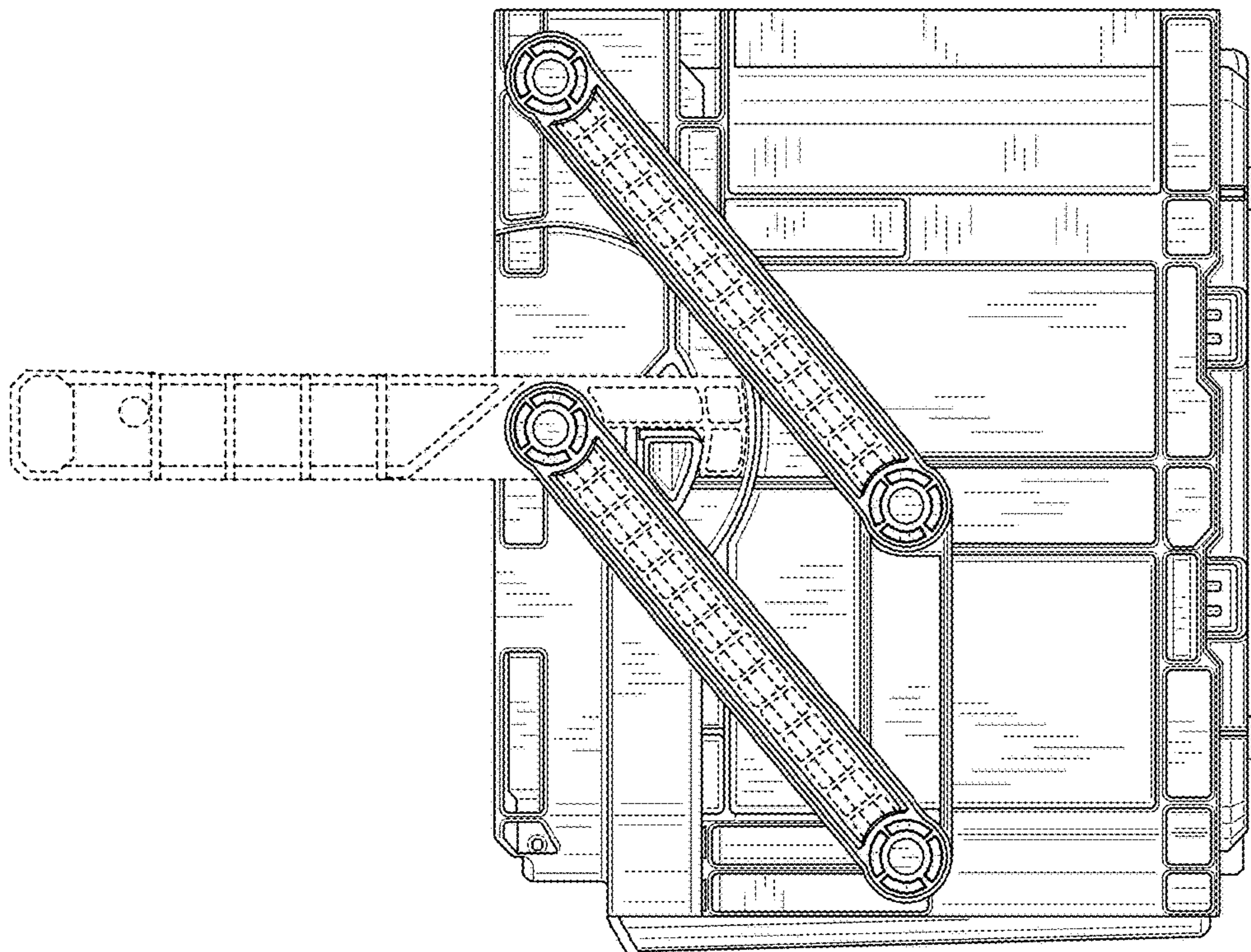

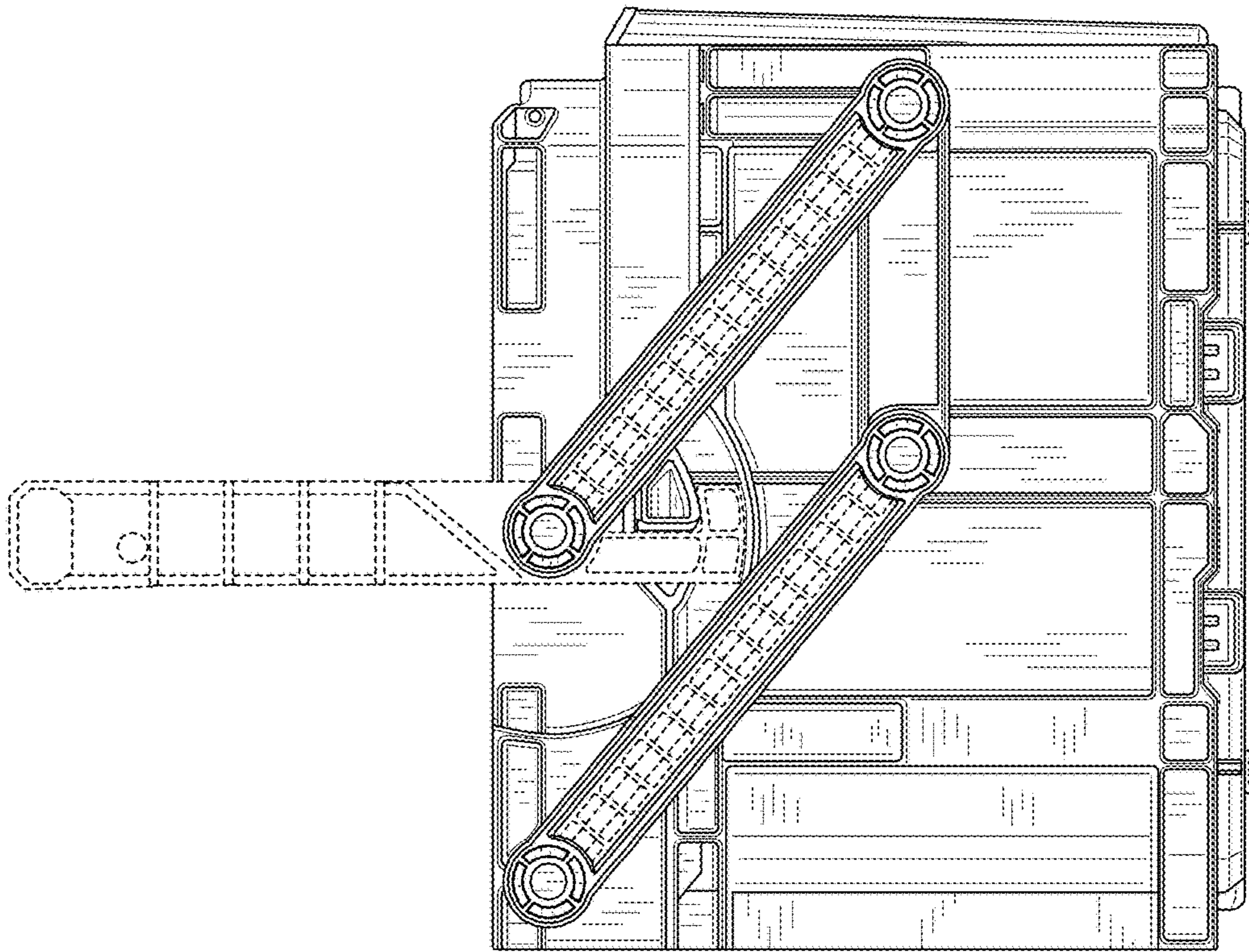

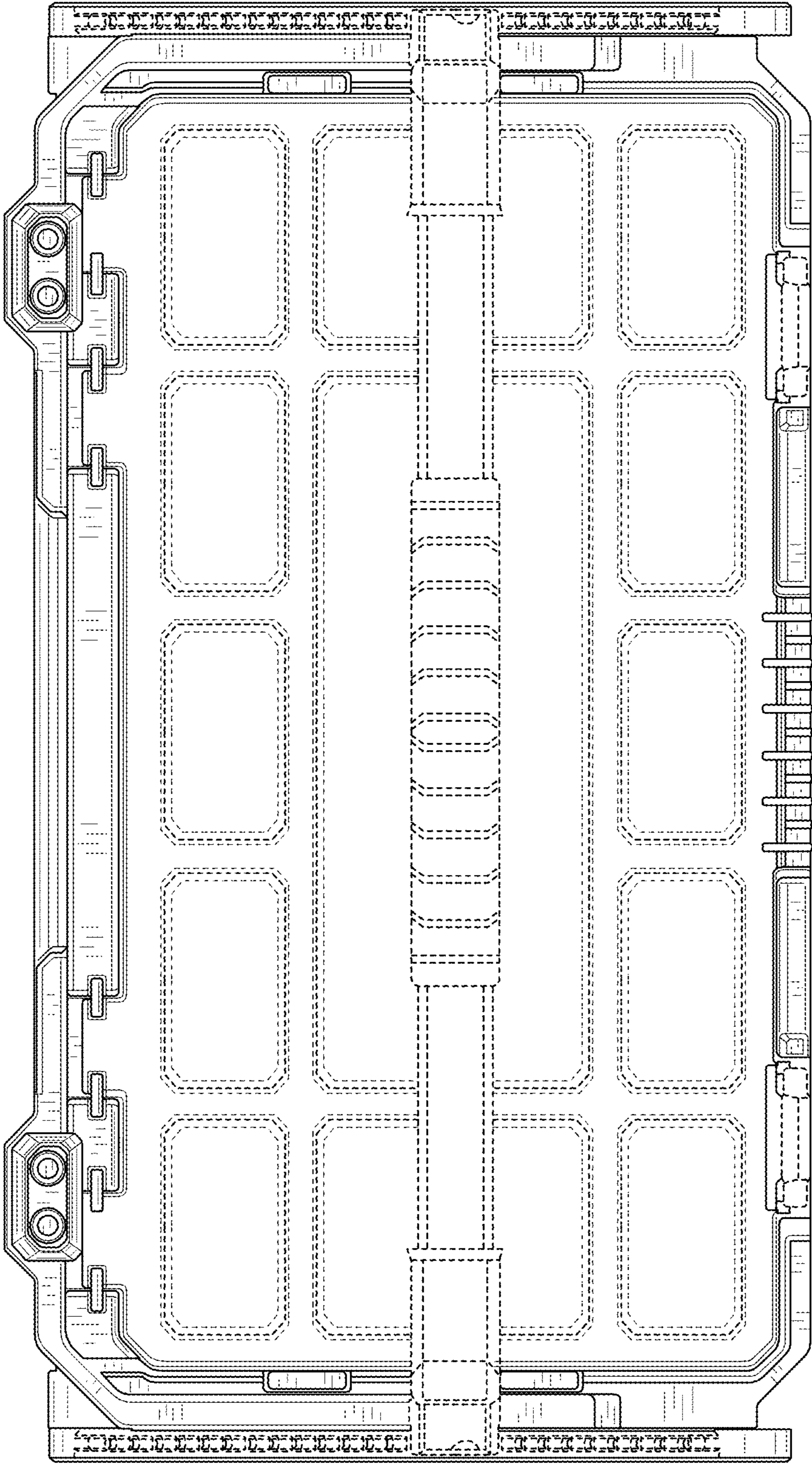

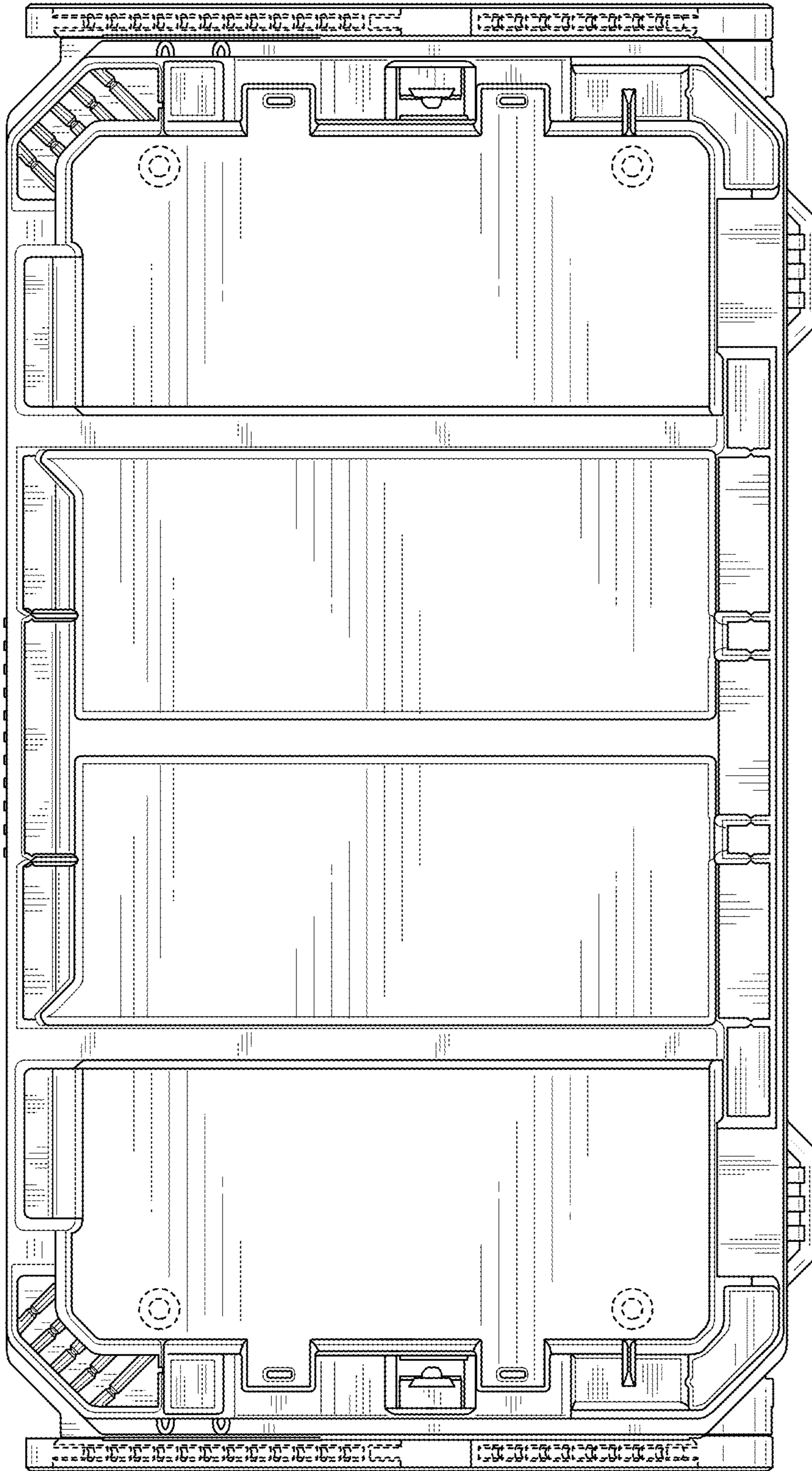

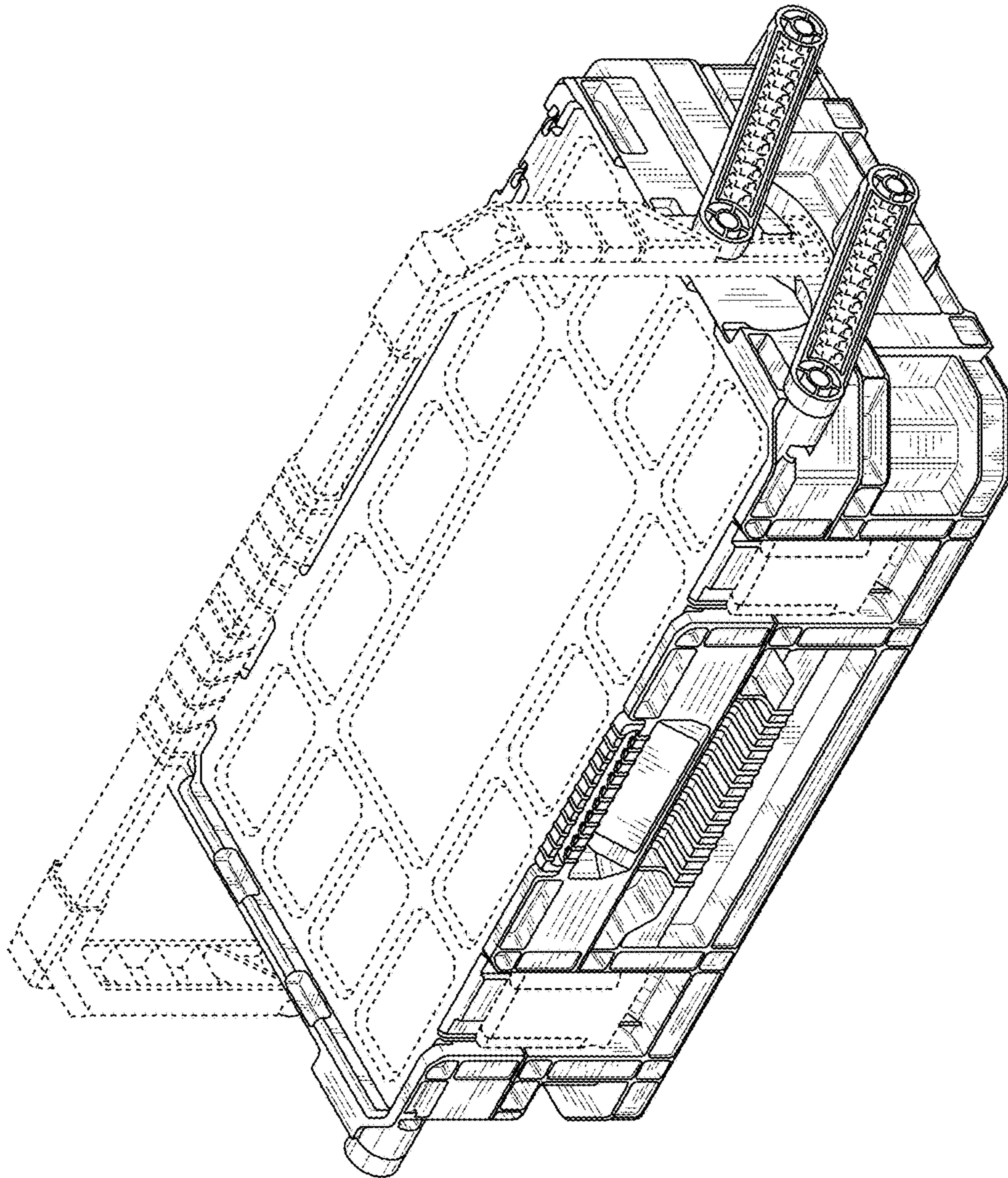

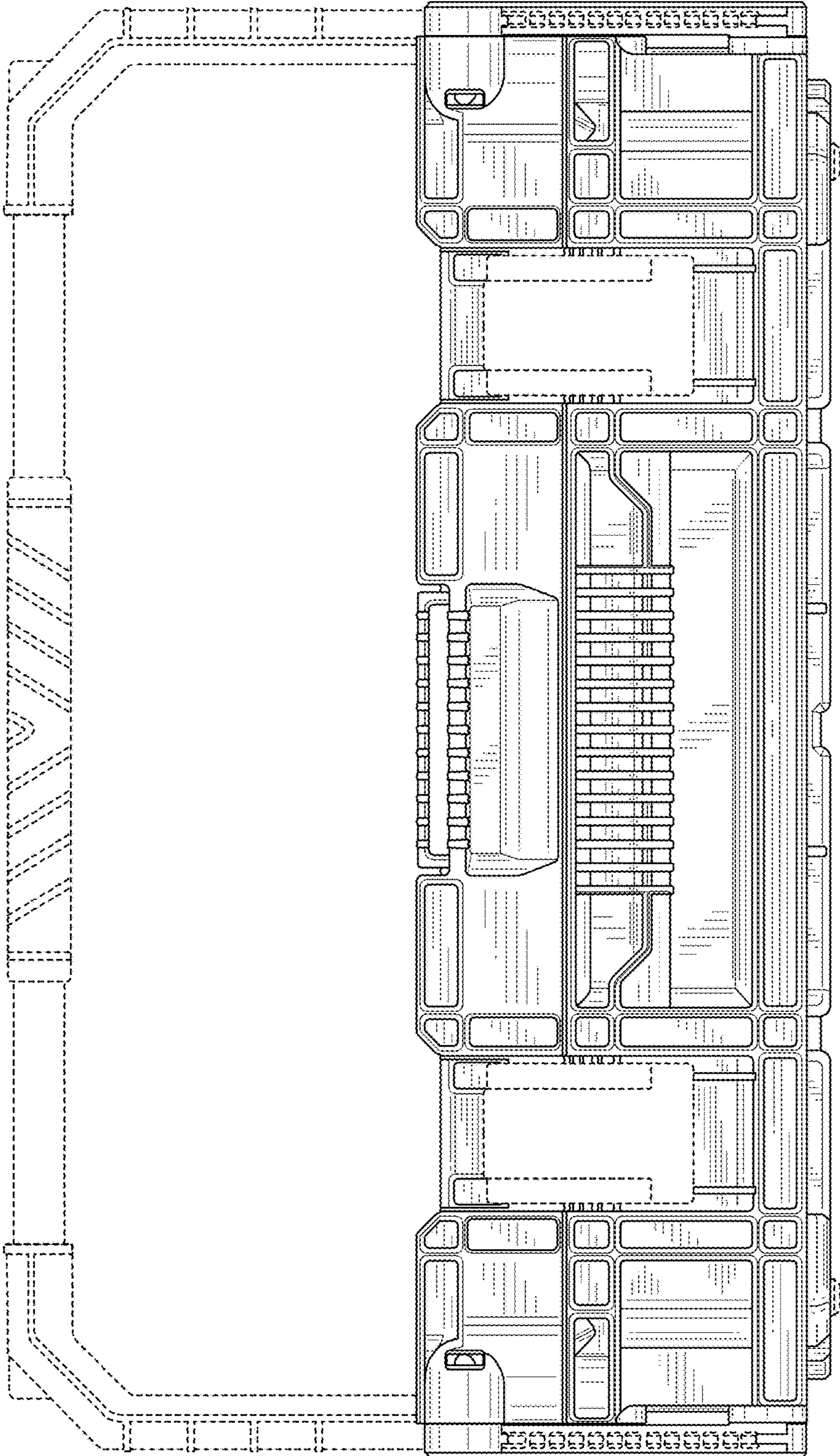

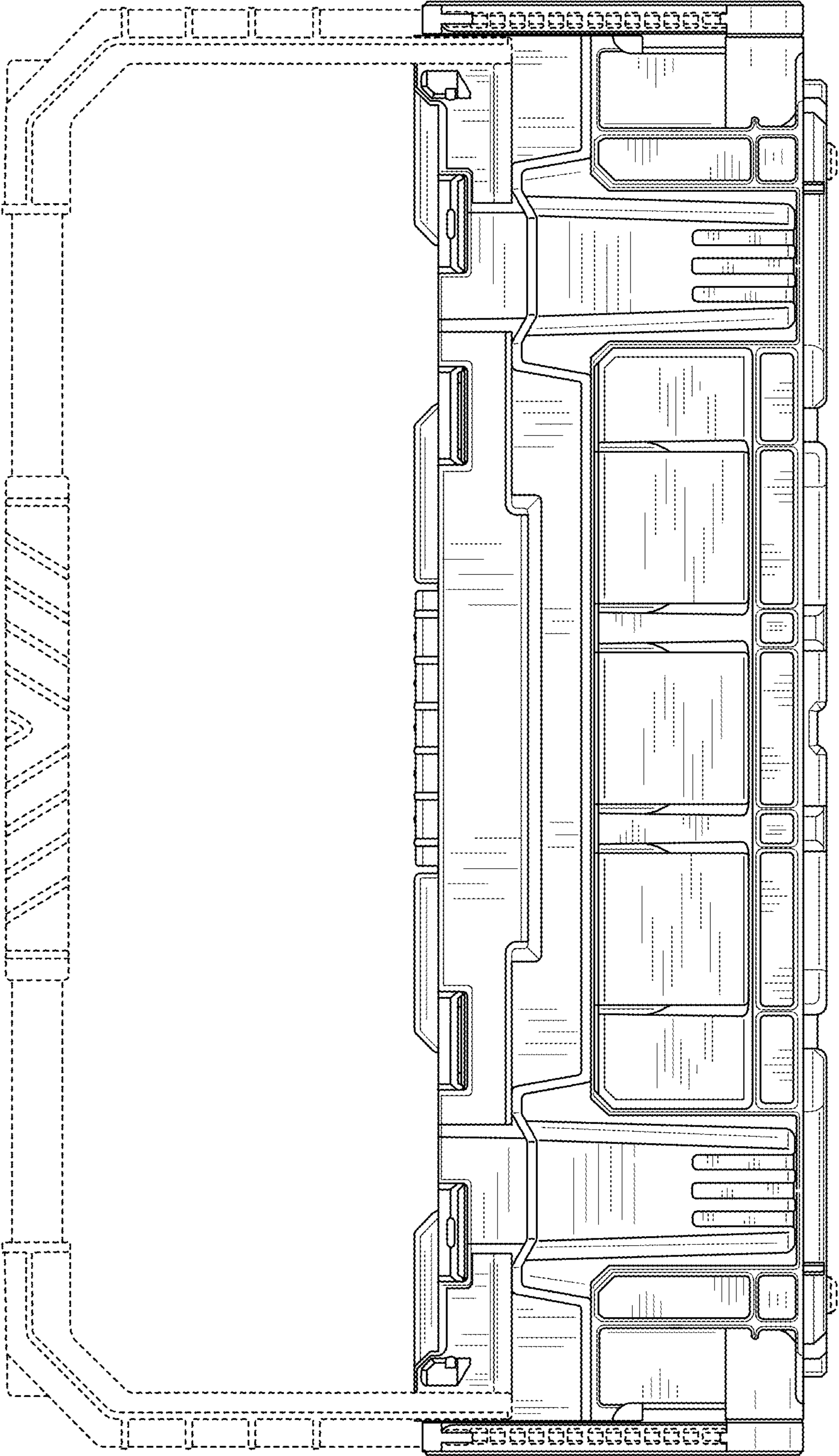

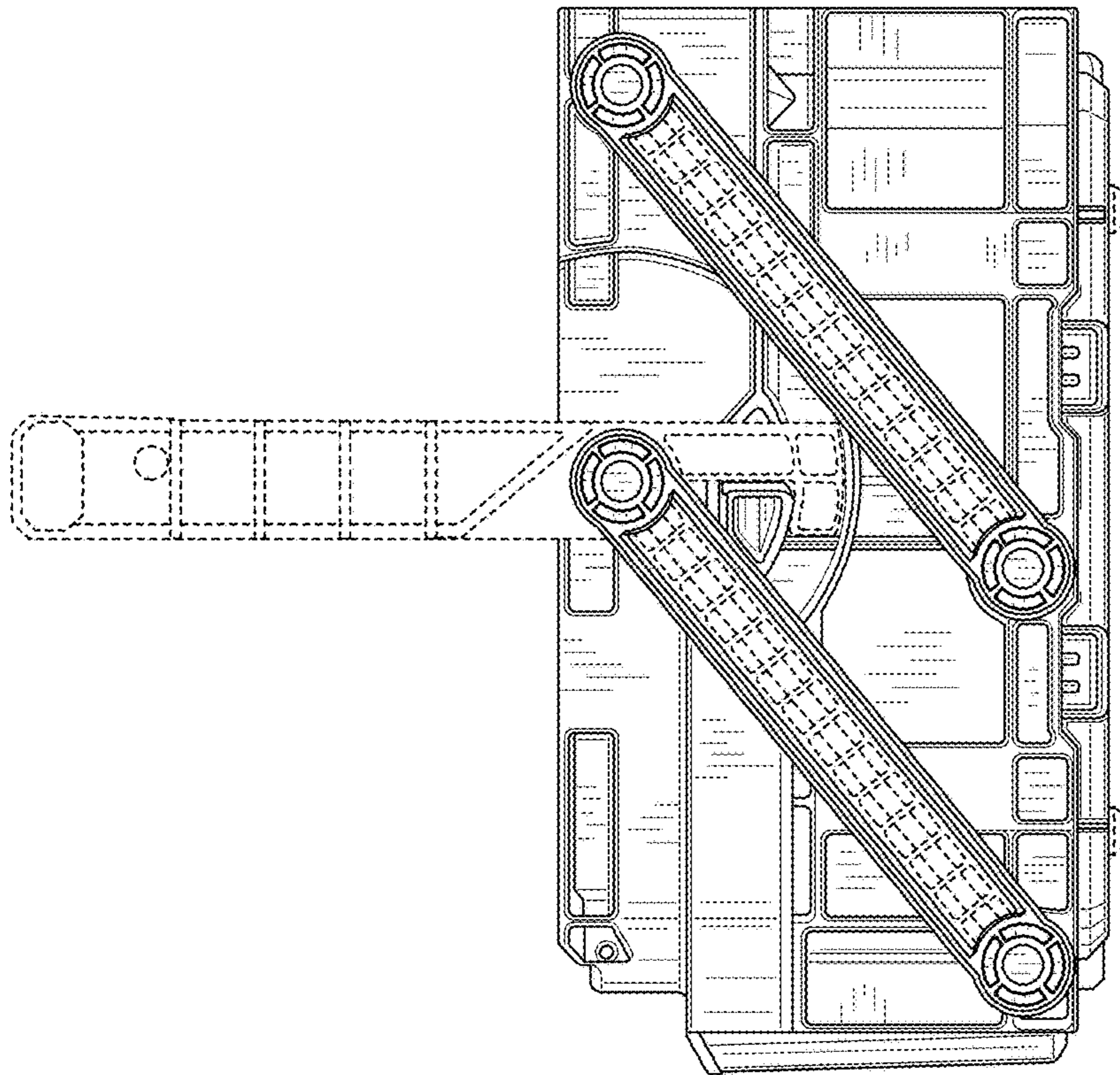

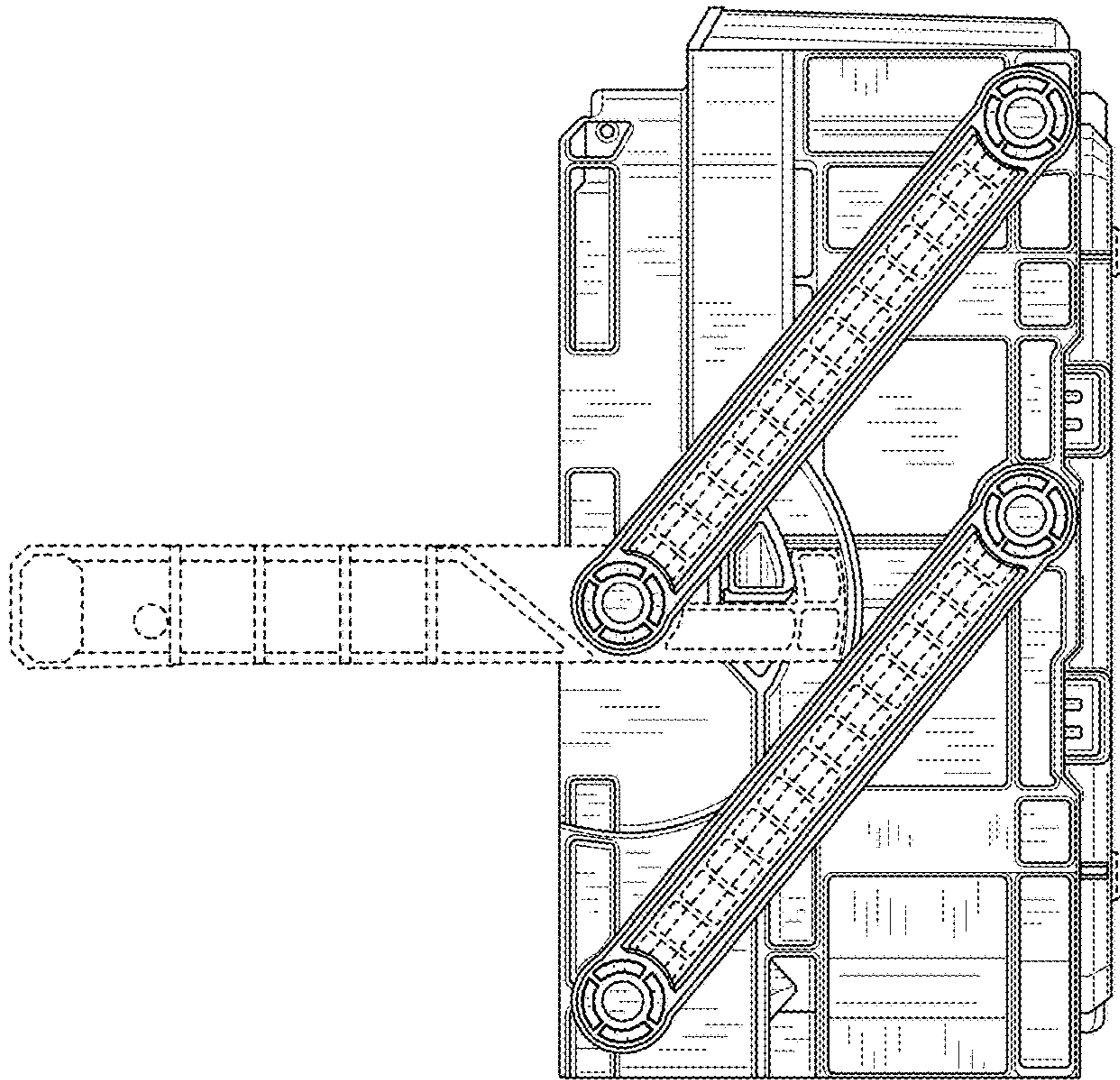

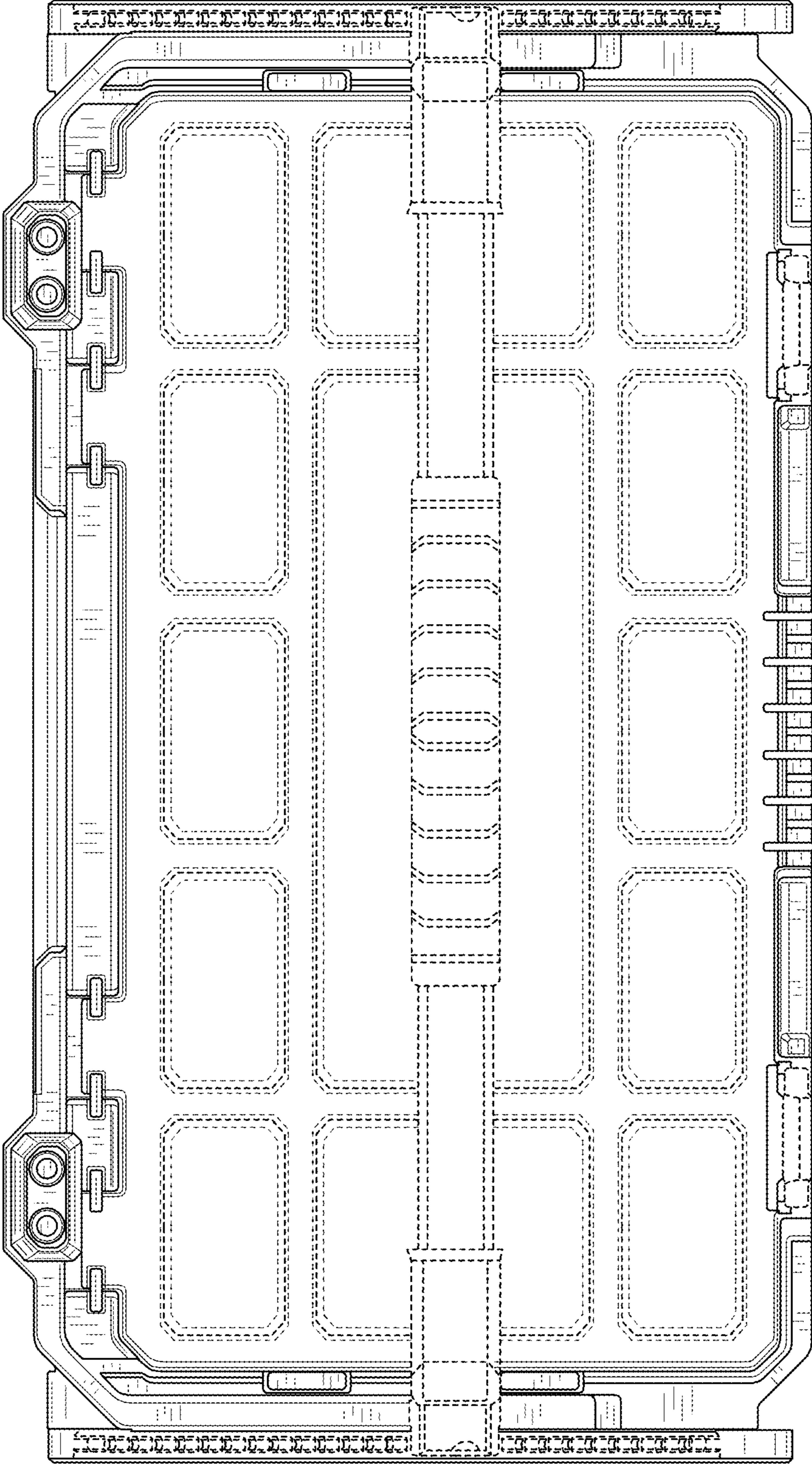

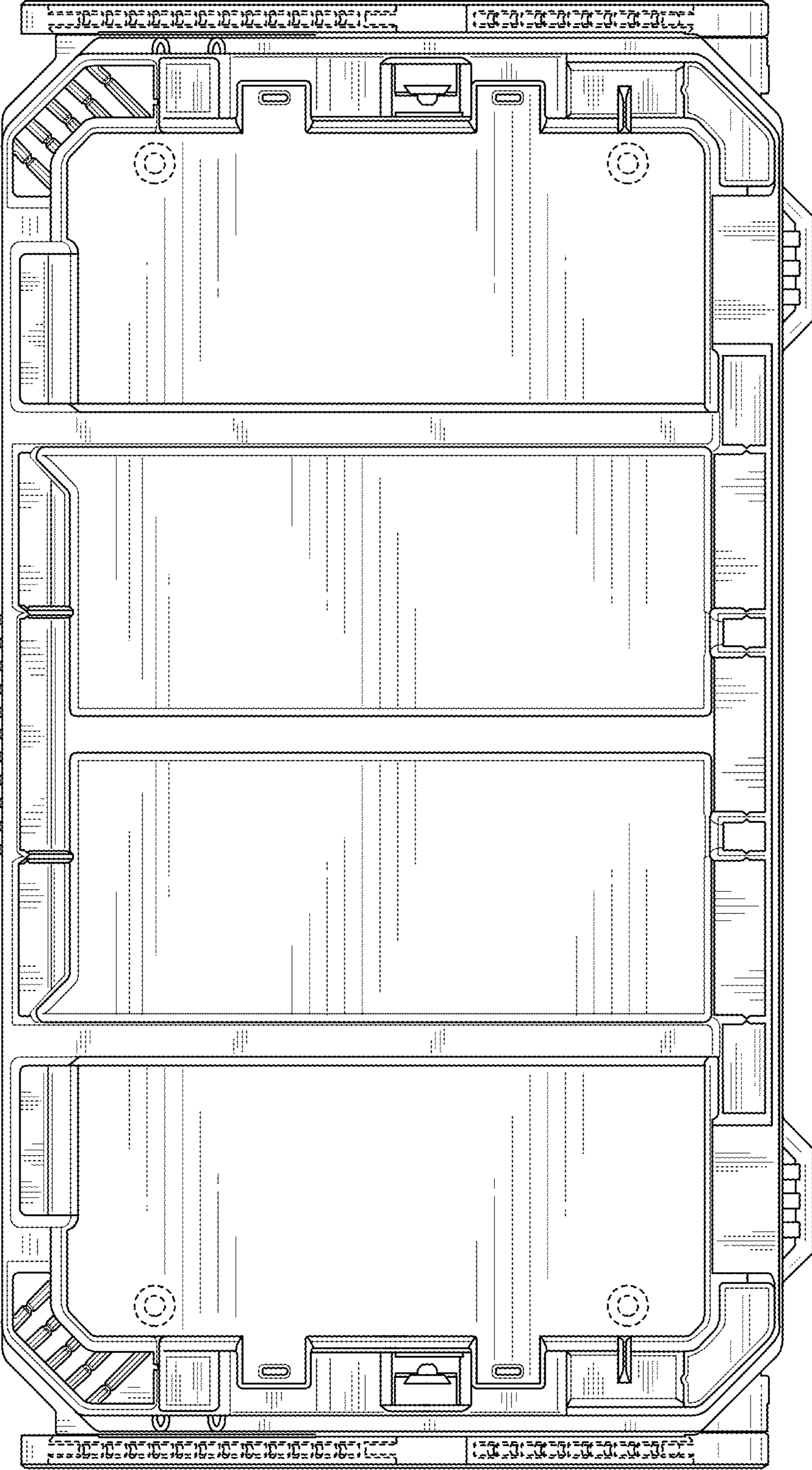
