(57) **CLAIM**

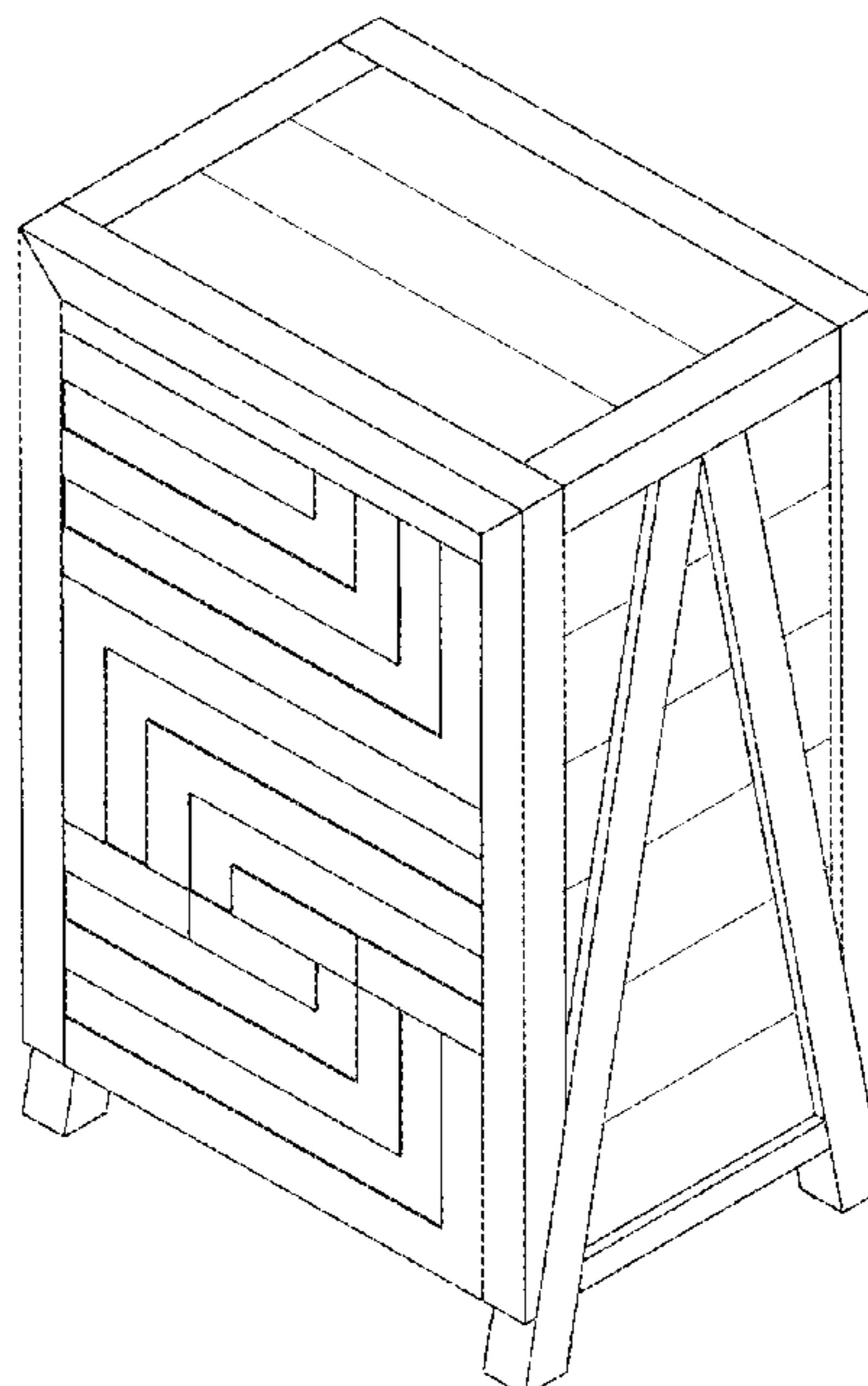
The ornamental design for a chest of drawers, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevational front view of a chest of drawers showing my new and ornamental design, FIG. 2 is an elevational rear view thereof, FIG. 3 is an elevational right side view thereof, FIG. 4 is an elevational left side view thereof, FIG. 5 is a top plan view thereof, FIG. 6 is a bottom plan view thereof, FIG. 7 is a perspective right front view thereof; and, FIG. 8 is a perspective left front view thereof.

The broken lines in FIG. 6 represent features of the chest of drawers which form no part of the claimed design.

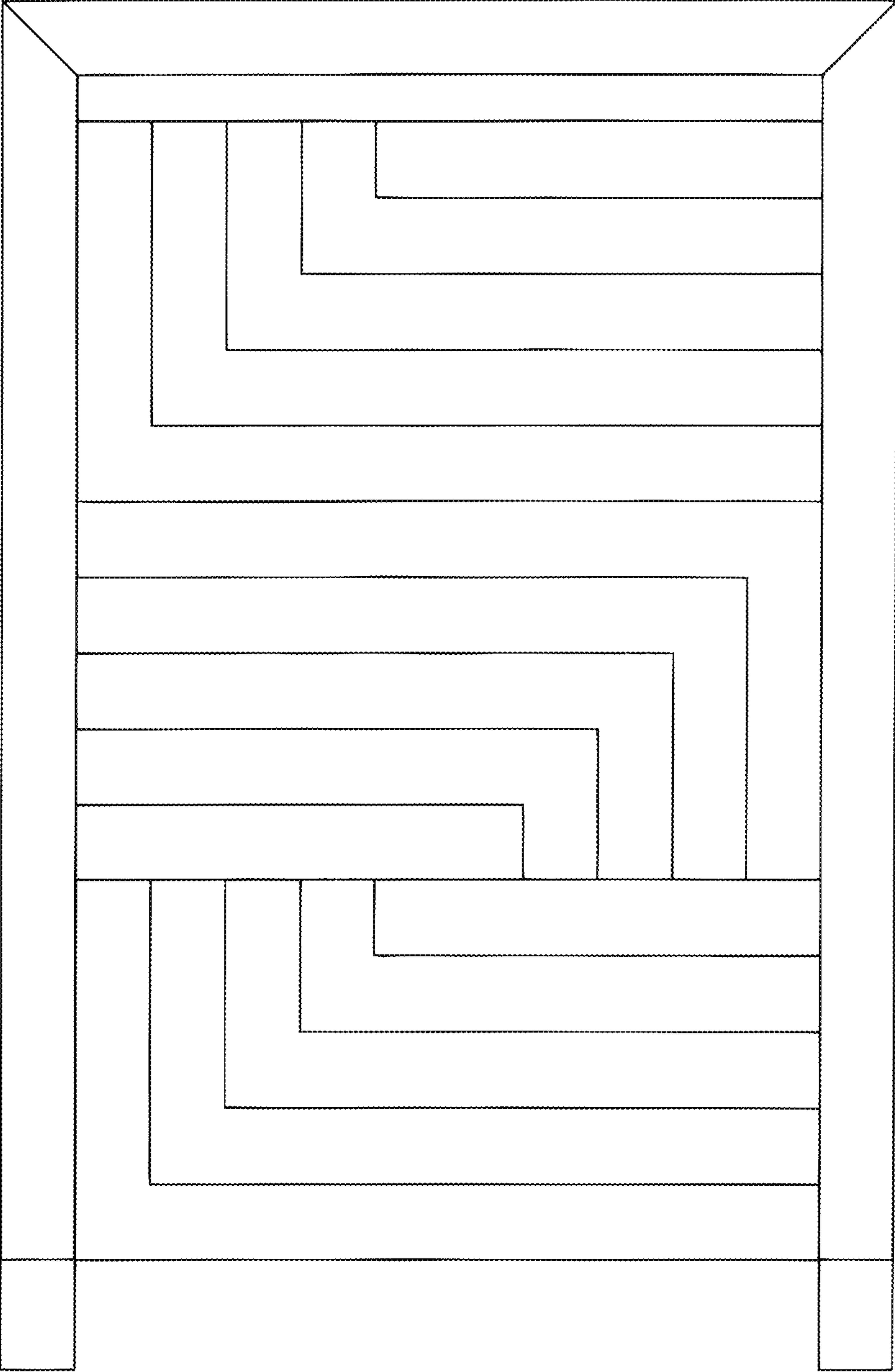

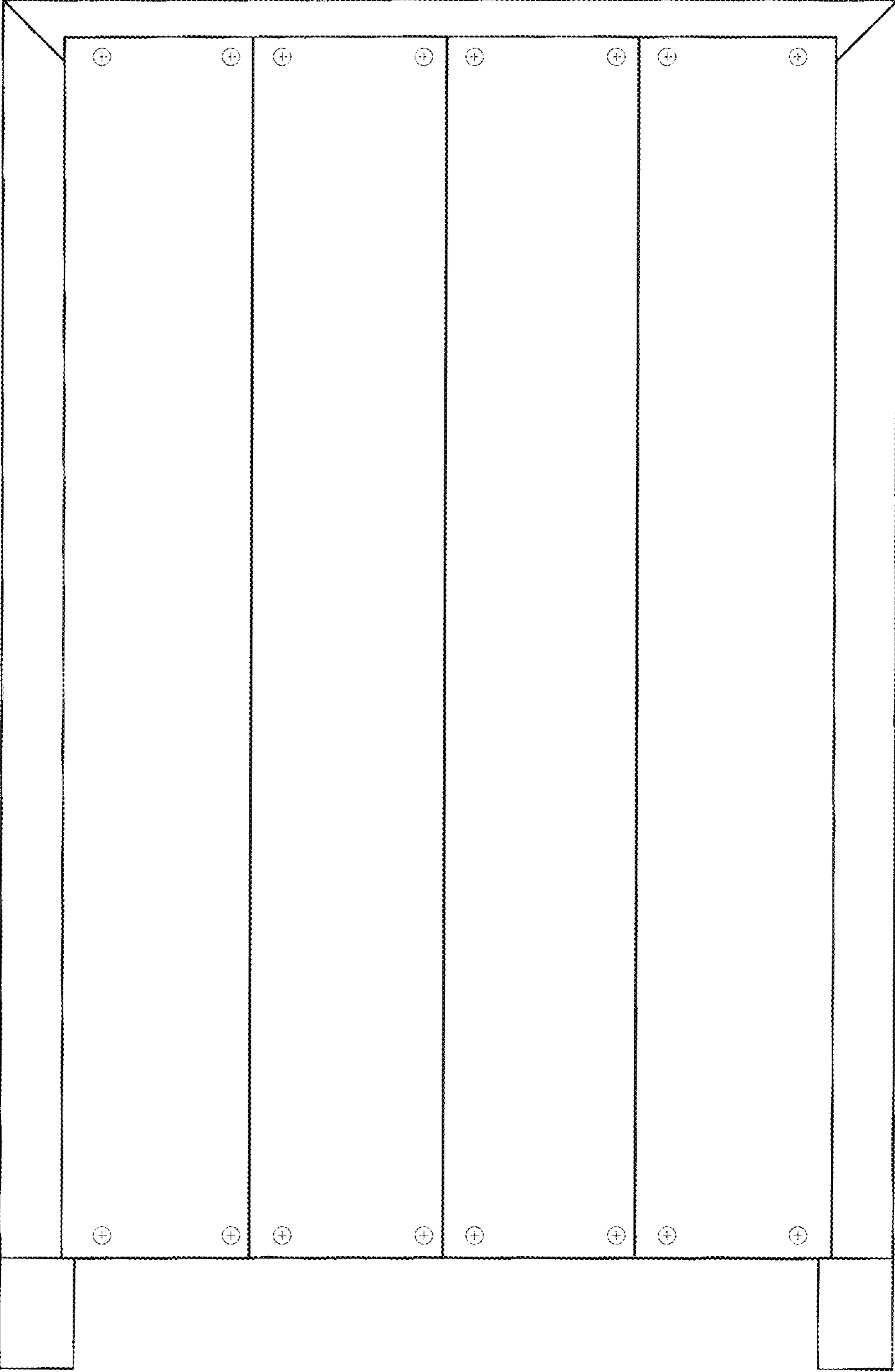

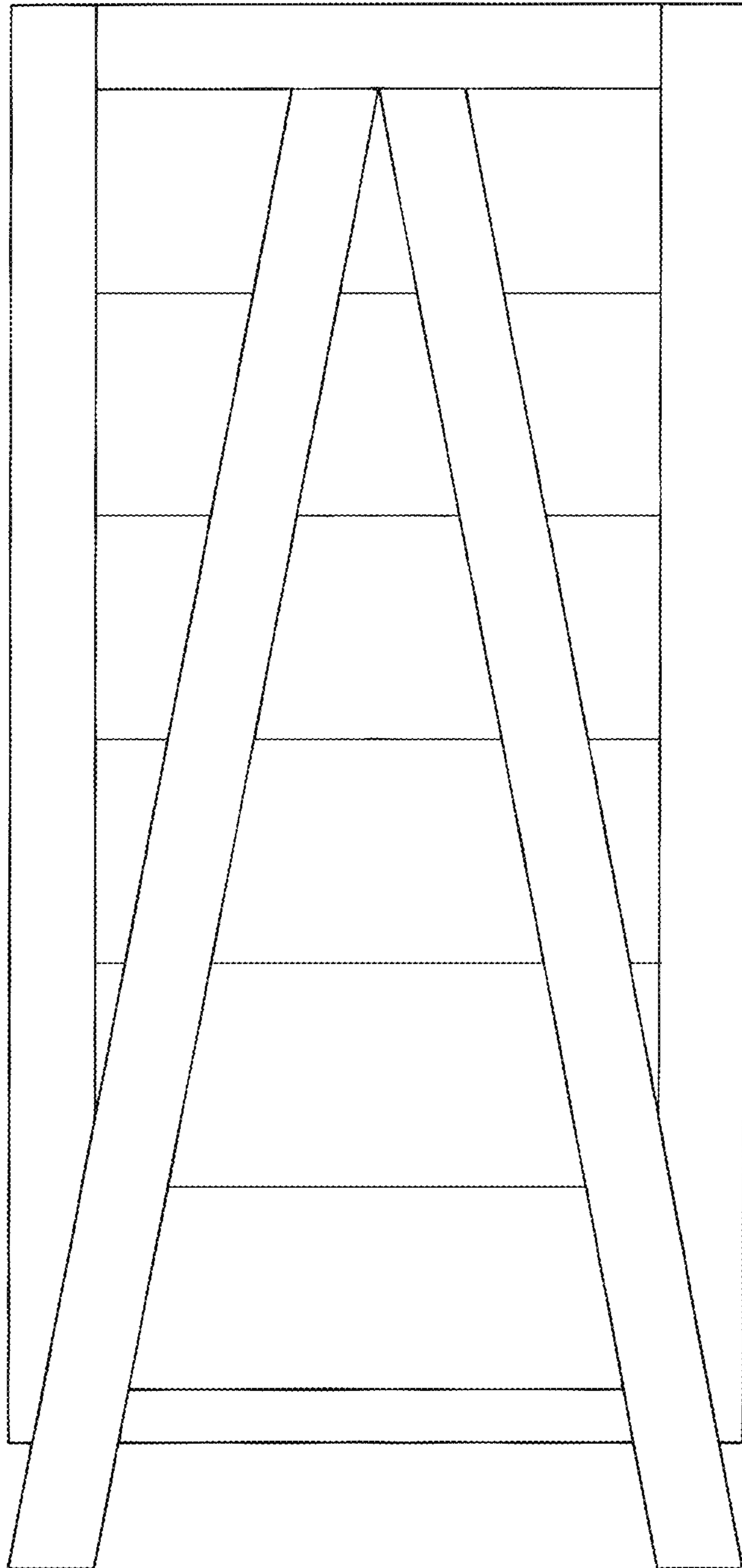

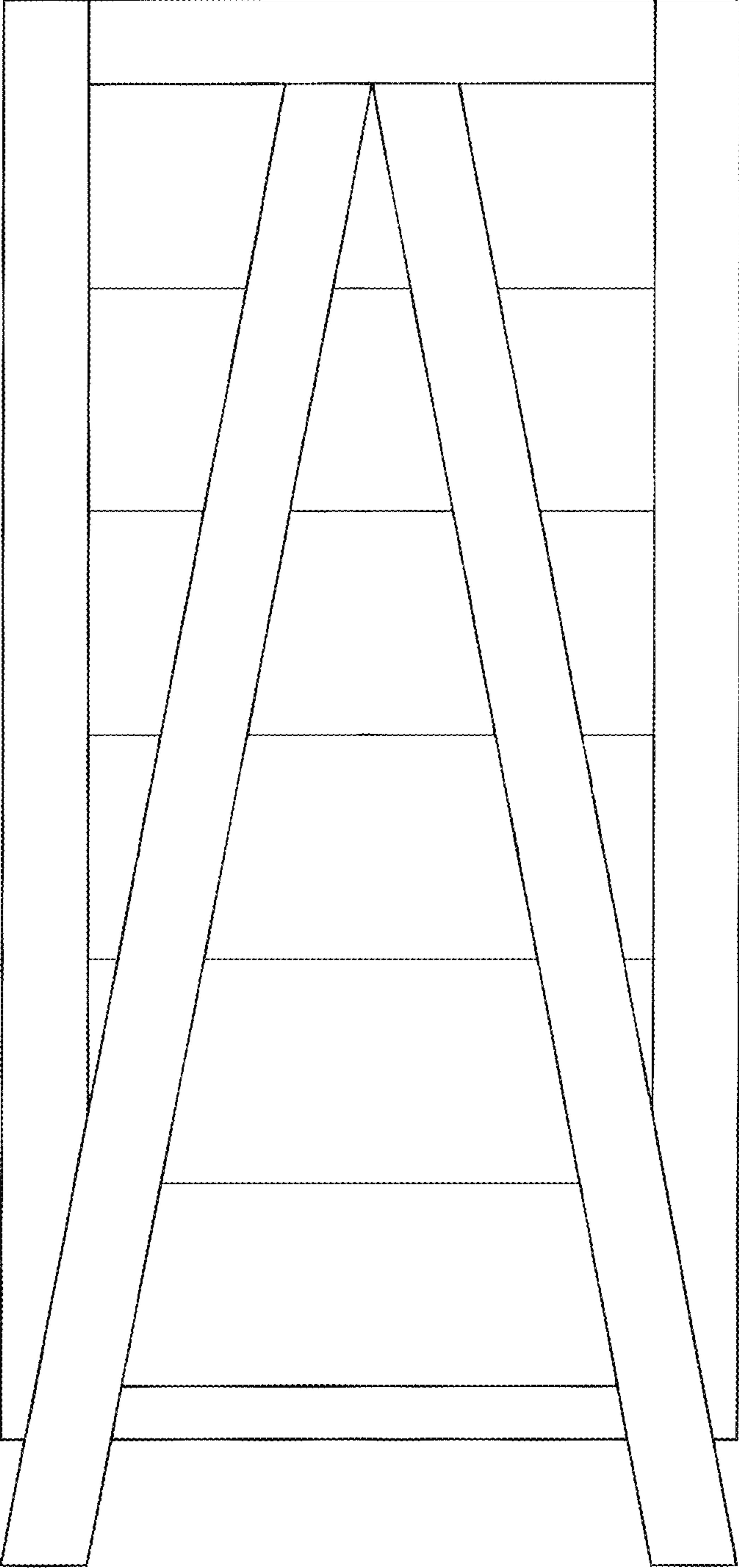

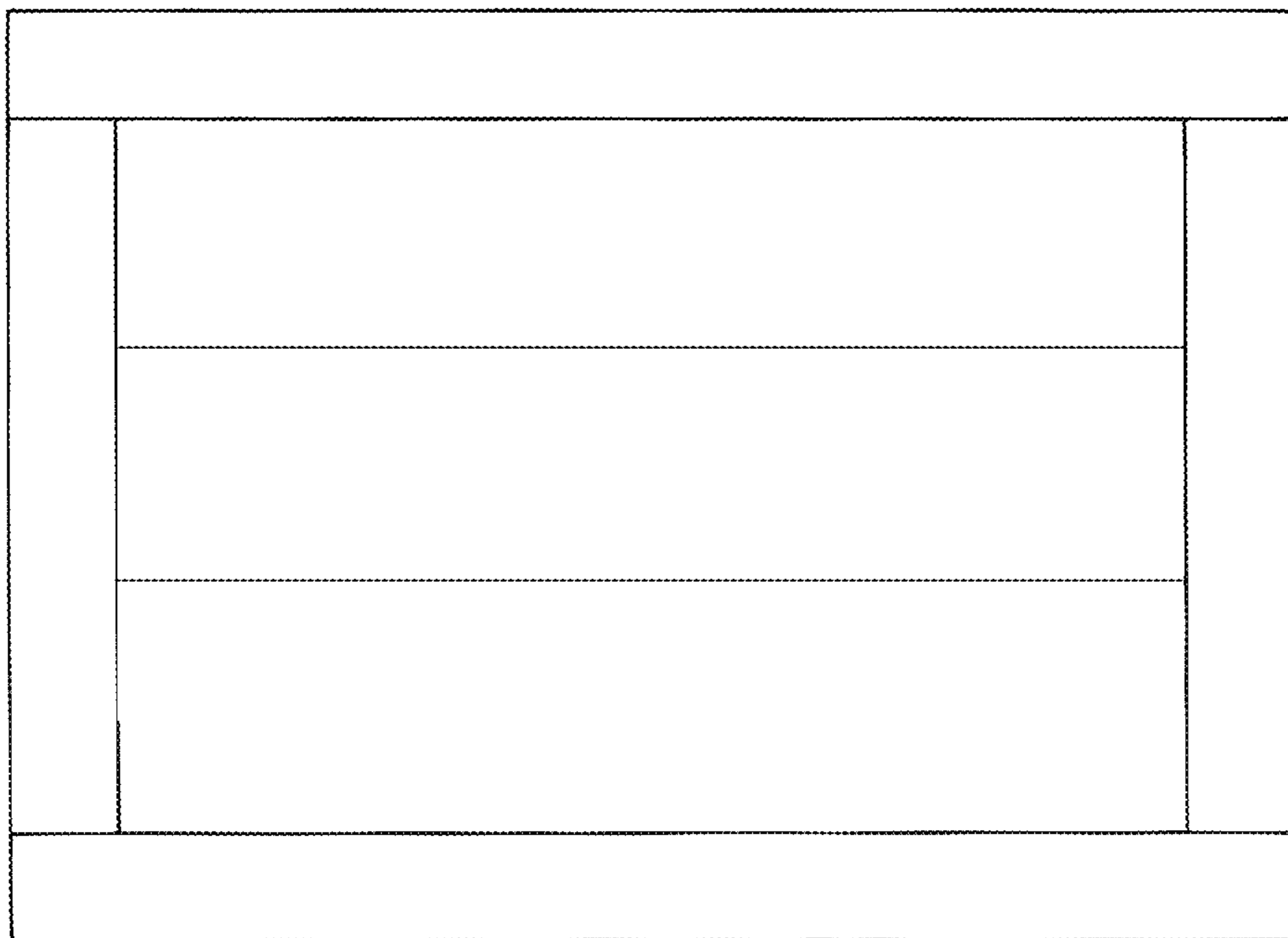

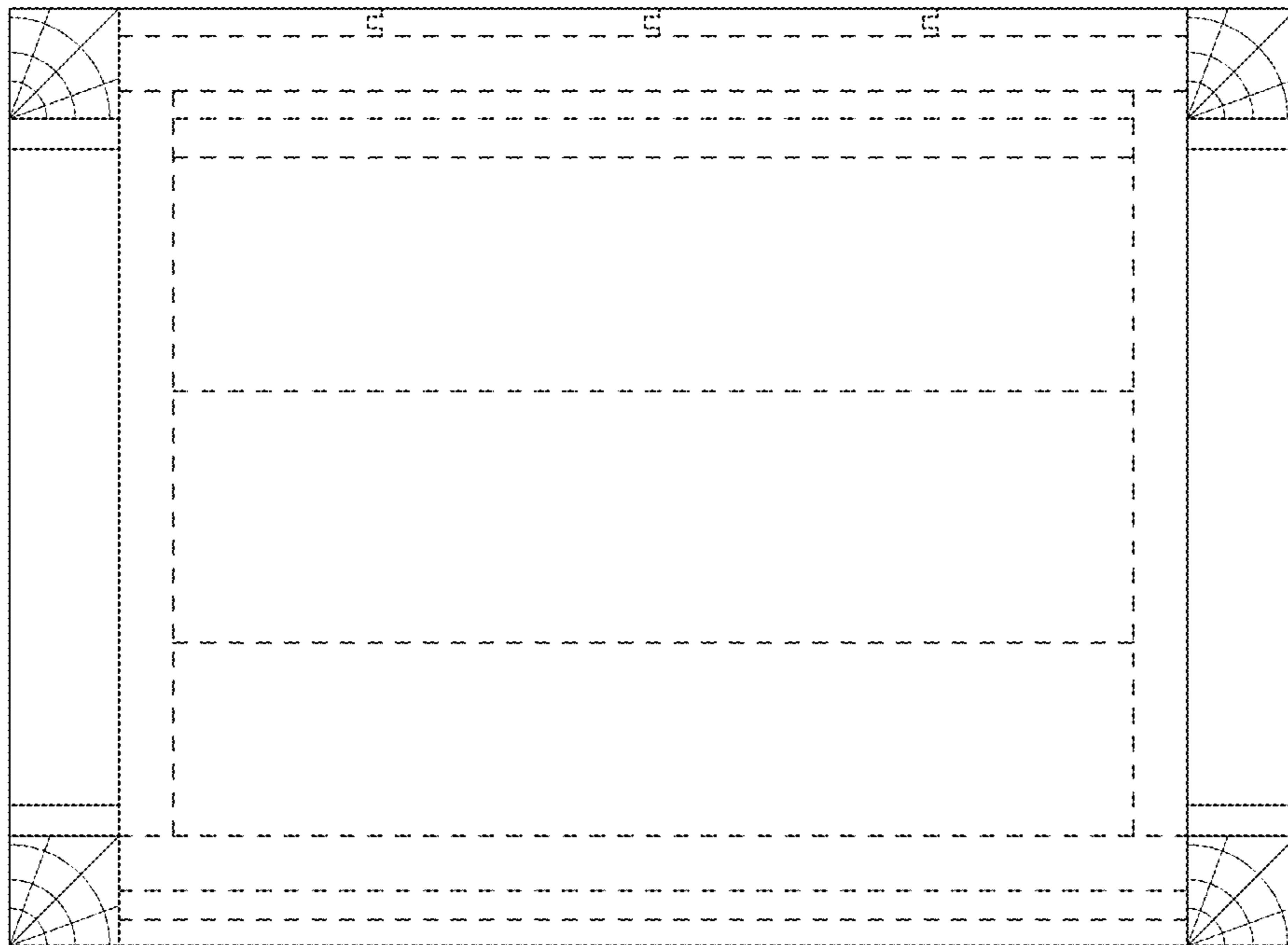

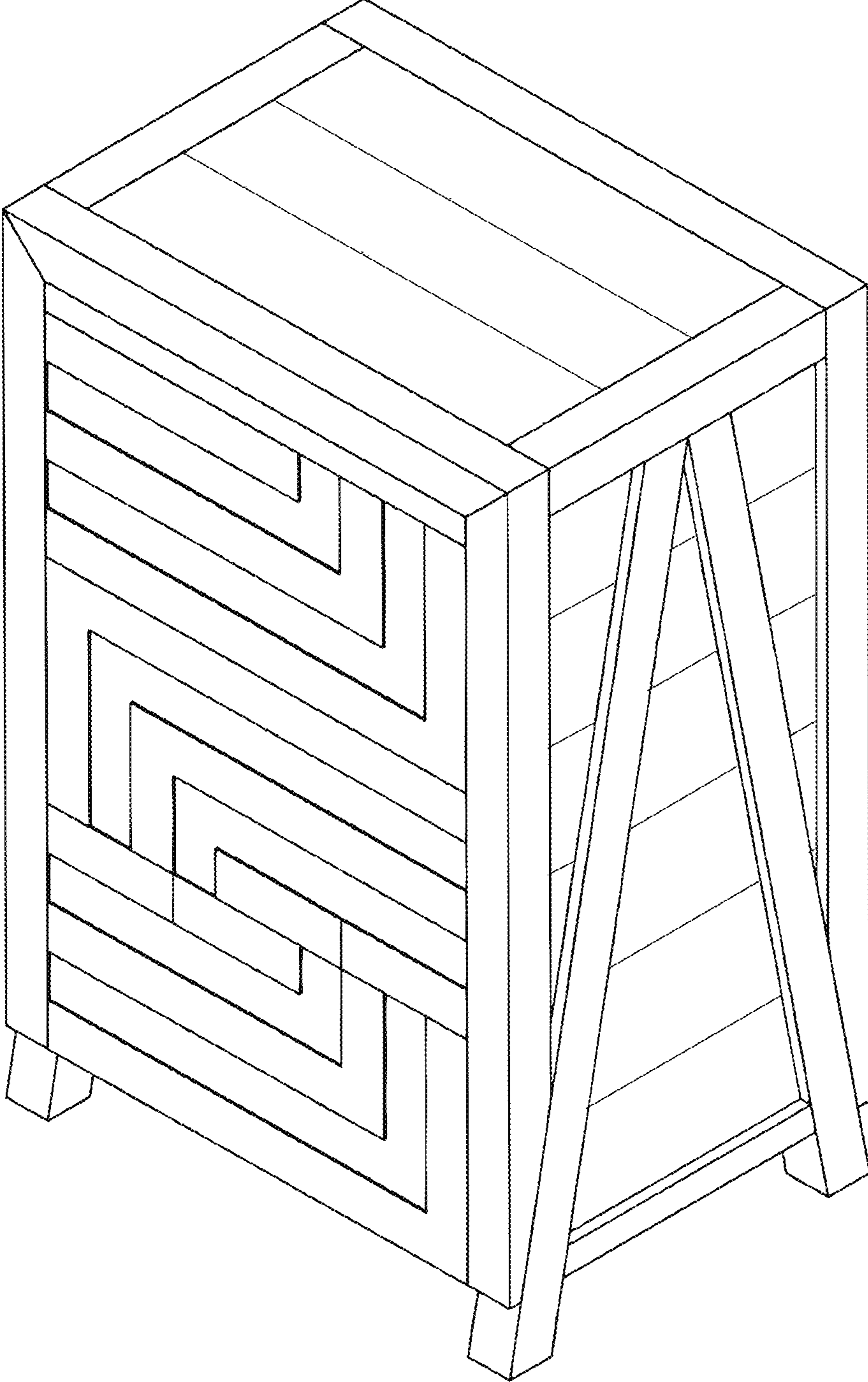

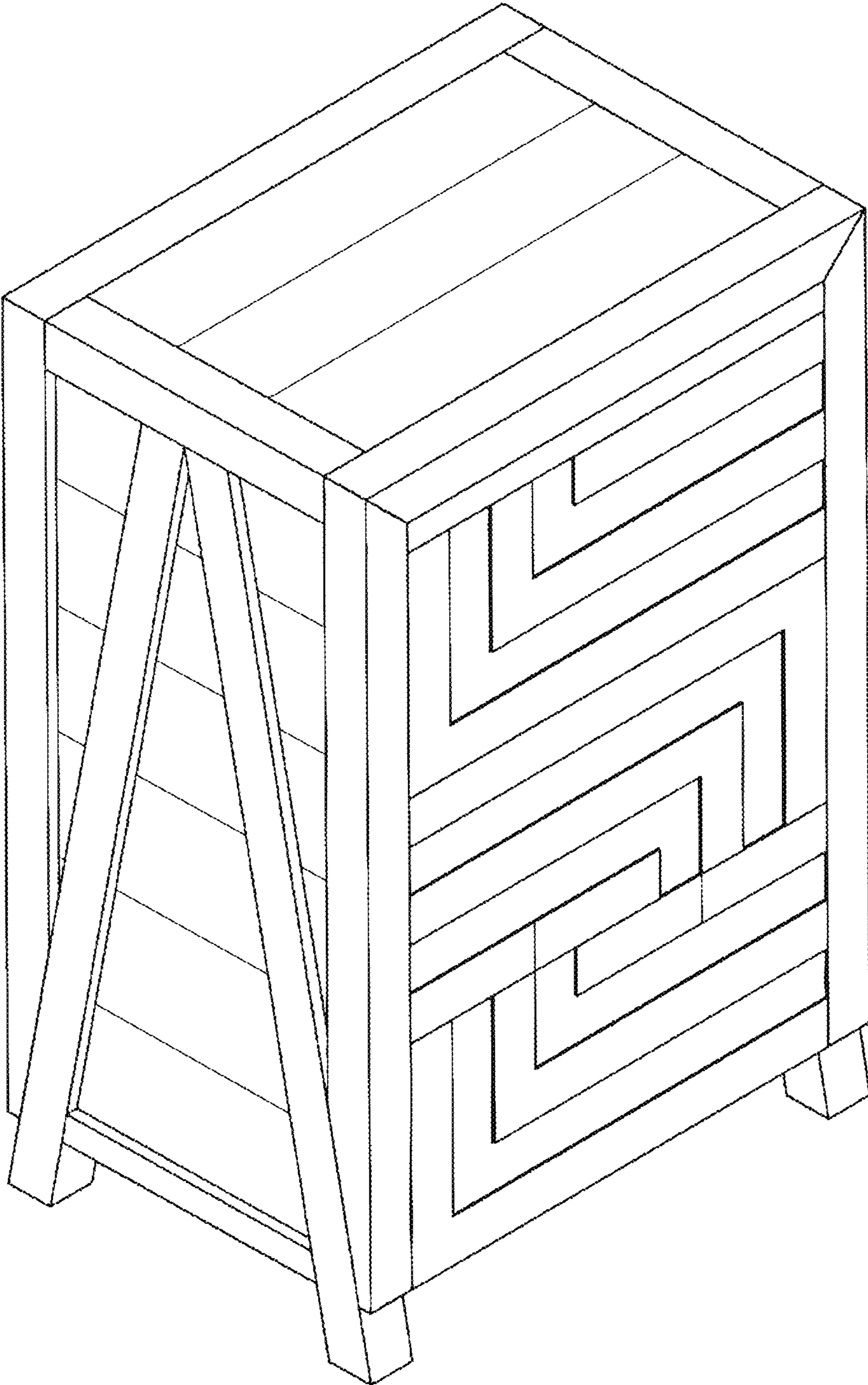
