(57) **CLAIM**

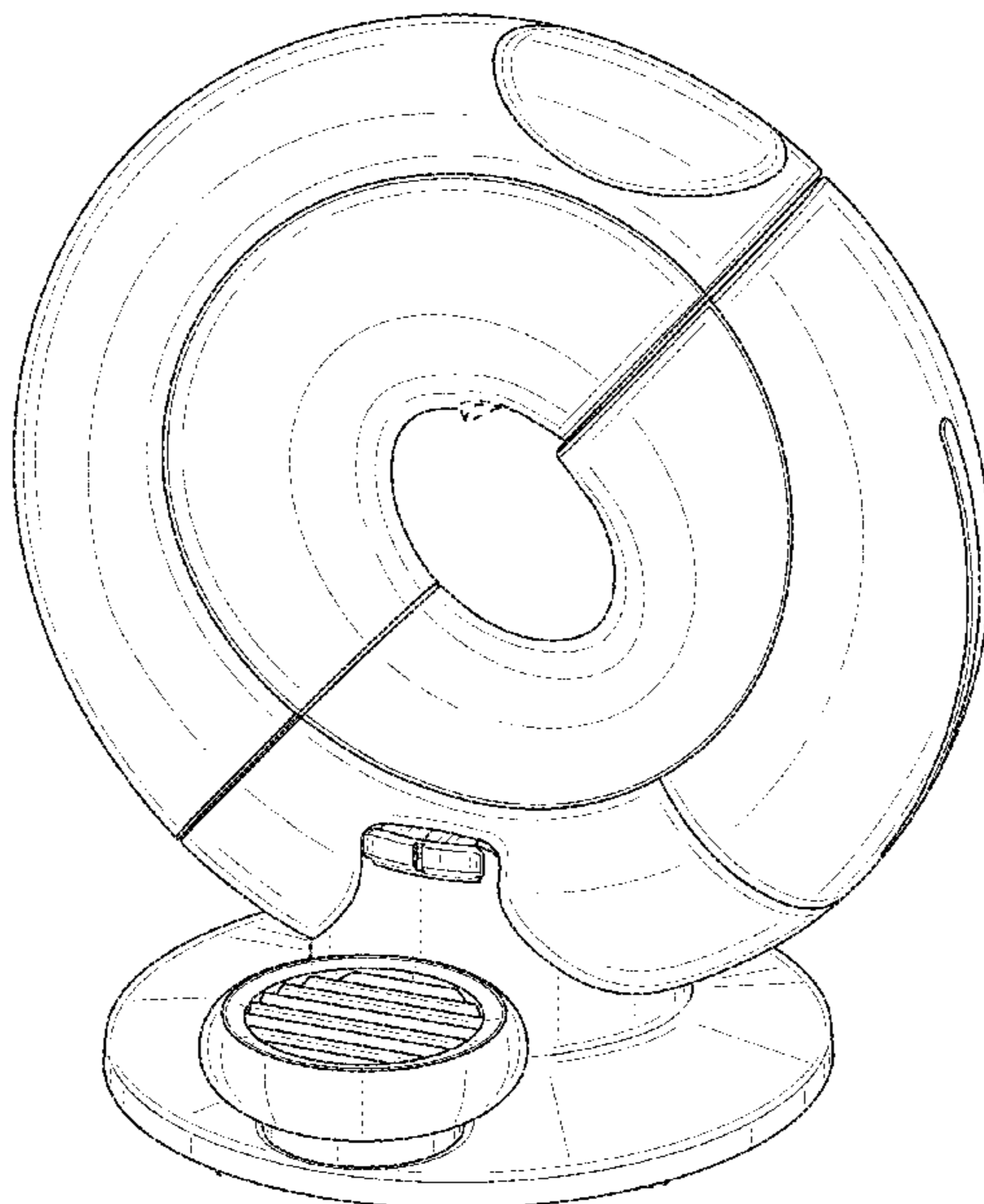
The ornamental design for a beverage dispenser, as shown

DESCRIPTION

FIG. 1 is a front, top perspective view of a beverage
dispenser showing my new design in a closed configuration;
FIG. 2 is a front elevation view of the new design in the
closed configuration;
FIG. 3 is a rear elevation view of the new design in the
closed configuration;
FIG. 4 is a left side view of the new design in the closed

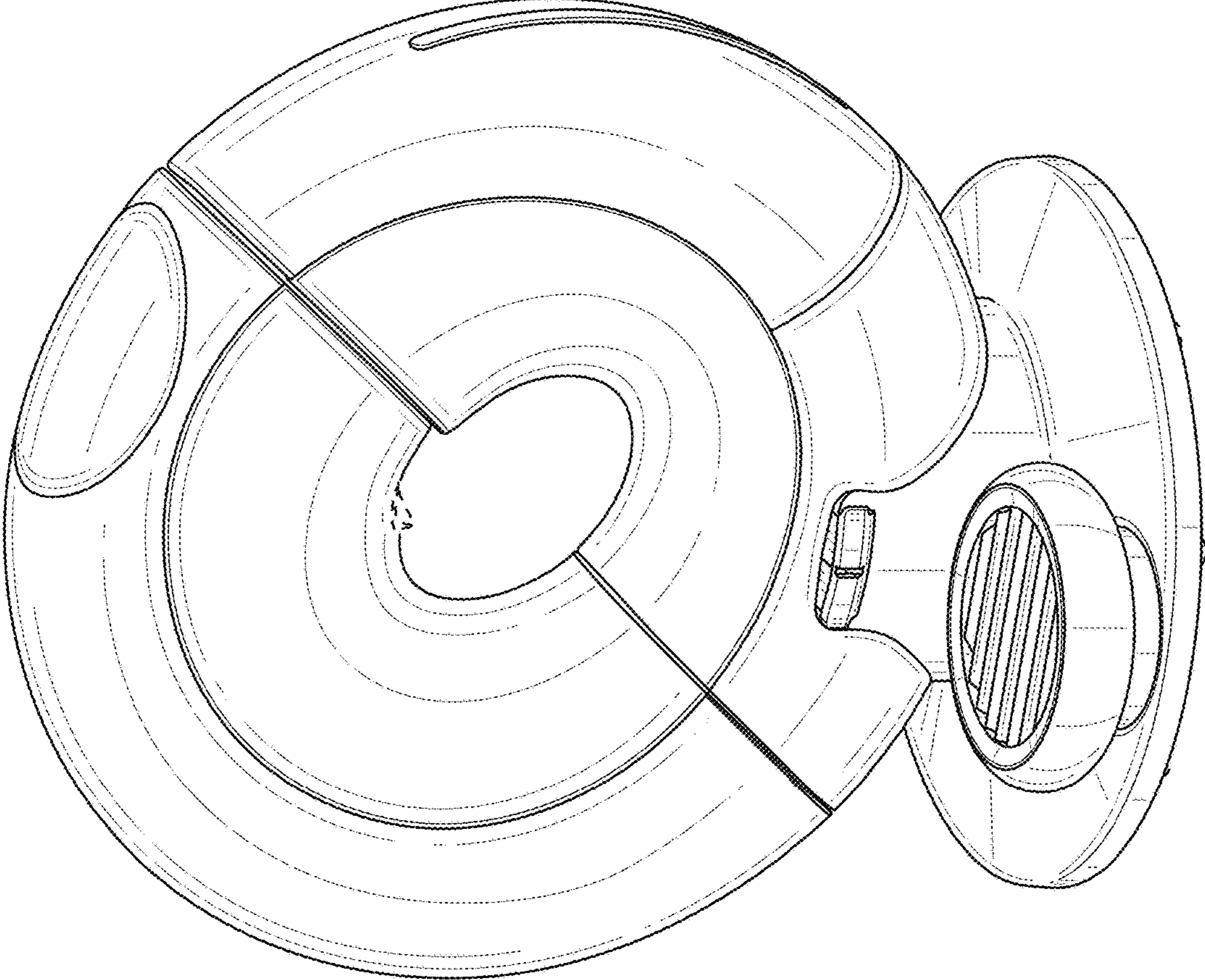

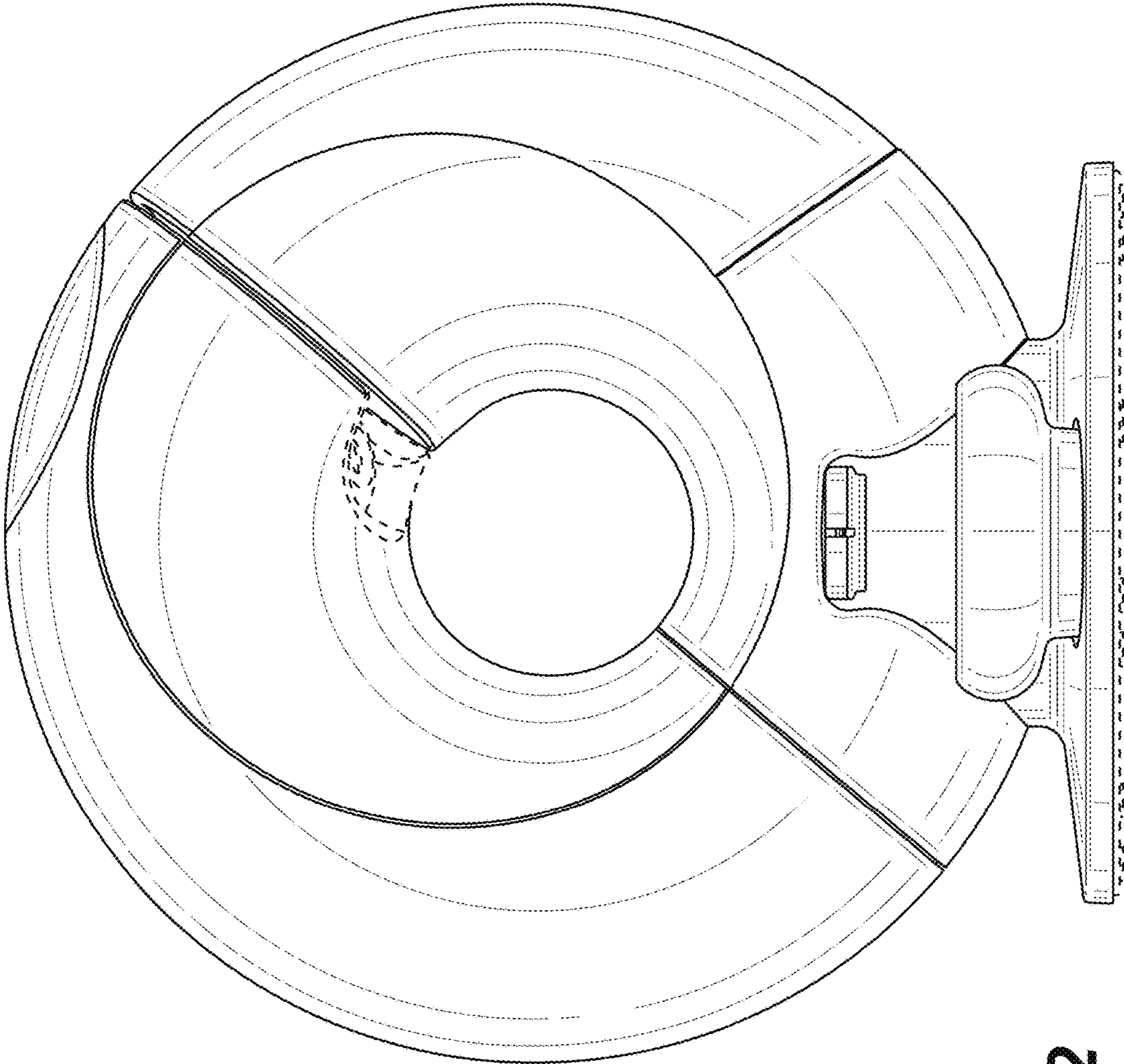

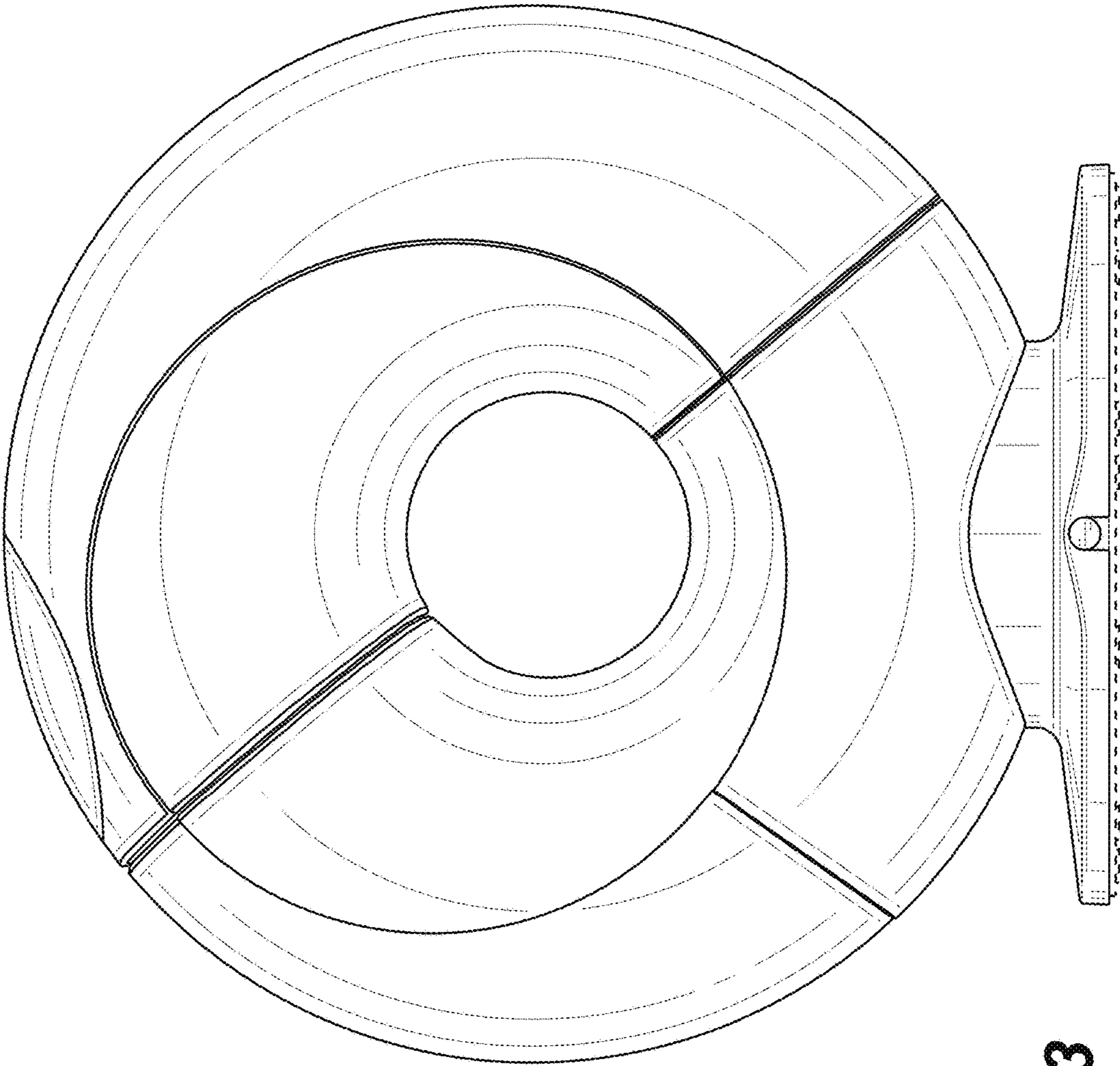

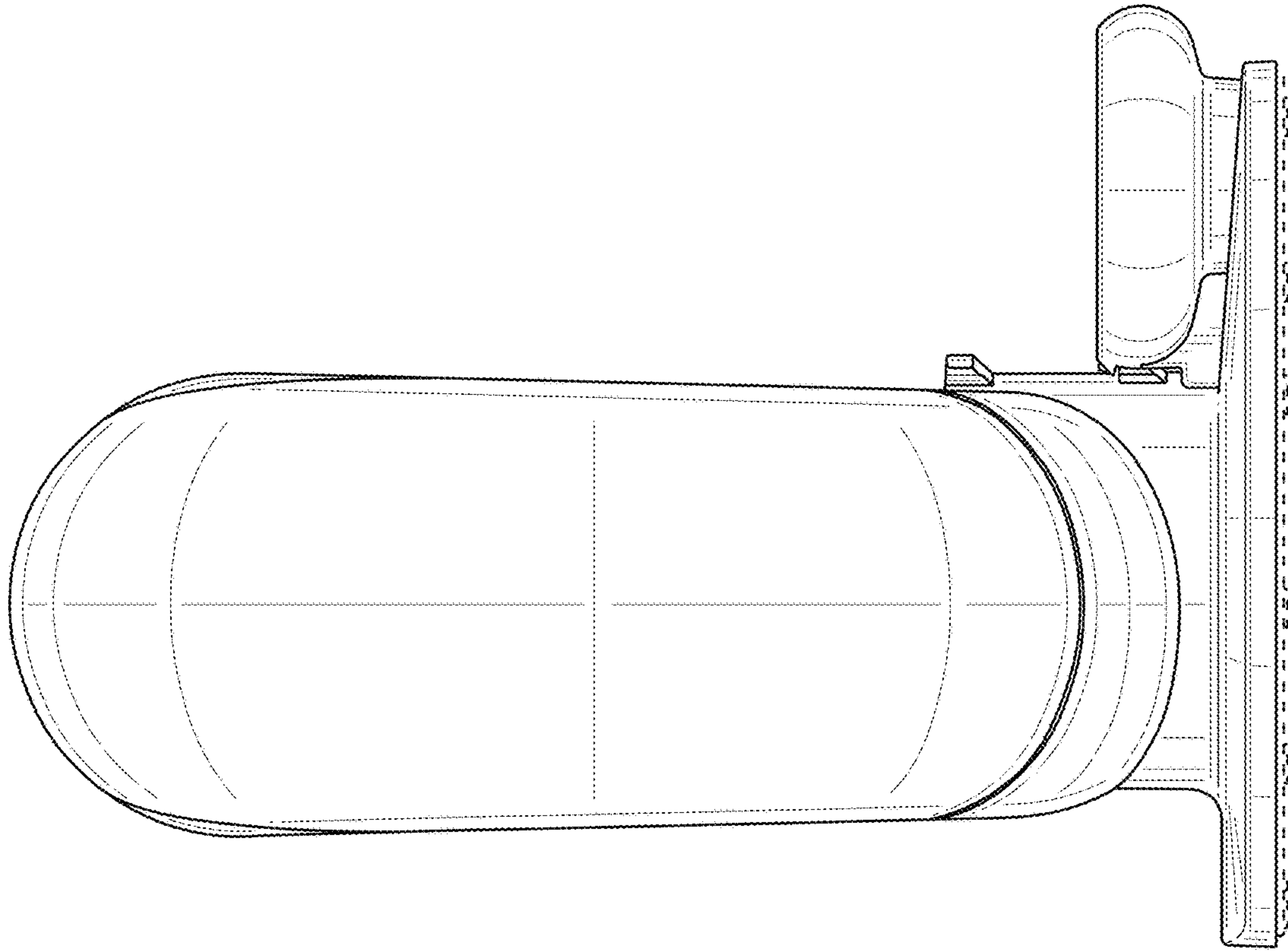

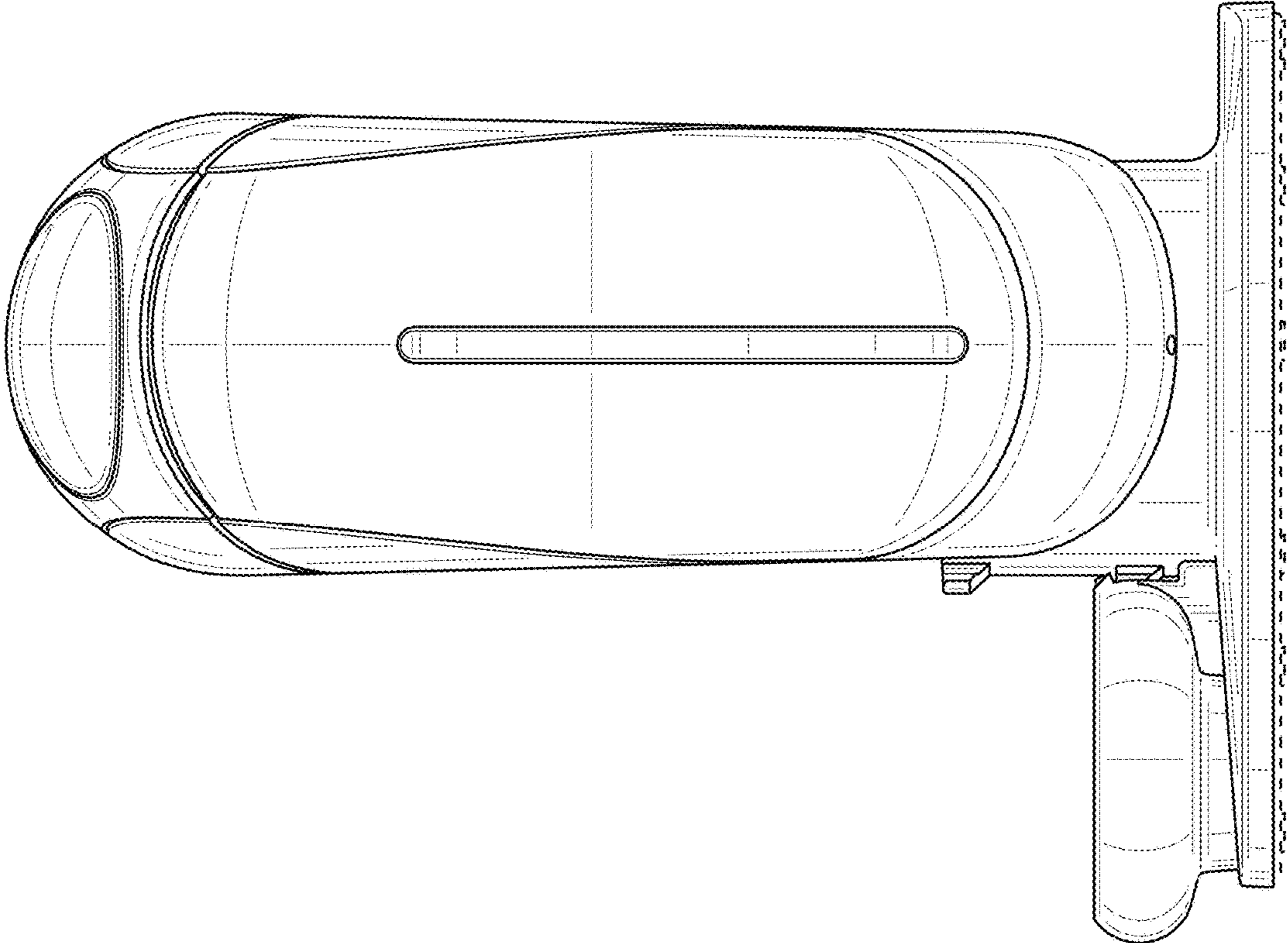

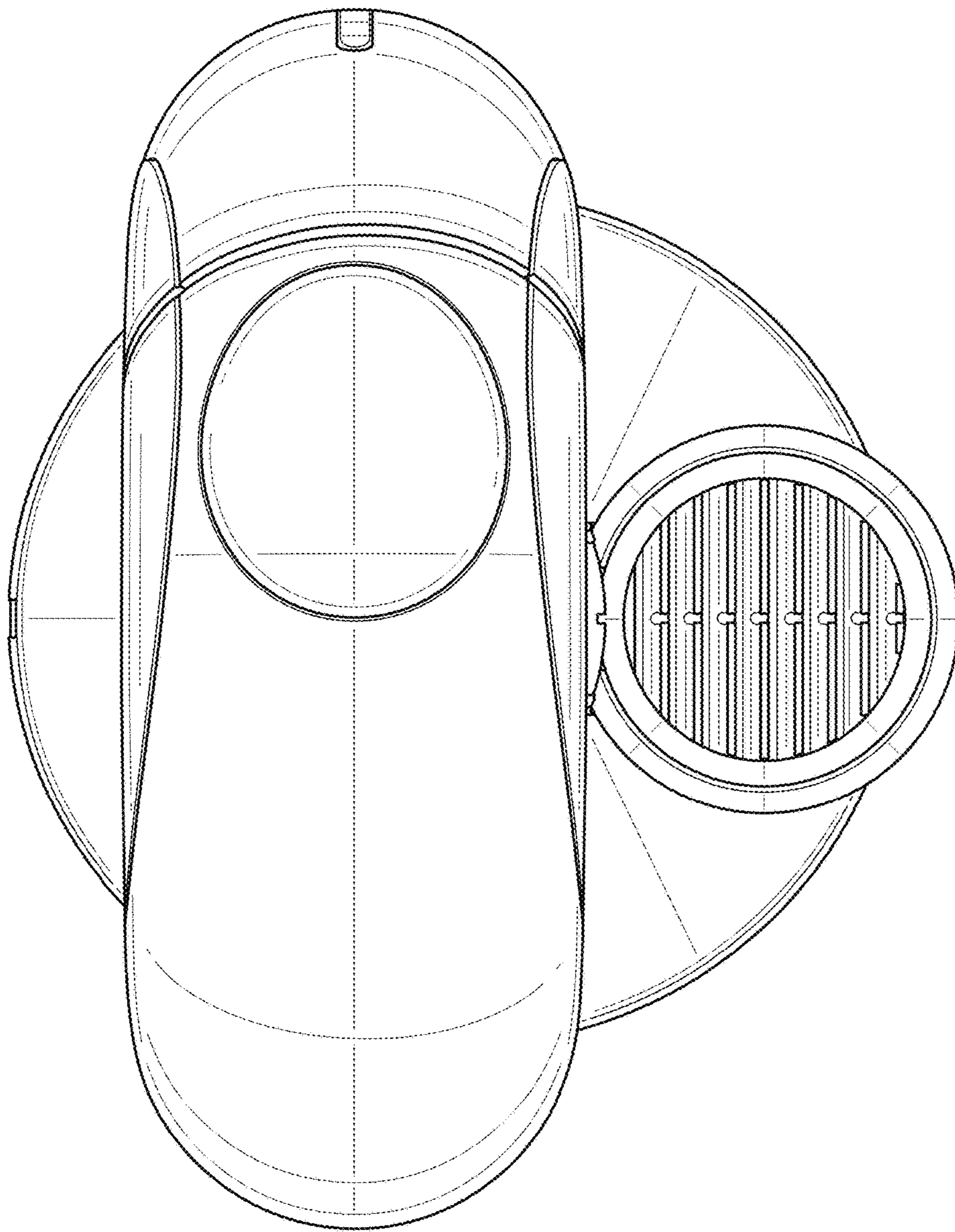

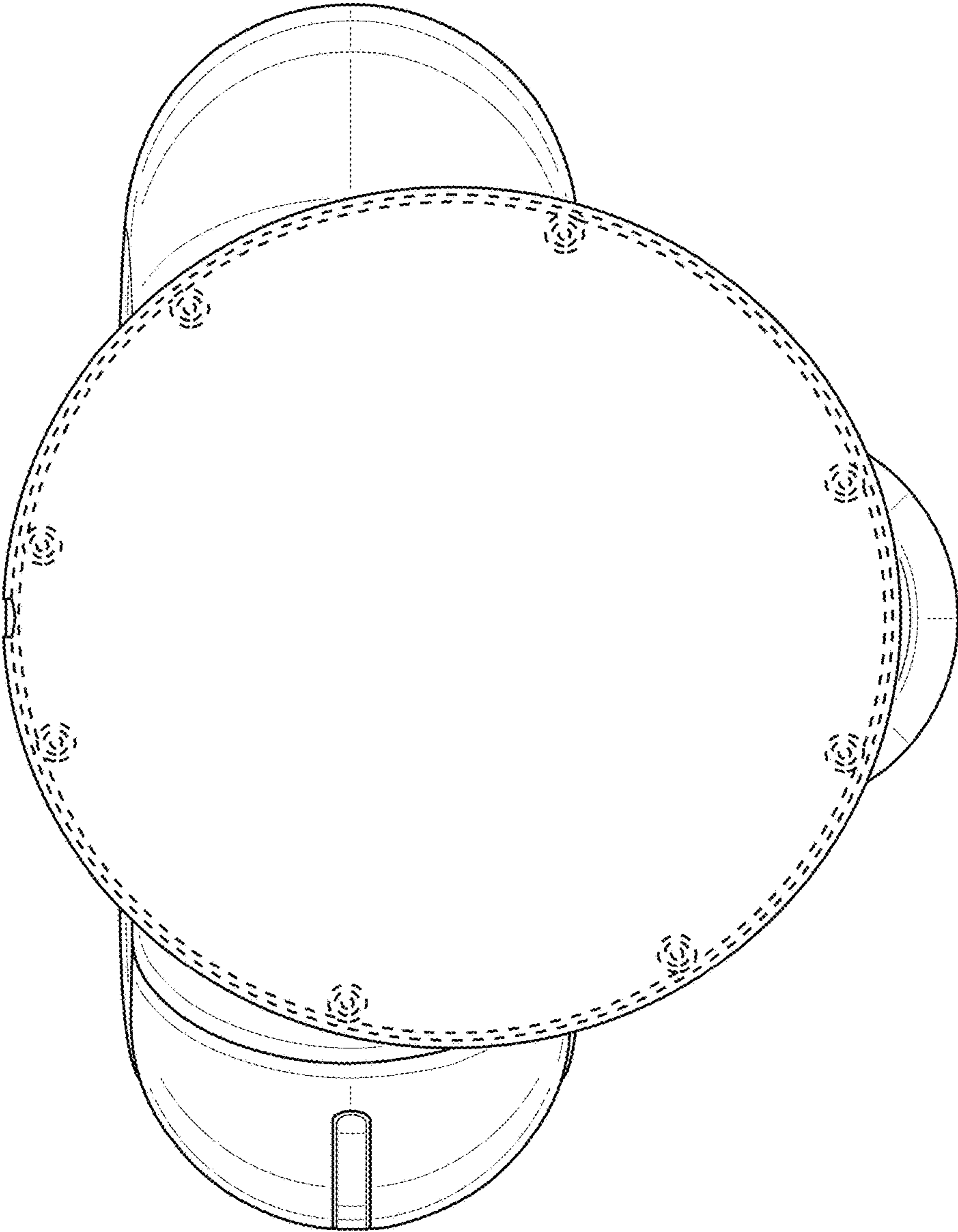

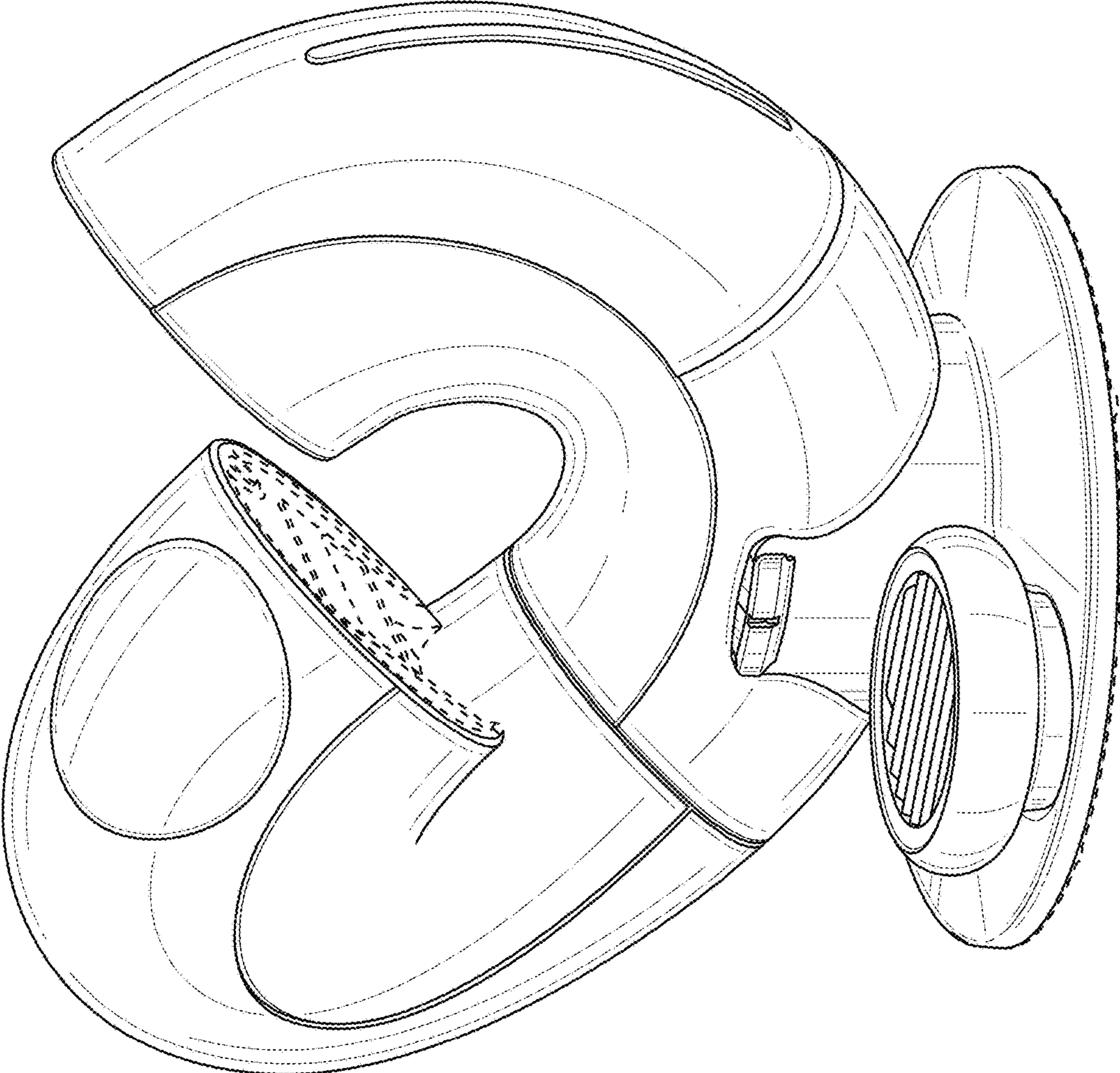

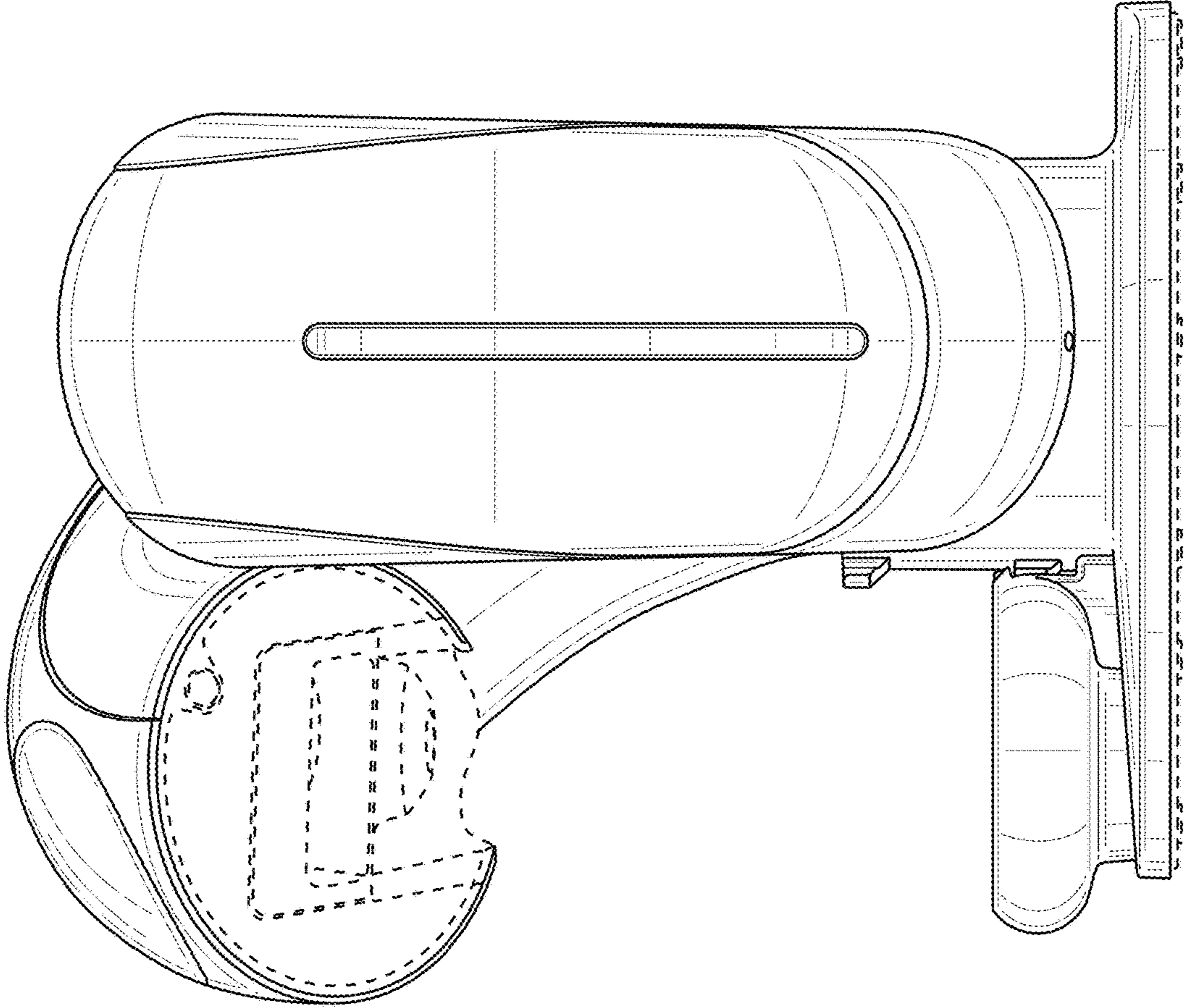
