FIG. 2 is a front view thereof, a rear view being the same.

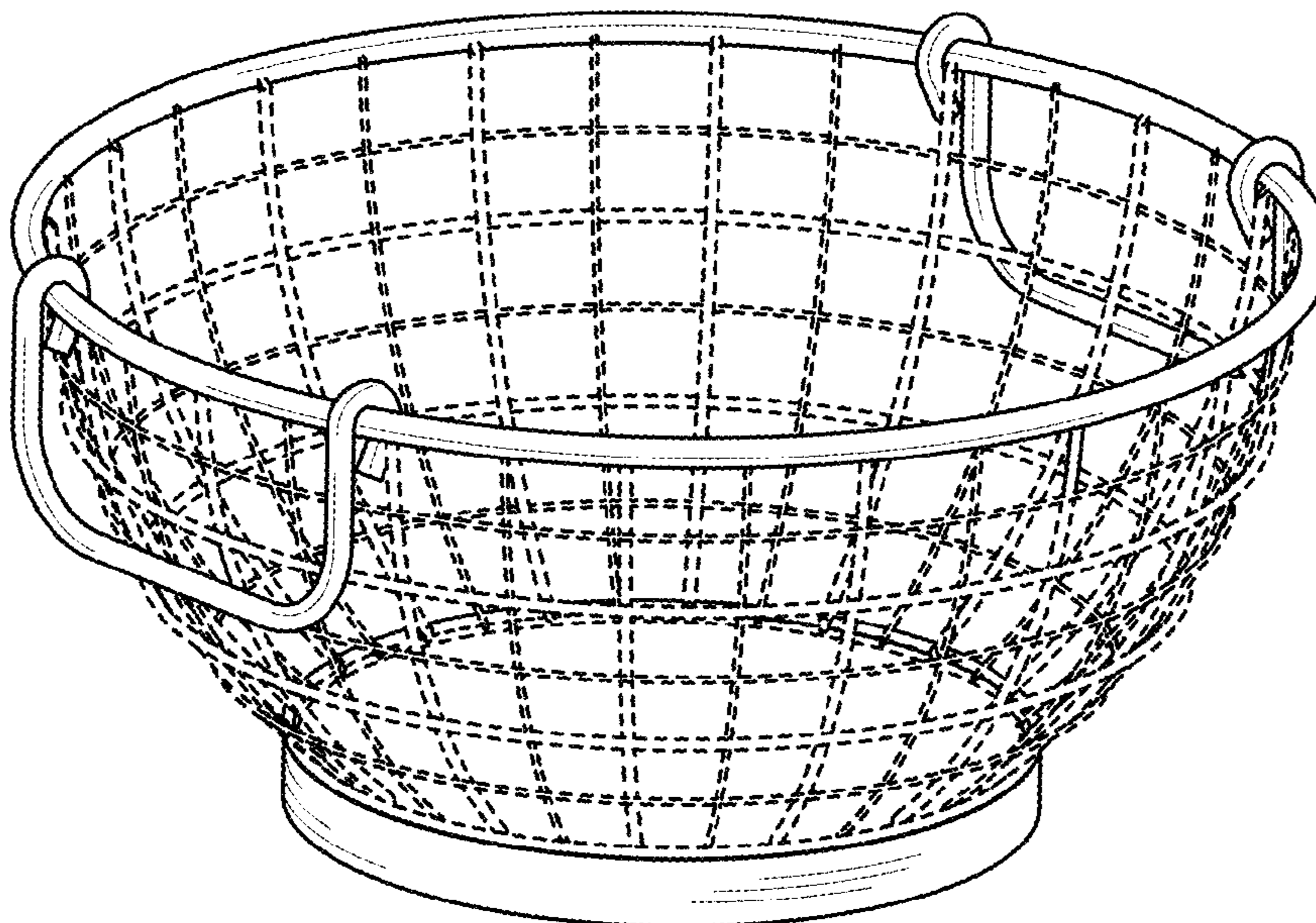
FIG. 3 is a left side view, a right side view being the same.

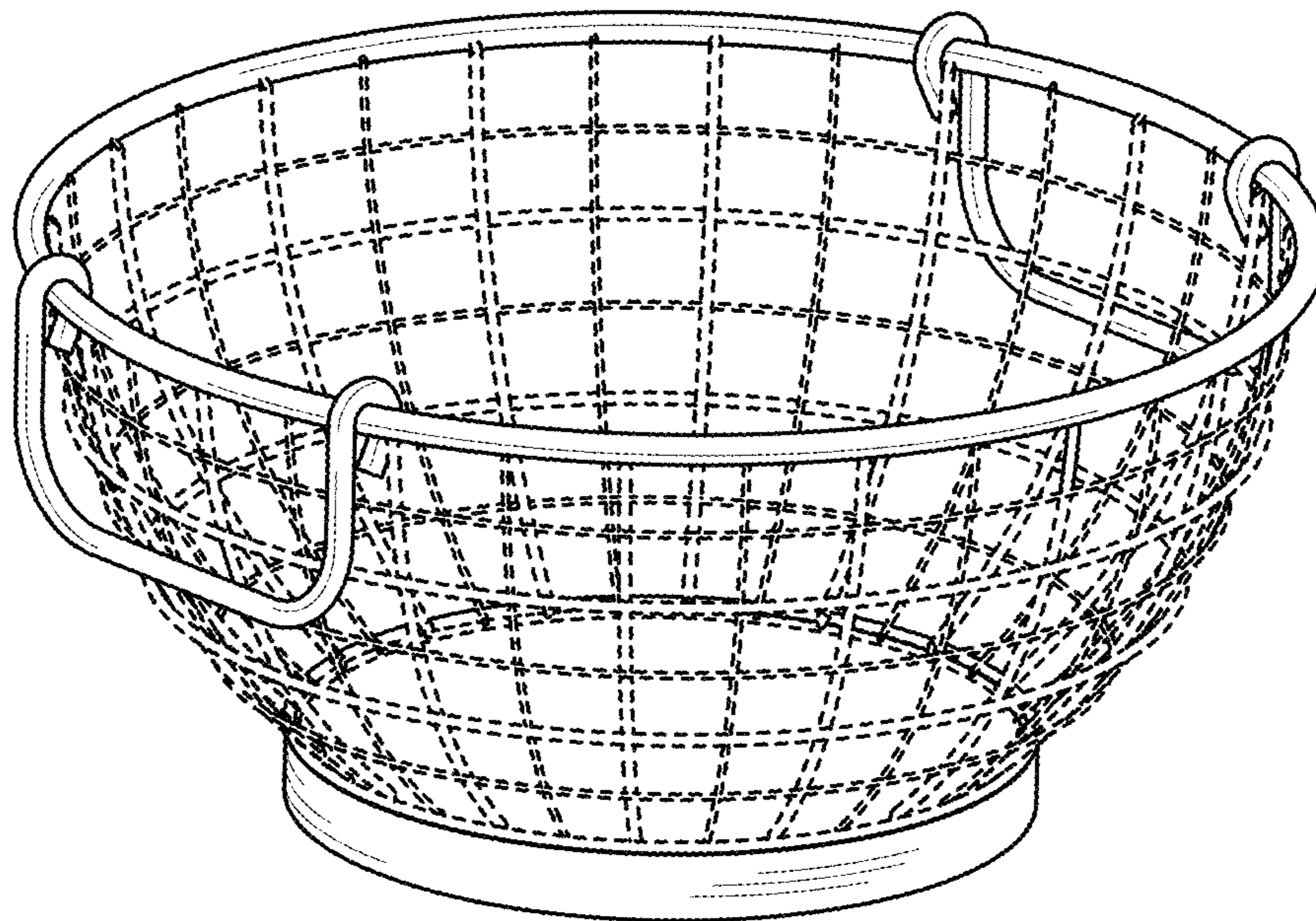

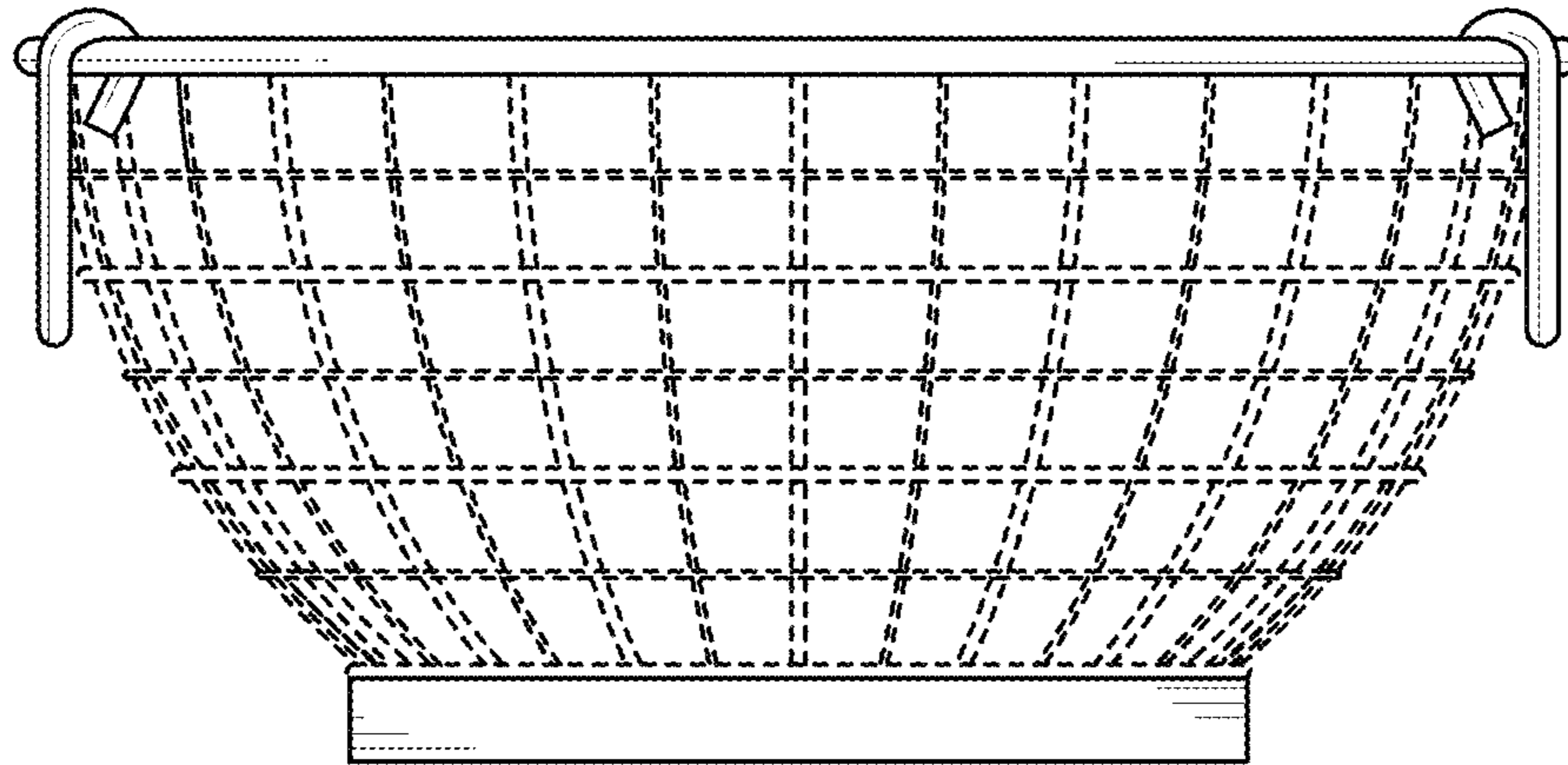

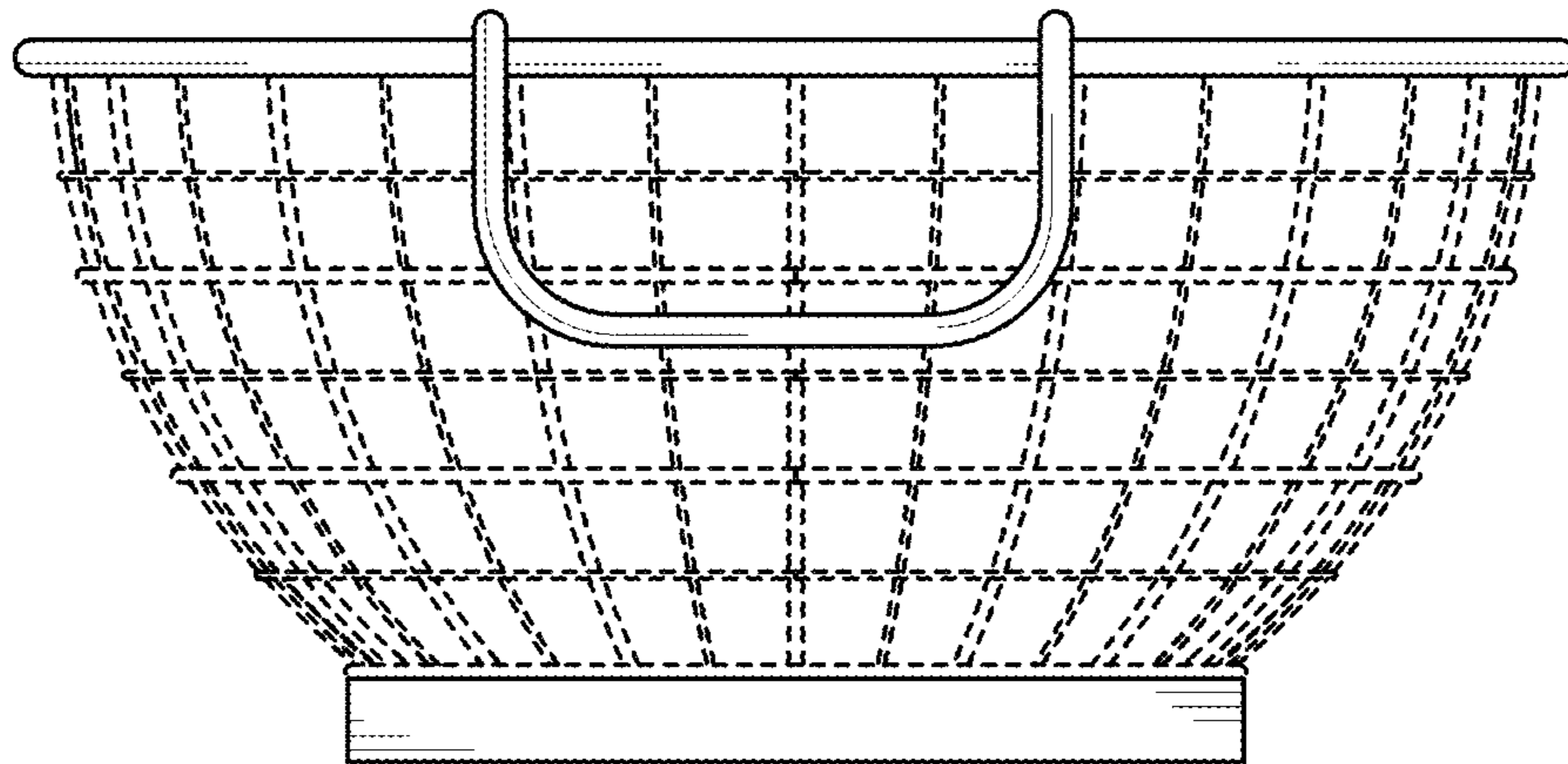

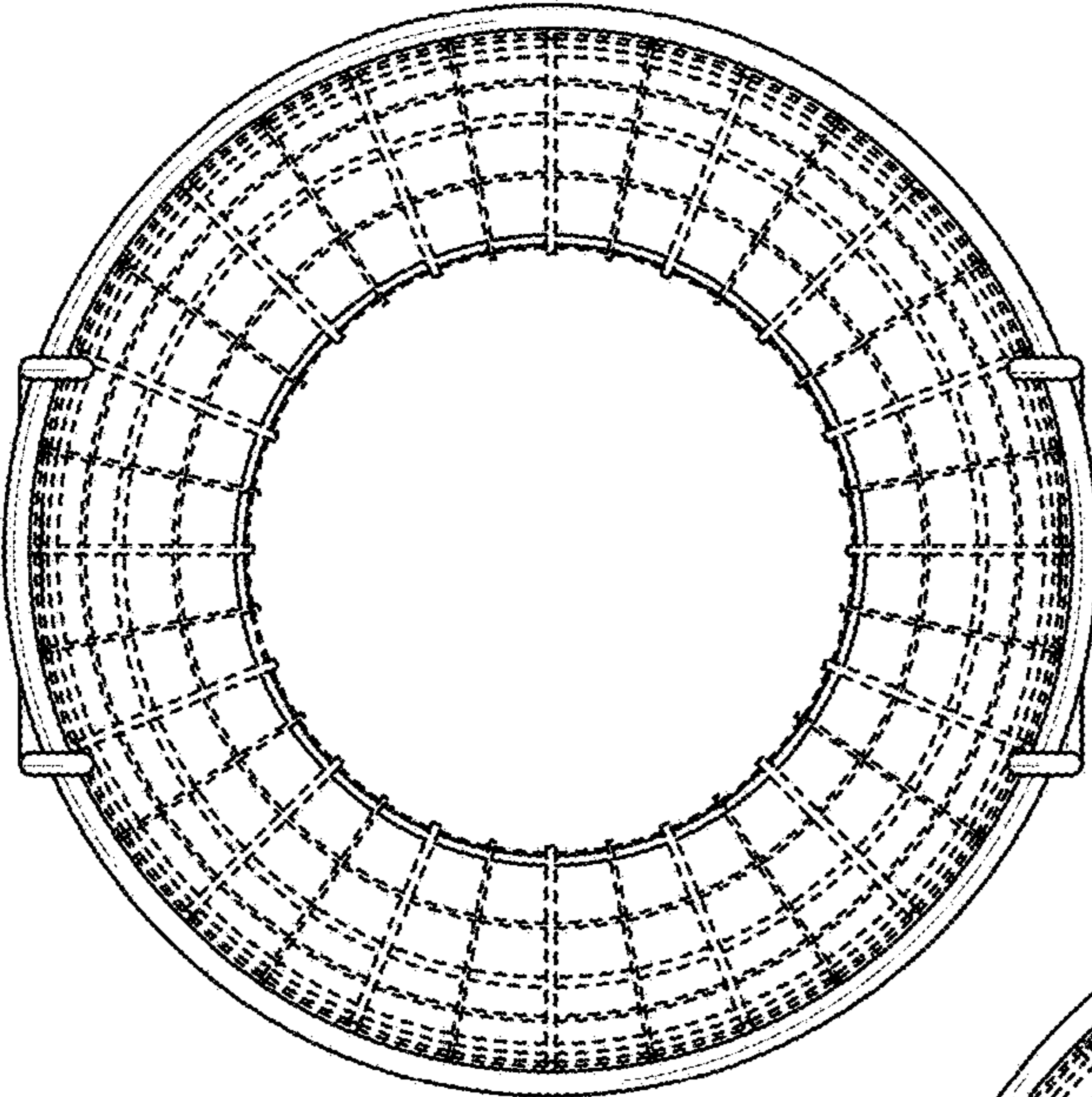

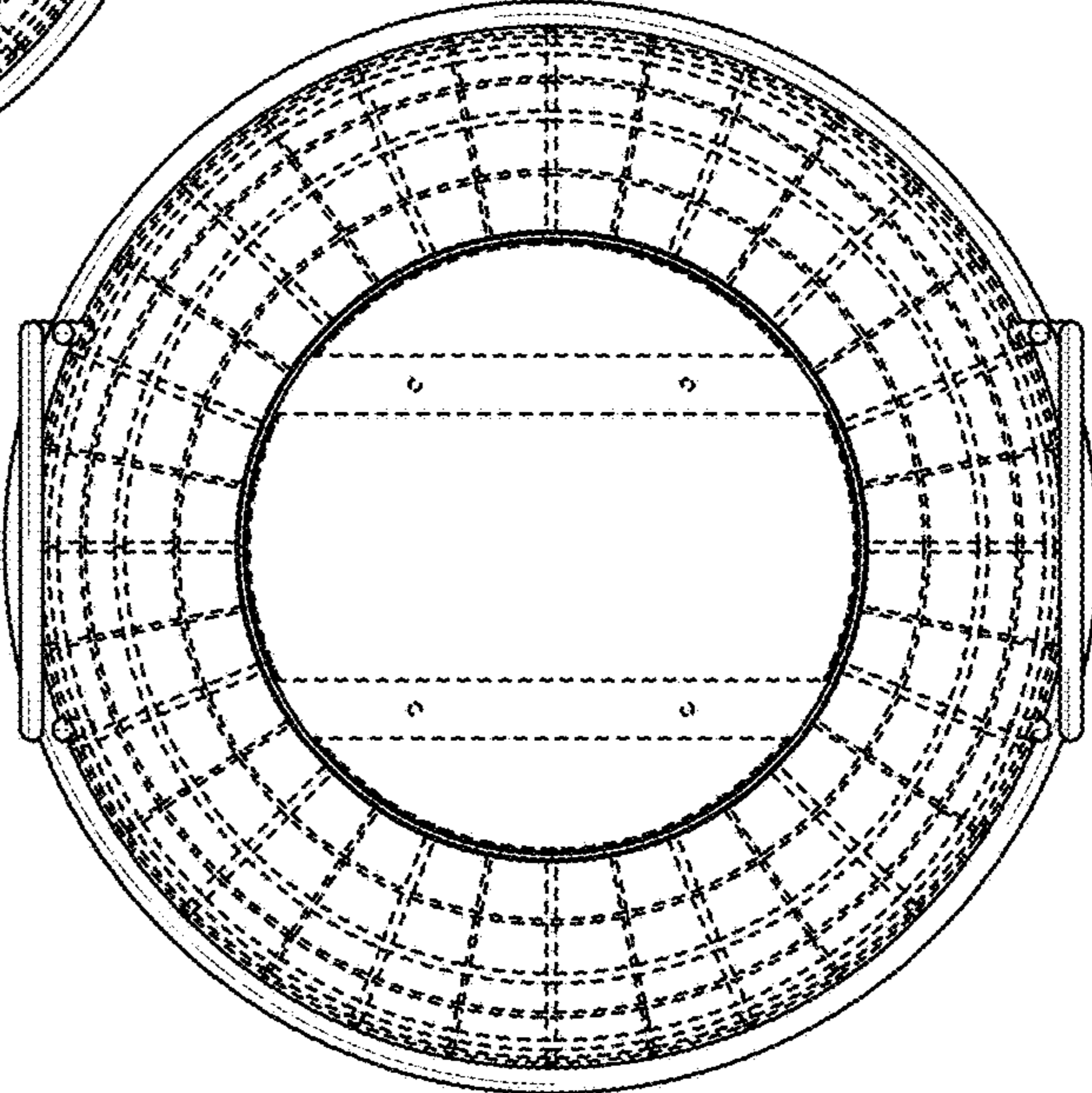
