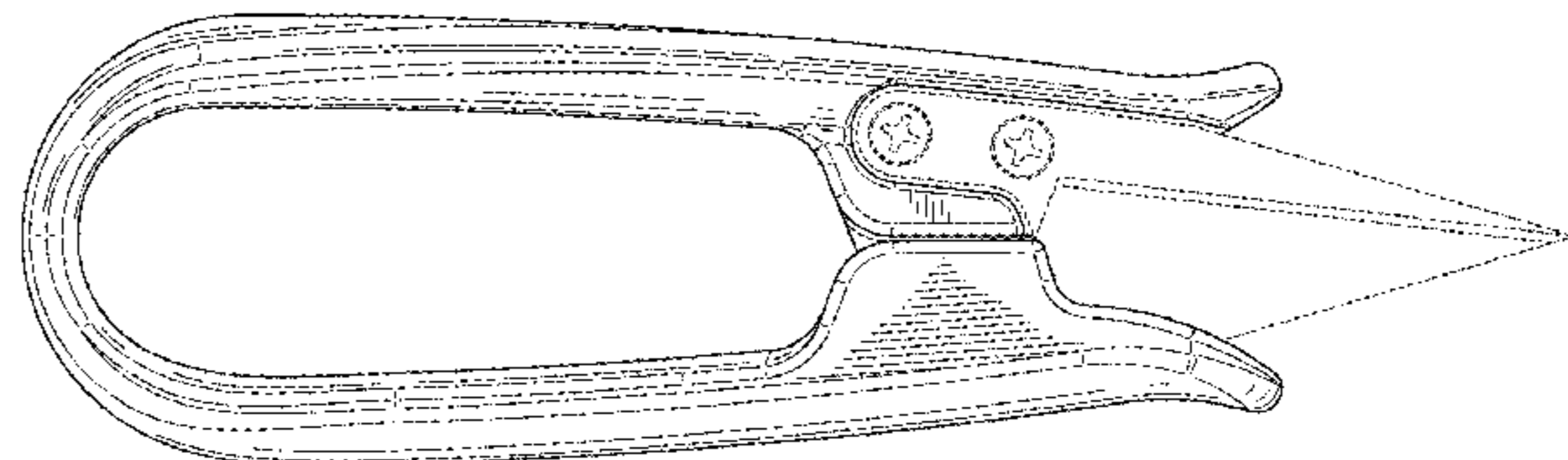
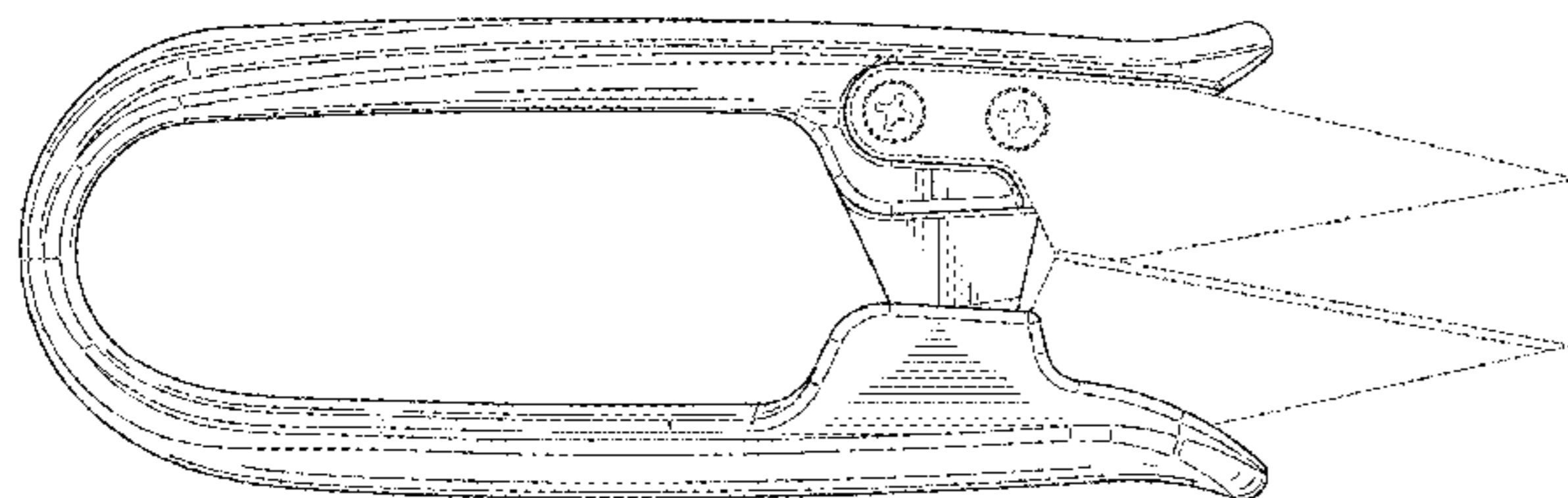
We claim the ornamental design for snips, as shown and described.

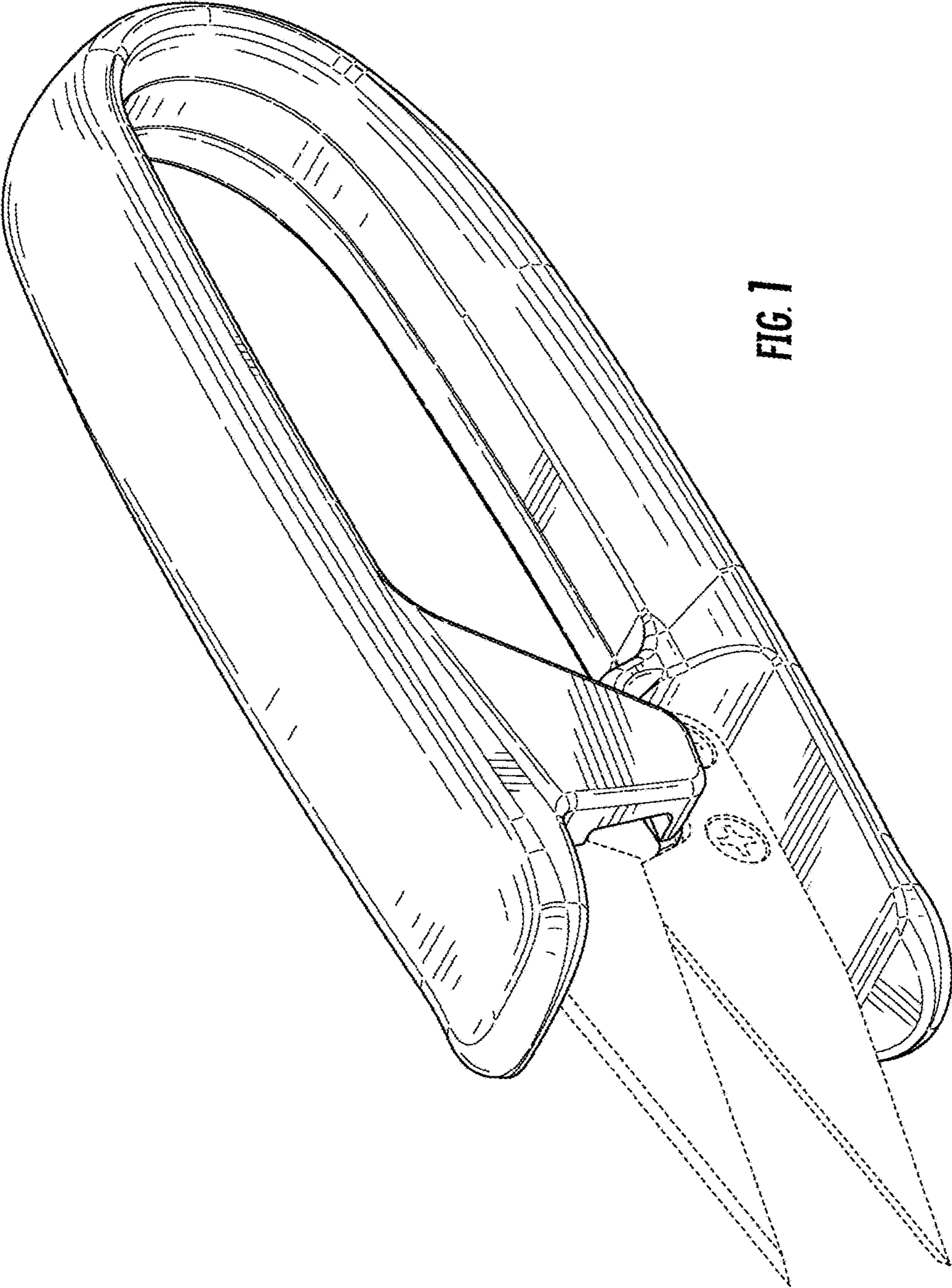
DESCRIPTION

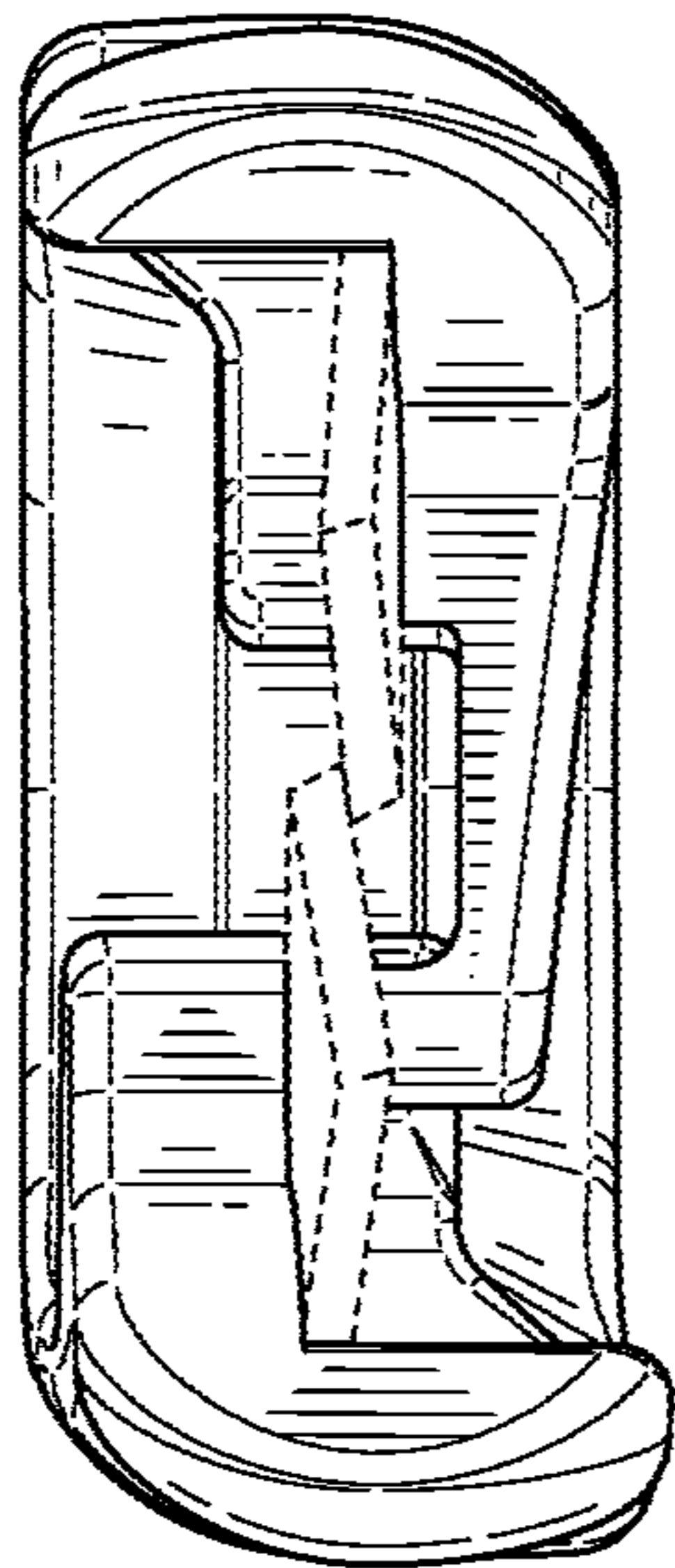

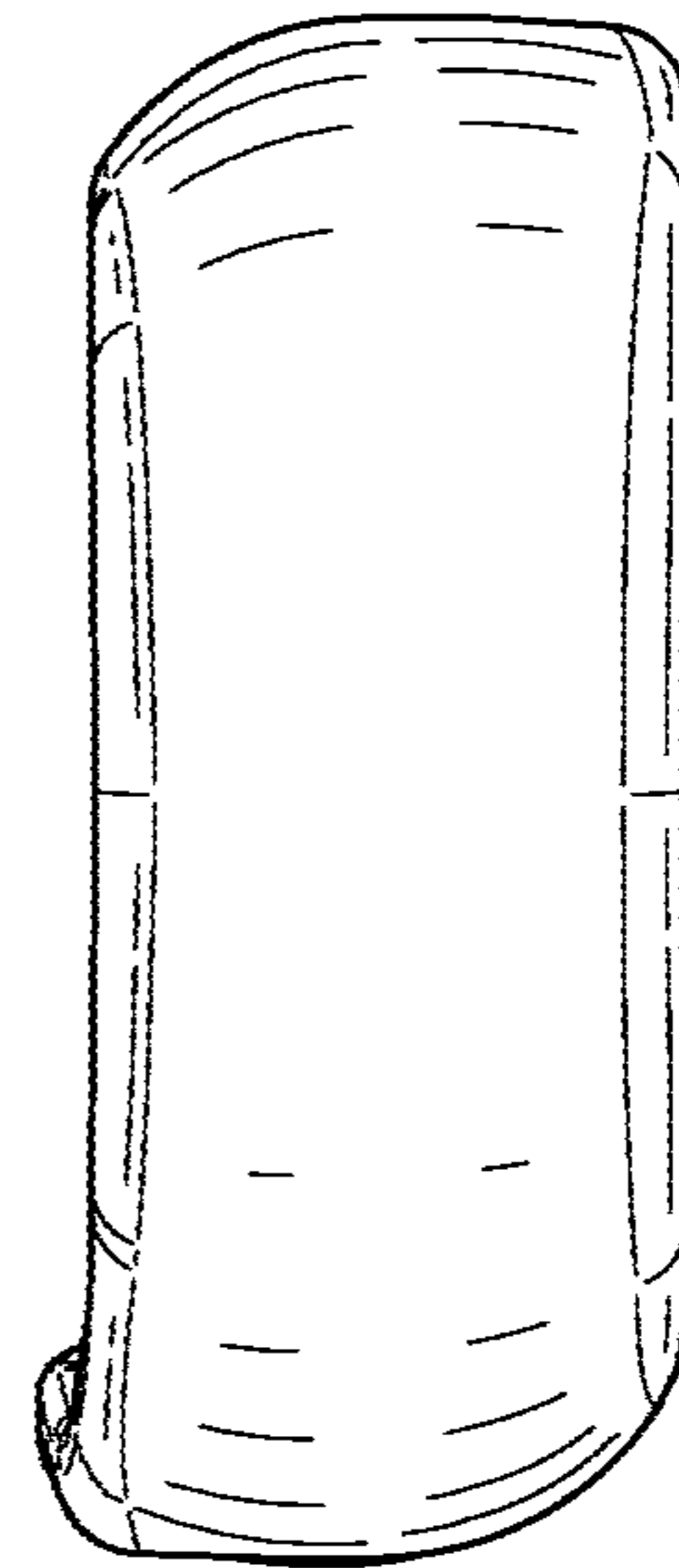

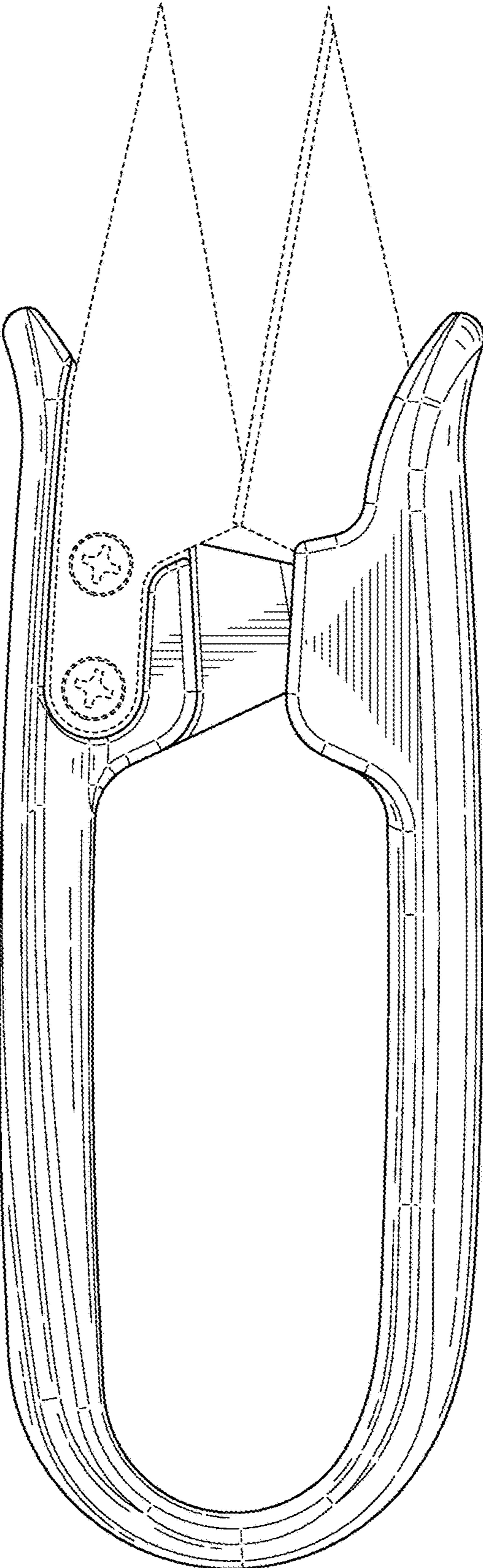

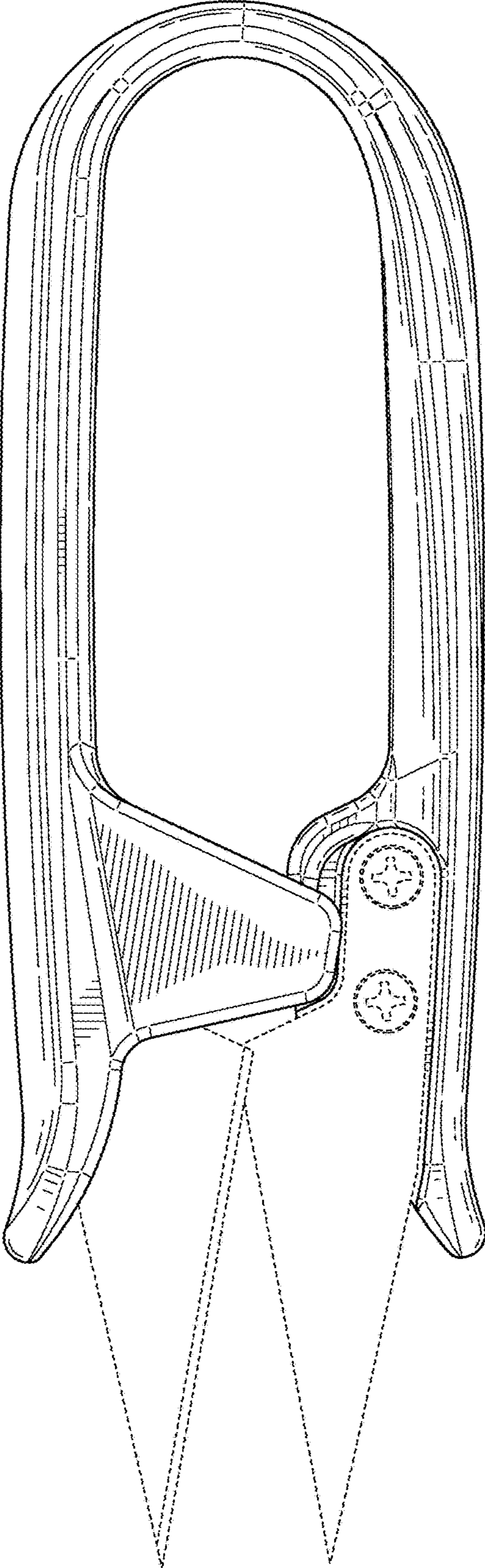

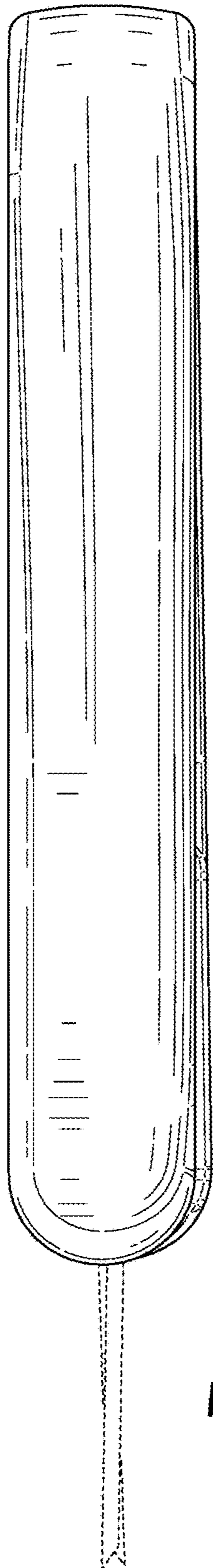

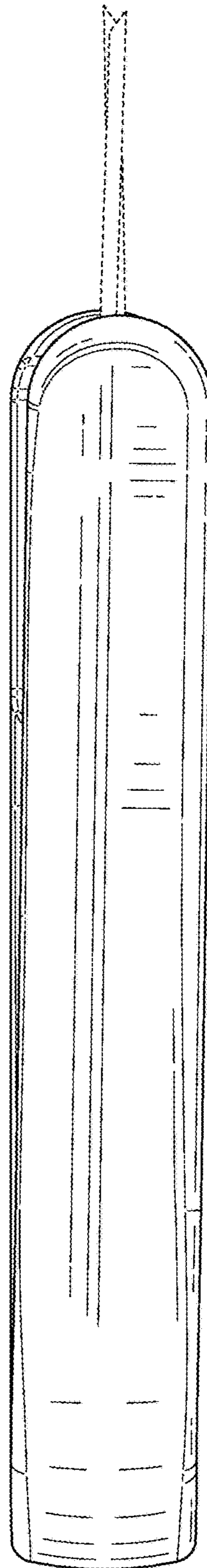

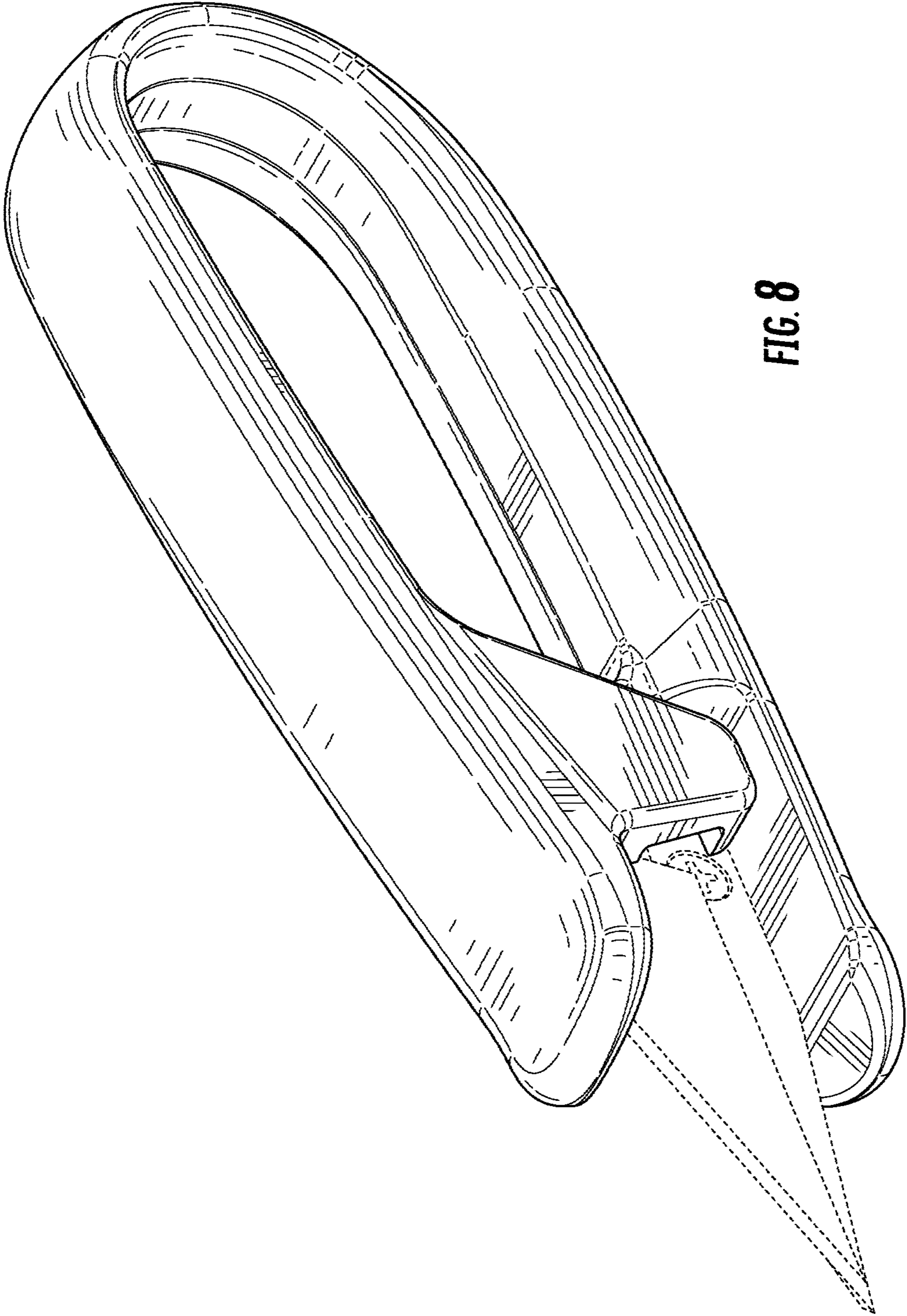

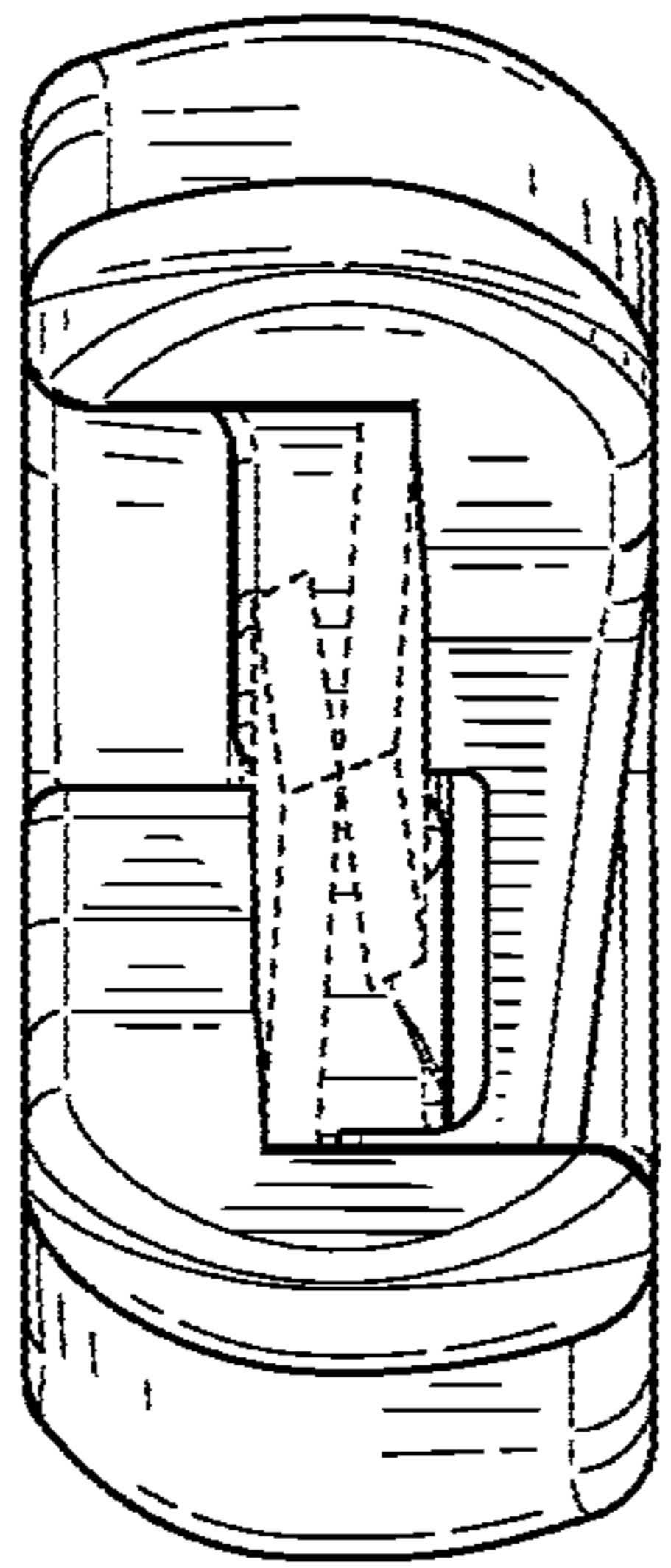

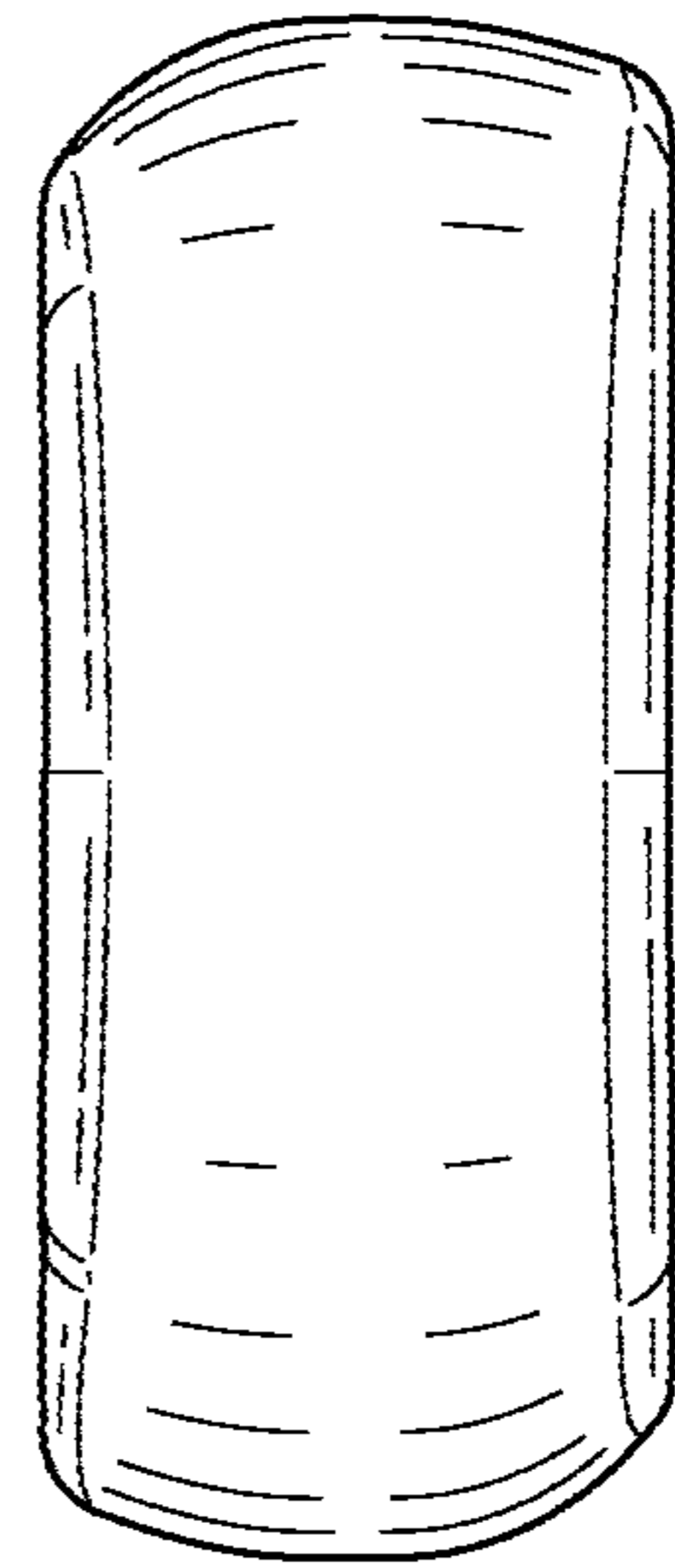

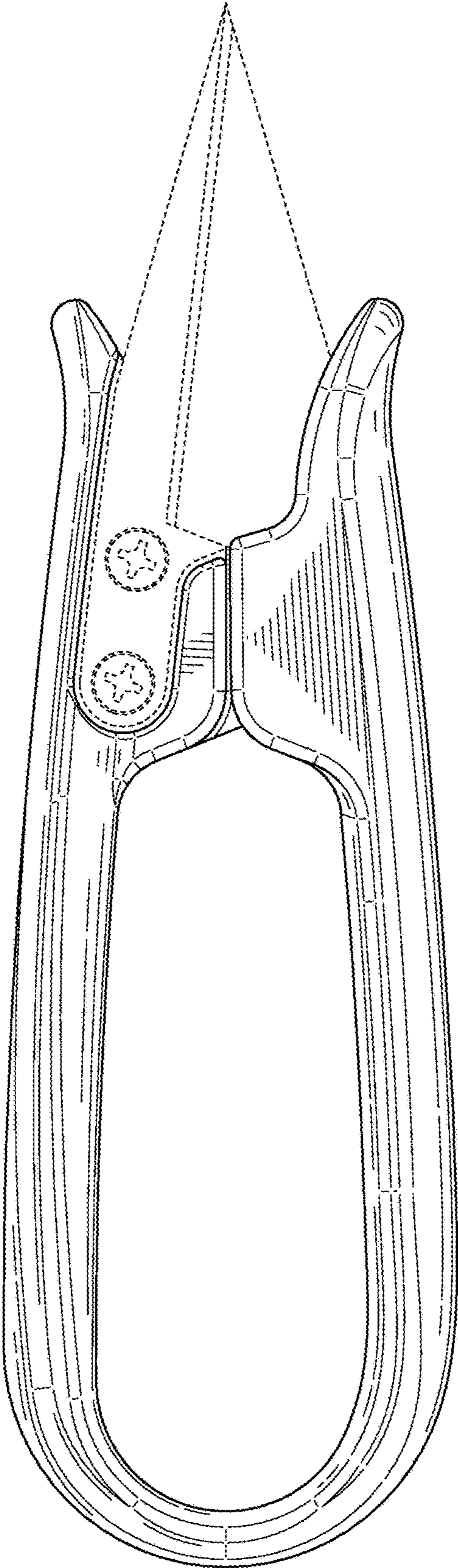

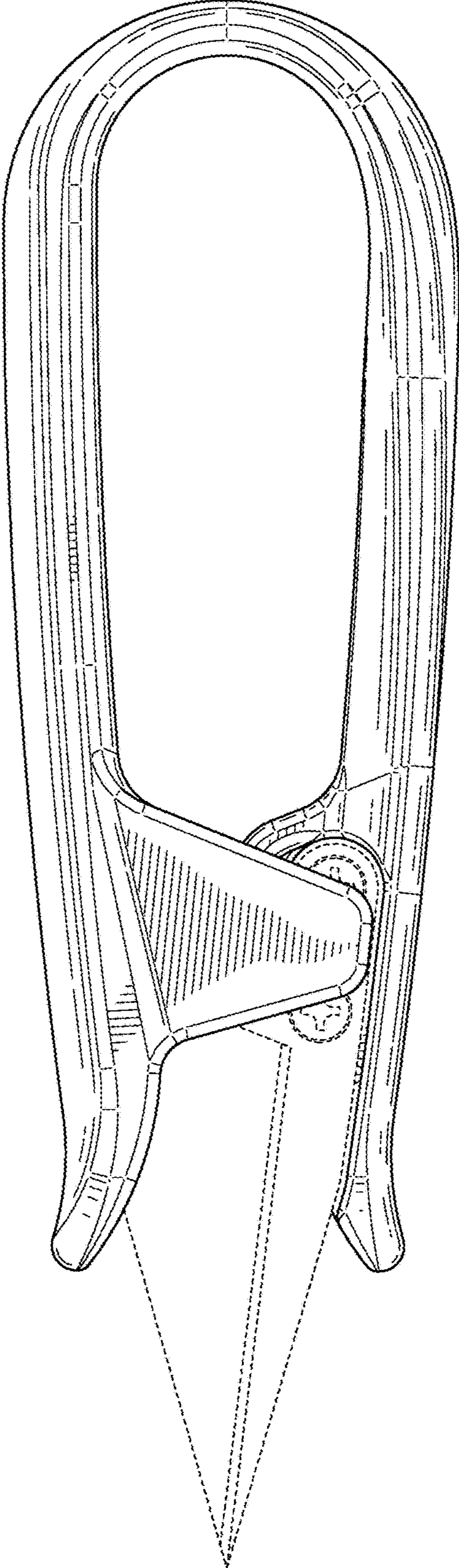

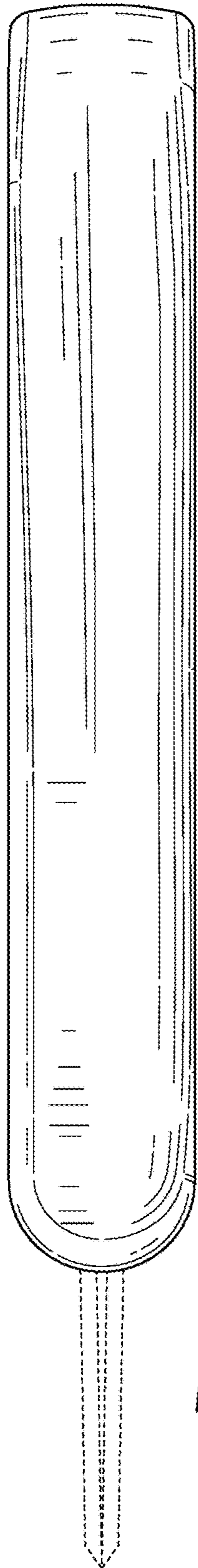

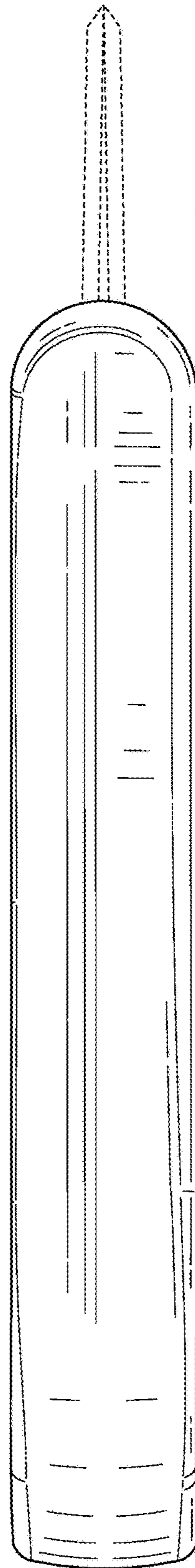
