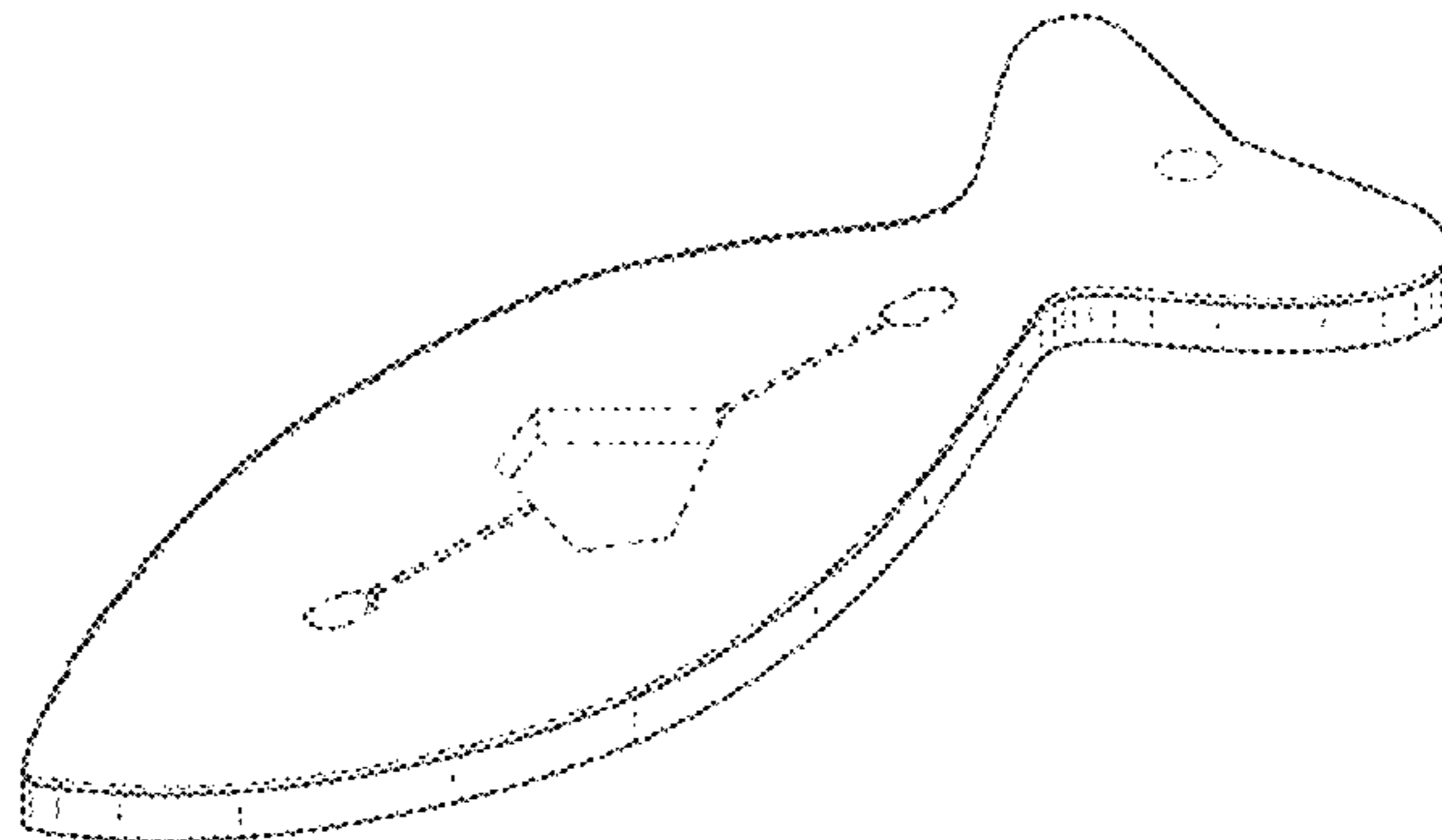
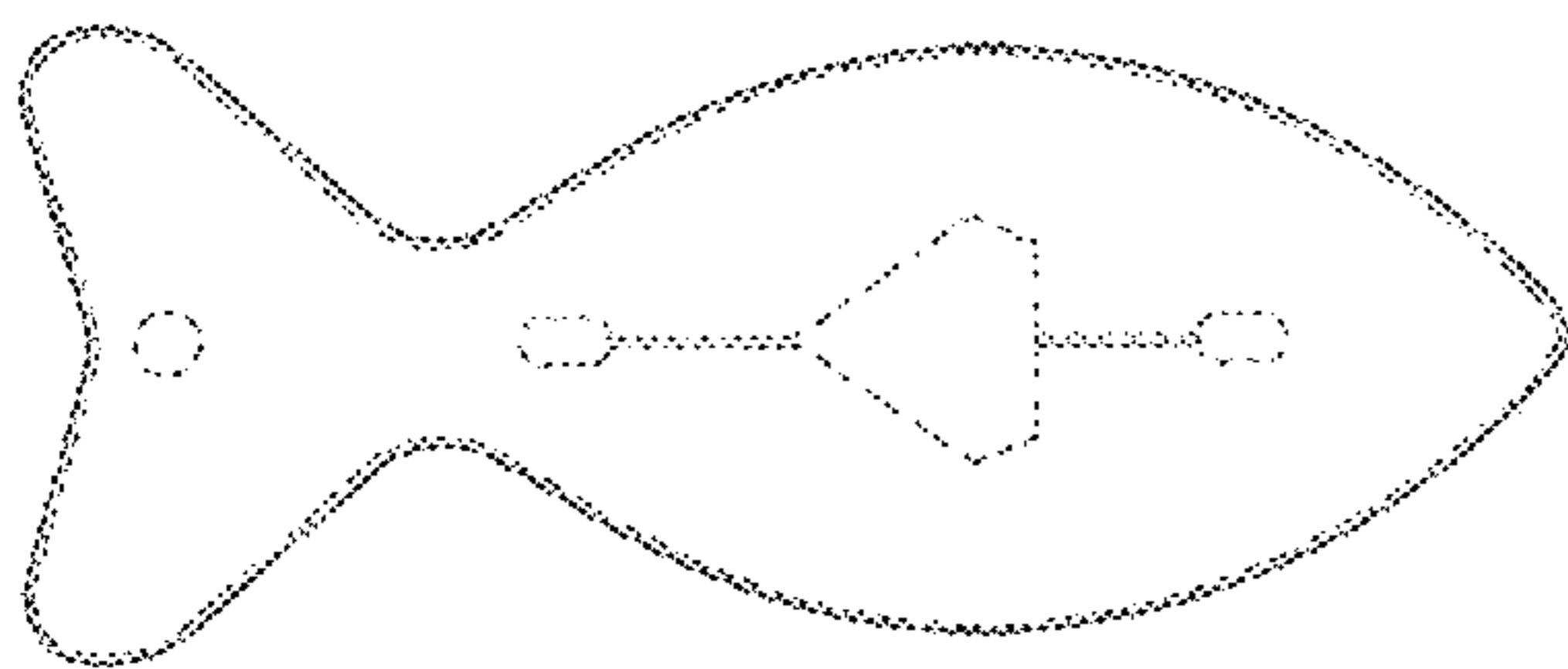
The ornamental design for a cable lock, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of a cable lock according to the design;

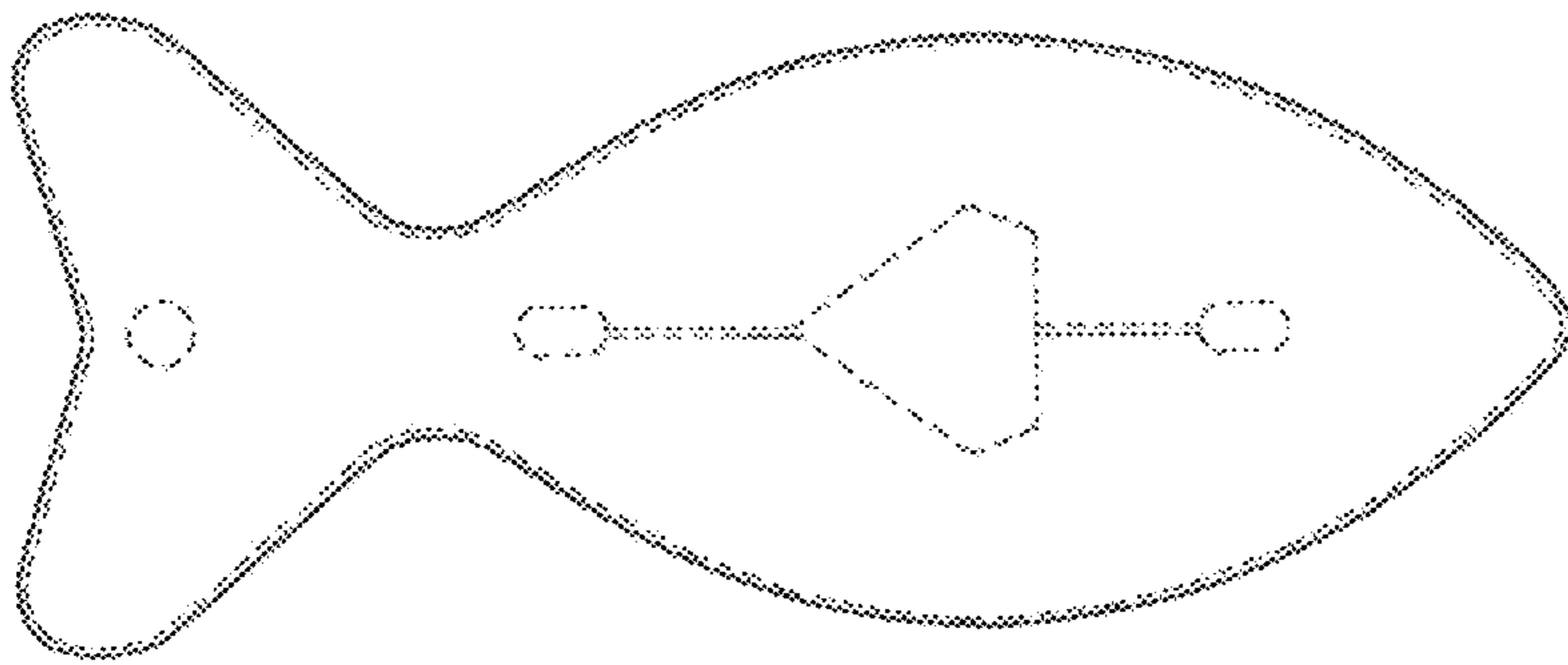

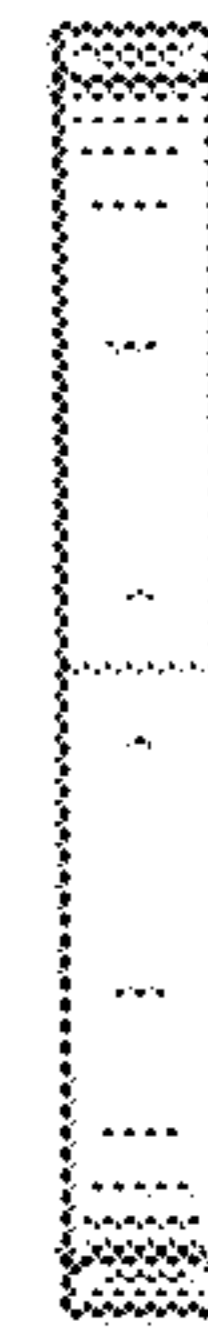

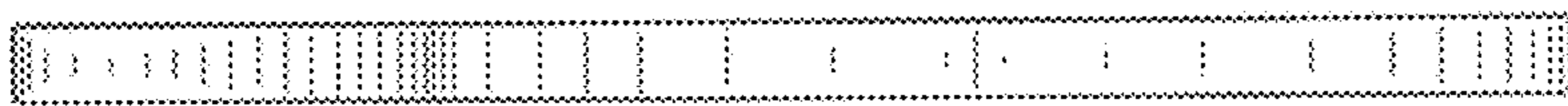

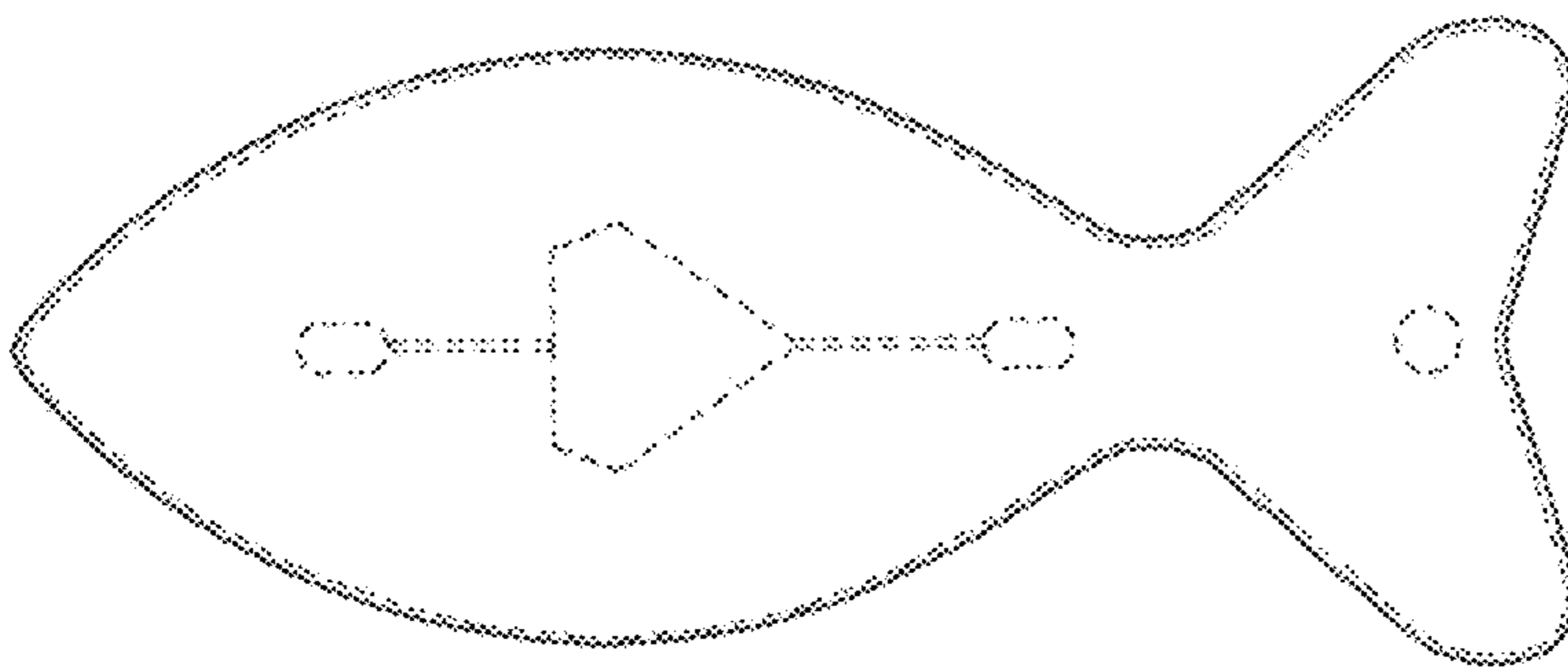

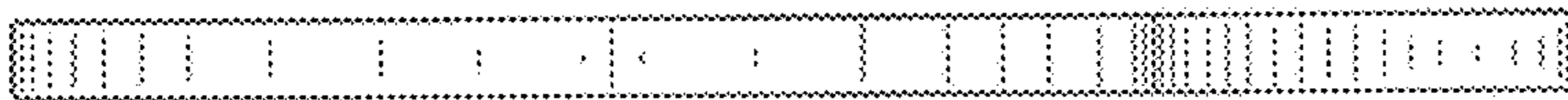

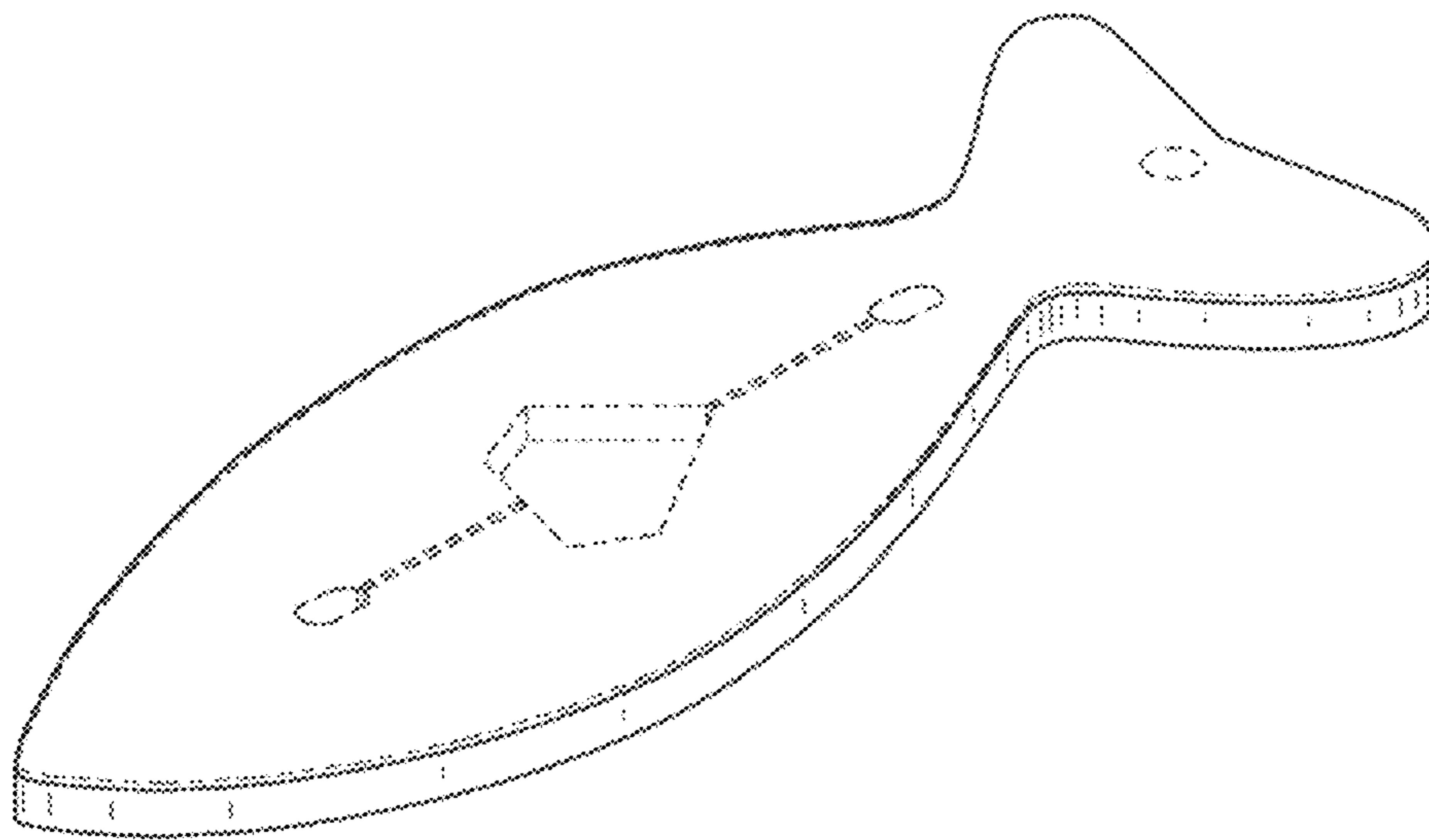
