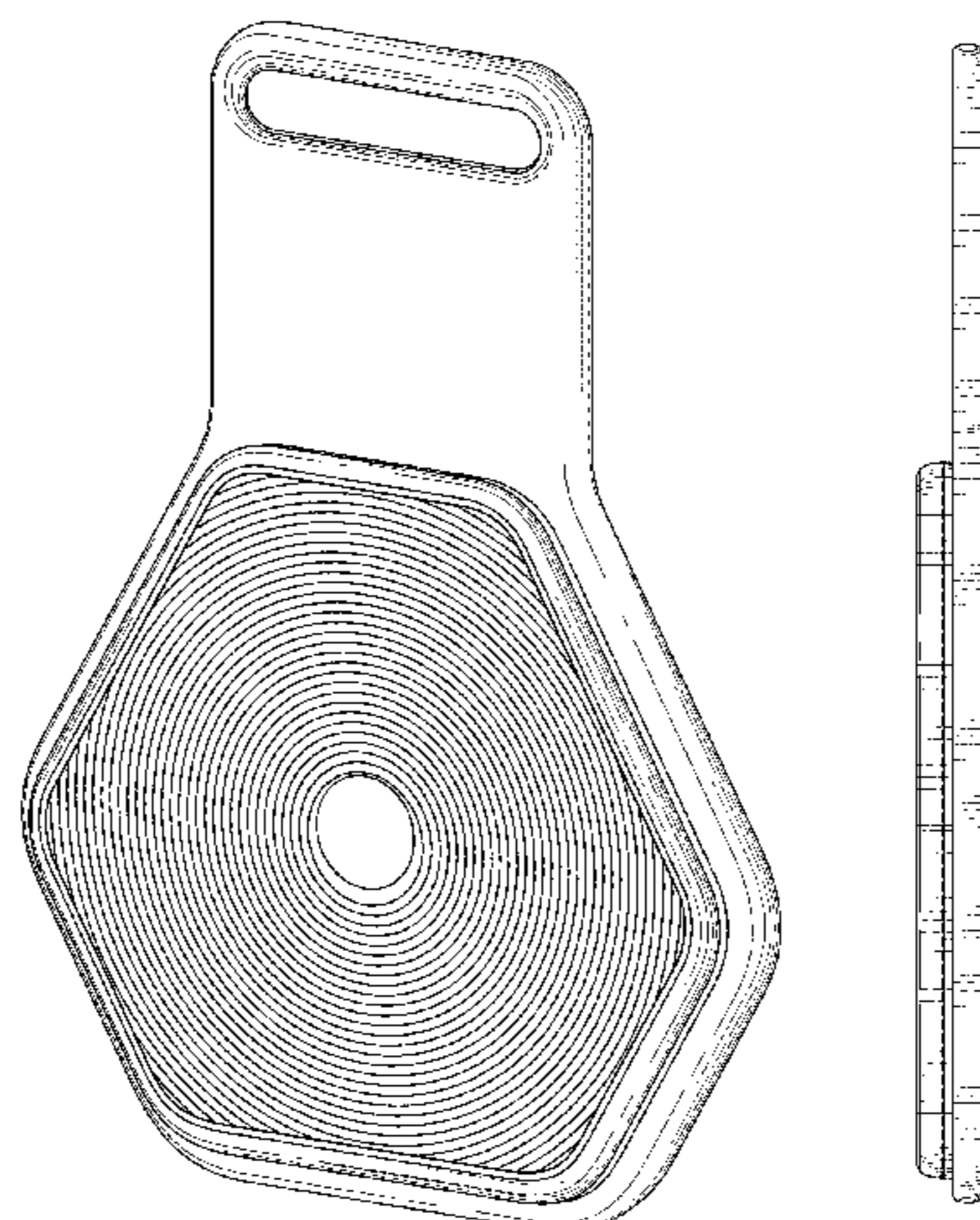


FIG. 7 is a bottom view of the wearable personal identification device.

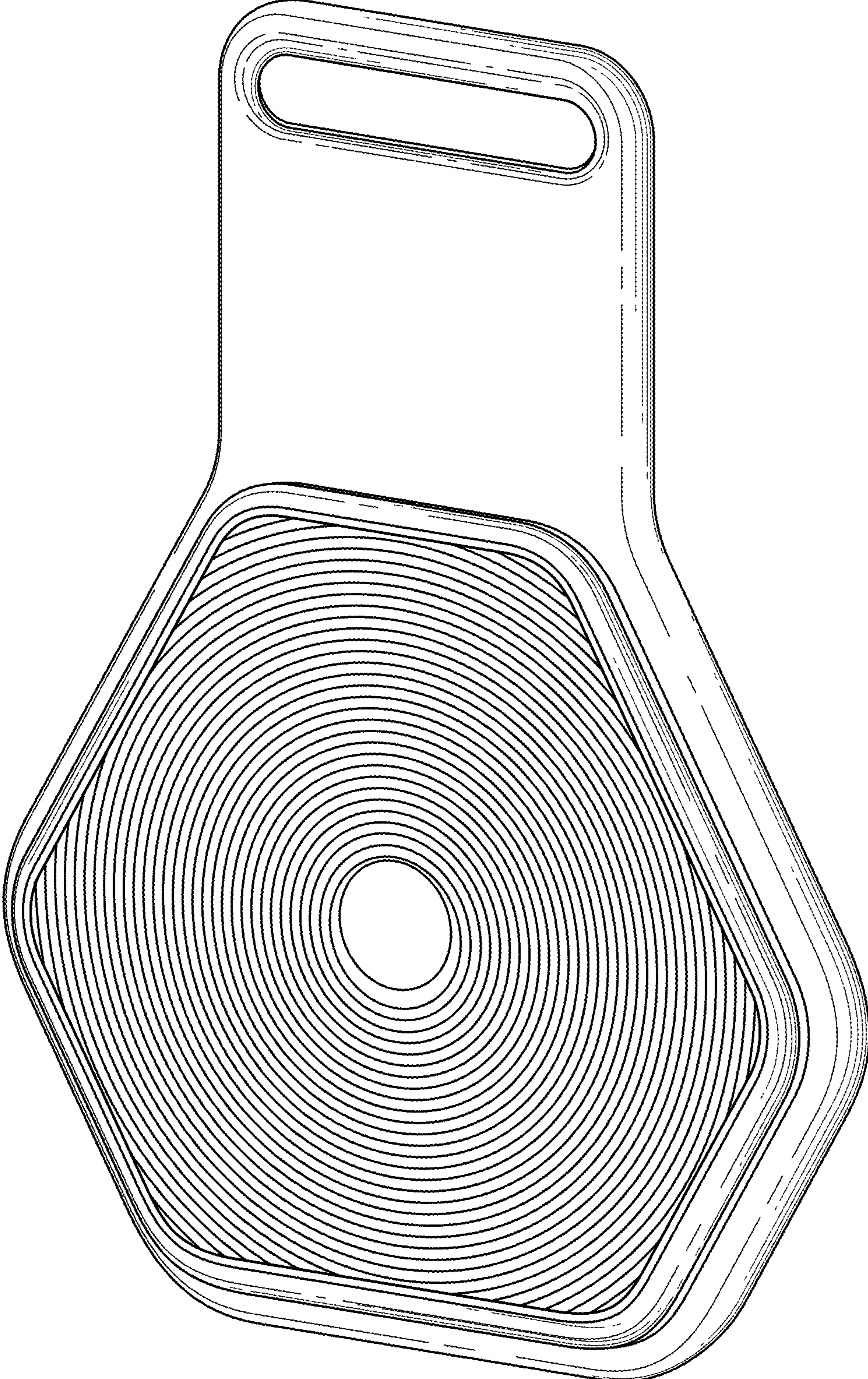

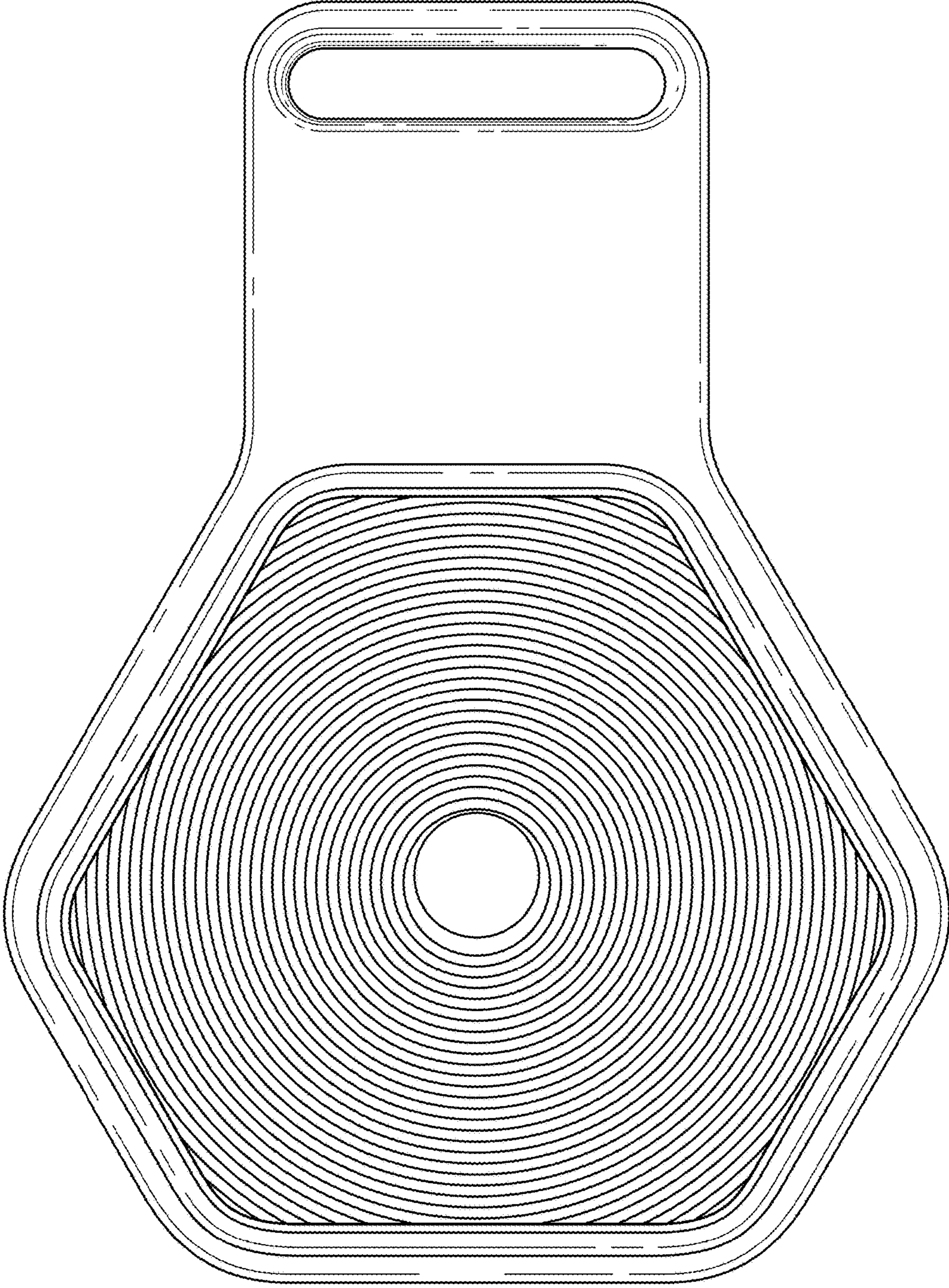

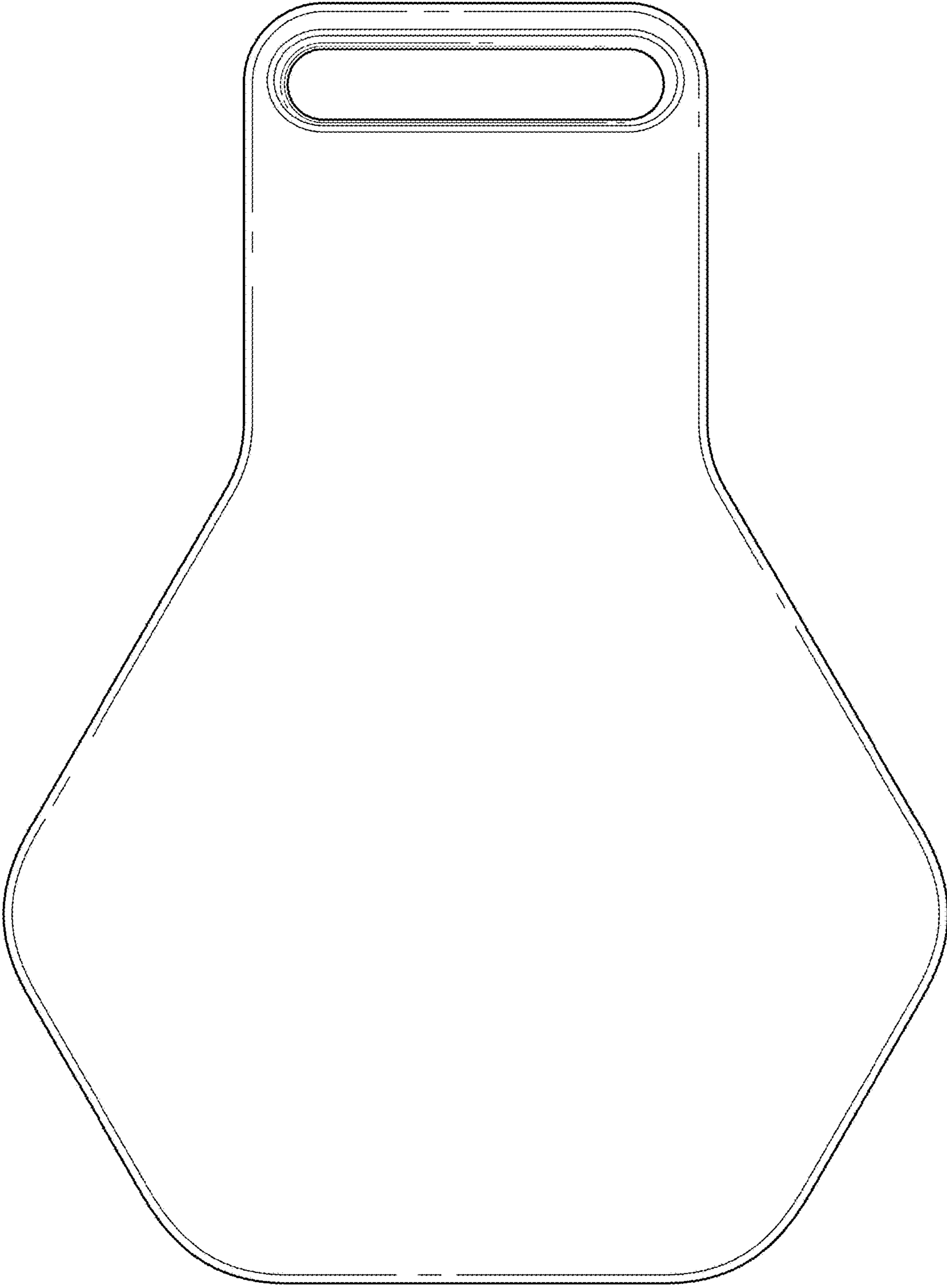

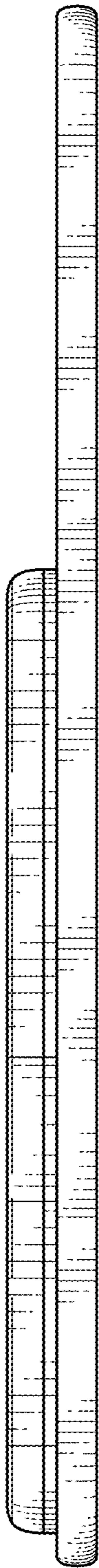

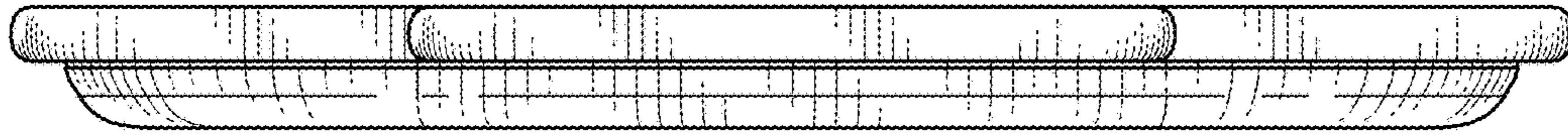

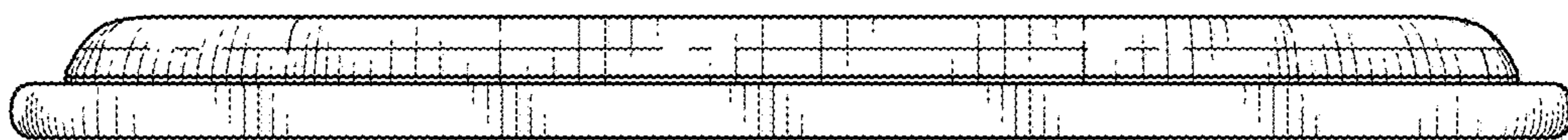
