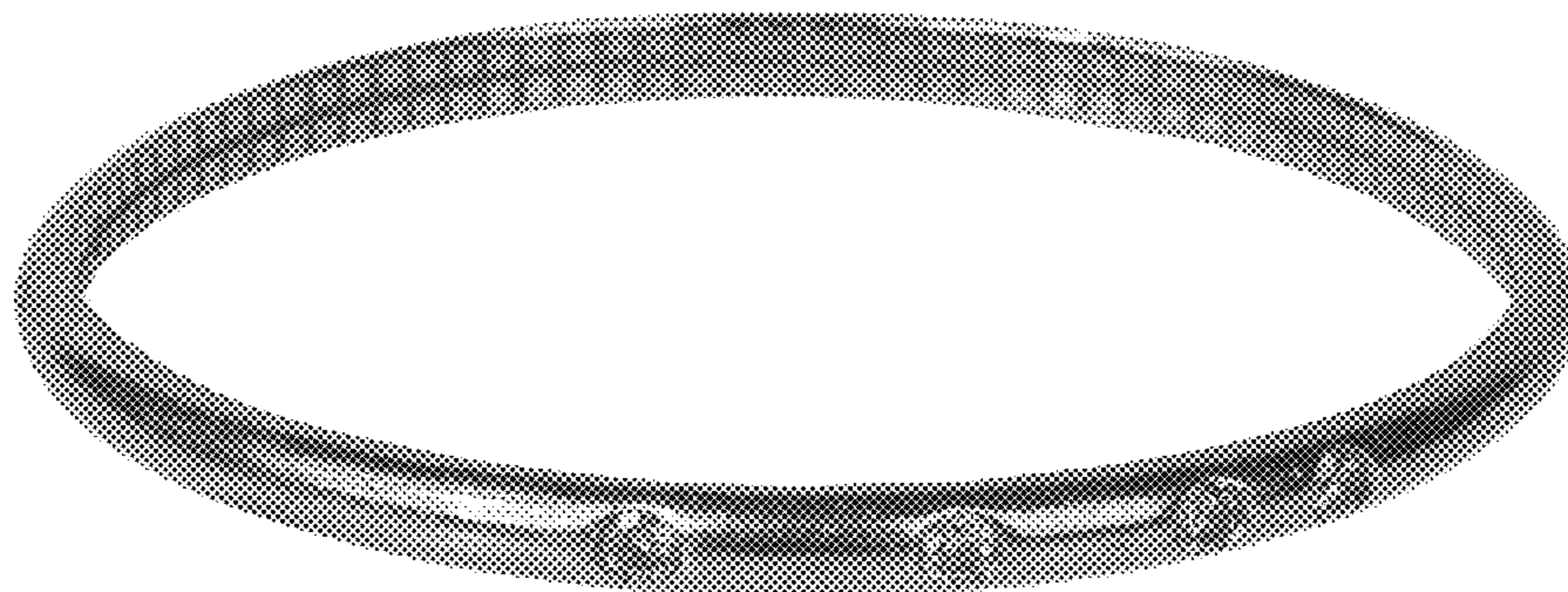

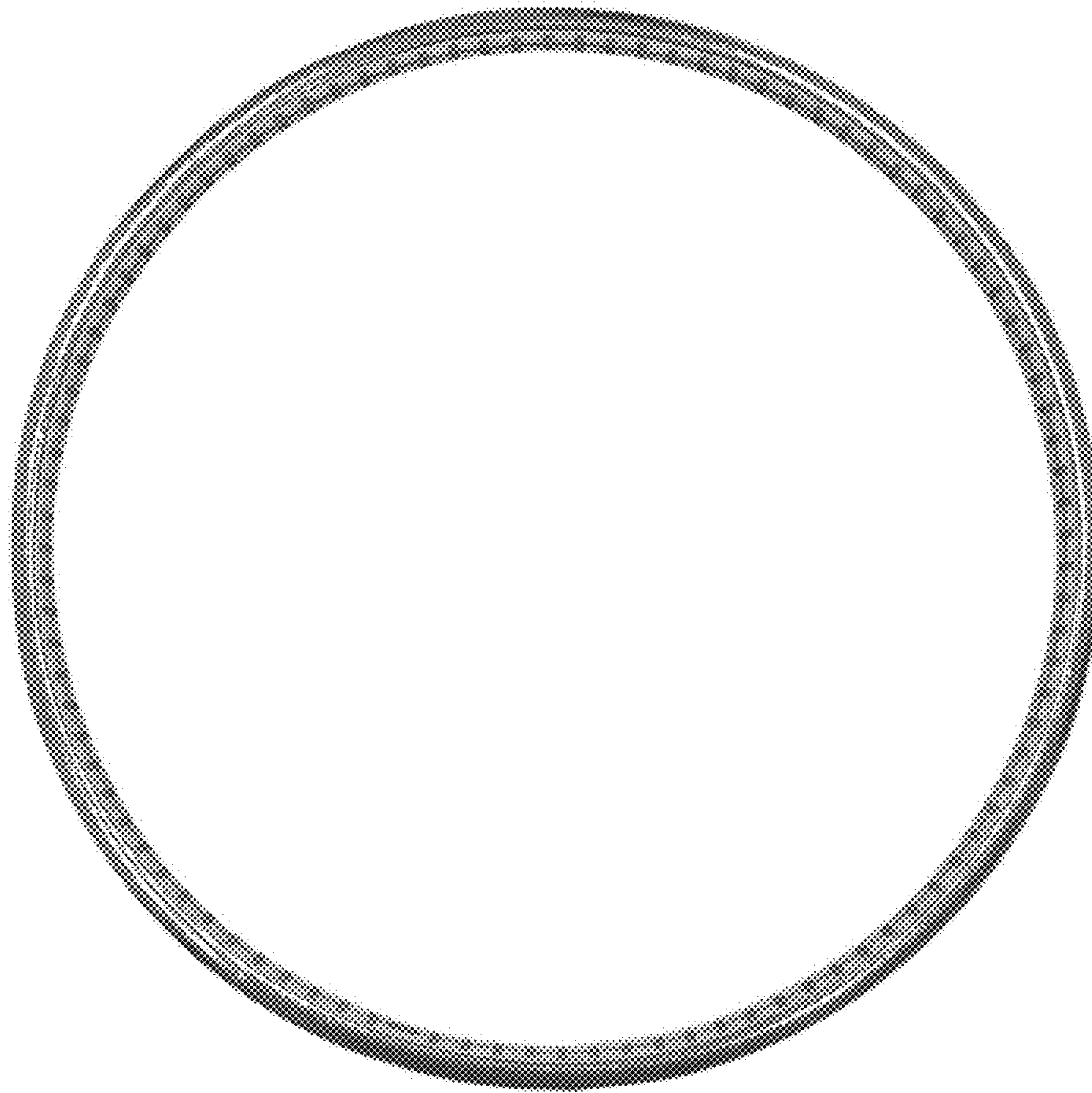
The ornamental design for a bracelet, as shown and described.

DESCRIPTION

1. Bracelet
1.1 : is a top view of the bracelet;
1.2 : is a front view thereof;
1.3 : is another front view thereof;
1.4 : is a side view rotated 90° from the front view;
1.5 : is a side view rotated 180° from the side view of 1.4;
1.6 : is another side view rotated 180° from the side view of 1.4; and
1.7 : is a top and side perspective view.

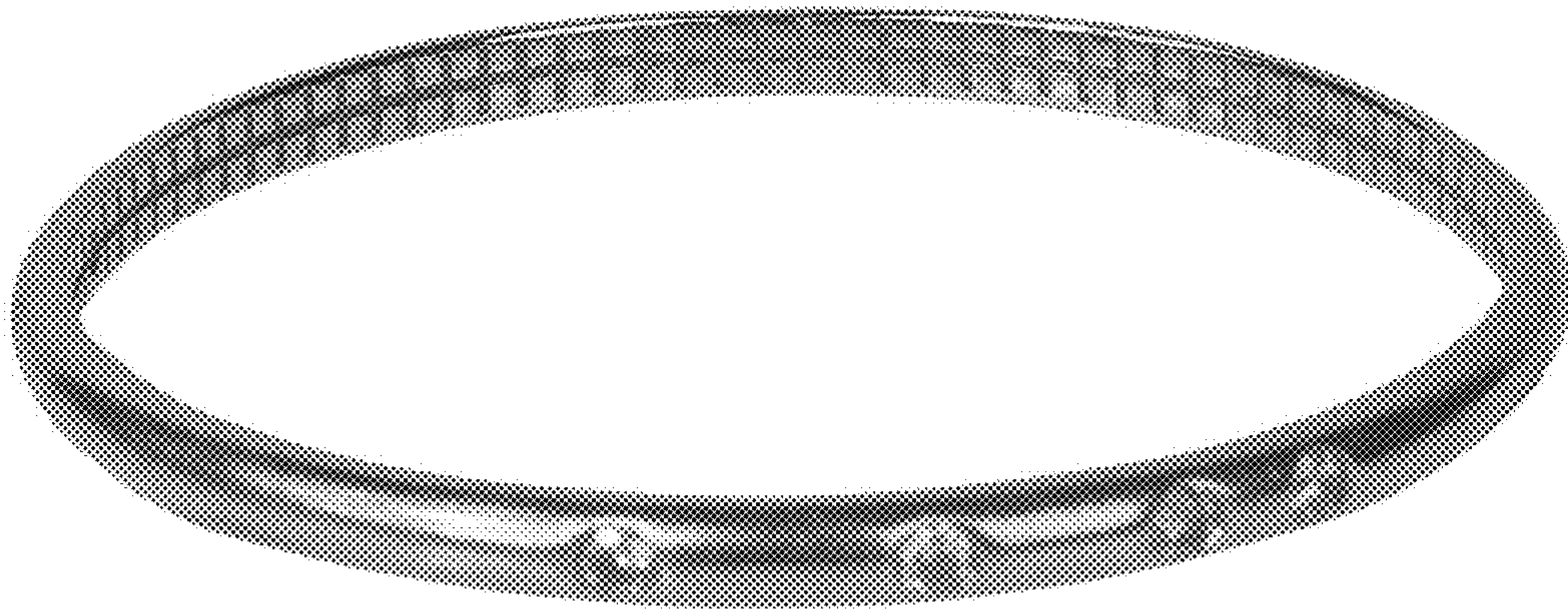

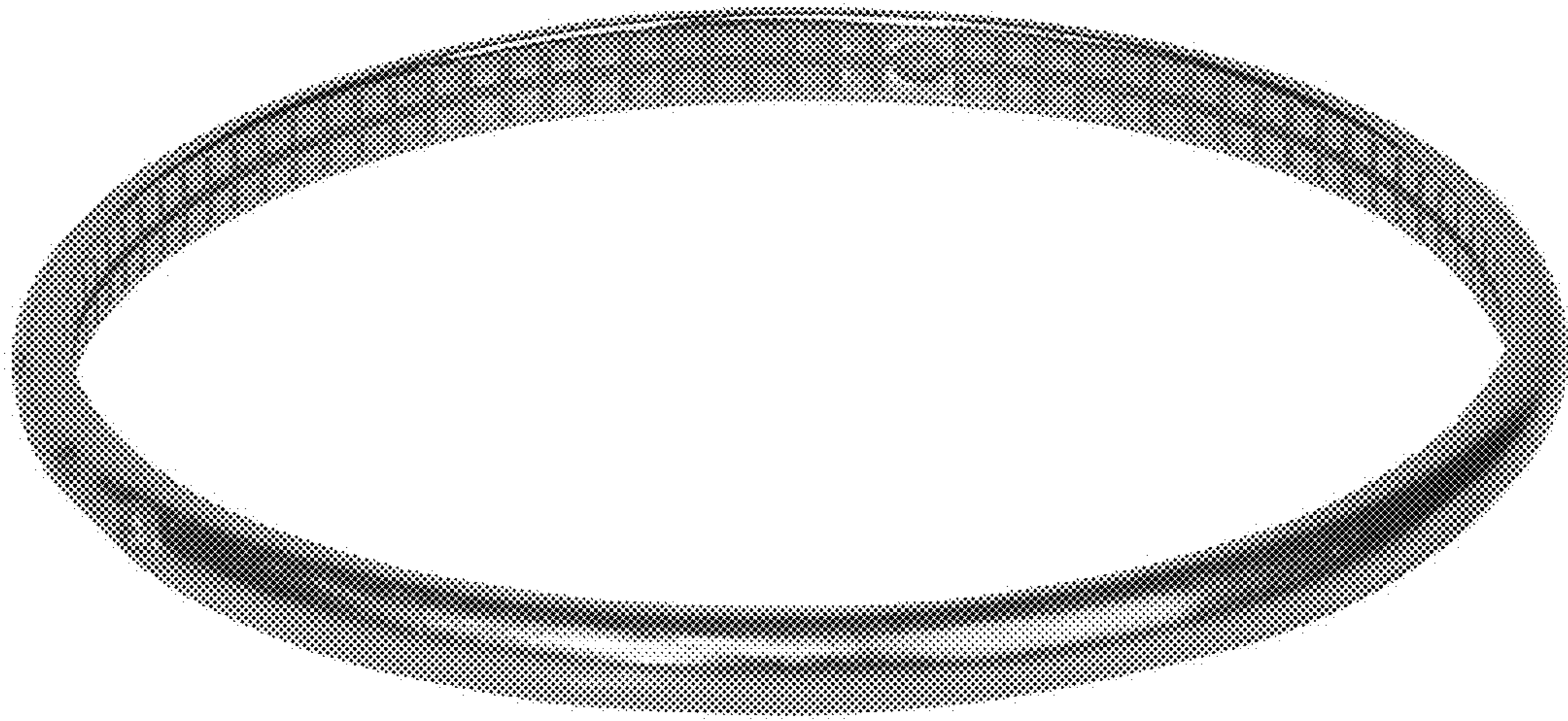

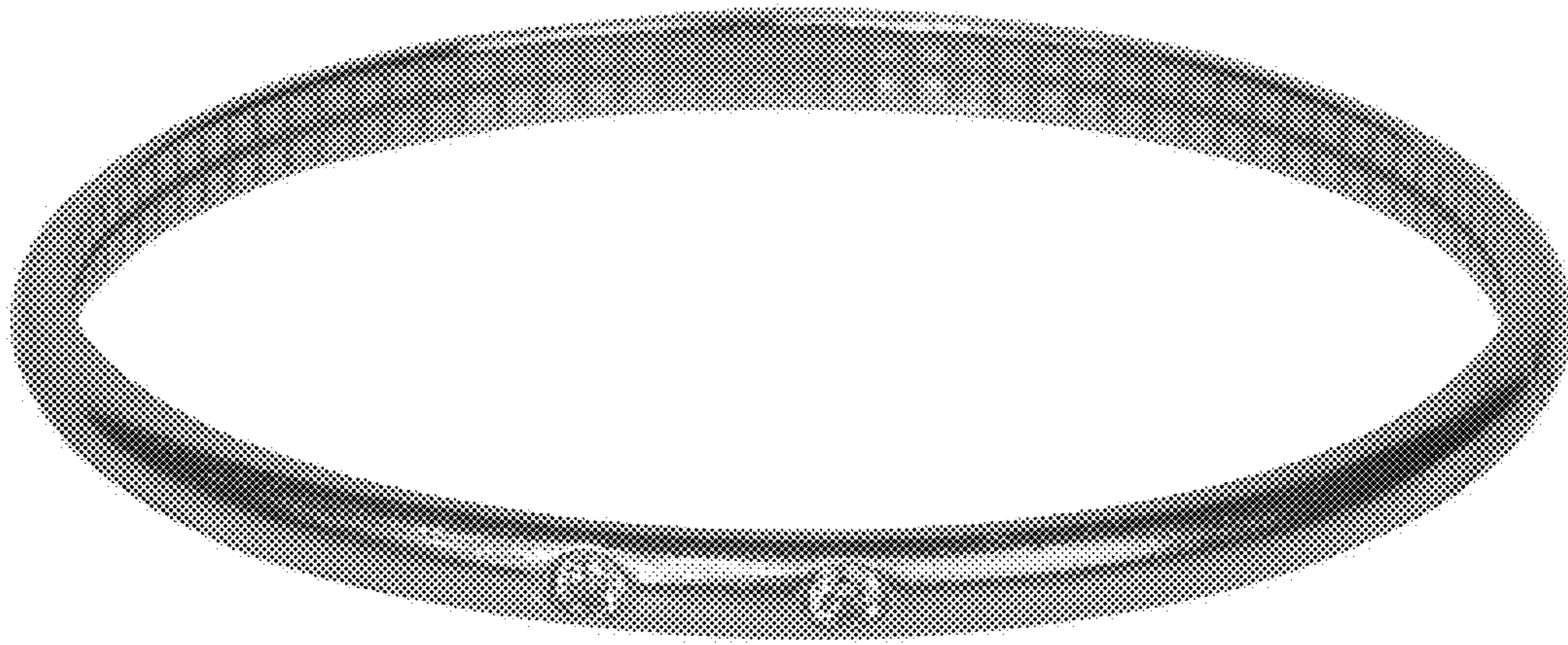




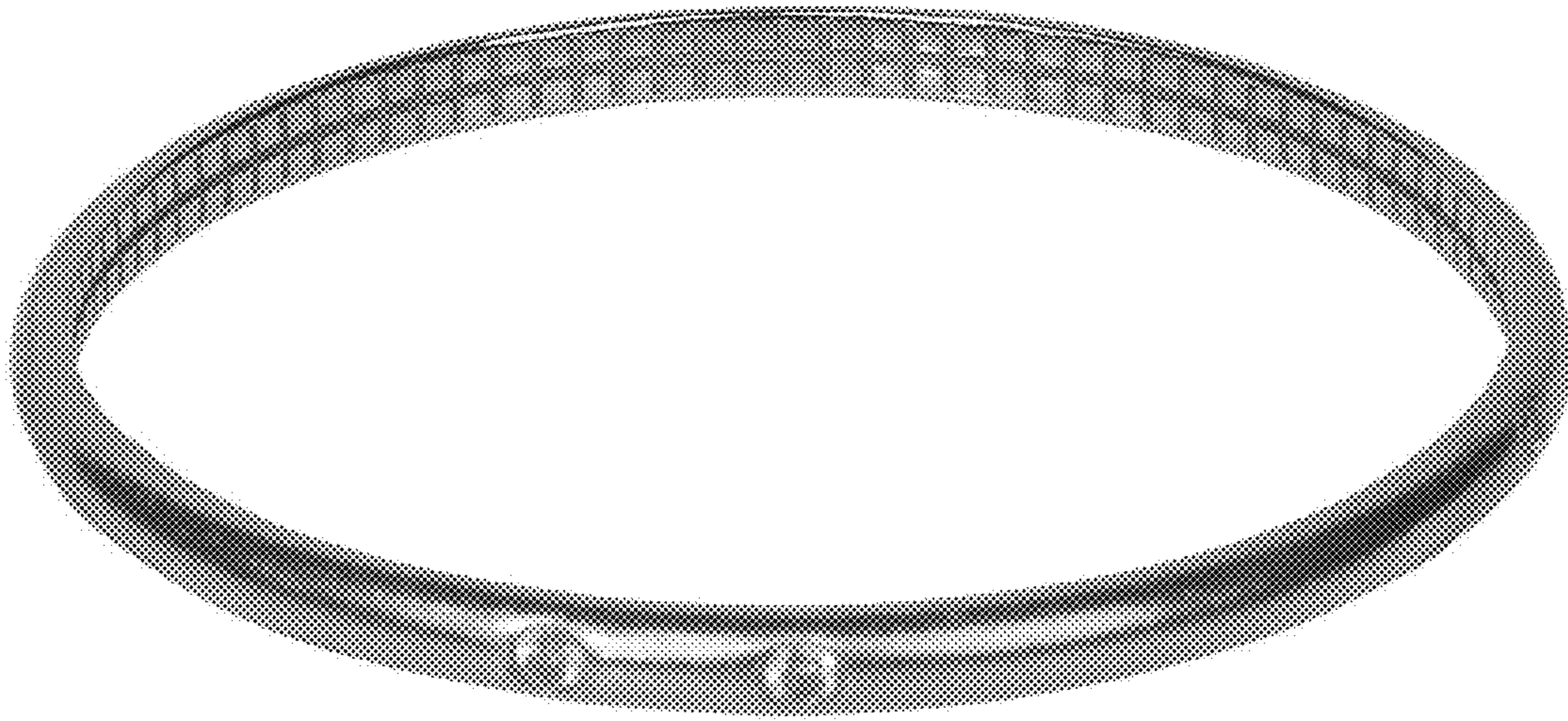
