The ornamental design for an earring, as shown and described.

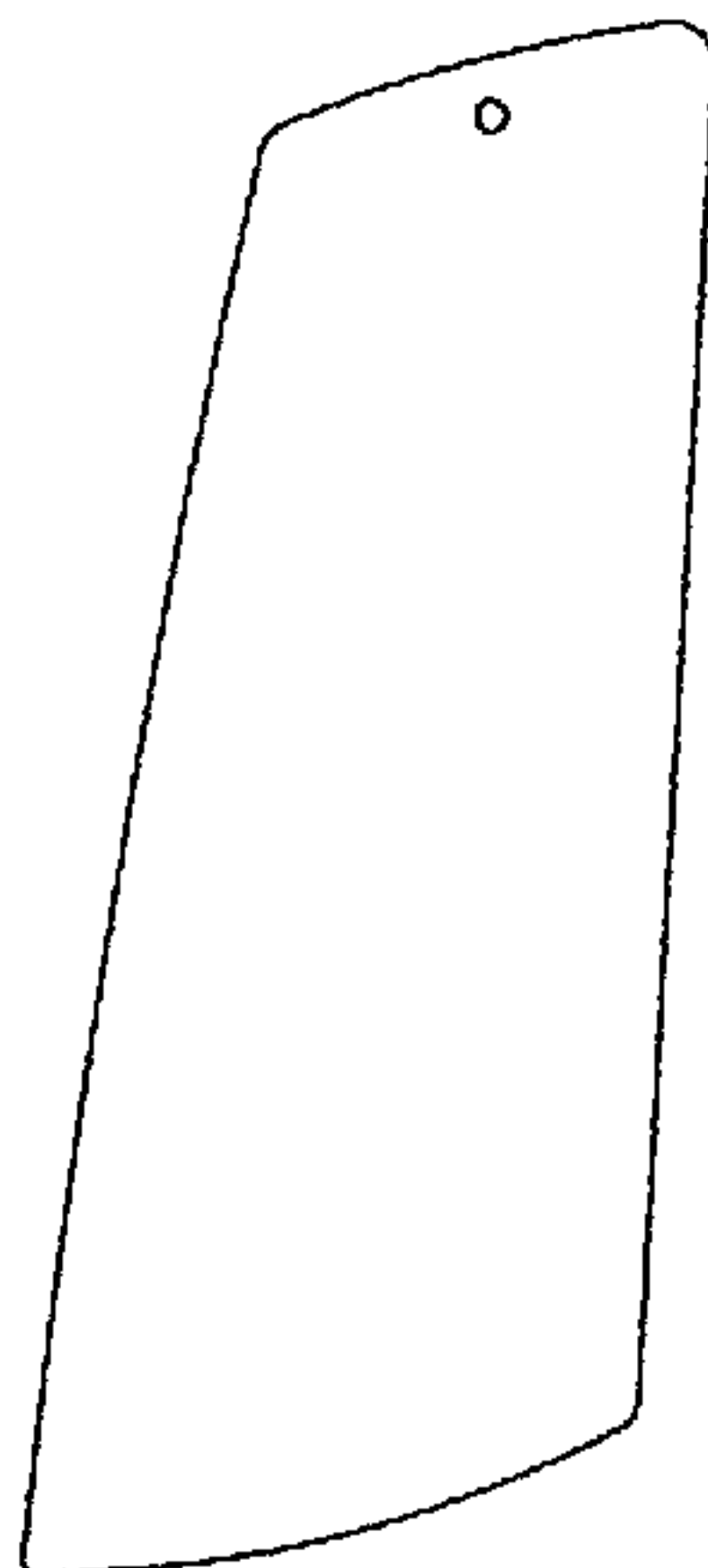
**DESCRIPTION**

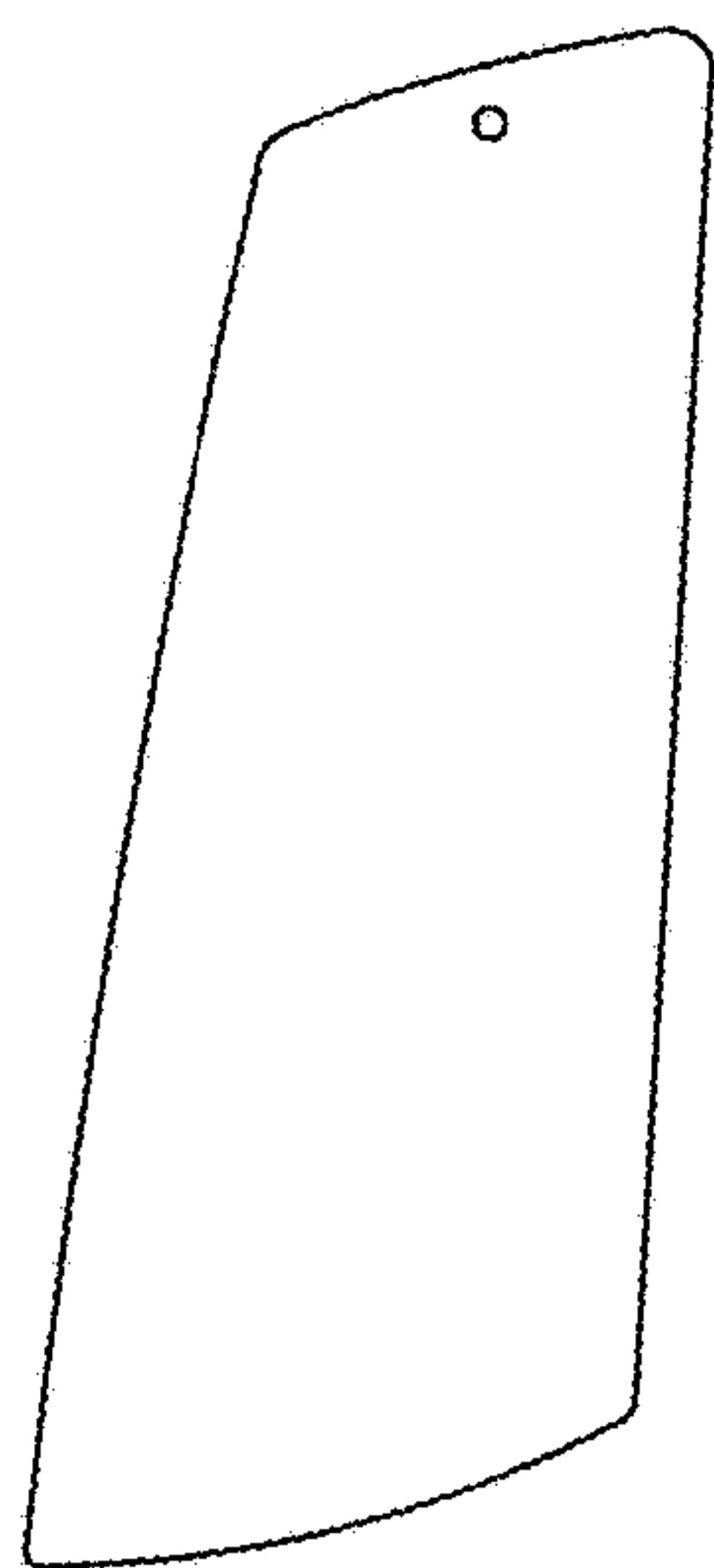

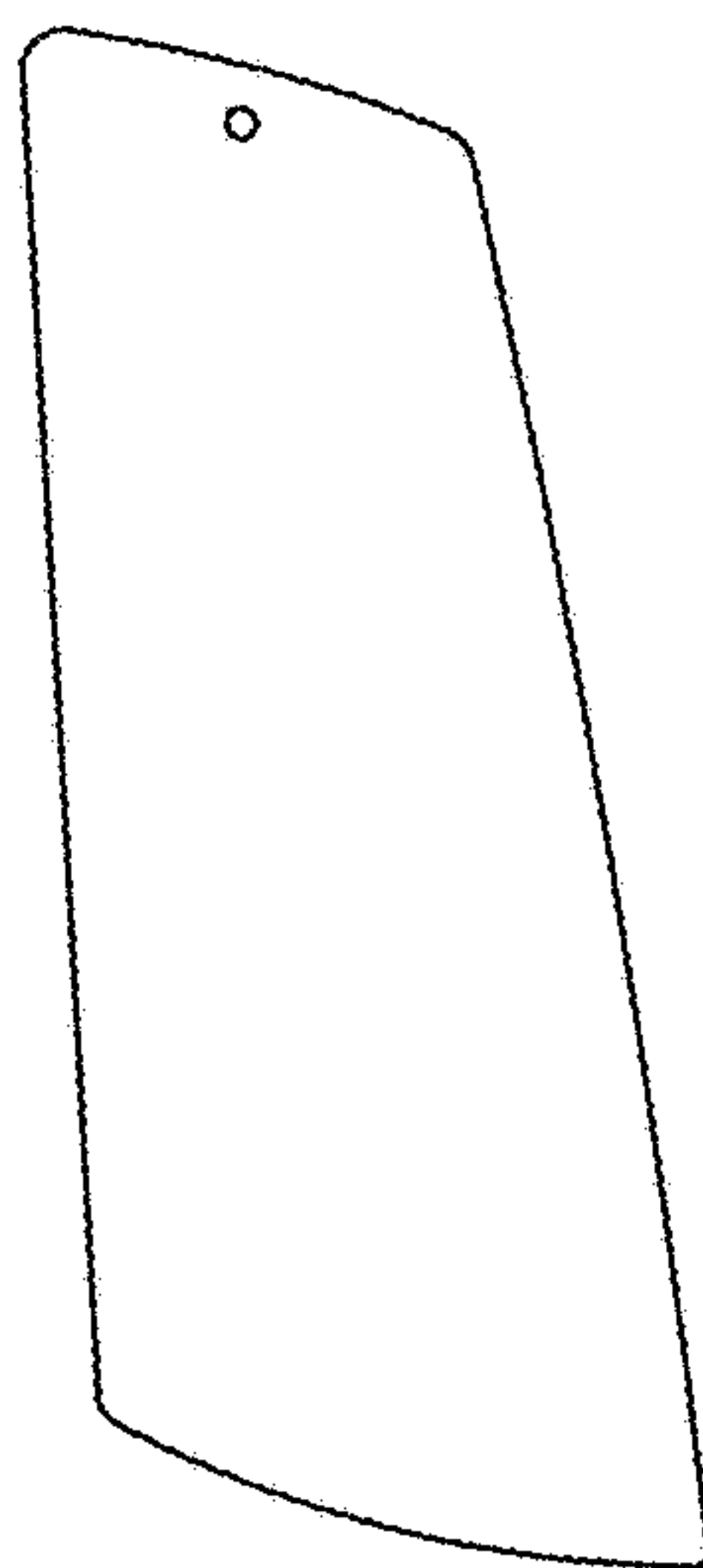

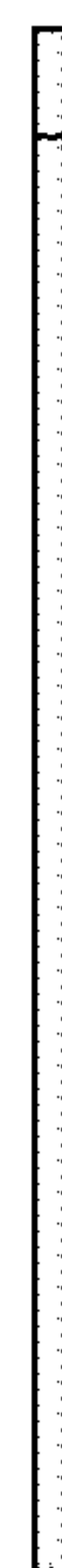
