The ornamental design for a two stone pendant, as shown and described.

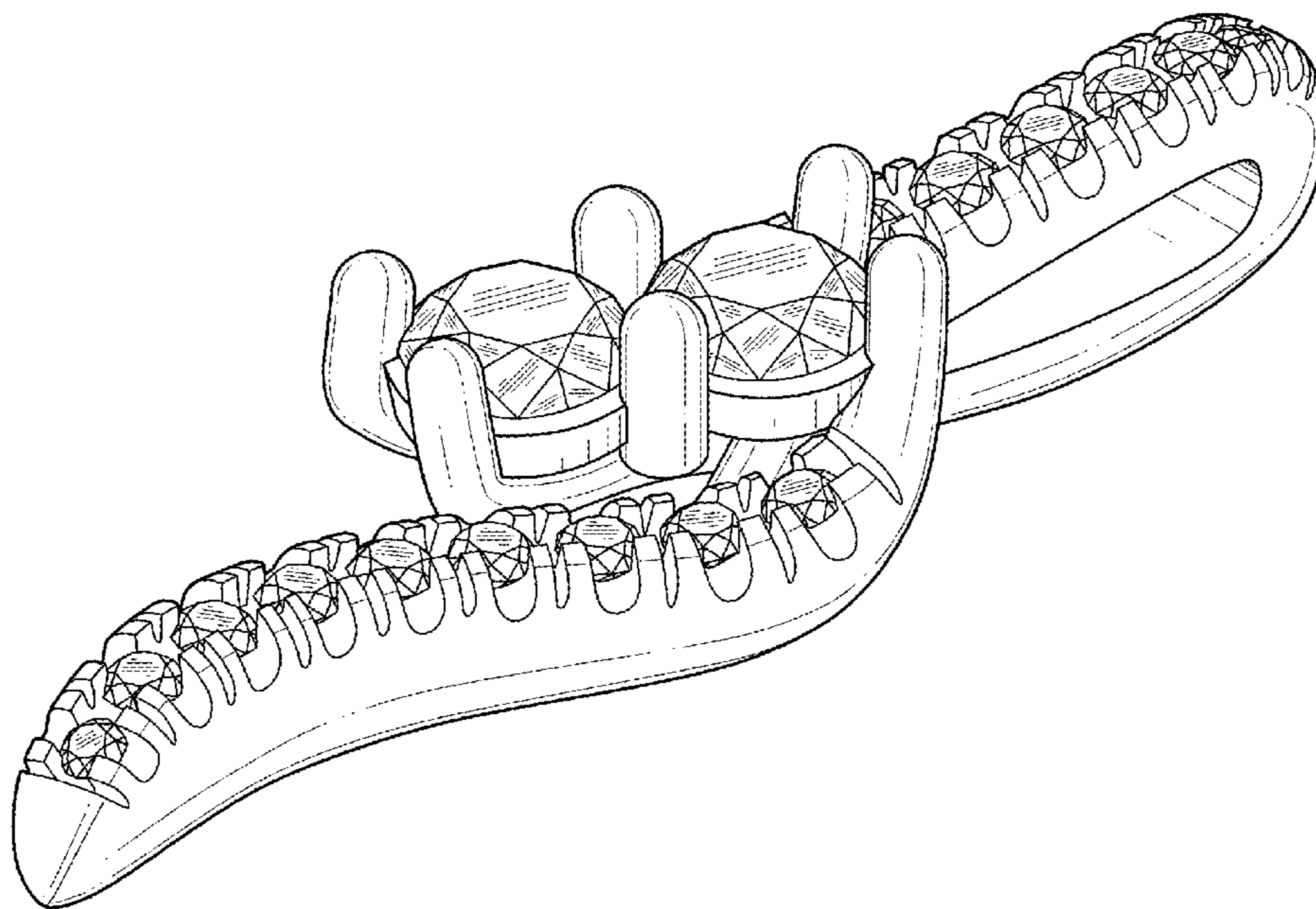
DESCRIPTION

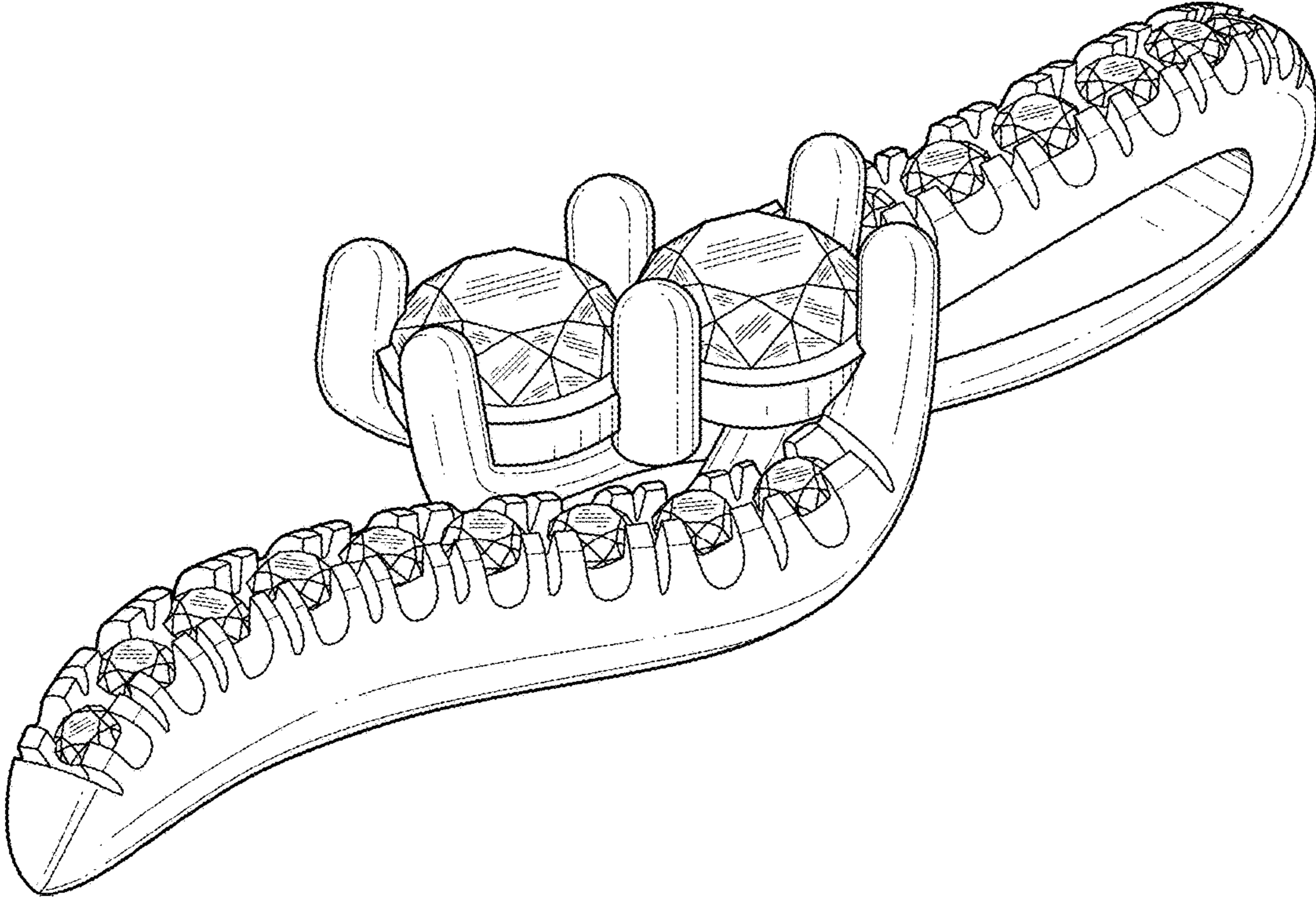

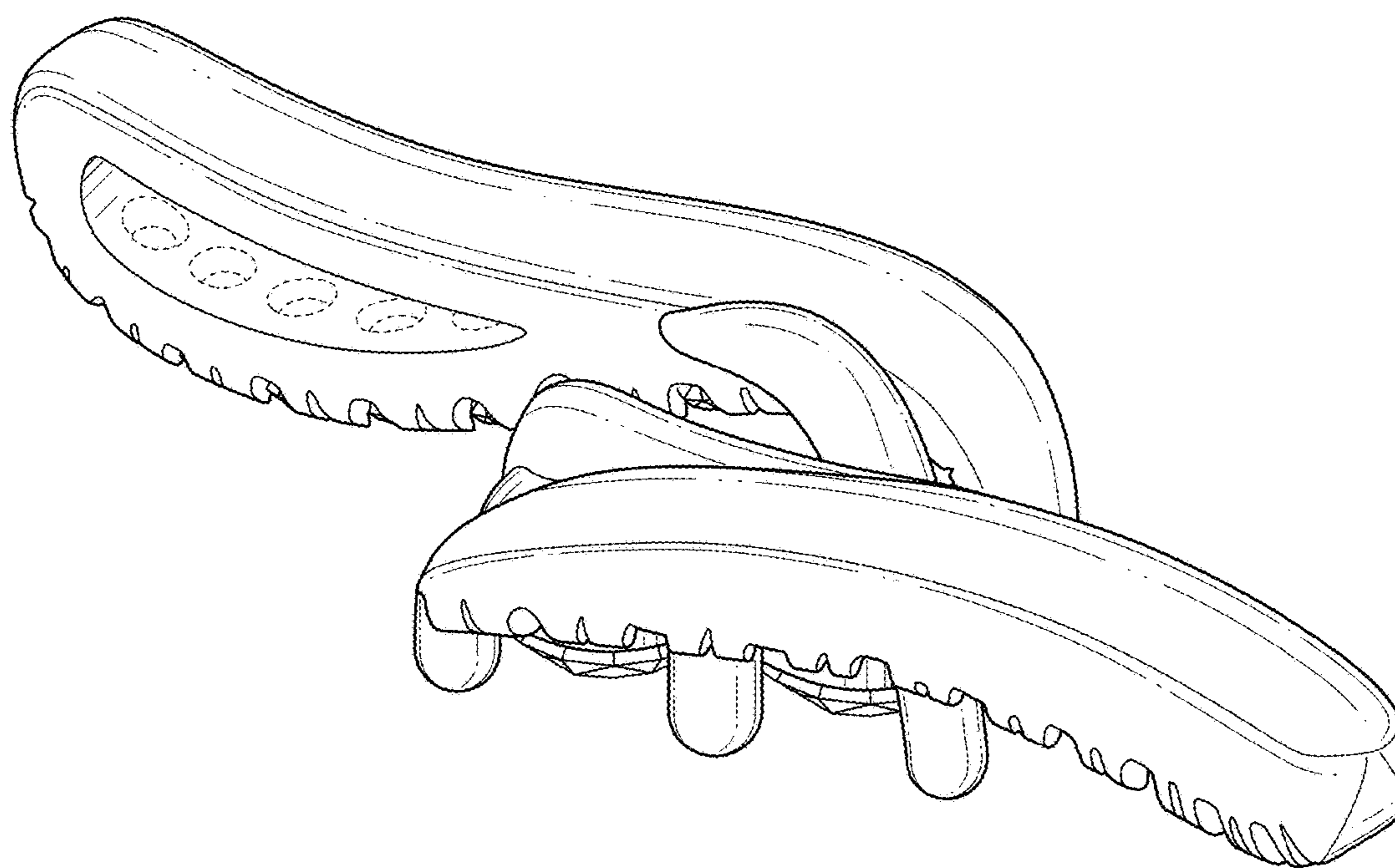

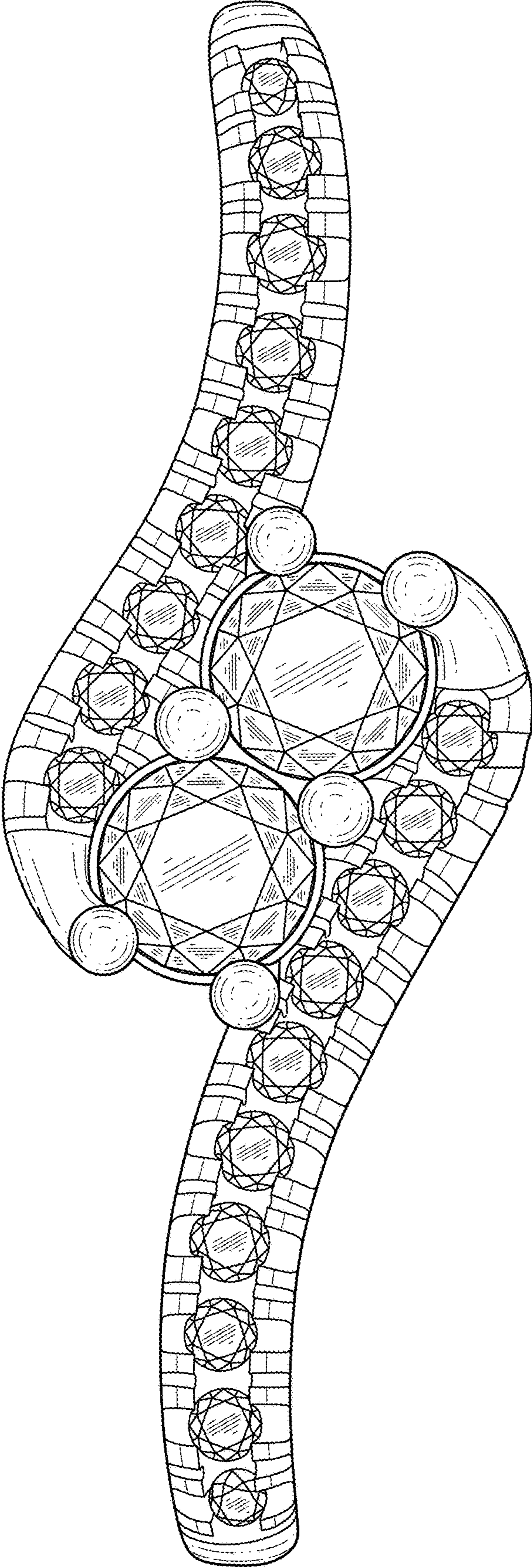

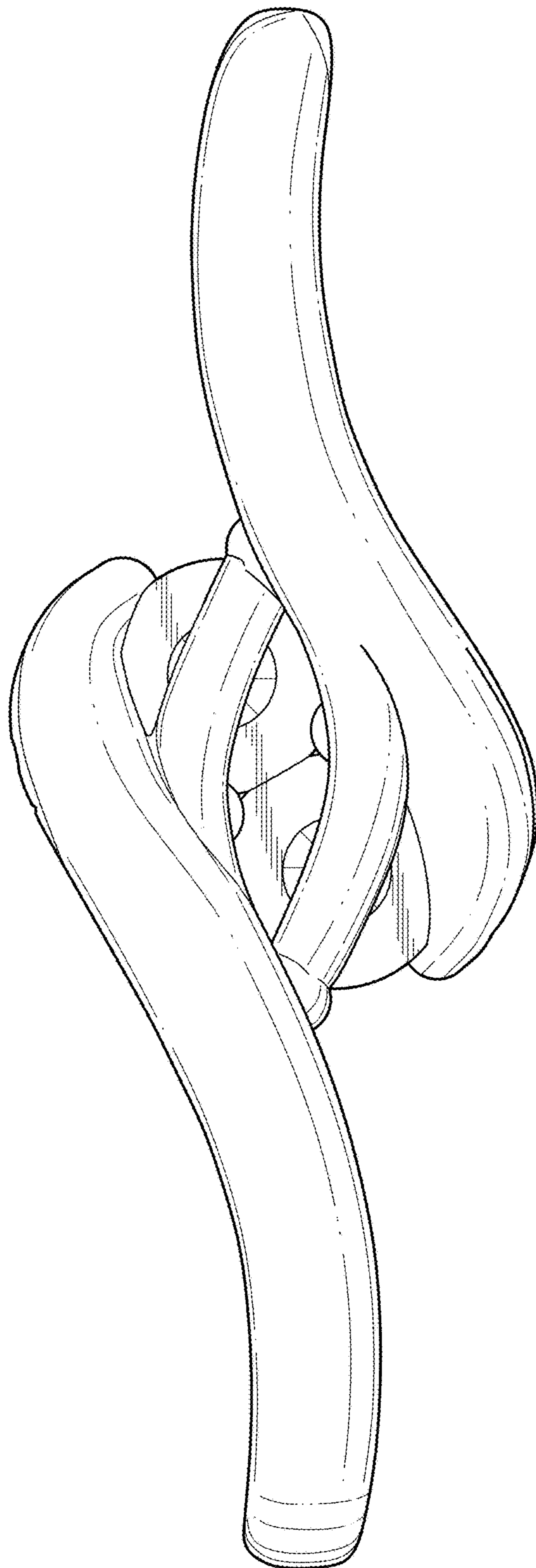

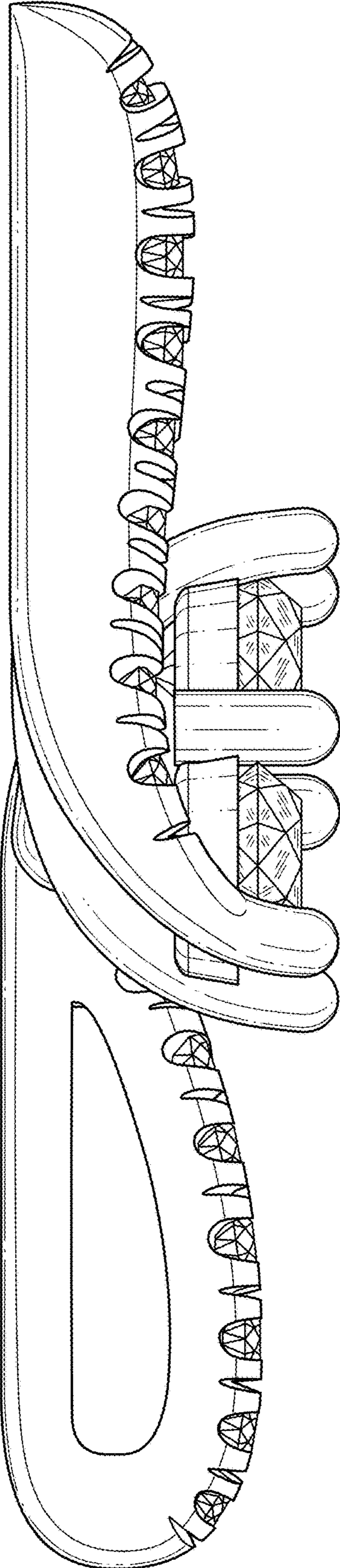

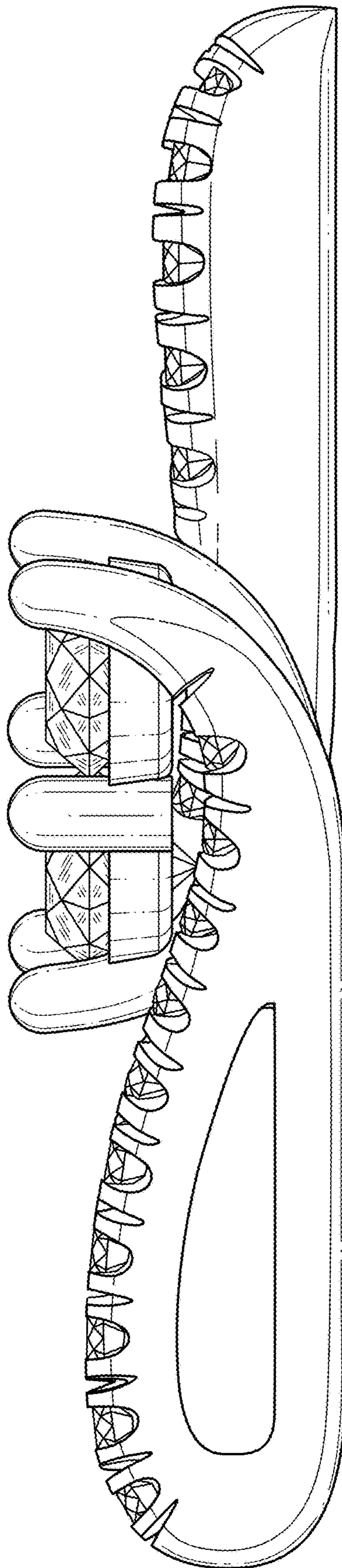

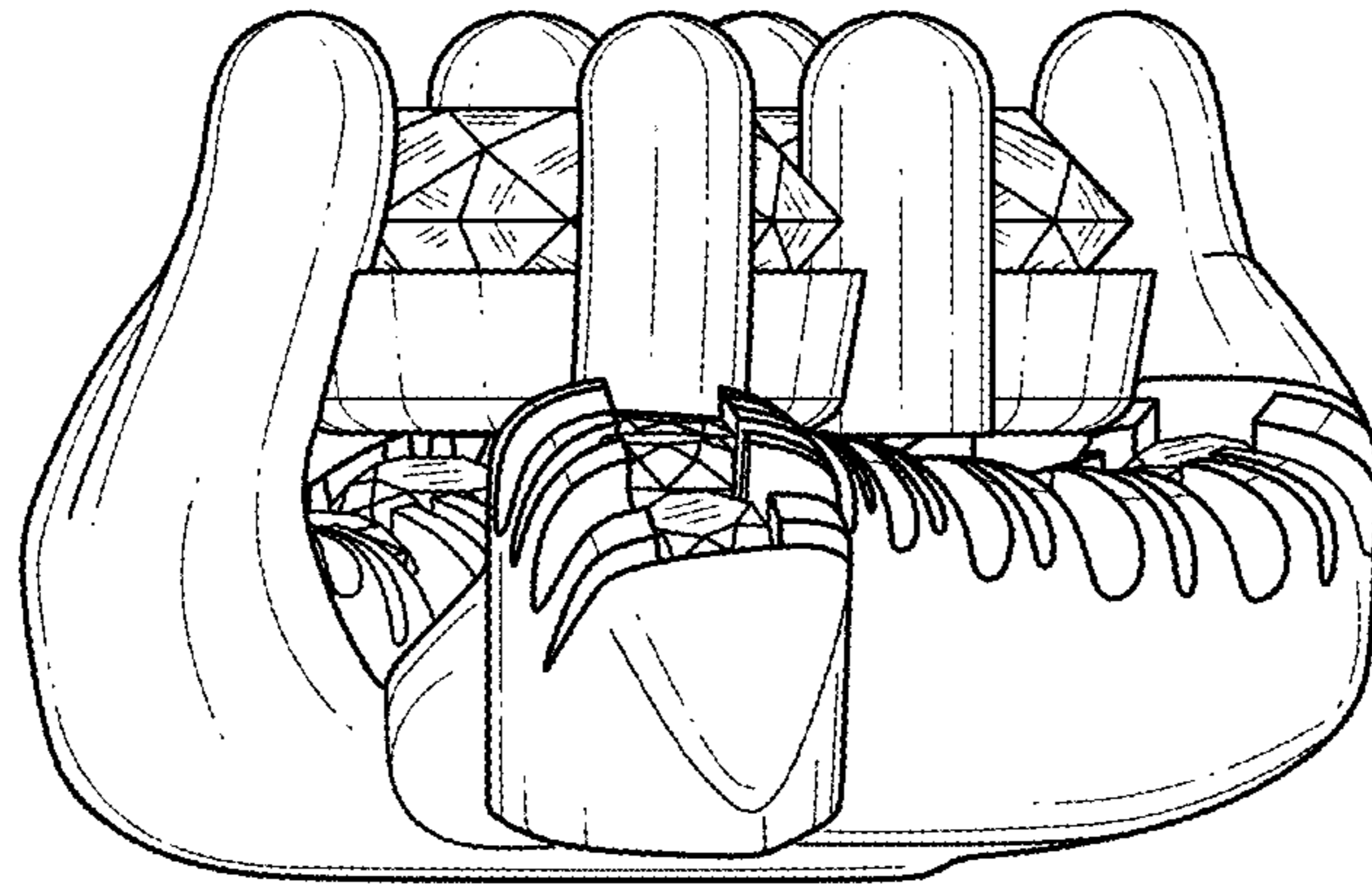

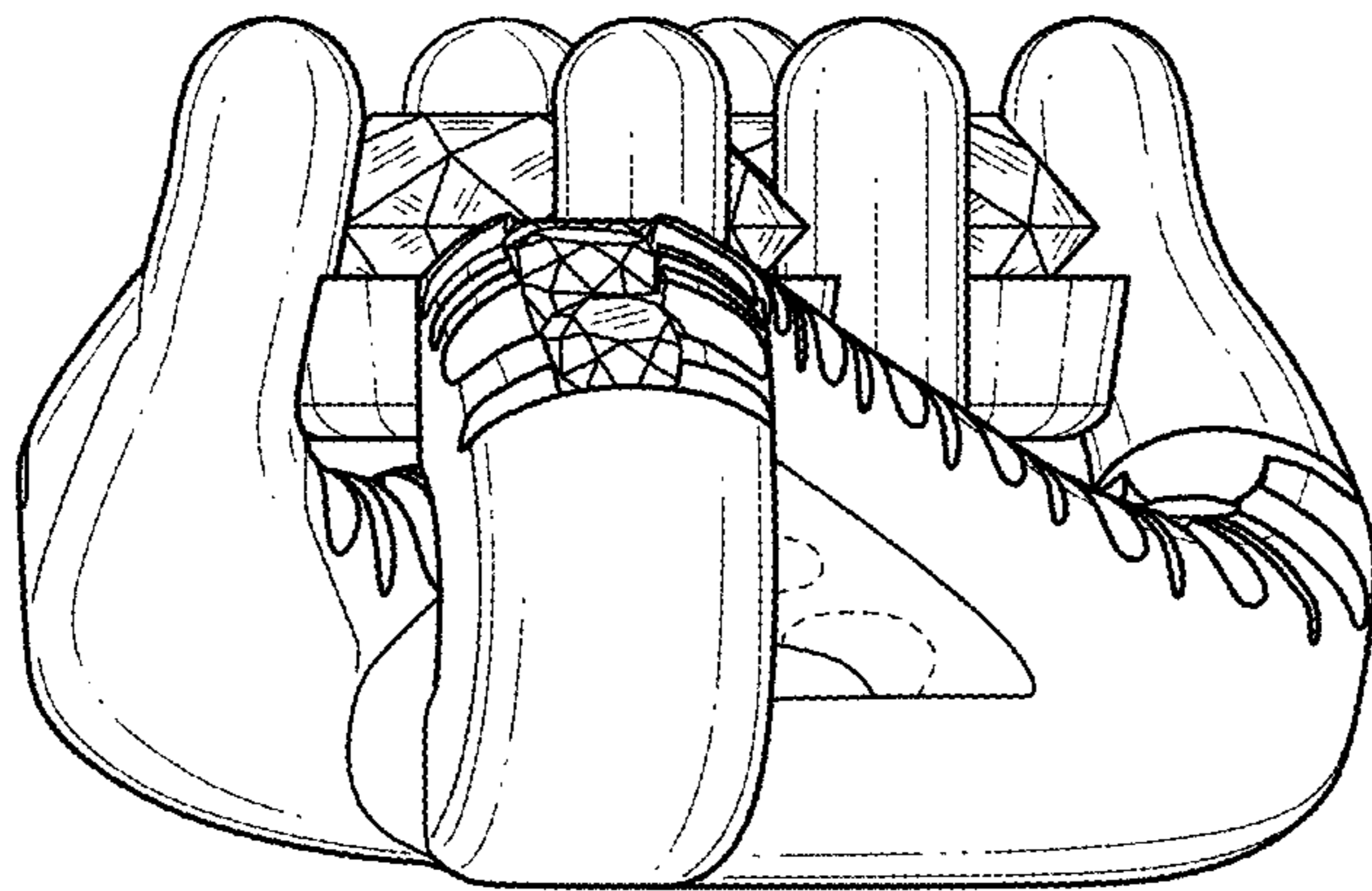
