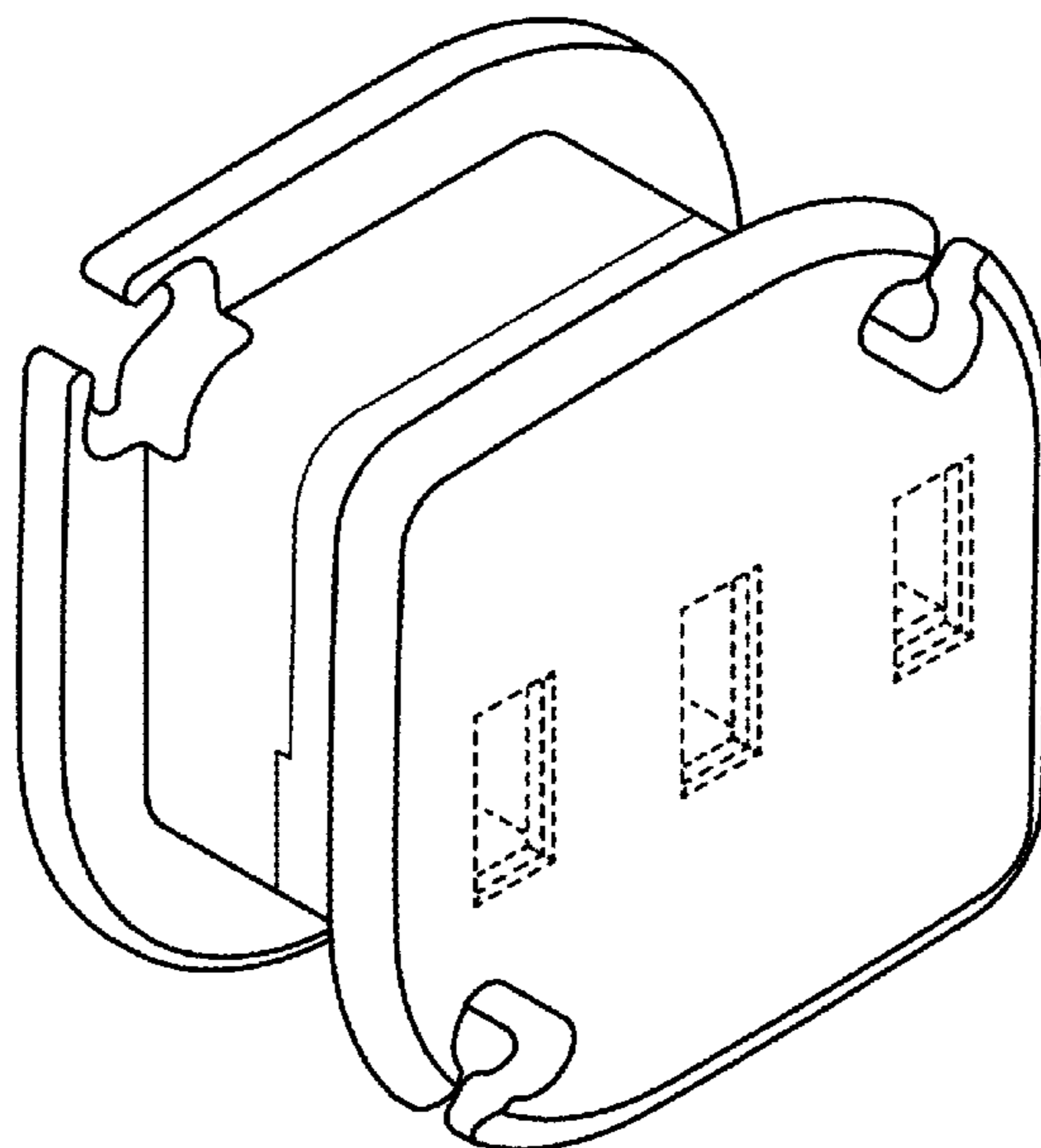
The ornamental design for a mobile charging device, as shown and described.

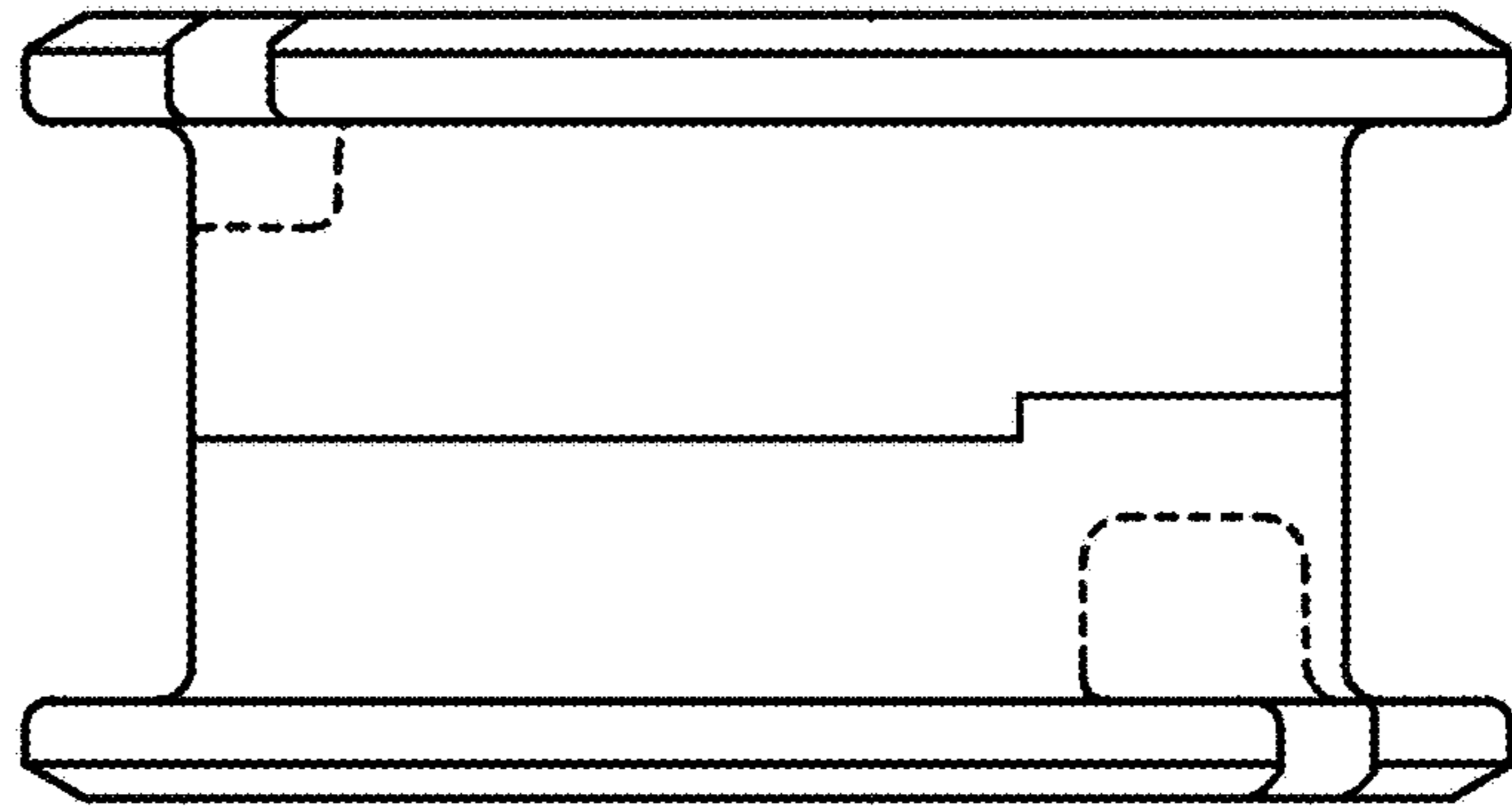

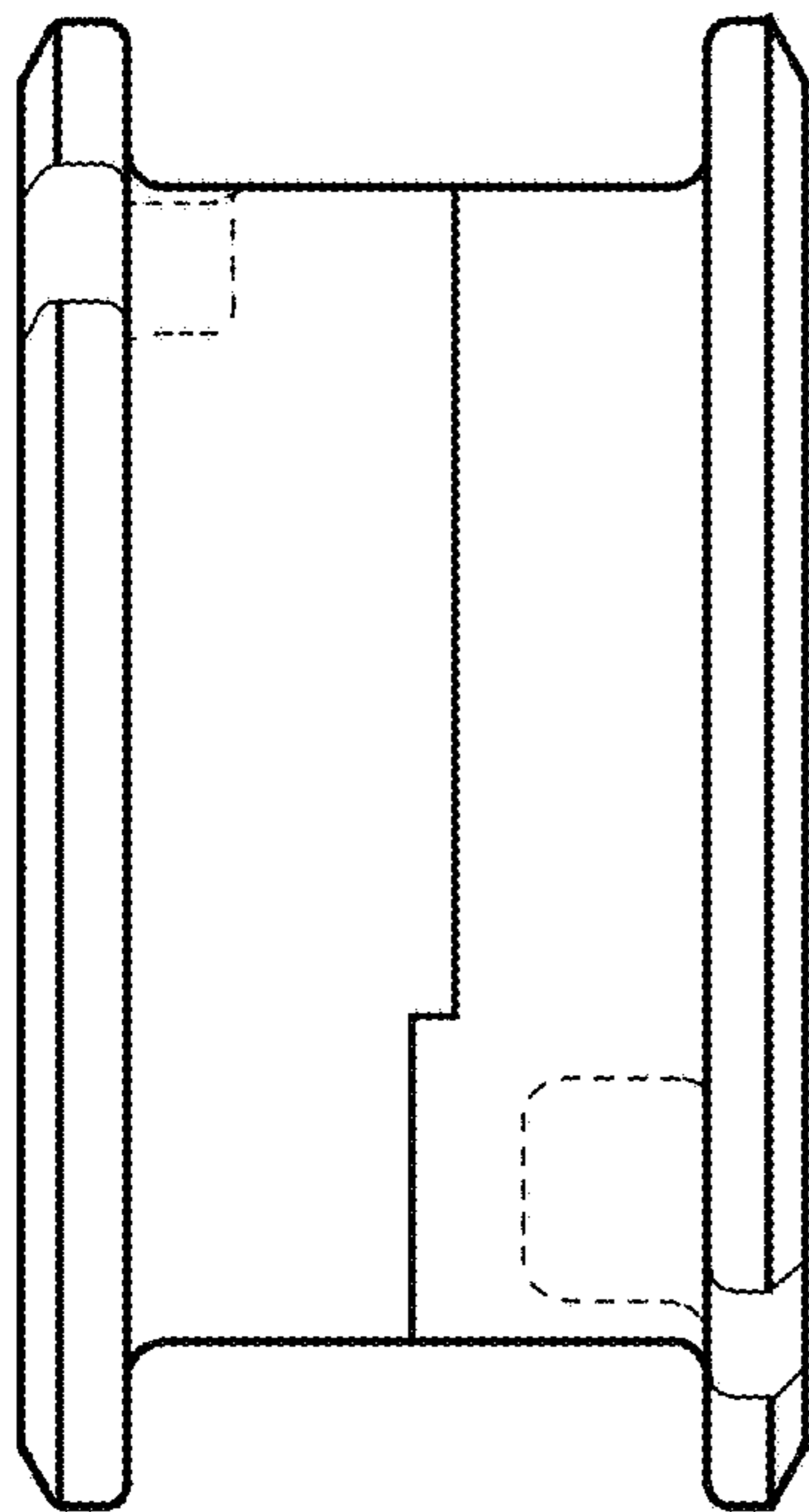

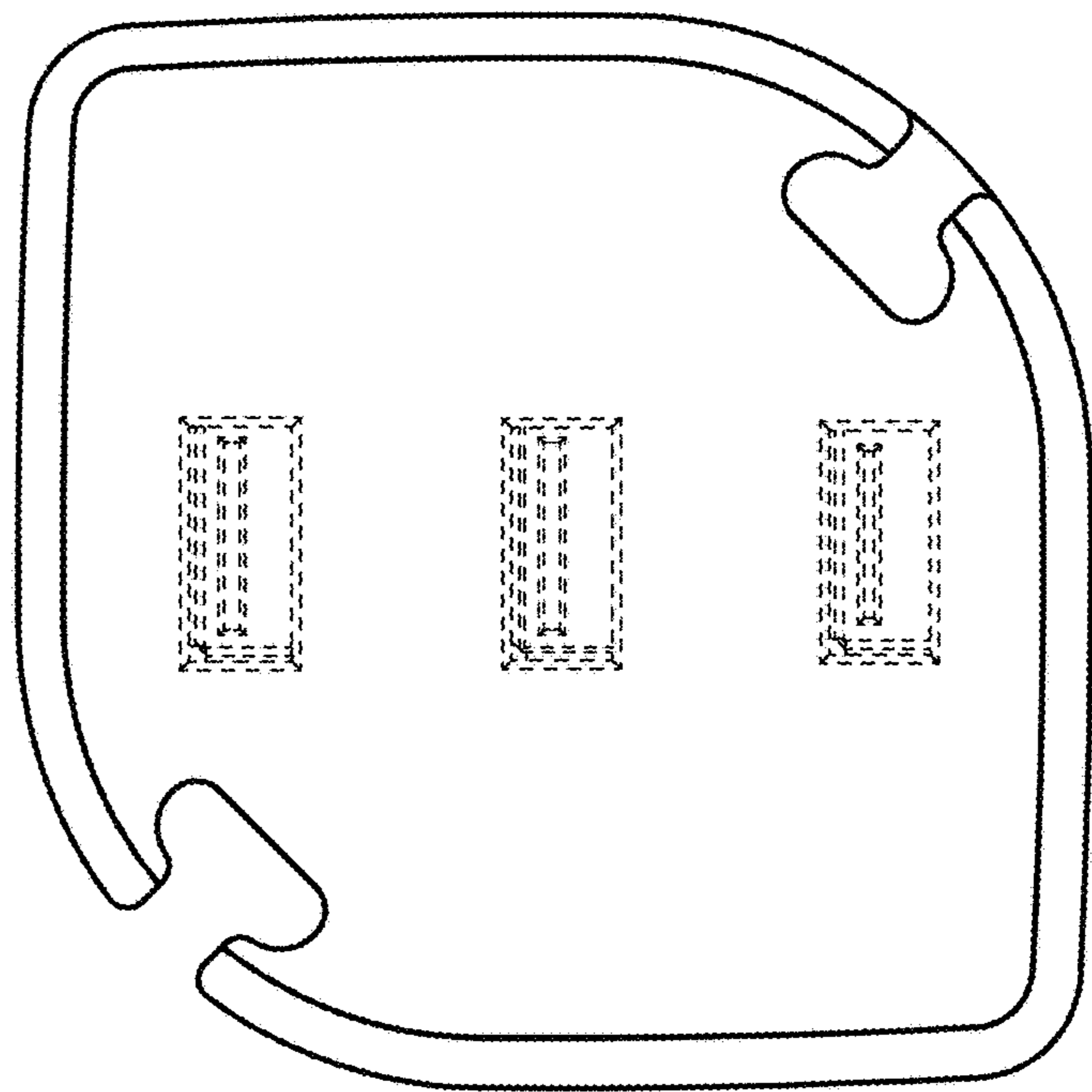

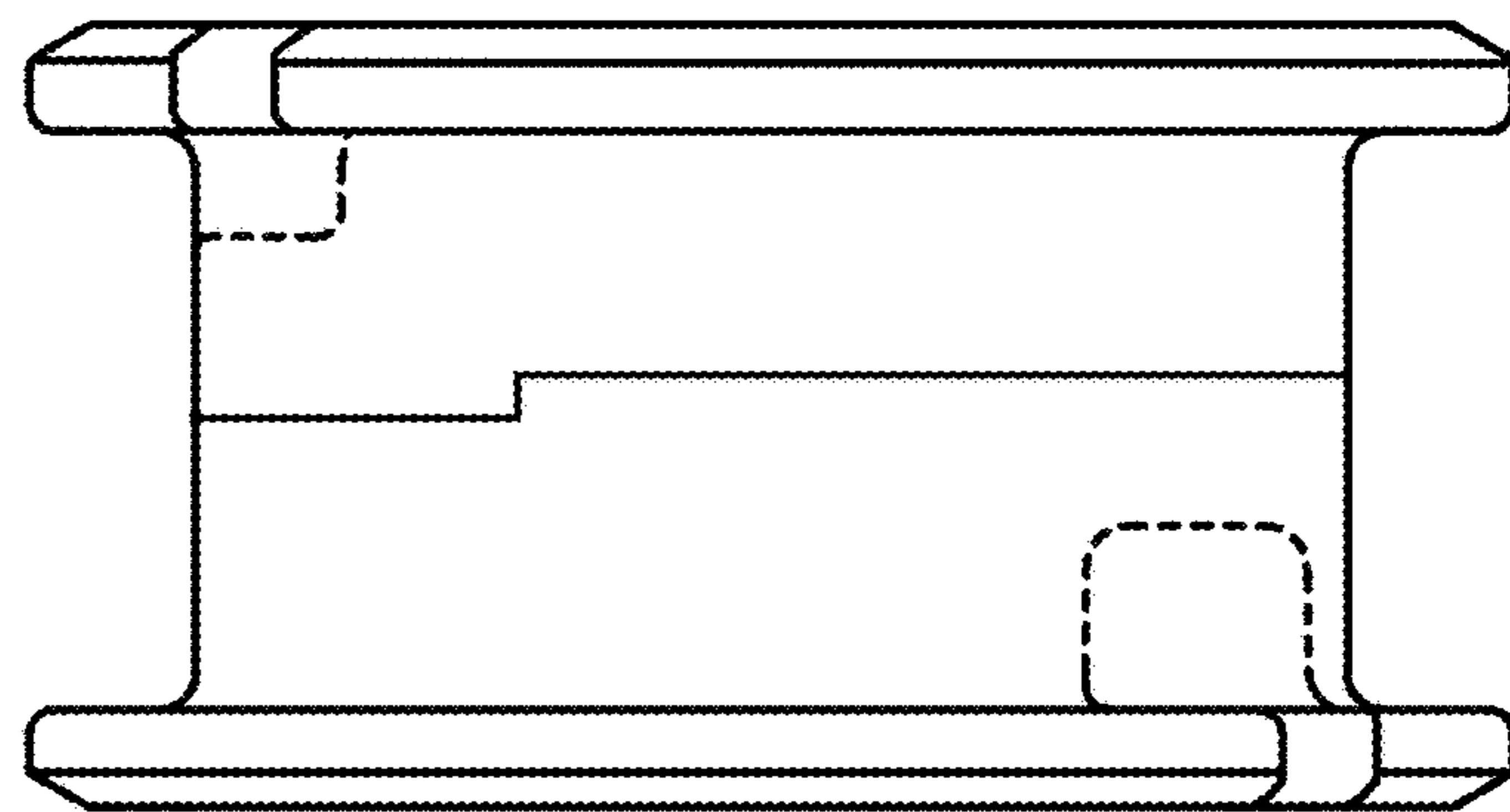

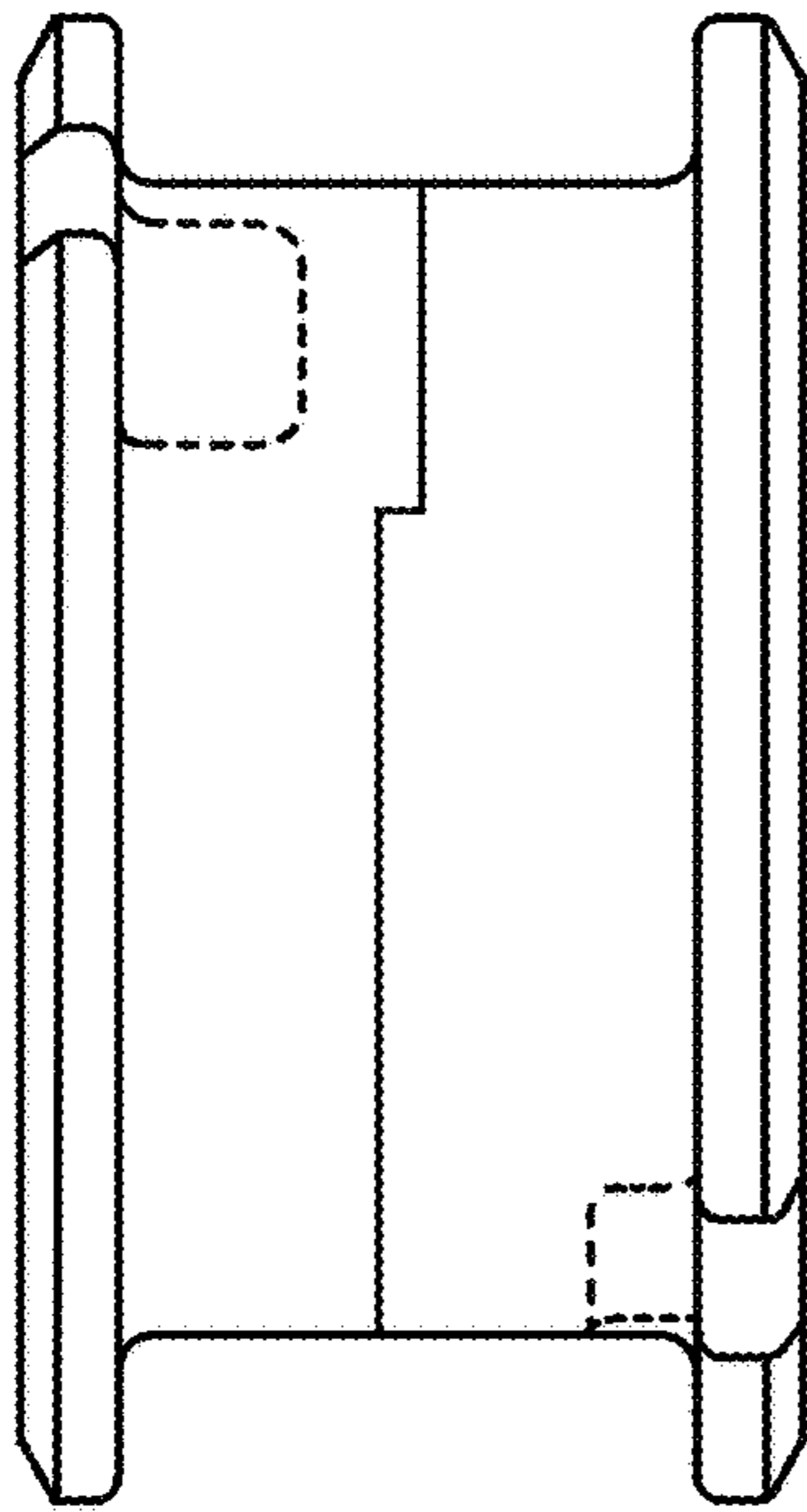

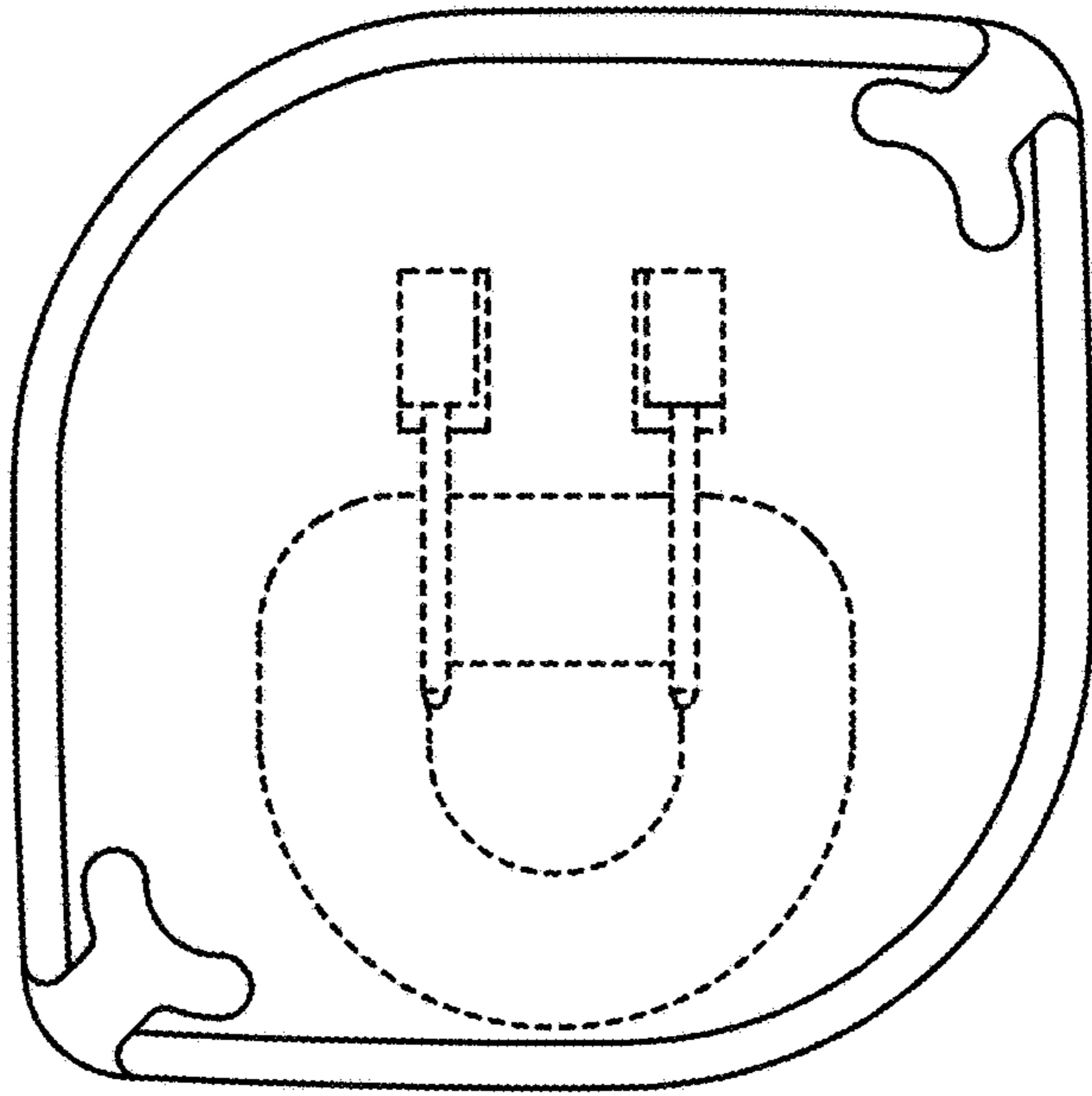

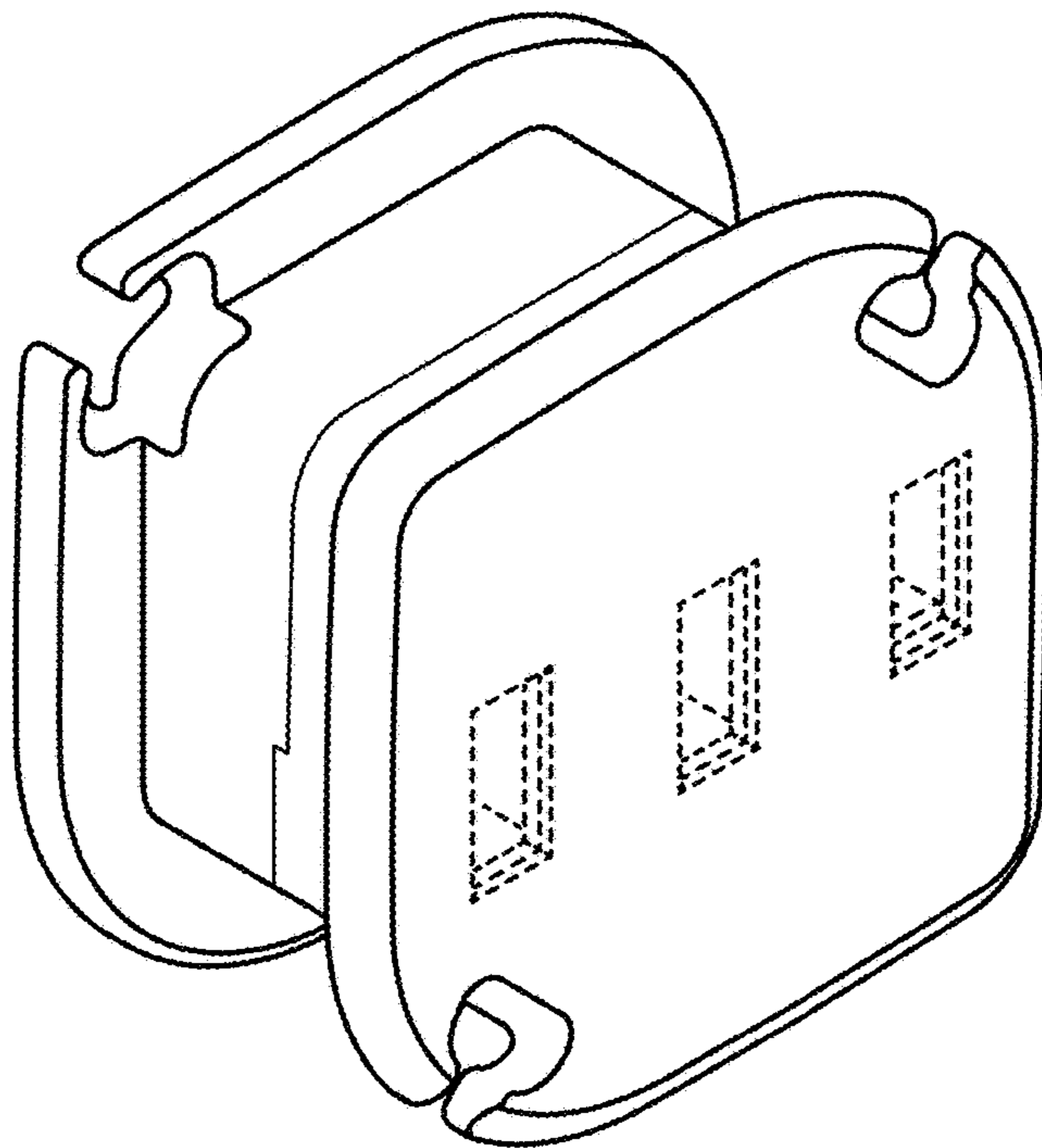
