The ornamental design for a display screen with graphical user interface of an incubator, as shown and described.

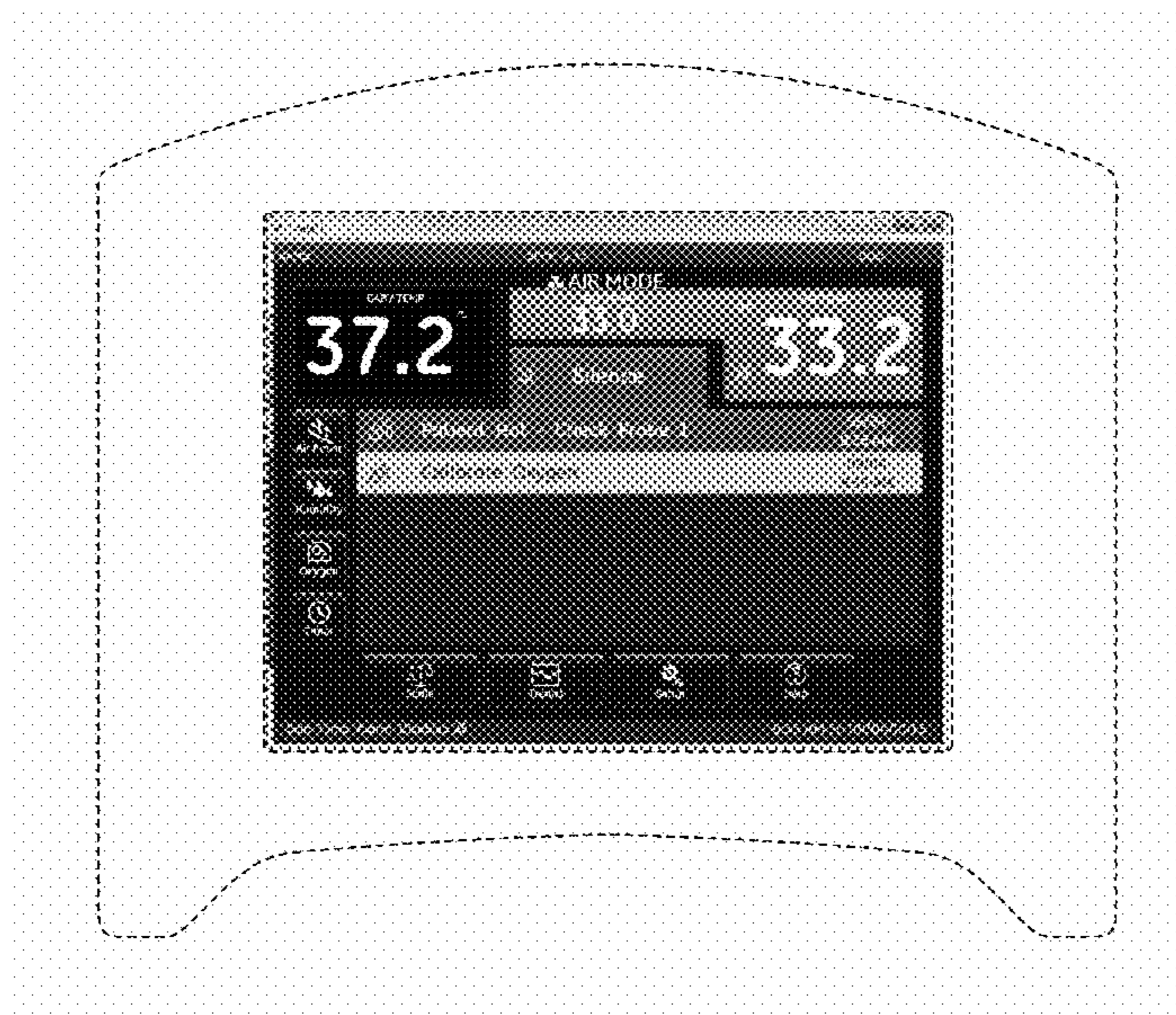
DESCRIPTION
