(57) **CLAIM**

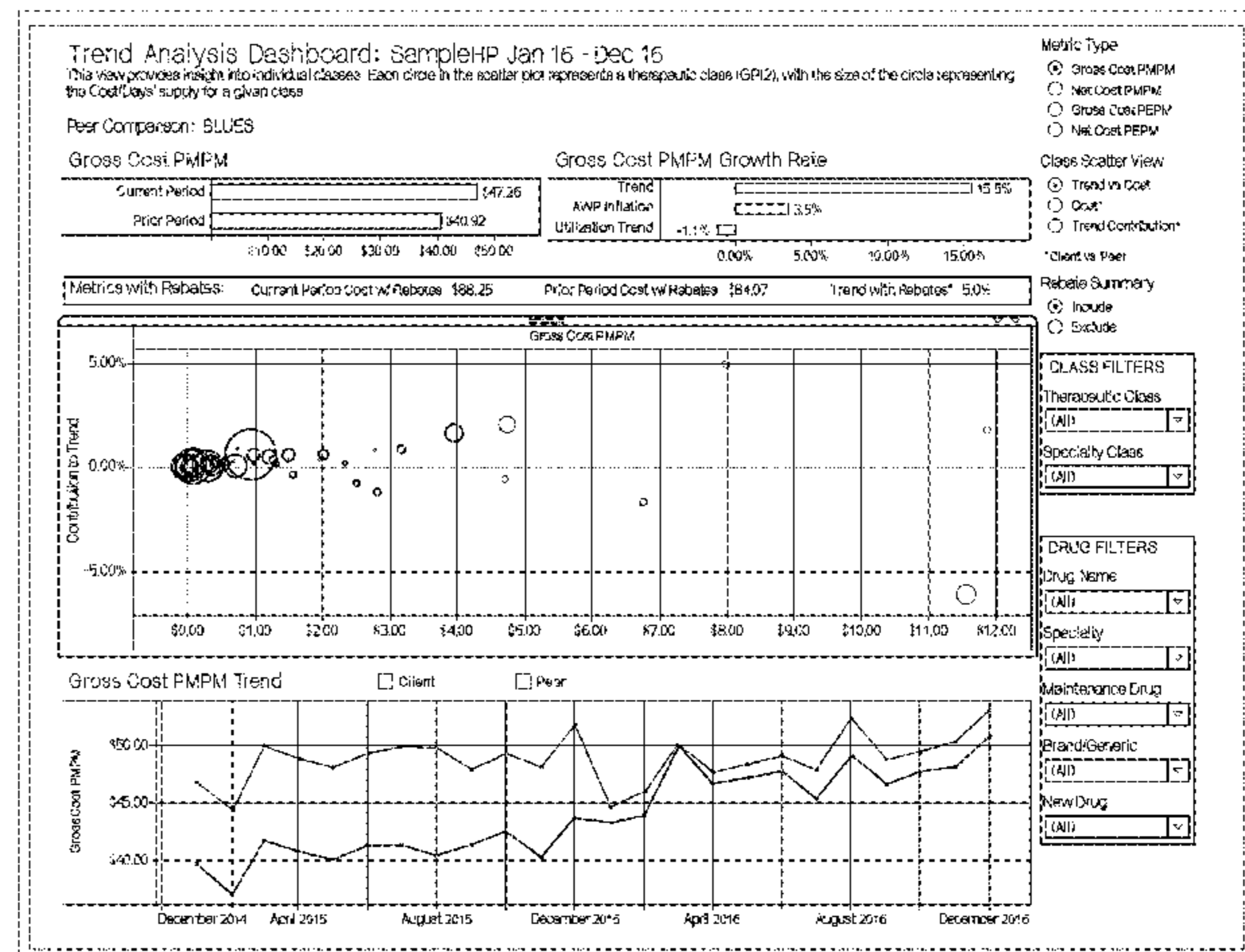
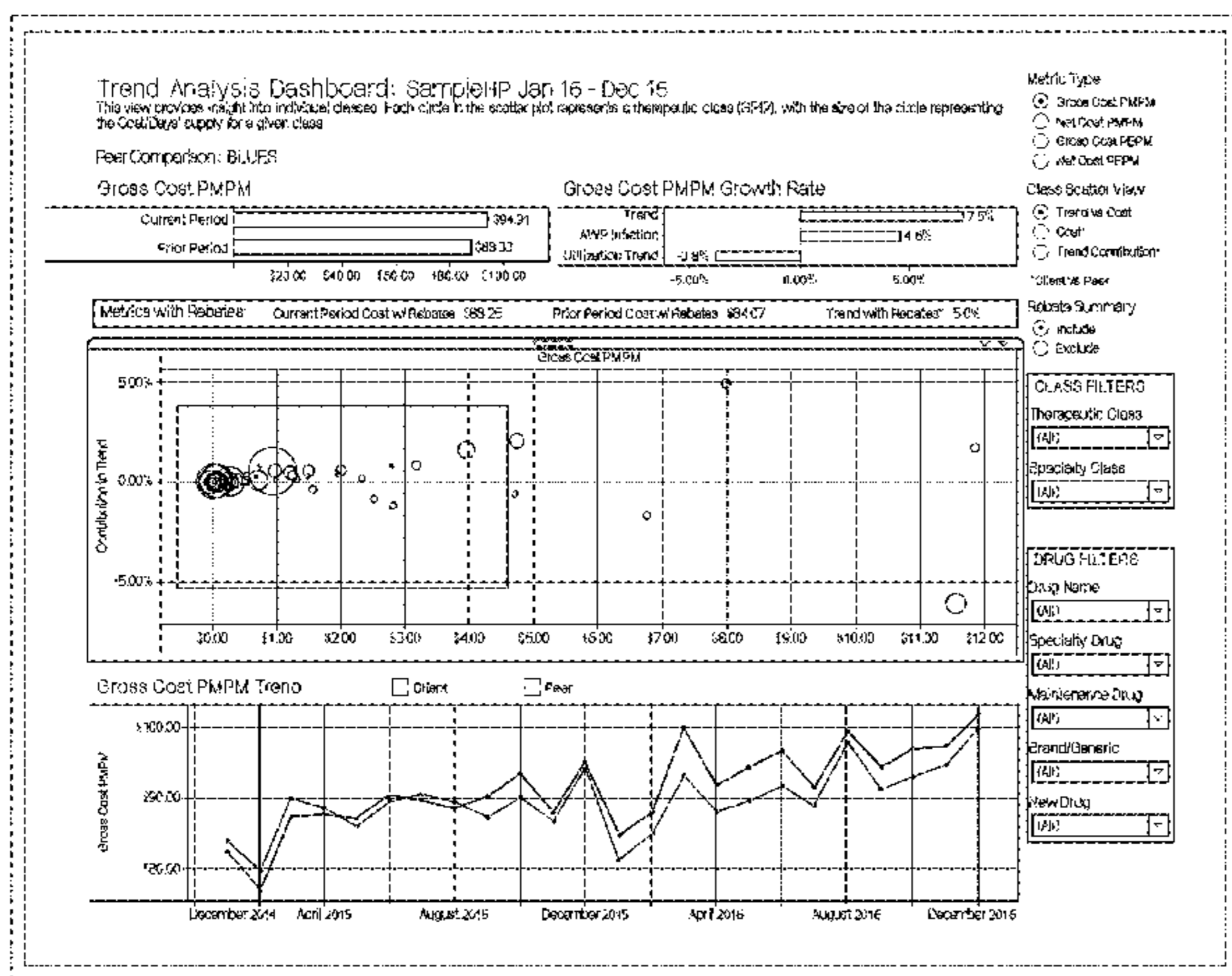
The ornamental design for a display screen or portion thereof with animated graphical user interface for data analysis reporting, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image of a display screen or portion thereof with animated graphical user interface for data analysis reporting showing our new design; and, FIG. 2 is a front view of a second image thereof.

Within the drawings, the appearance of a transitional image sequentially transitions between the images shown in FIGS. 1 and 2. The appearance of the animated graphical user interface transitions sequentially between the images shown in FIGS. 1 and 2. The process or period in which one image transitions to another forms no part of the claimed design. The outermost broken line showing of a display screen or portion thereof and the other broken lines showing elements of the animated graphical user interface illustrate portions of the article and do not form part of the claimed design.

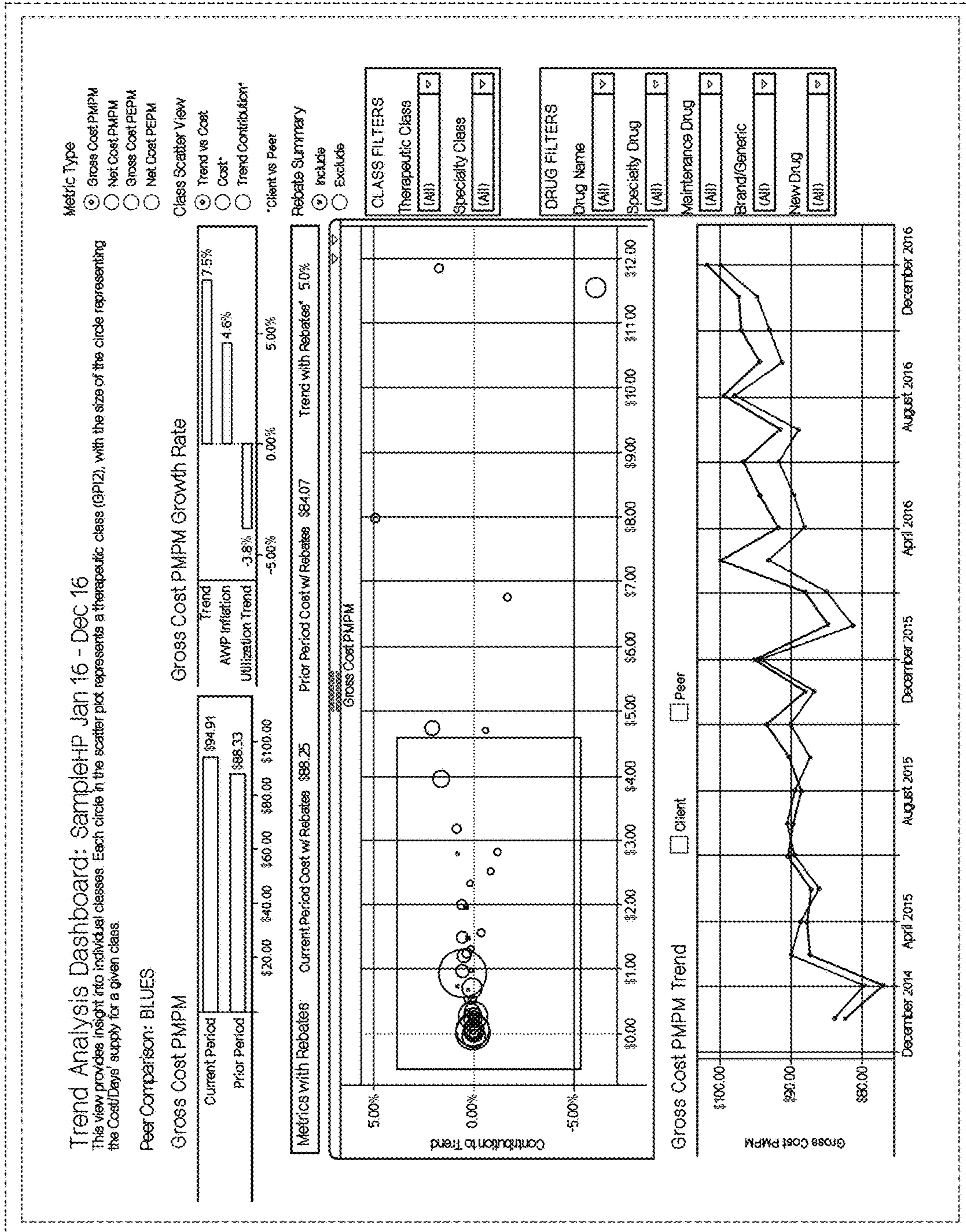

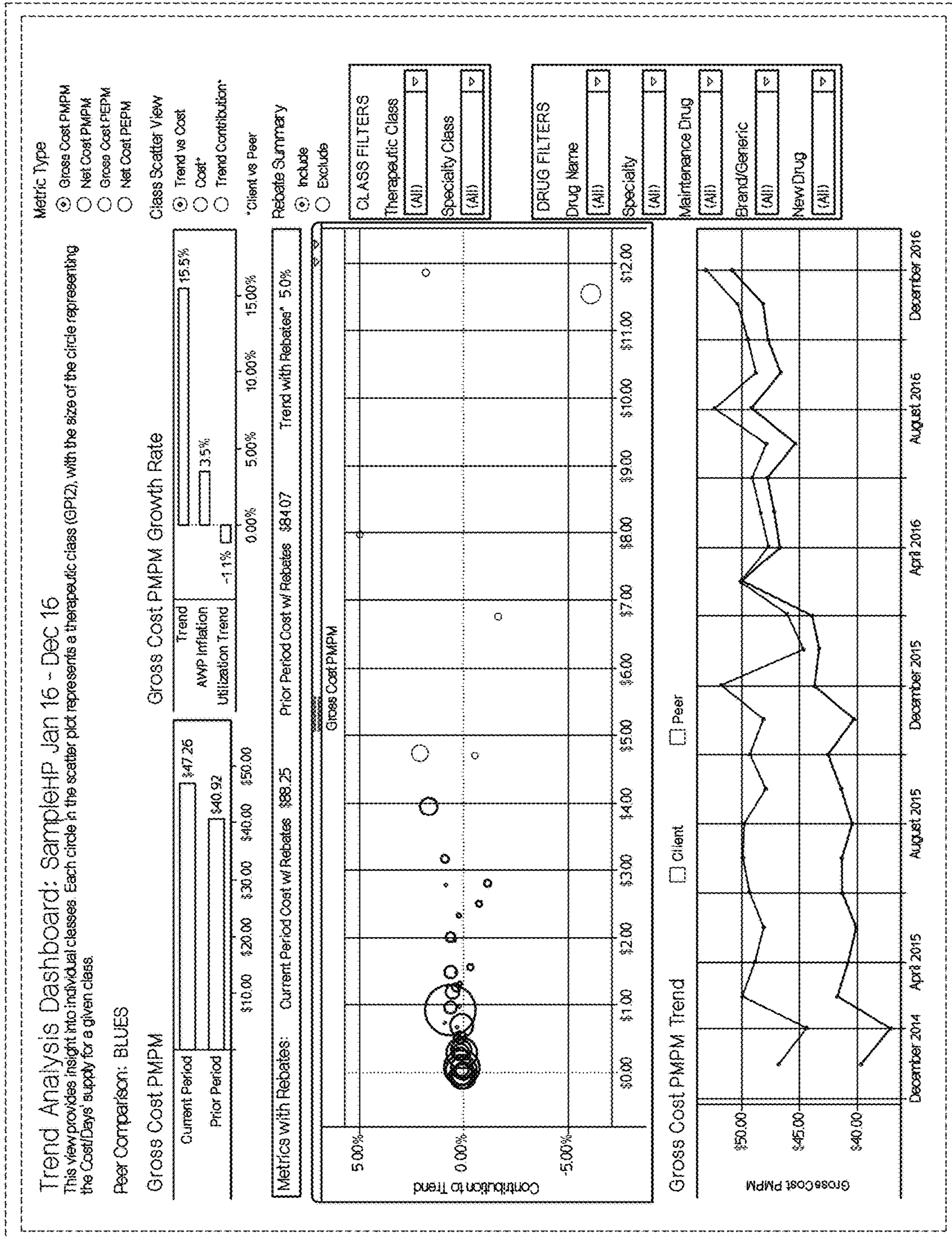
