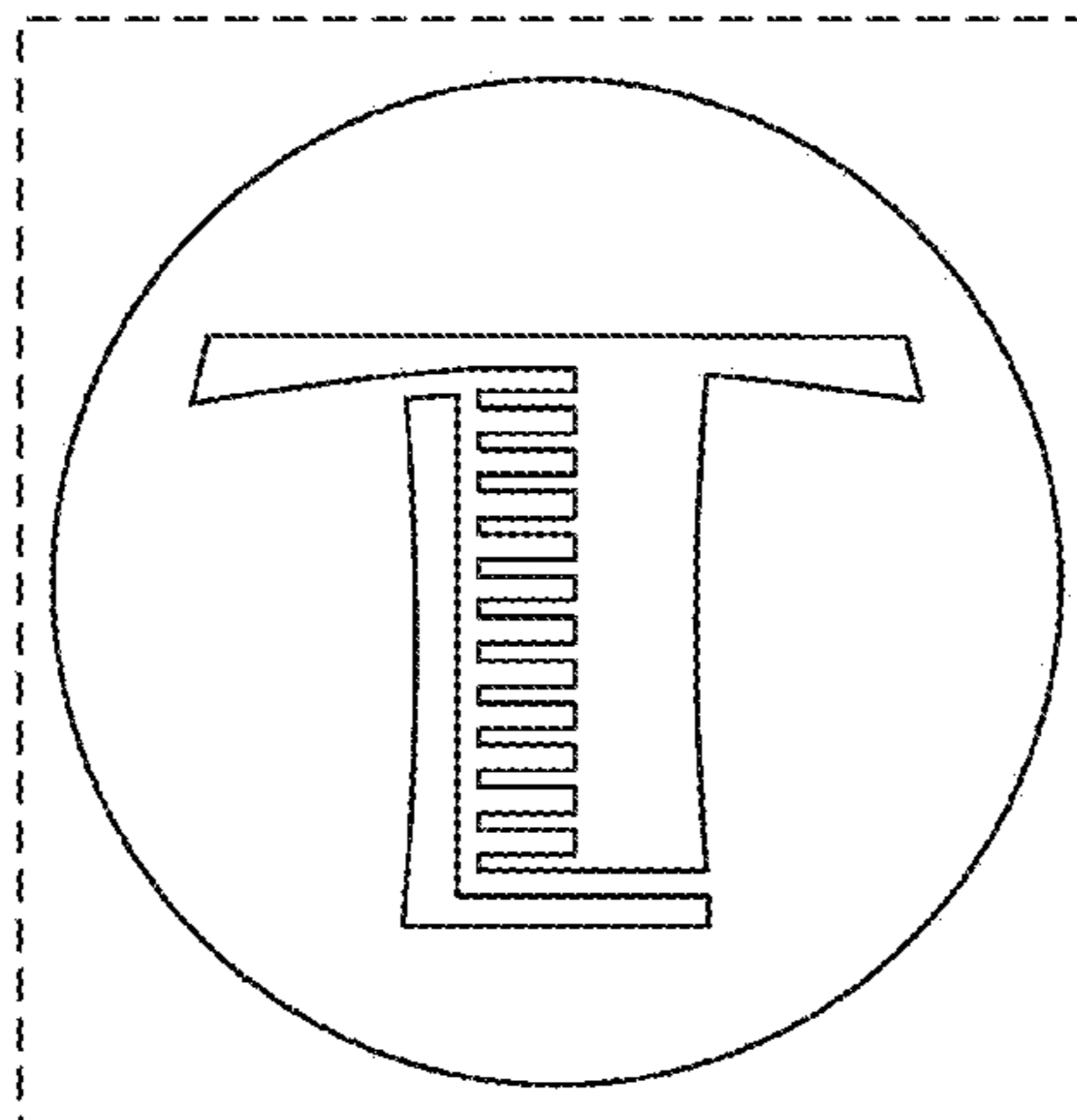
CLAIM
