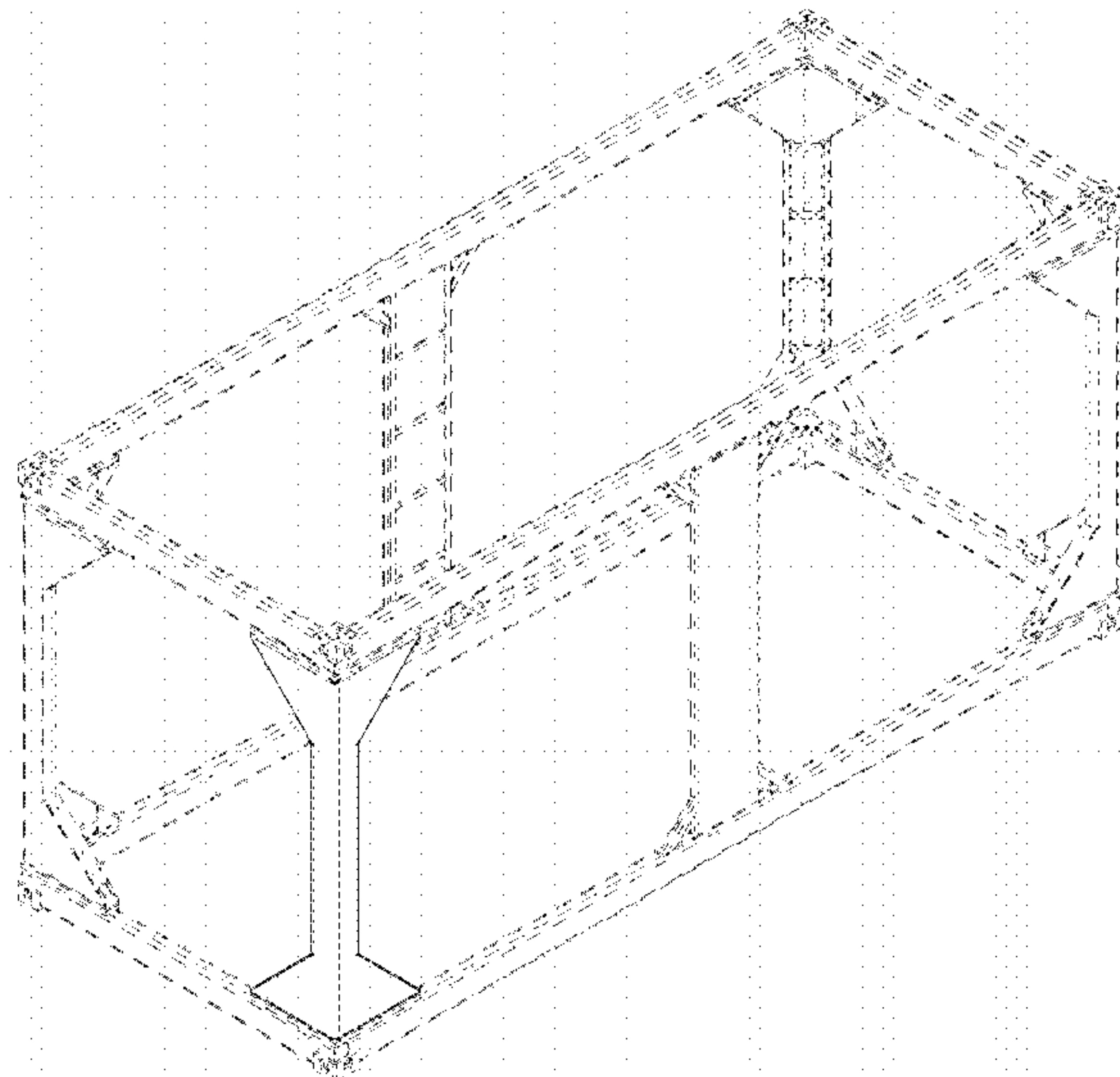
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an isometric view of a corner of a container showing my new design;

FIG. 4 an enlarged left side view of FIG. 1;

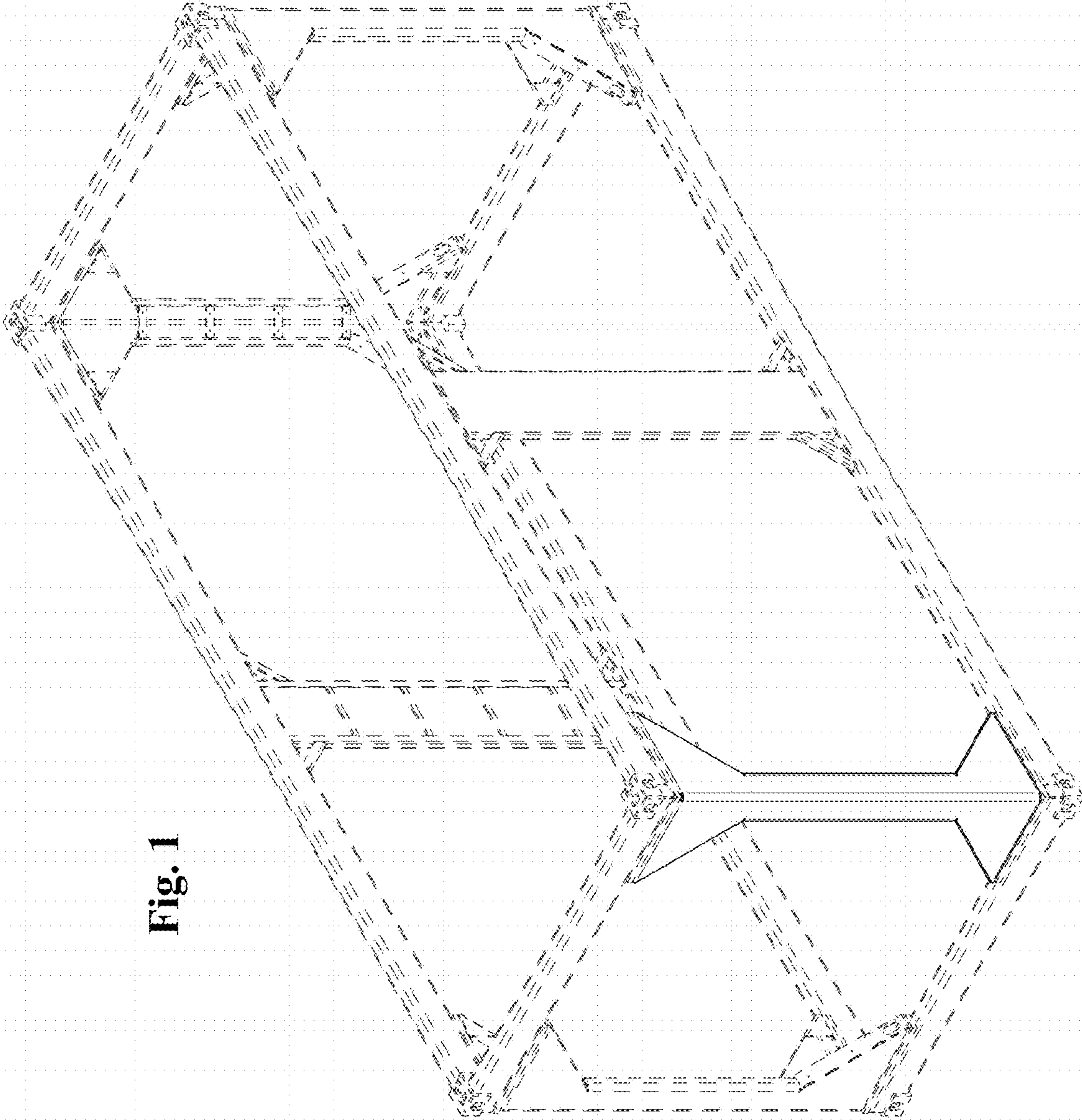

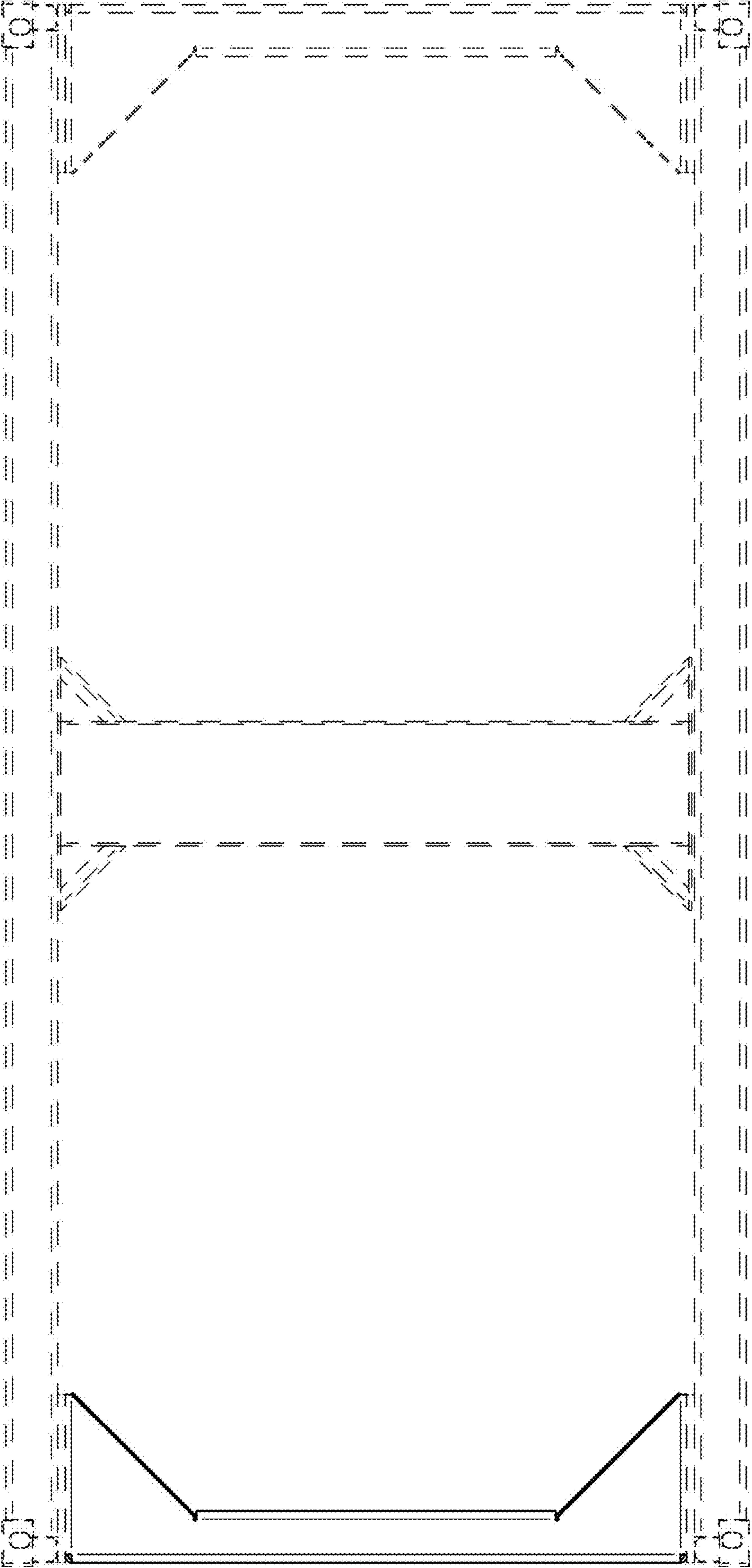

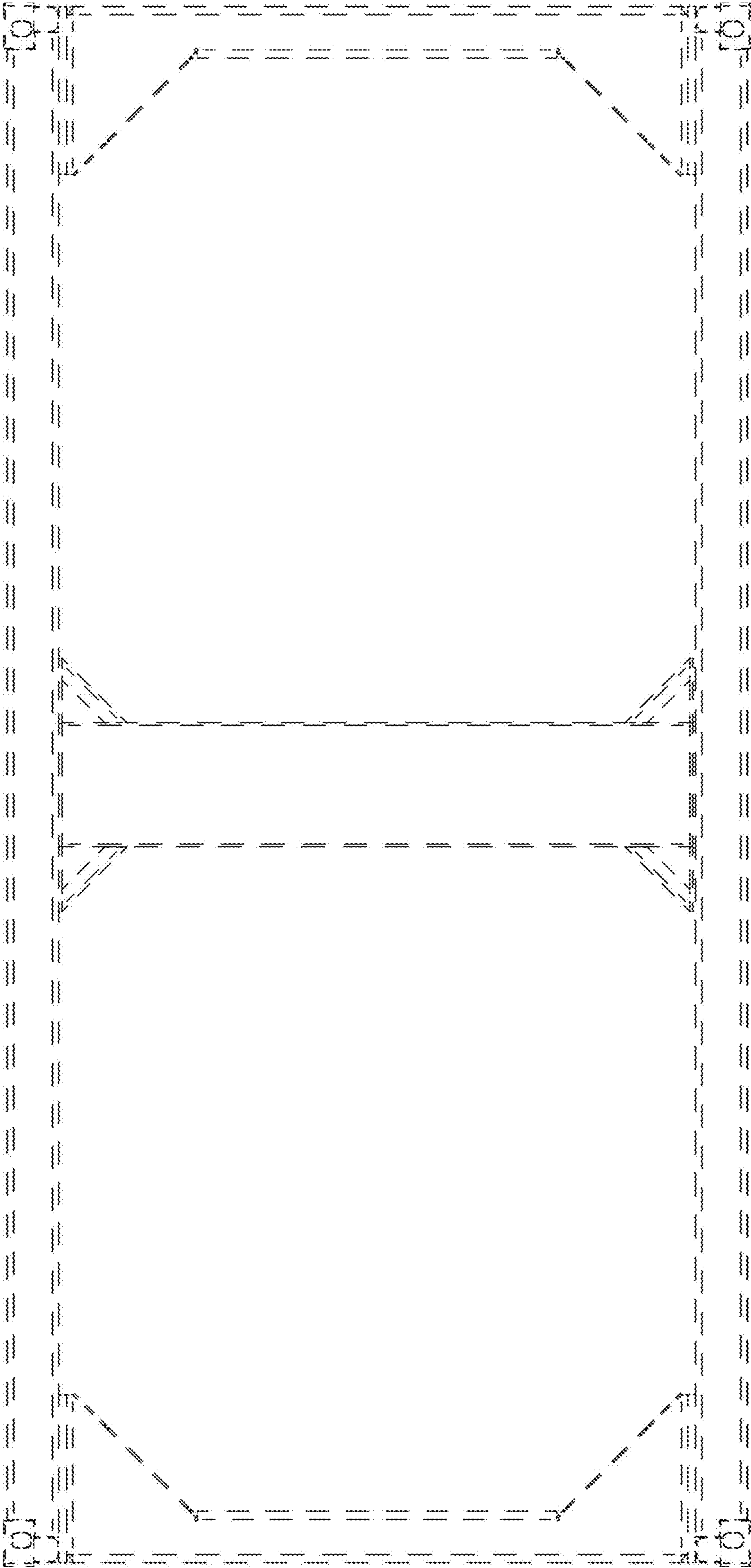

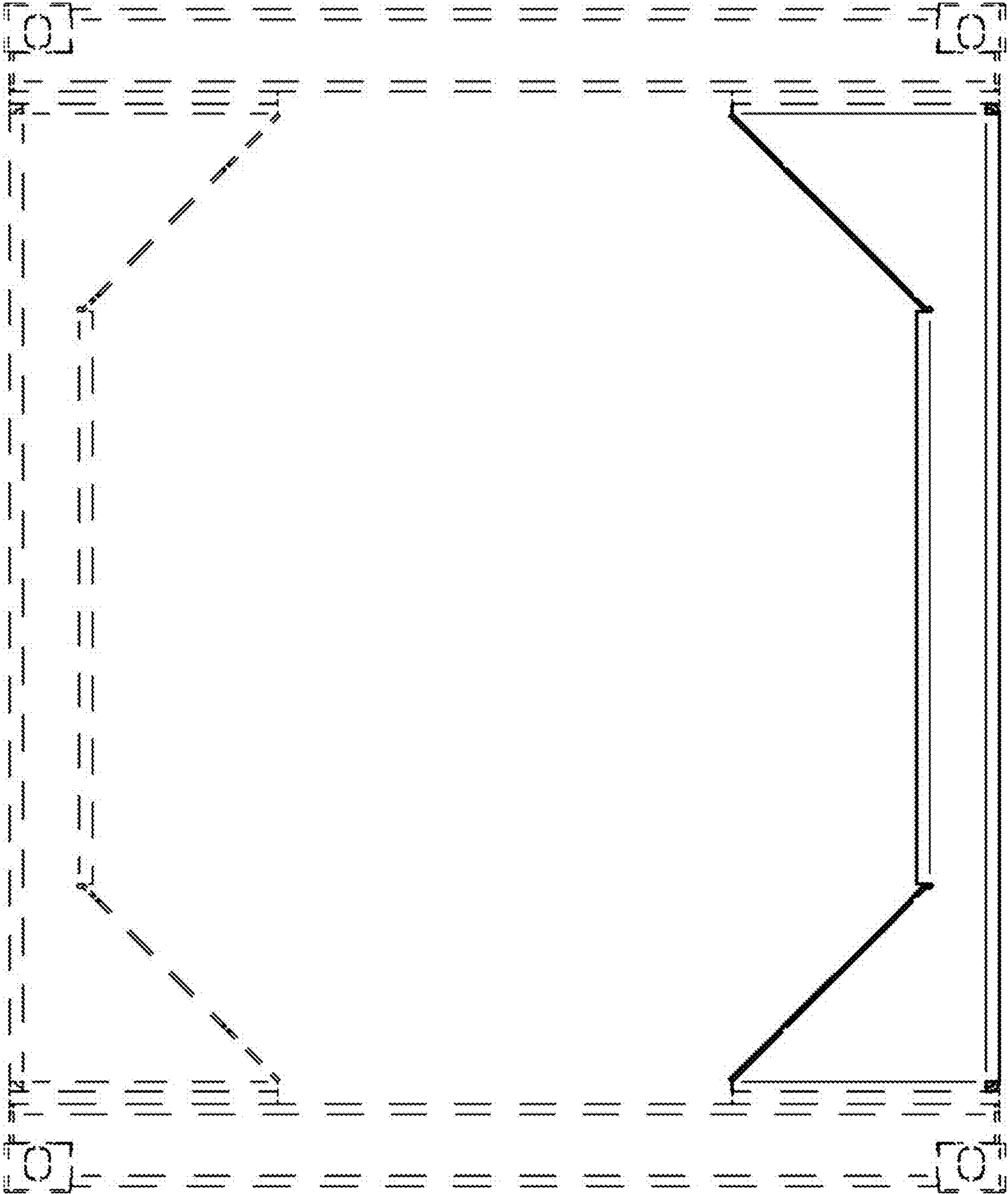

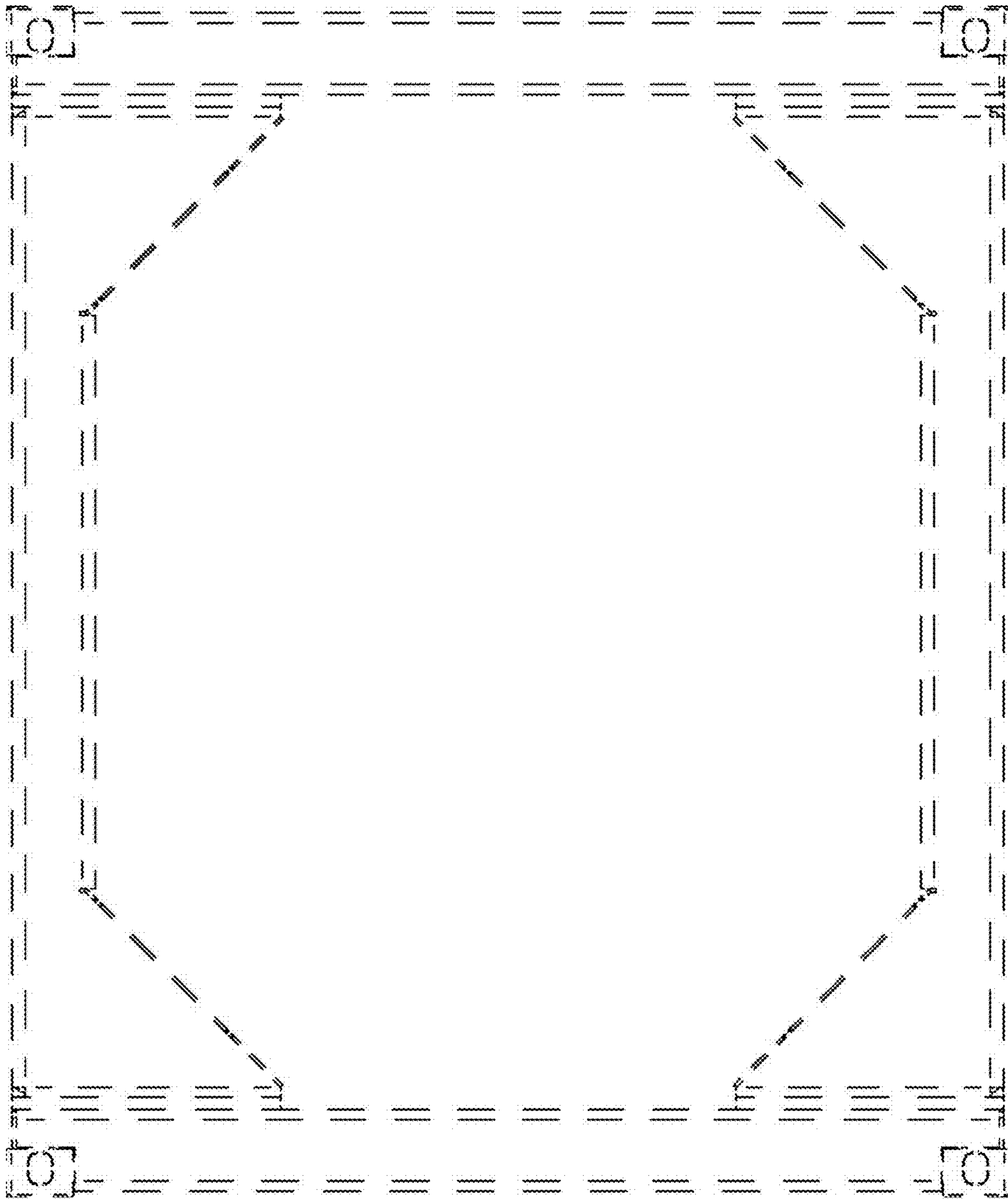

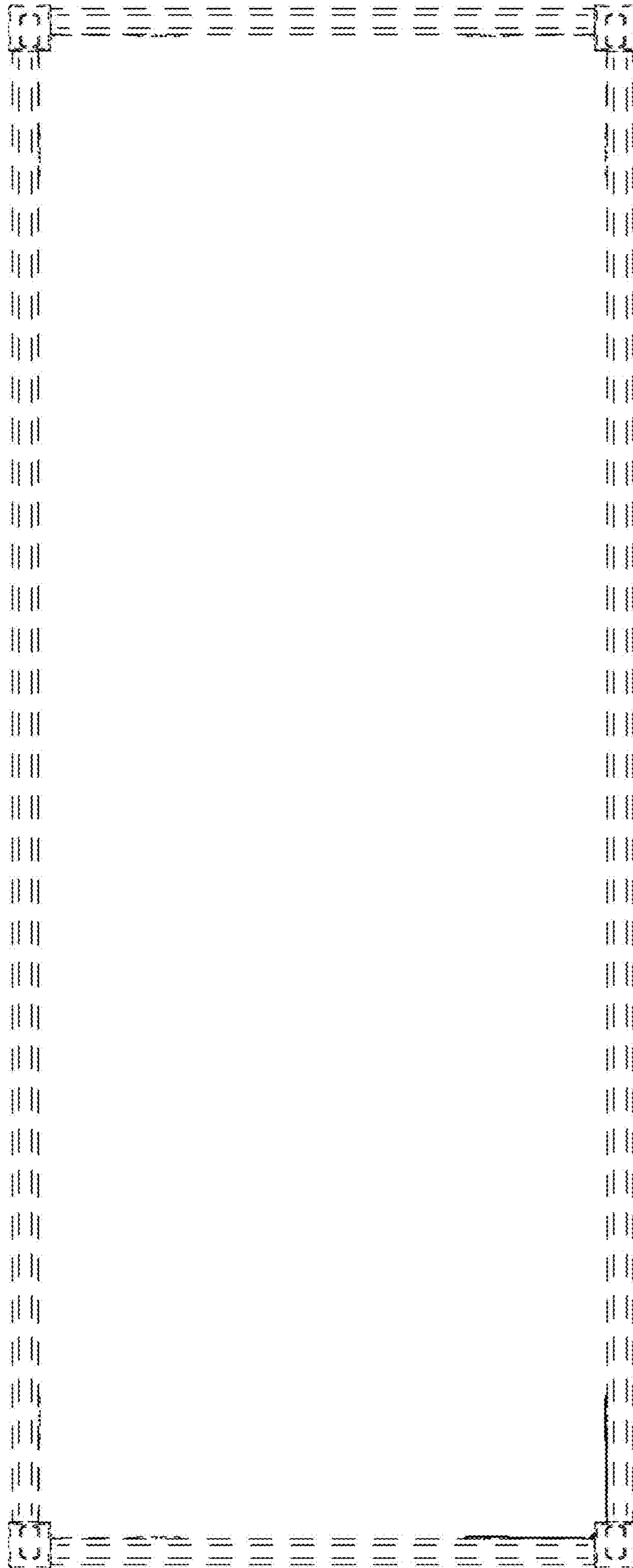
