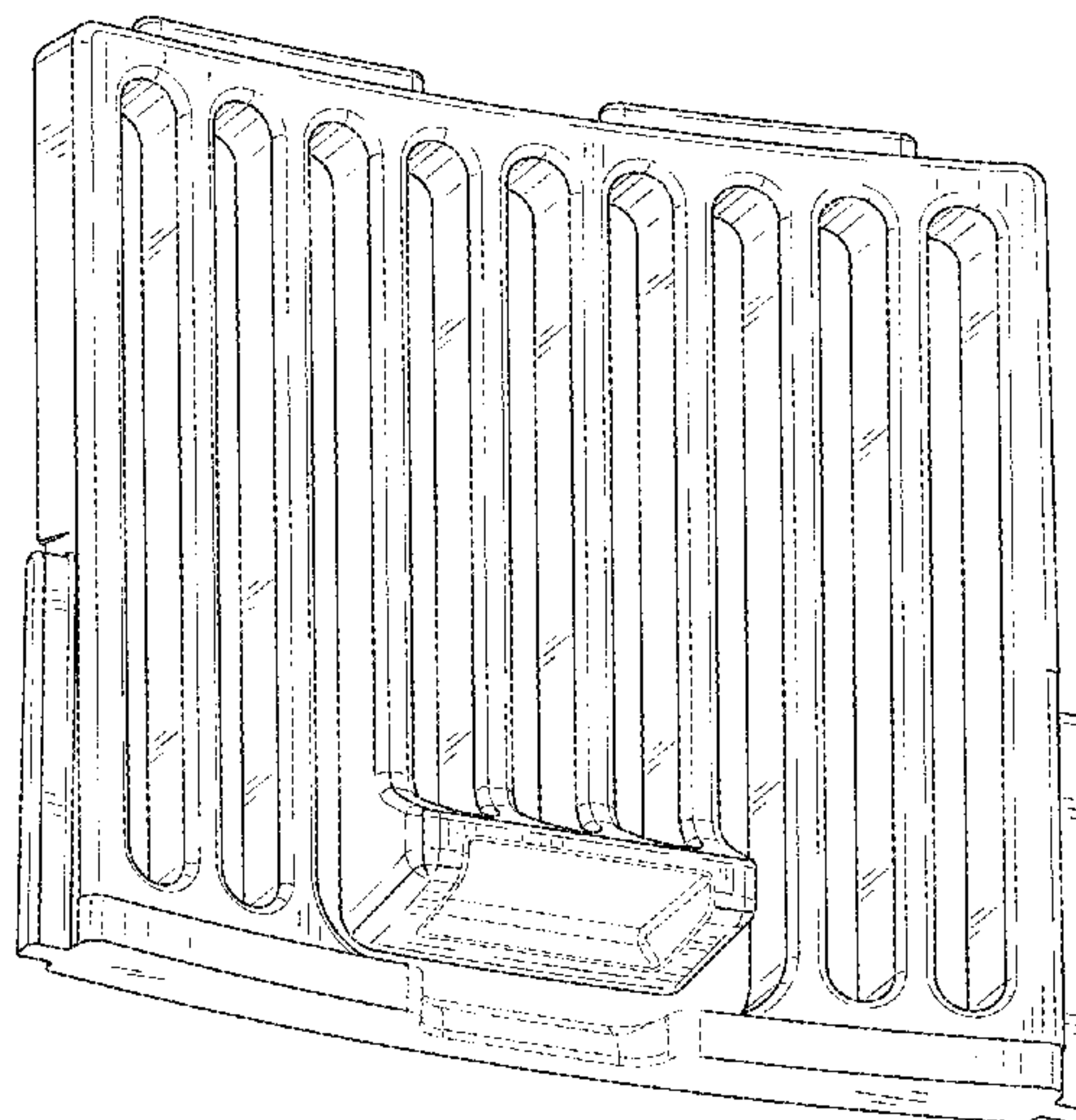
(57) **CLAIM**

The ornamental design for a removable air screen for an agricultural meter housing, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a removable air screen for an agricultural meter housing;  
FIG. 2 is a bottom view of the removable air screen;  
FIG. 3 is a top view of the removable air screen;  
FIG. 4 is a right side view of the removable air screen;

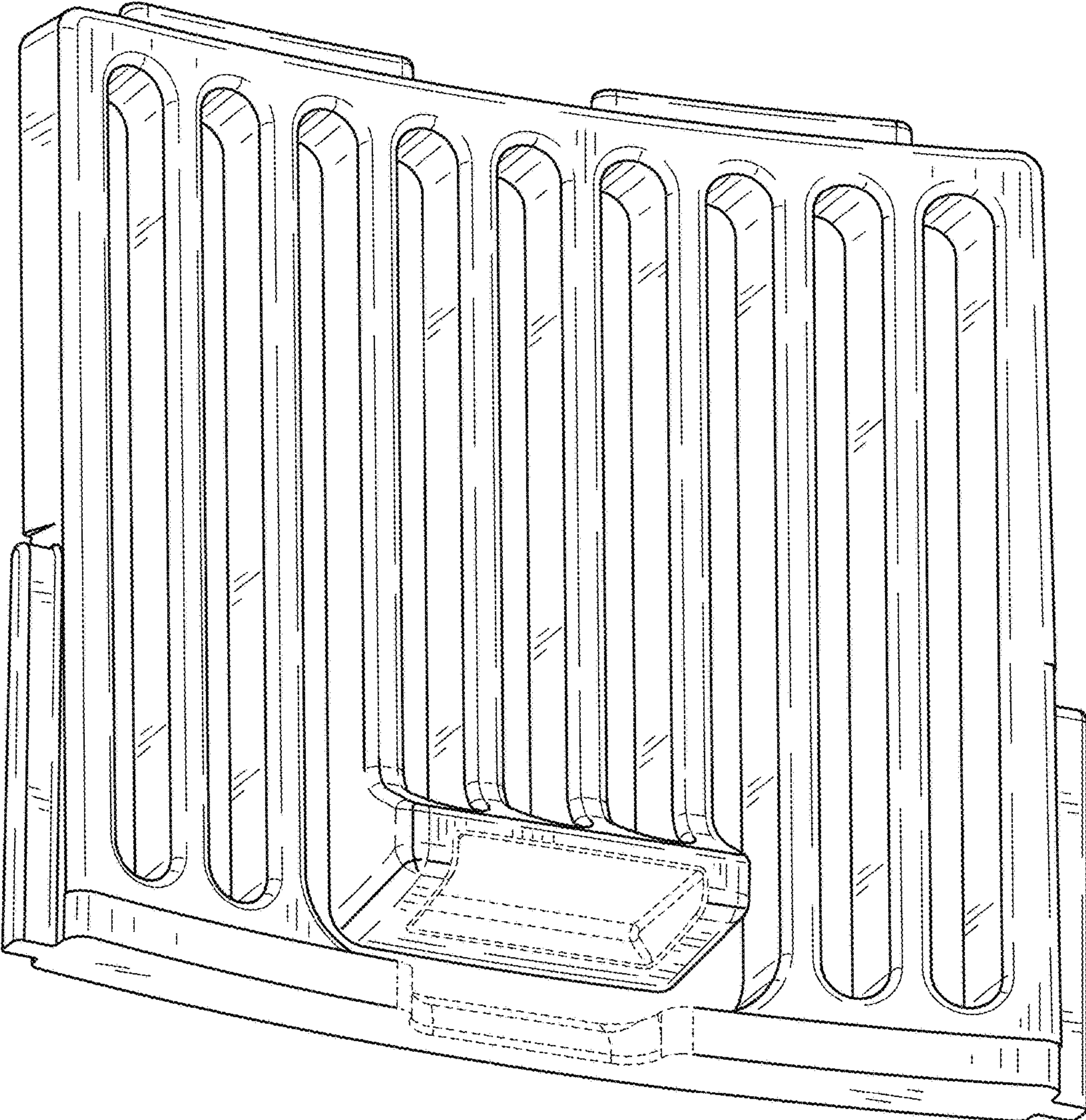

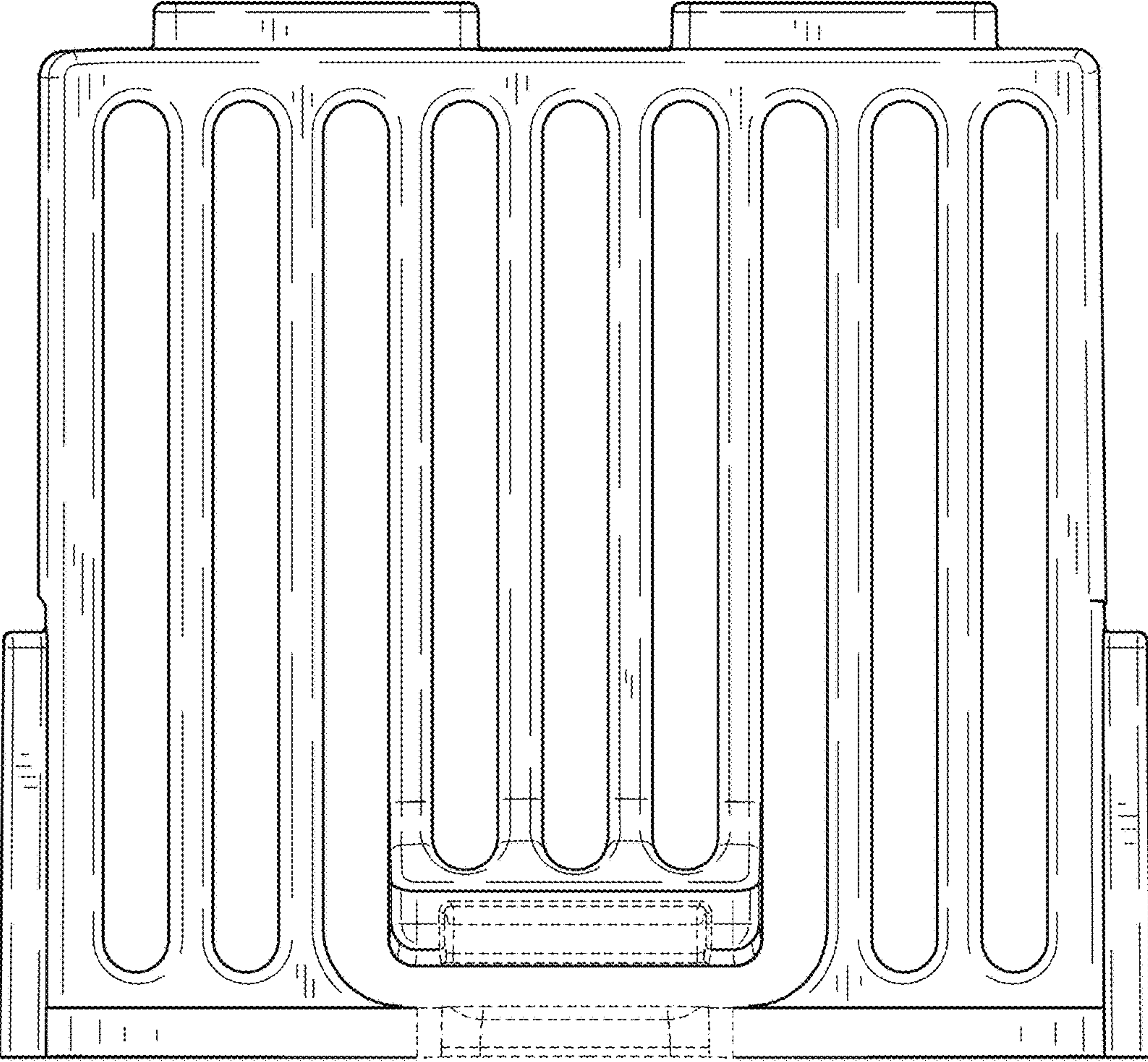

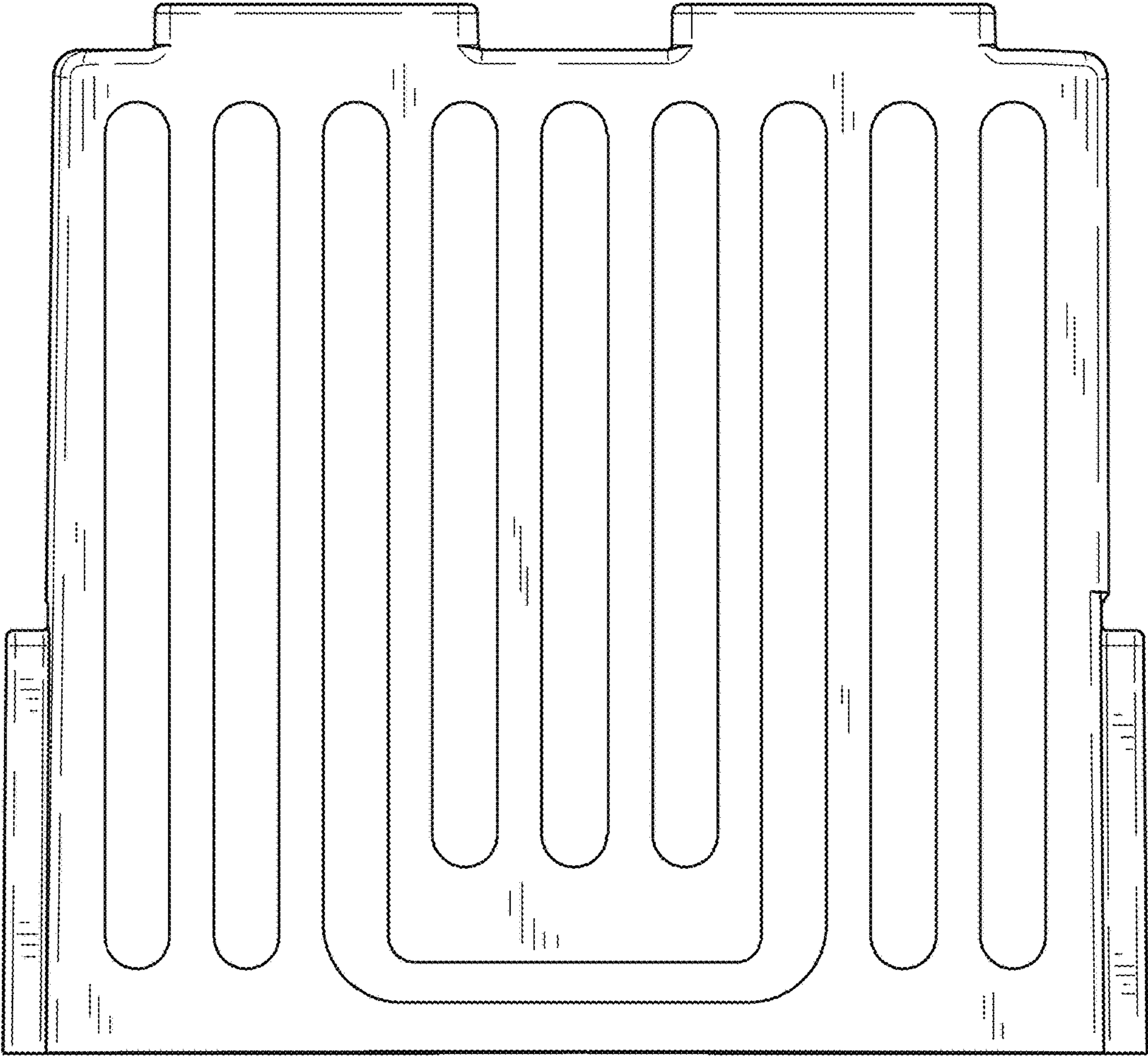

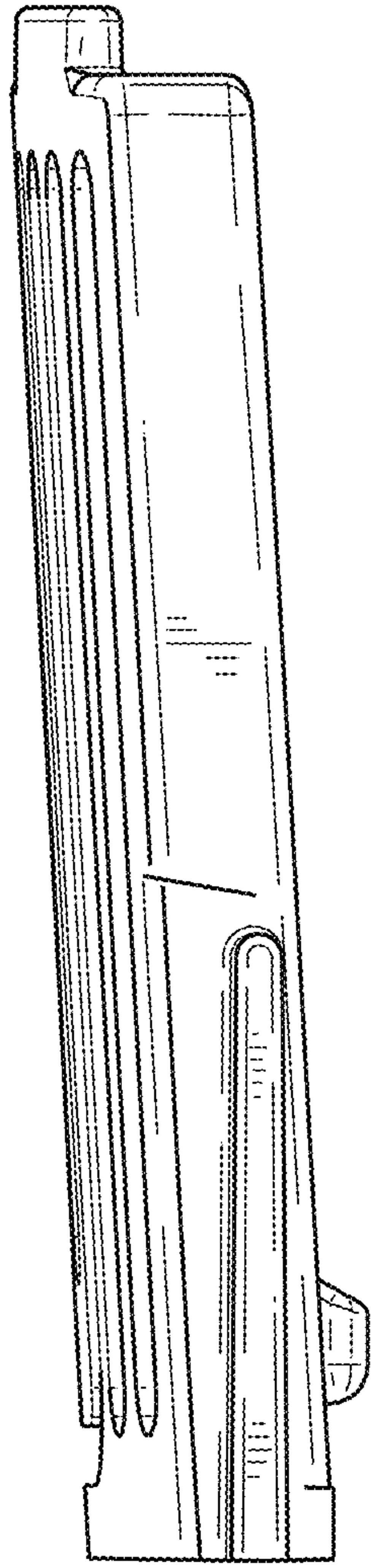

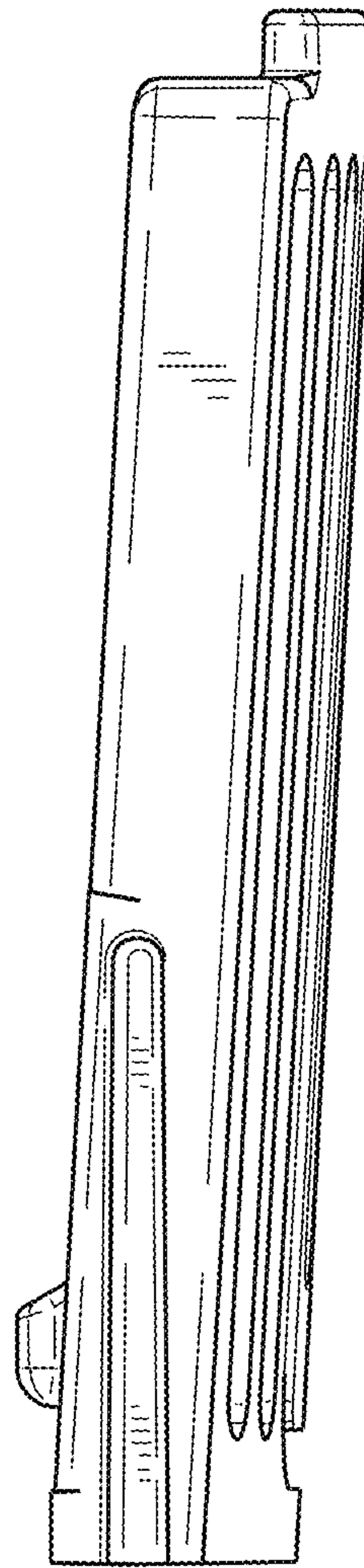

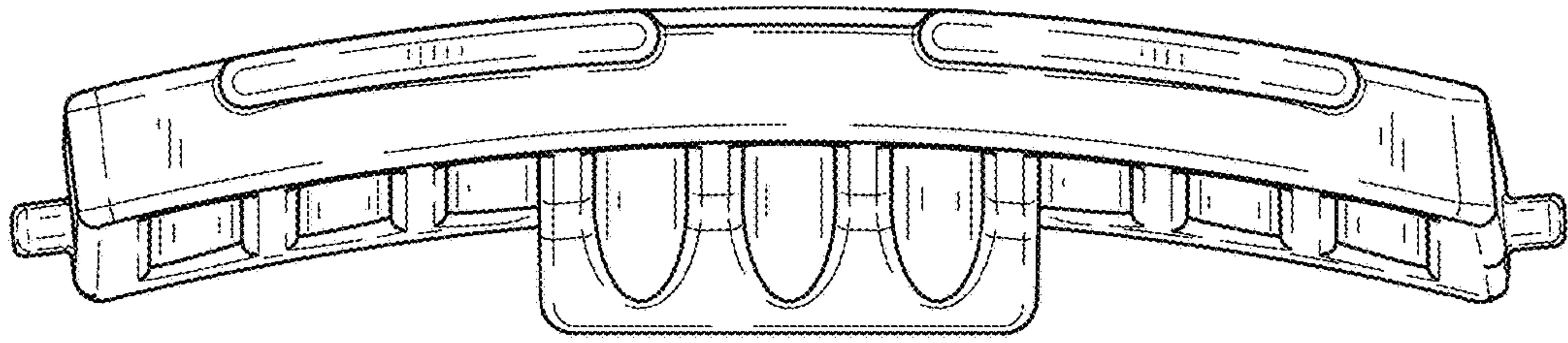

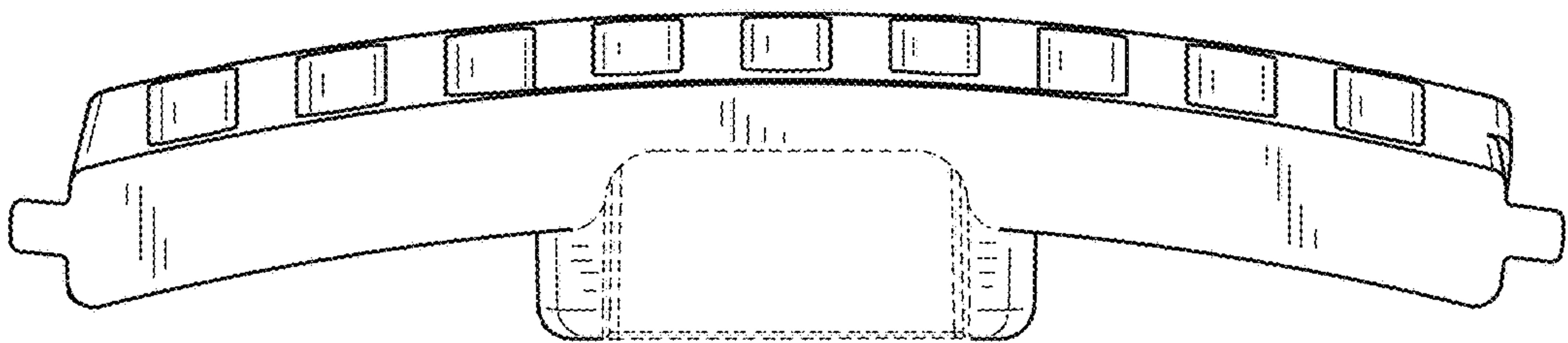
