FIG. 1 is a perspective view of the laser sintering machine of my design, taken from the left-hand side of, and slightly above, the laser sintering machine;

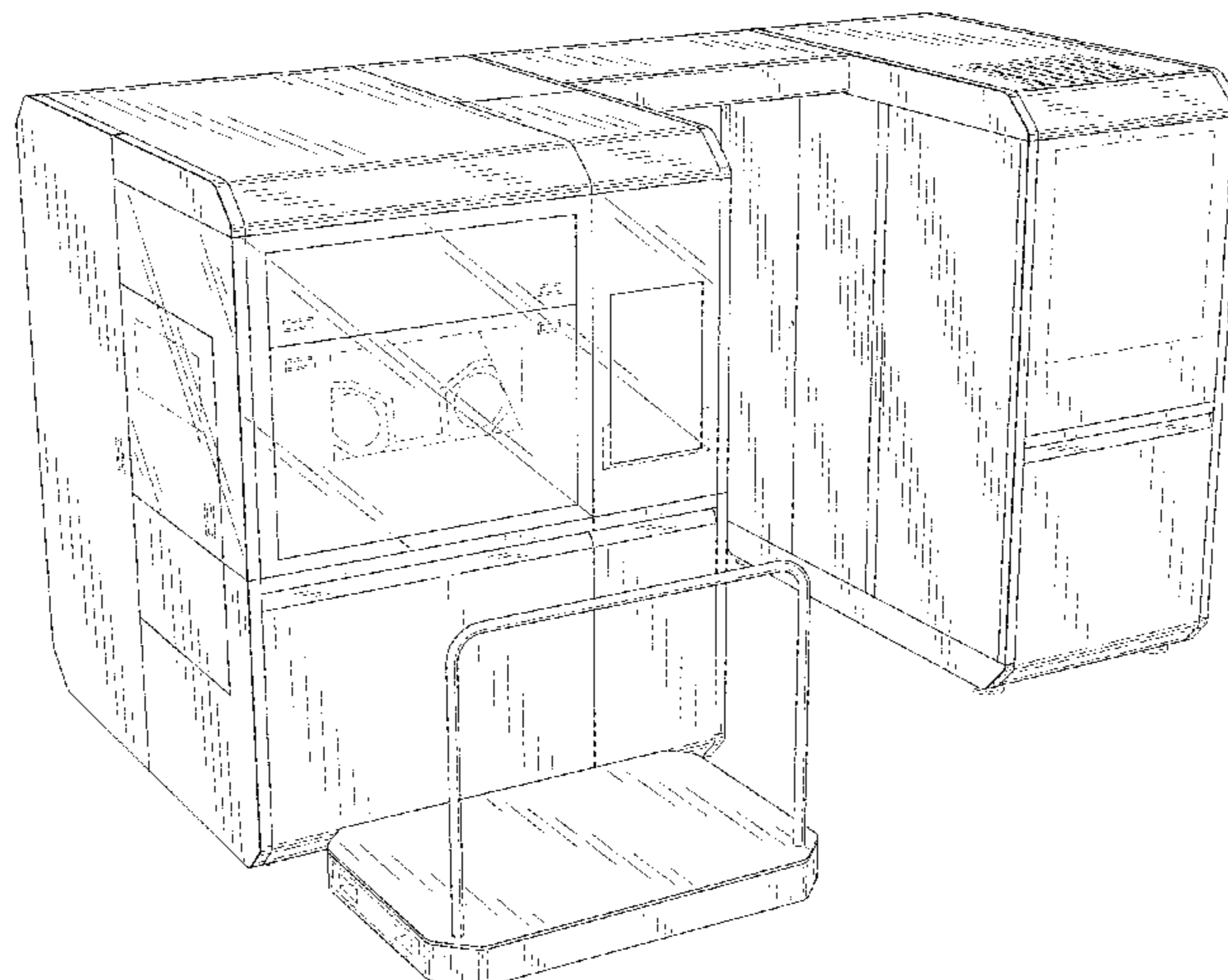
FIG. 2 is a perspective view of the laser sintering machine of my design, taken from the right-hand side of the laser sintering machine;

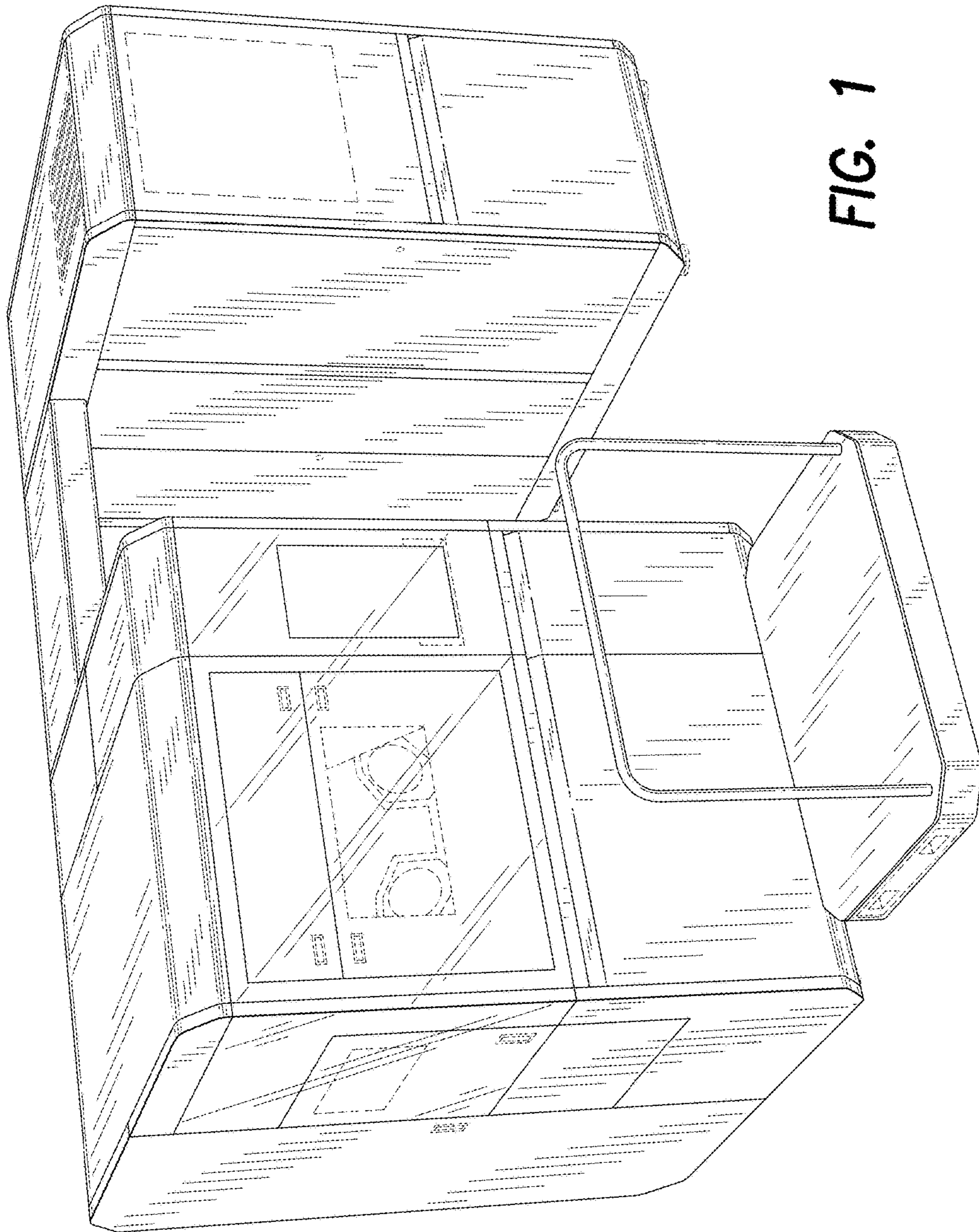
FIG. 3 a left-hand perspective view of the laser sintering machine of my design, showing the left-hand side of the laser sintering machine; and,

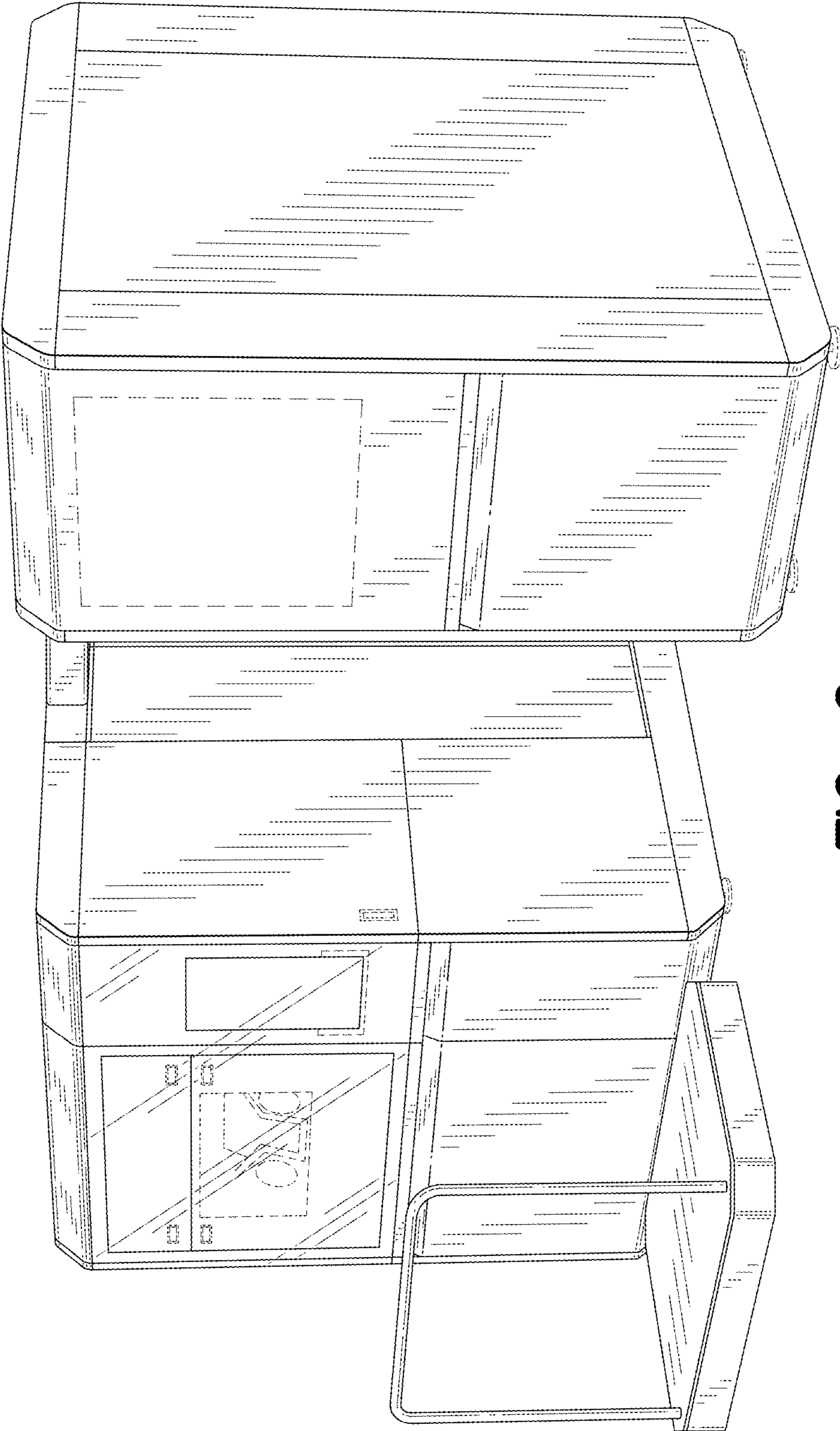
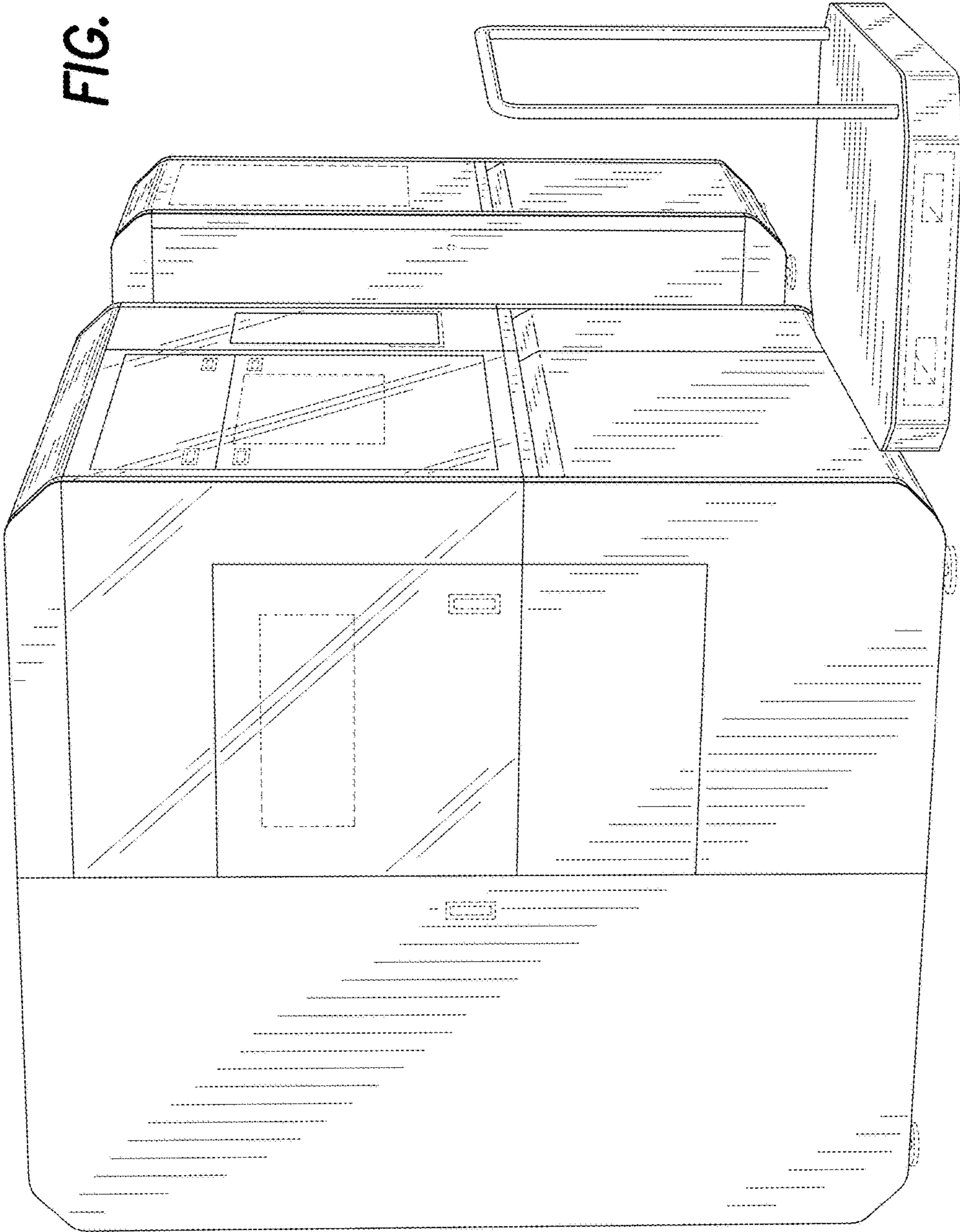

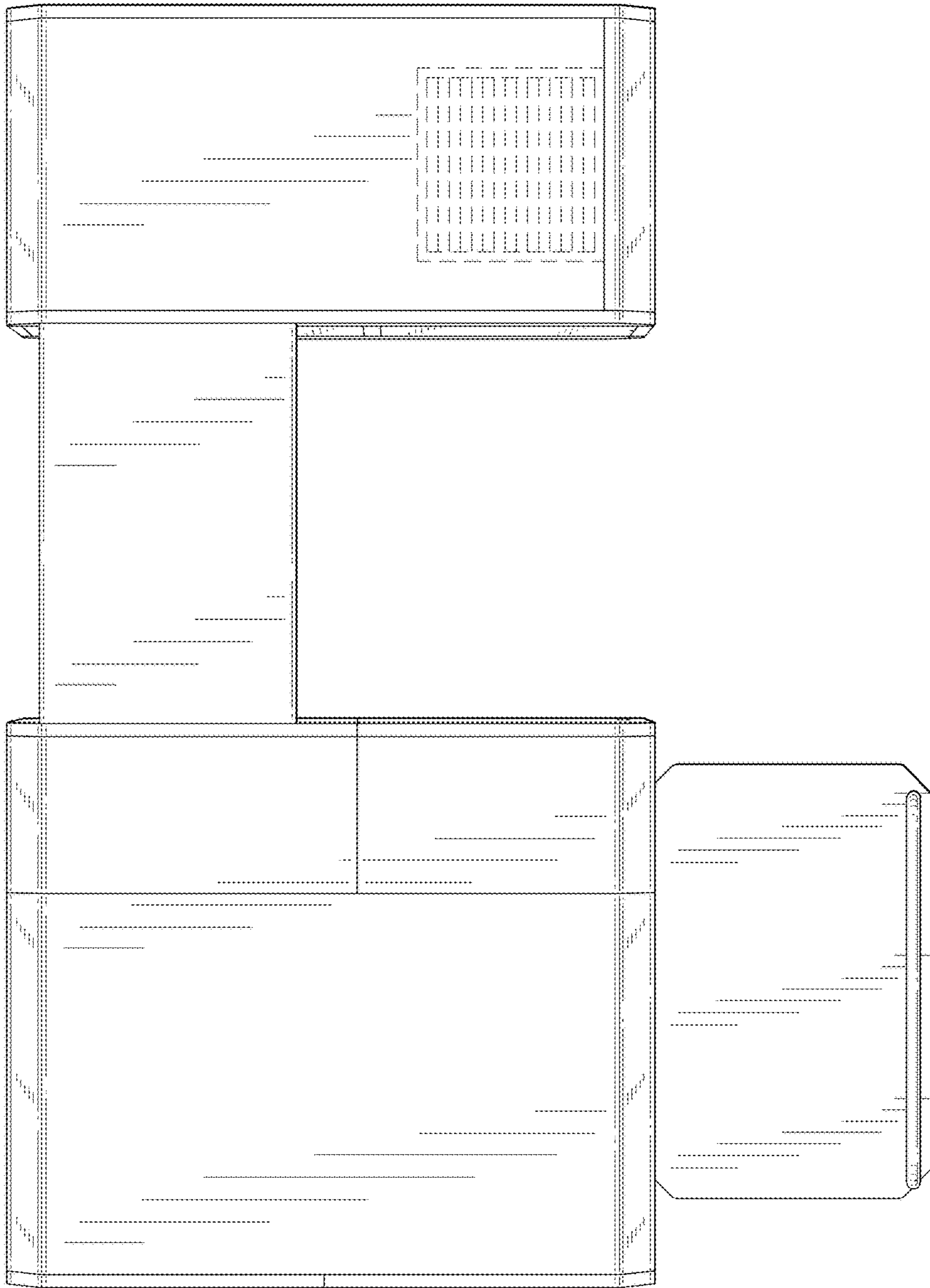
