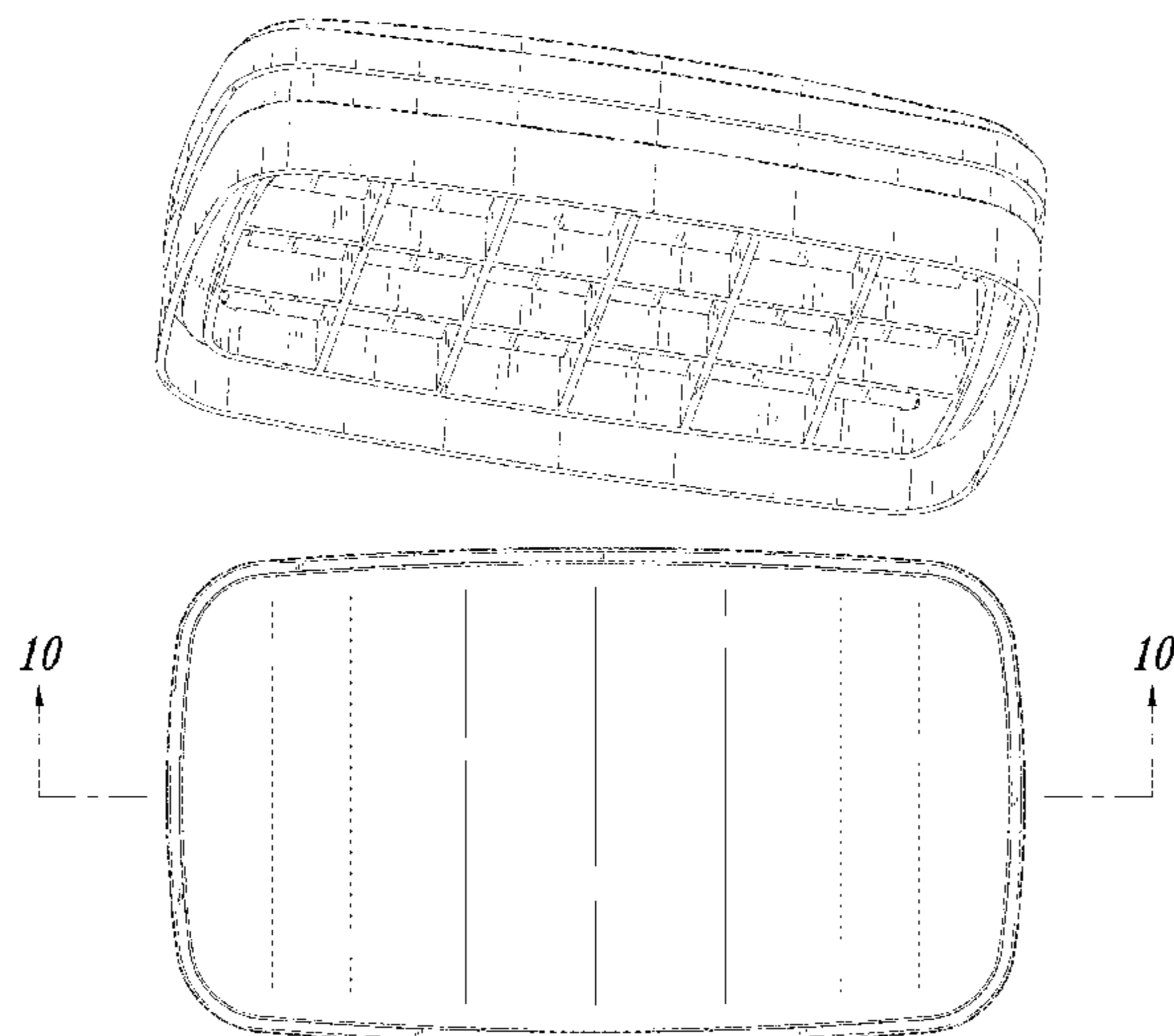
(57) **CLAIM**

The ornamental design for a combined stamp pad and case, as shown and described.

DESCRIPTION

FIG. 1 top, front perspective view of a combined stamp pad and case showing my new design;
 FIG. 2 is a bottom, front perspective view thereof;
 FIG. 3 is a bottom, left side perspective view thereof;
 FIG. 4 is a front elevational view thereof, the rear elevational view being a mirror image thereof;
 FIG. 5 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is an exploded top perspective view thereof showing the case in an open state in order to show aspects of the design not otherwise apparent;
 FIG. 9 is a cross-sectional view thereof, taken in the direction of line 9-9 of FIG. 4; and,
 FIG. 10 is a cross-sectional view thereof, taken in the direction of line 10-10 of FIG. 6.
 The broken lines in FIGS. 9 and 10 are included for the purpose of illustrating portions of the article that form no part of the claimed design. In addition, the innermost surface (as shown with symbolic broken line hatching) directly adjoining the outer most solid line edge forms no part of the claimed design. The dot-dash broken line arrows in the FIGS. 4 and 6 views are used to identify the cross section views, are for reference purposes only, and form no part of the claimed design.

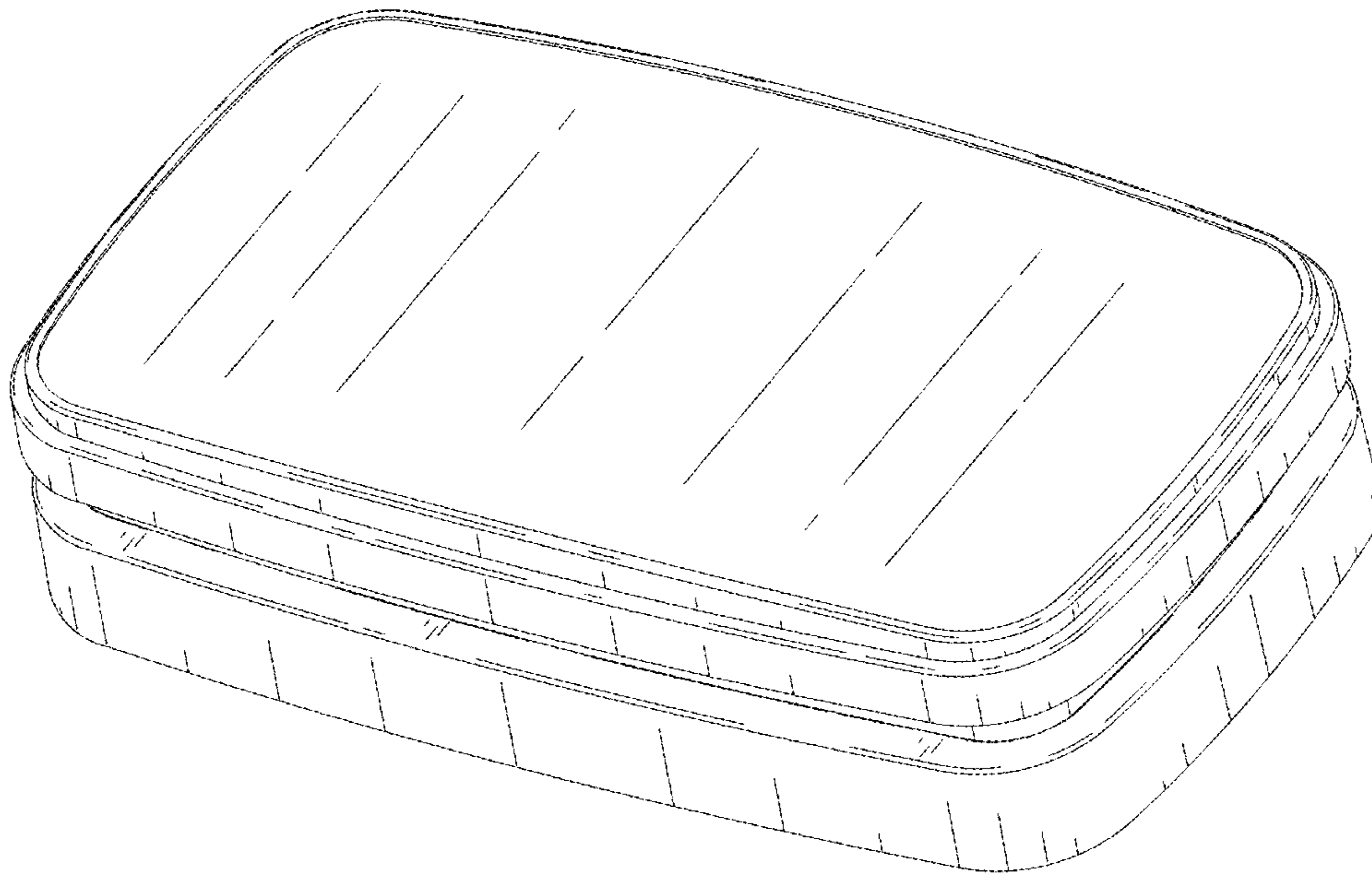

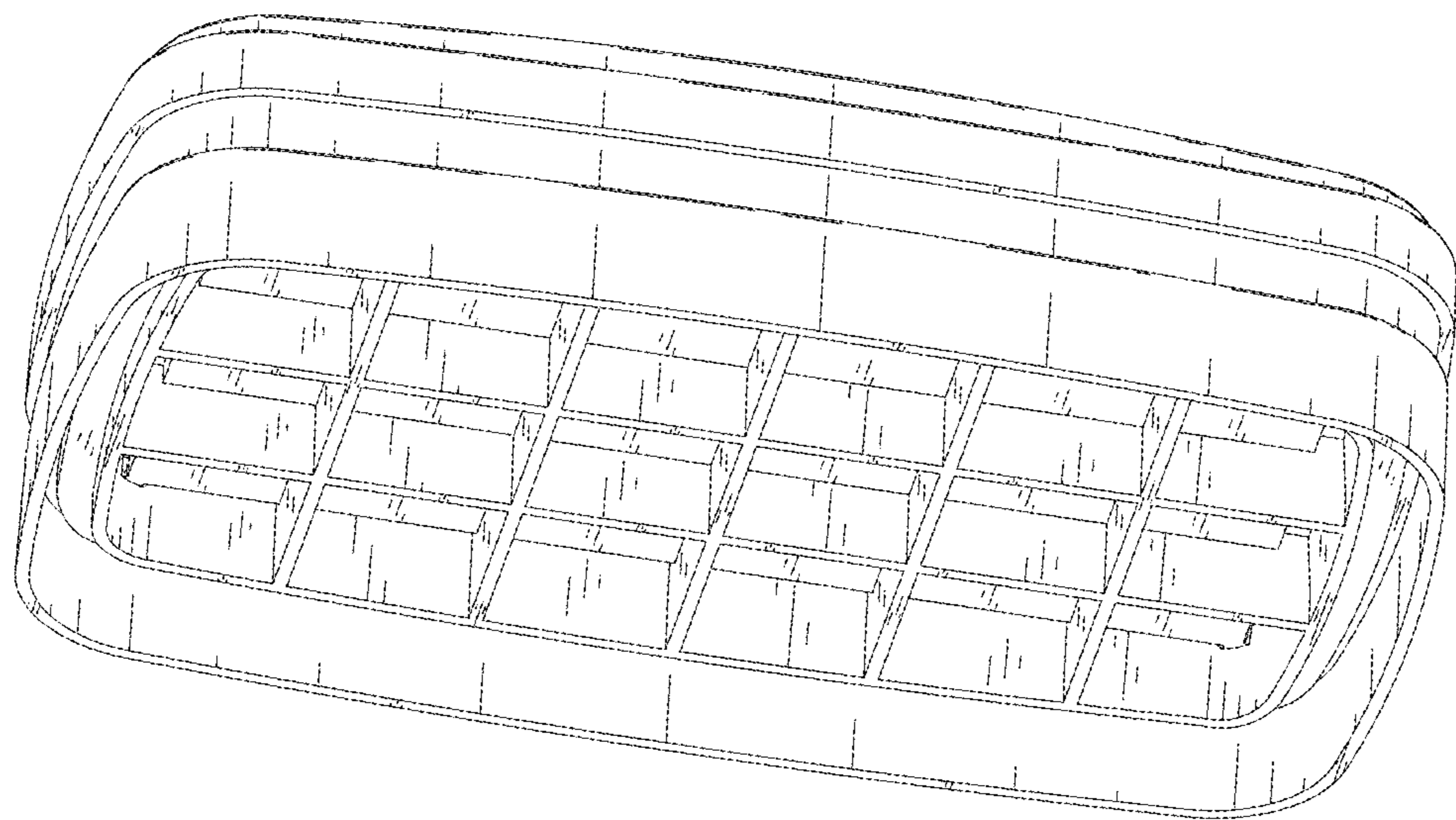

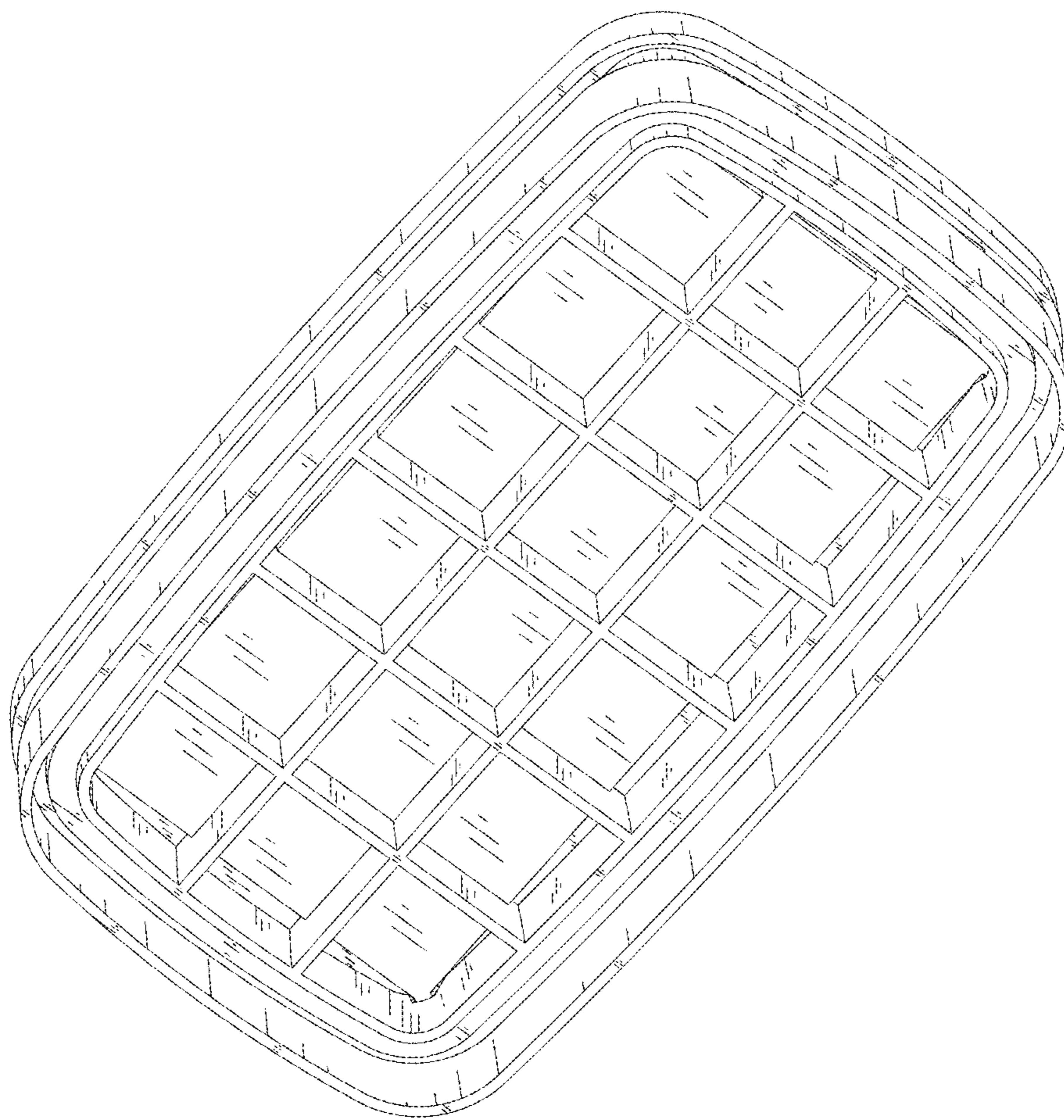

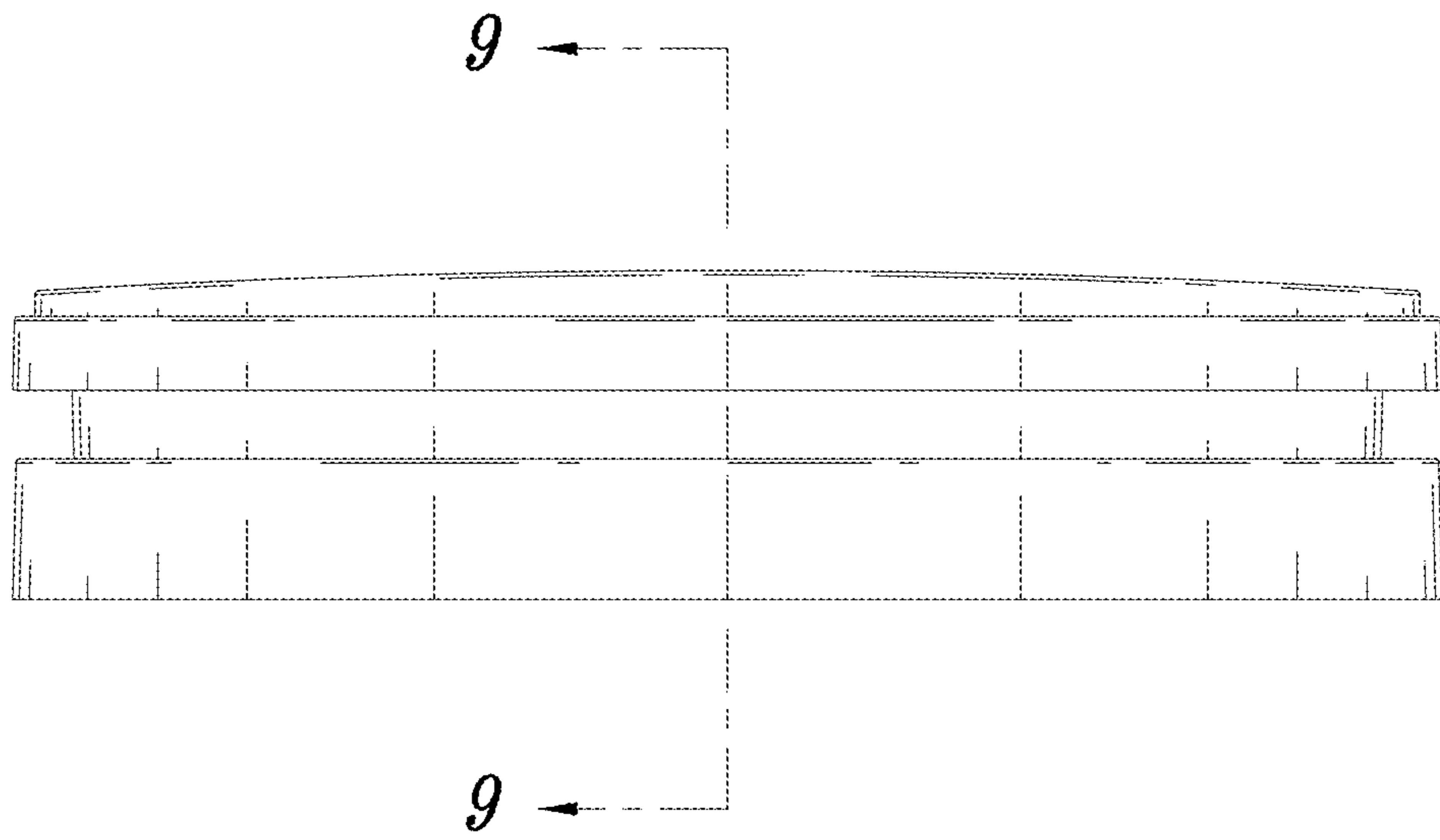

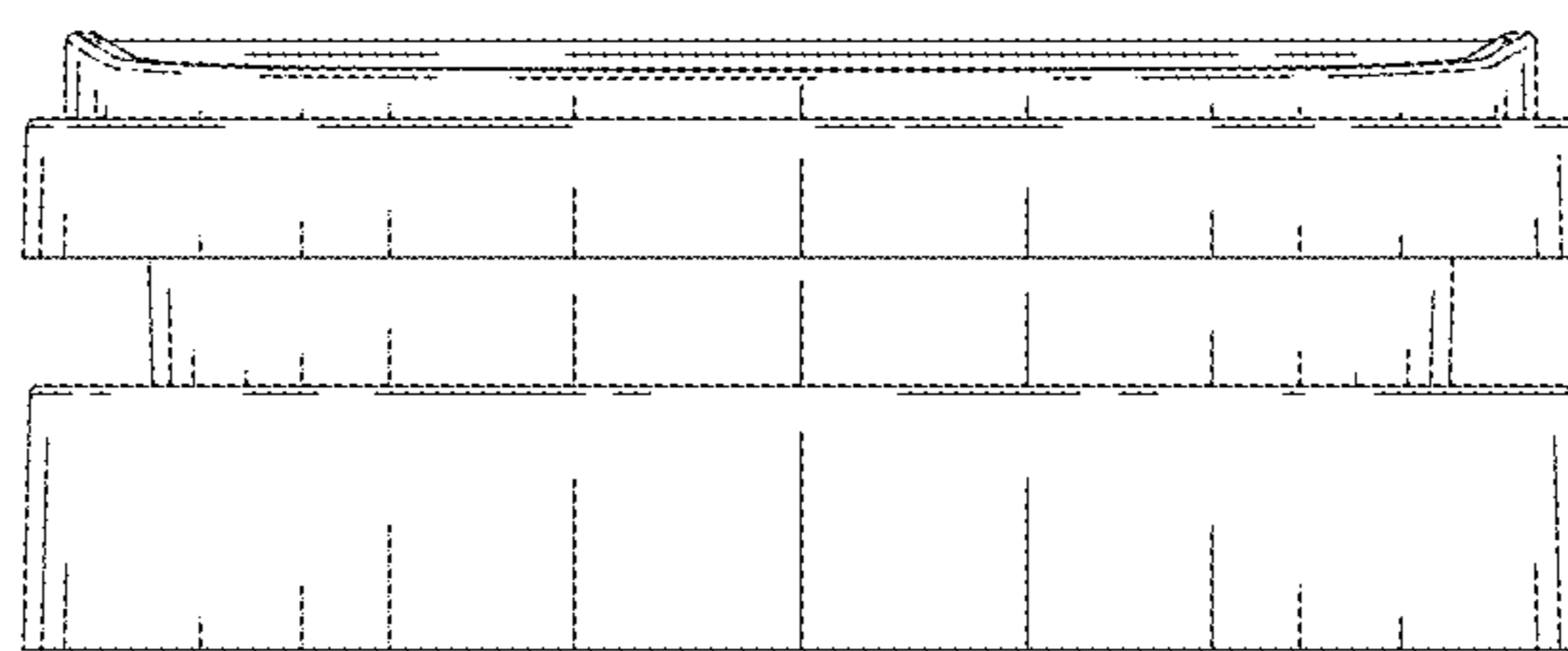

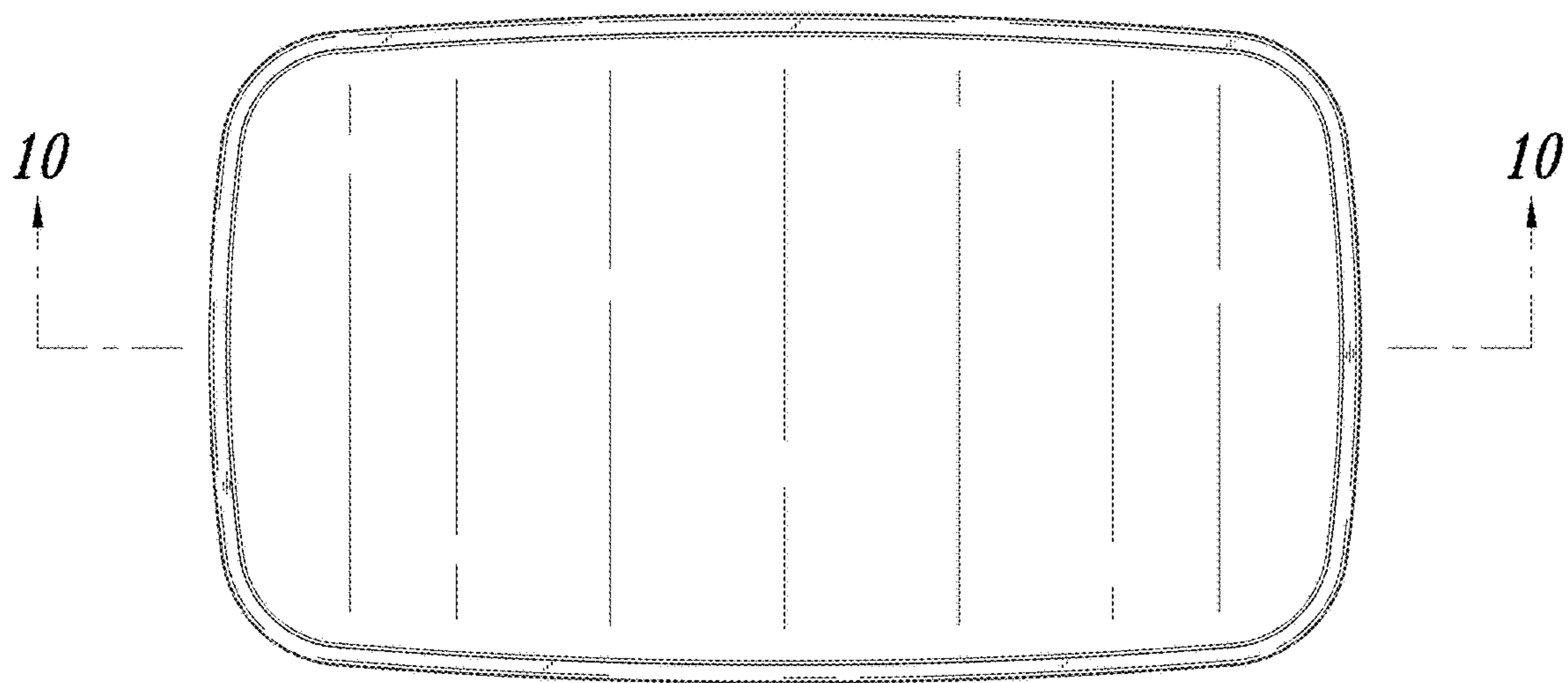

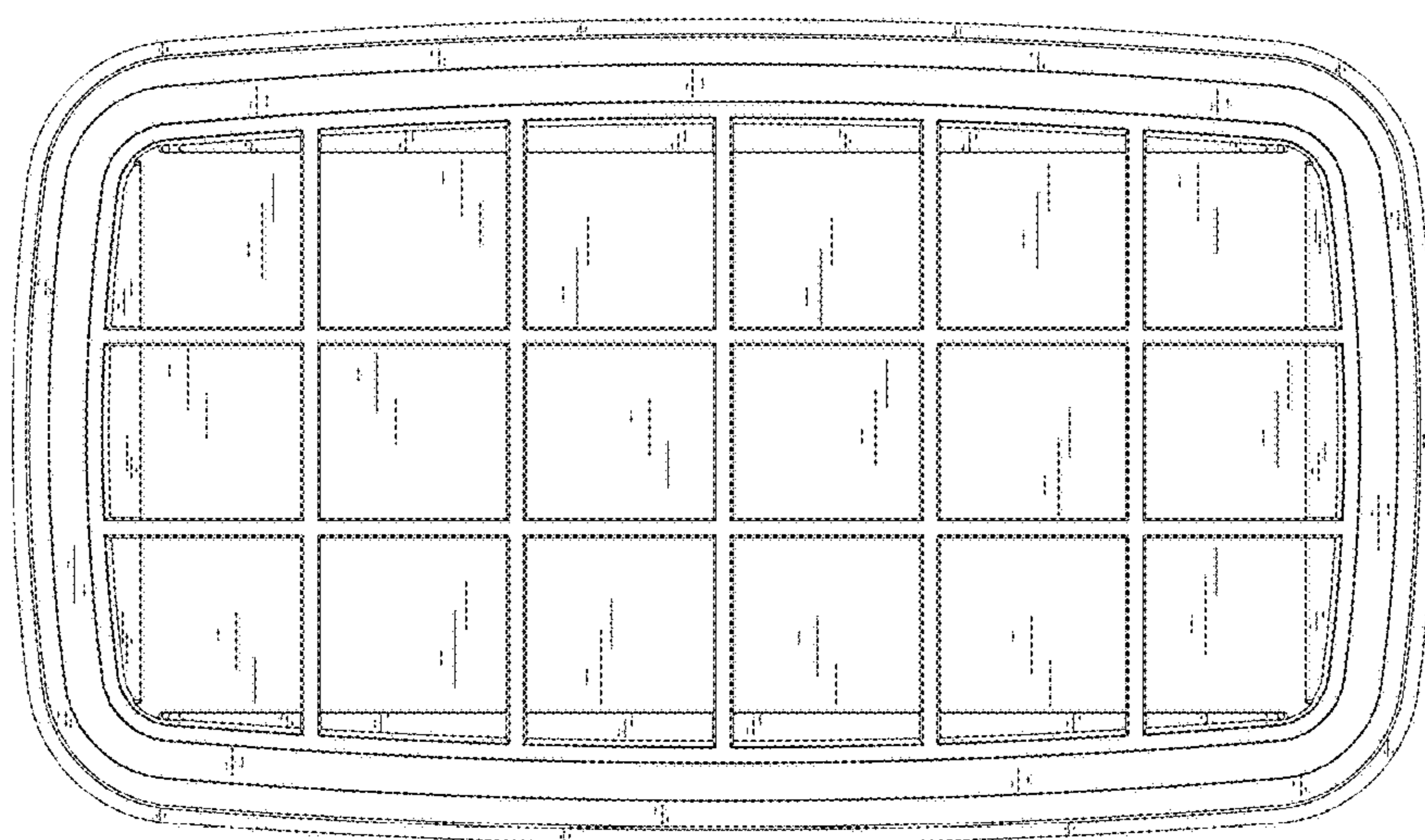

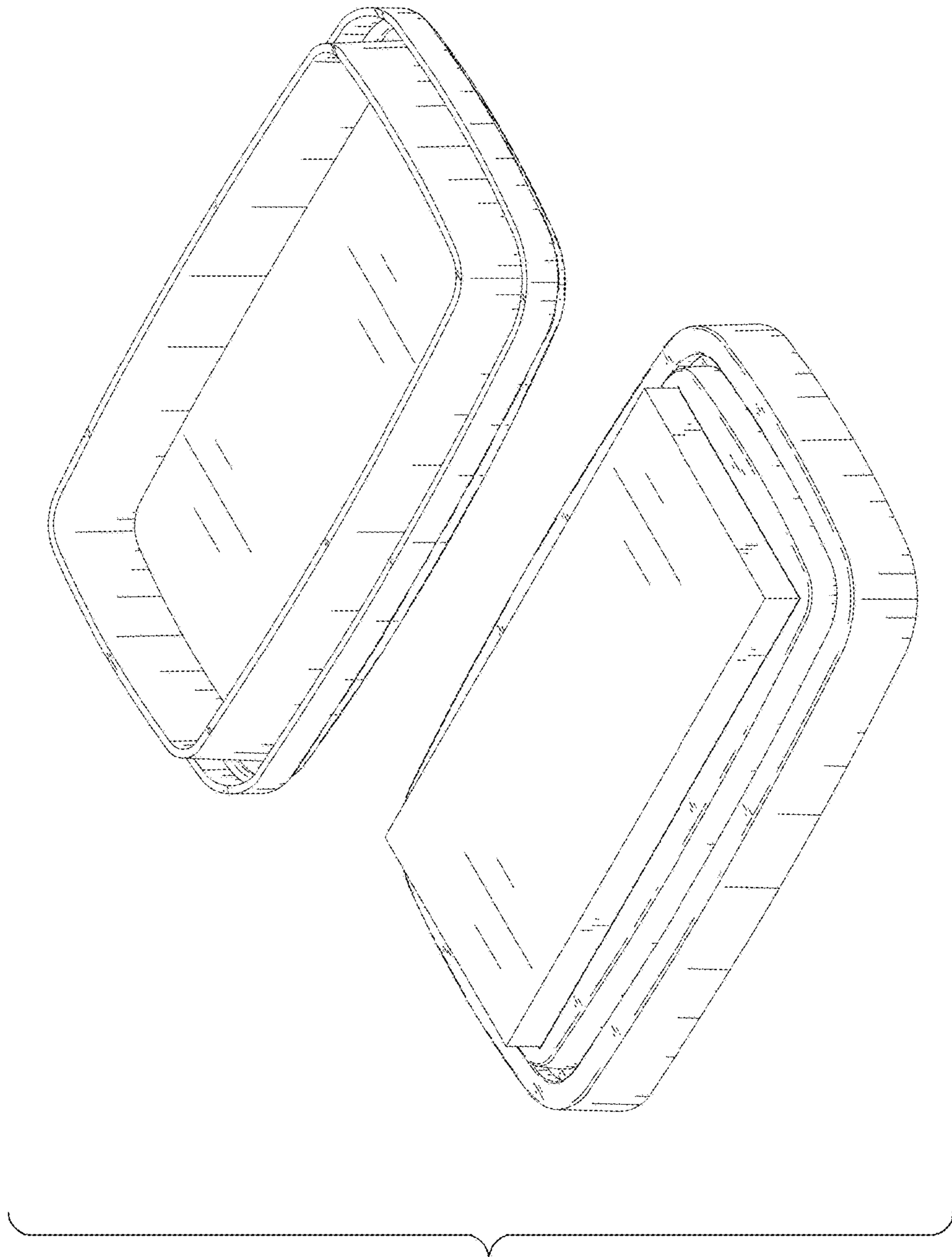

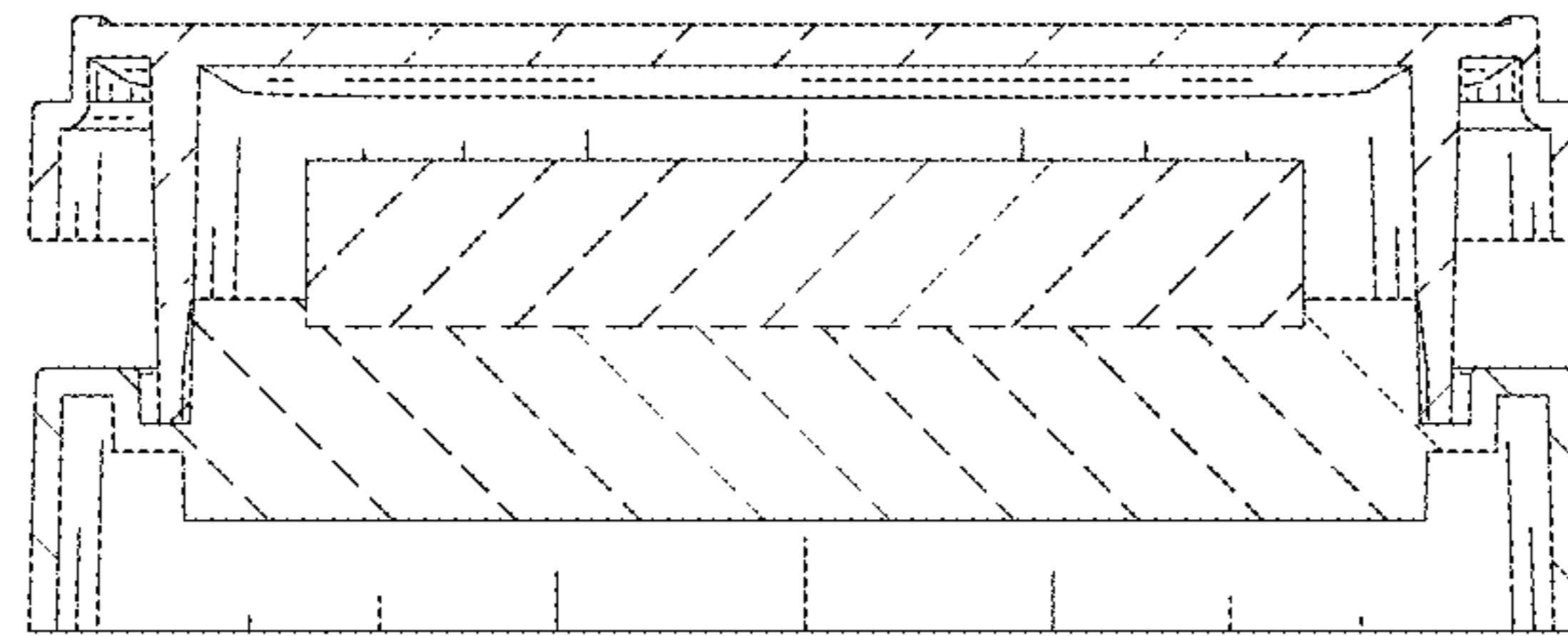

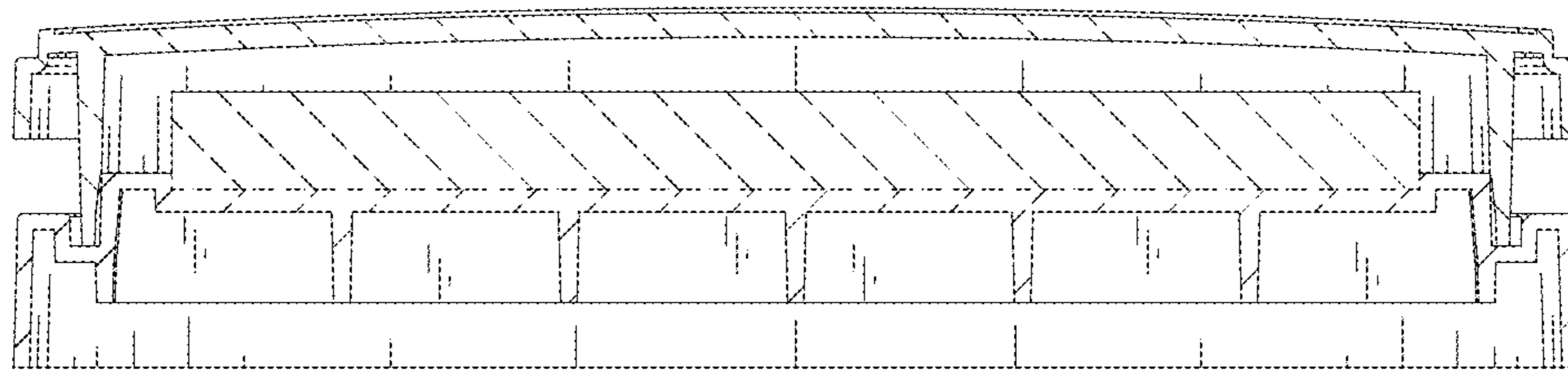
